(57) **CLAIM**

We claim the ornamental design for a display screen or portion thereof with icon, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of a display screen or portion thereof with icon showing our new design; FIG. 2 is a second embodiment thereof; FIG. 3 is an enlarged view of the icon in FIG. 1, shown separately for clarity of illustration; and, FIG. 4 is an enlarged view of the icon in FIG. 2, shown separately for clarity of illustration. The broken line perimeter in FIGS. 1 through 2 shows a display screen or portion thereof and forms no part of the claimed design.

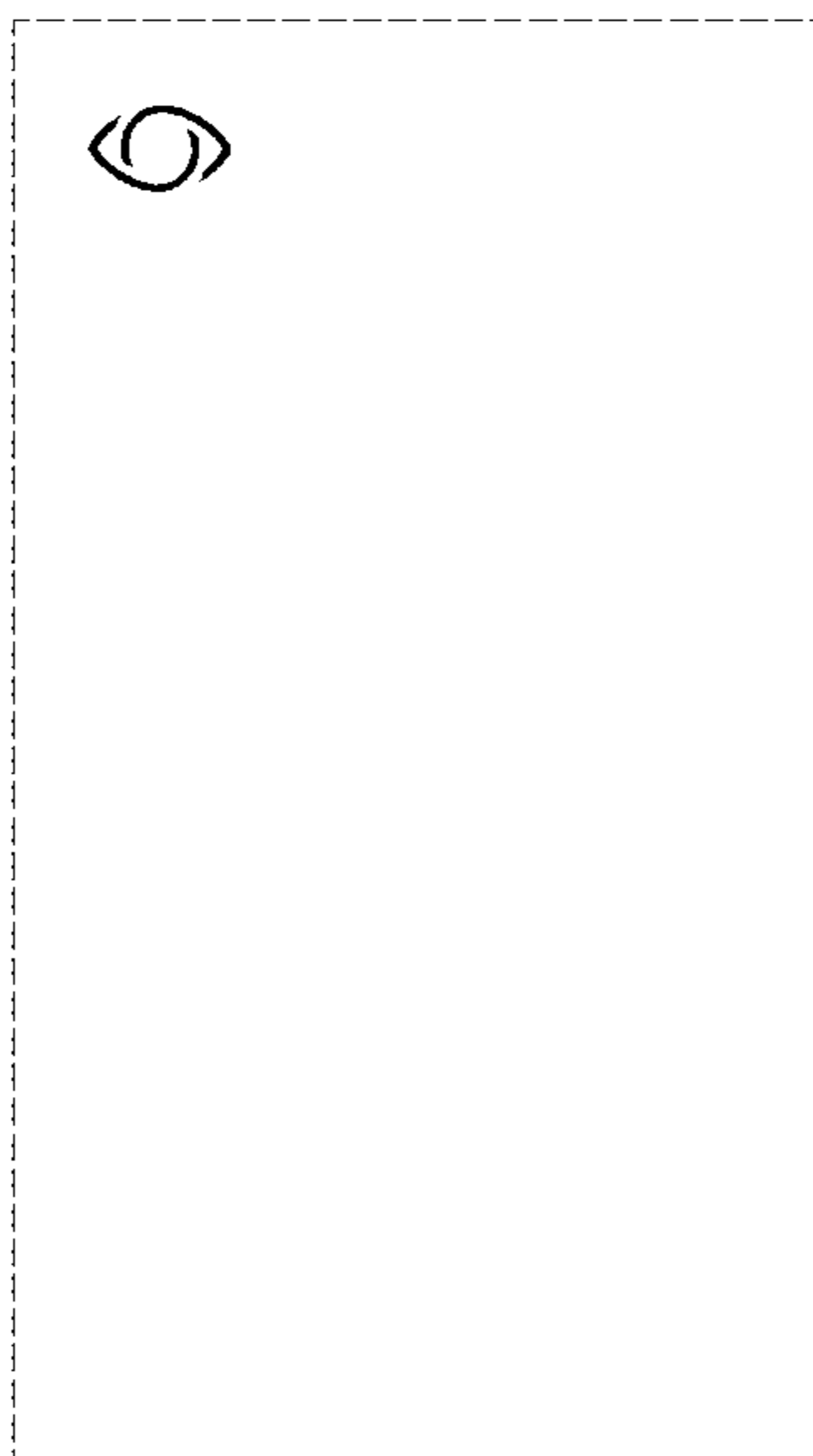

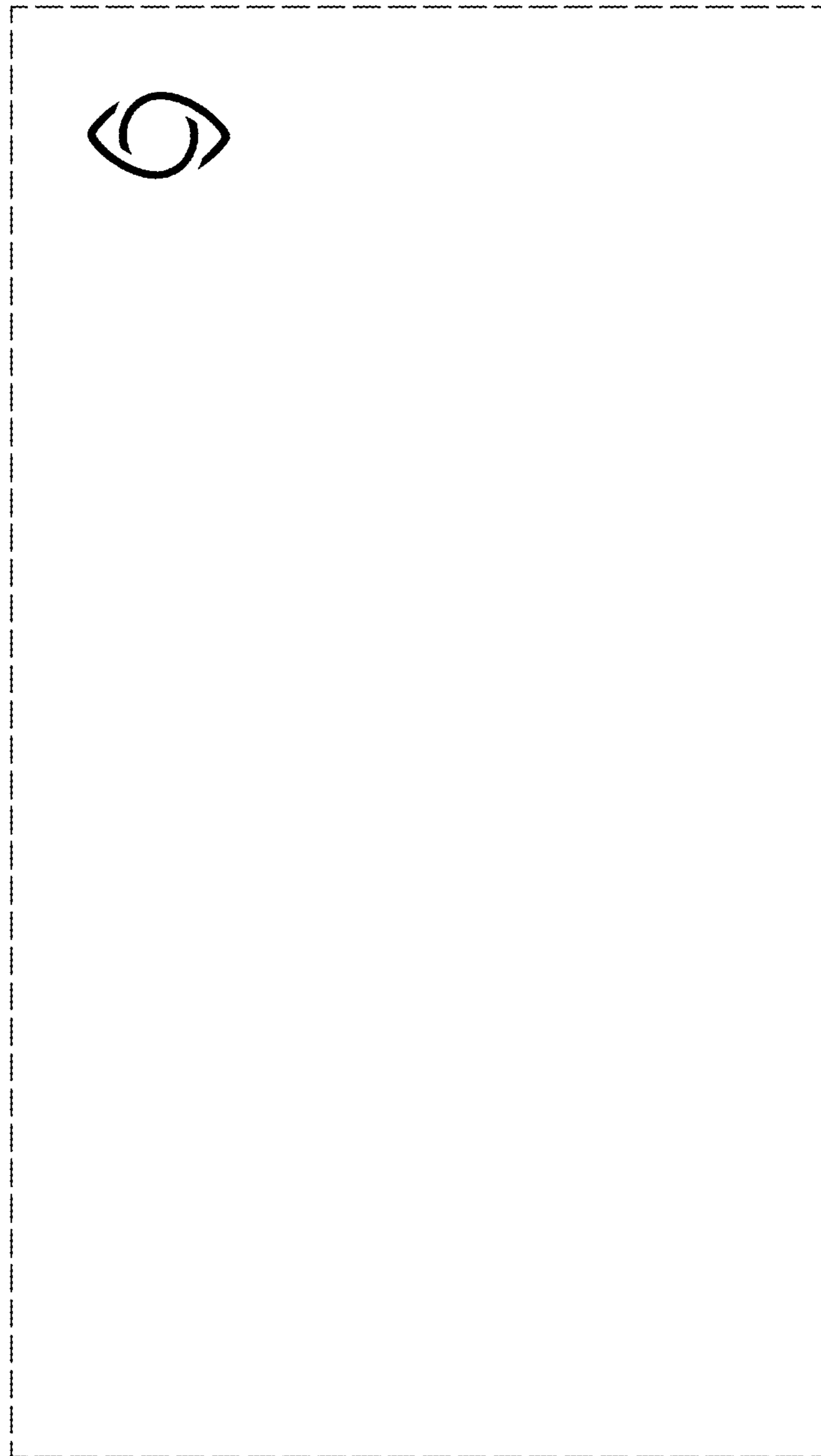

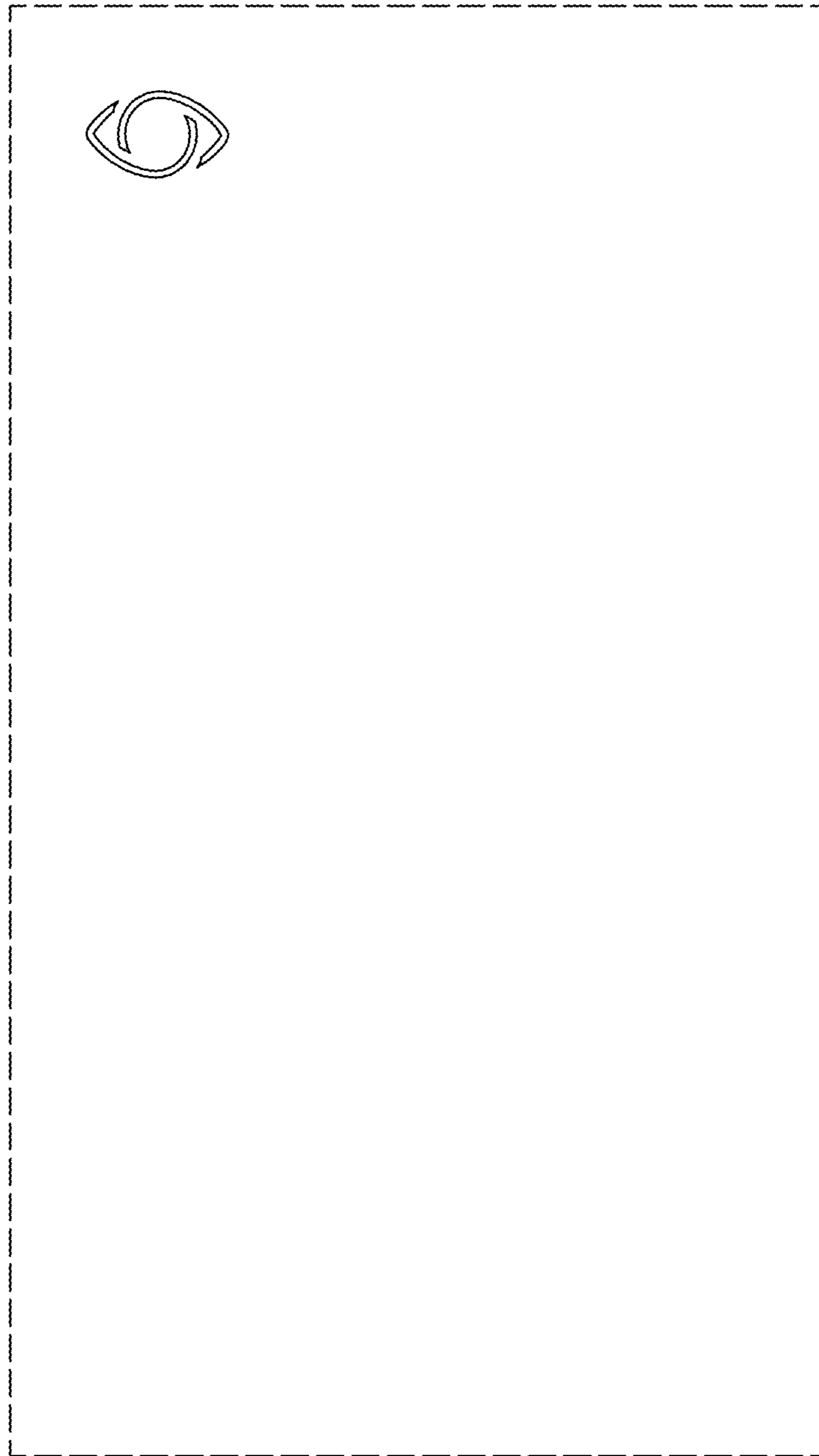

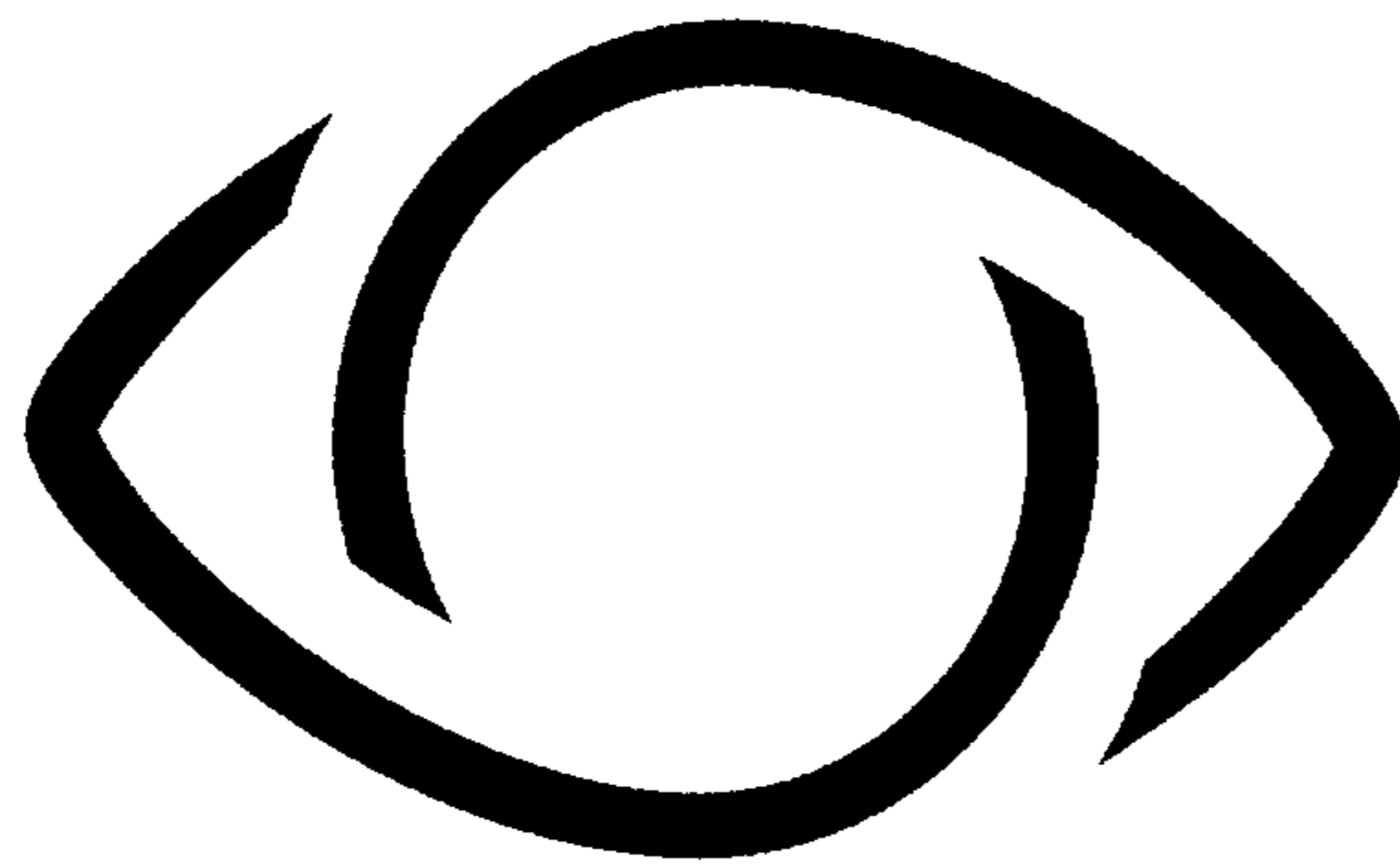
