DESCRIPTION

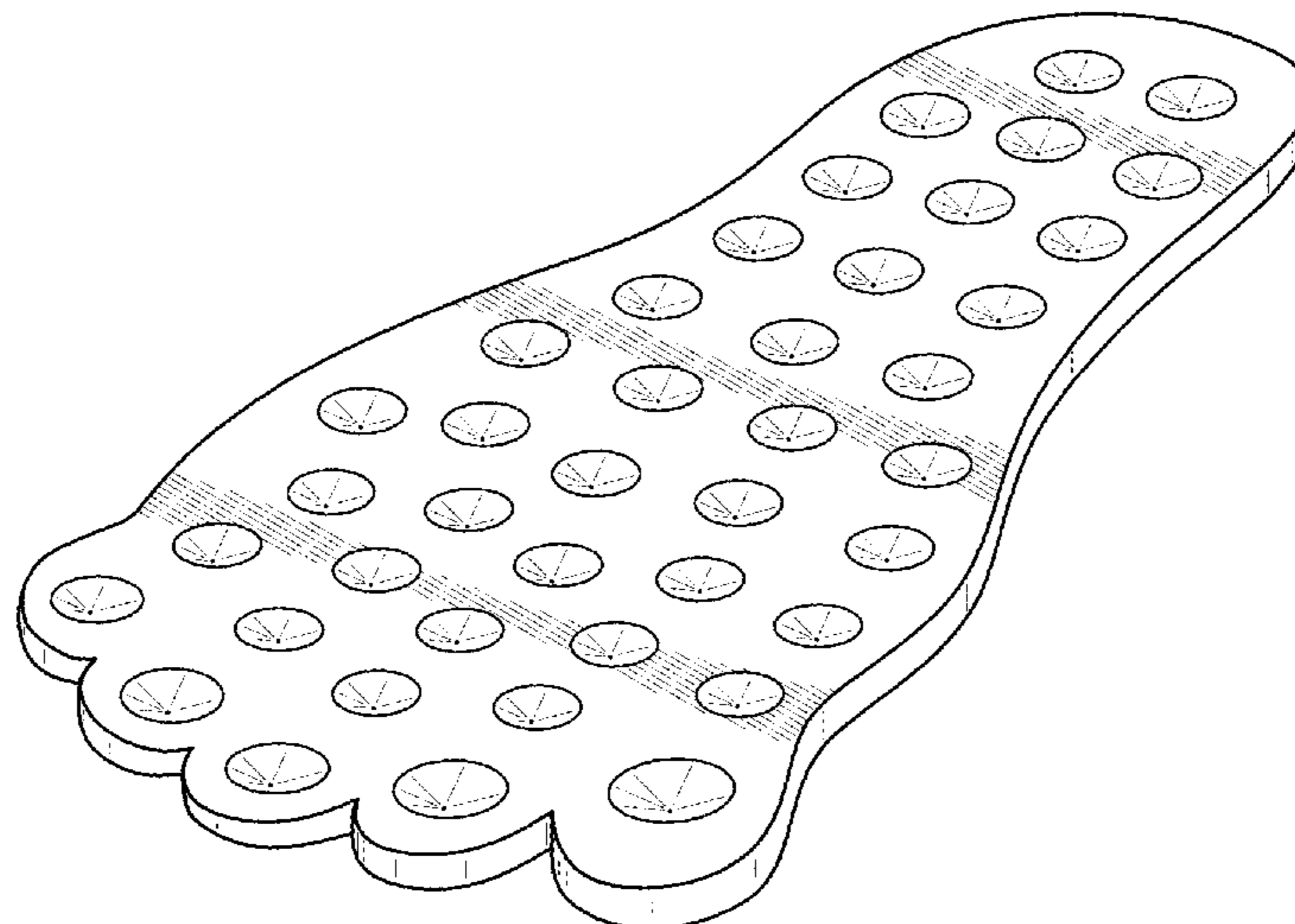
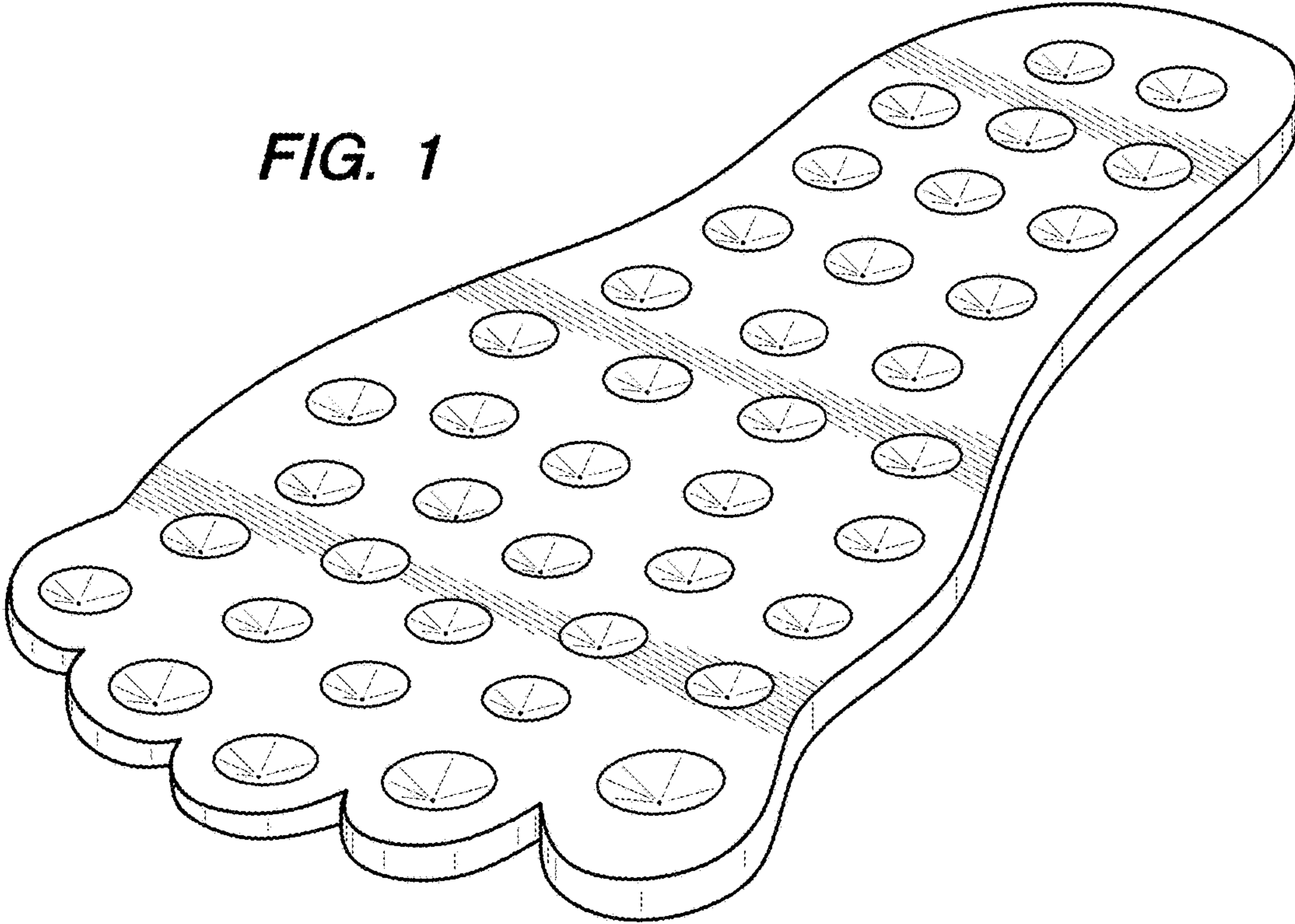

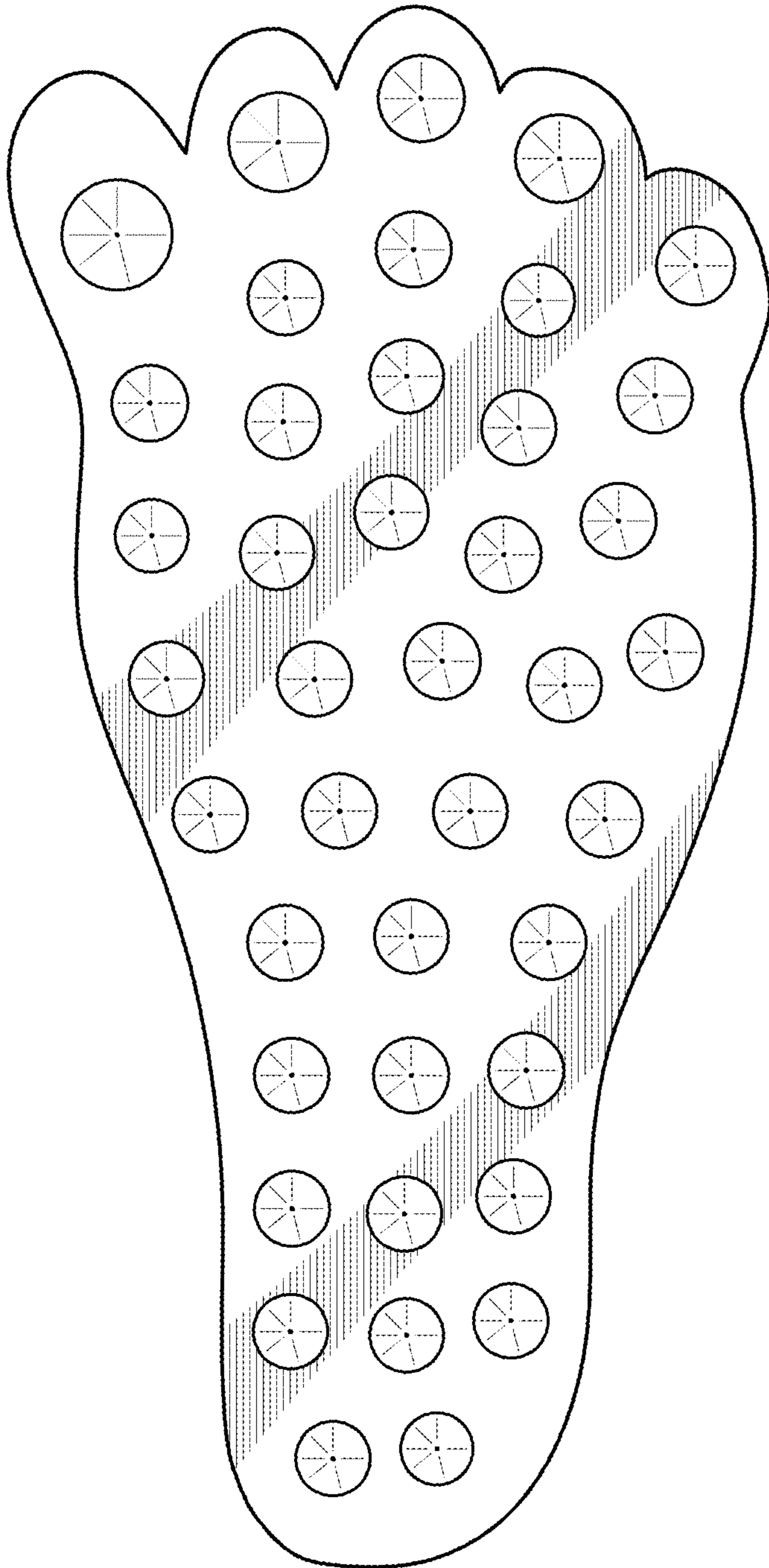

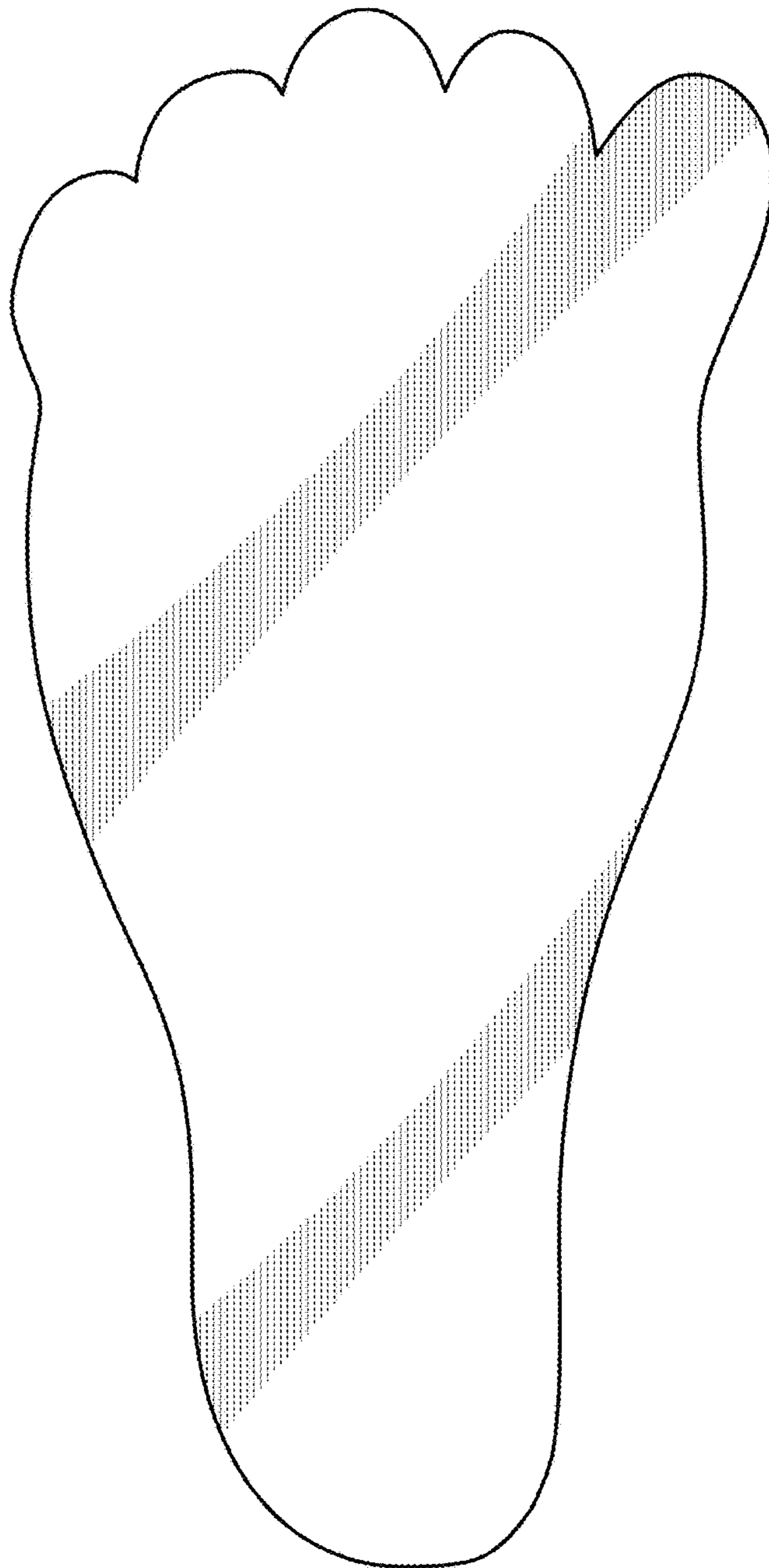
