new design;

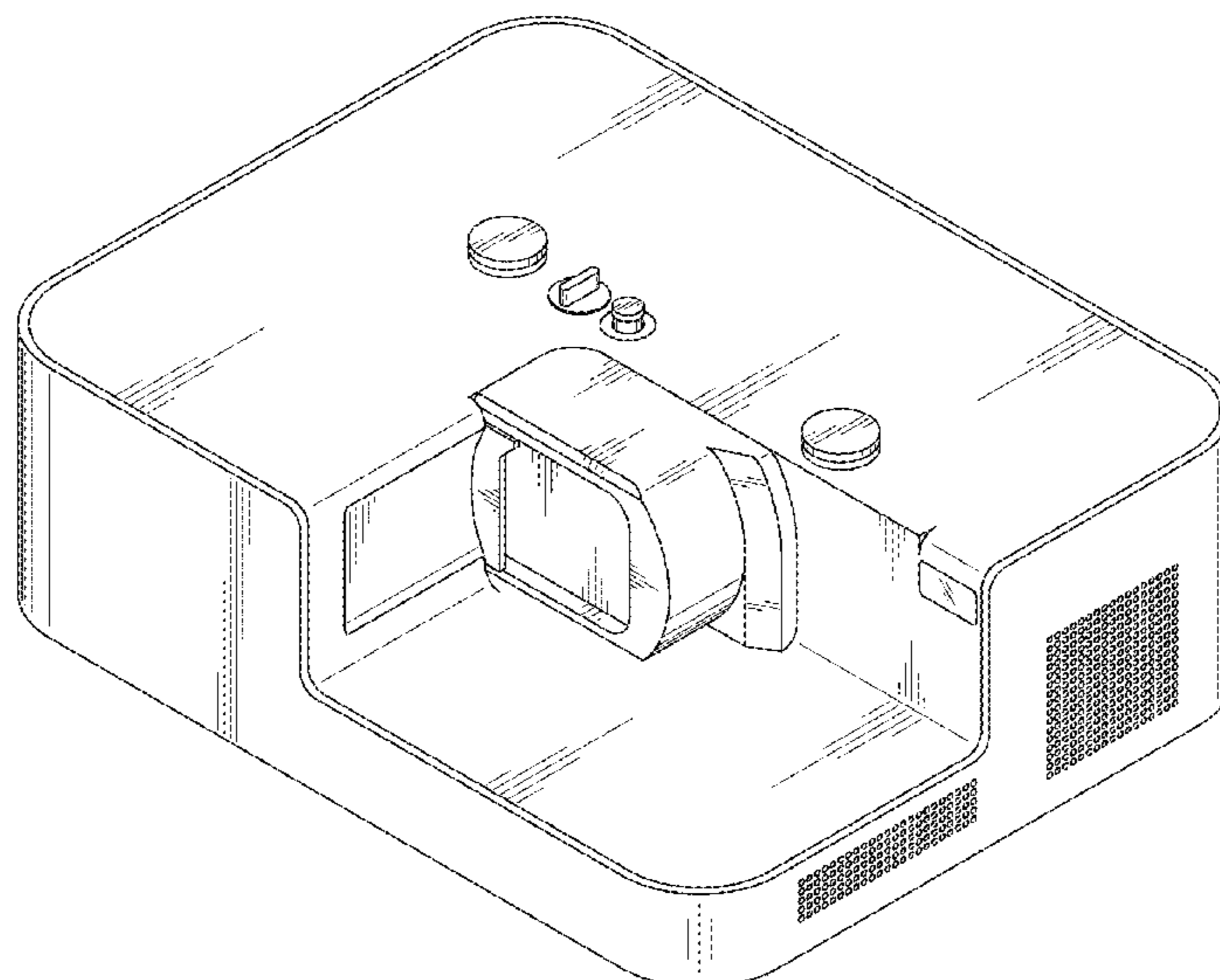

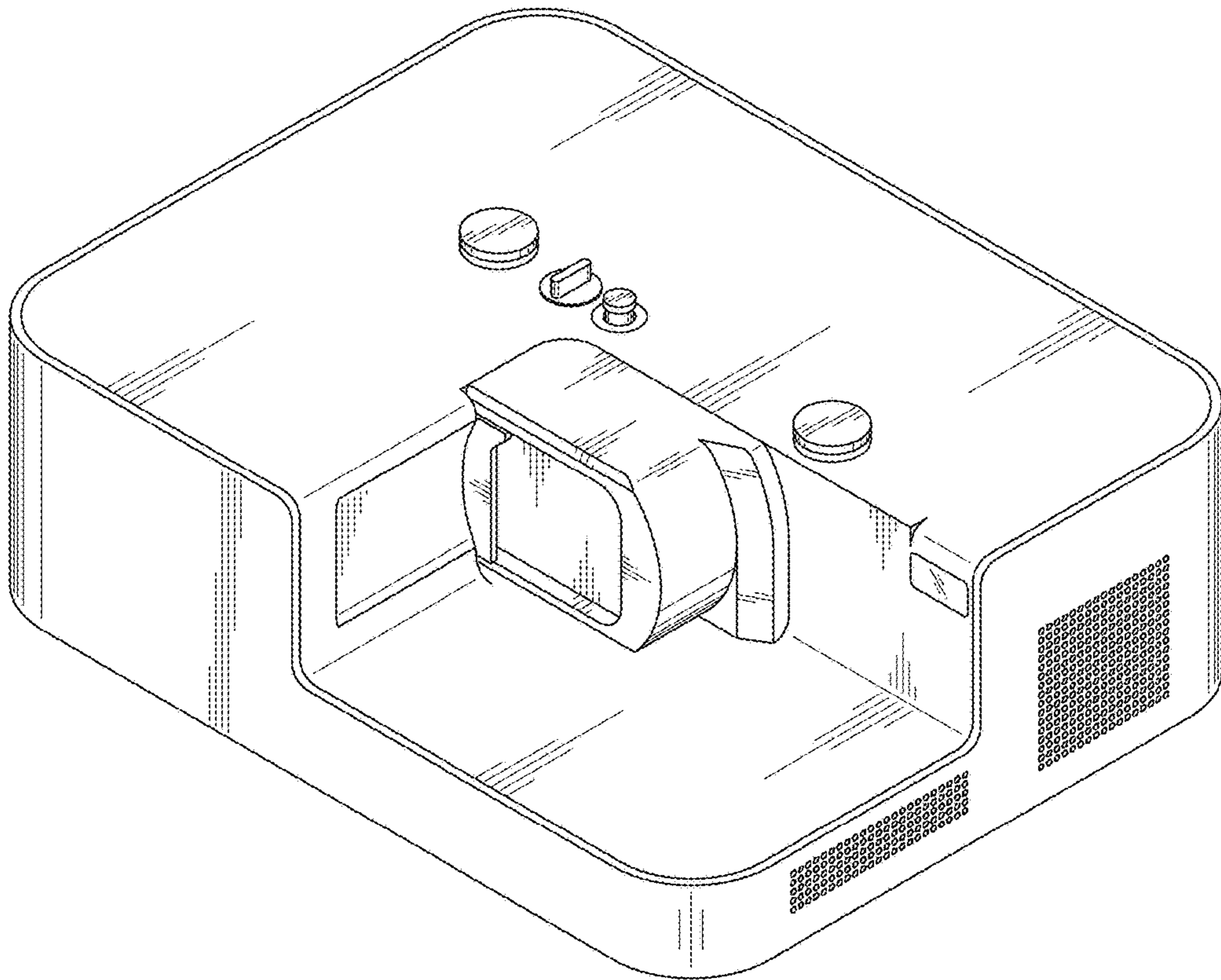
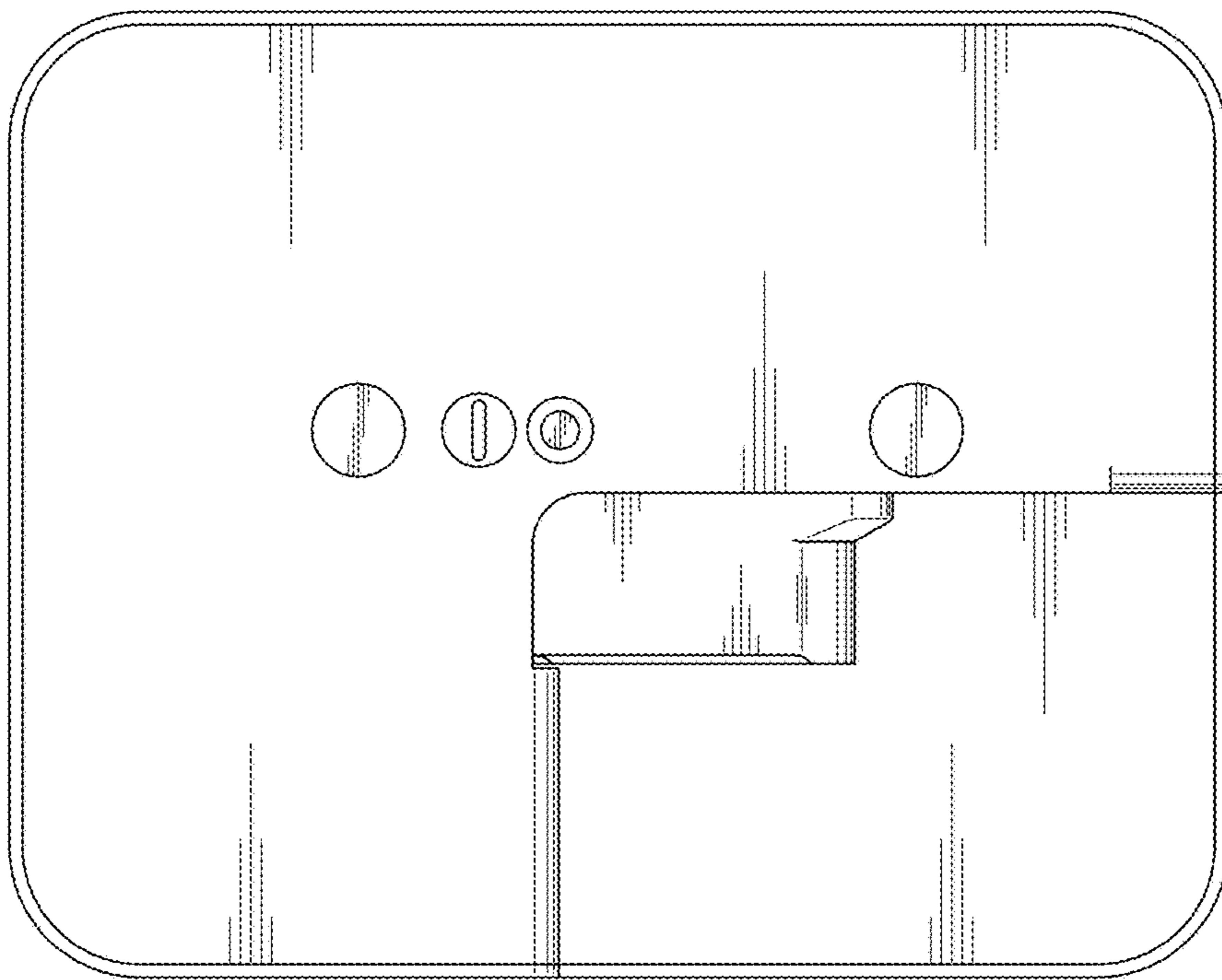
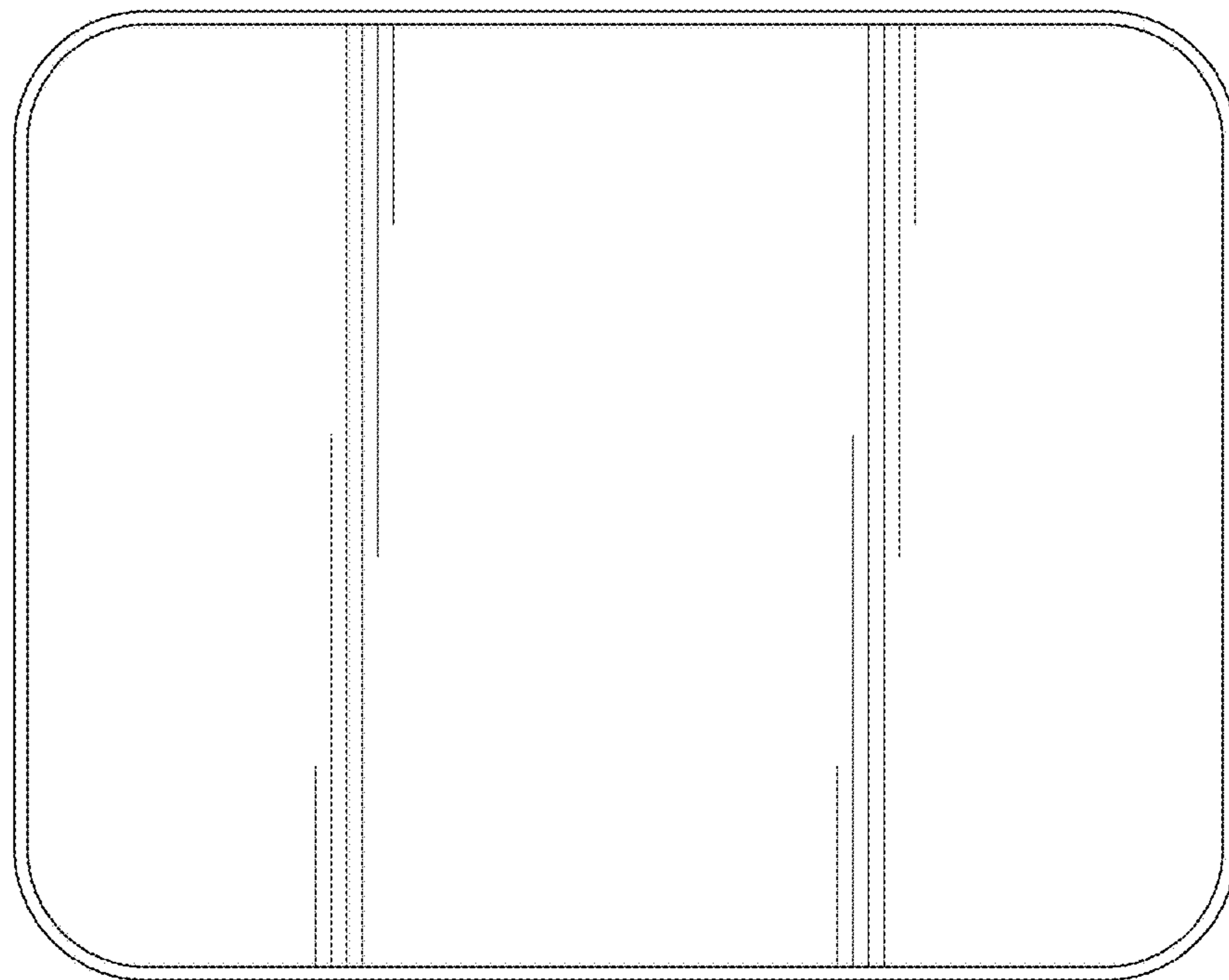


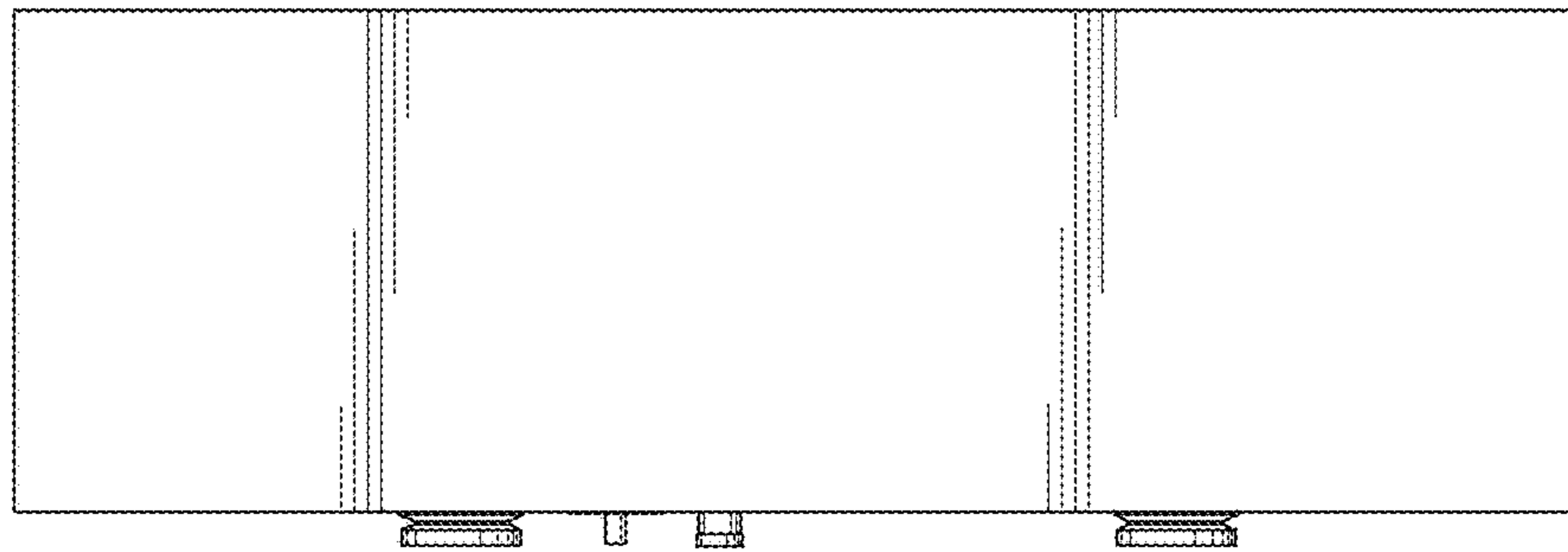

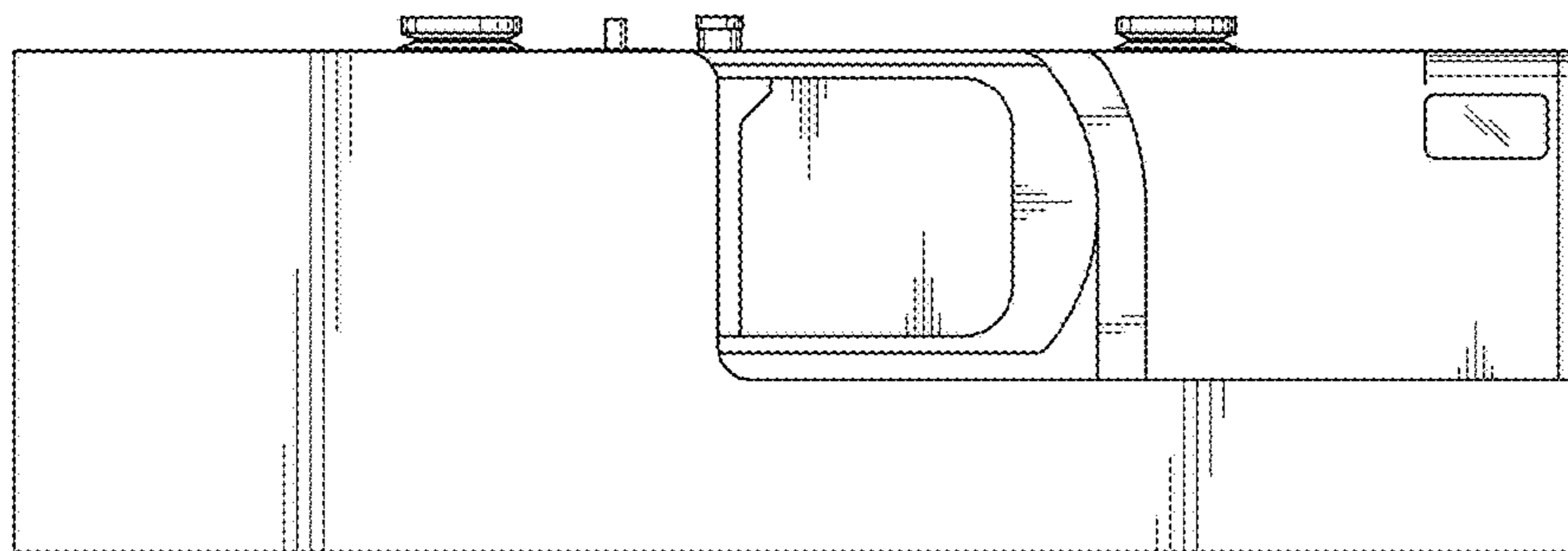
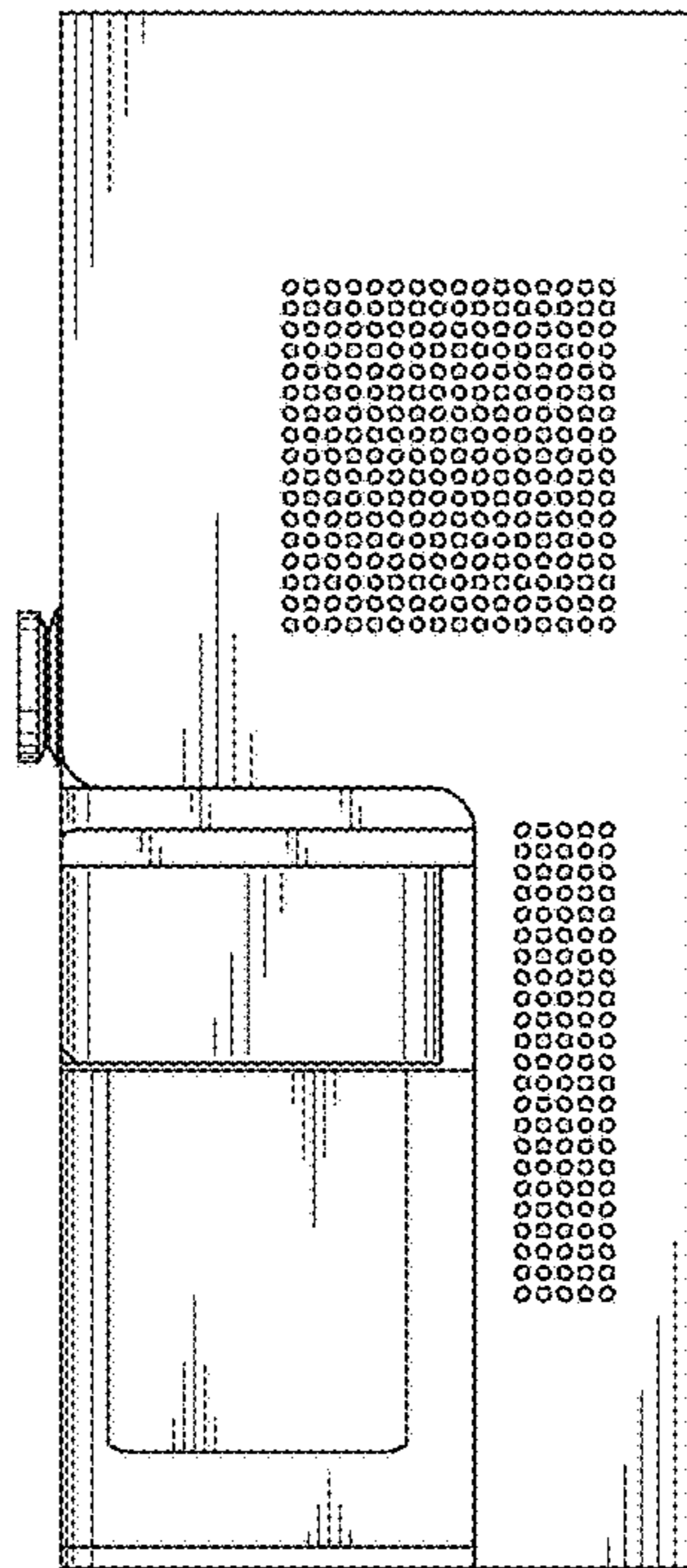
