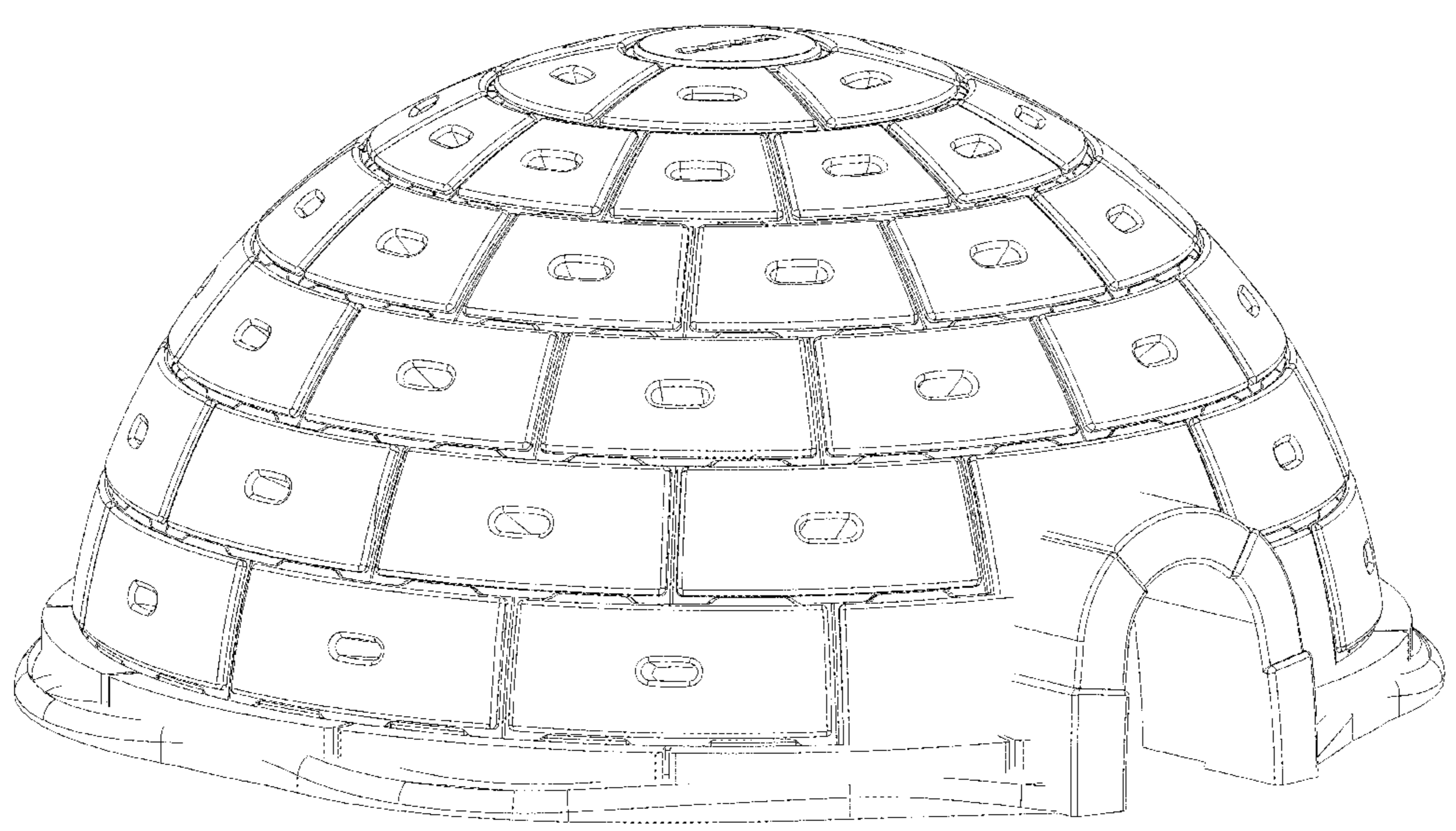

DESCRIPTION
 FIG. 1 is a perspective of equipment for a game, in accordance with the present invention, in a fully assembled configuration;
 FIG. 2 is a front view thereof;
 FIG. 3 is a right side view thereof, with the left side view being a mirror image;
 FIG. 4 is a top view thereof;
 FIG. 5 is a bottom view thereof;
 FIG. 6 is a perspective view with some brick components removed; and,
 FIG. 7 is a perspective view with all brick components removed.

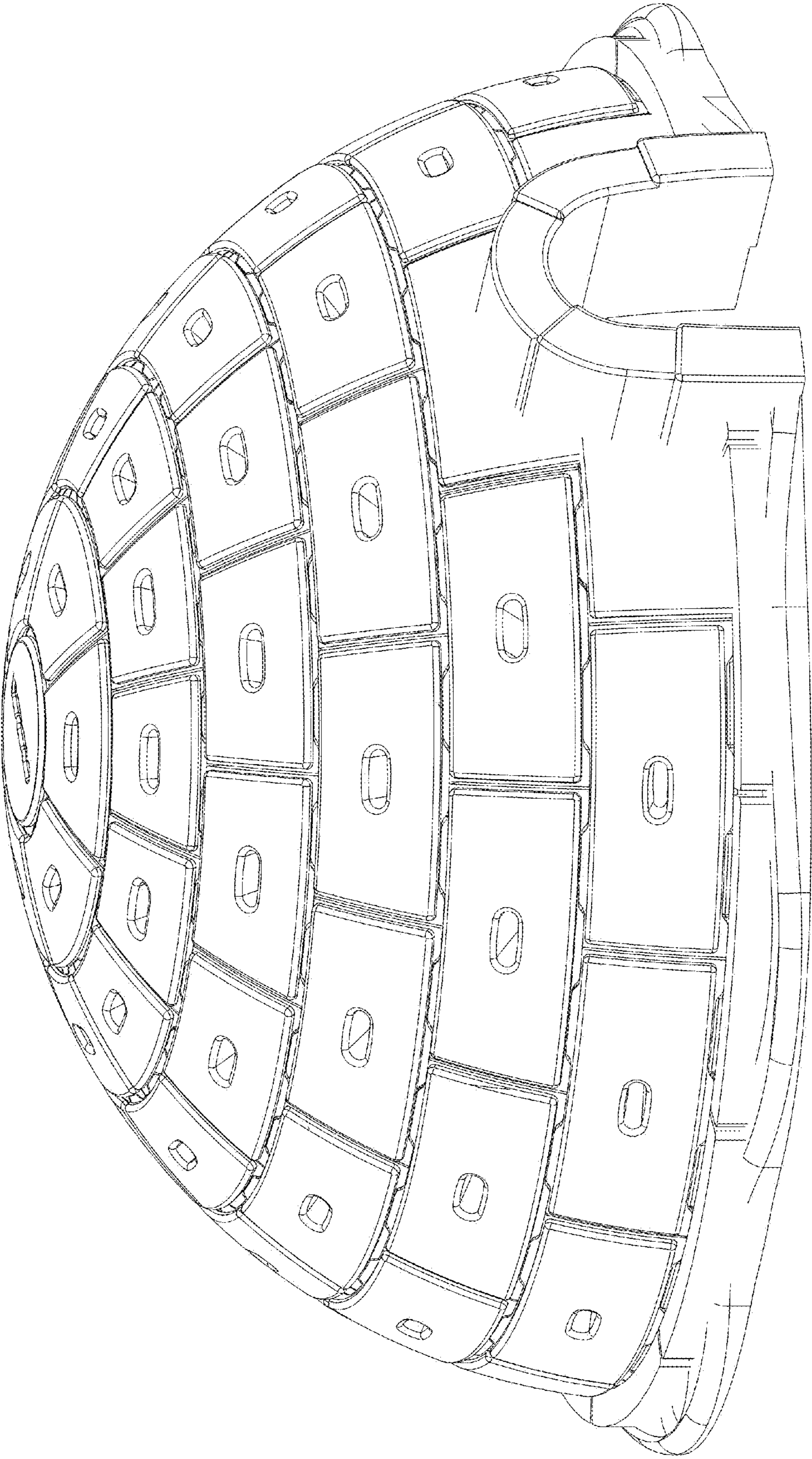

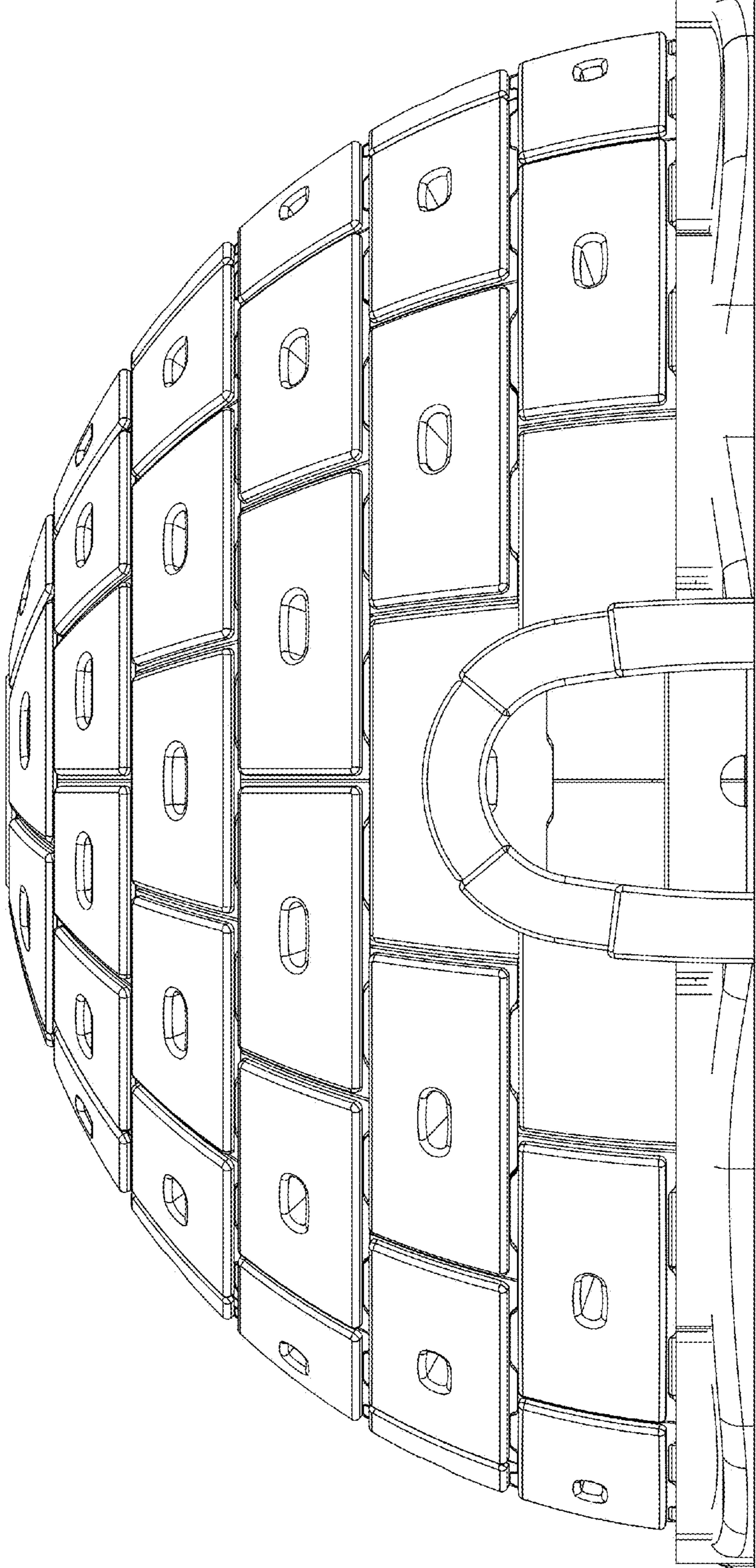

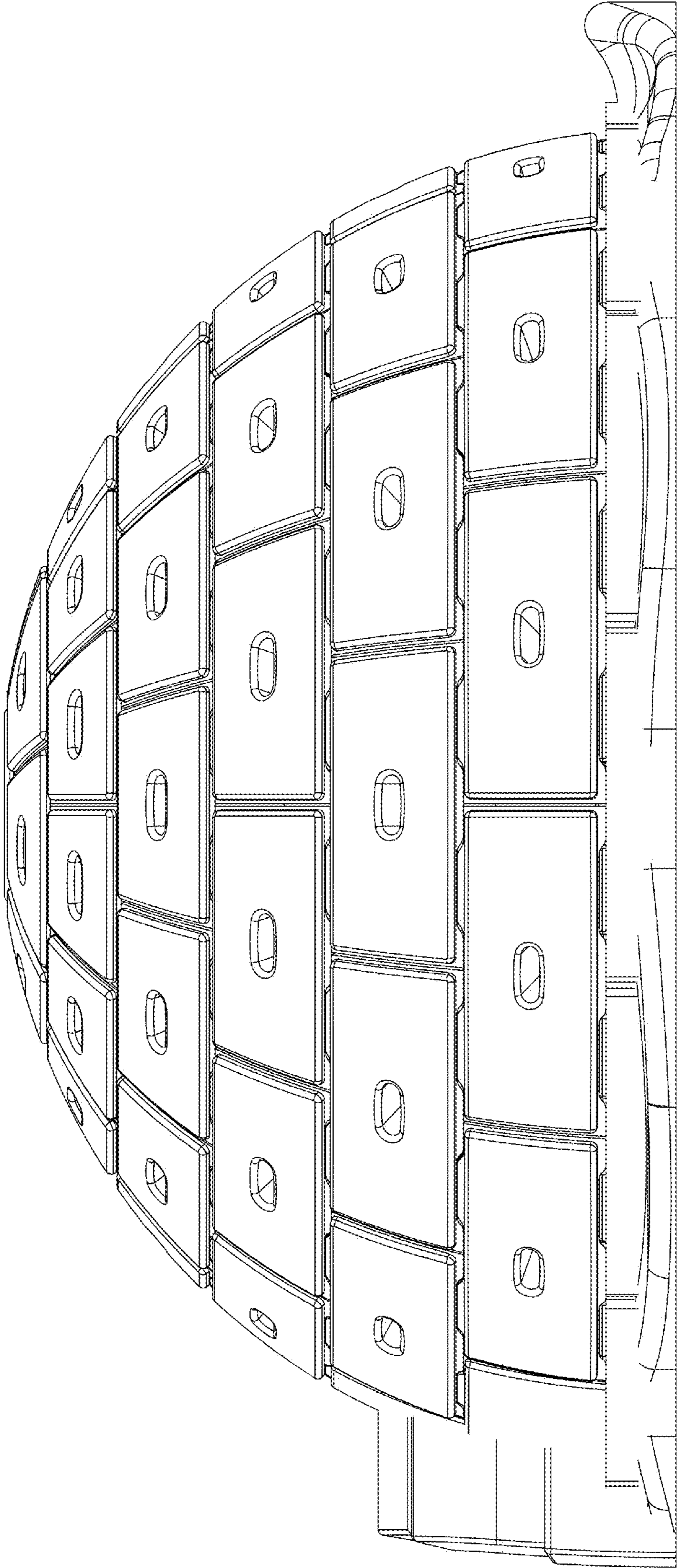

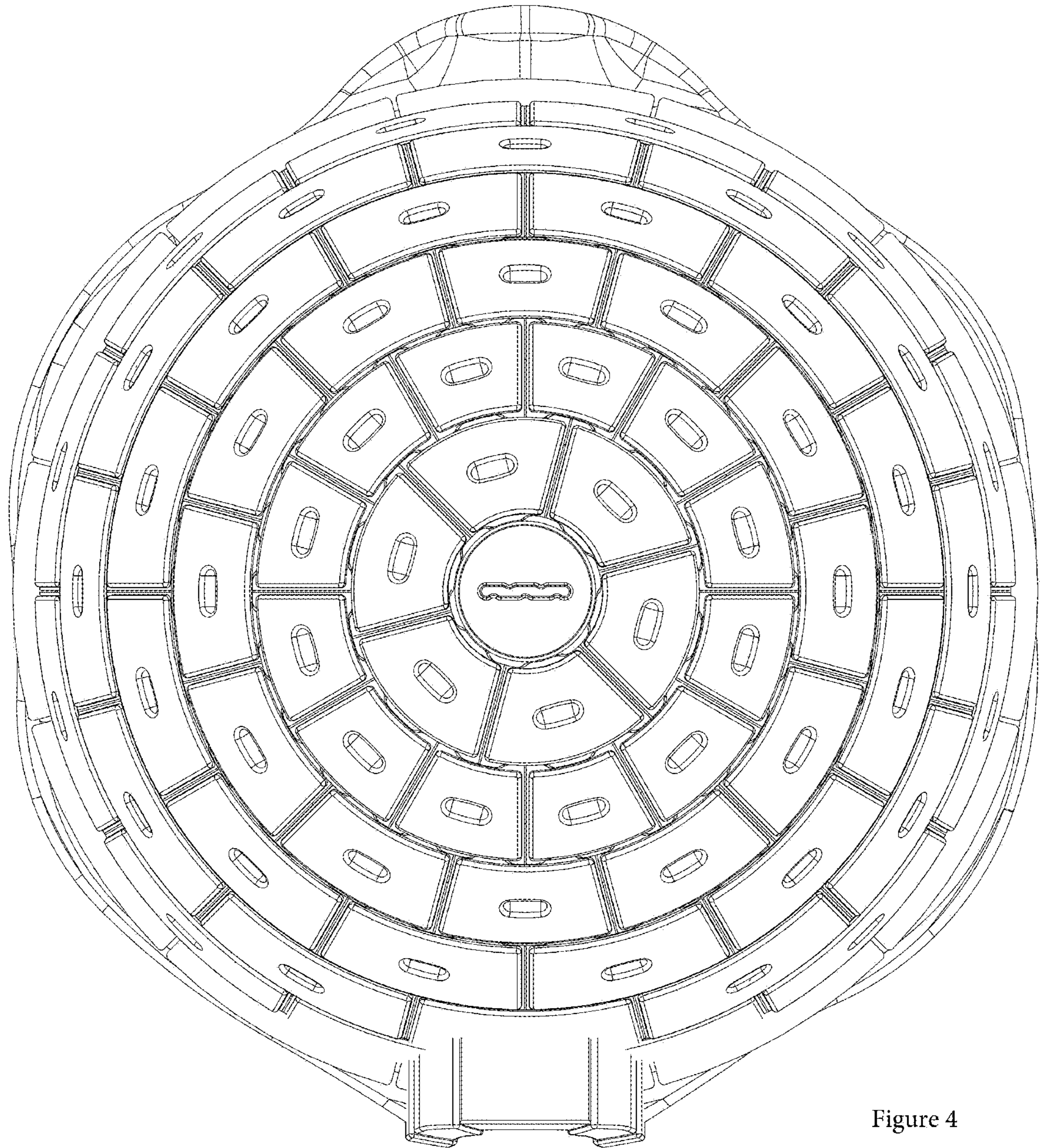

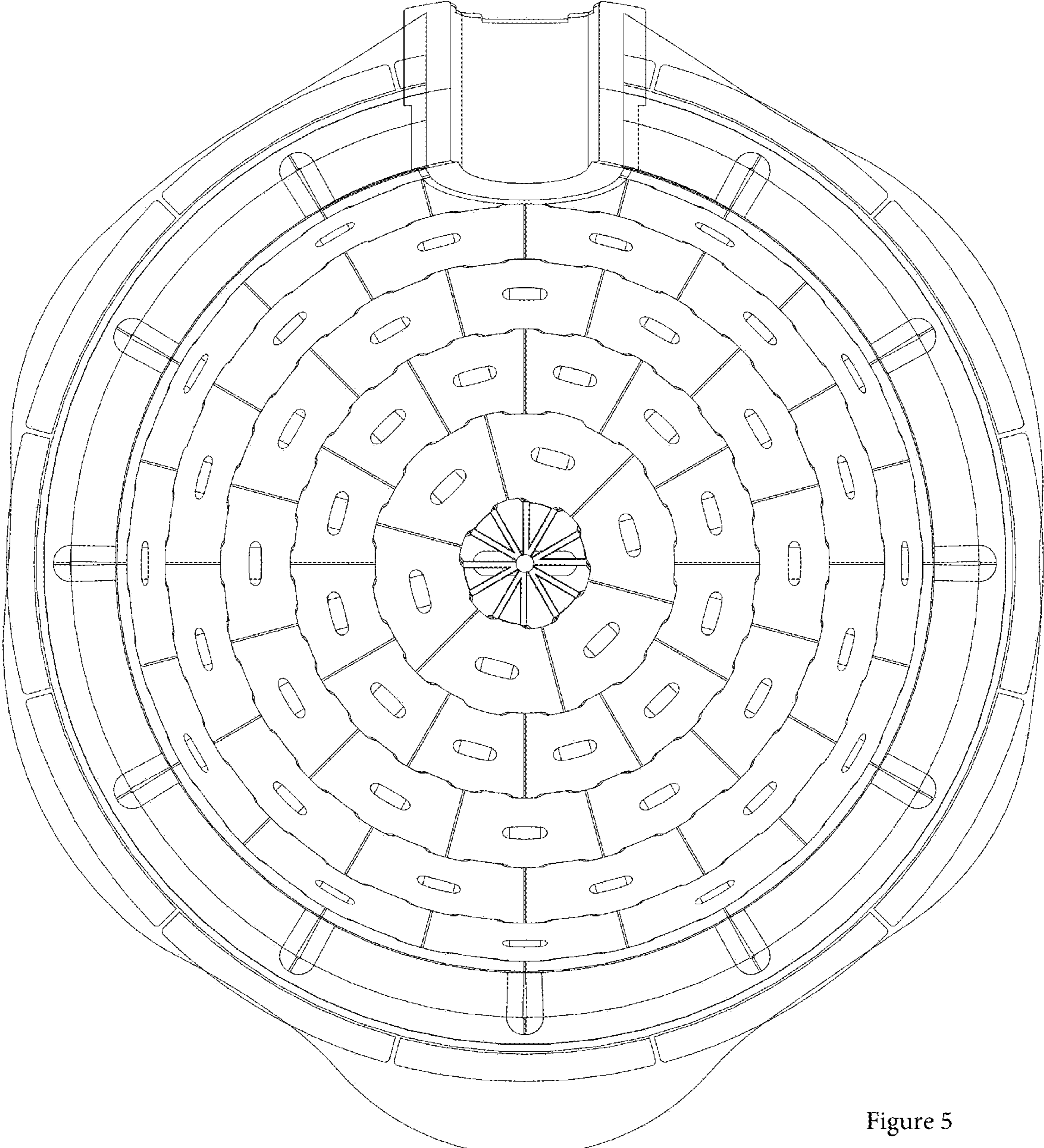

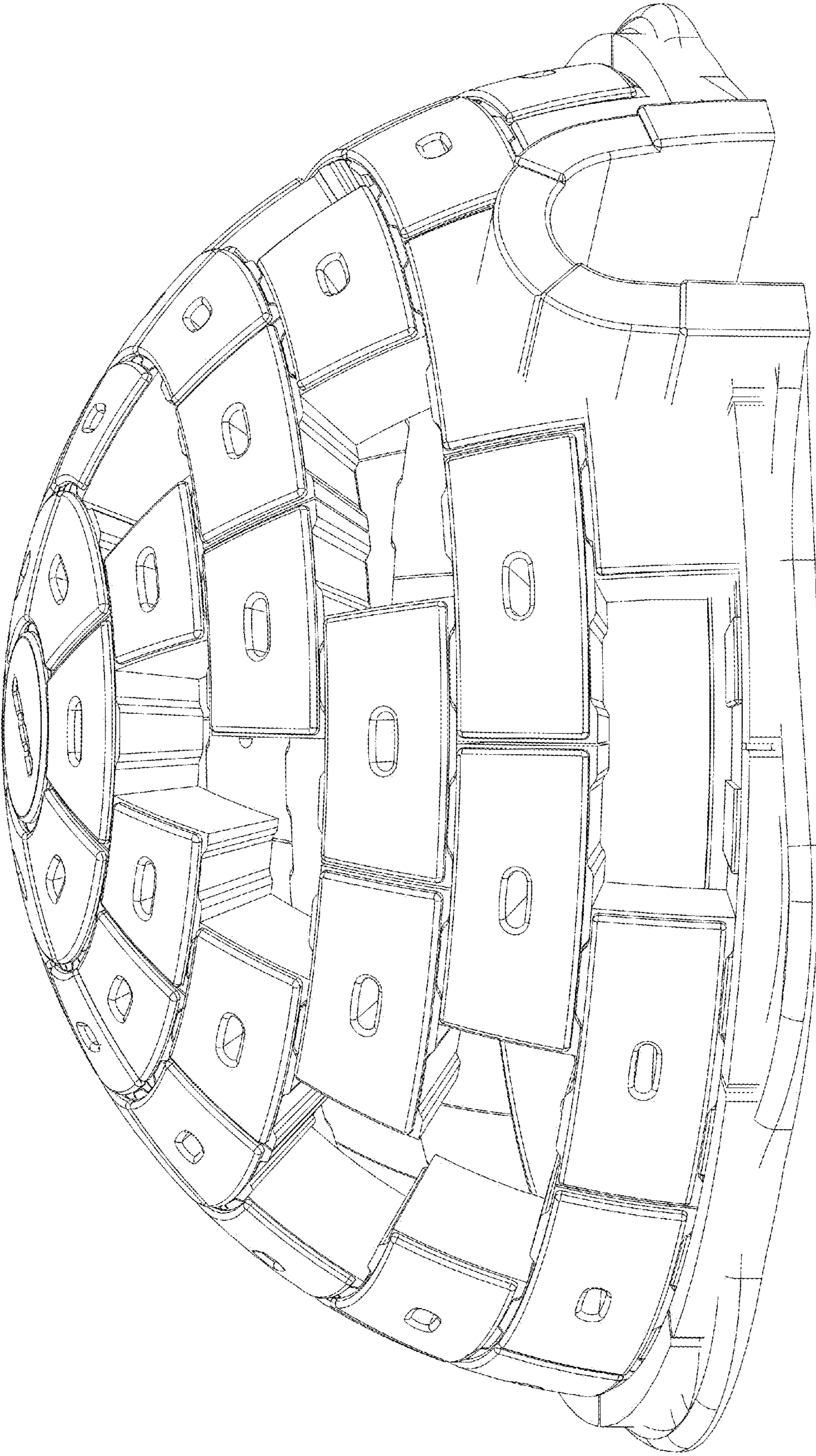

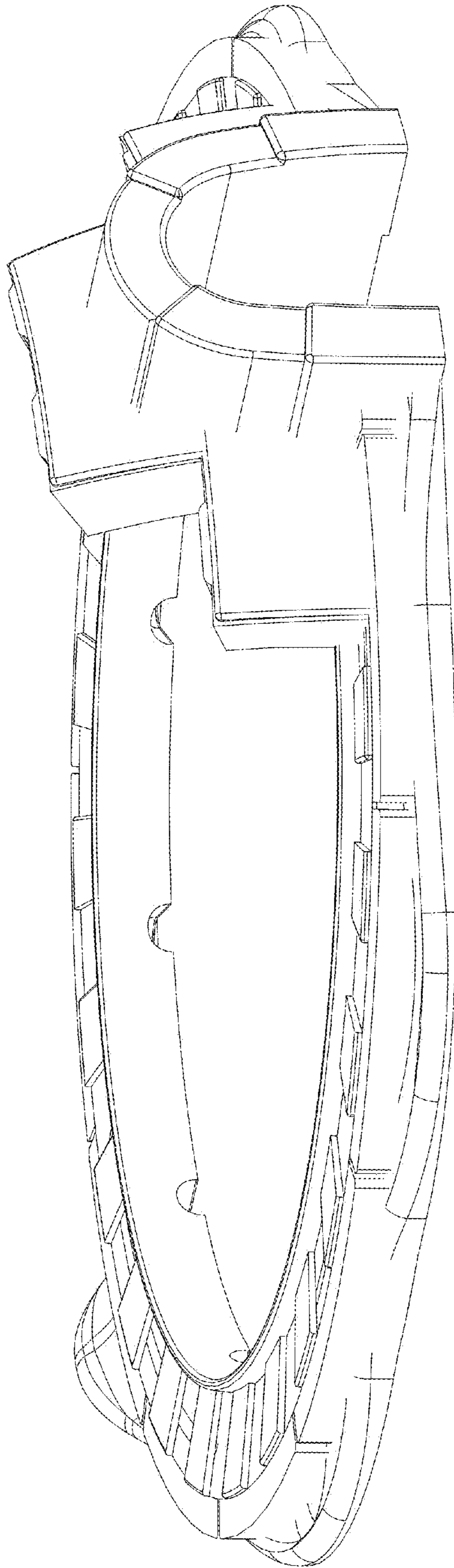
