FIG. 5 is a left side elevation view of FIG. 1

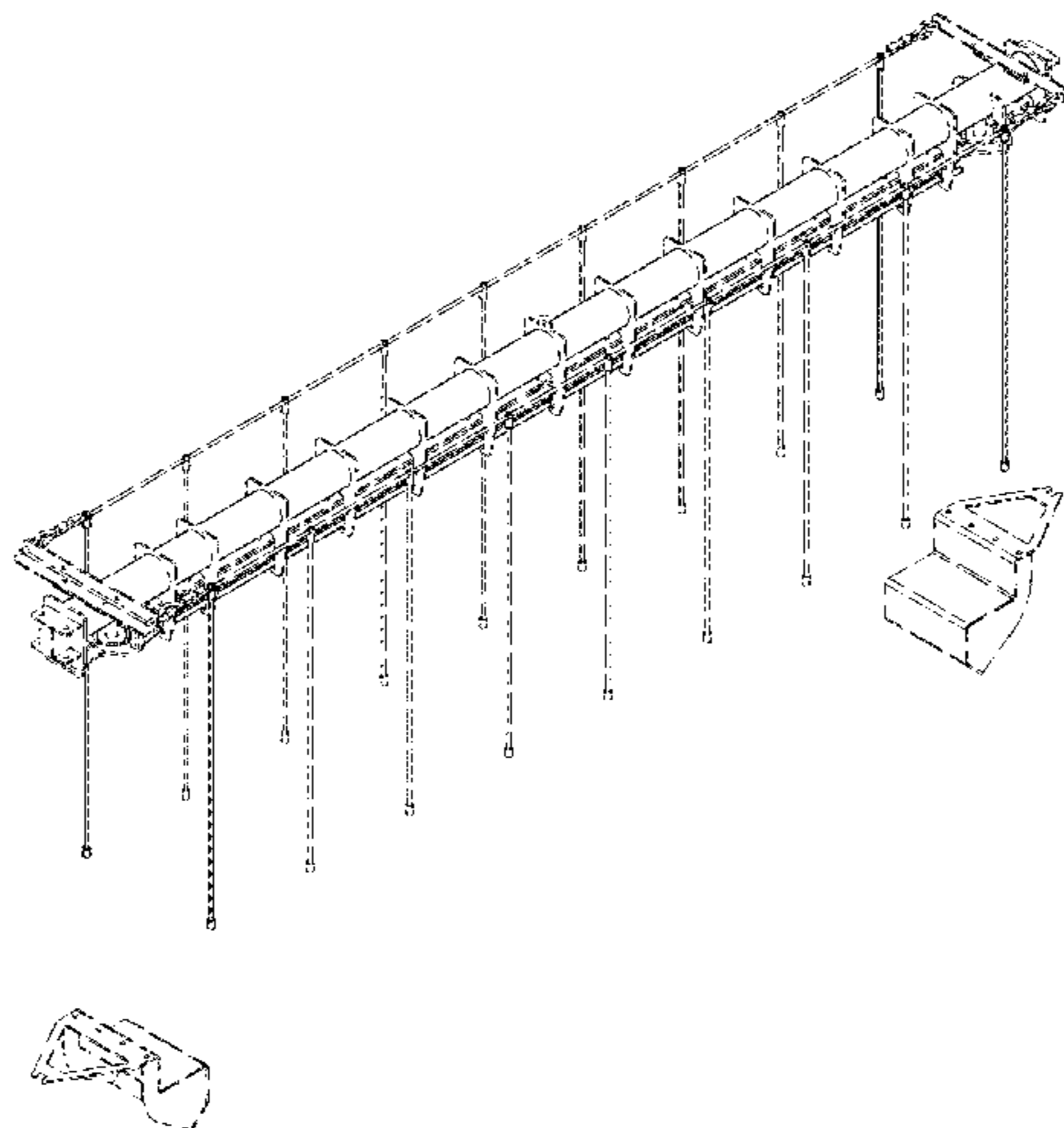
FIG. 6 is a right side elevation view of FIG. 1.

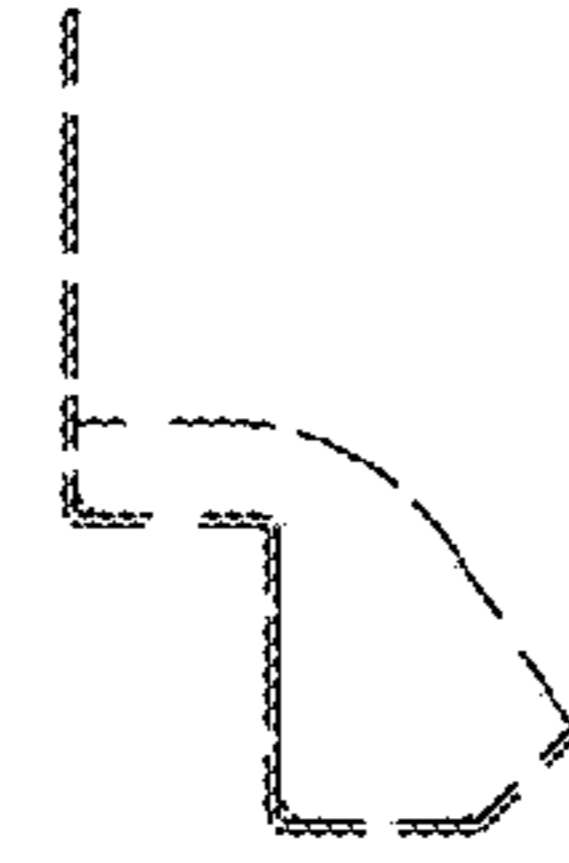
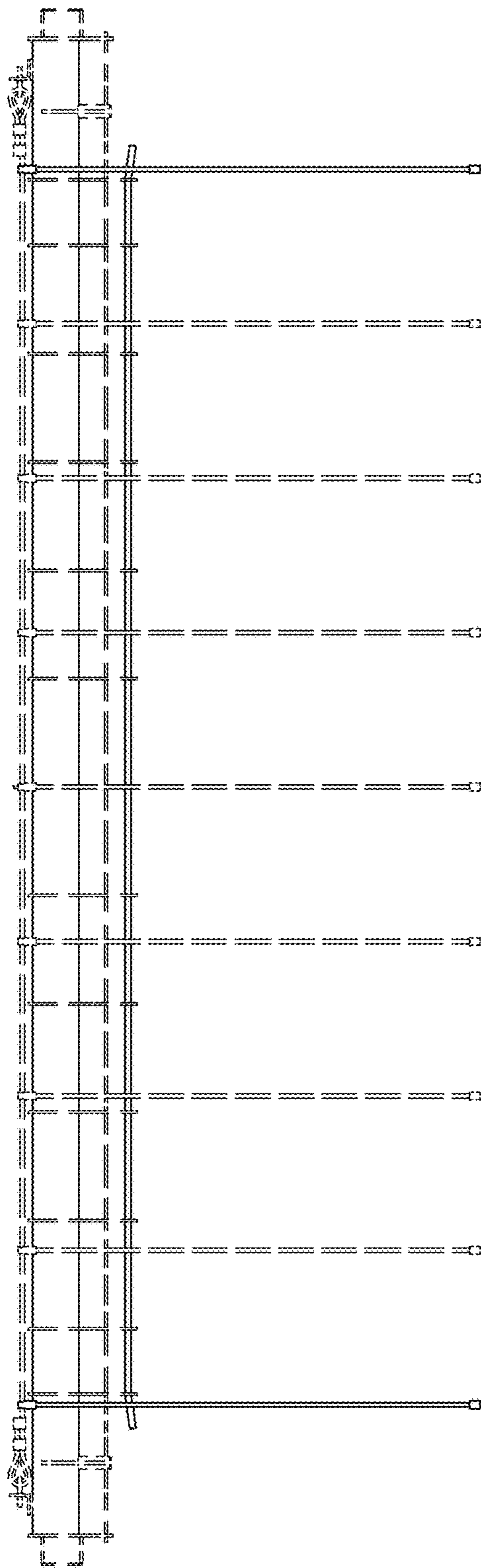

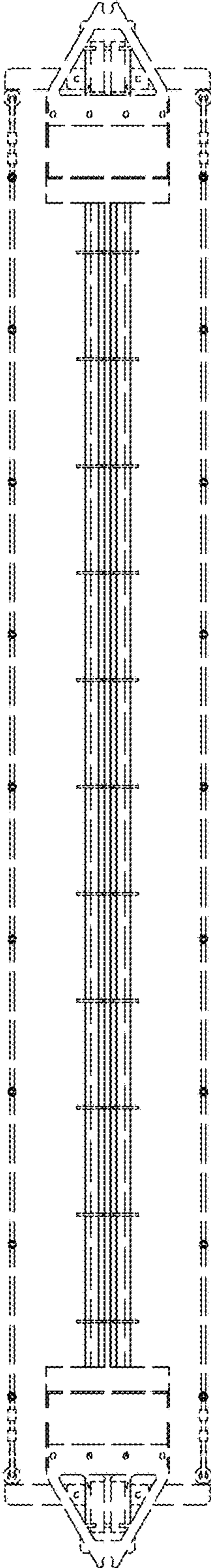

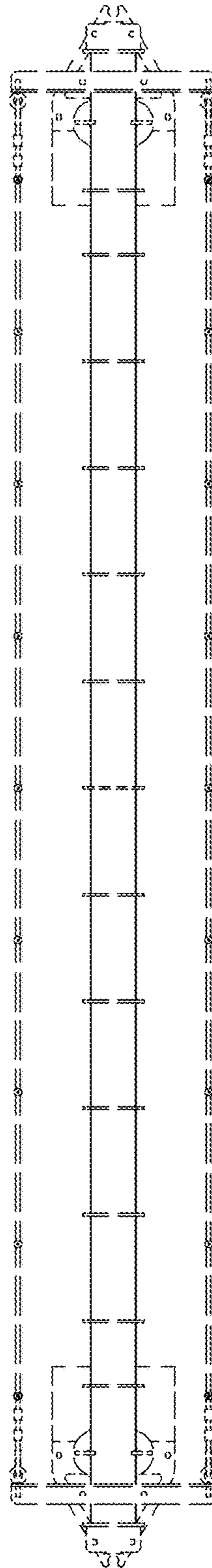

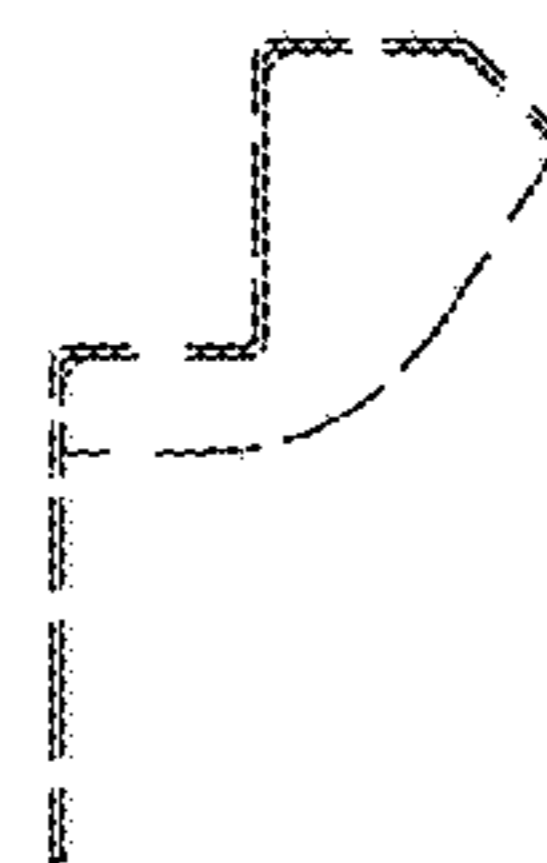
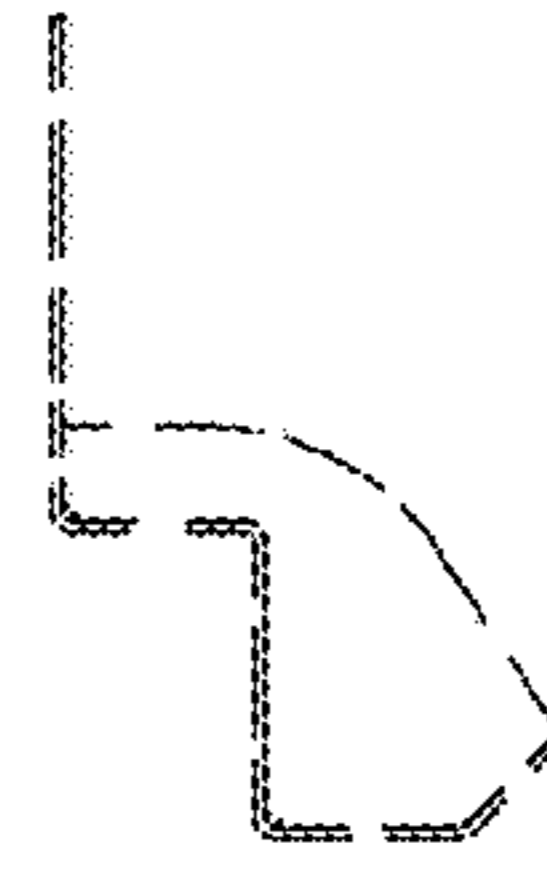
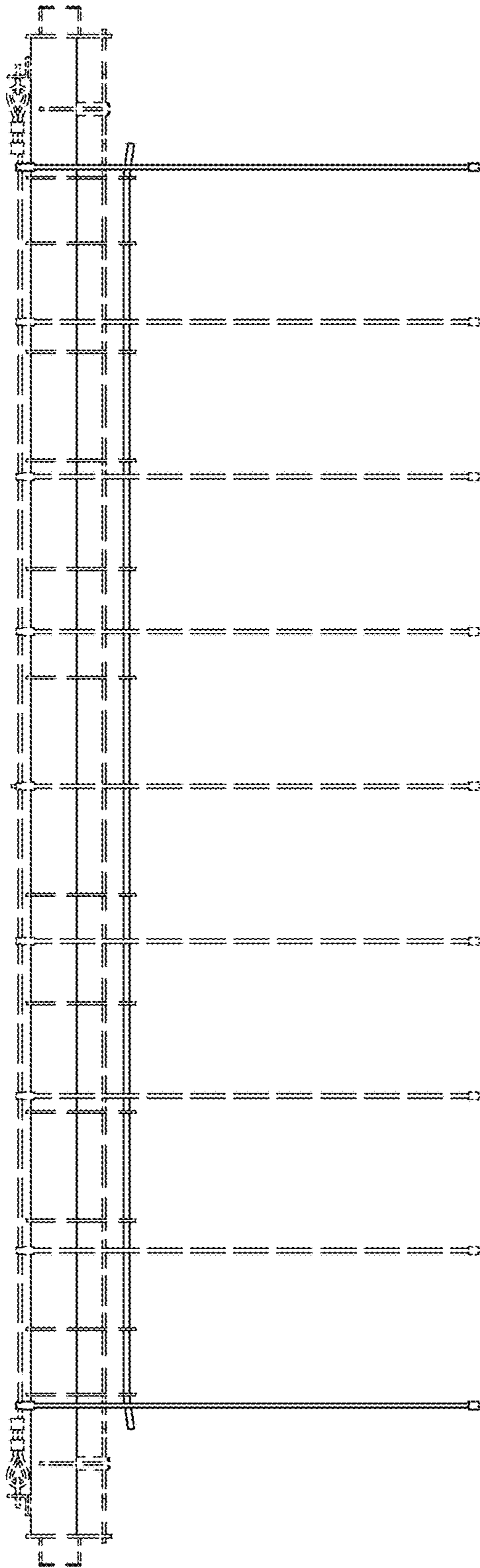

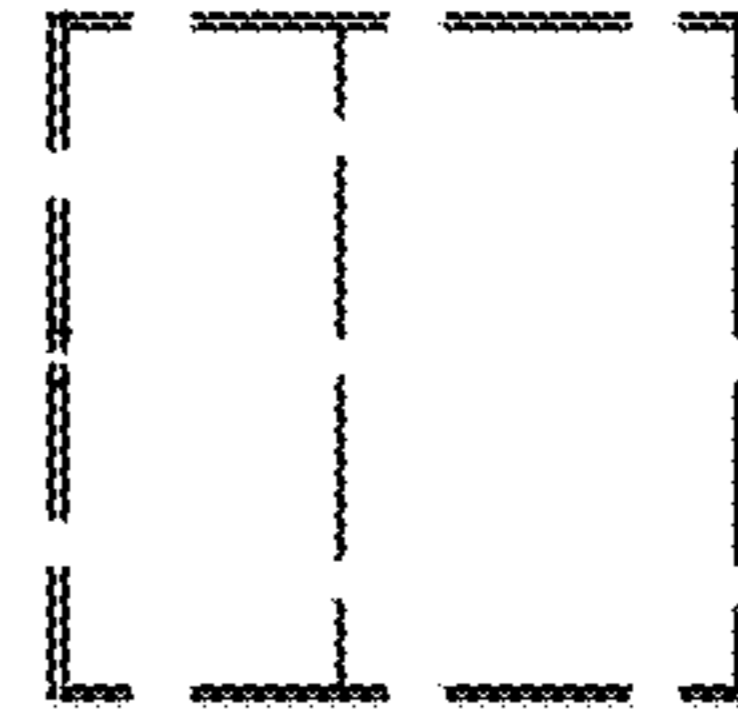
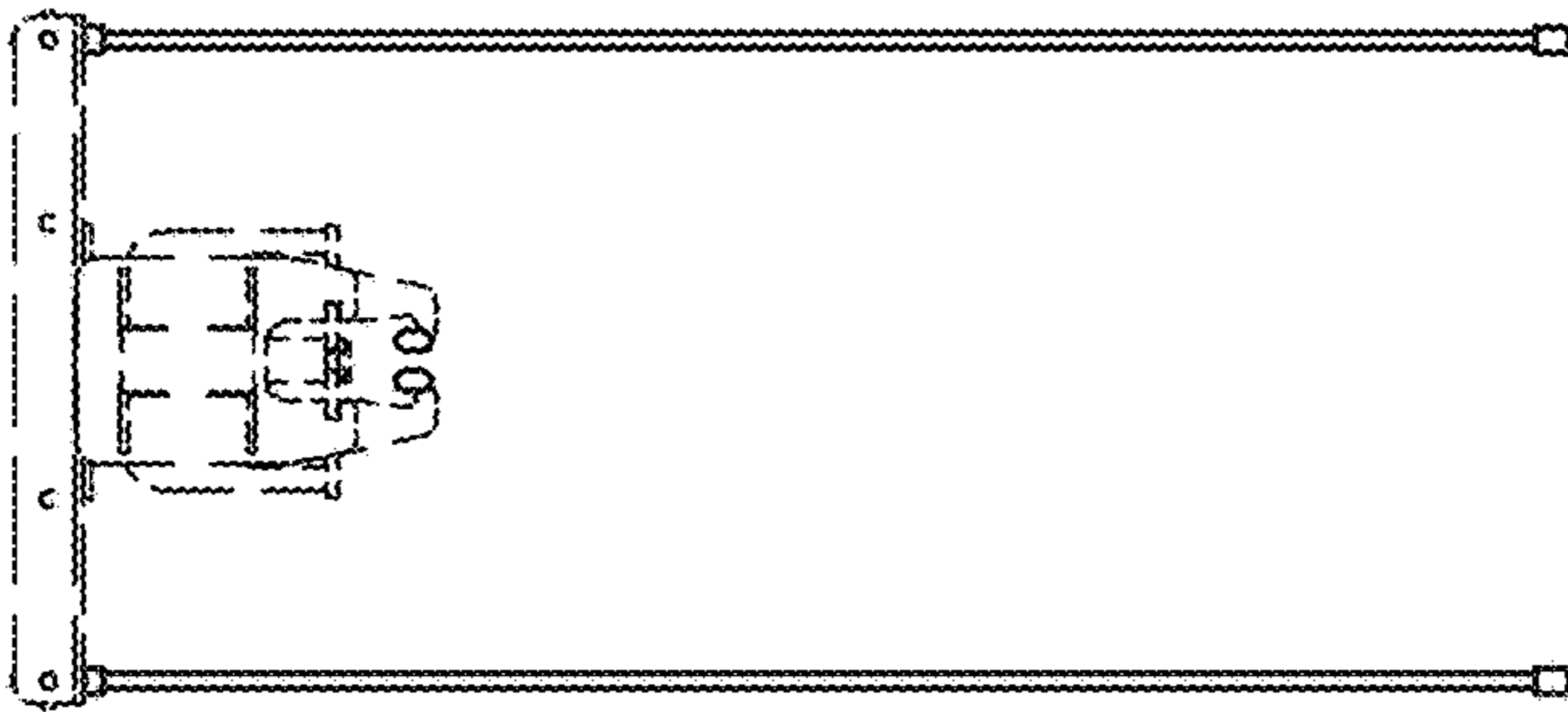

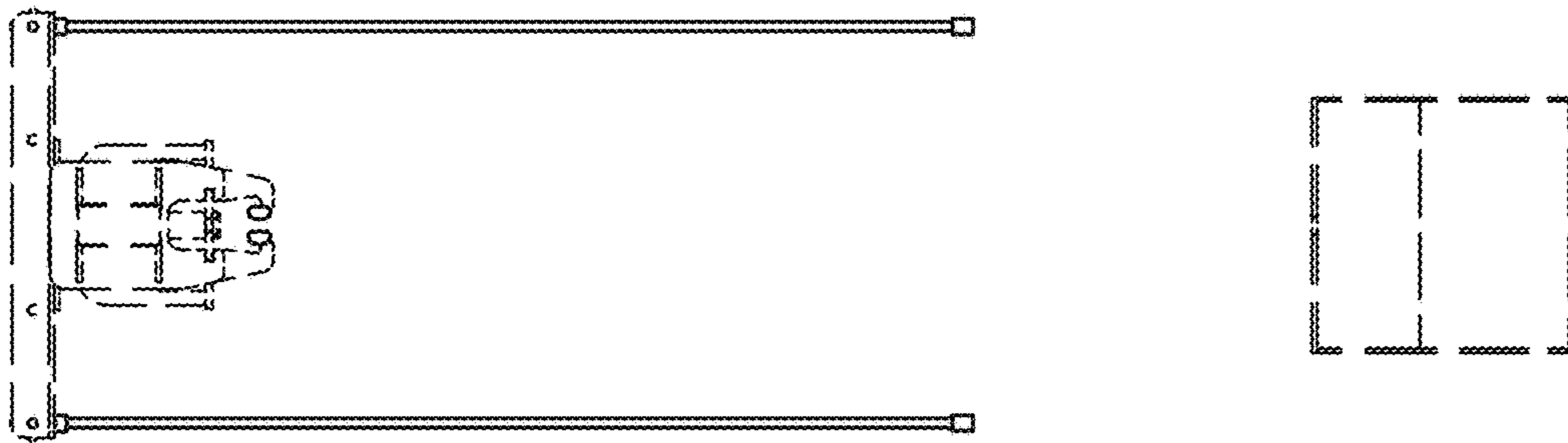

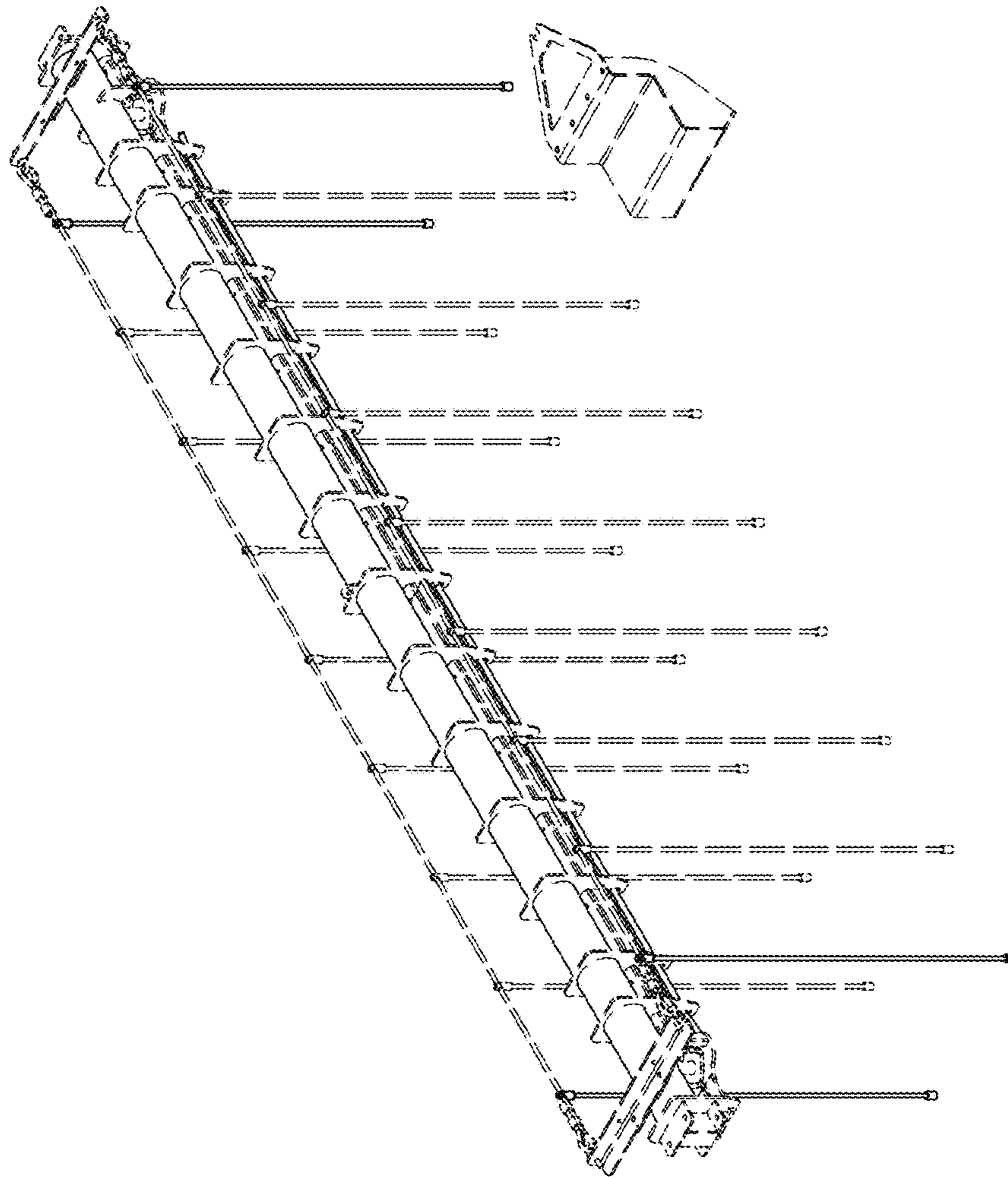

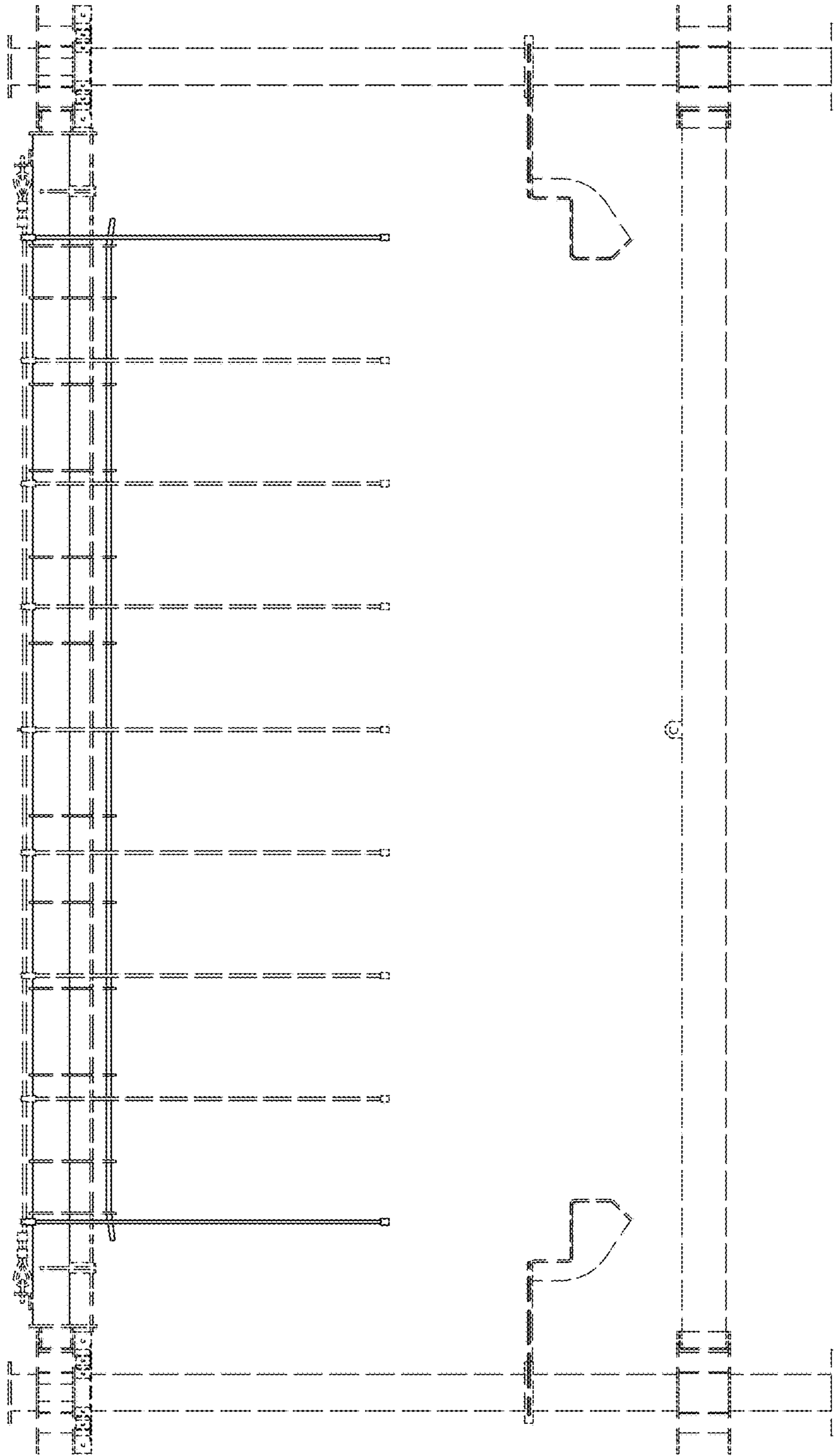
