(57) **CLAIM**

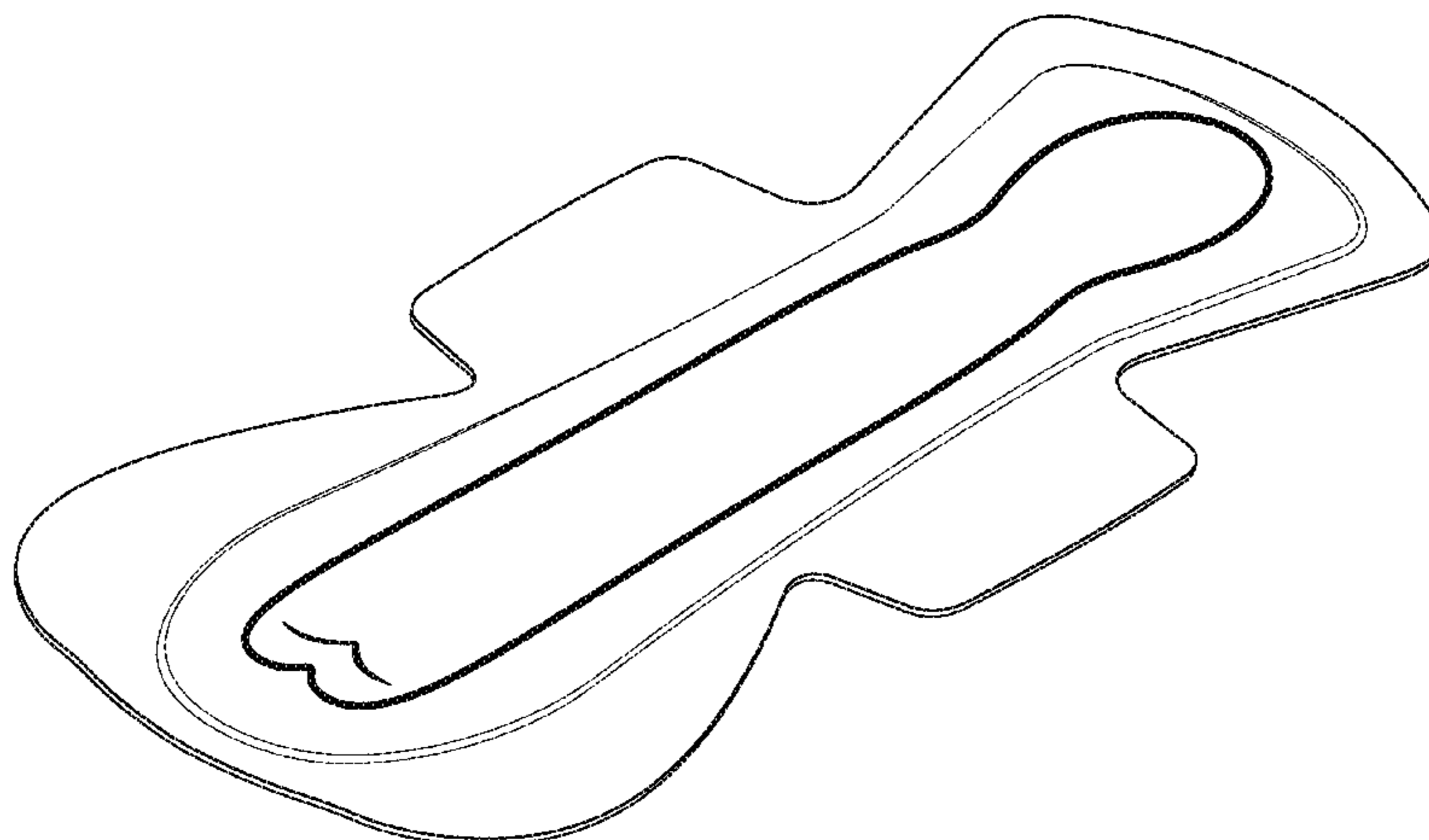
The ornamental design for a sanitary article, as shown and described.

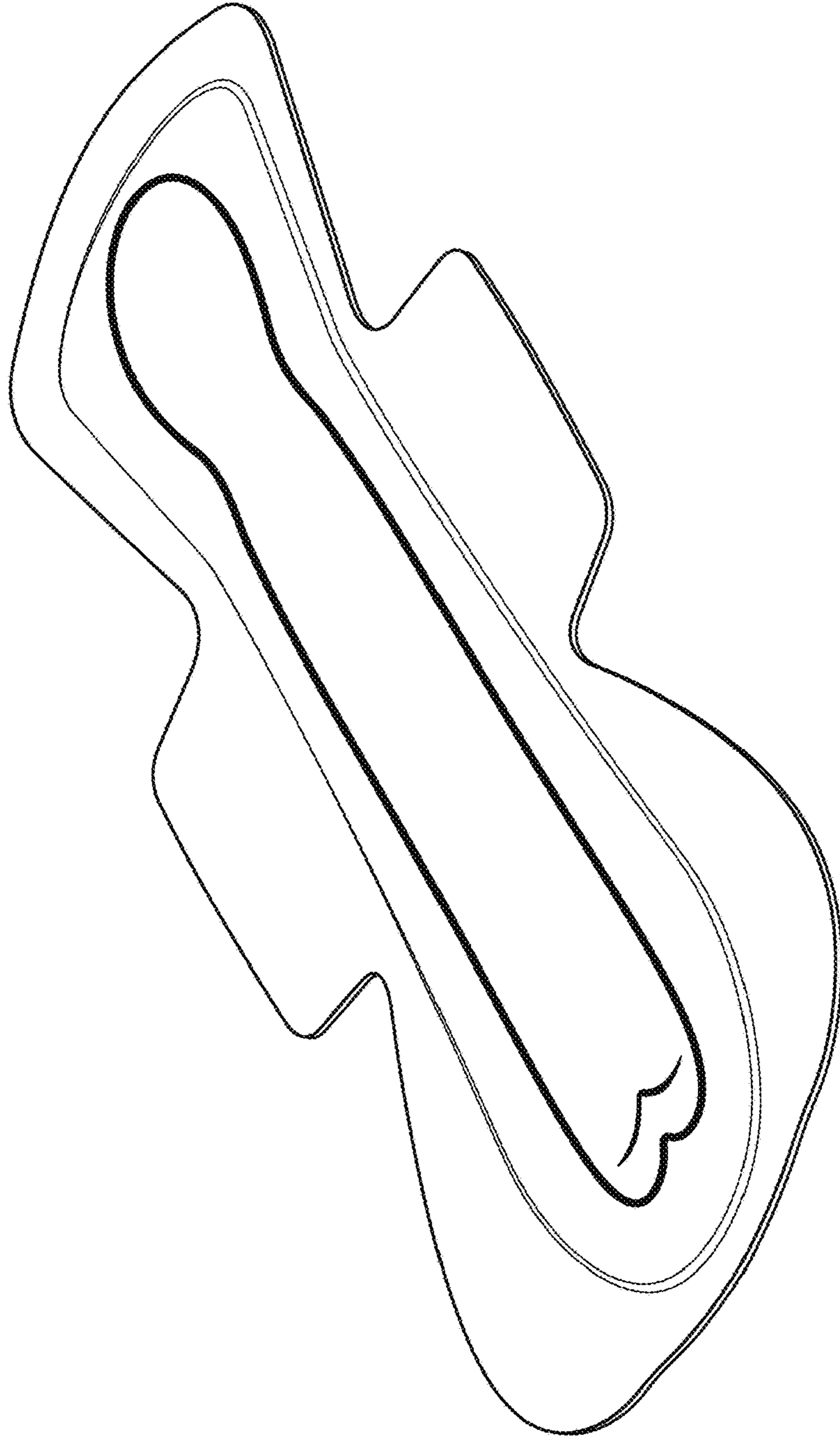

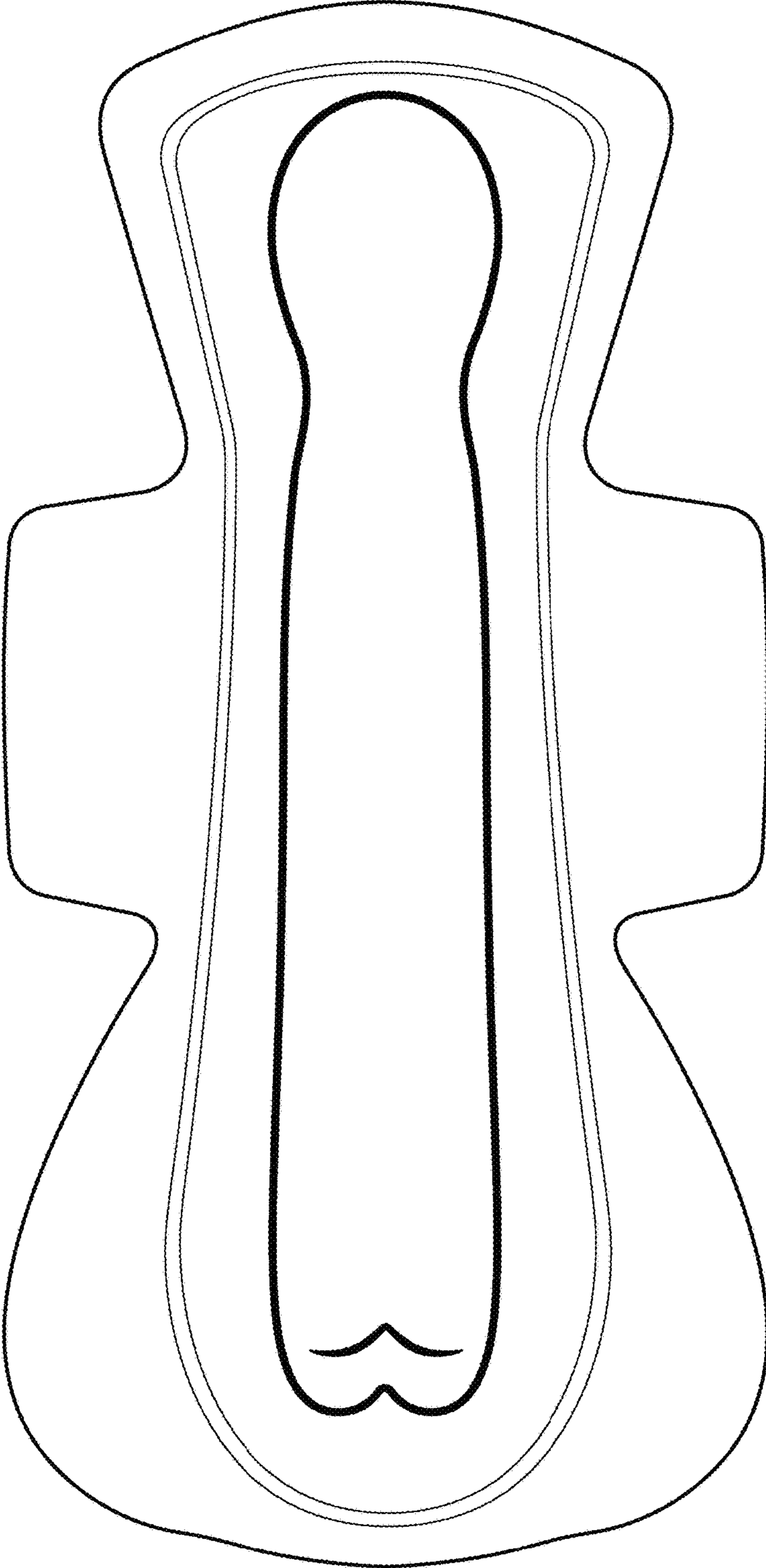

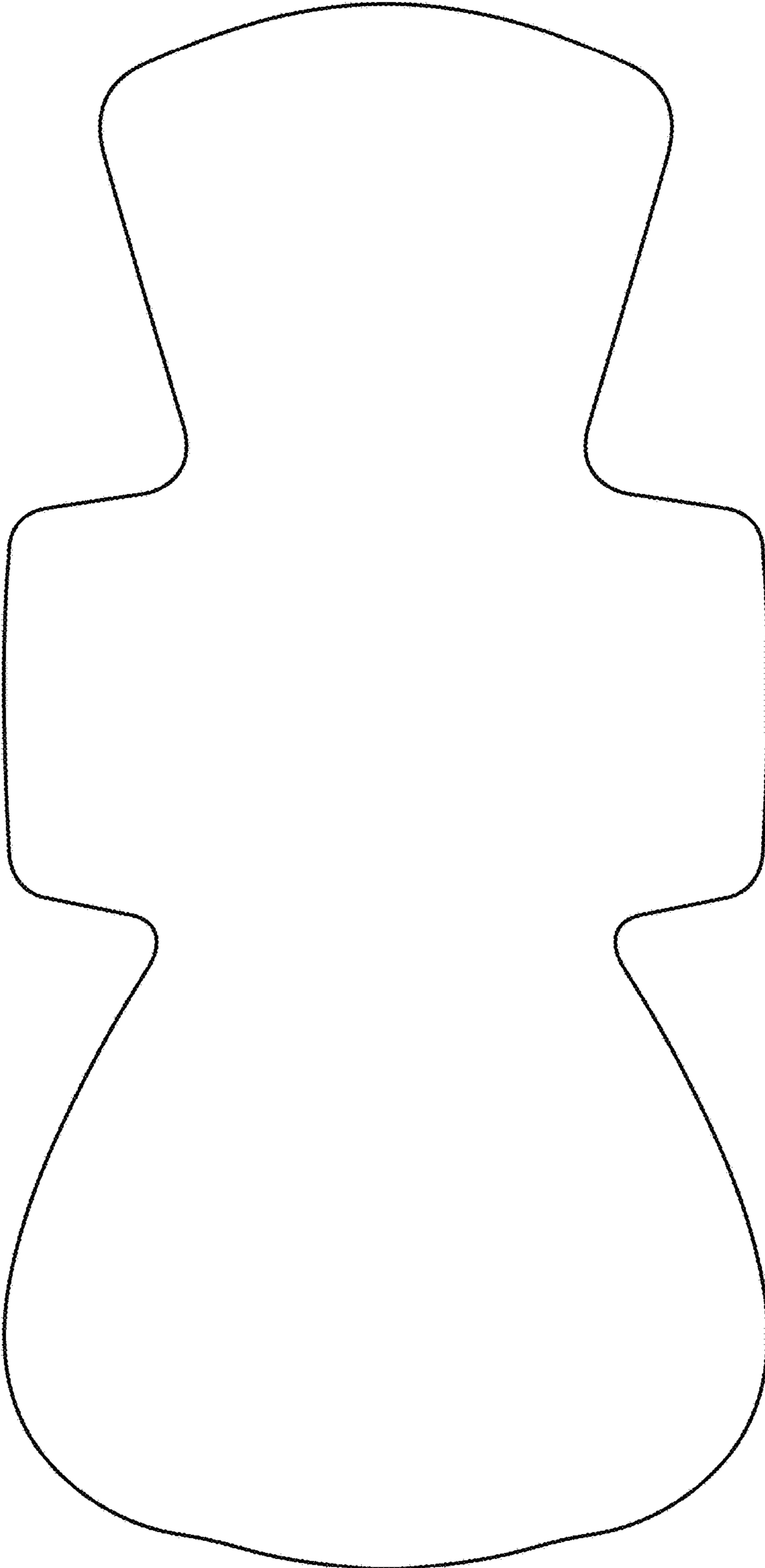

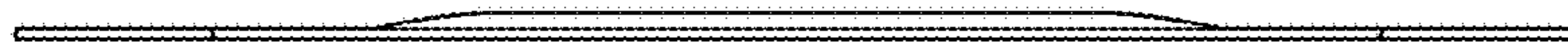

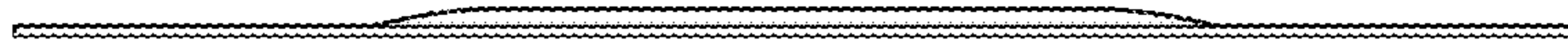
