(57) **CLAIM**

The ornamental design for a forceps and forceps insert, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a forceps and forceps insert according to an embodiment of the present invention. FIG. 2 is a front view of the forceps and forceps insert of FIG. 1.

FIG. 3 is a rear view of the forceps and forceps insert of FIG. 1.

FIG. 4 is a left side view of the forceps and forceps insert of FIG. 1.

FIG. 5 is a right side view of the forceps and forceps insert of FIG. 1.

FIG. 6 is a top view of the forceps and forceps insert of FIG. 1.

FIG. 7 is a bottom view of the forceps and forceps insert of FIG. 1.

FIG. 8 is an enlarged front perspective view of the forceps insert according to FIG. 1.

FIG. 9 is a front view of the forceps insert of FIG. 8.

FIG. 10 is a rear view of the forceps insert of FIG. 8.

FIG. 11 is a left side view of the forceps insert of FIG. 8.

FIG. 12 is a right side view of the forceps insert of FIG. 8.

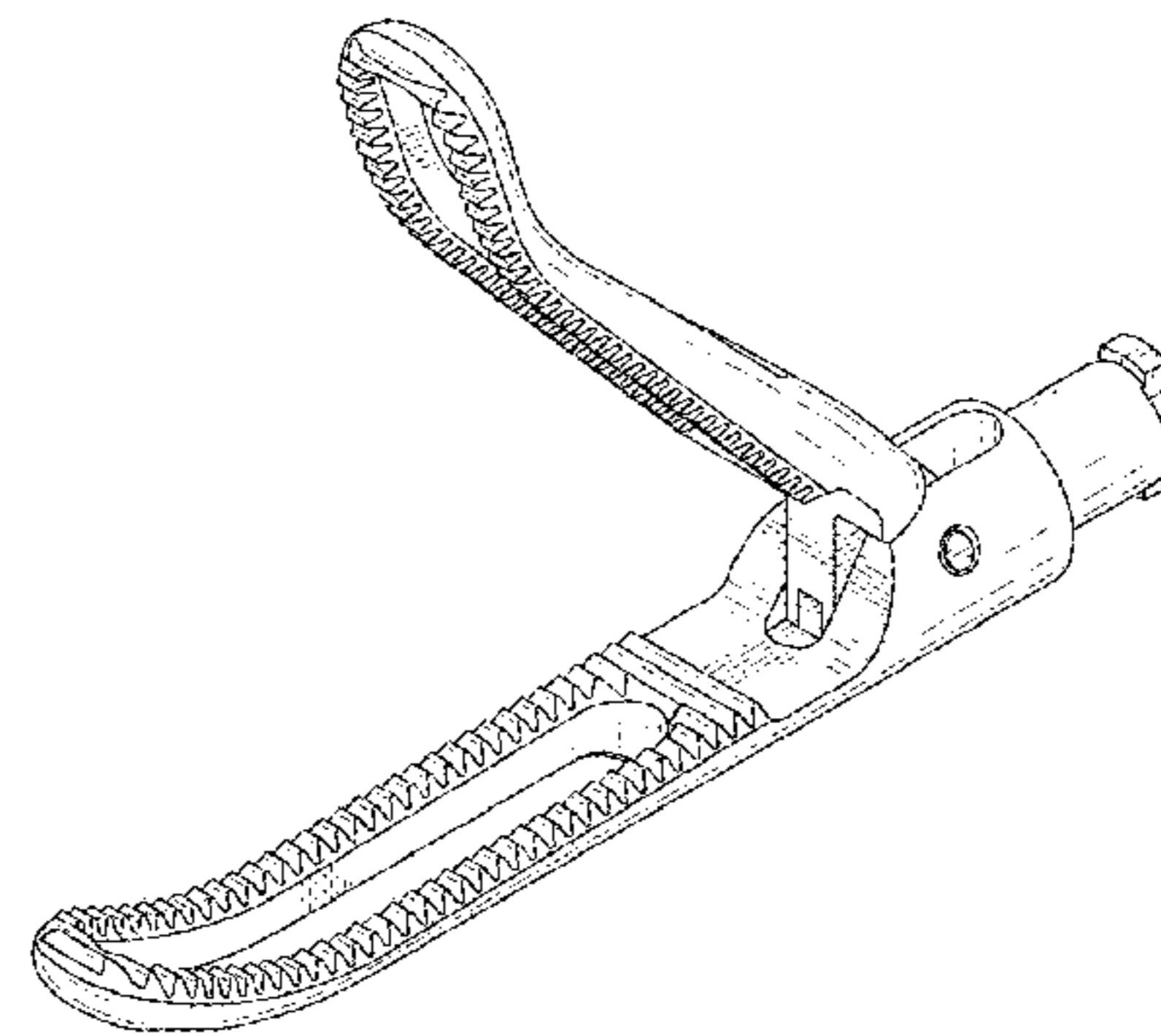
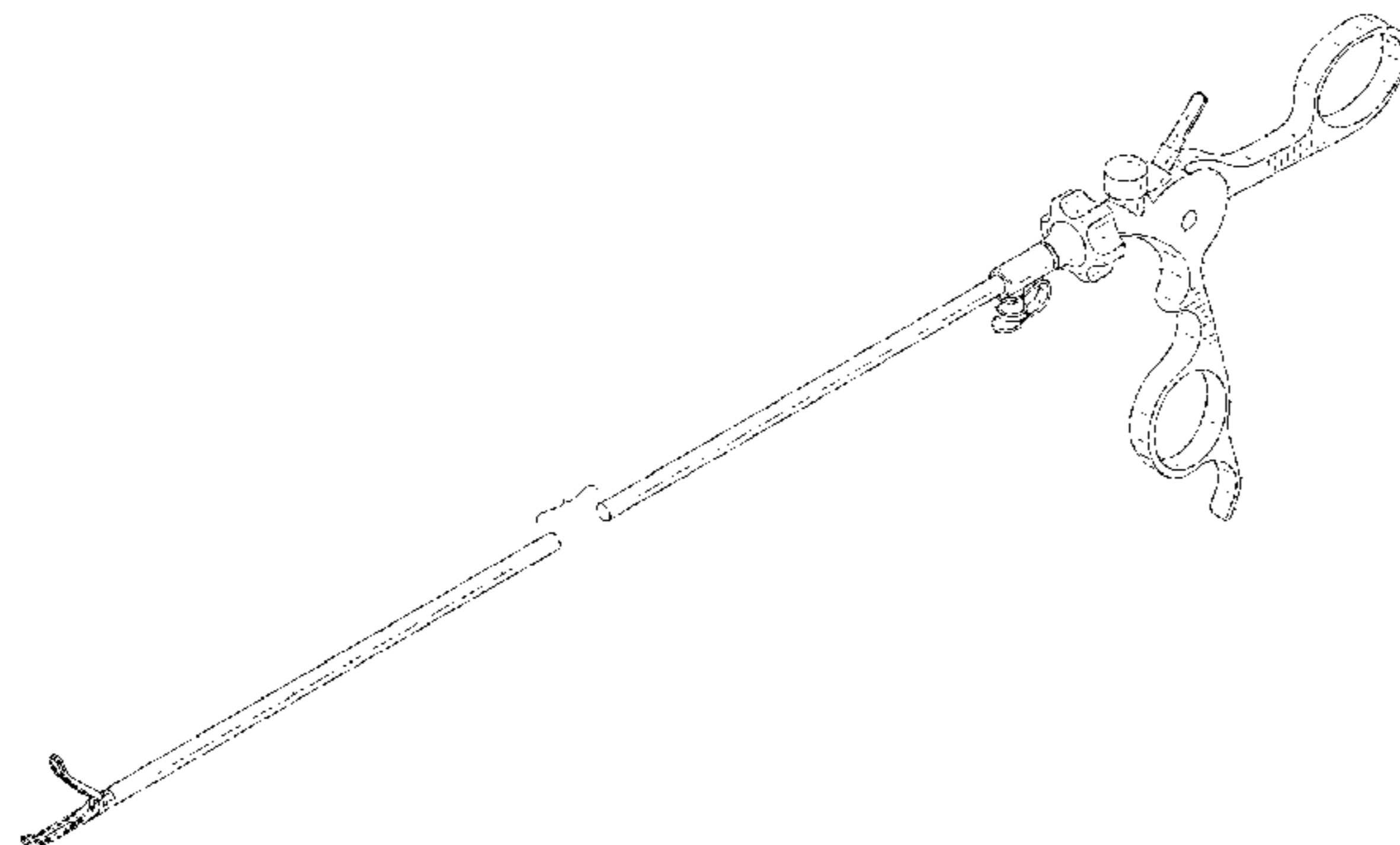
FIG. 13 is a top view of the forceps insert of FIG. 8; and,

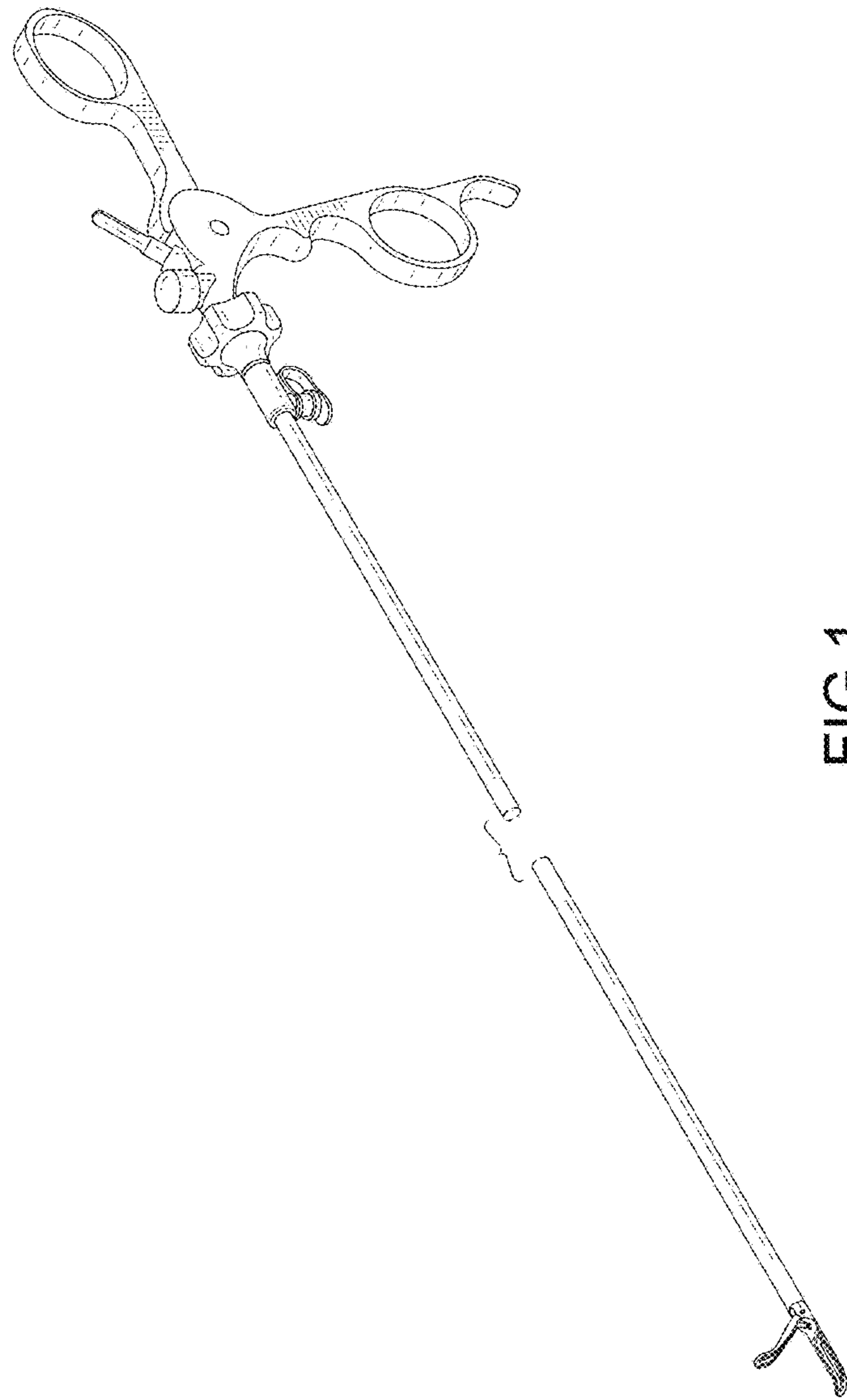

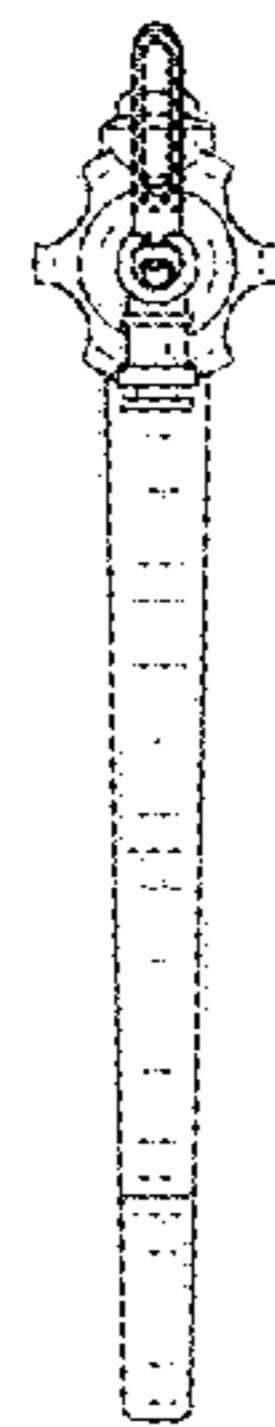

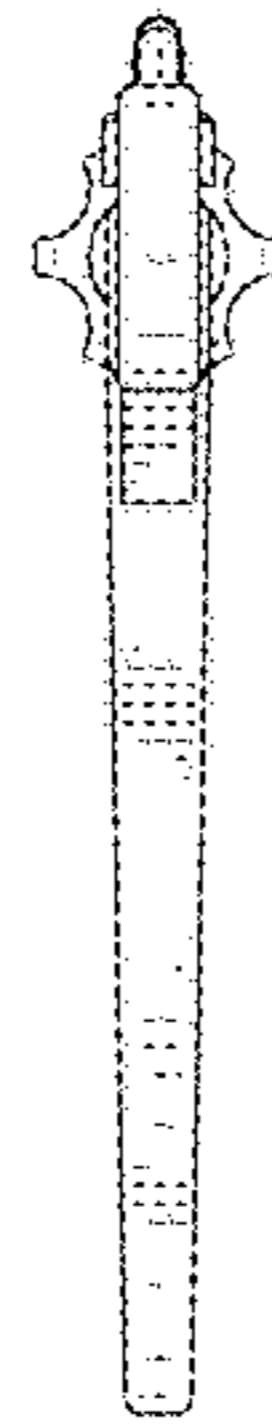

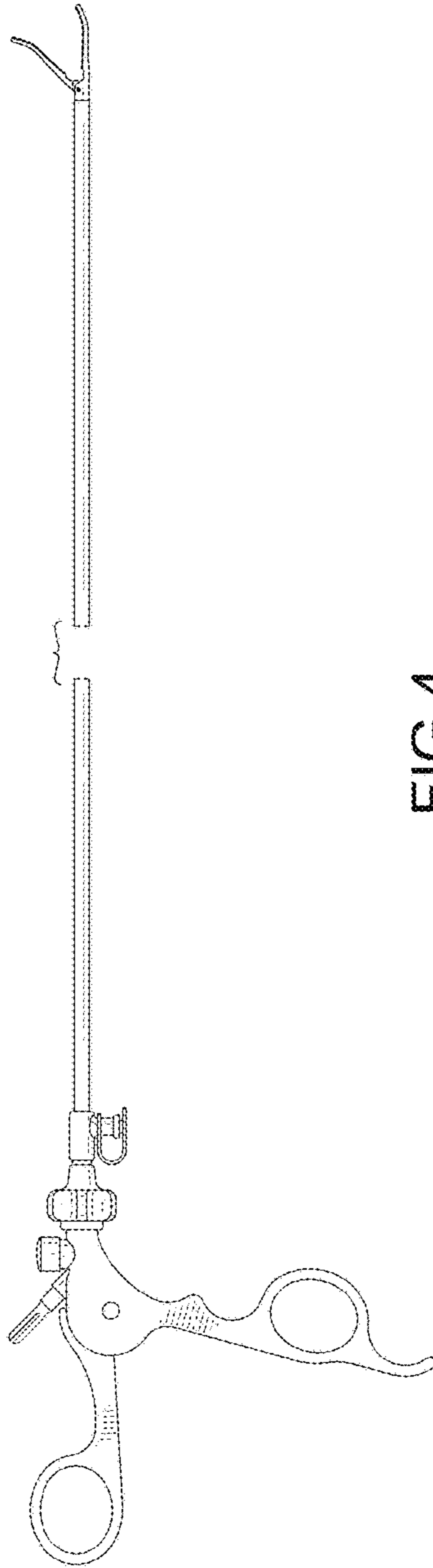

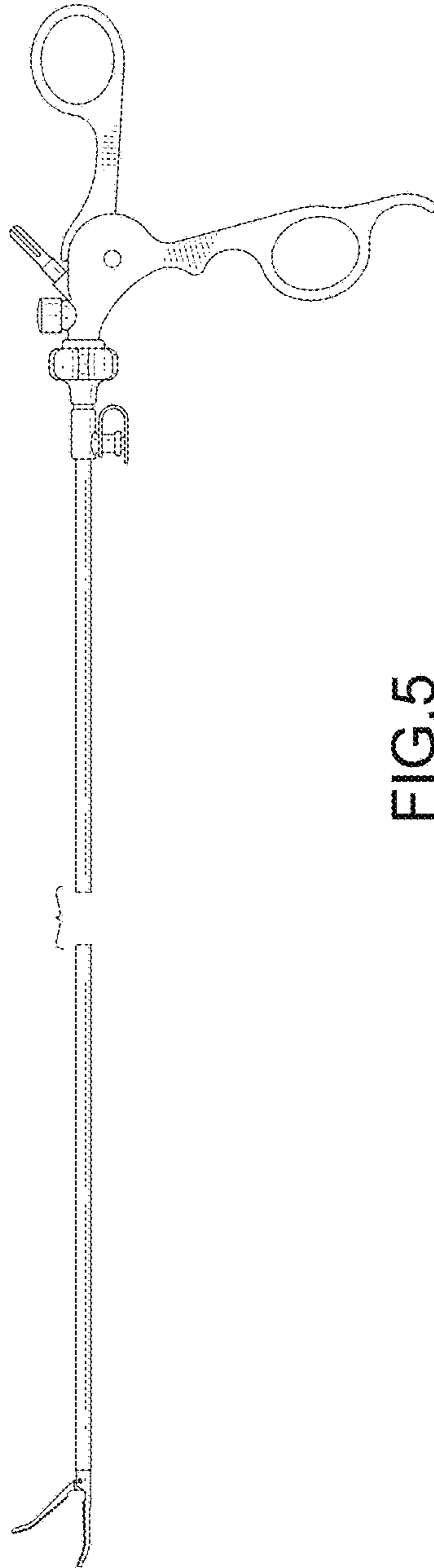

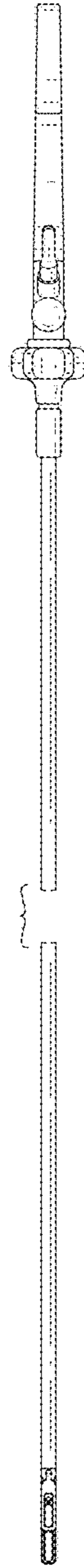

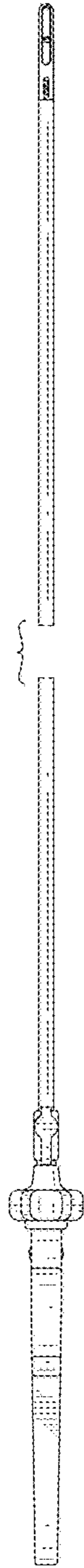

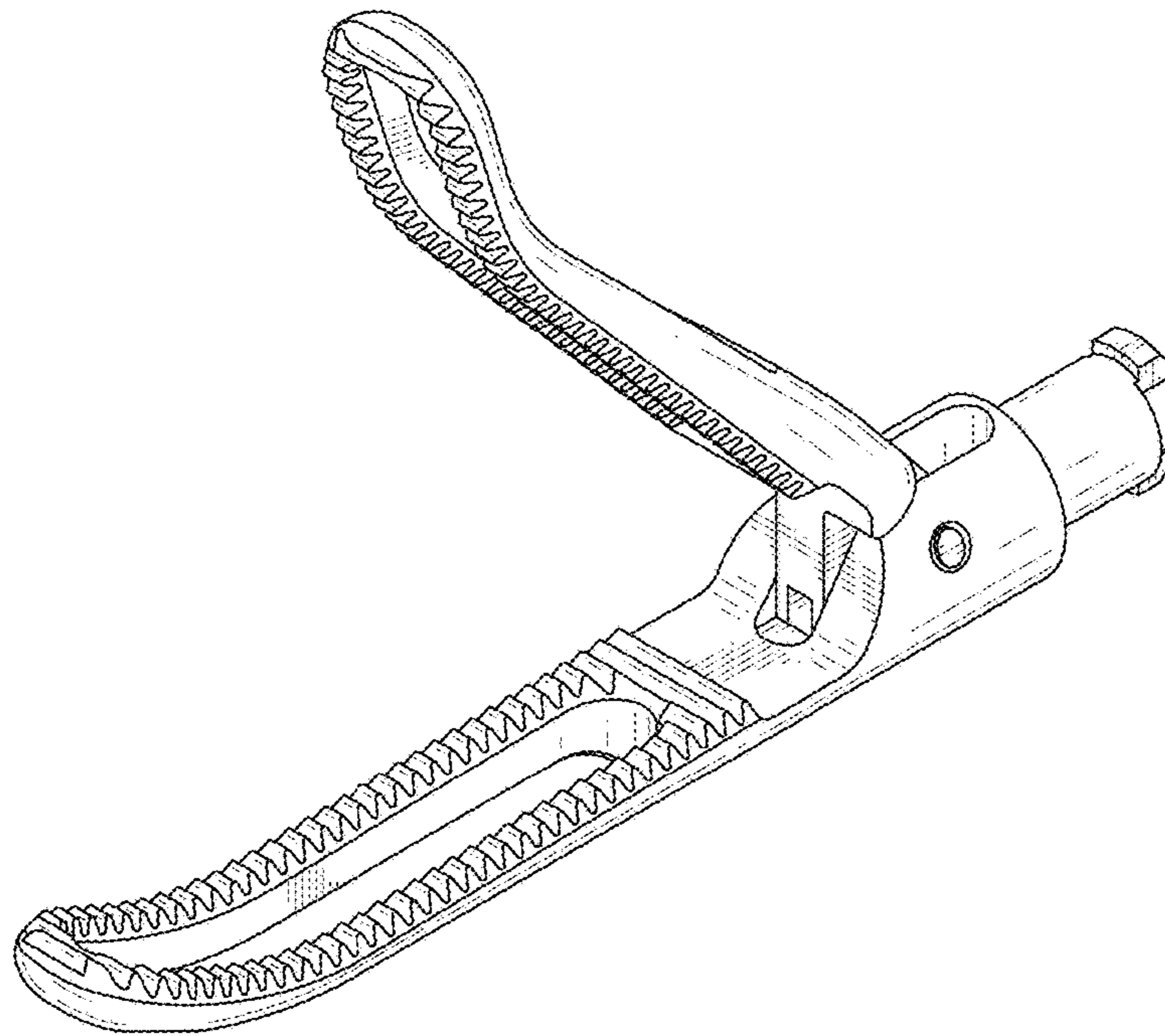

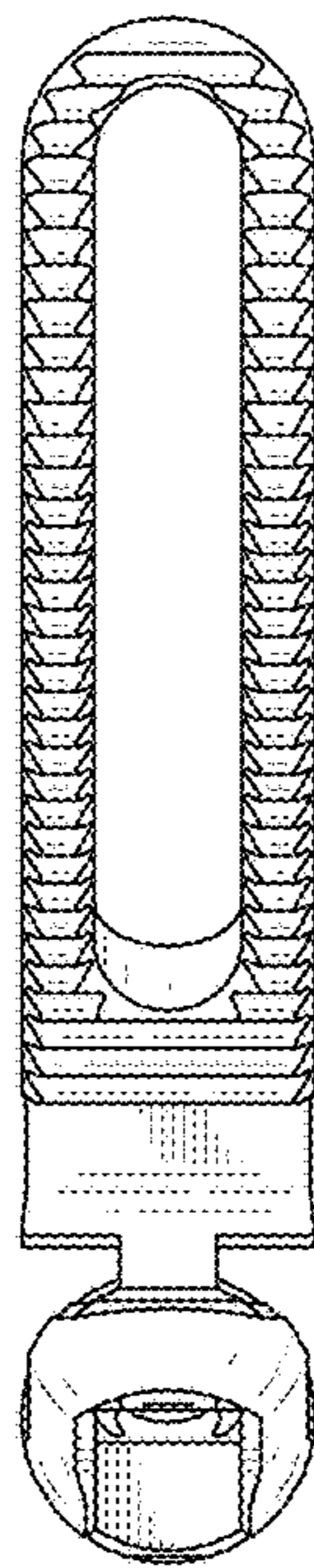

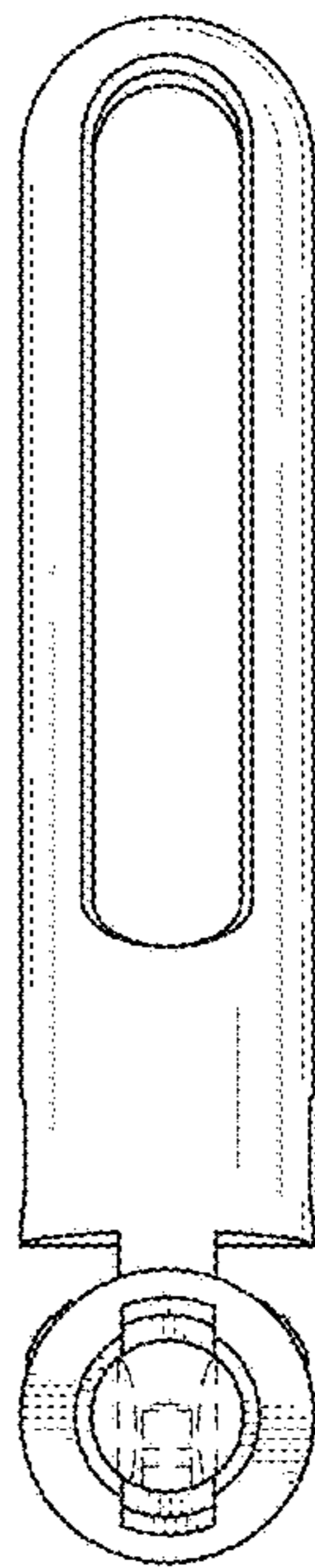

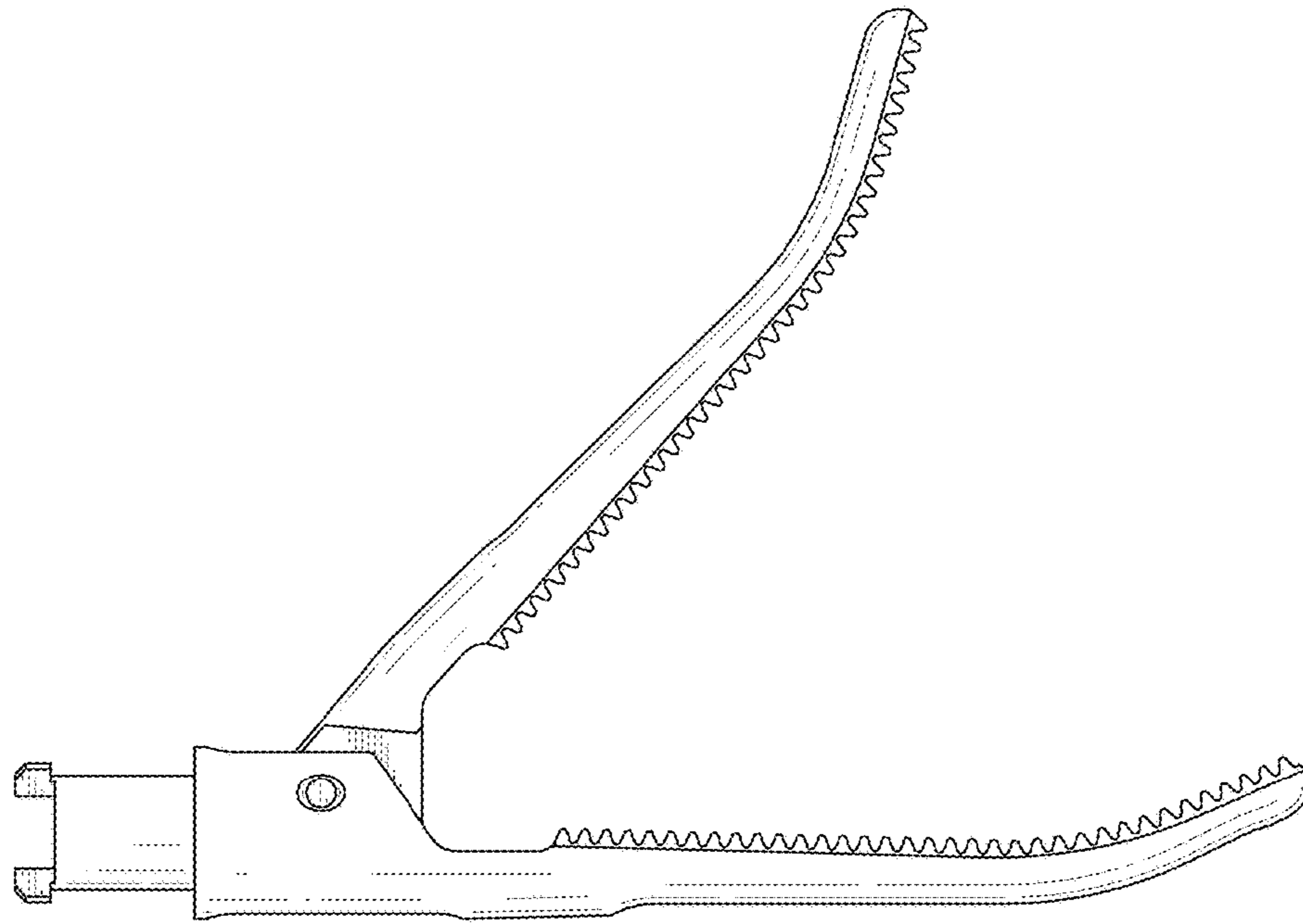

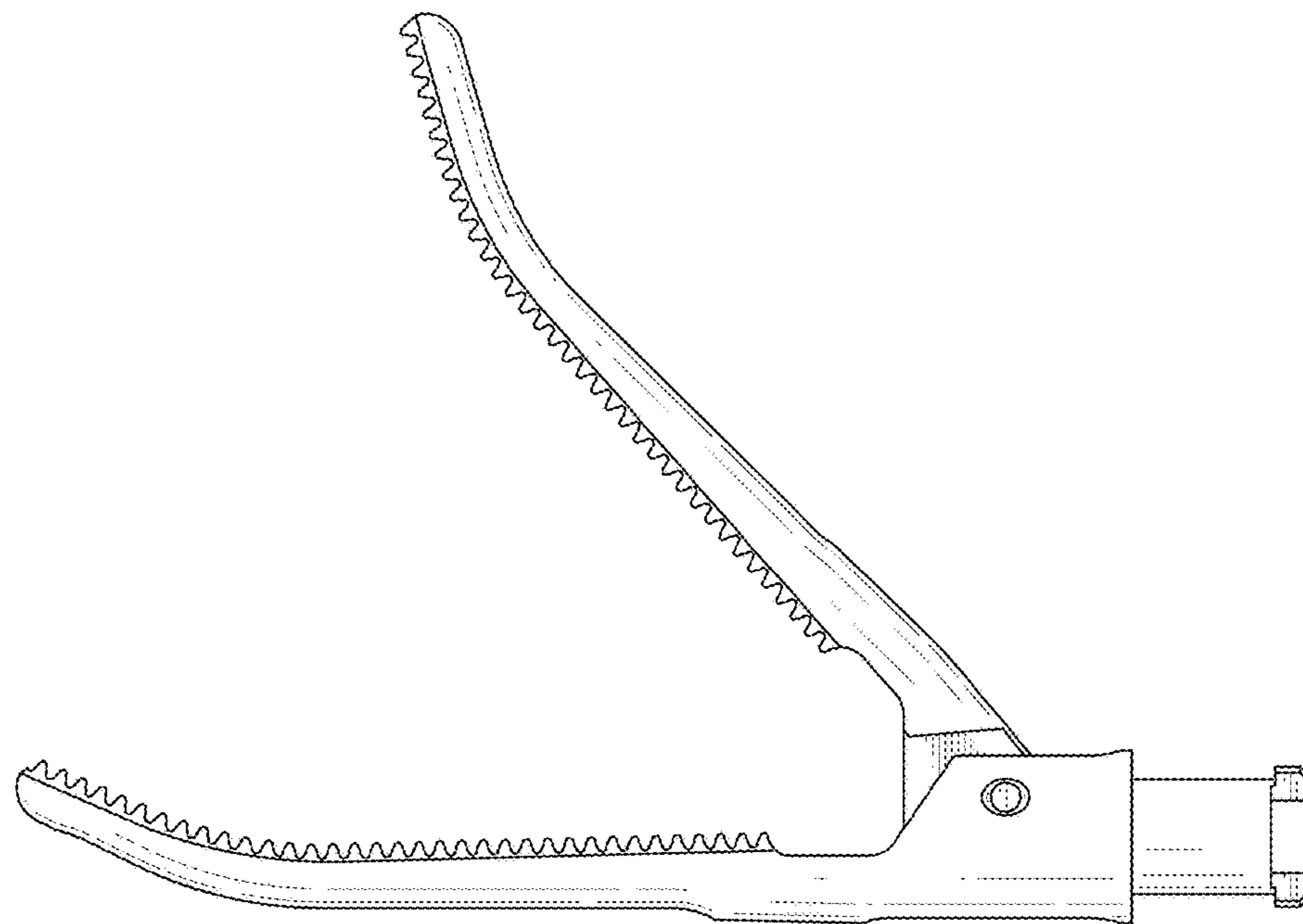

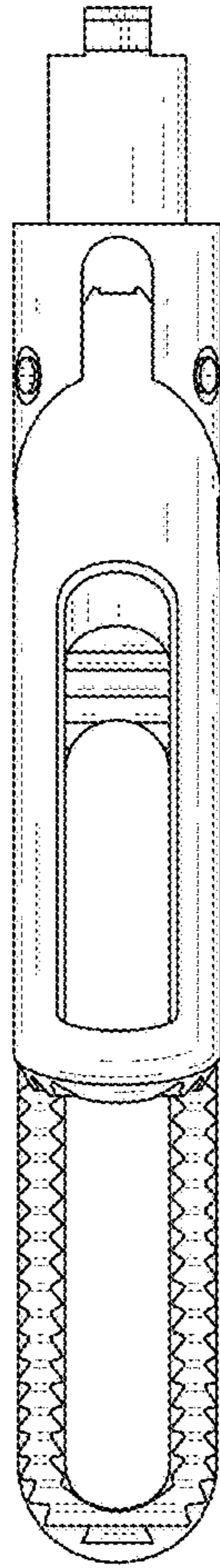

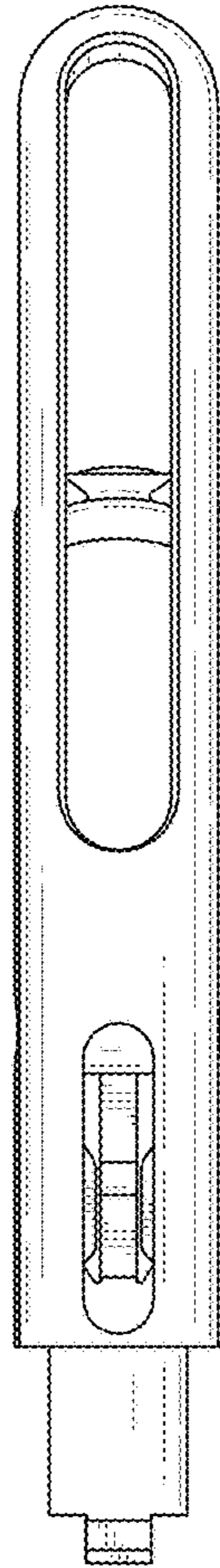
