DESCRIPTION

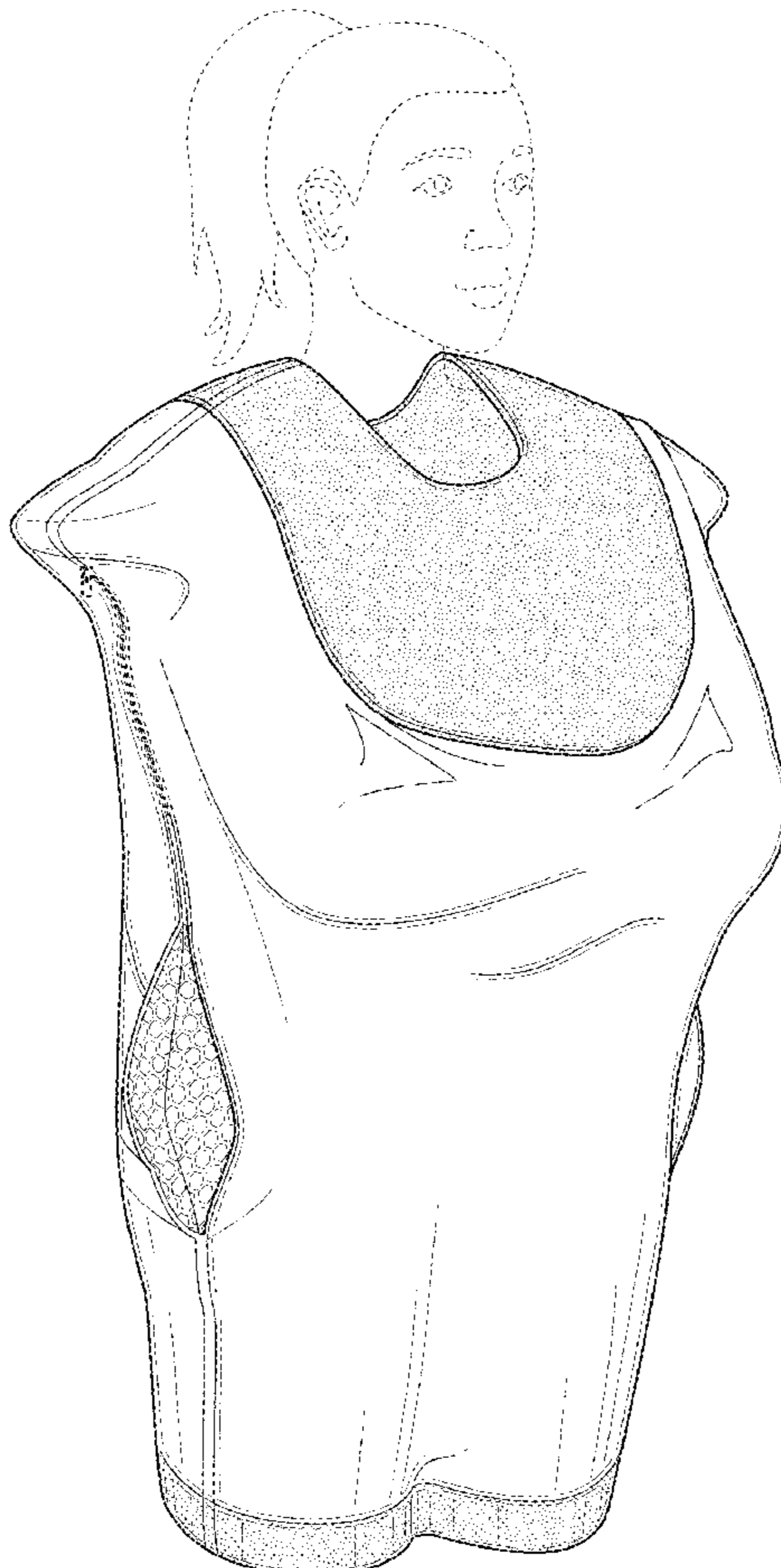
FIG. 1 is a perspective view of the sensory activity sack;

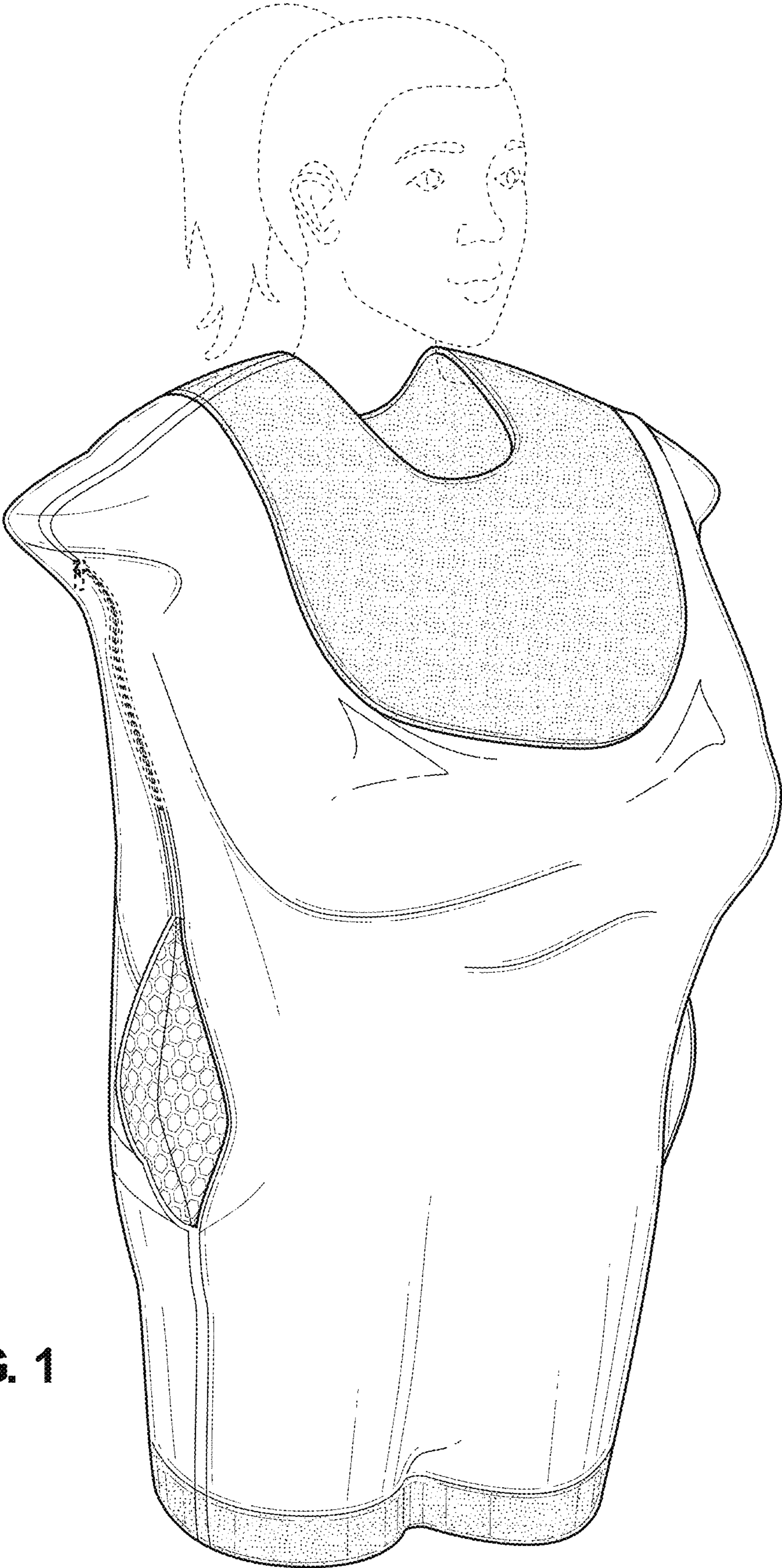

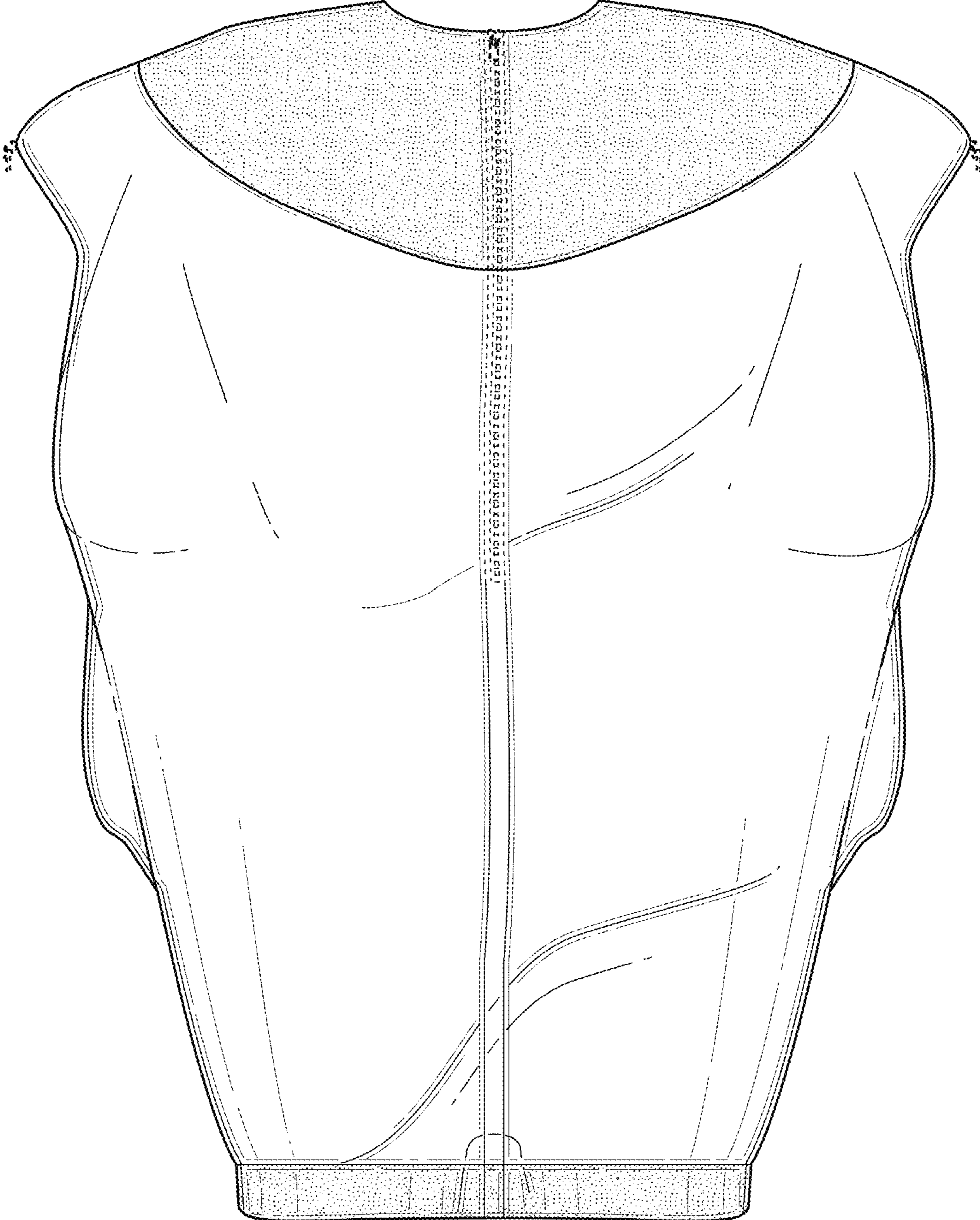

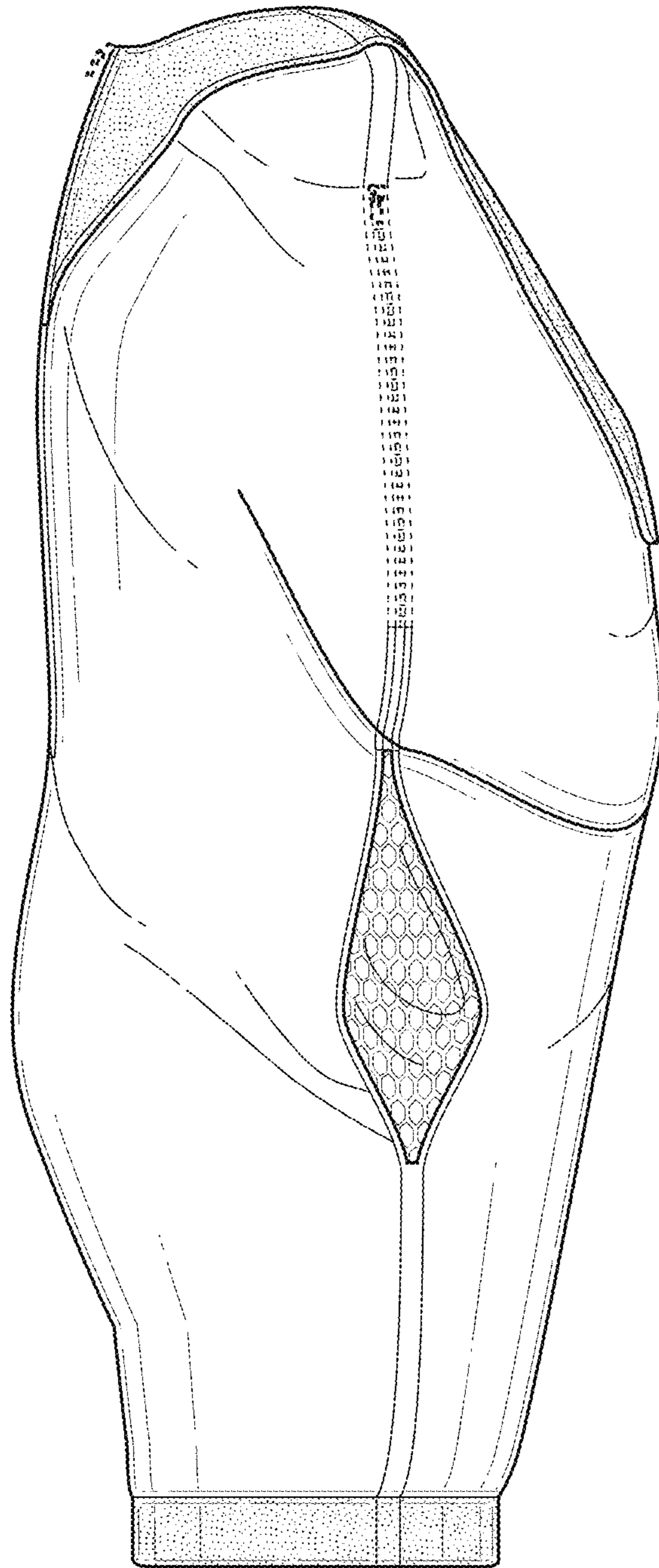

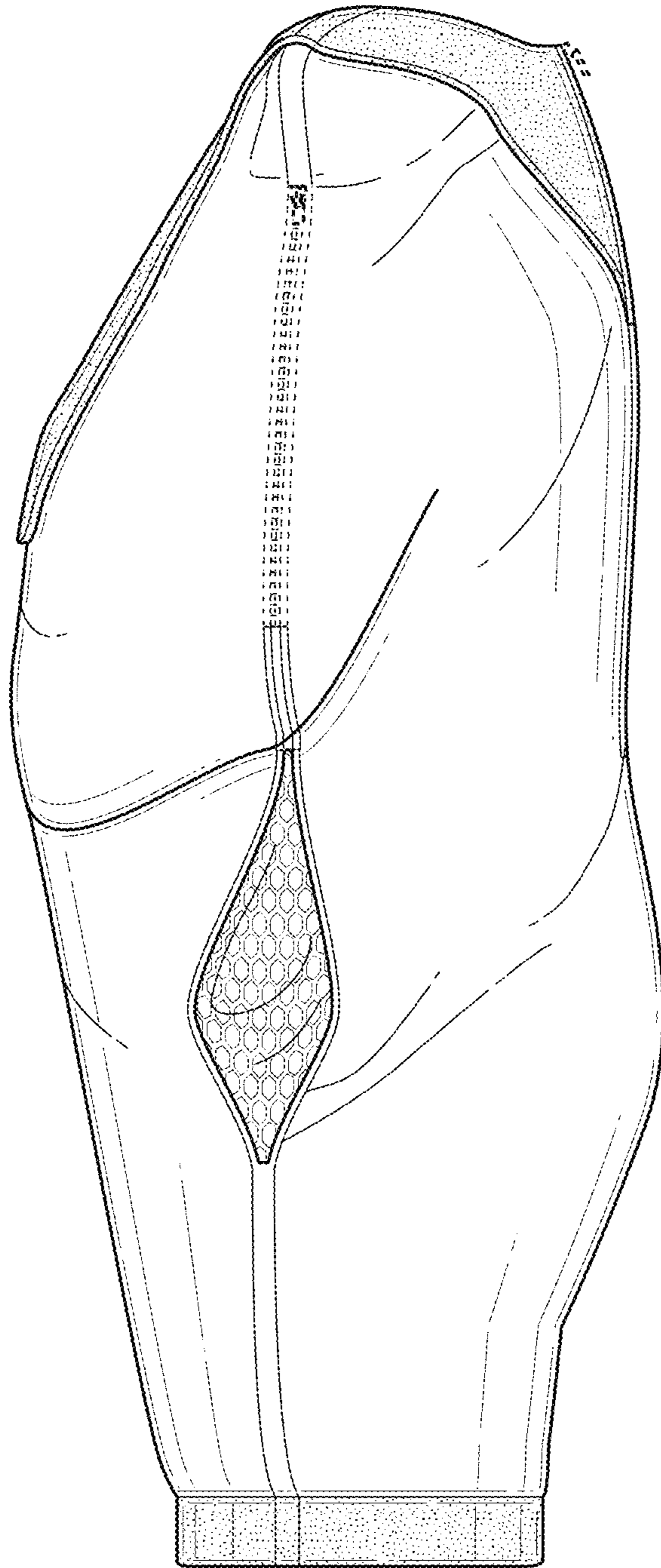

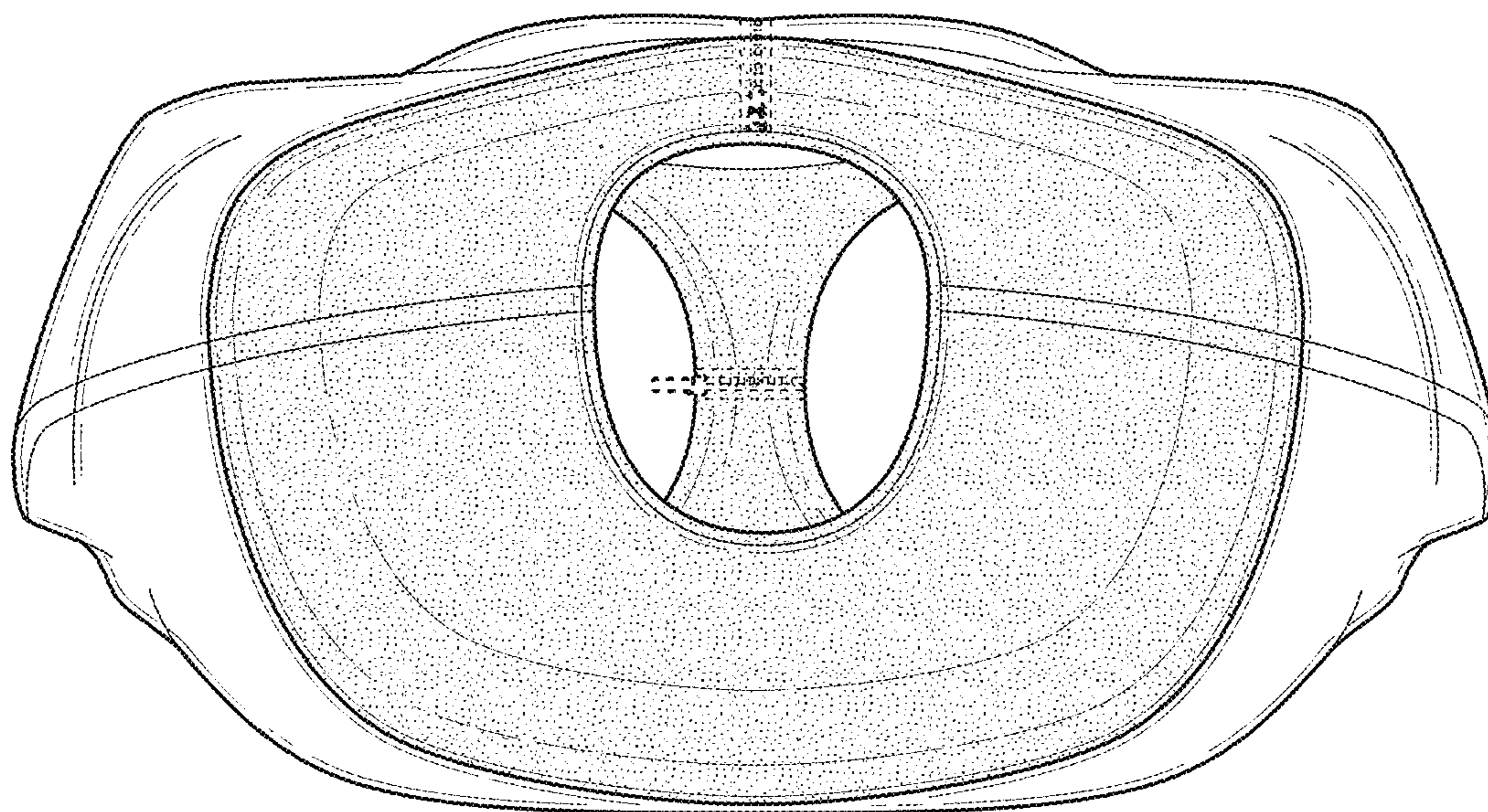

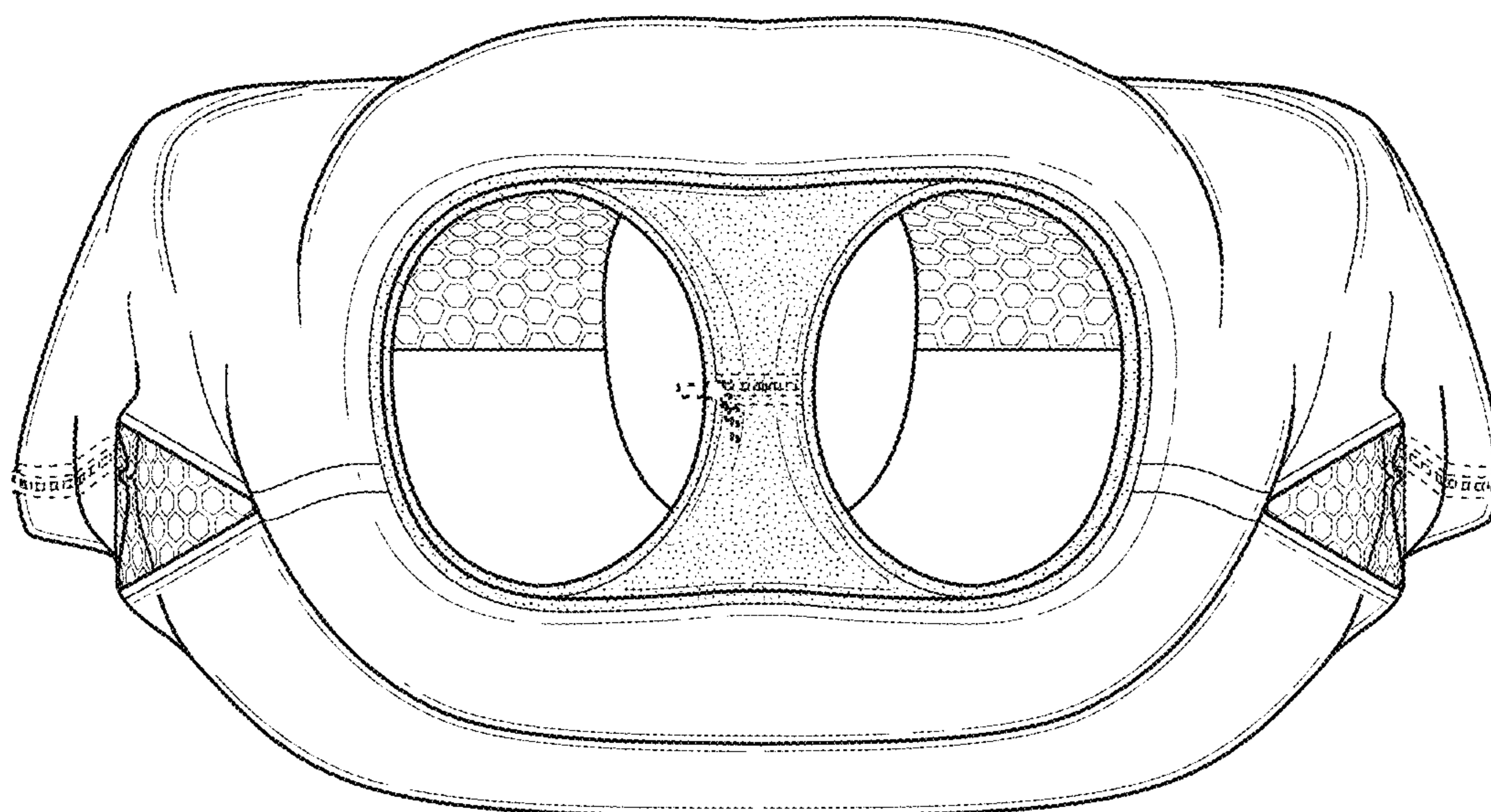
