(57) **CLAIM**

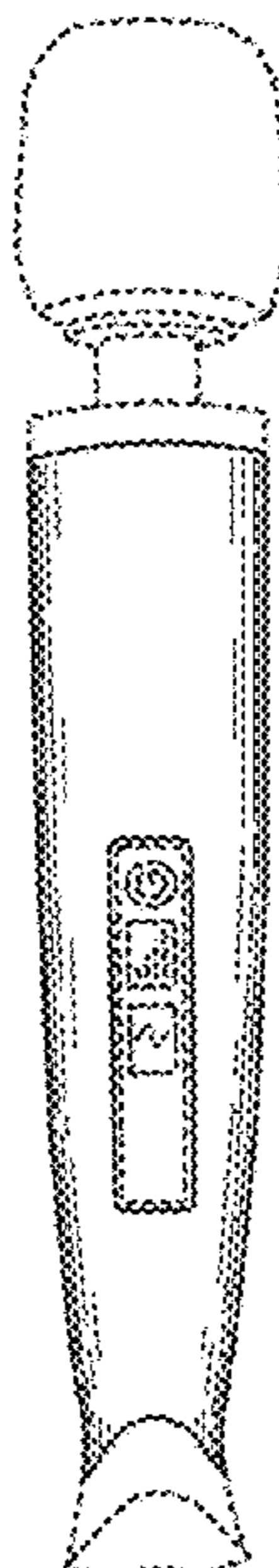
I claim the ornamental design for a skin cover for a mas-

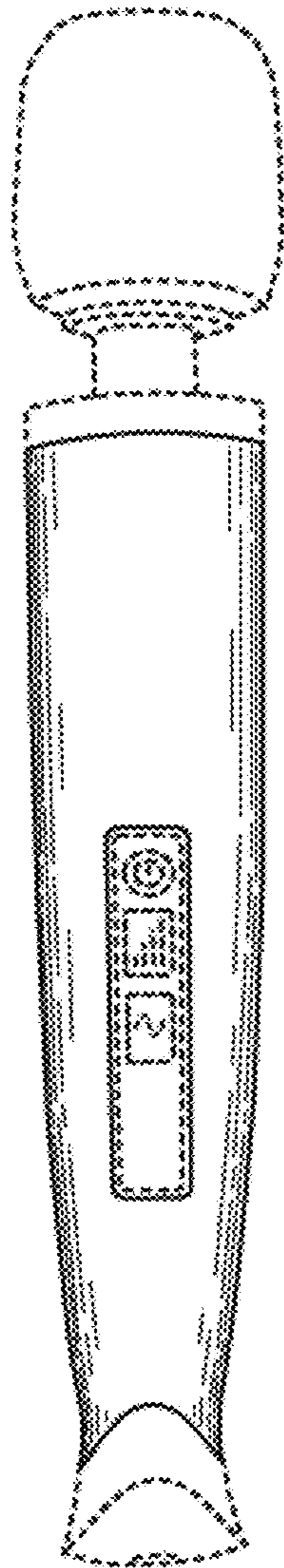

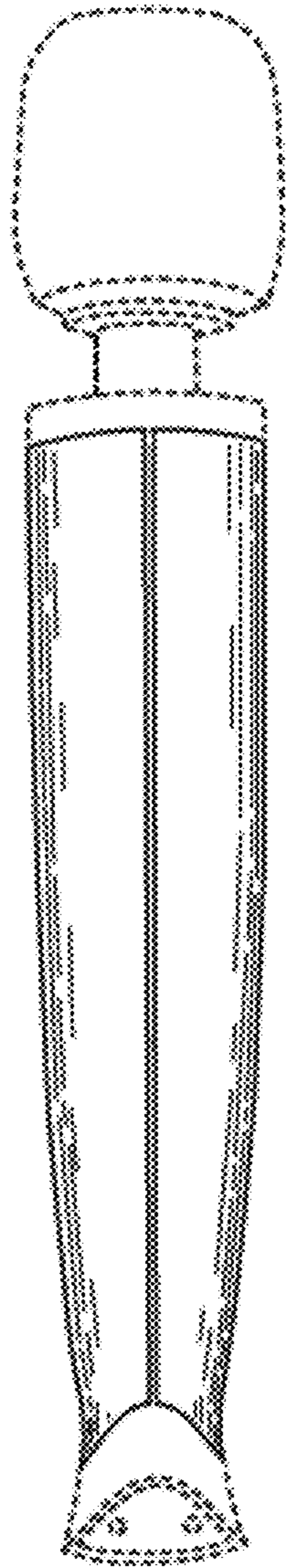

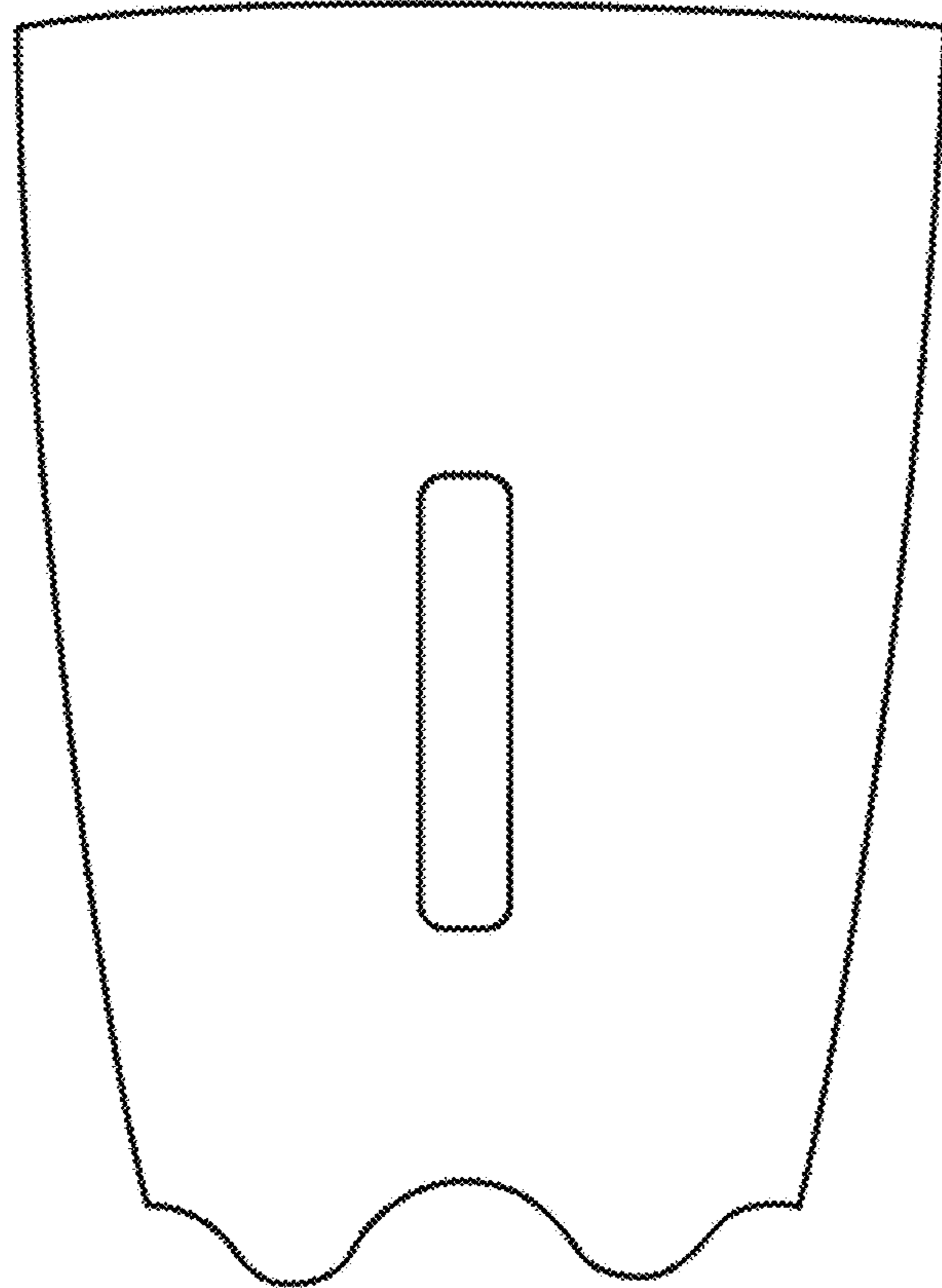
