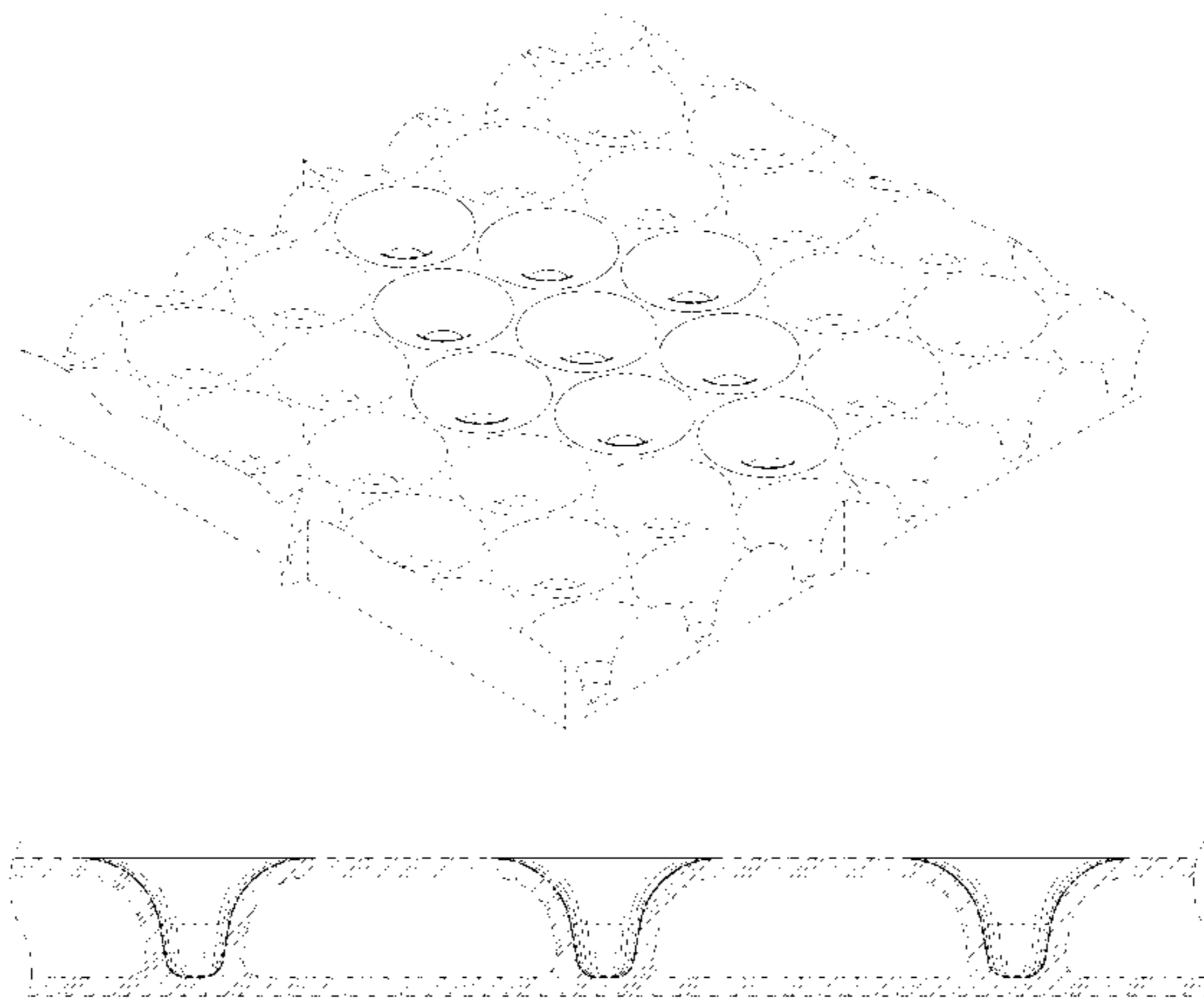
(57) **CLAIM**

The ornamental design for a blow-molded panel with a pattern of depressions, as shown and described.

**DESCRIPTION**

FIG. 1 is an upper perspective view of a blow-molded panel with a pattern of depressions showing our new design; FIG. 2 is a top plan view thereof; and, FIG. 3 is an enlarged cross-sectional side view thereof taken along line 3-3 in FIG. 2. The broken lines in the drawings depict portions of the blow-molded panel with a pattern of depressions that form no part of the claimed design.

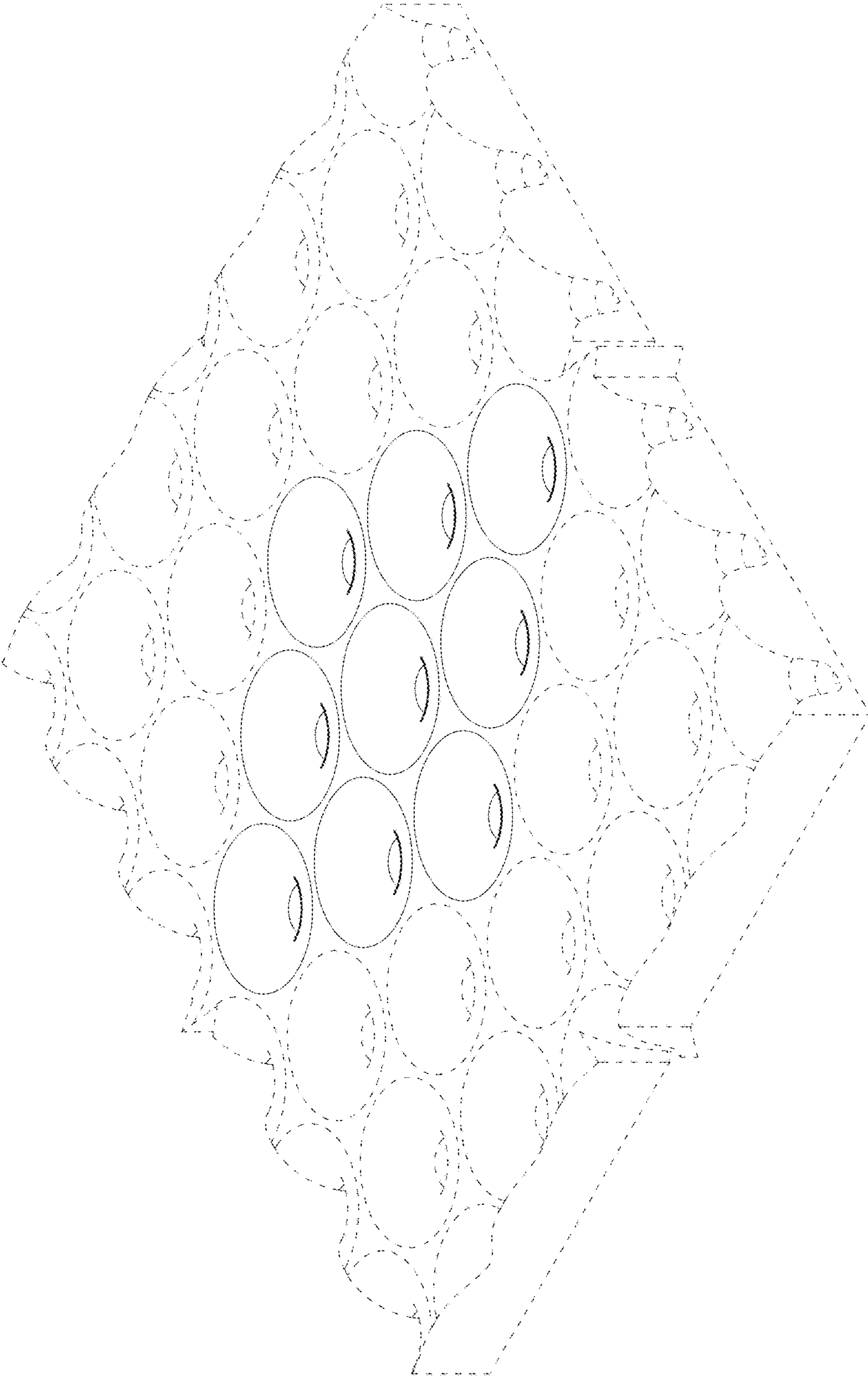

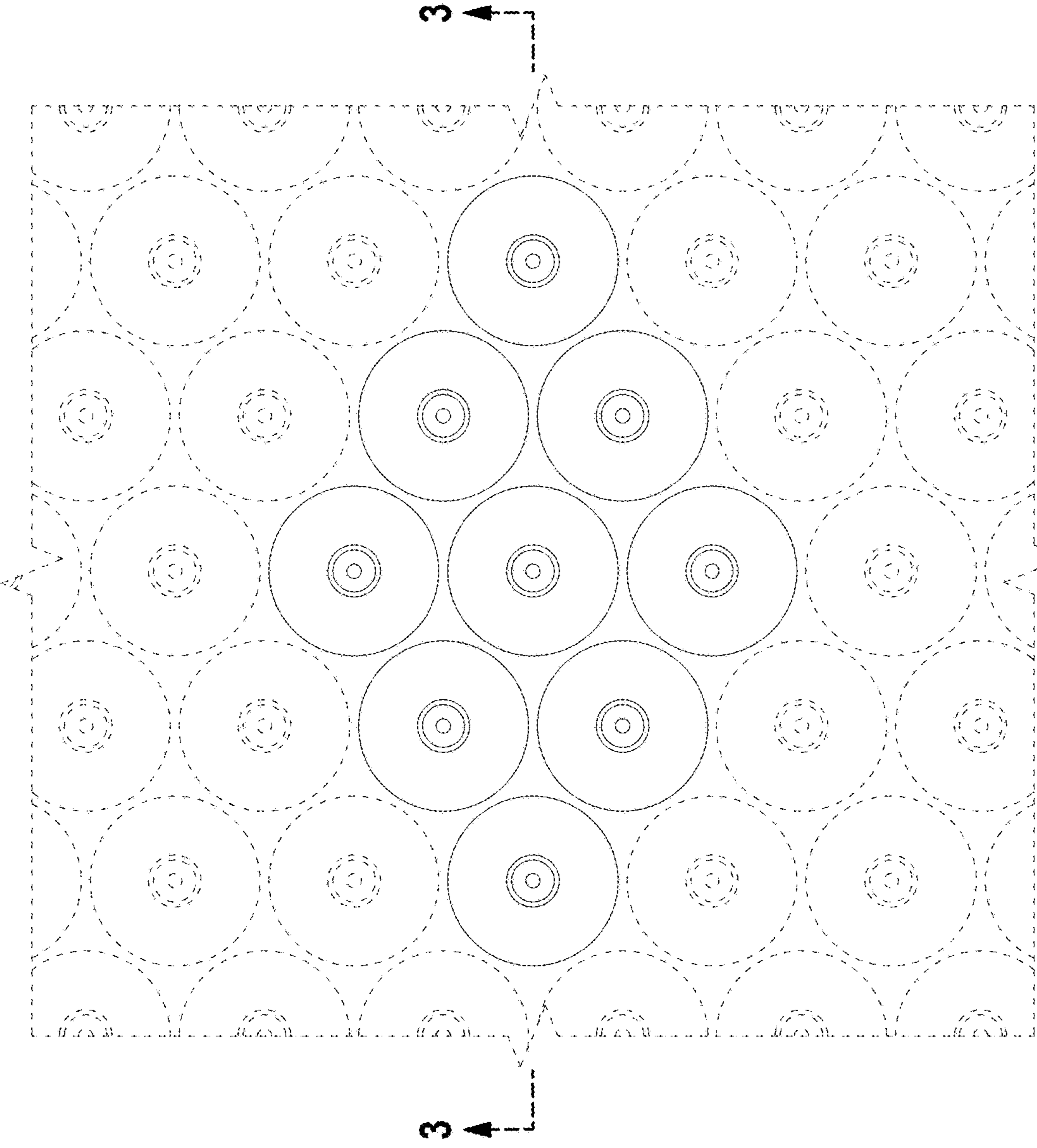

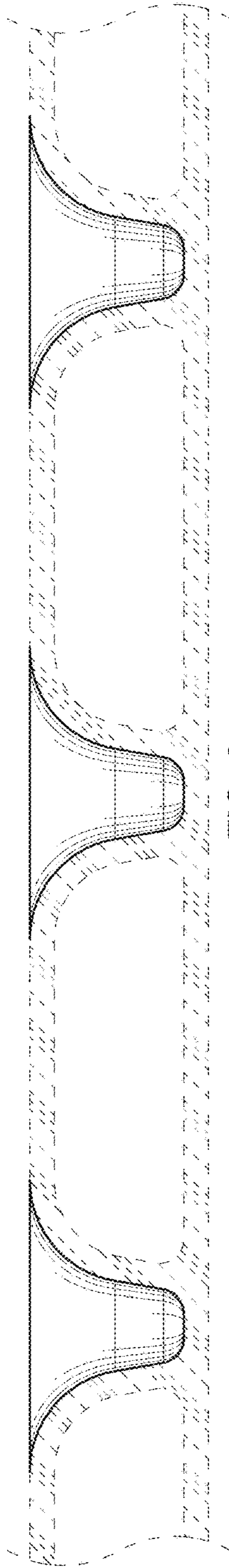
