DESCRIPTION

FIG. 1 is a perspective view of a compact, showing our new design, in a closed position of use;

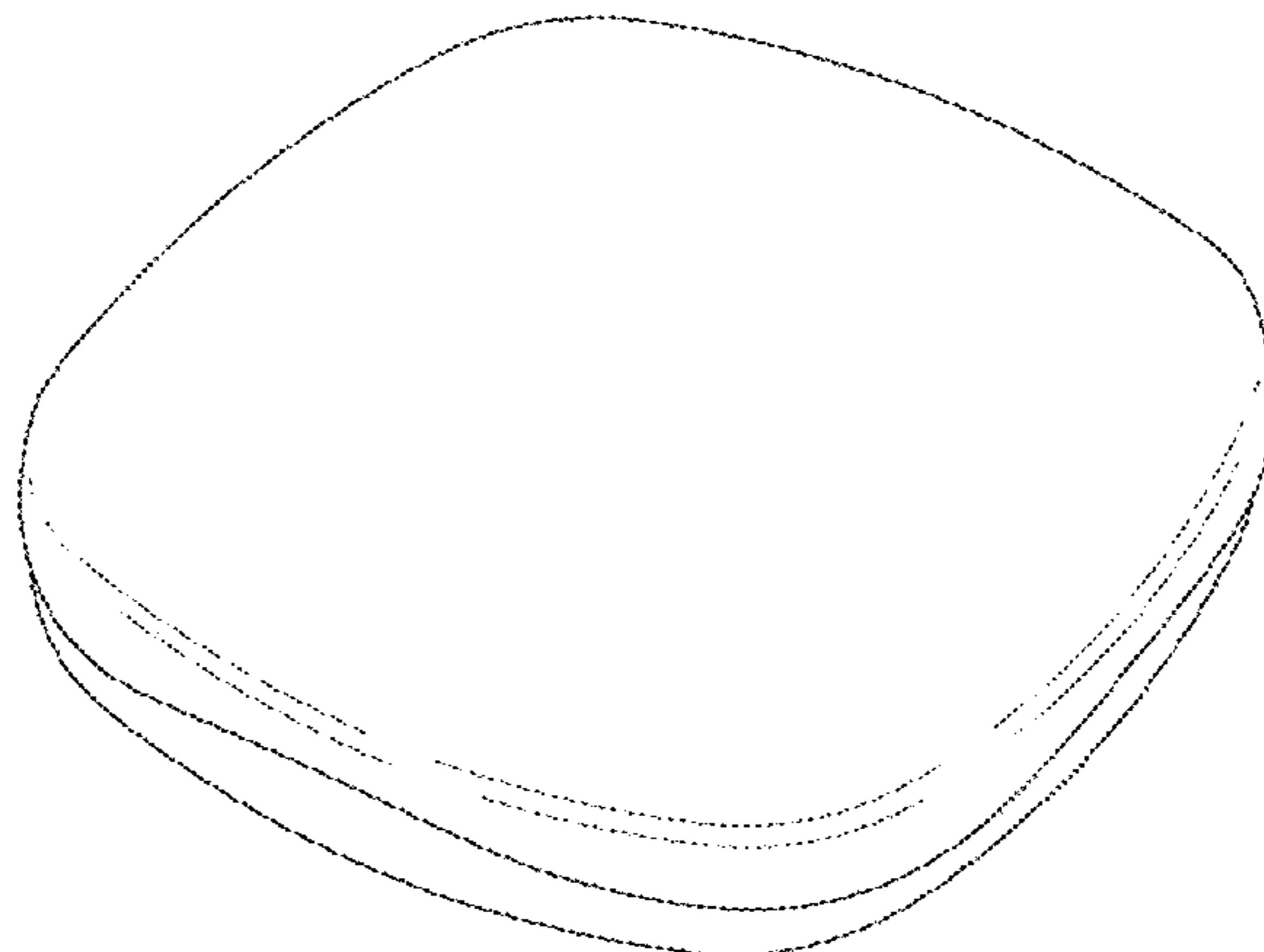

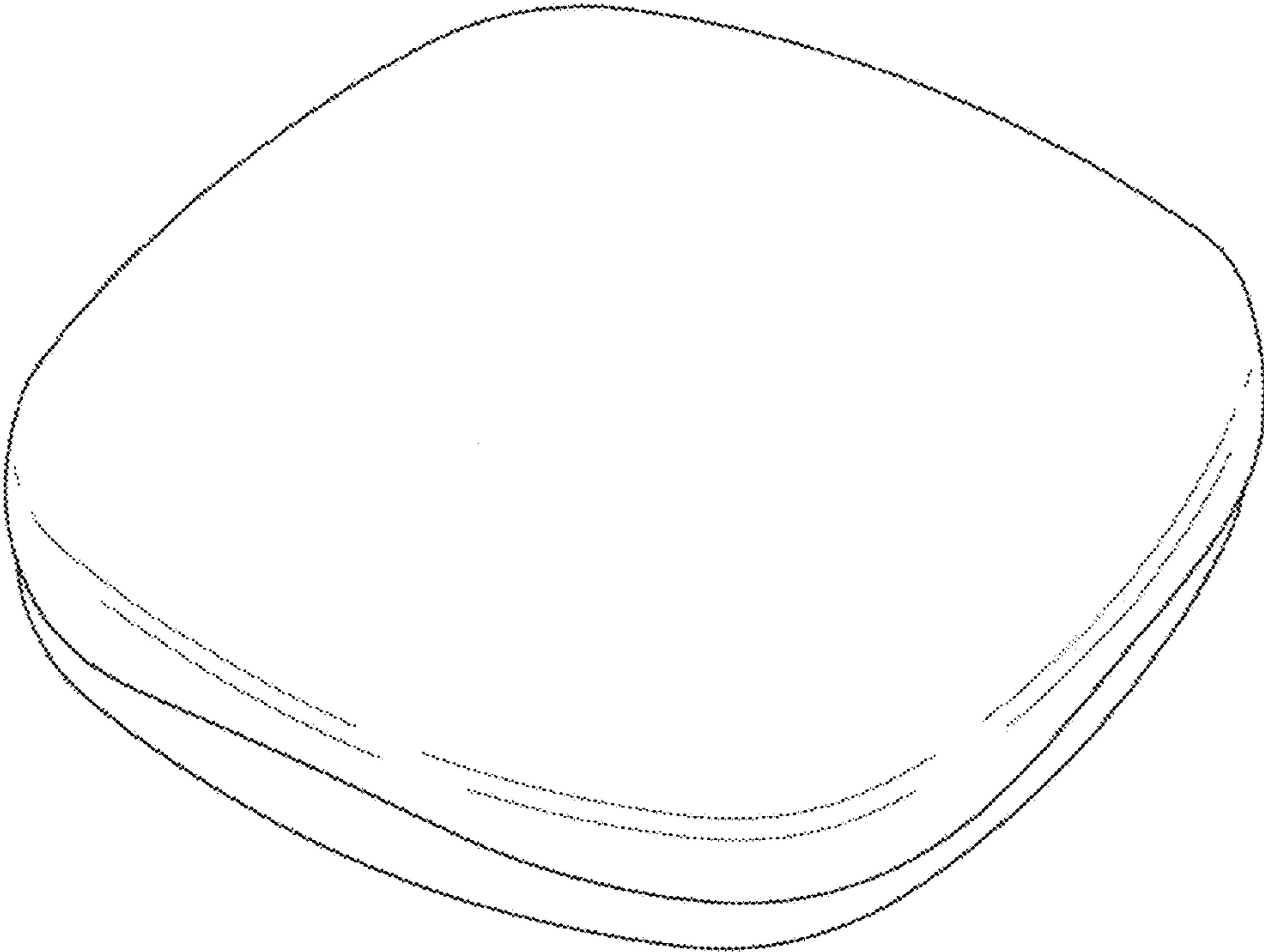

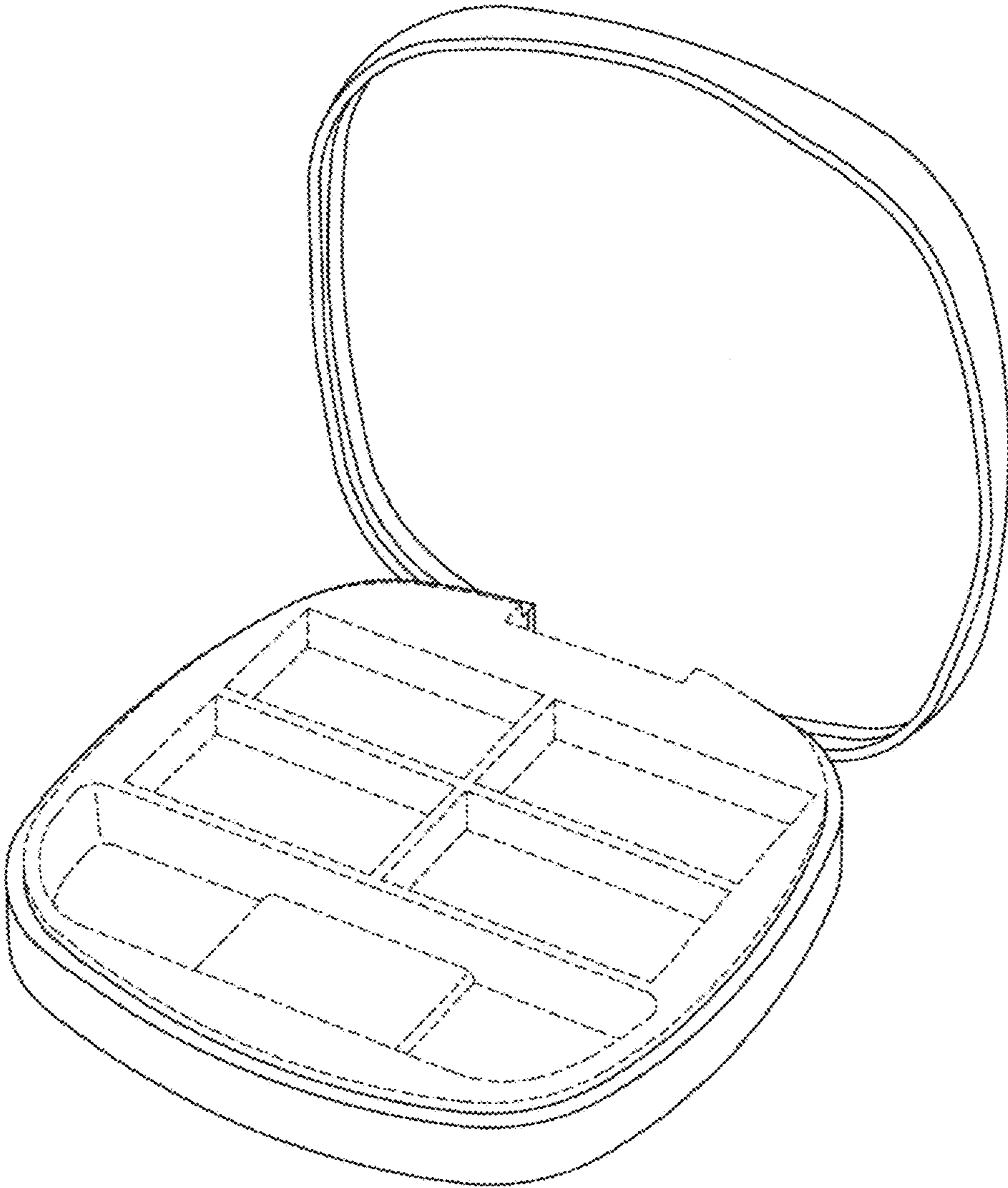

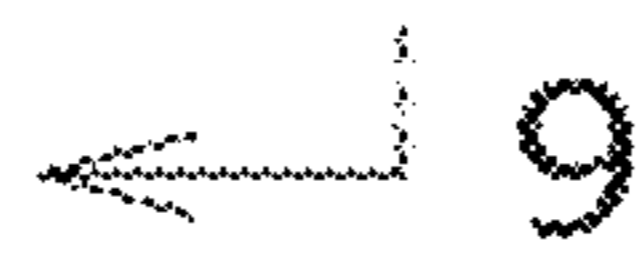
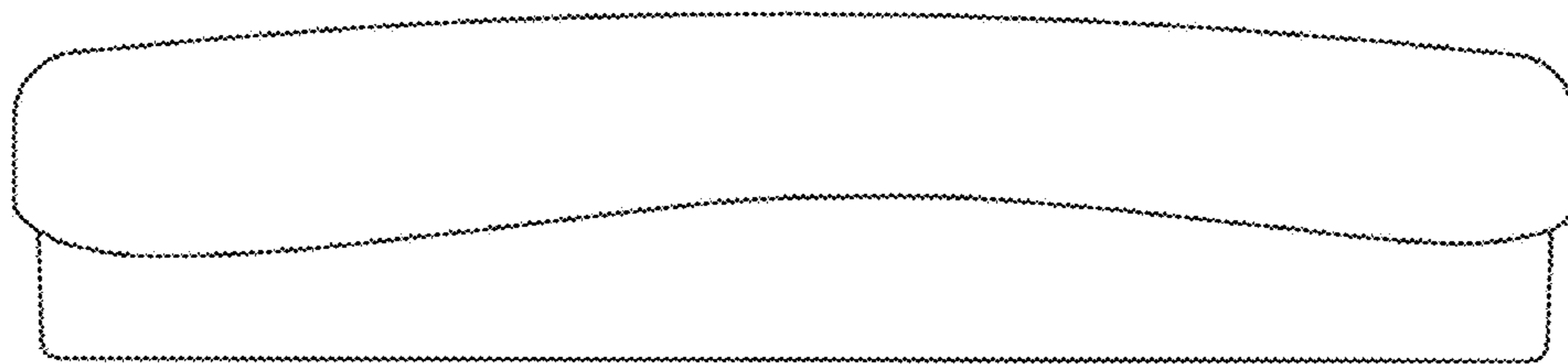
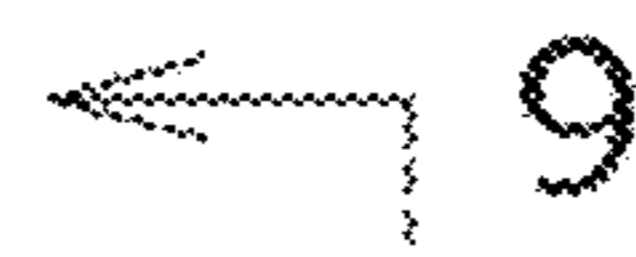

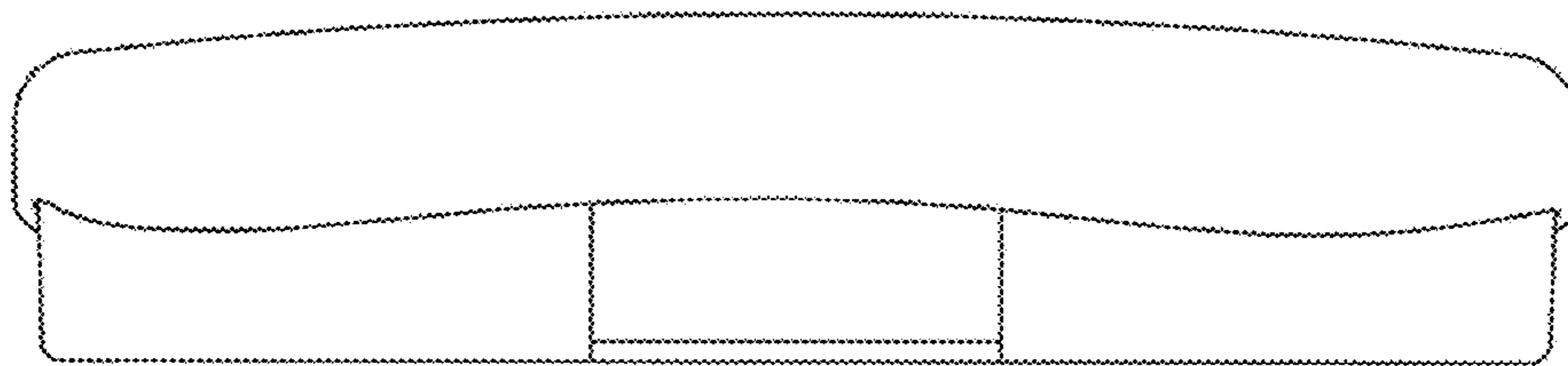

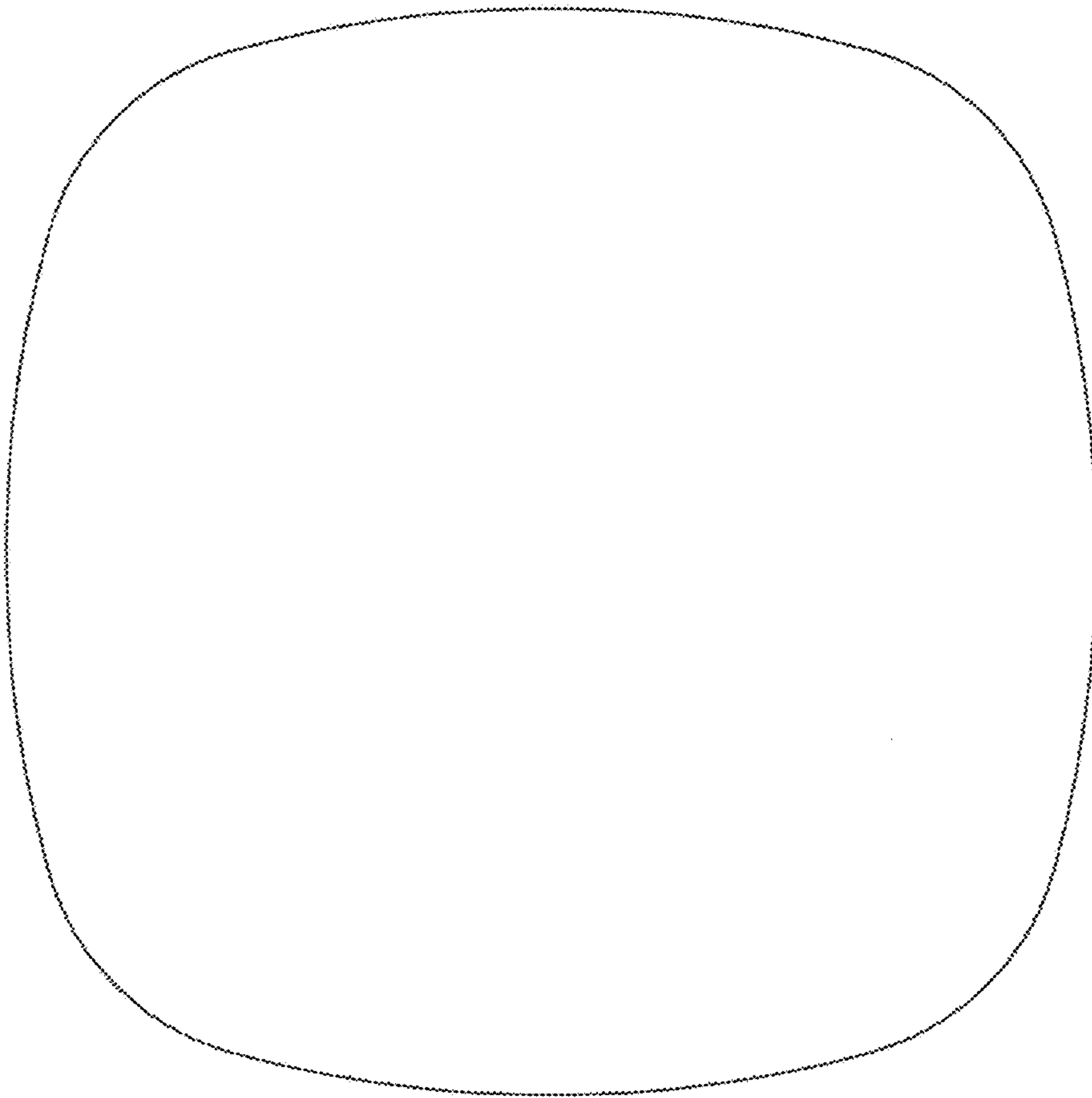

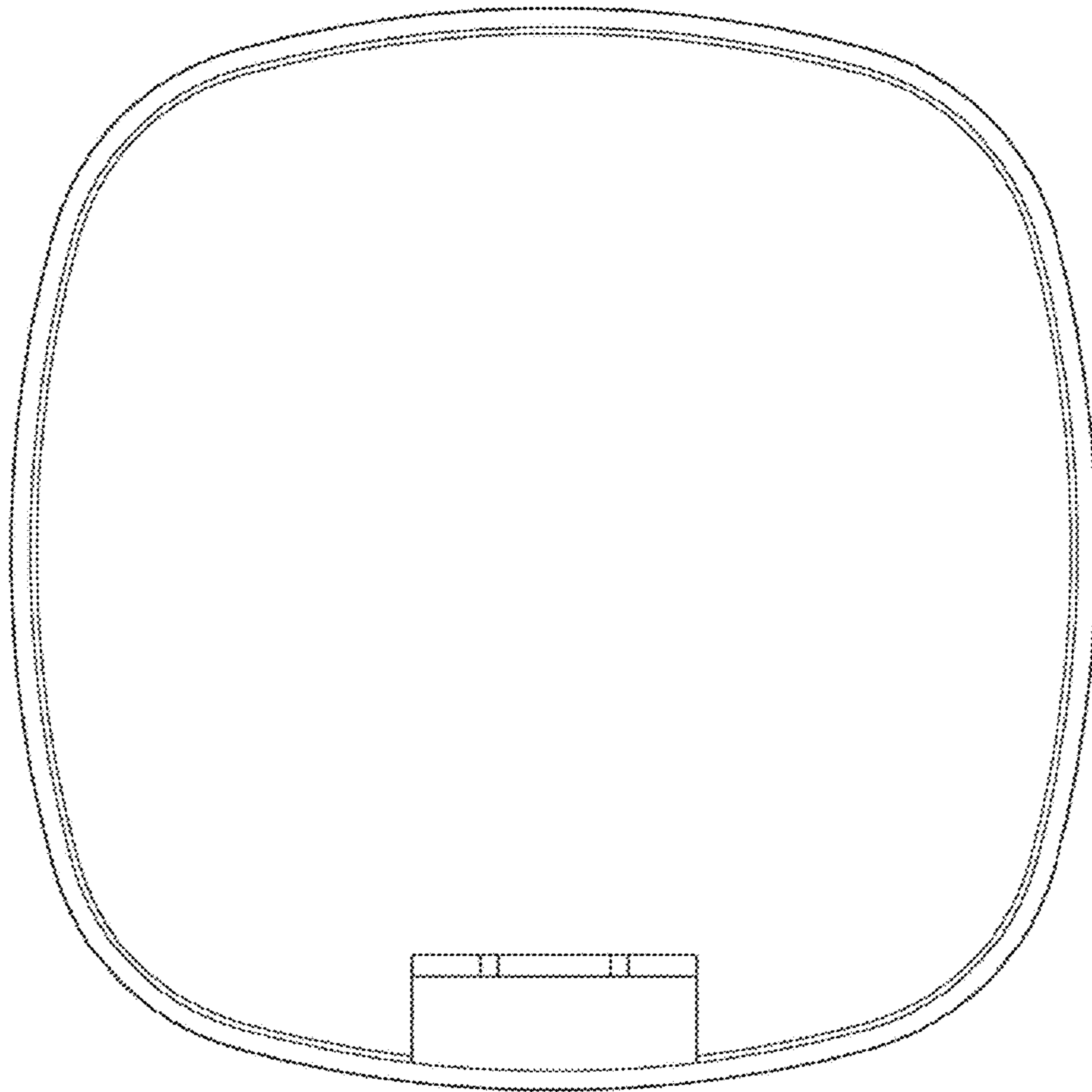
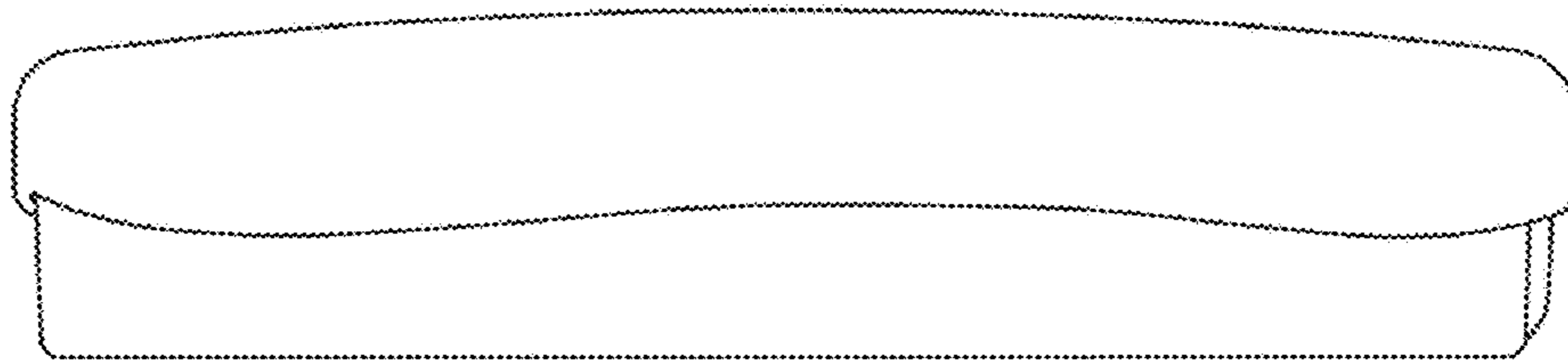

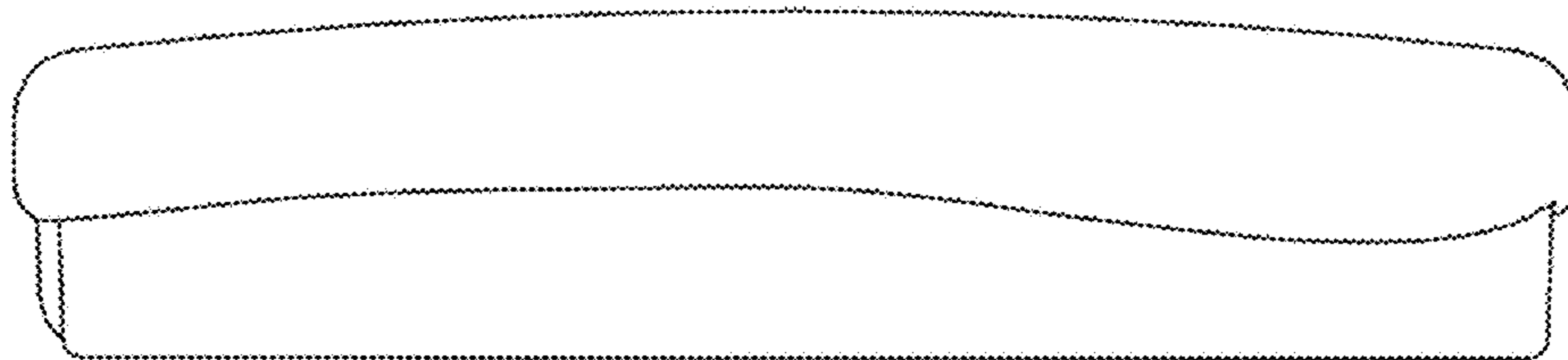

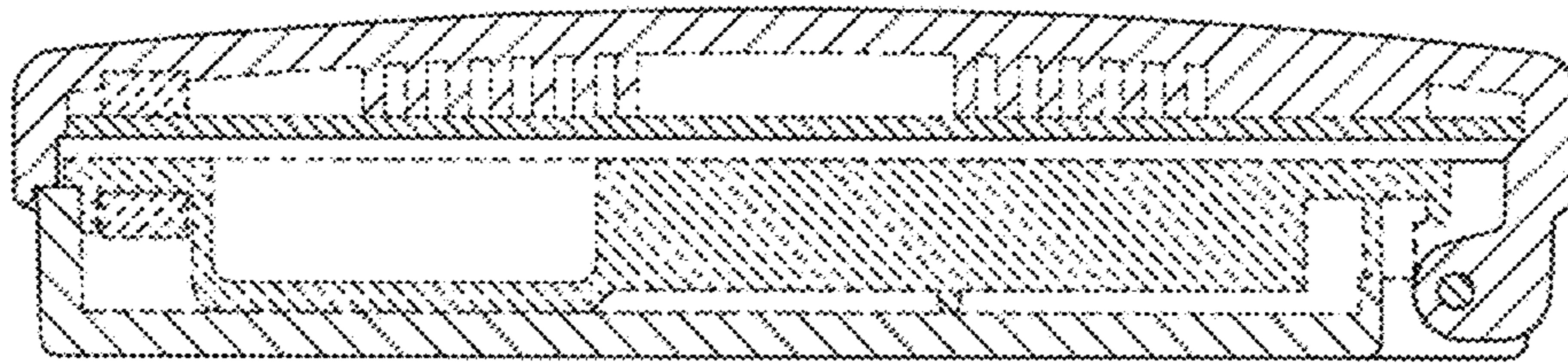
