FIG. 3 is a perspective rear view thereof;

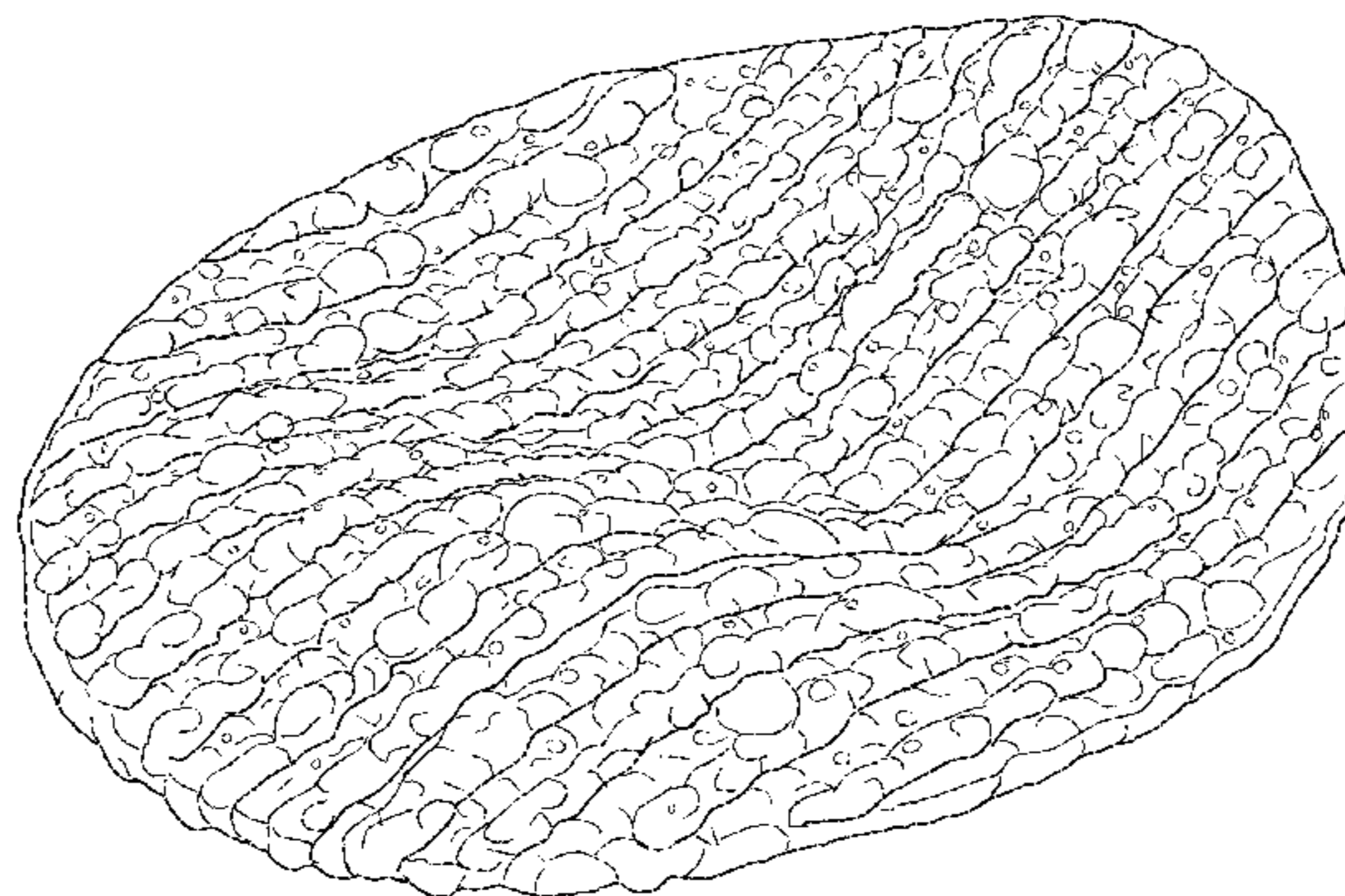
FIG. 4 is a perspective left side view thereof;

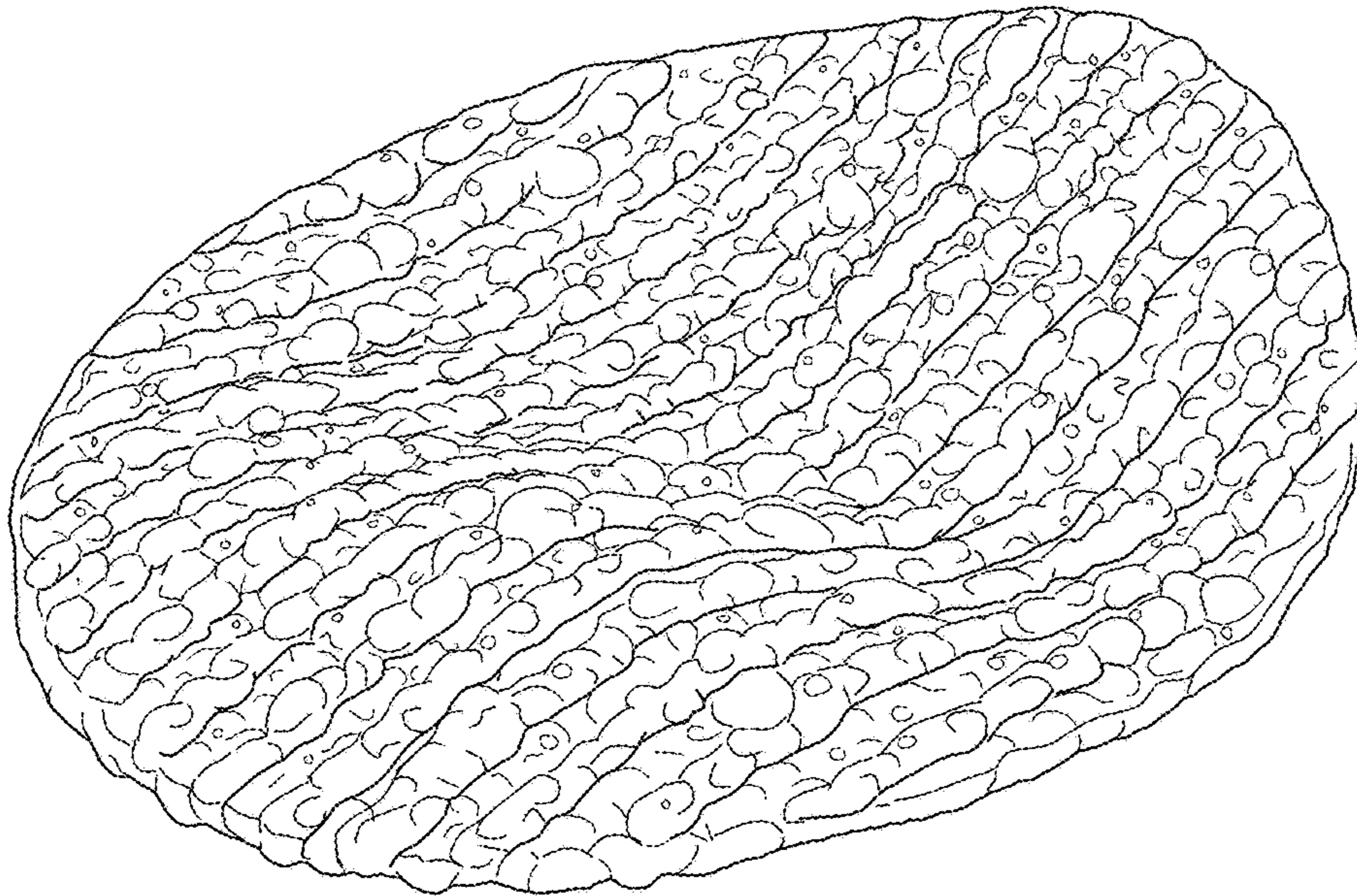
FIG. 5 is a perspective right side view thereof;

FIG. 6 is a top plan view thereof; and,

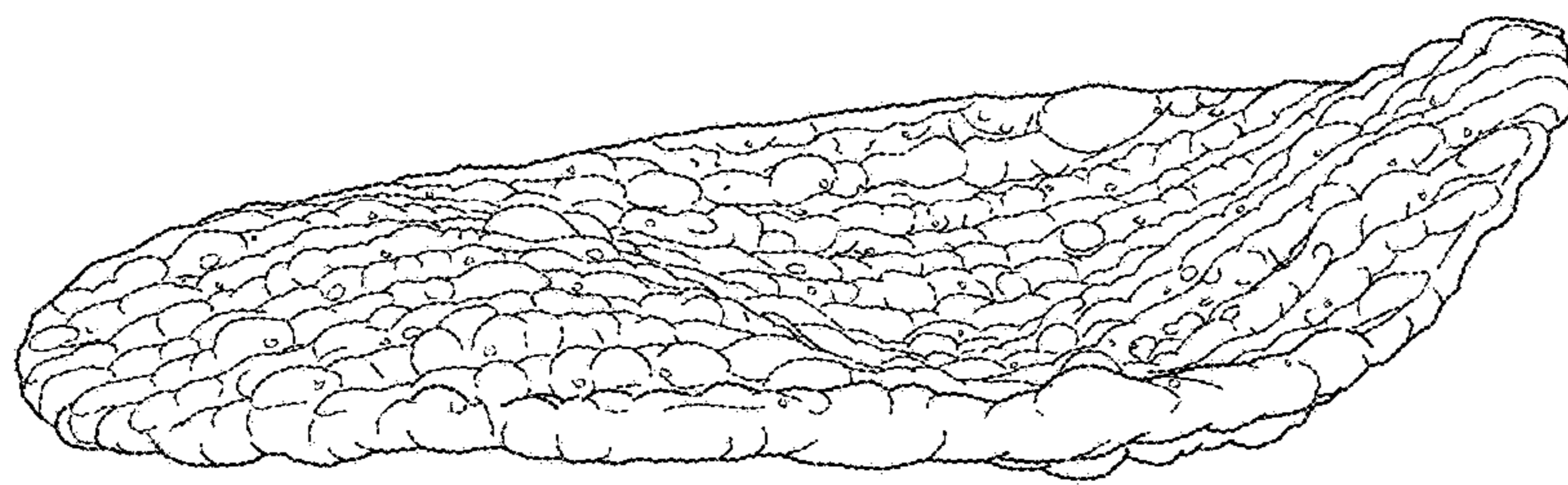
FIG. 7 is a bottom plan view thereof.

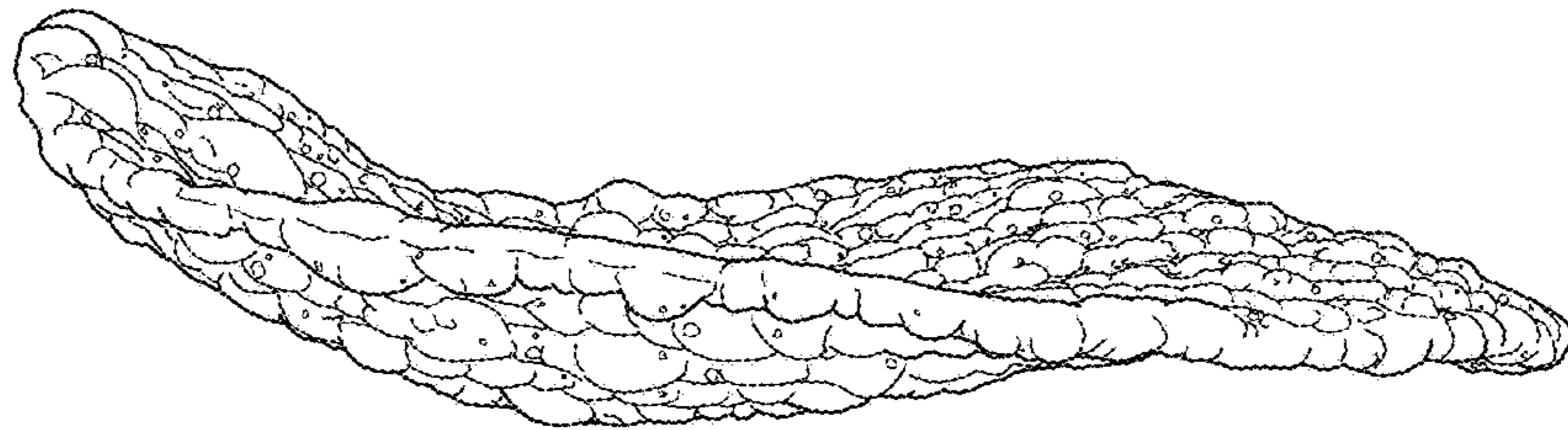




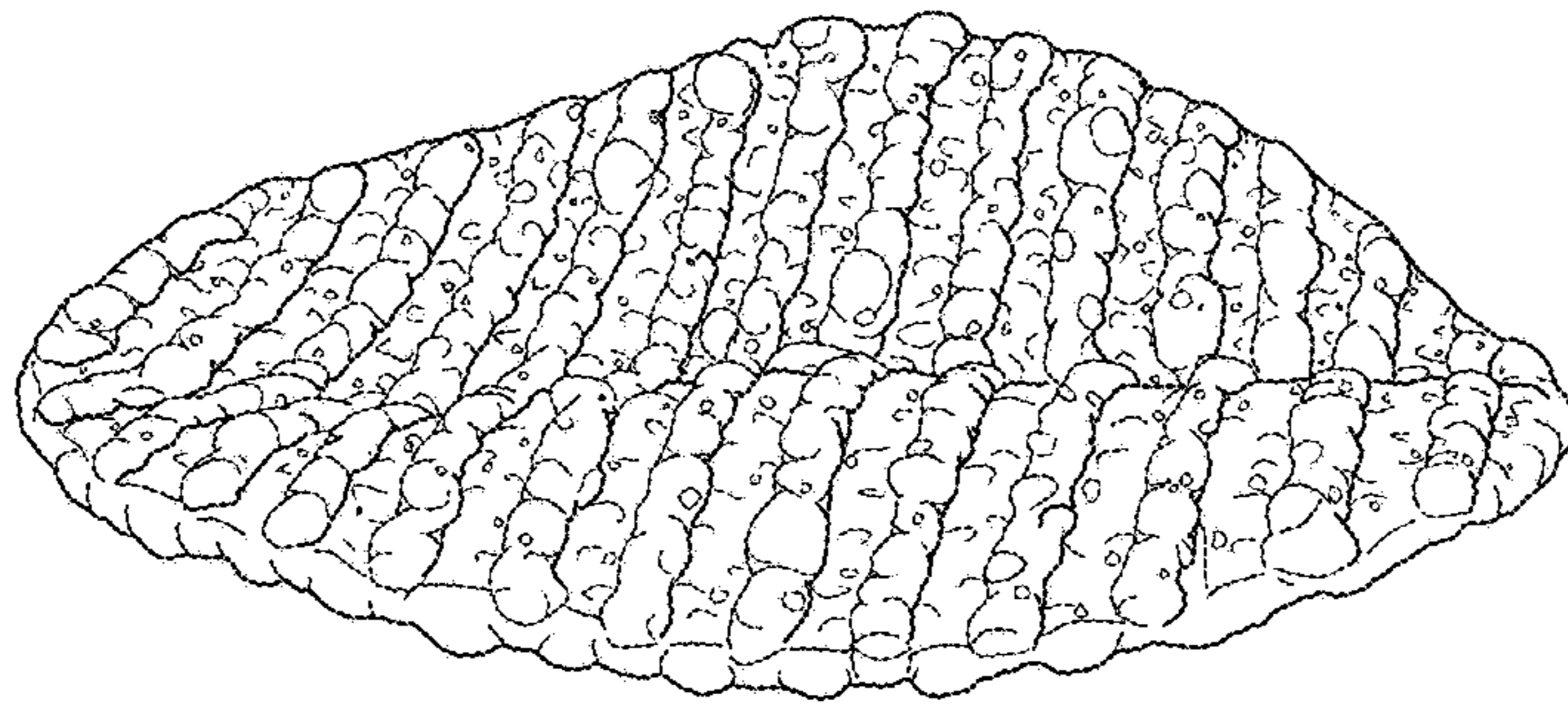

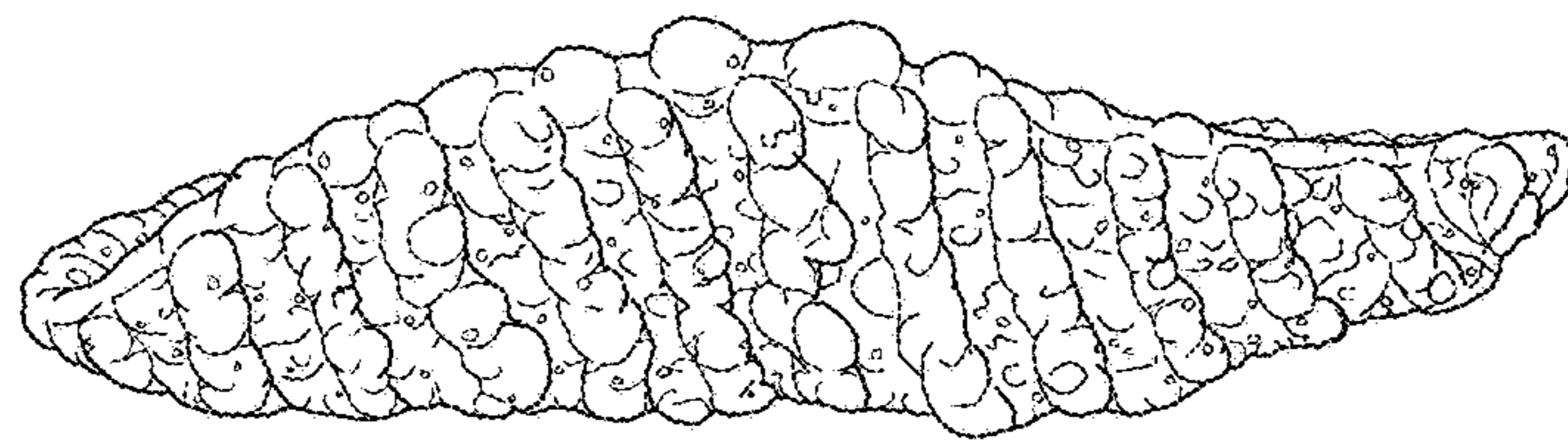

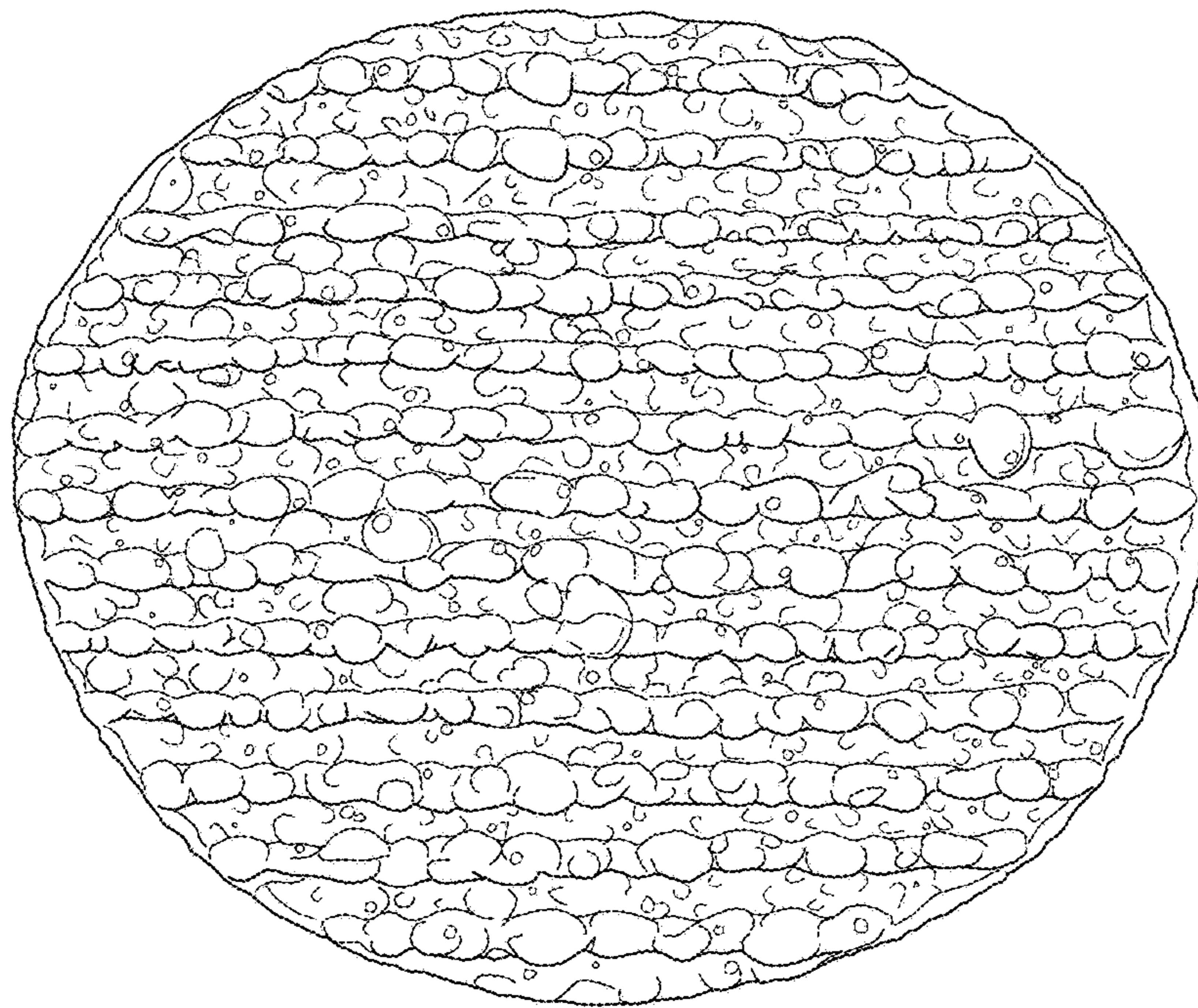

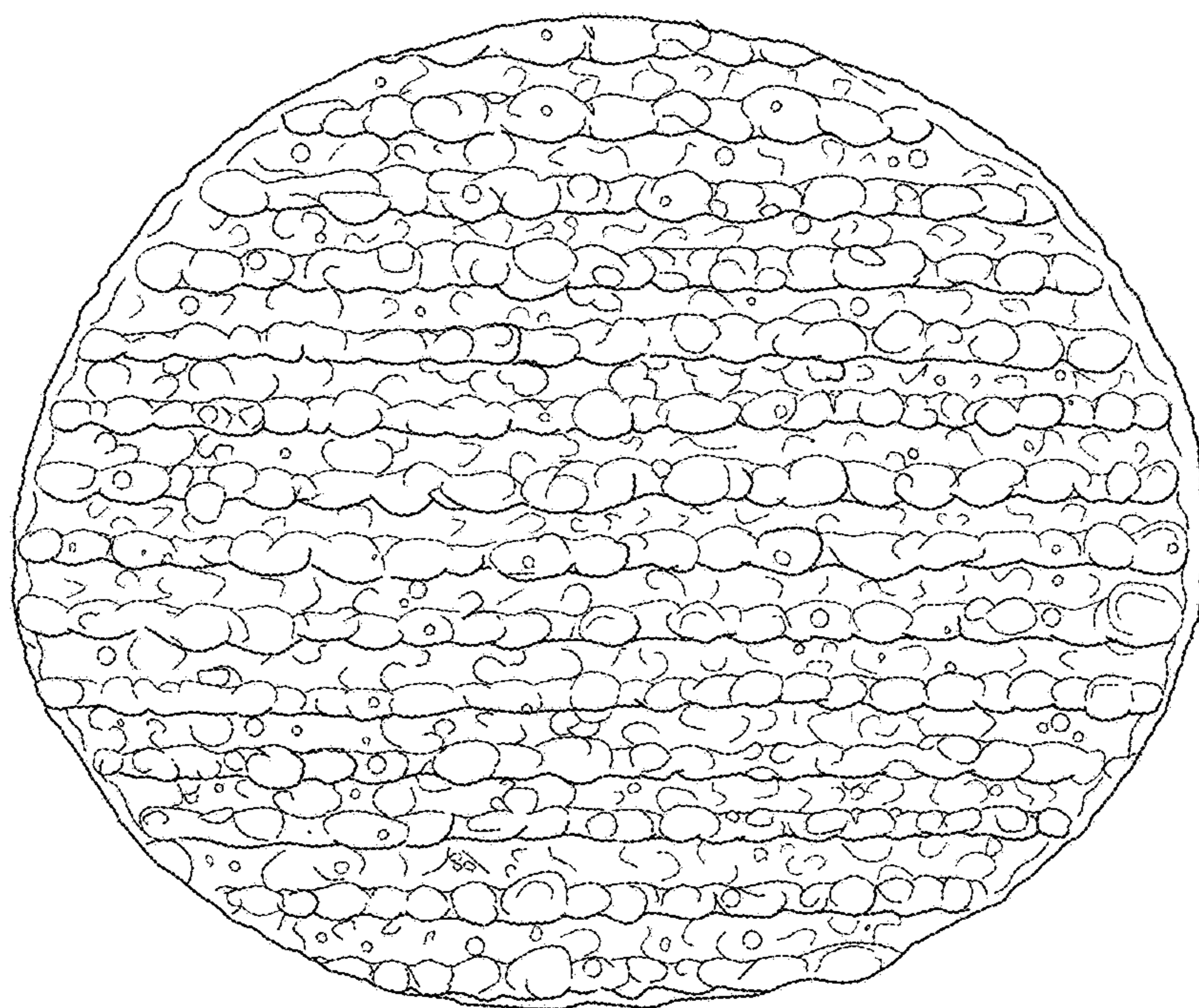
