DESCRIPTION

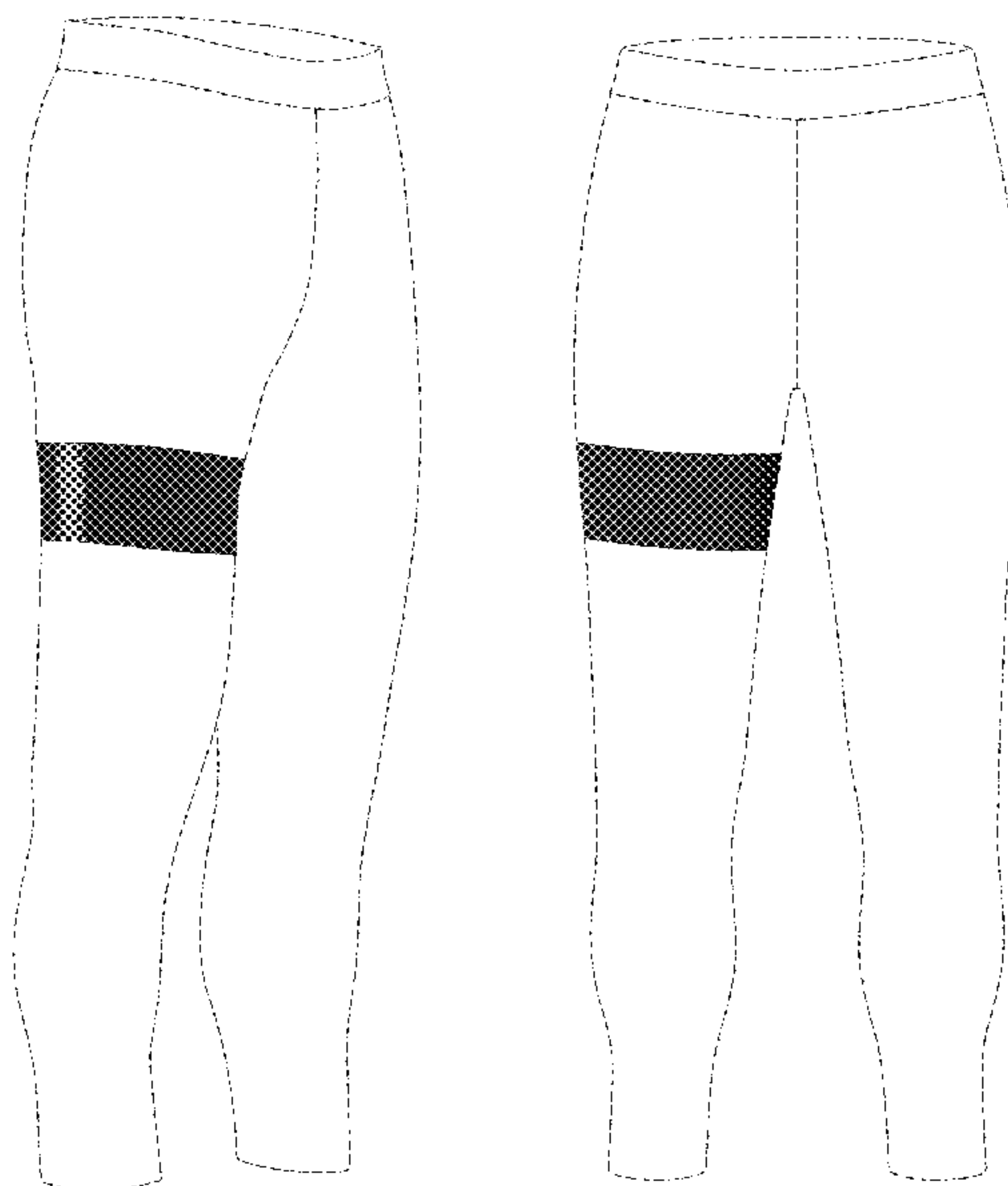
FIG. 1 is a front perspective view of a garment showing our new design according to a first embodiment;

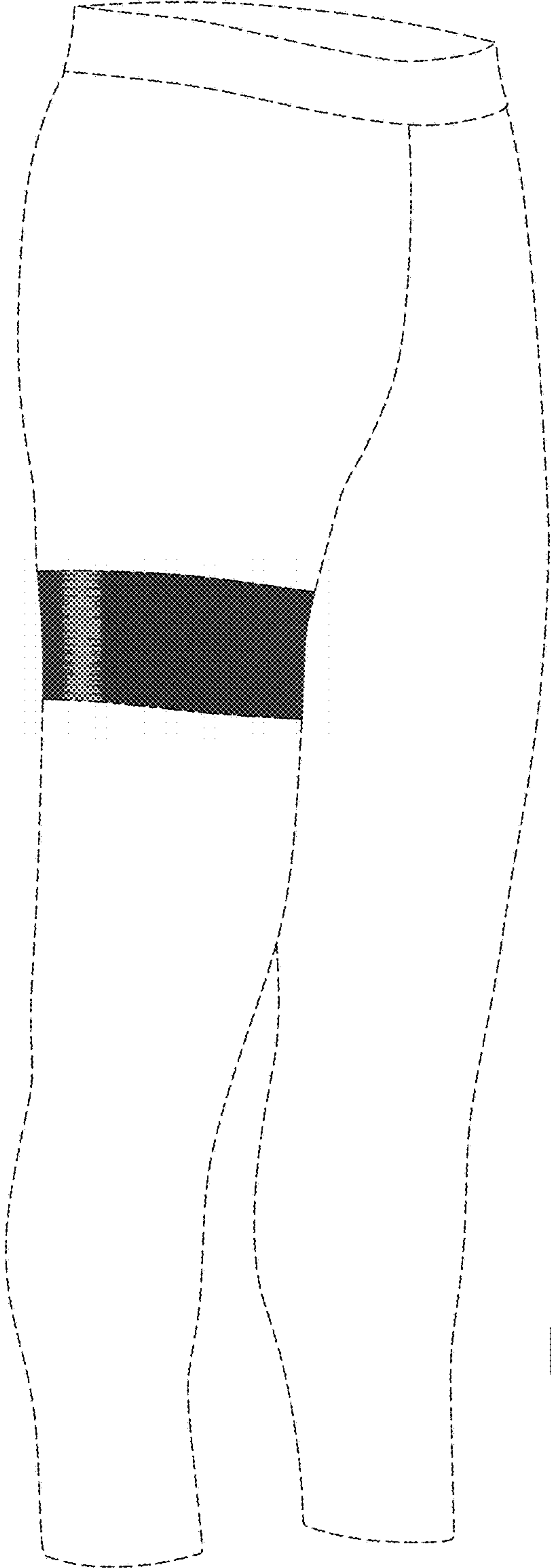

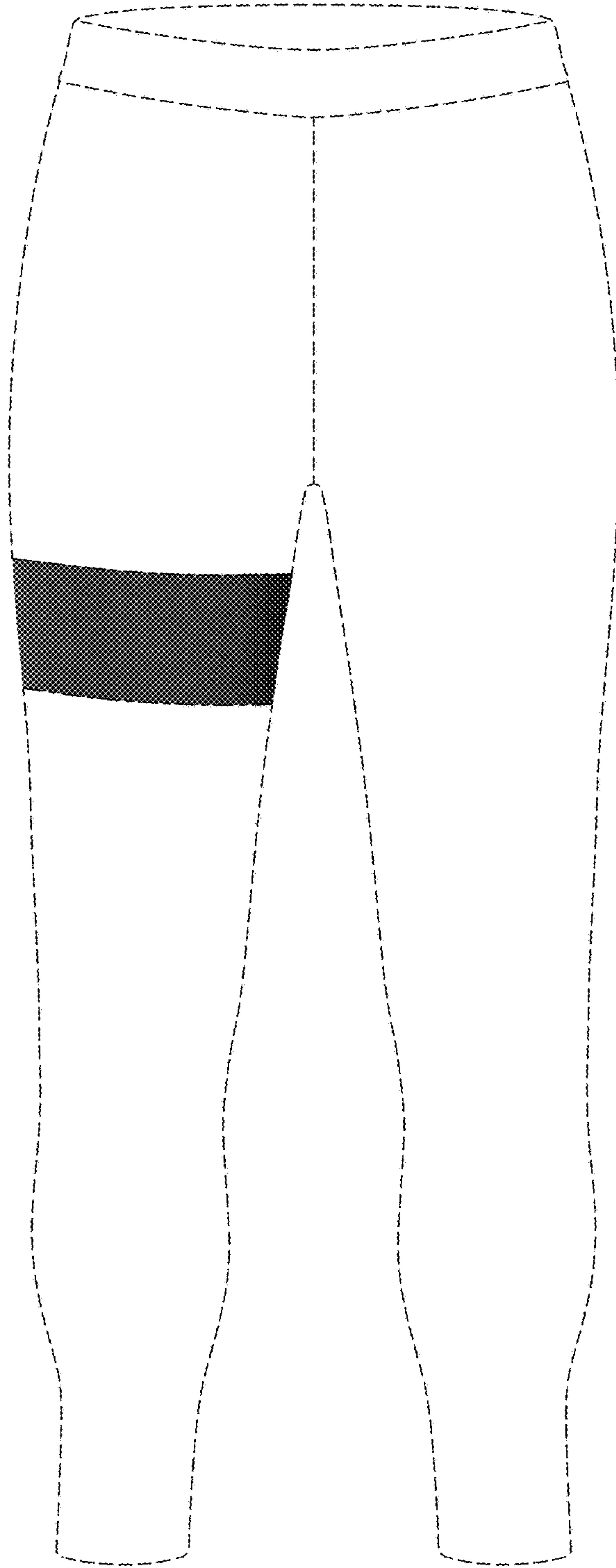

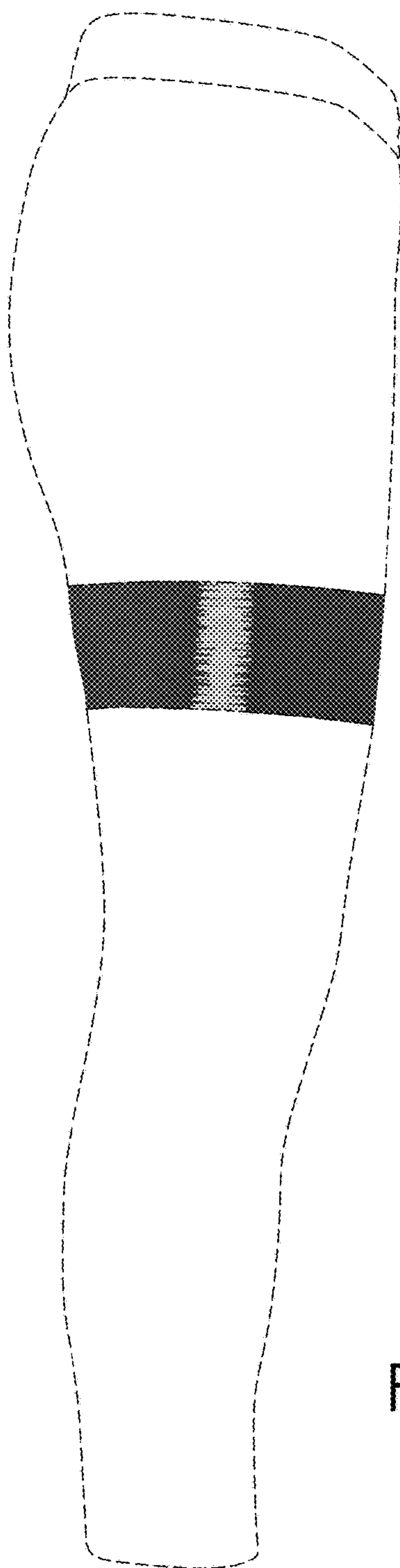

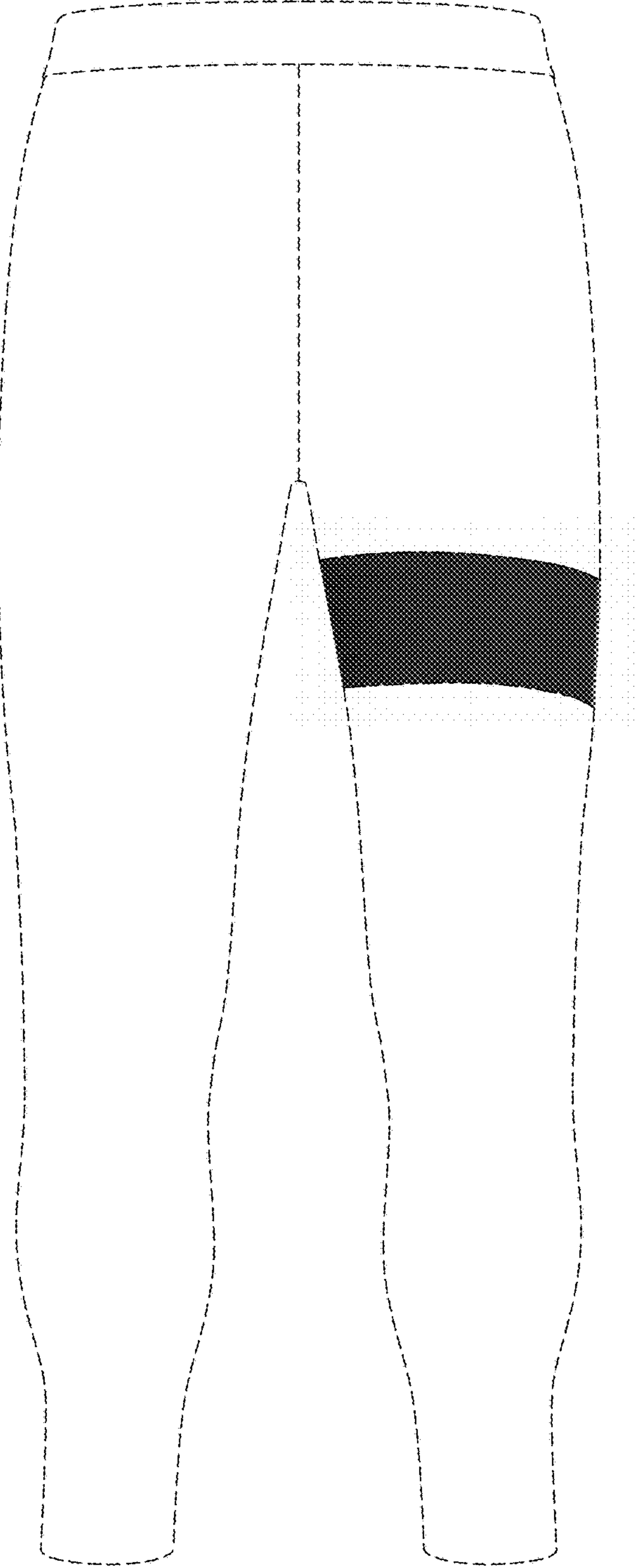

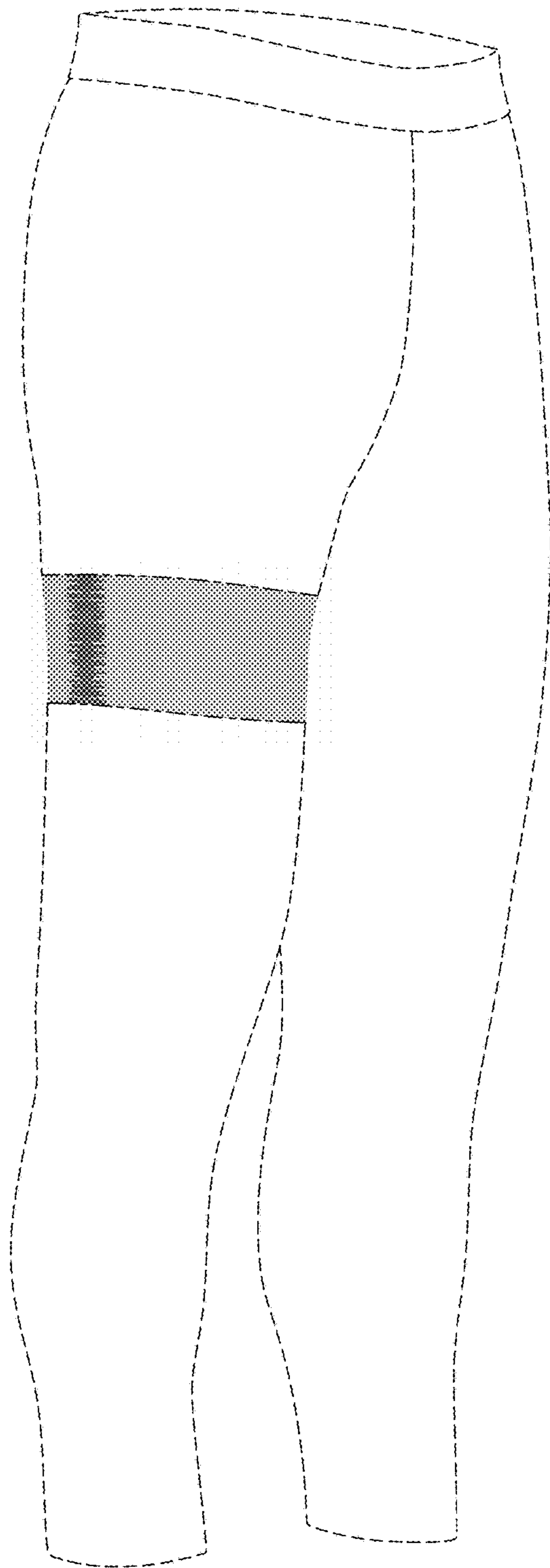

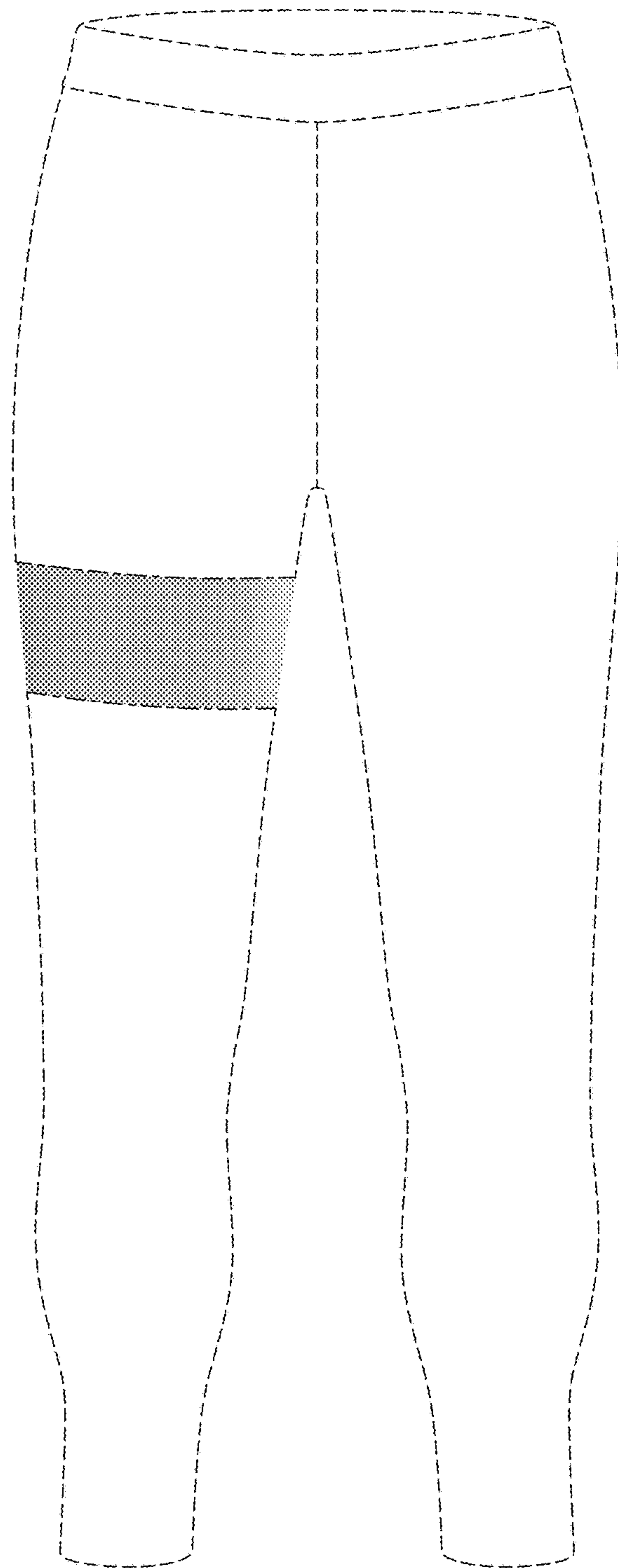

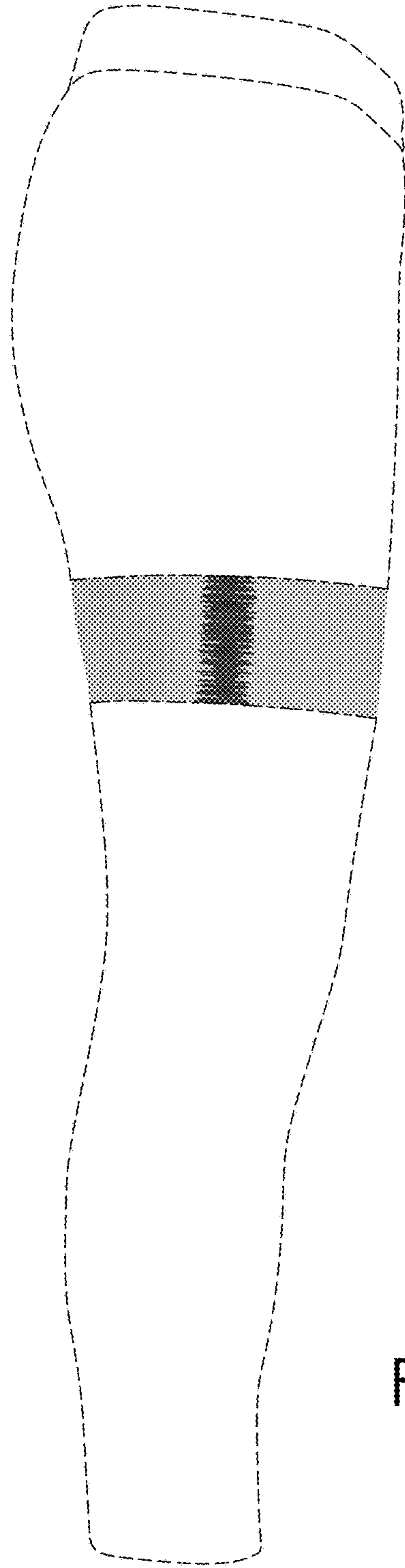

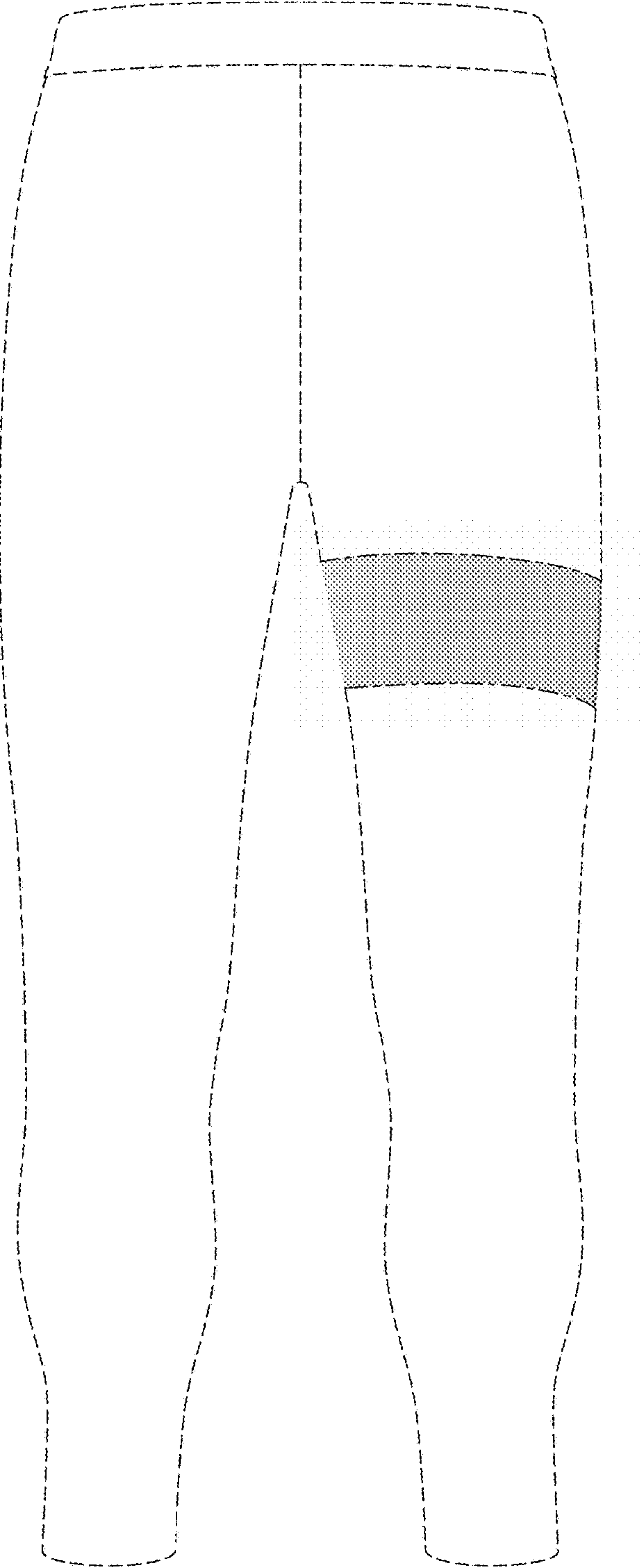
