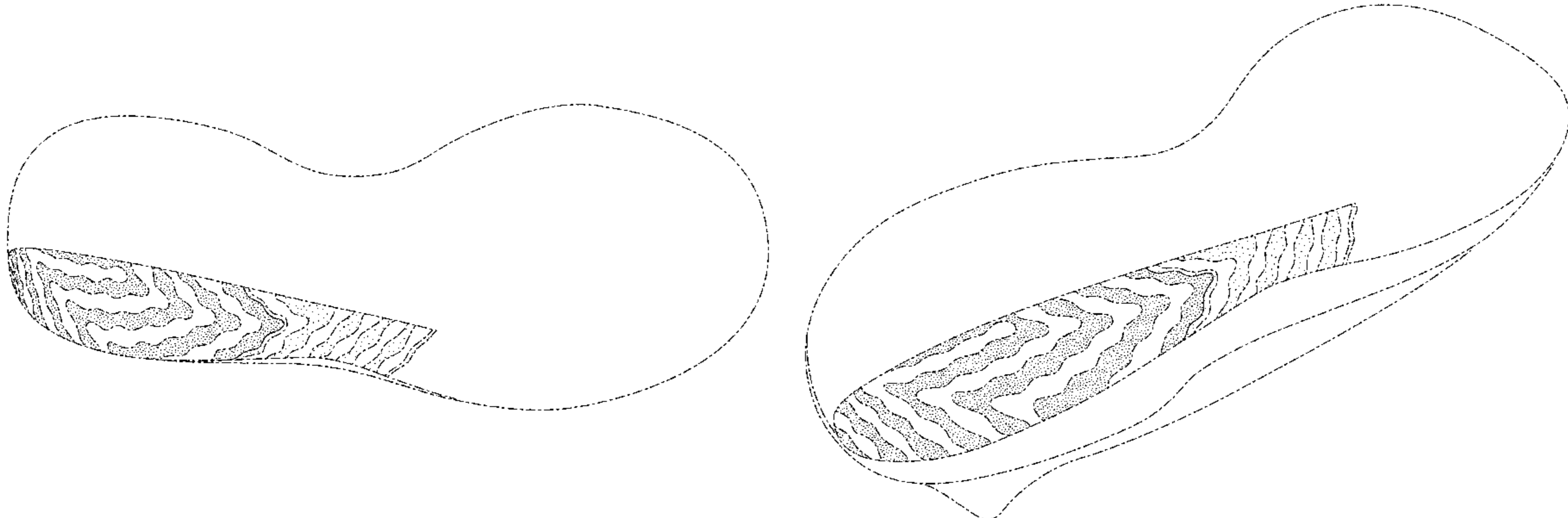
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom view of a shoe showing my new design; and,  
FIG. 2 is a rear bottom perspective view thereof.  
The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The broken lines showing the groove elements form no part of the claimed design. The contrast in shading represents a contrast in appearance only and does not represent any particular color. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

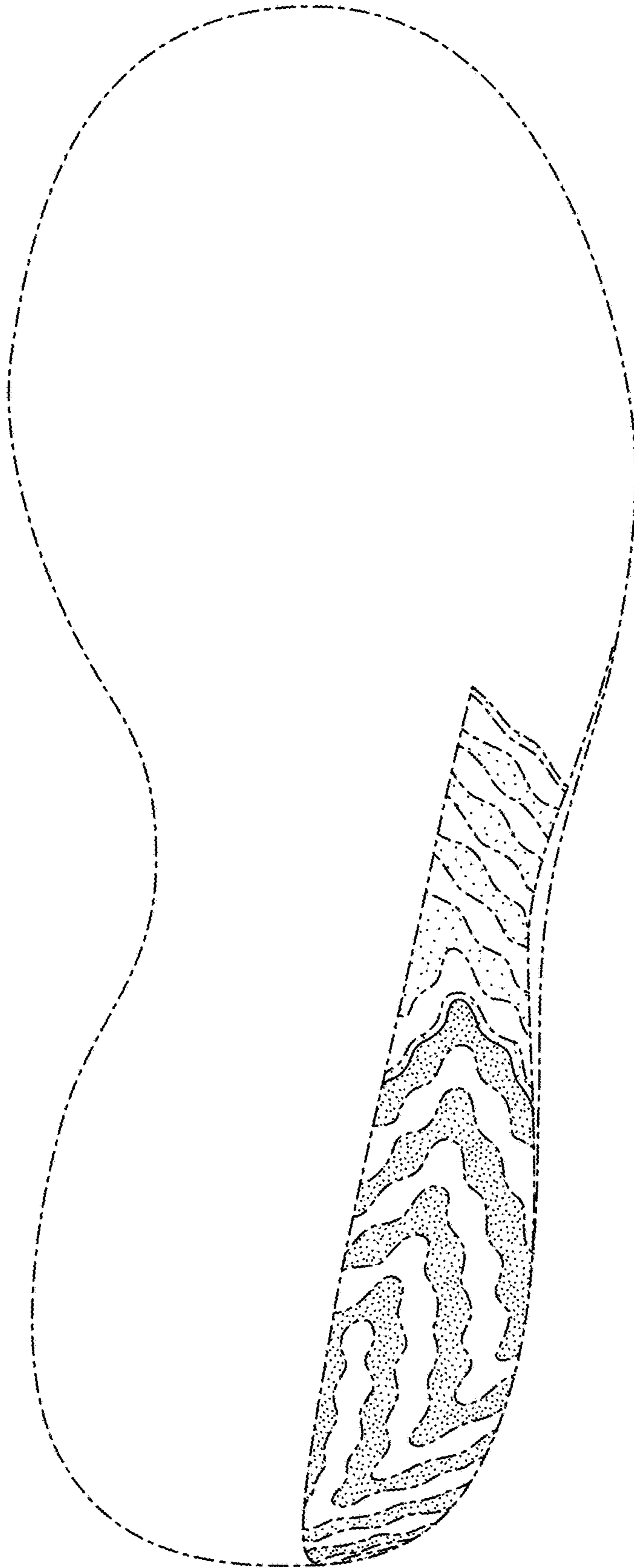

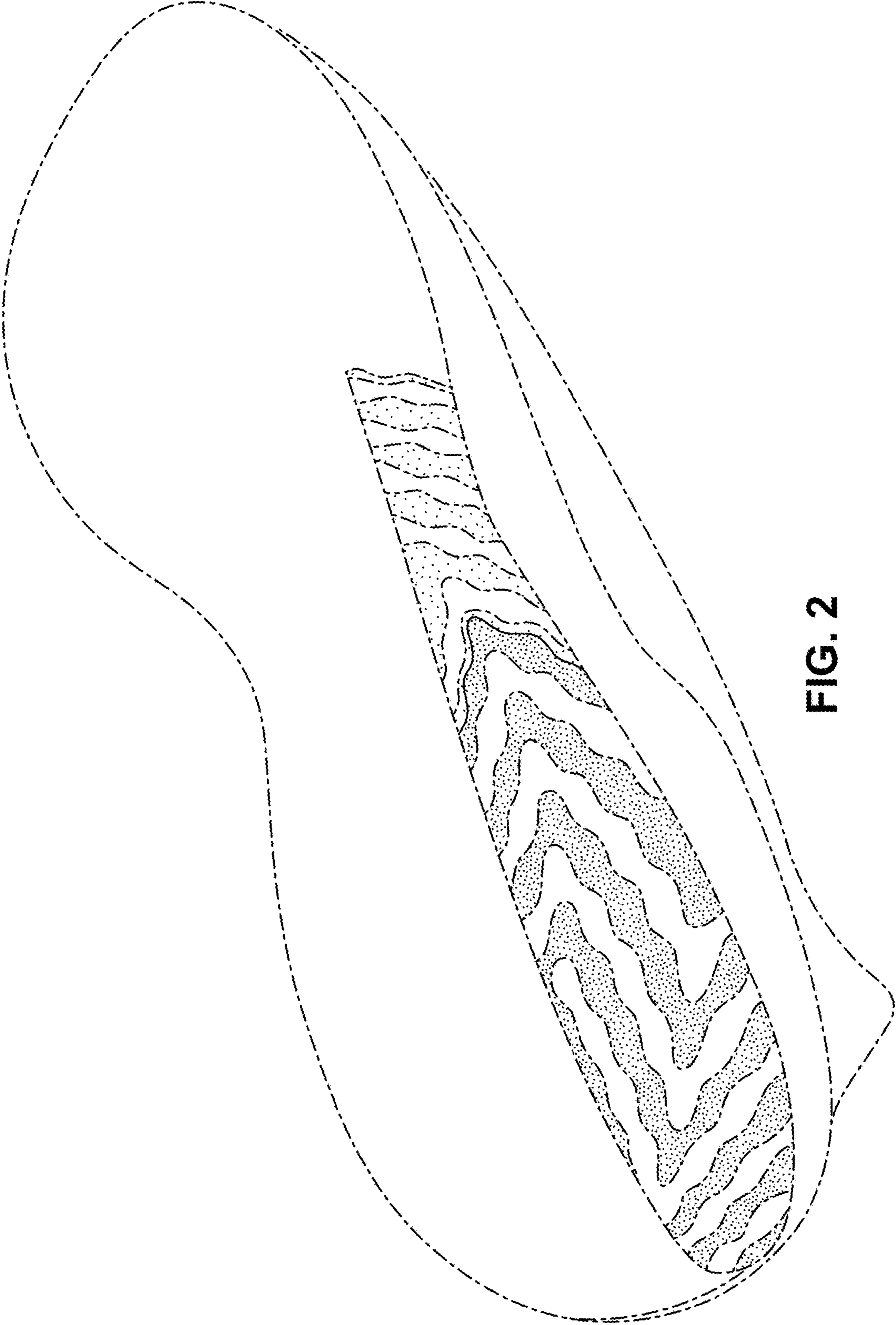
