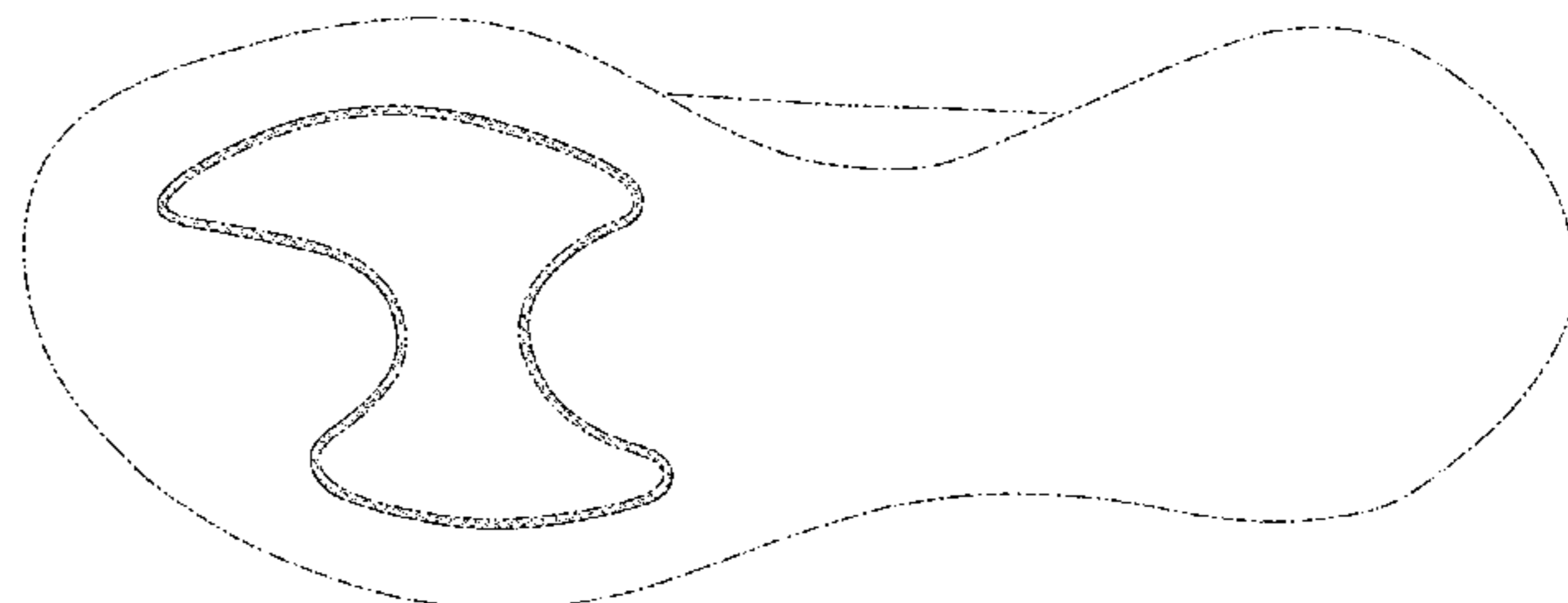
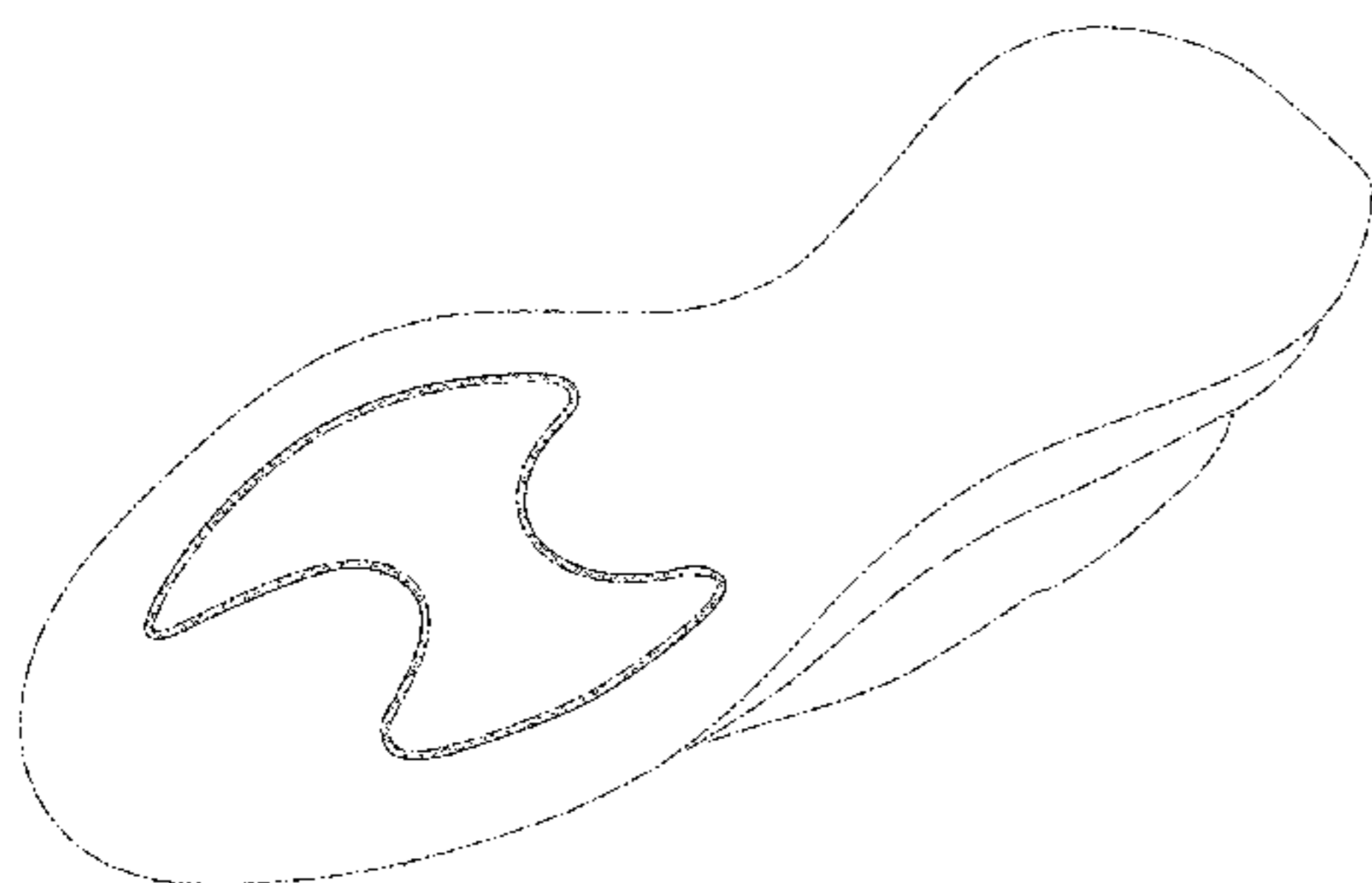
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;
 FIG. 2 is a bottom view thereof; and,
 FIG. 3 is a rear perspective view thereof.
 The broken line immediately adjacent to the shaded area defines the internal bounds of the claimed design and forms no part thereof. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

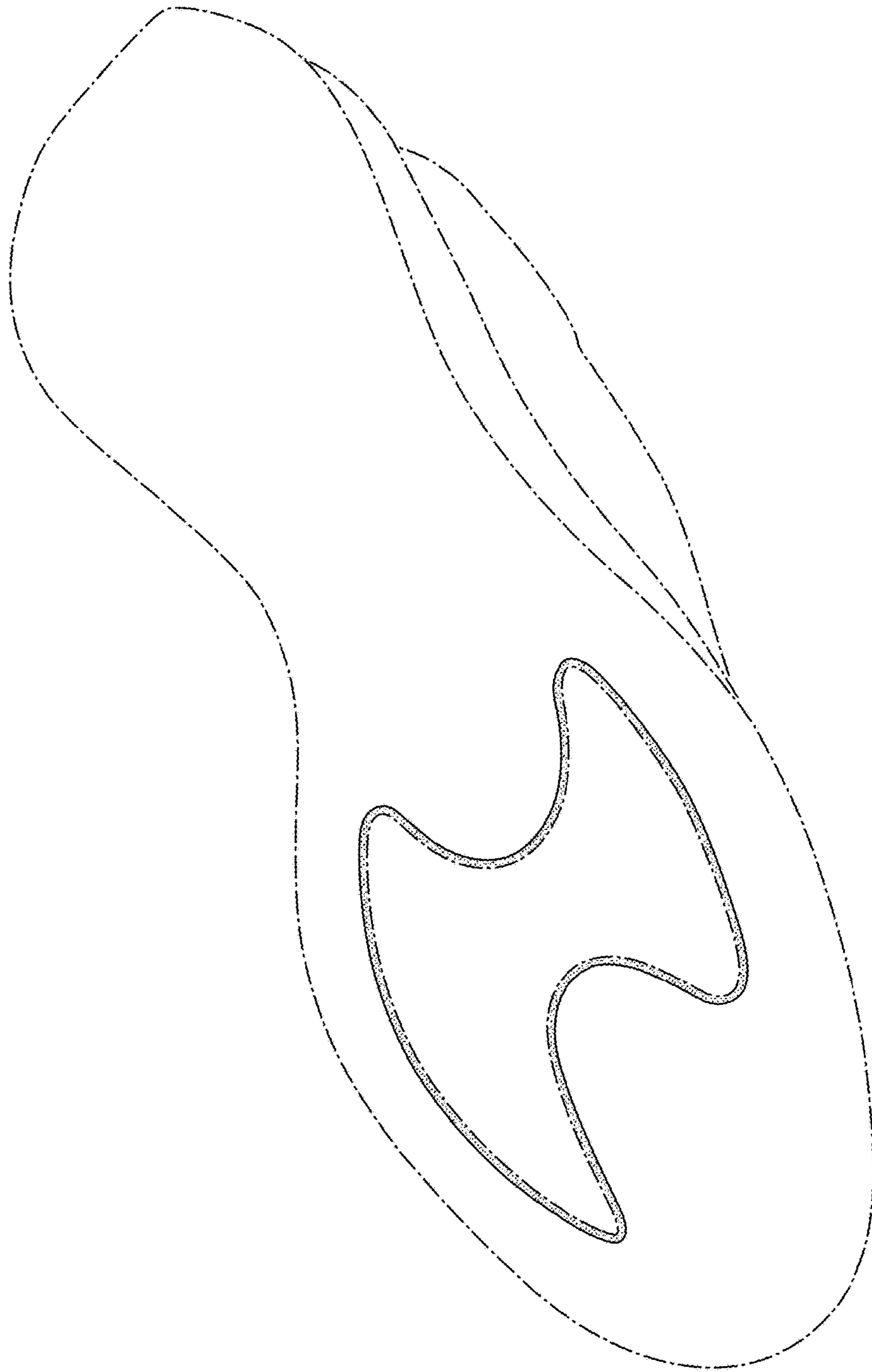

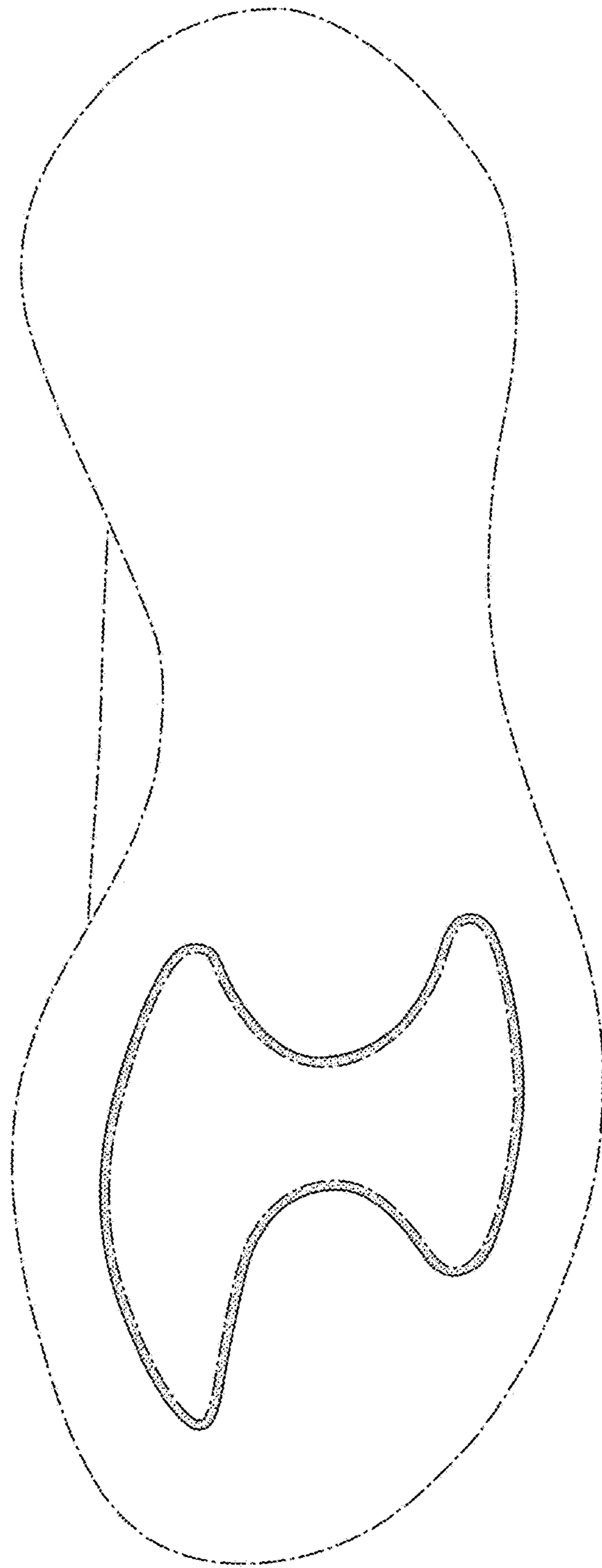

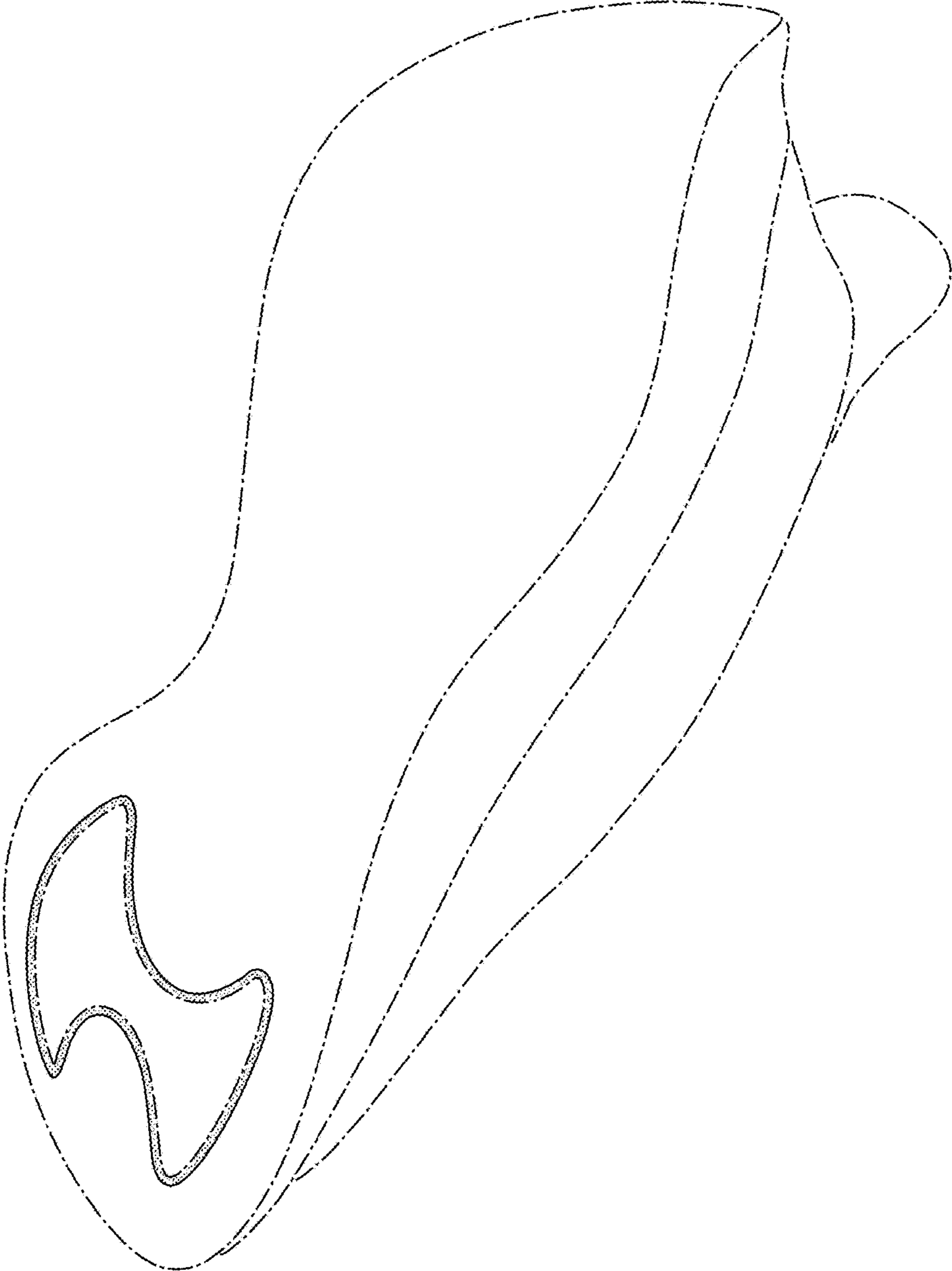
