FIG. 2 is another perspective view from above with the handles unclasp.

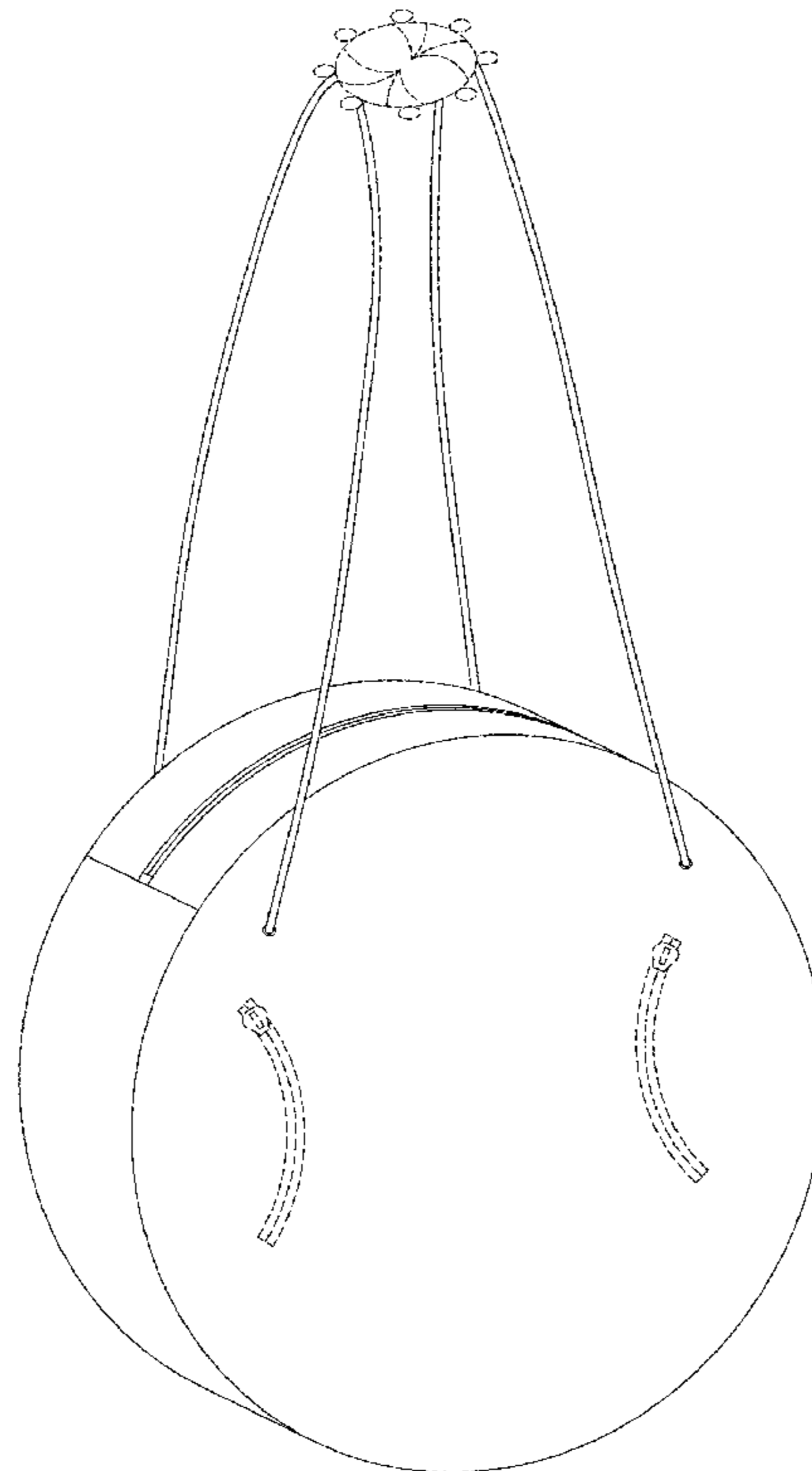
FIG. 3 is a side view thereof;

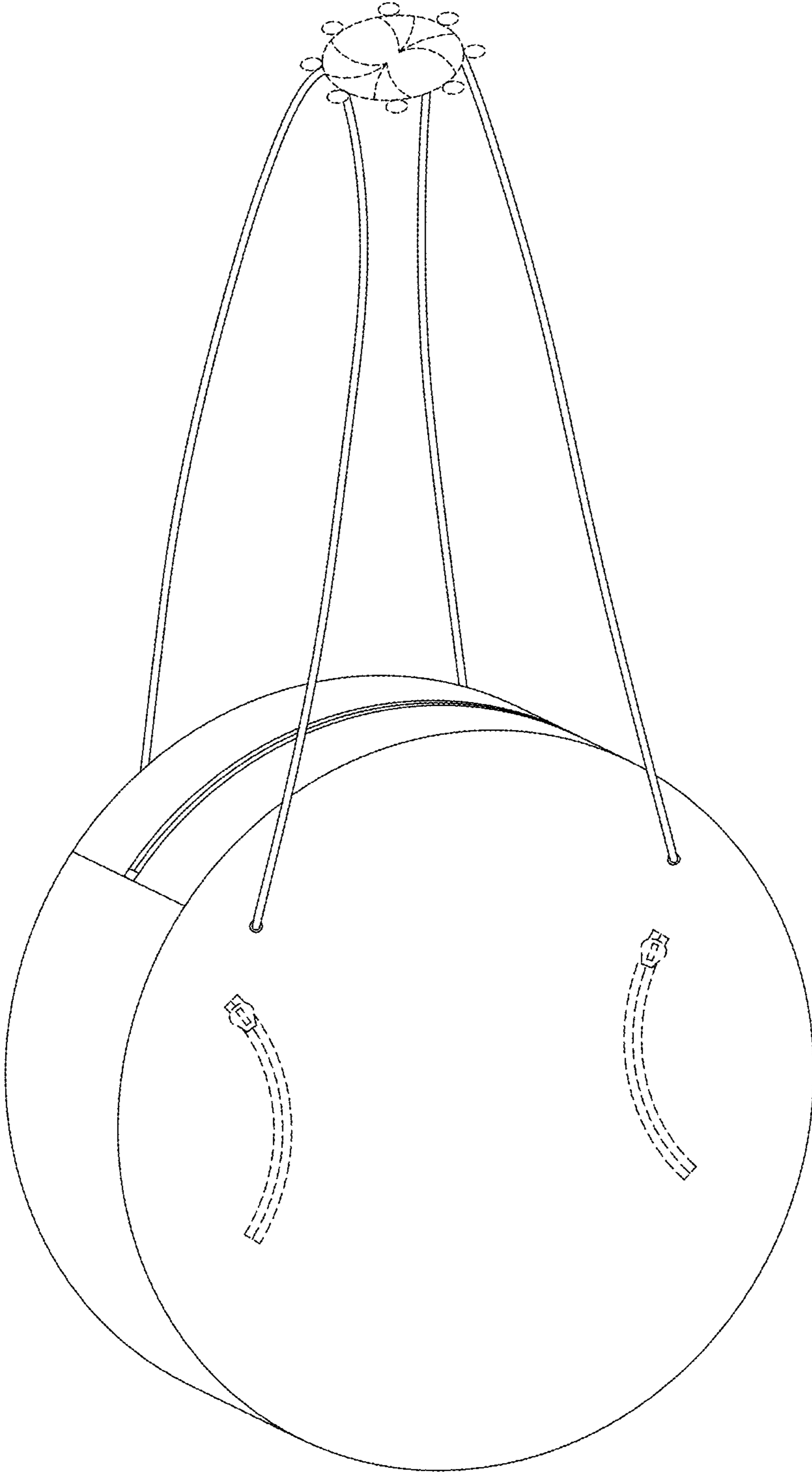

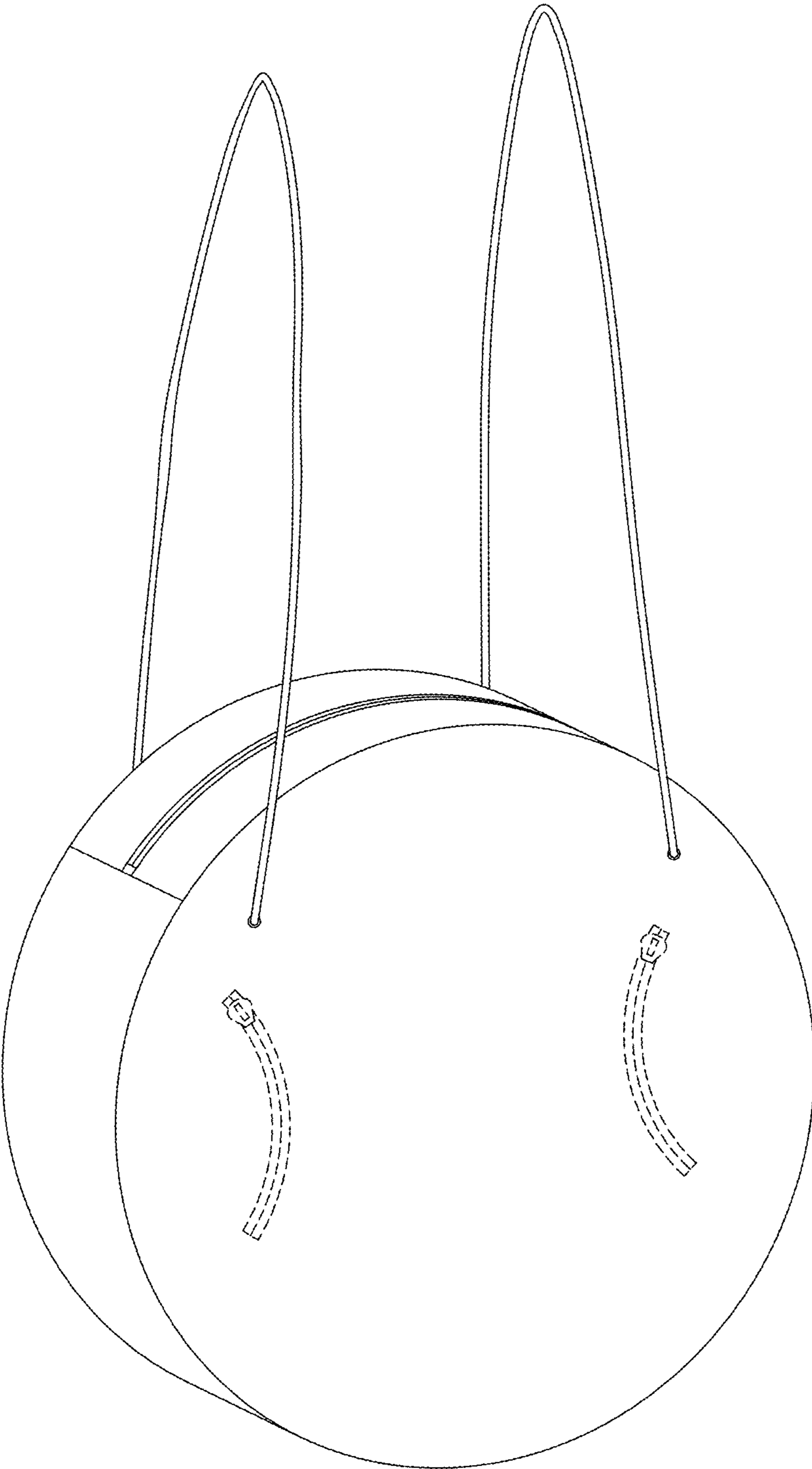

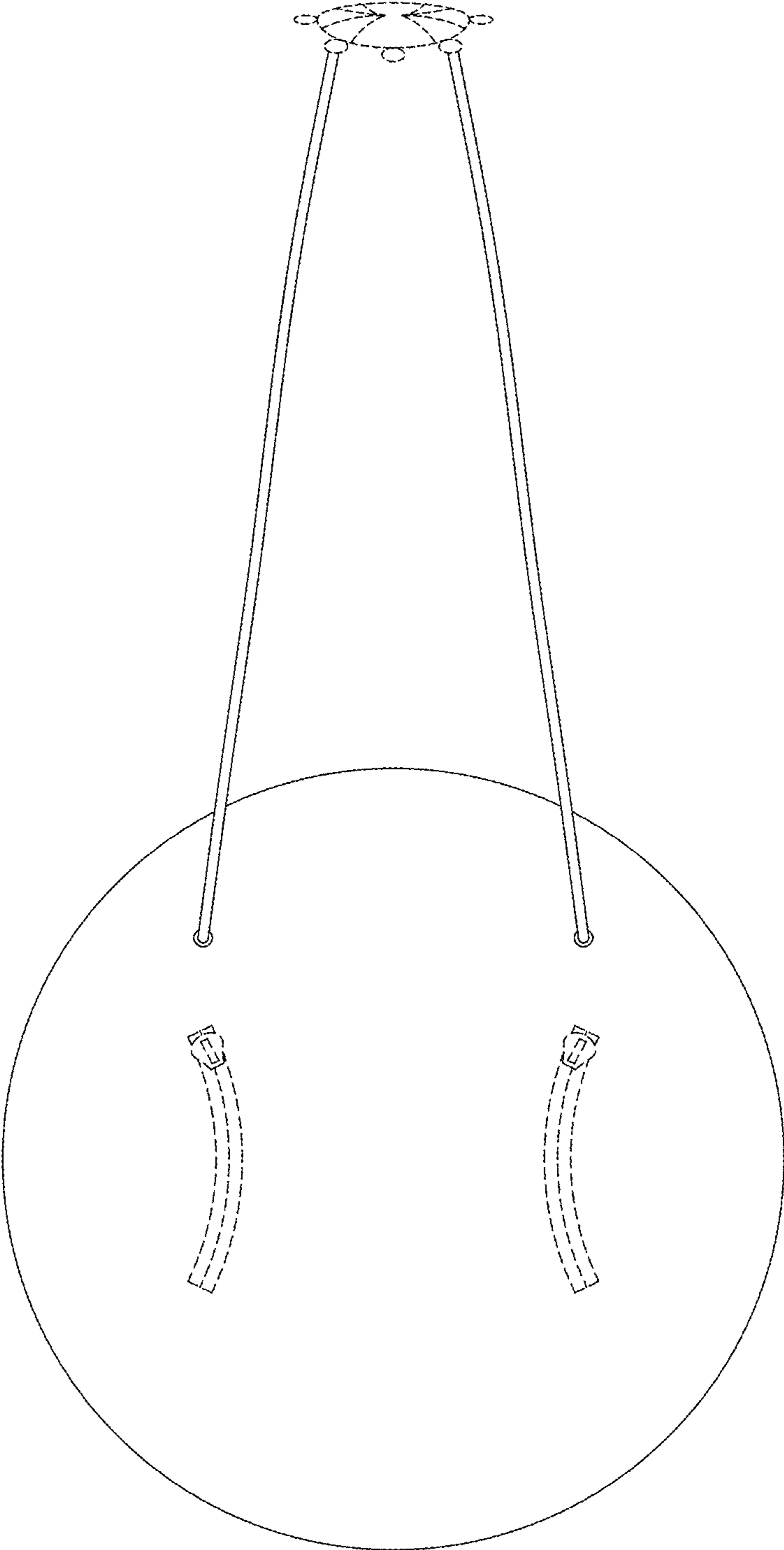

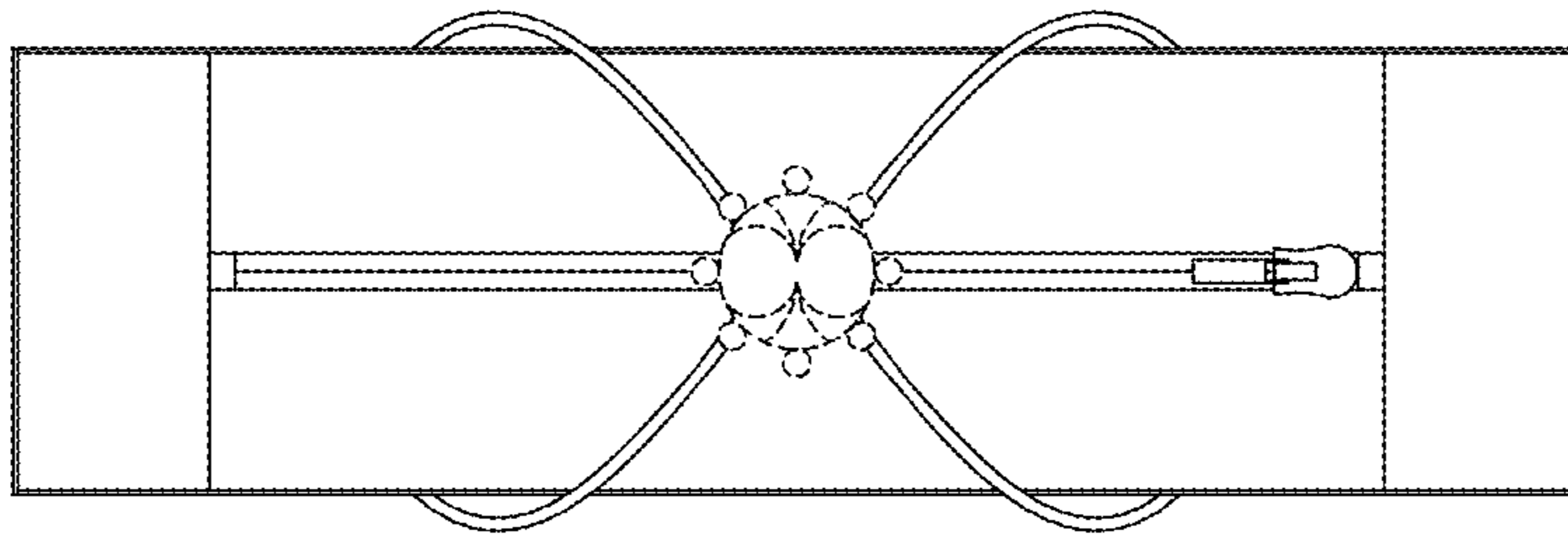

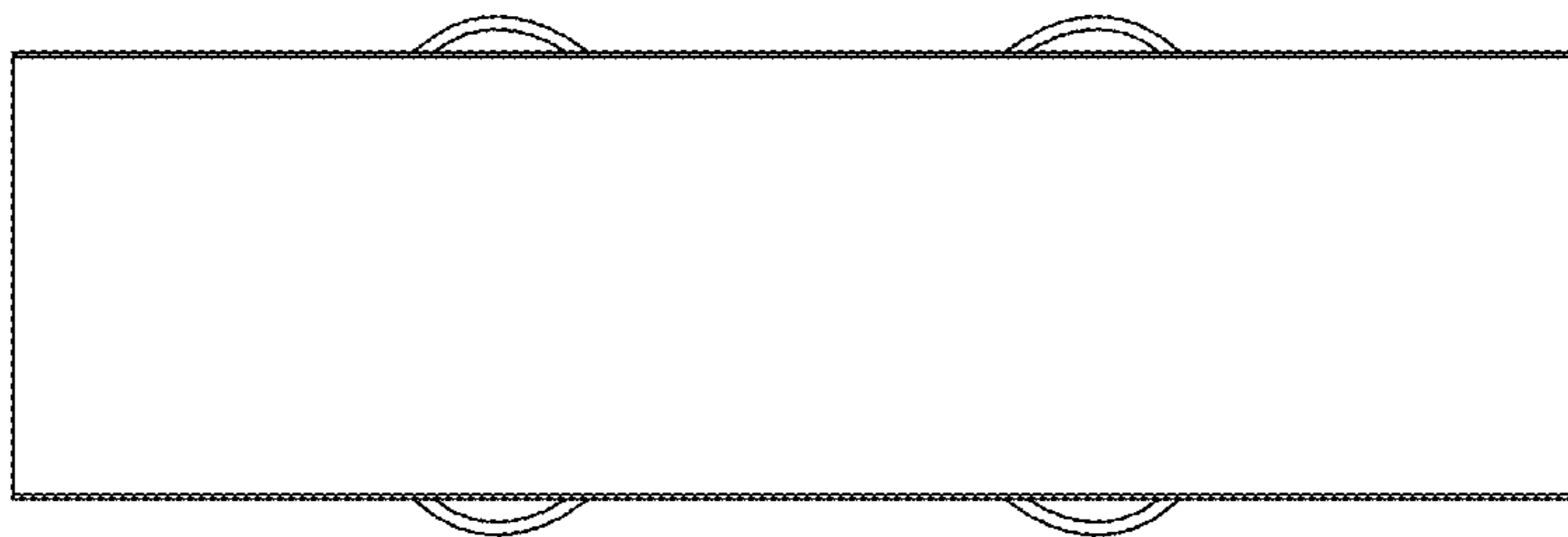
