1. Travel case with compartments for the transport of glasses and contact lenses

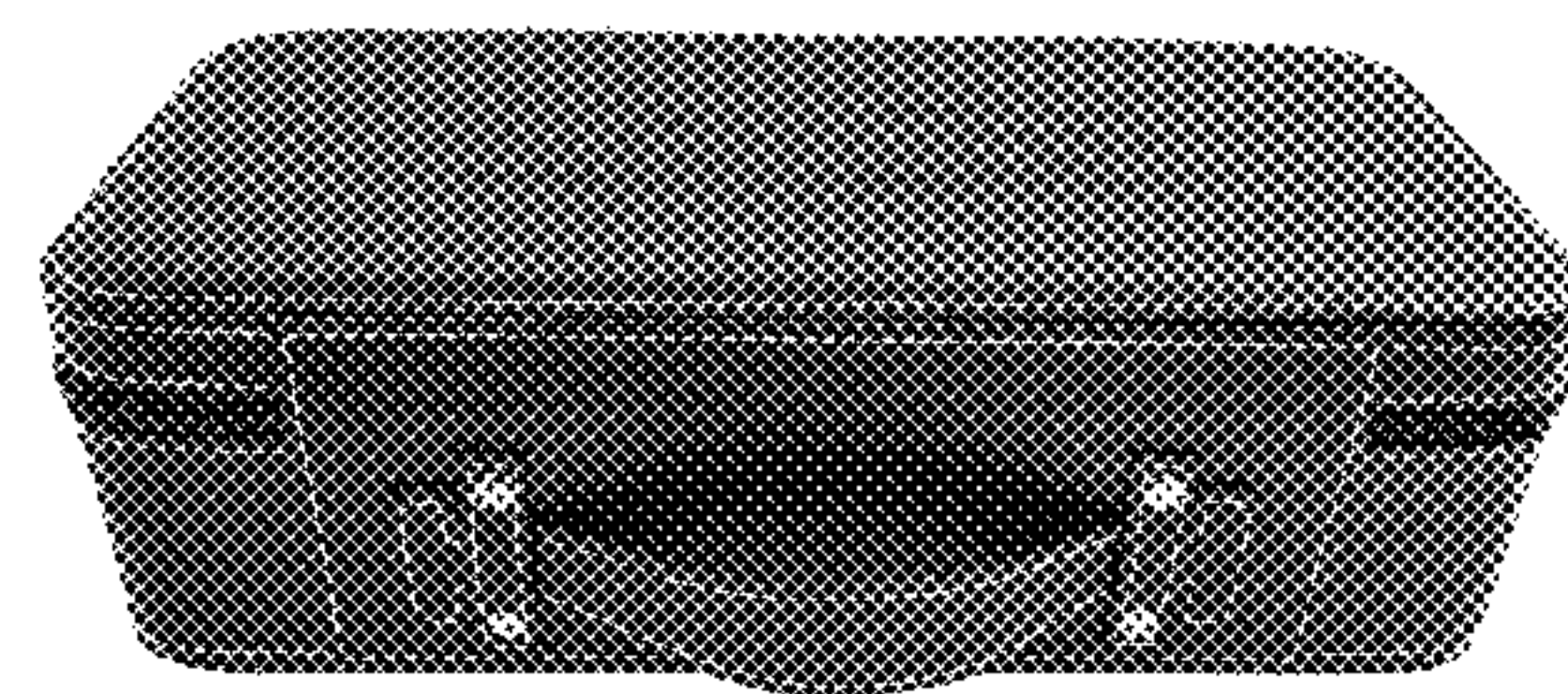
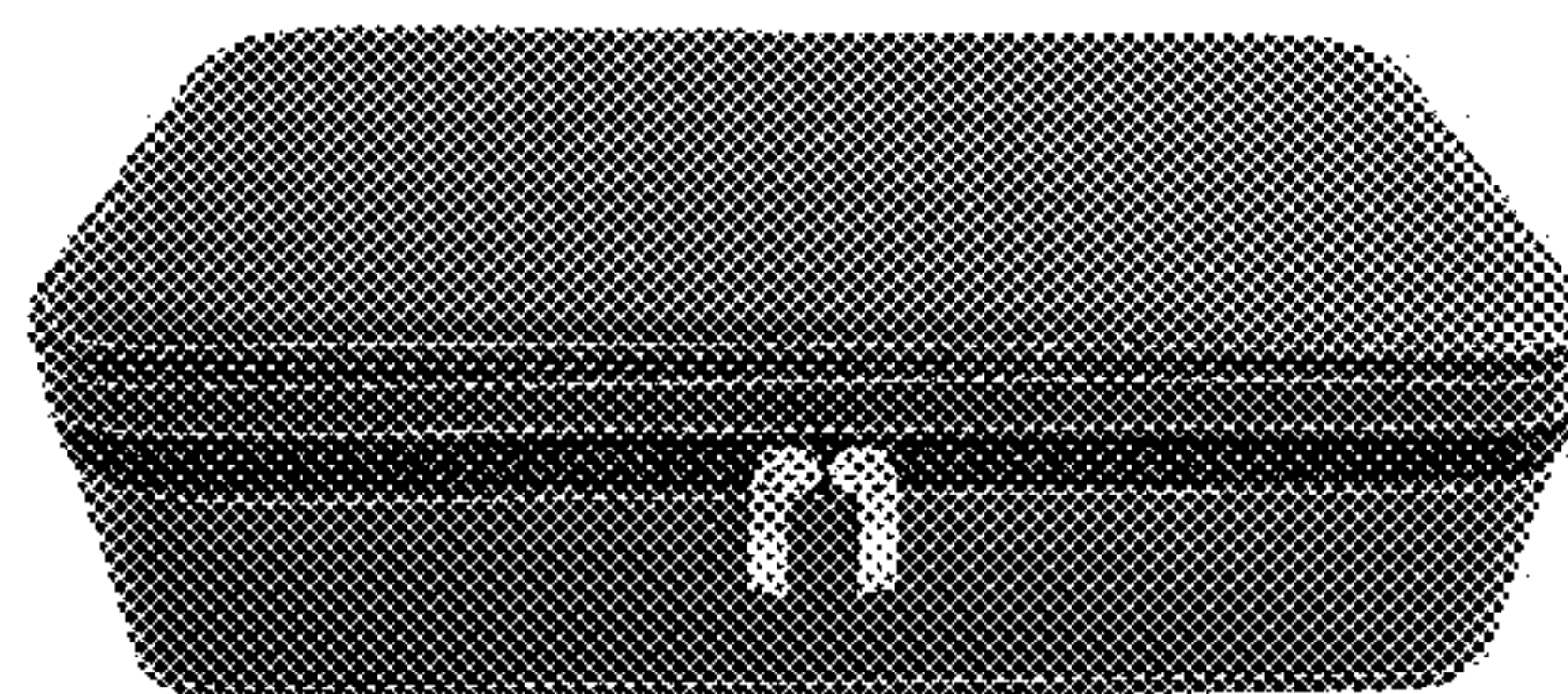
1.1 is a front perspective view showing a new design for a travel case with compartments for the transport of glasses and contact lenses;
