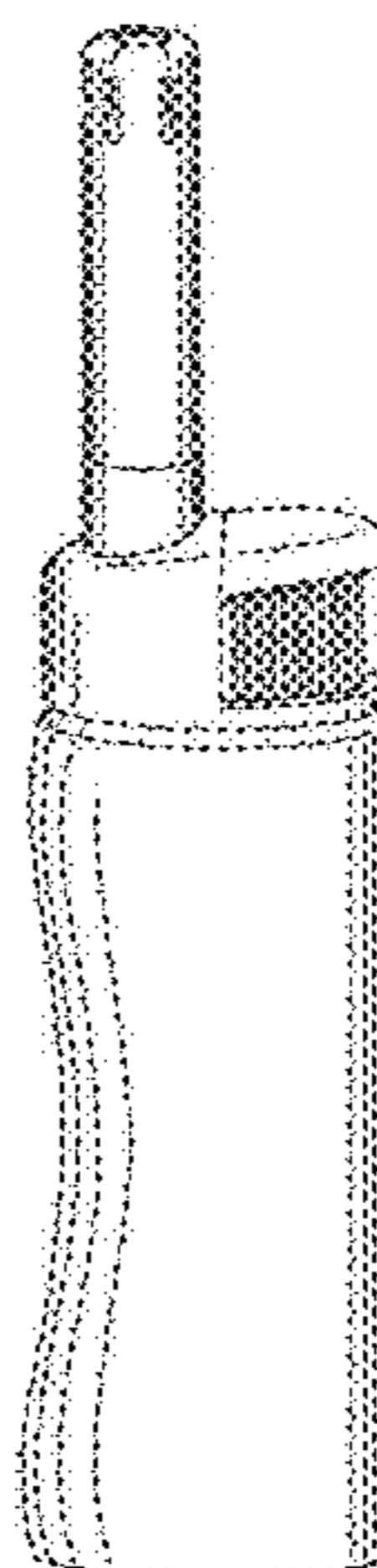
(57) **CLAIM**

The ornamental design for a mini barbecue lighter, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a mini barbecue lighter, showing my new design;  
 FIG. 2 is a left side view thereof;  
 FIG. 3 is a right side view thereof;  
 FIG. 4 is a top view thereof;  
 FIG. 5 is a bottom view thereof;  
 FIG. 6 is a front view thereof; and,  
 FIG. 7 is a back view thereof.  
 The broken lines in FIG. 5 depict portions of the mini barbecue lighter that form no part of the claimed design.

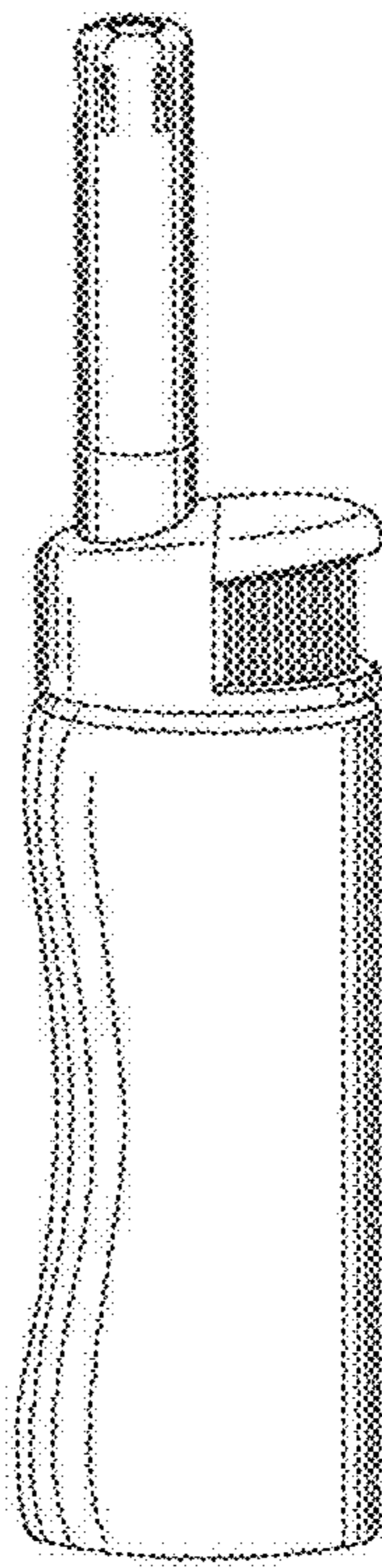

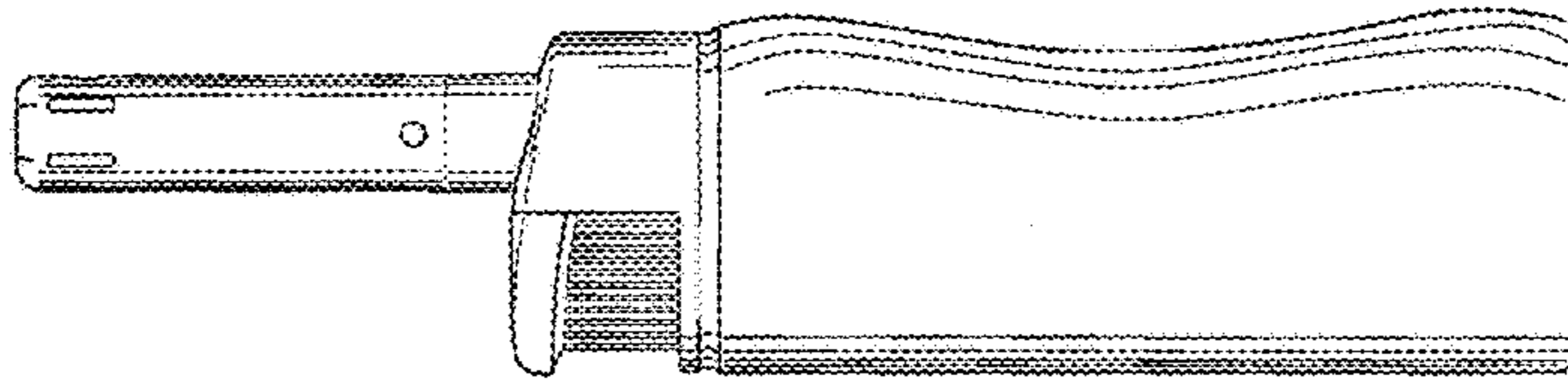

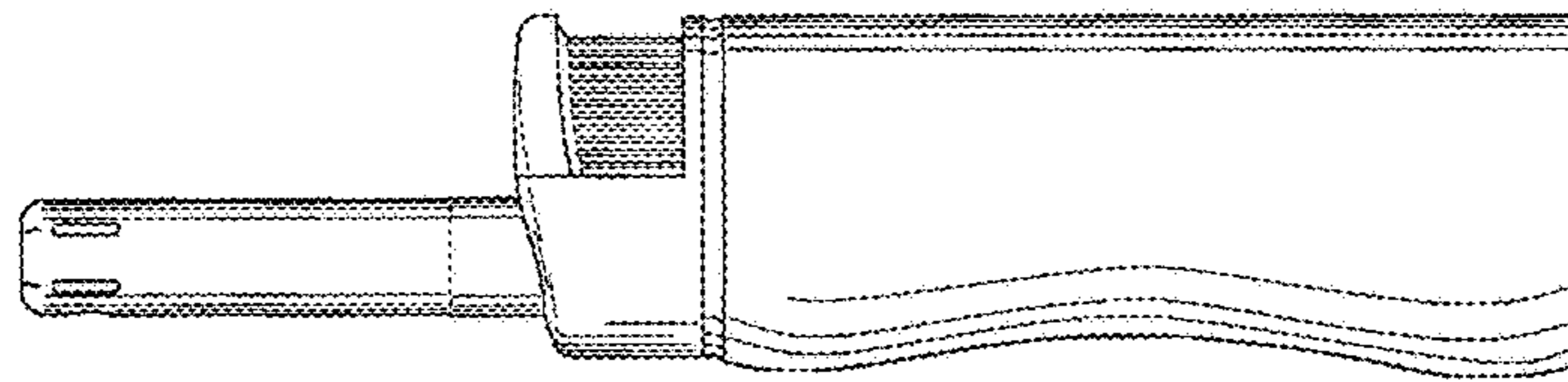

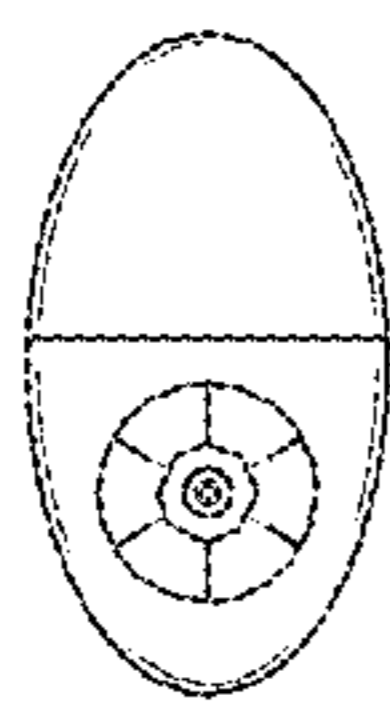

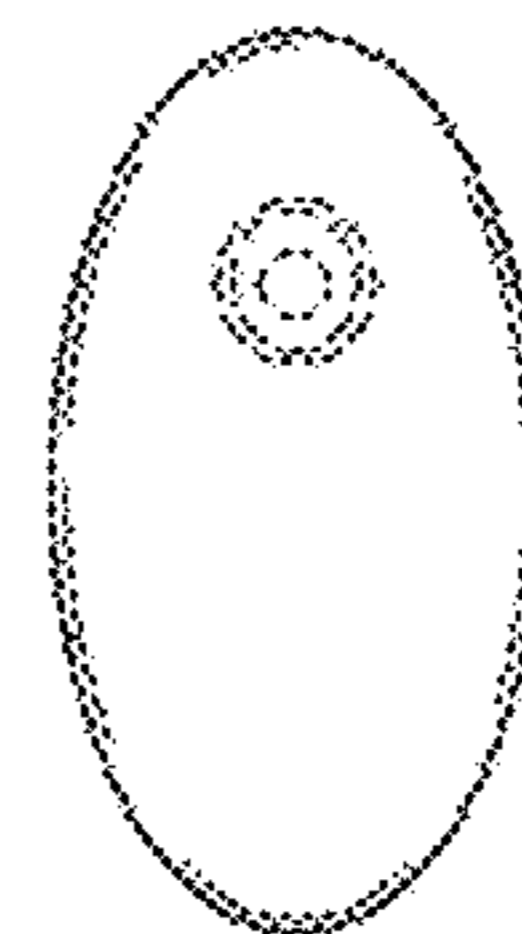

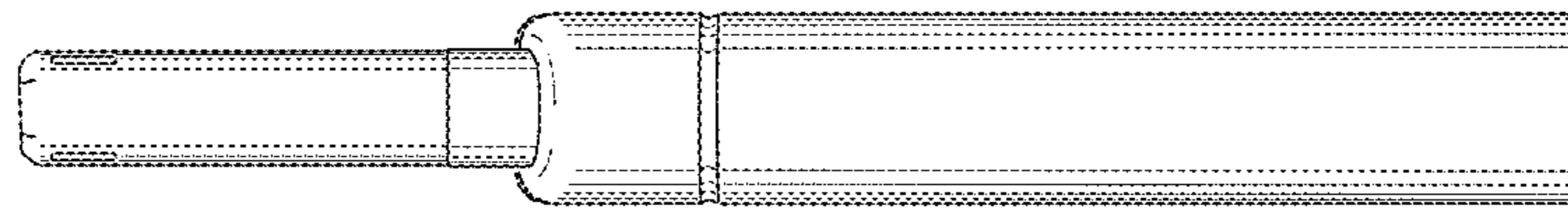

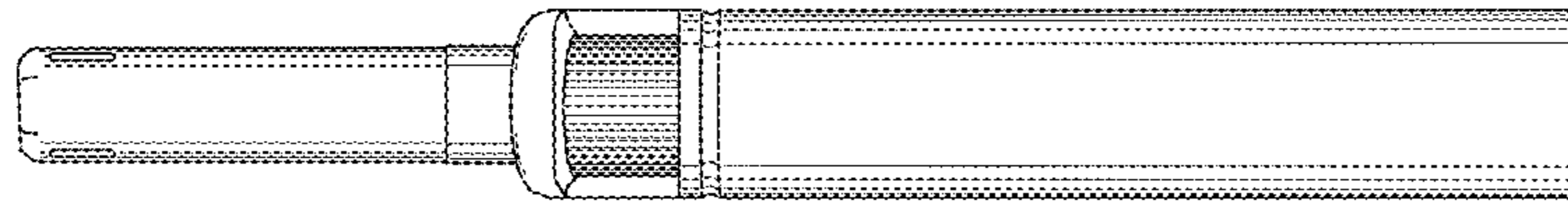
