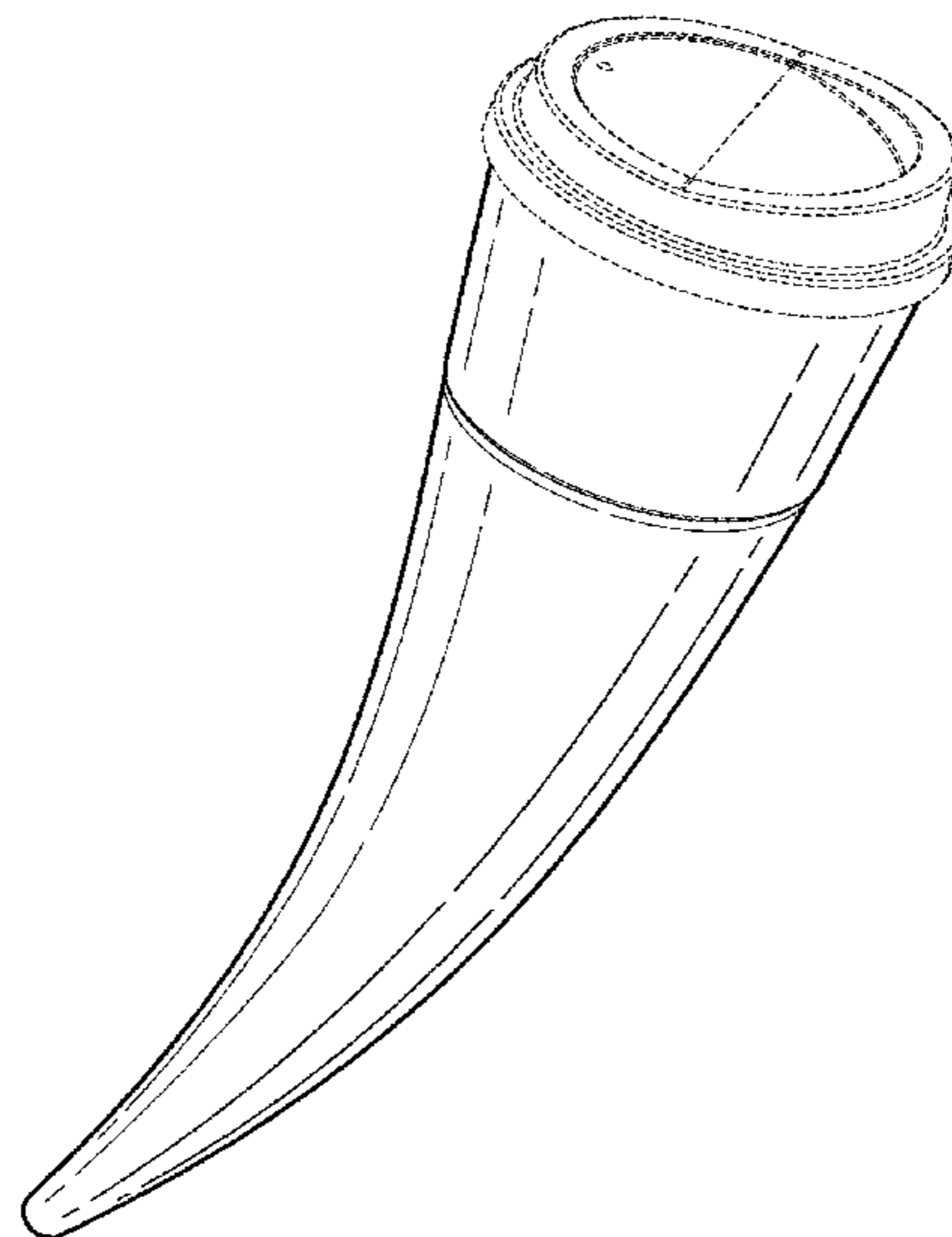
(57) **CLAIM**

The ornamental design for a drinking horn, as shown and described.

DESCRIPTION

FIG. 1 is a right perspective view of a first embodiment of a drinking horn showing my new design; FIG. 2 is a back elevation view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; and, FIG. 7 is a right side elevation view of a second embodiment of a drinking horn, showing my new design. The broken lines shown in the drawings illustrate portions of the drinking horn that form no part of the claimed design.

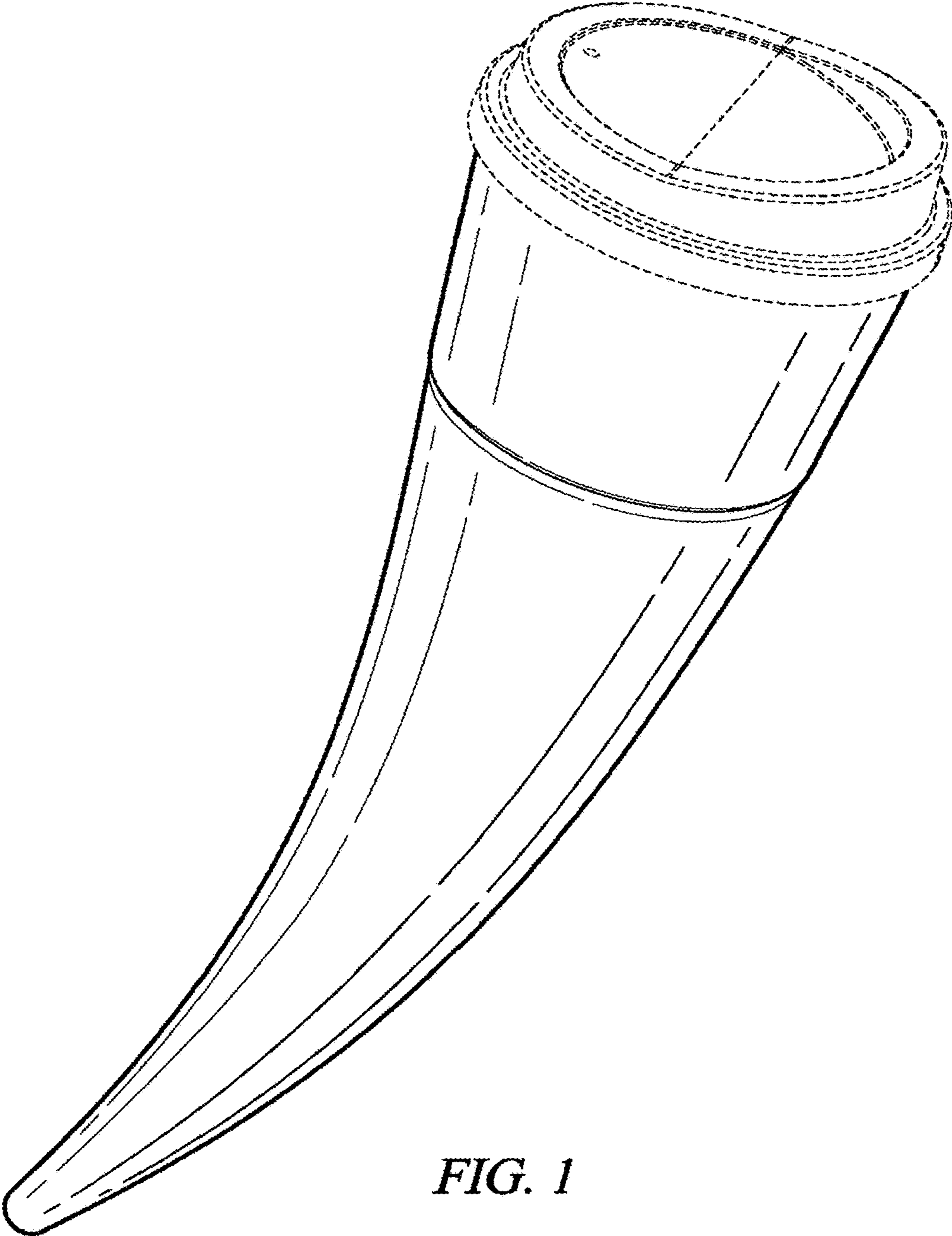

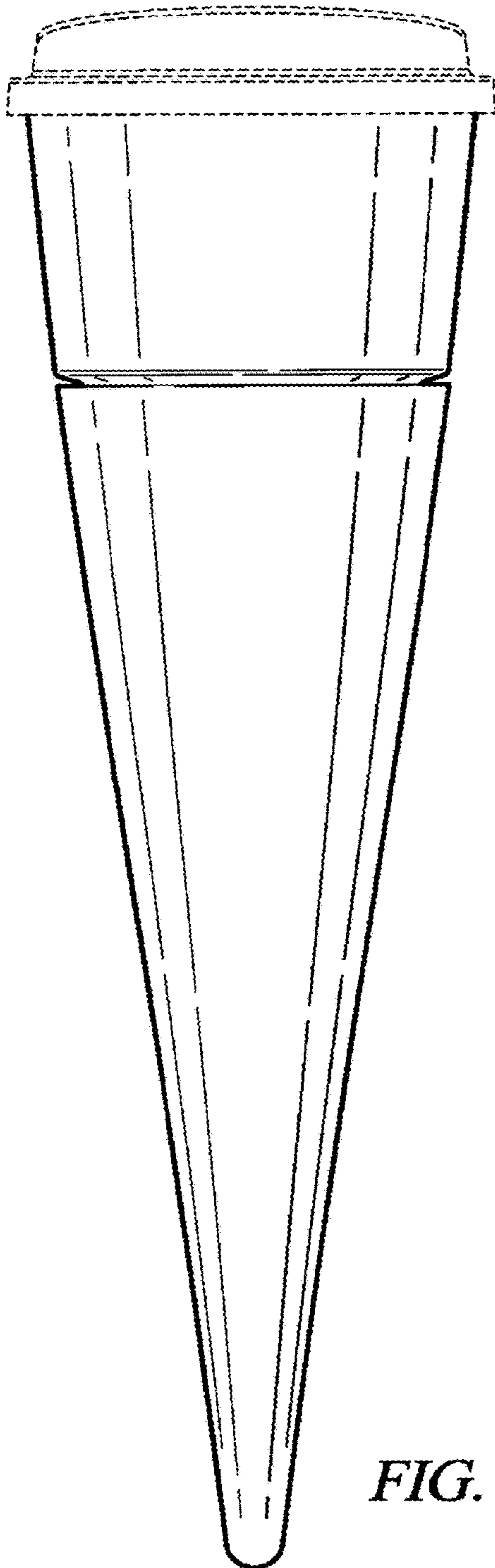

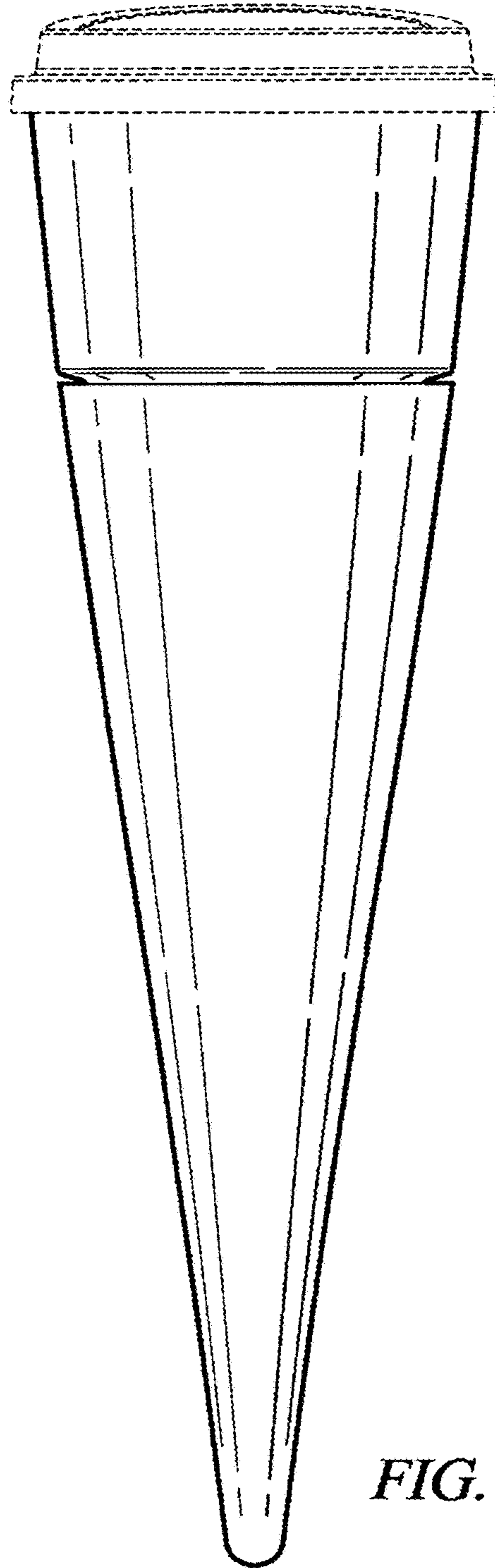

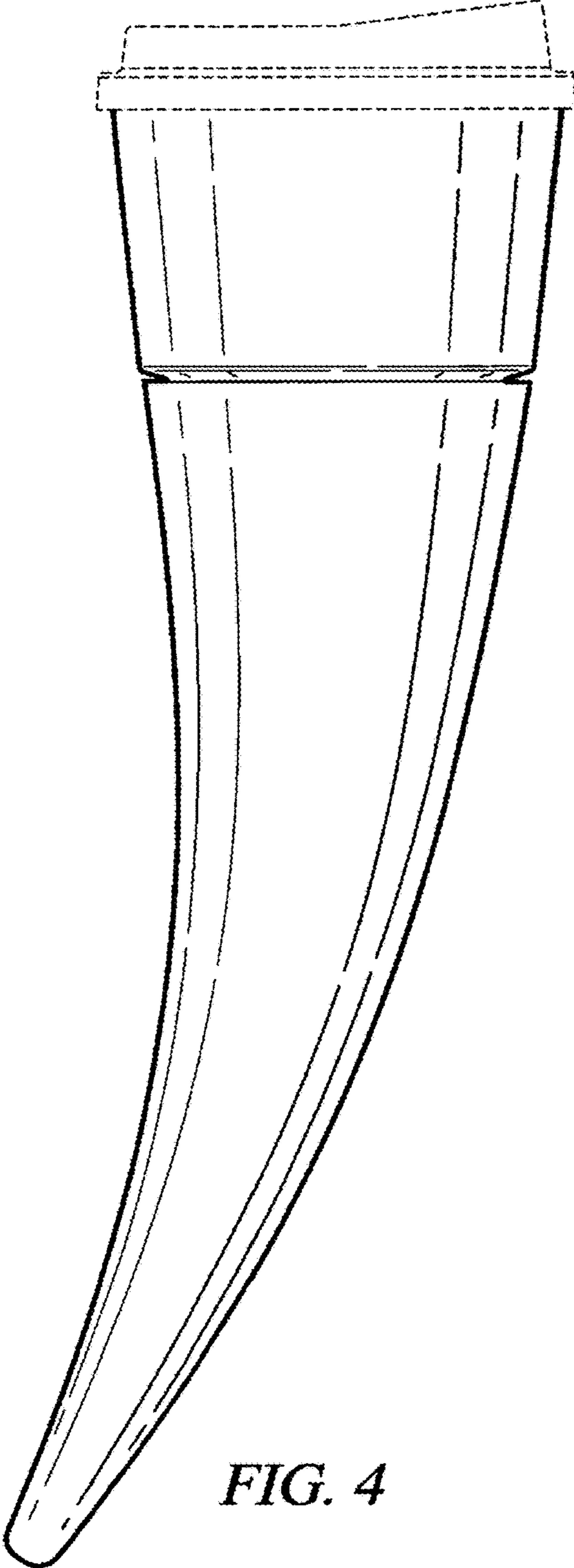

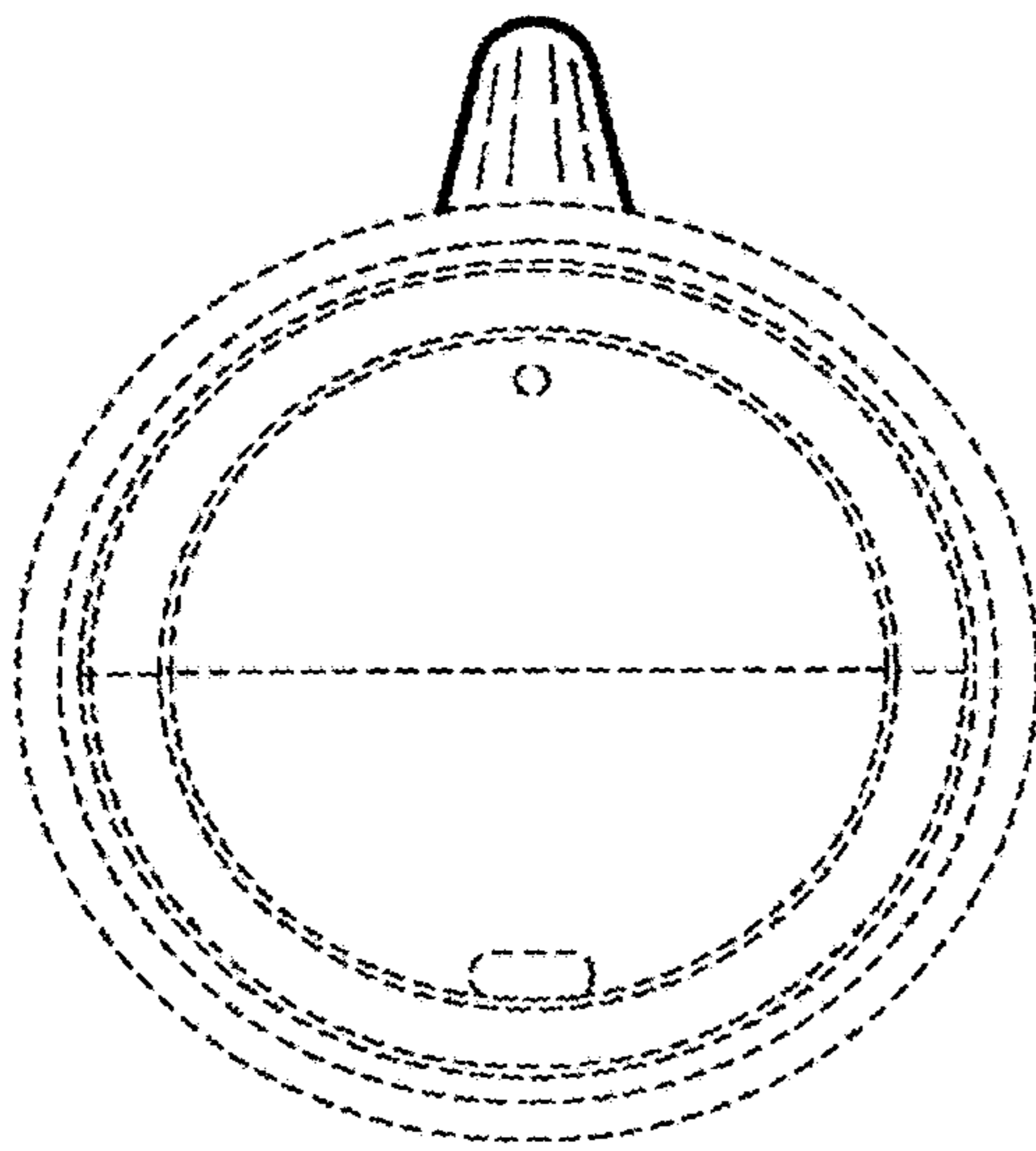

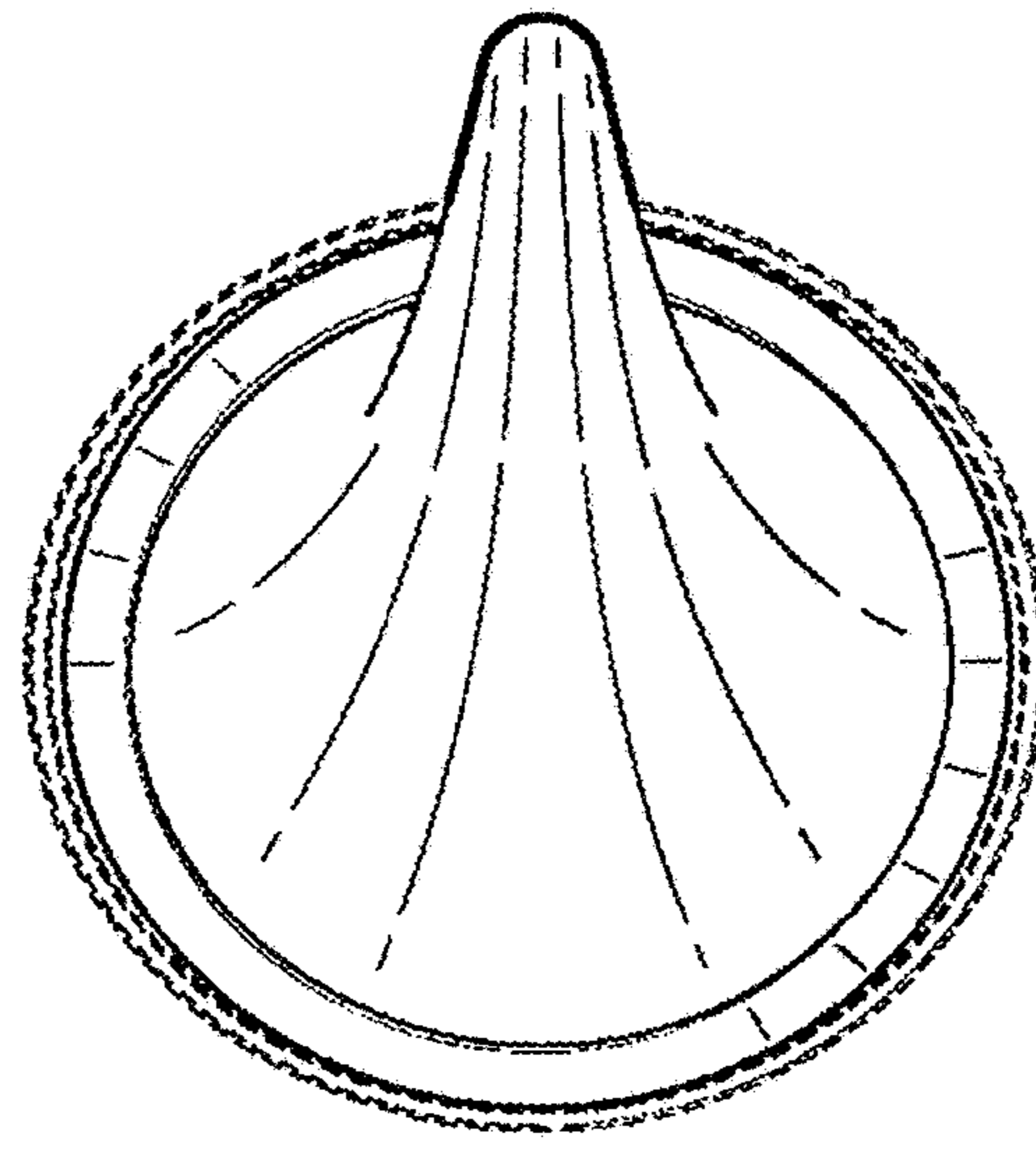

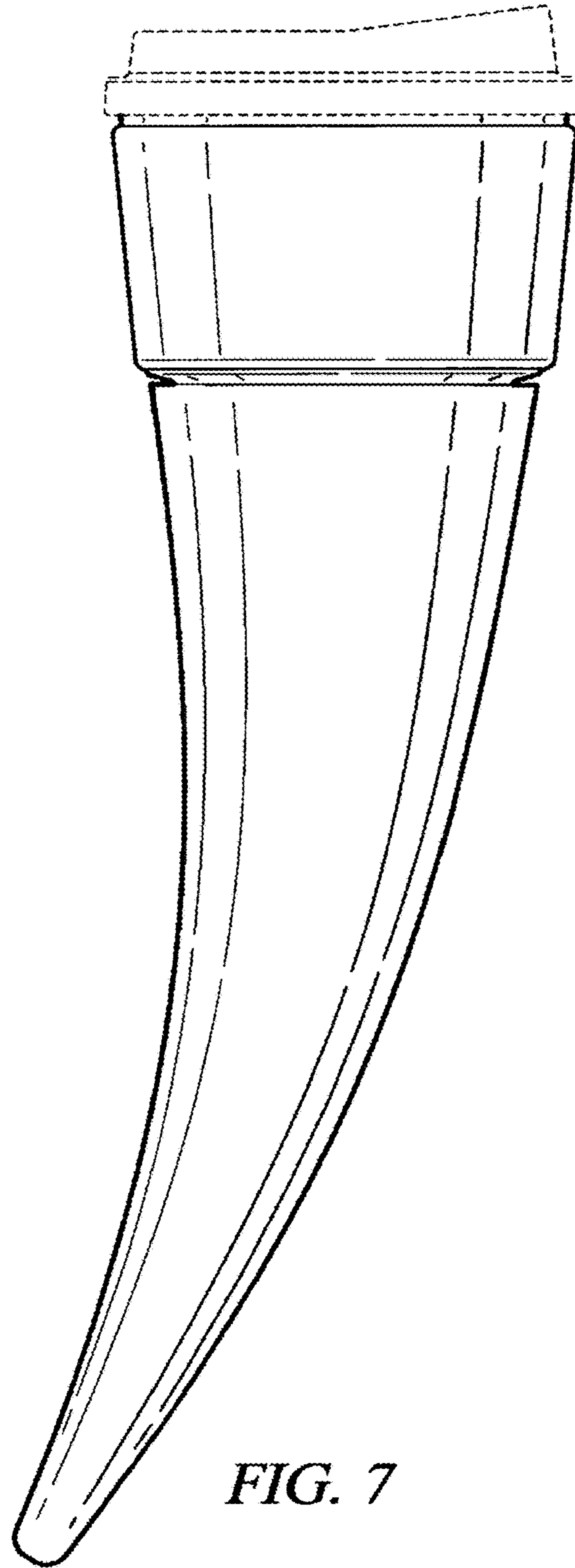
