FIG. 18 is a left side view of the cooler of FIG. 15;

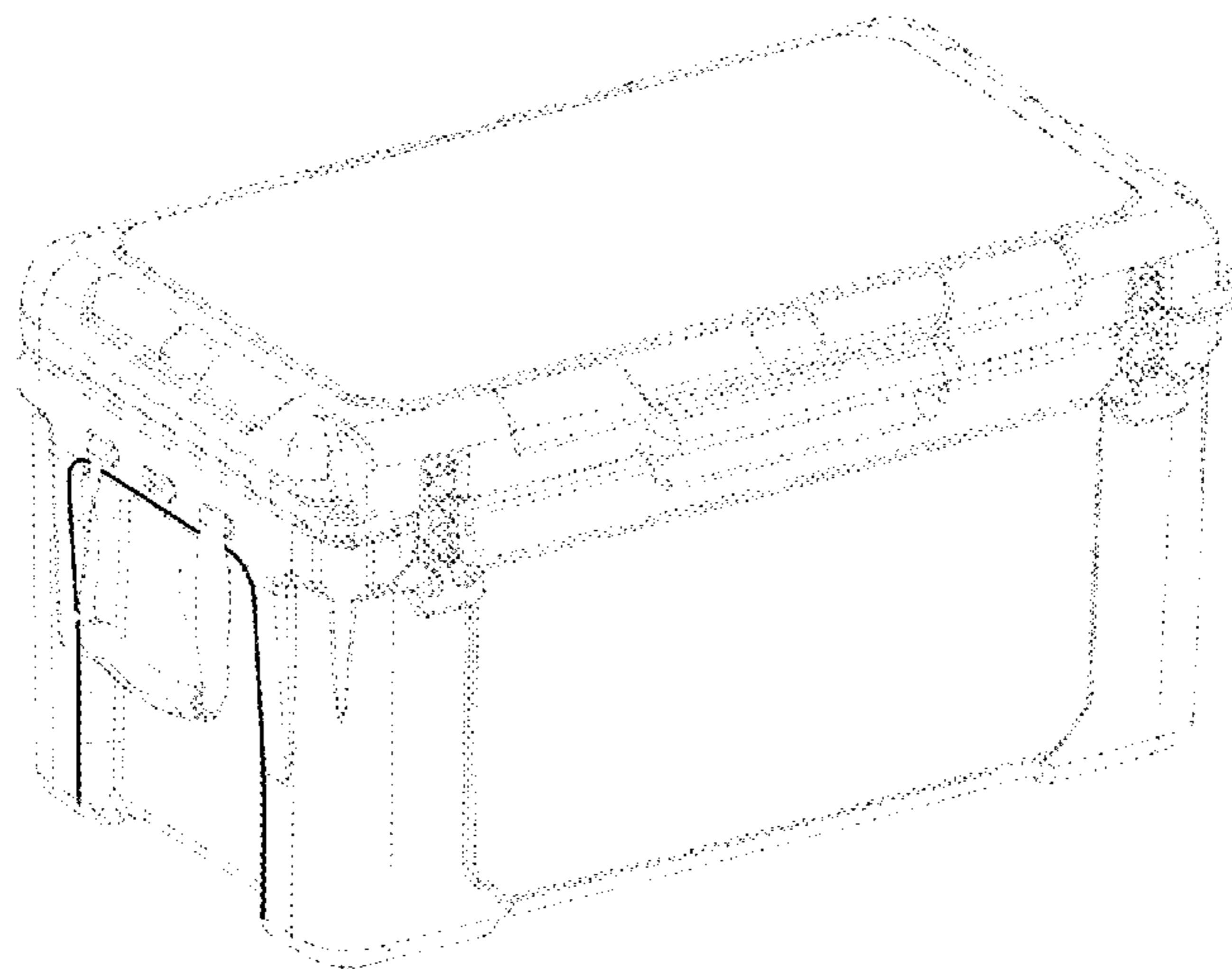
FIG. 19 is a right side view of the cooler of FIG. 15;

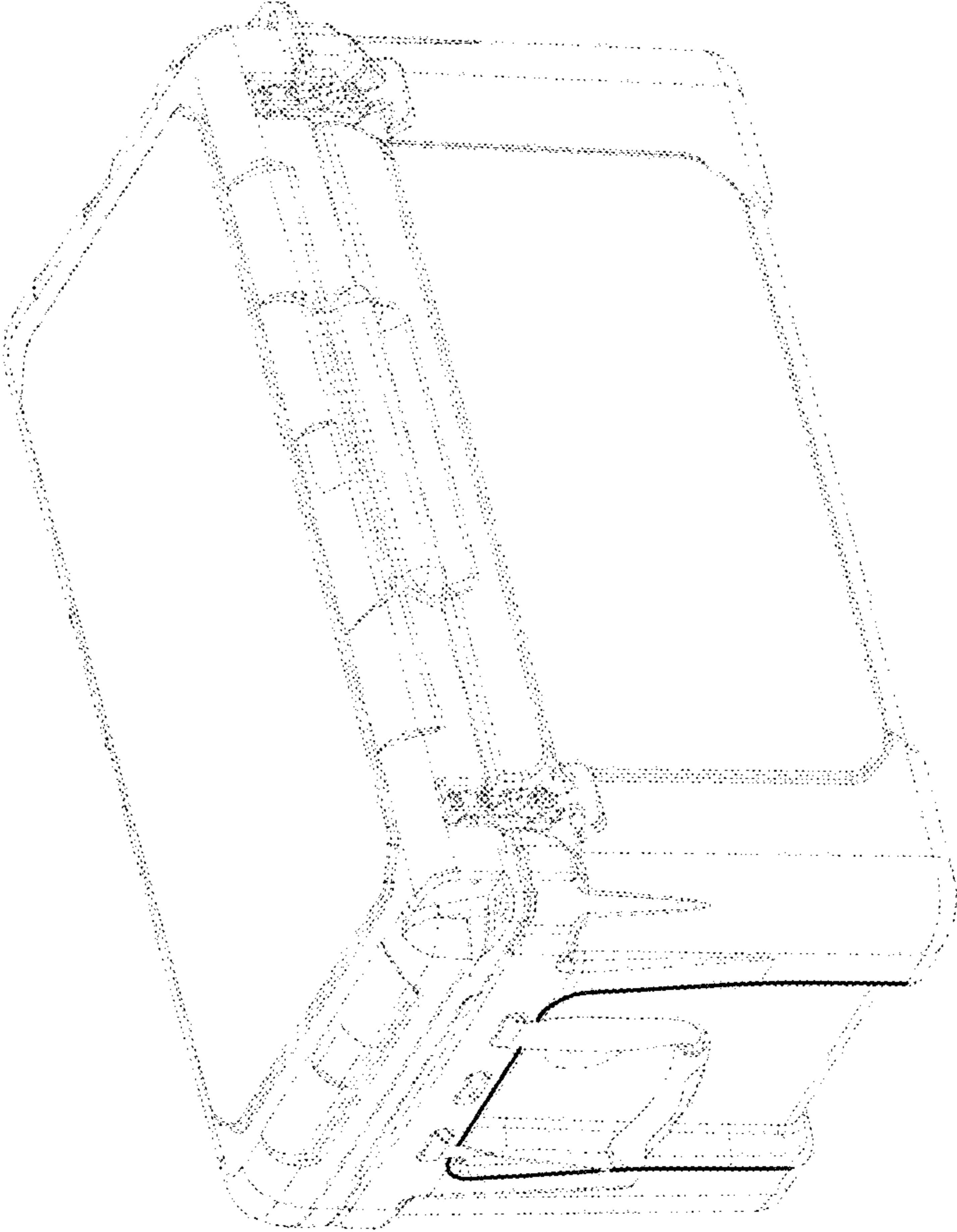

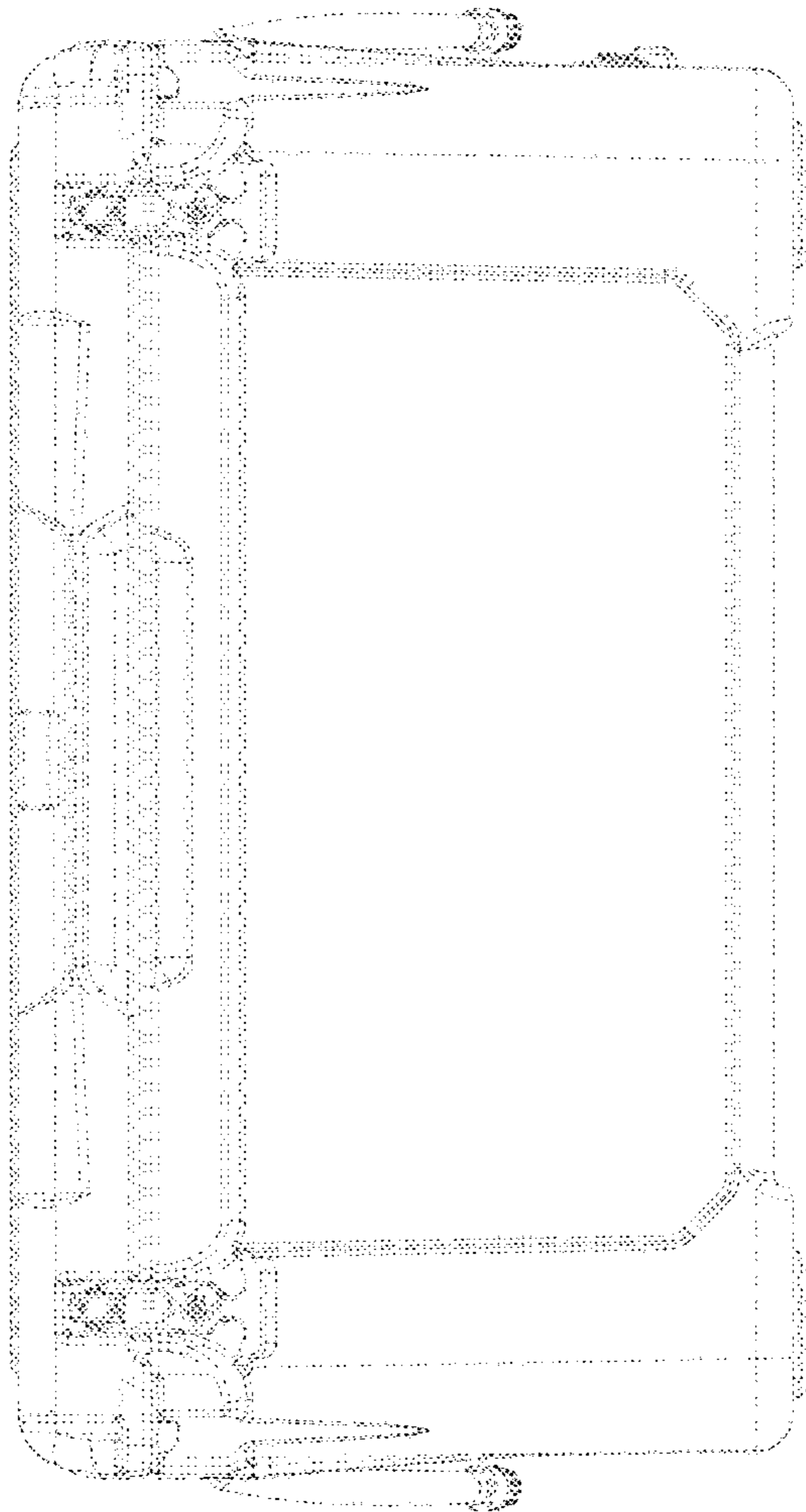

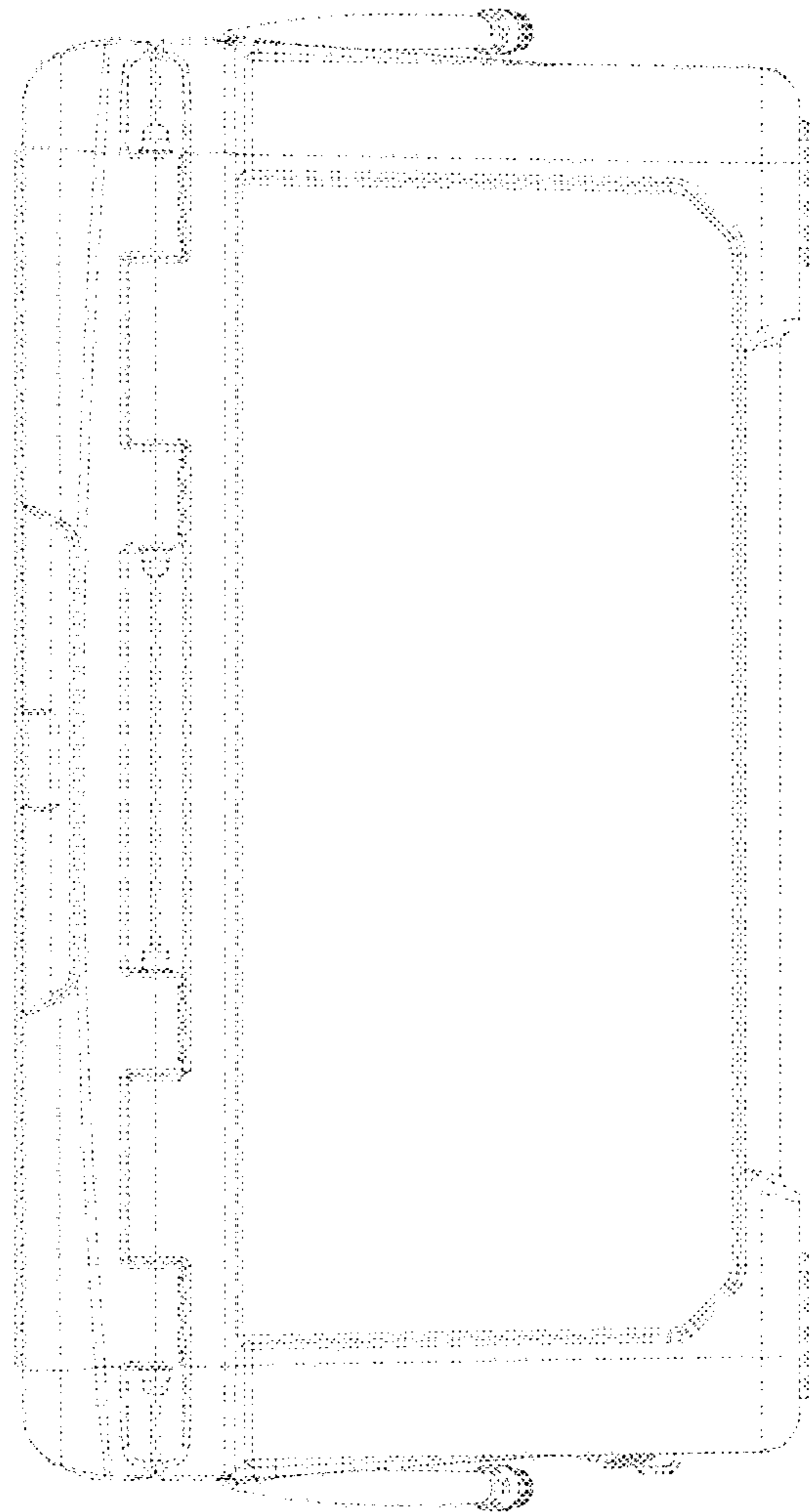

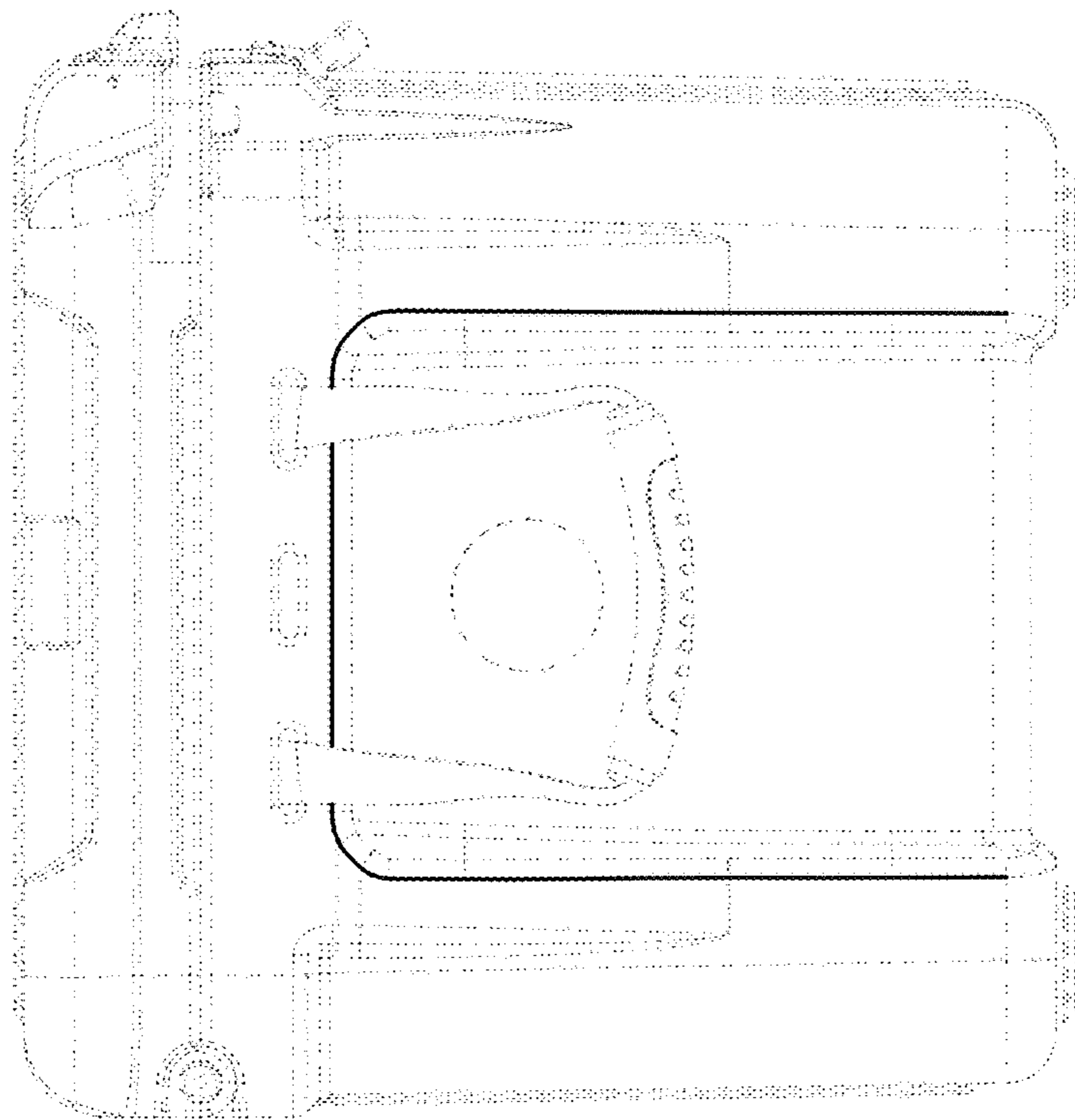

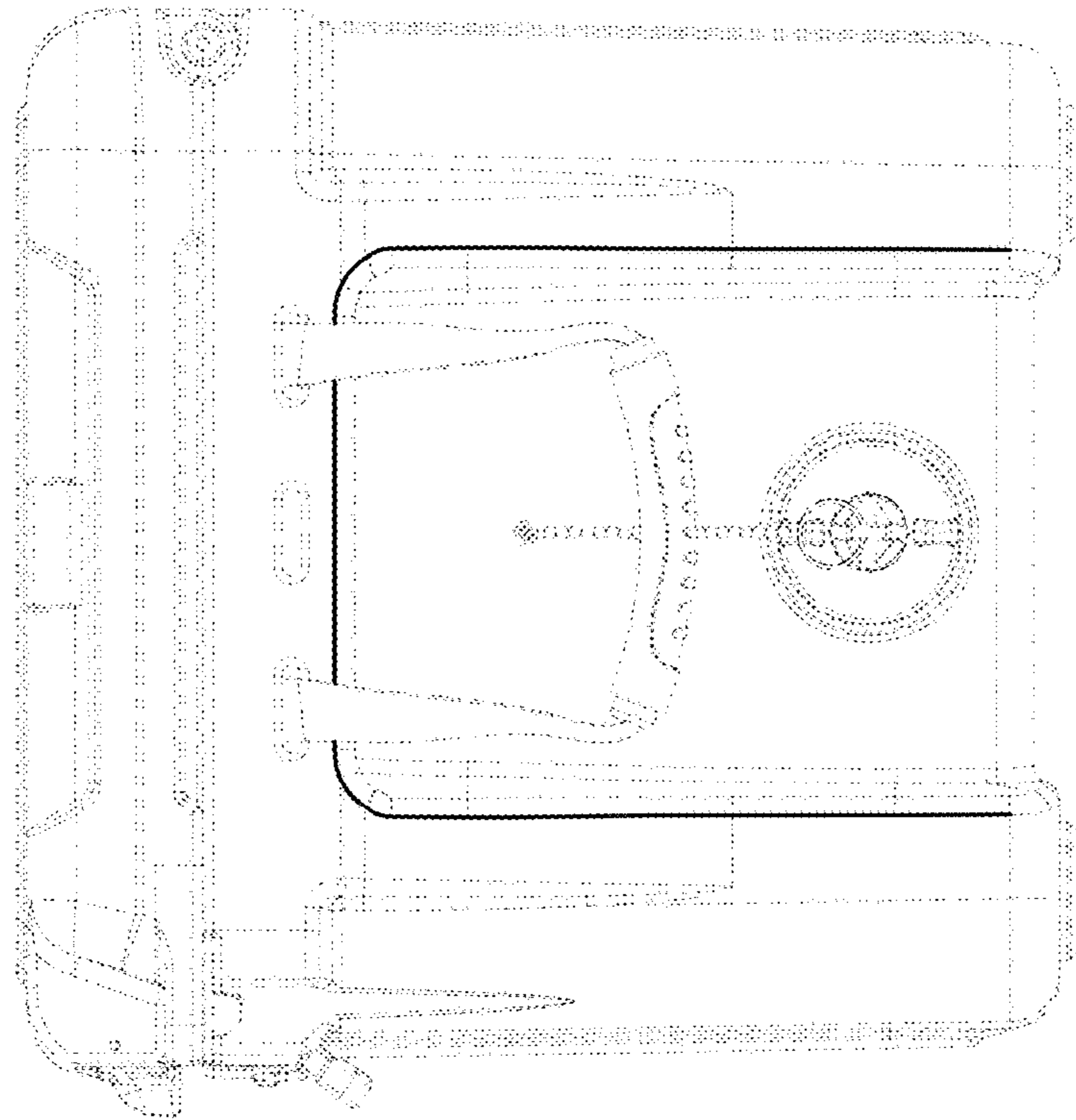

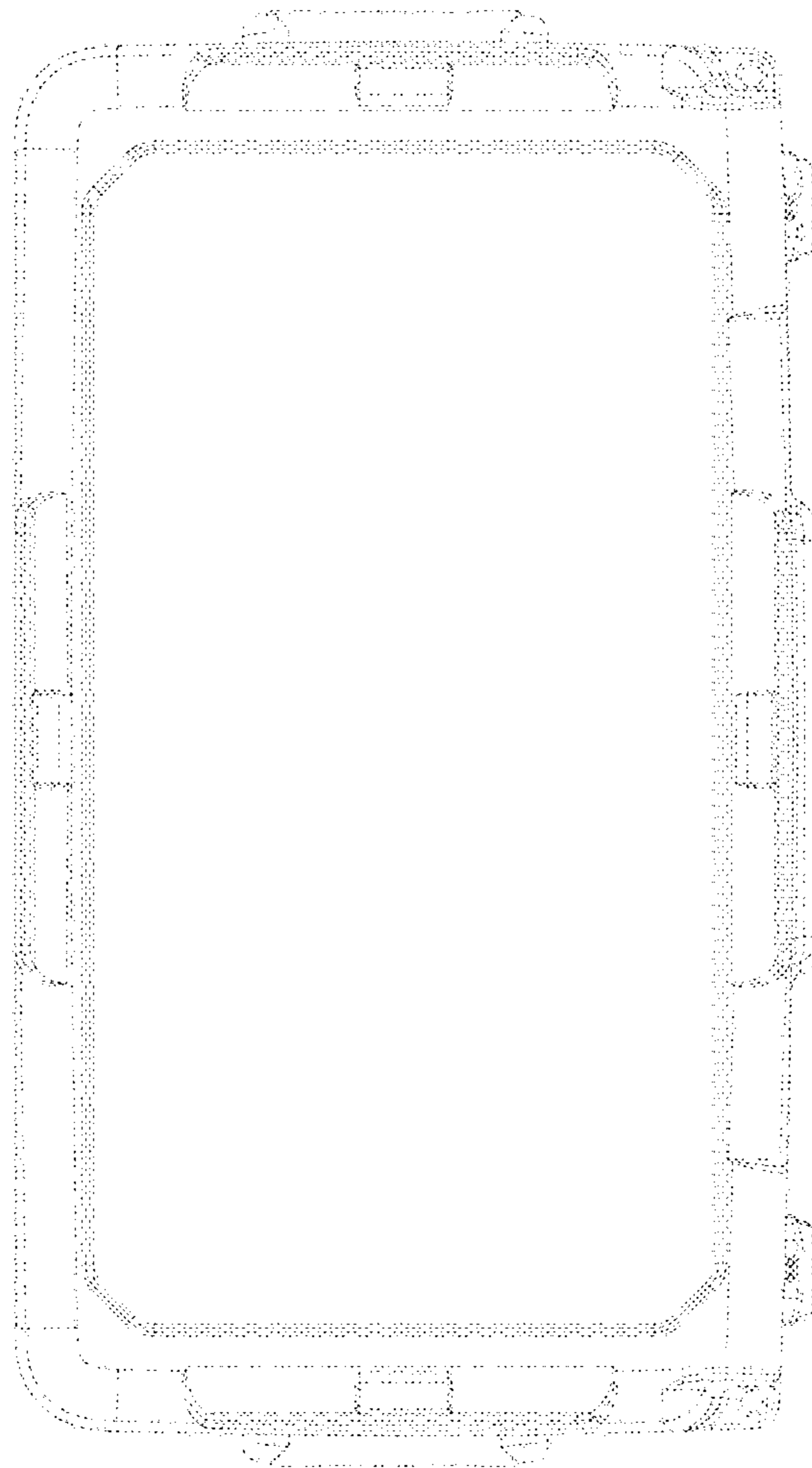

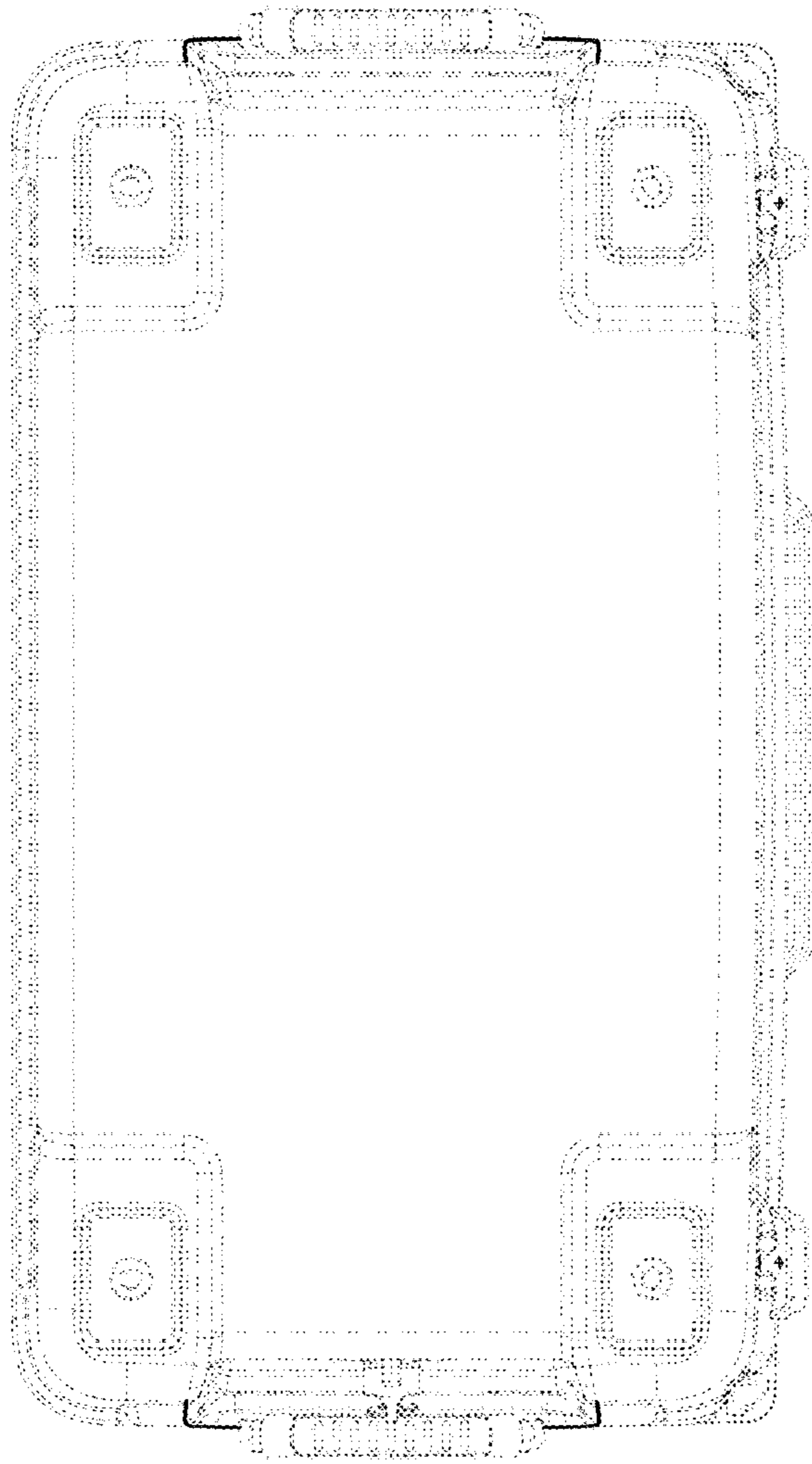

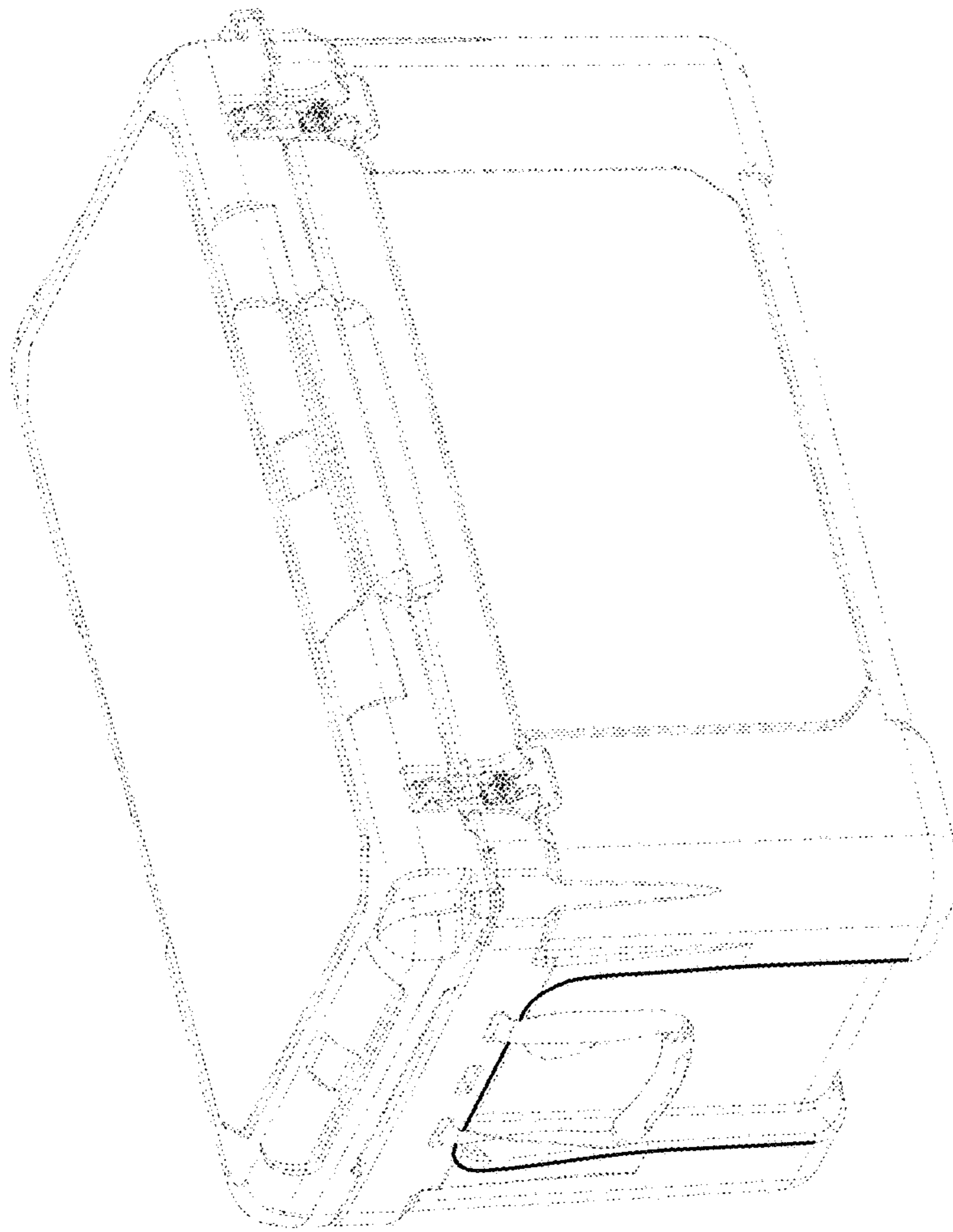

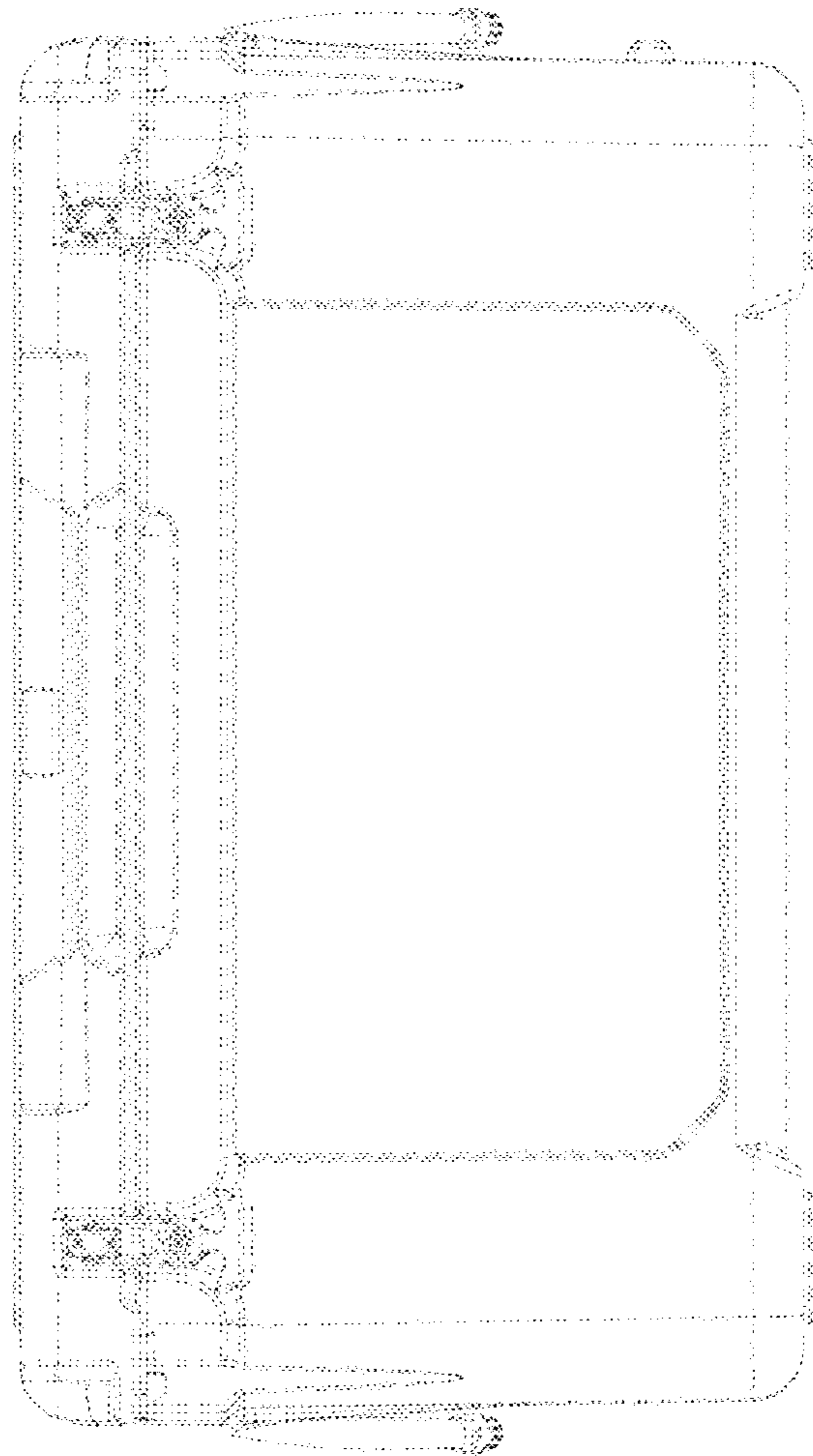

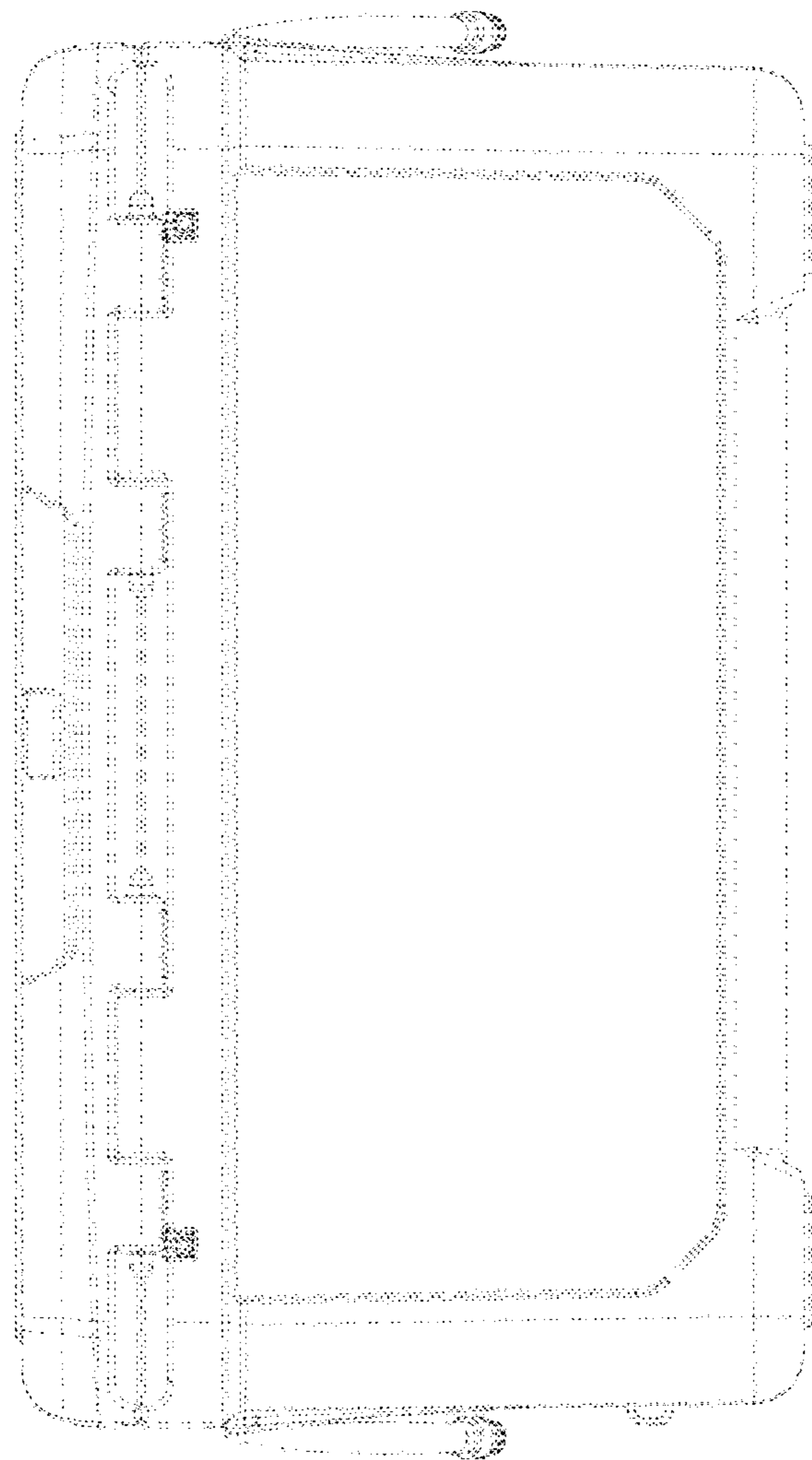

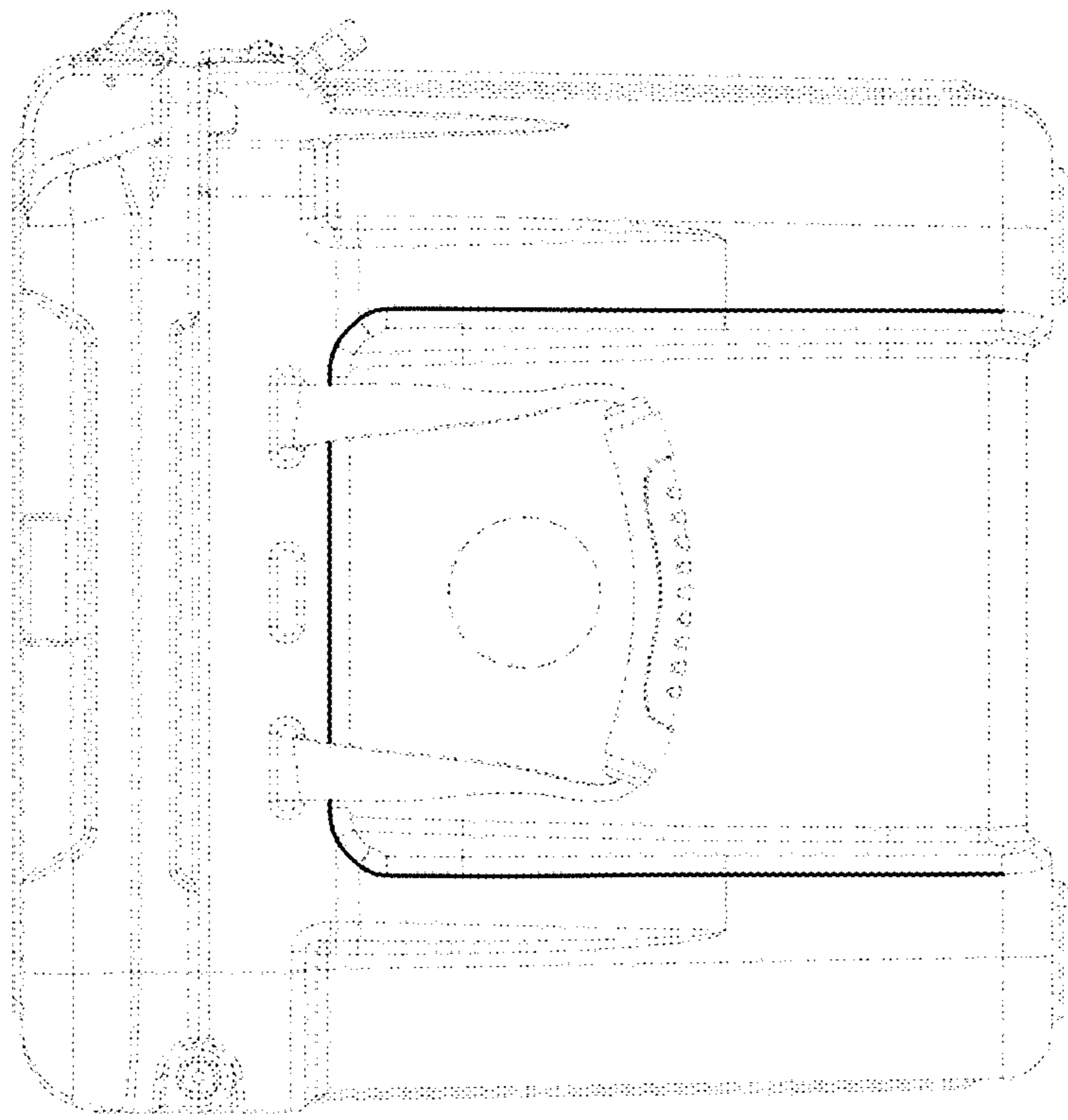

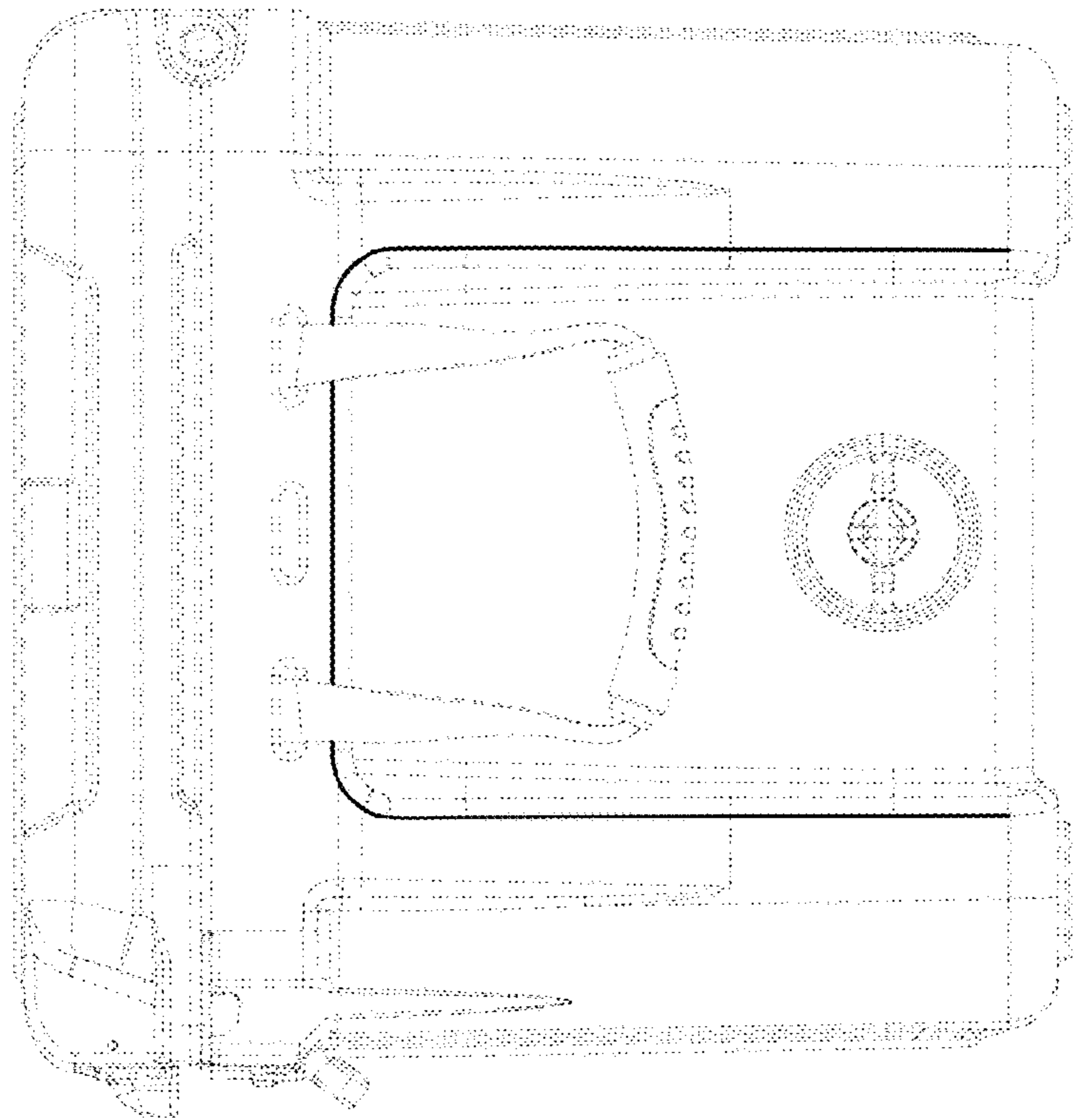

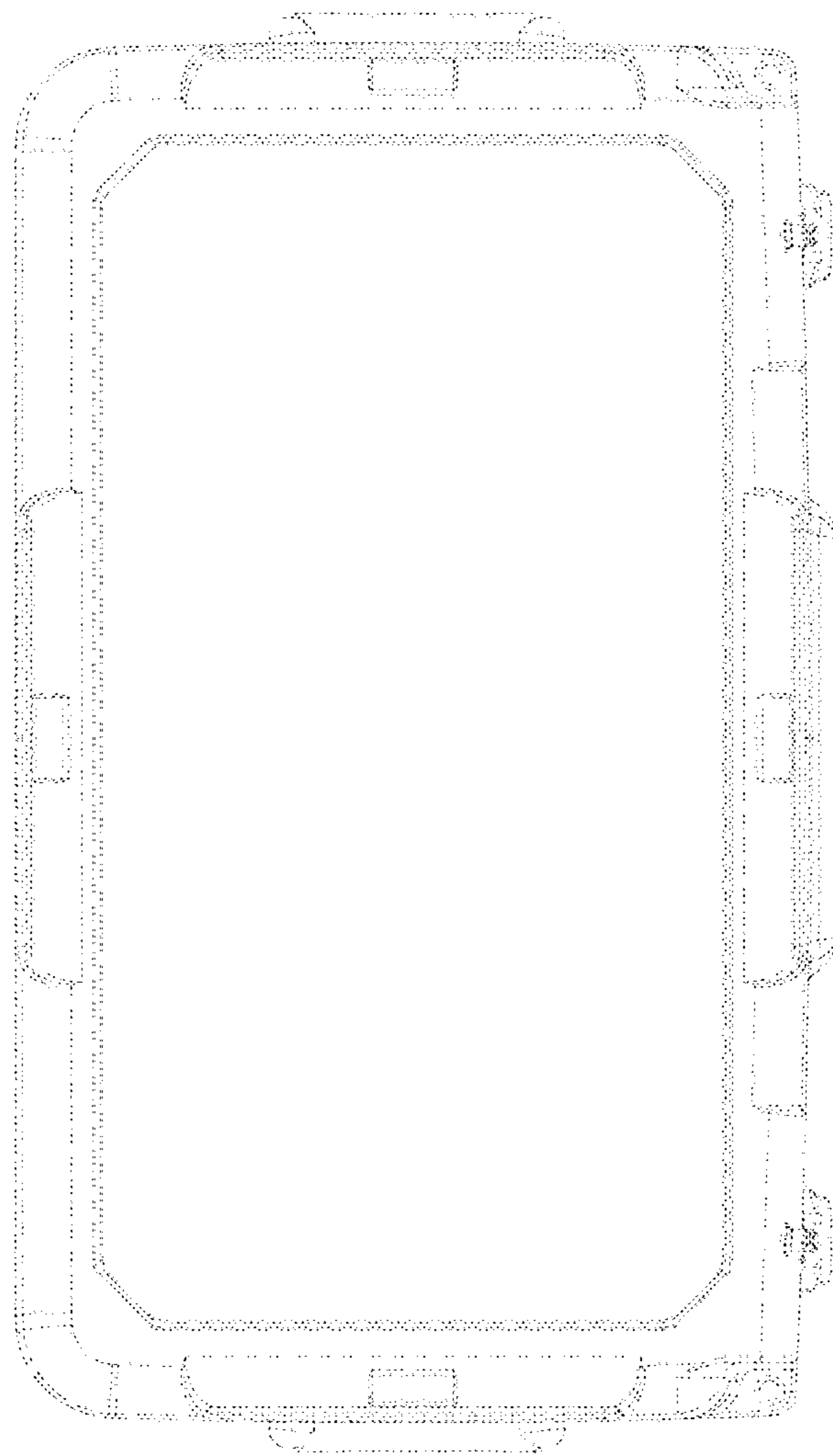

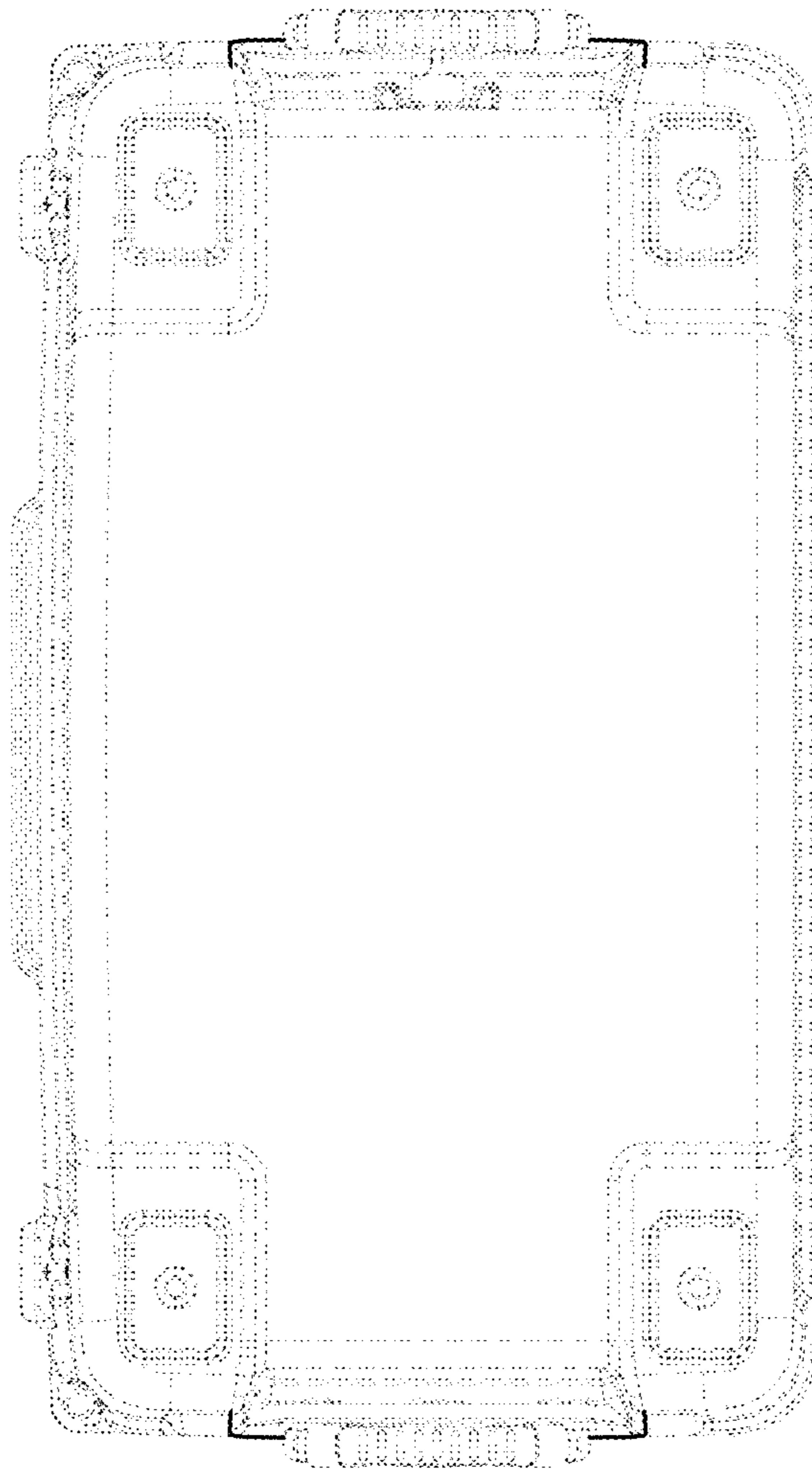

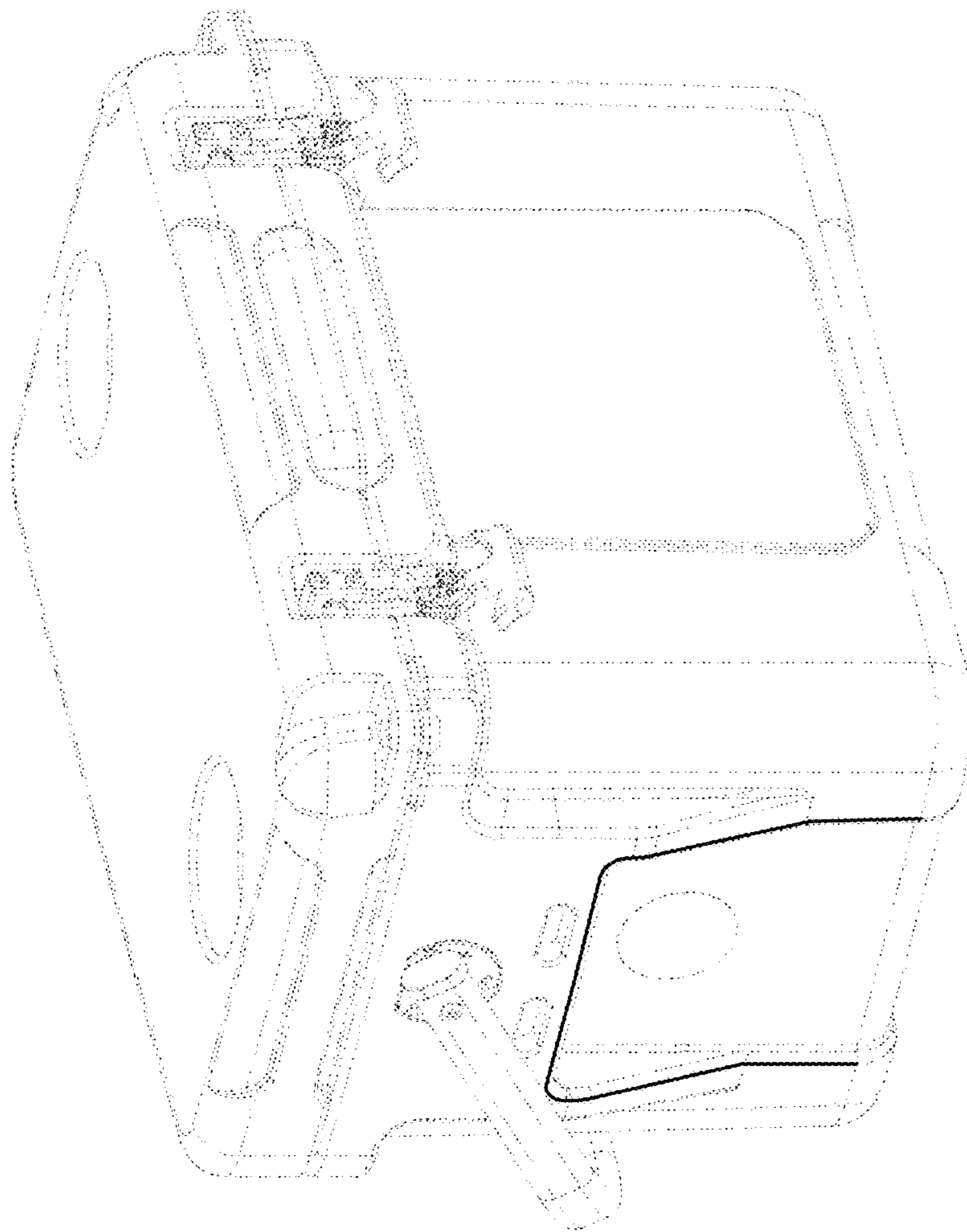

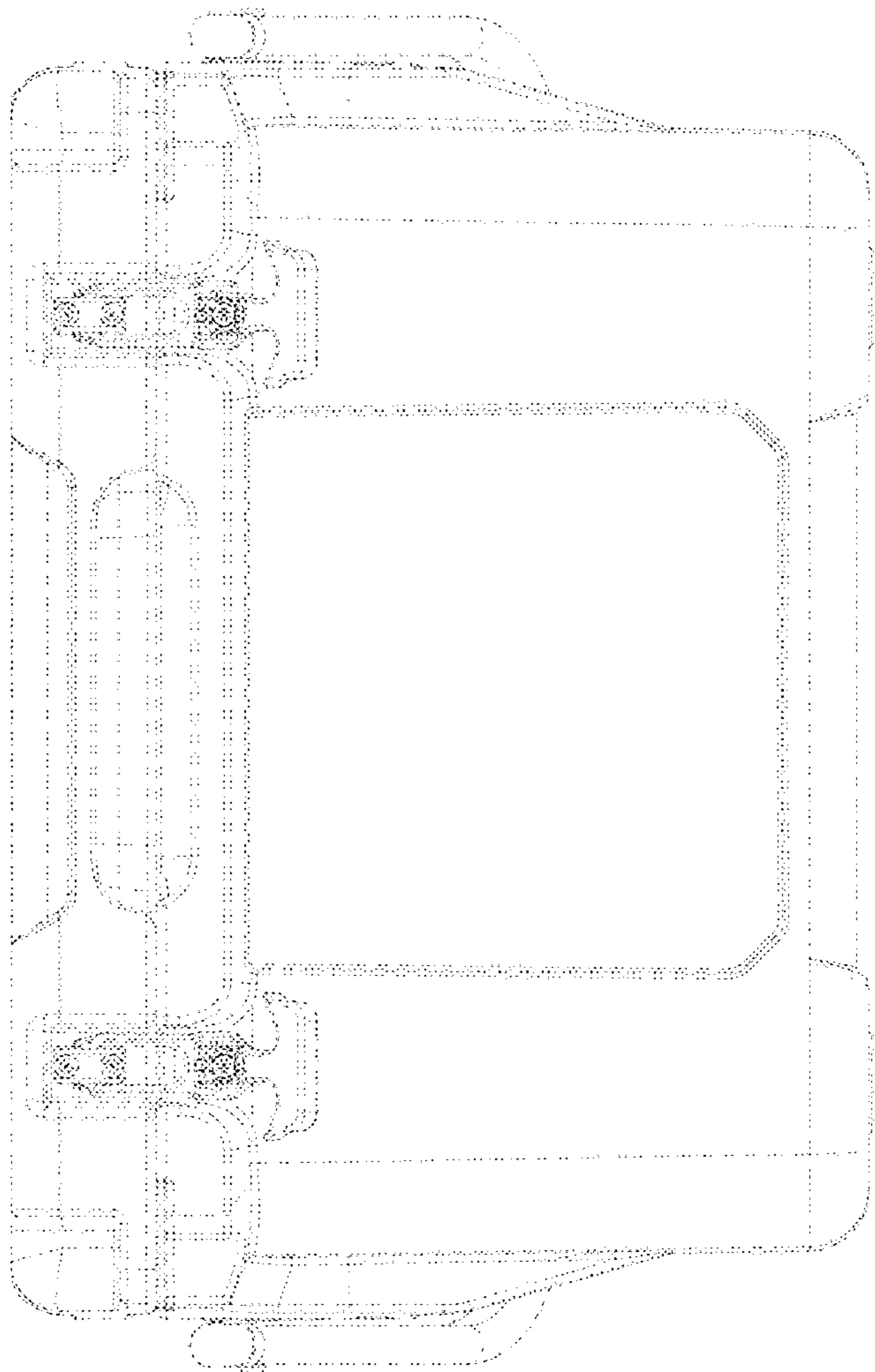

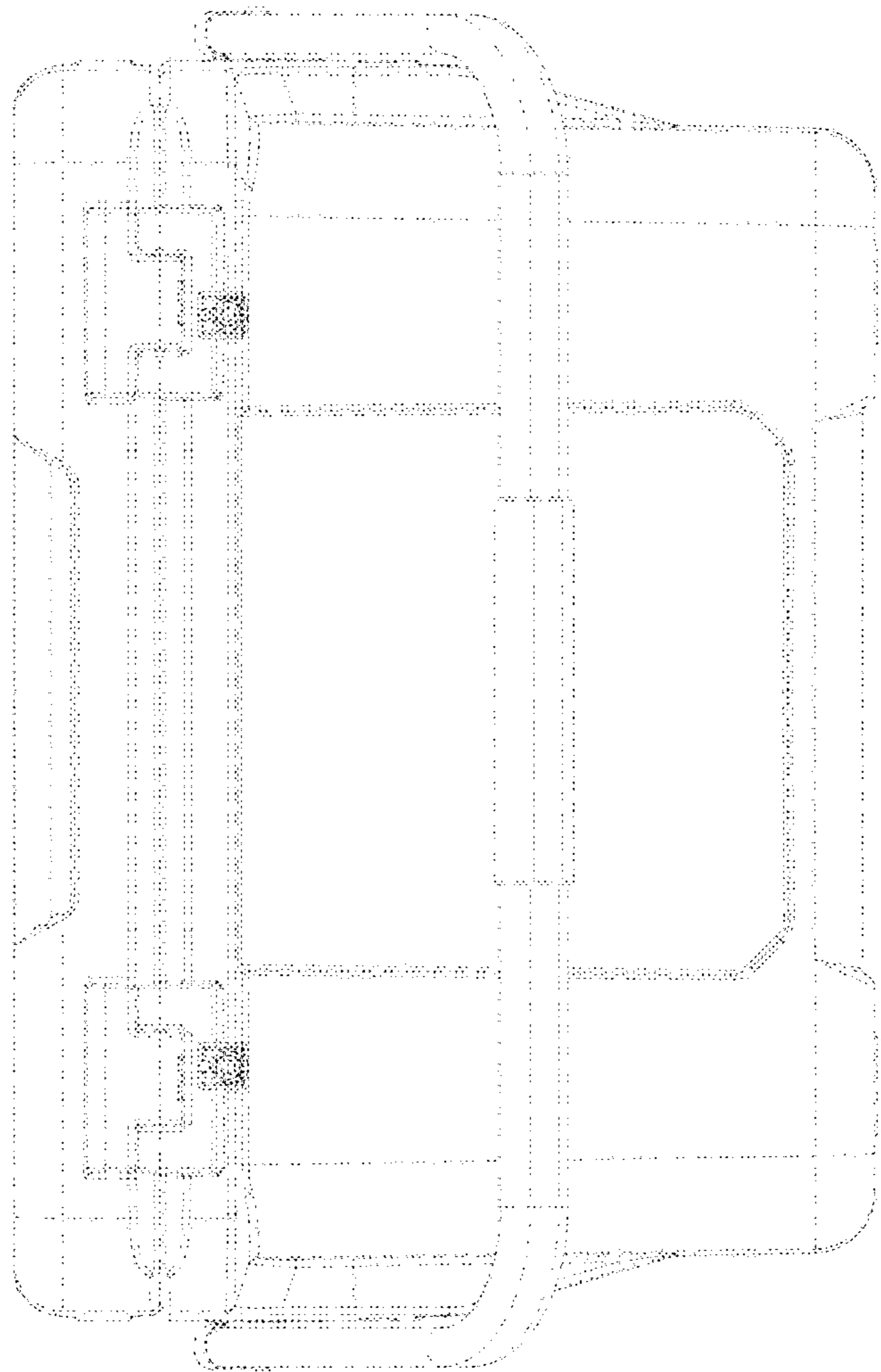

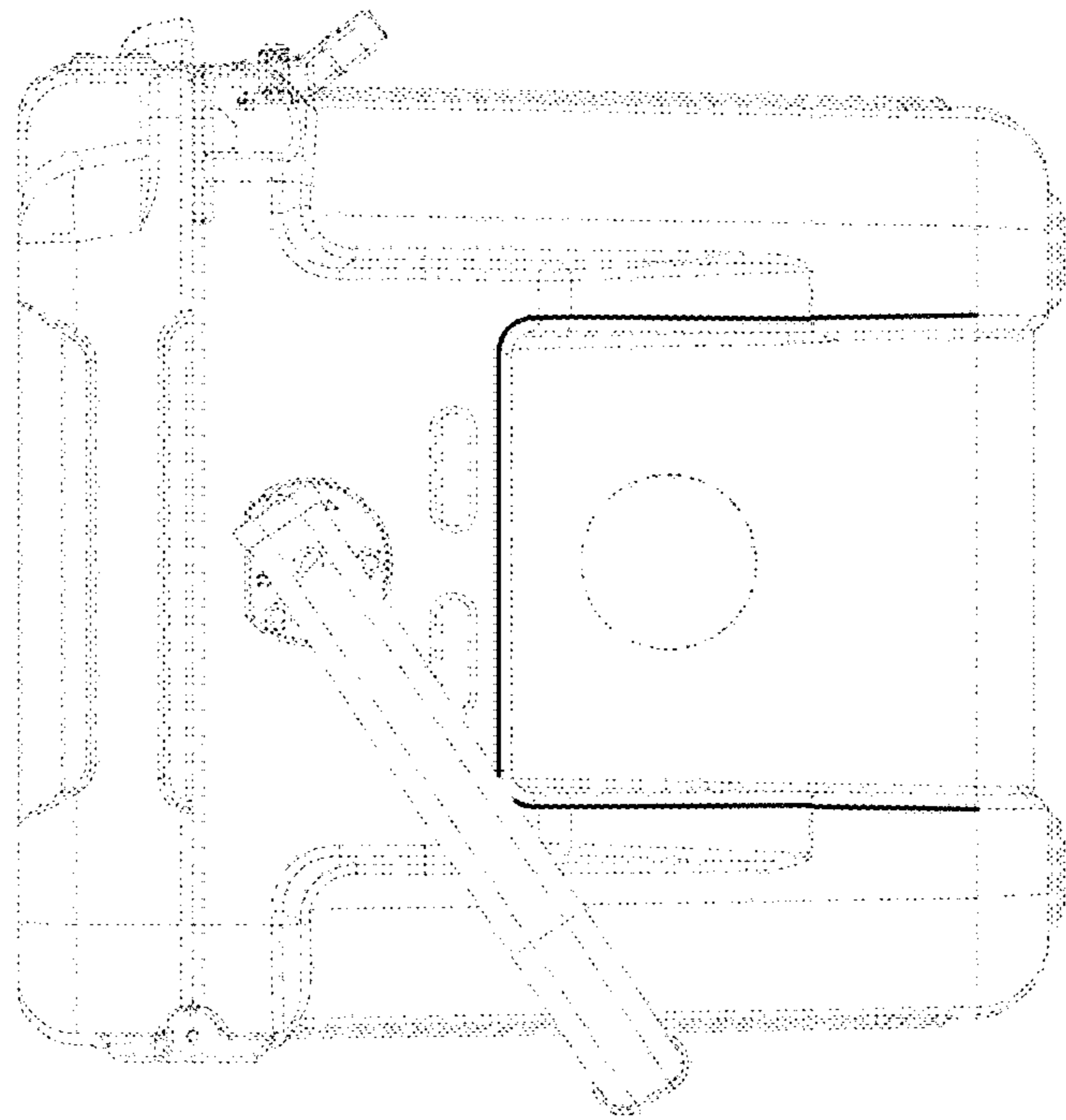

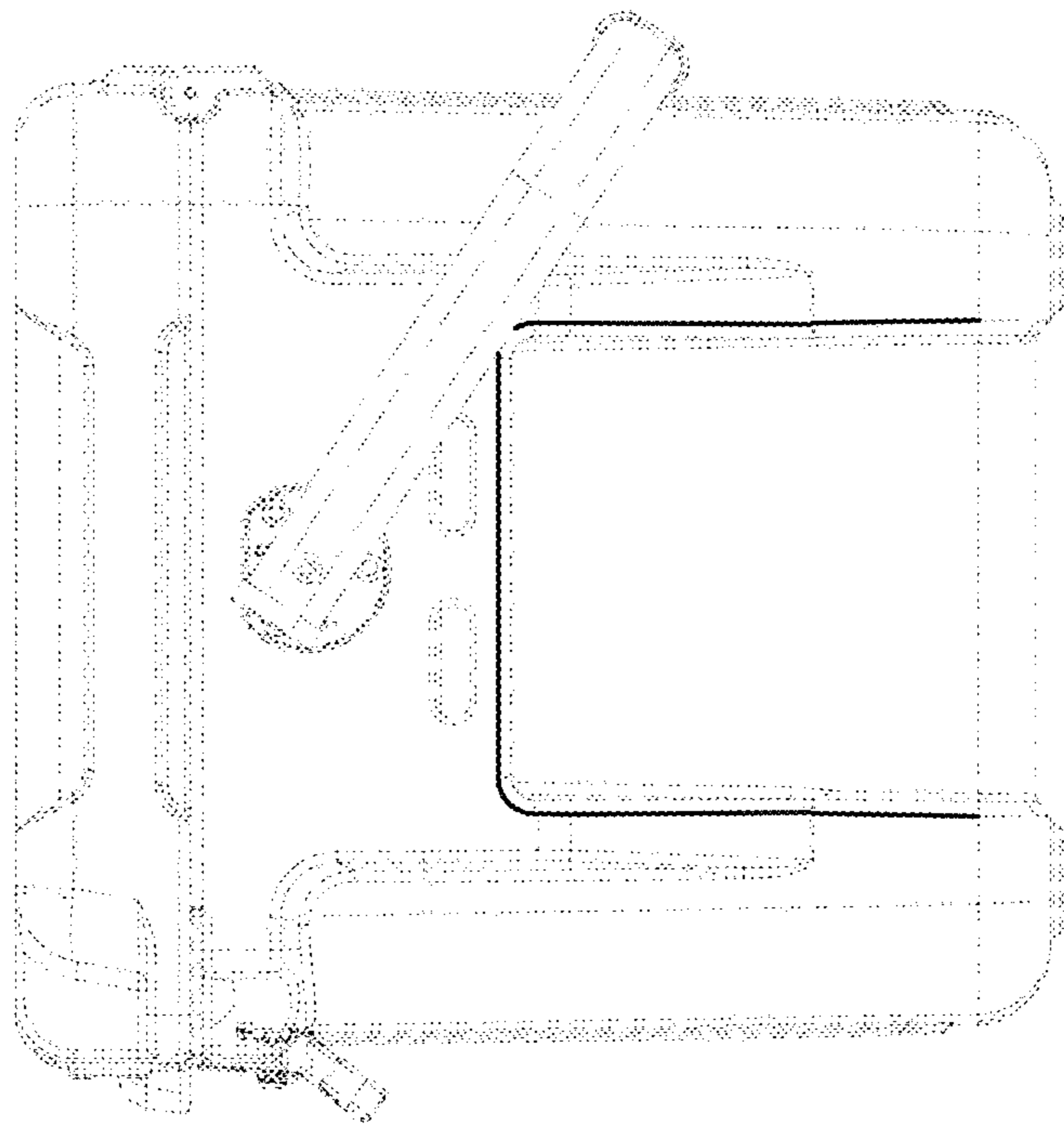

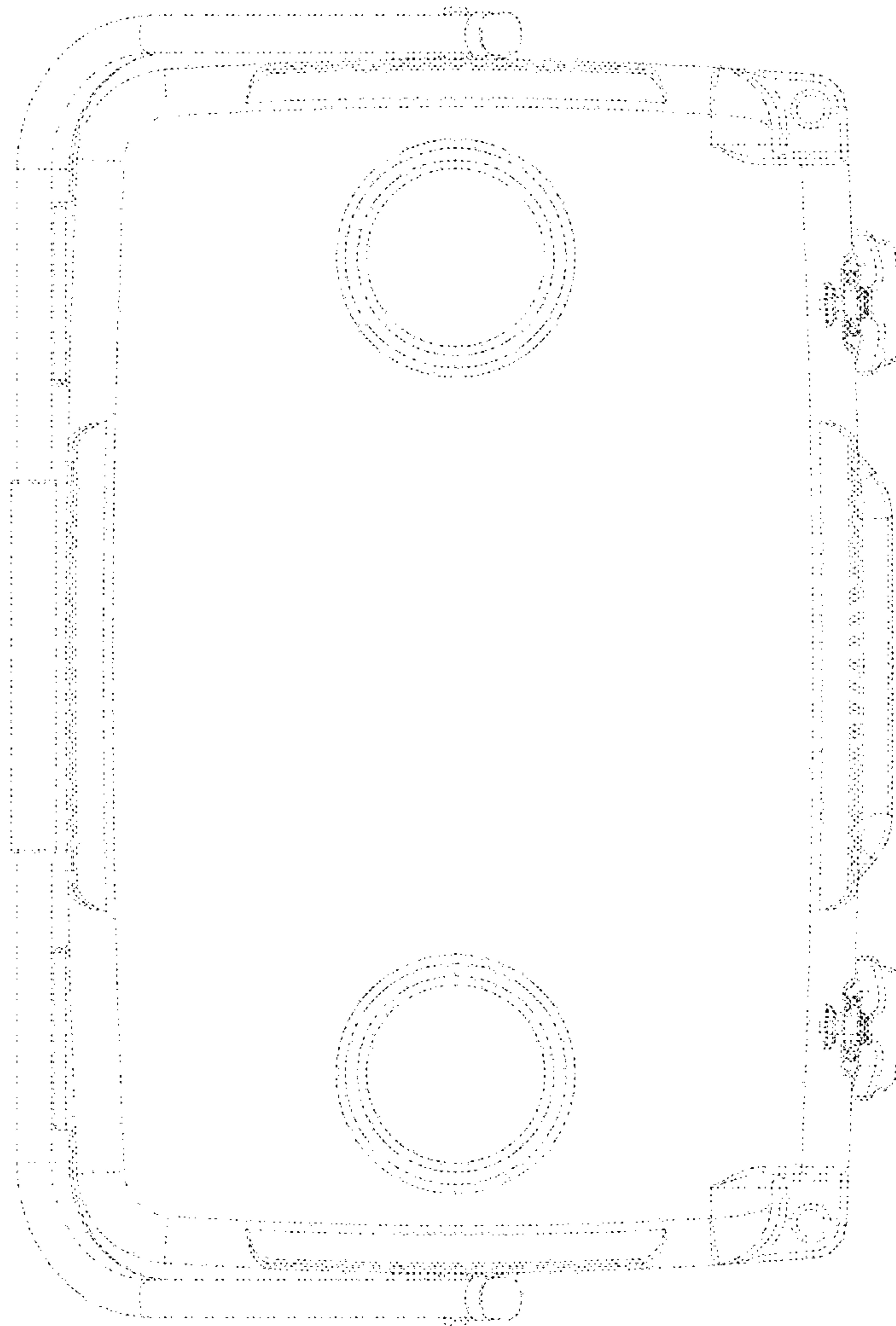

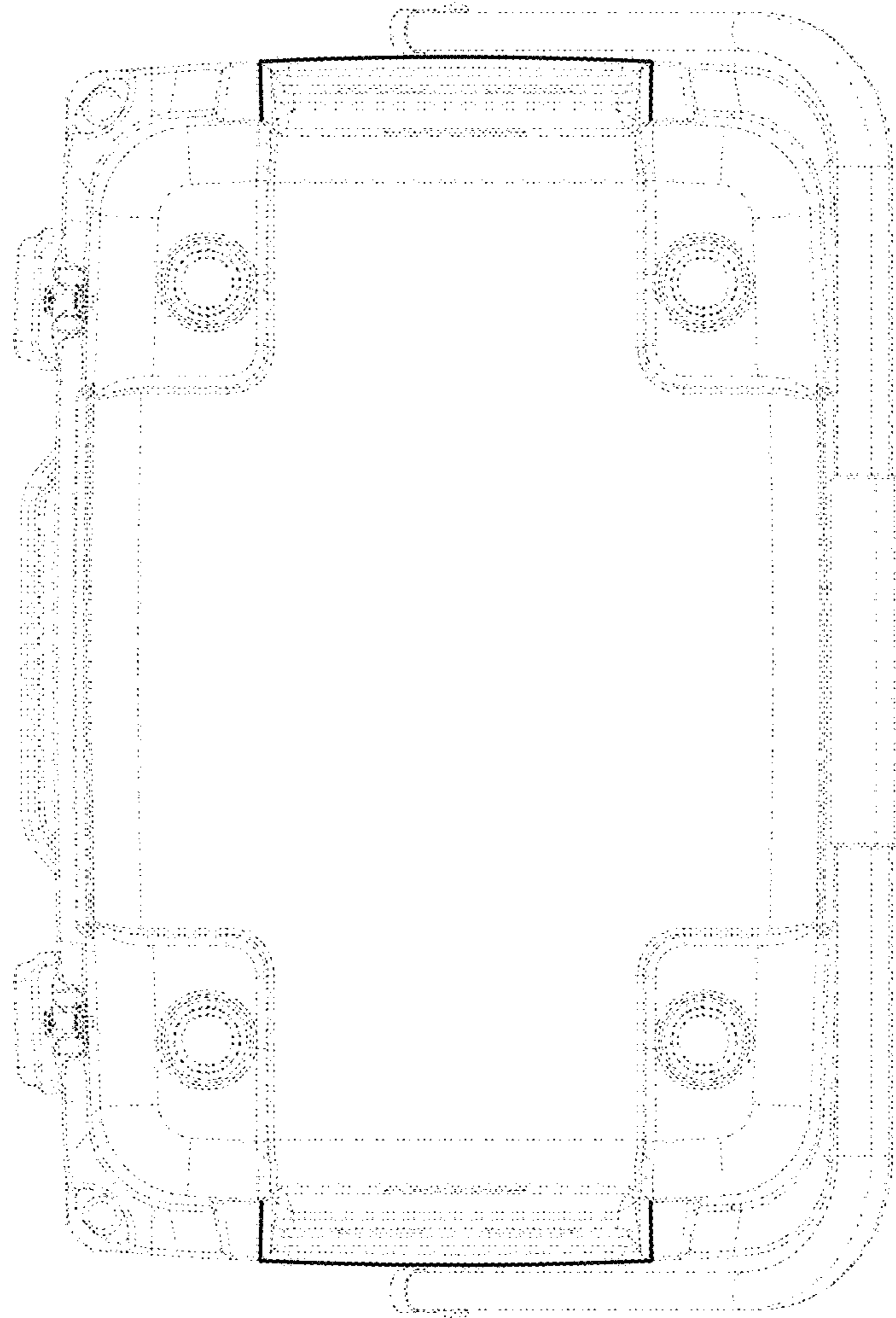
