FIG. 5 shows a first side view thereof.

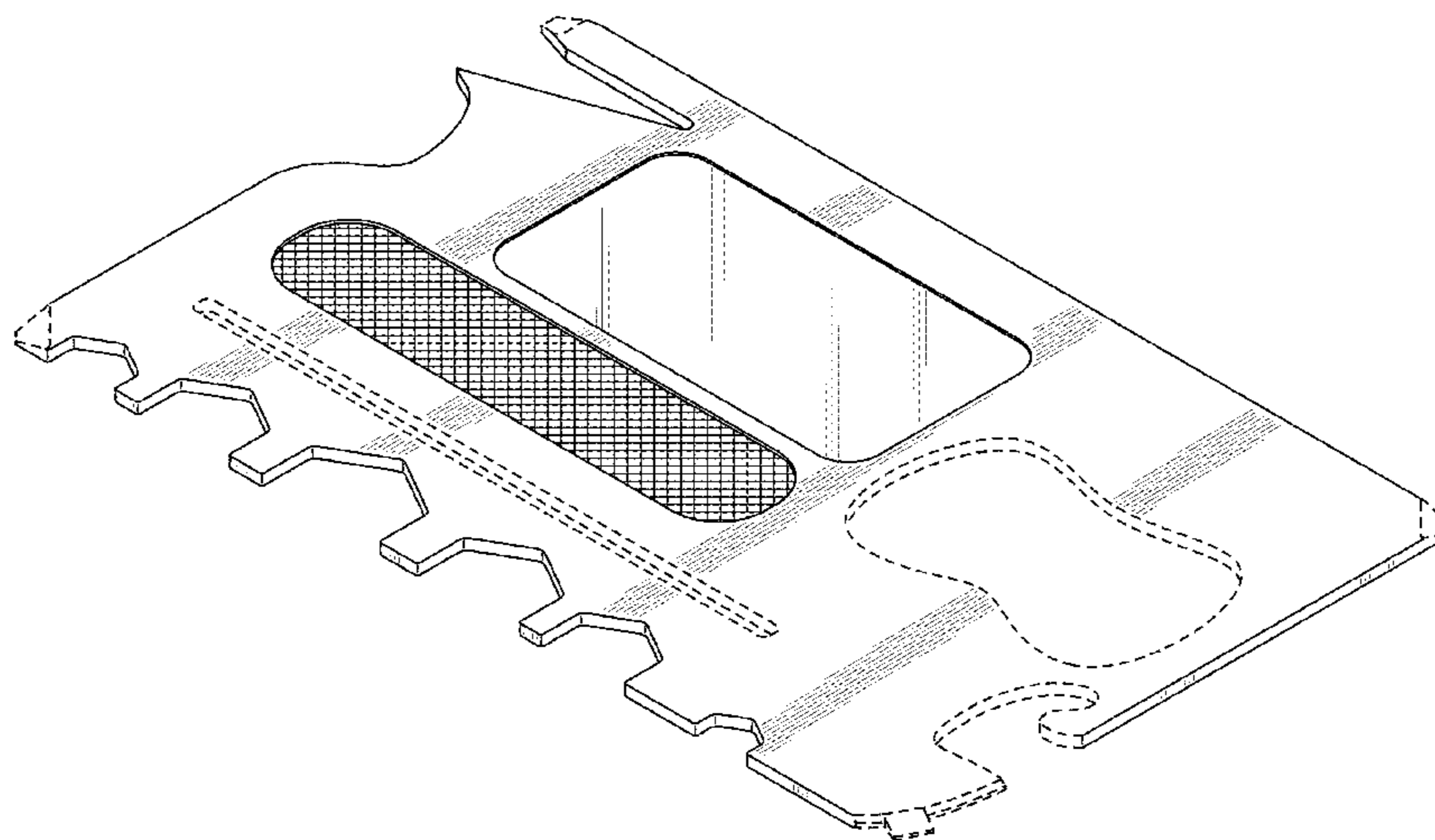
FIG. 6 shows a second side view thereof.

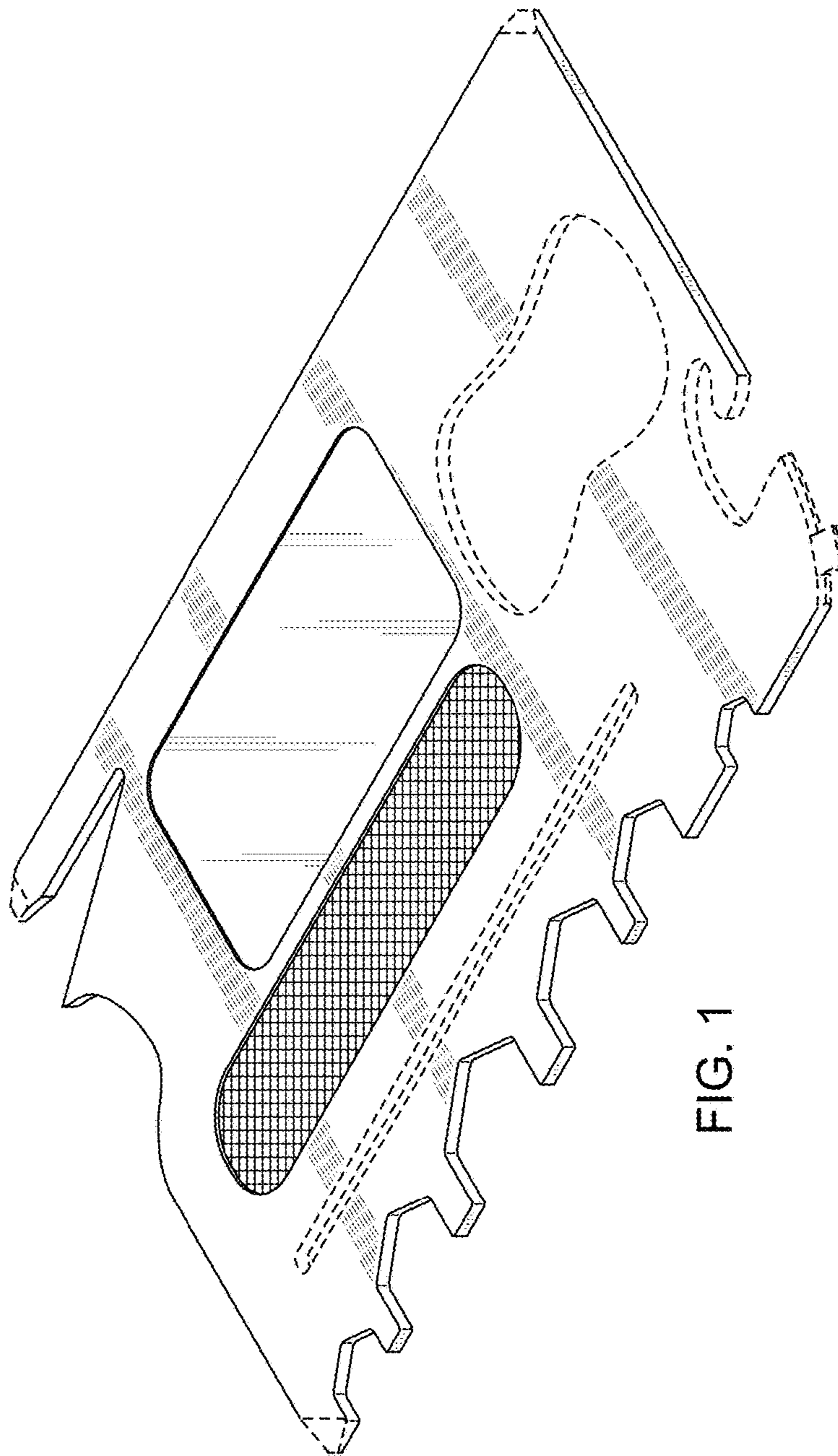

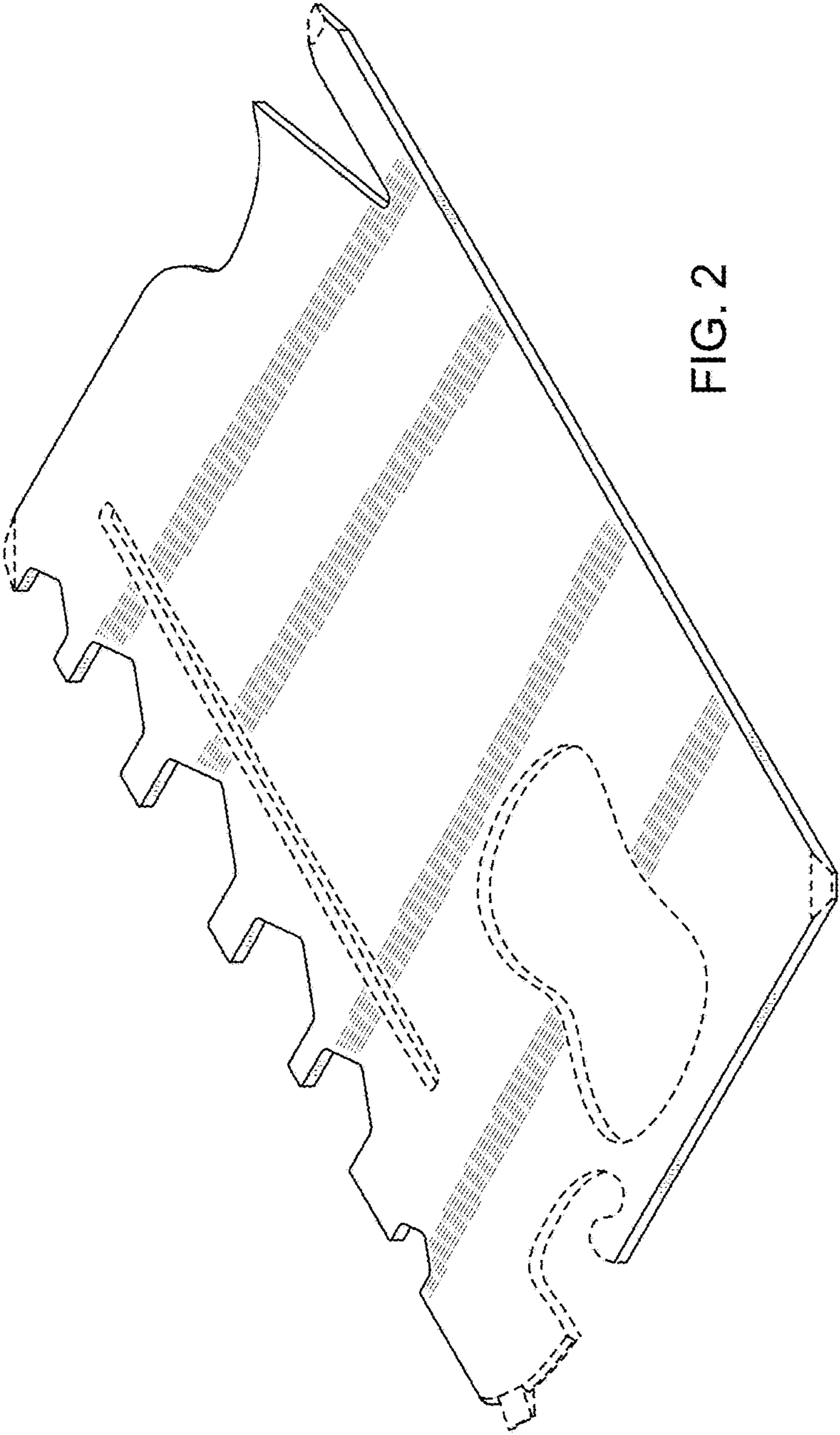

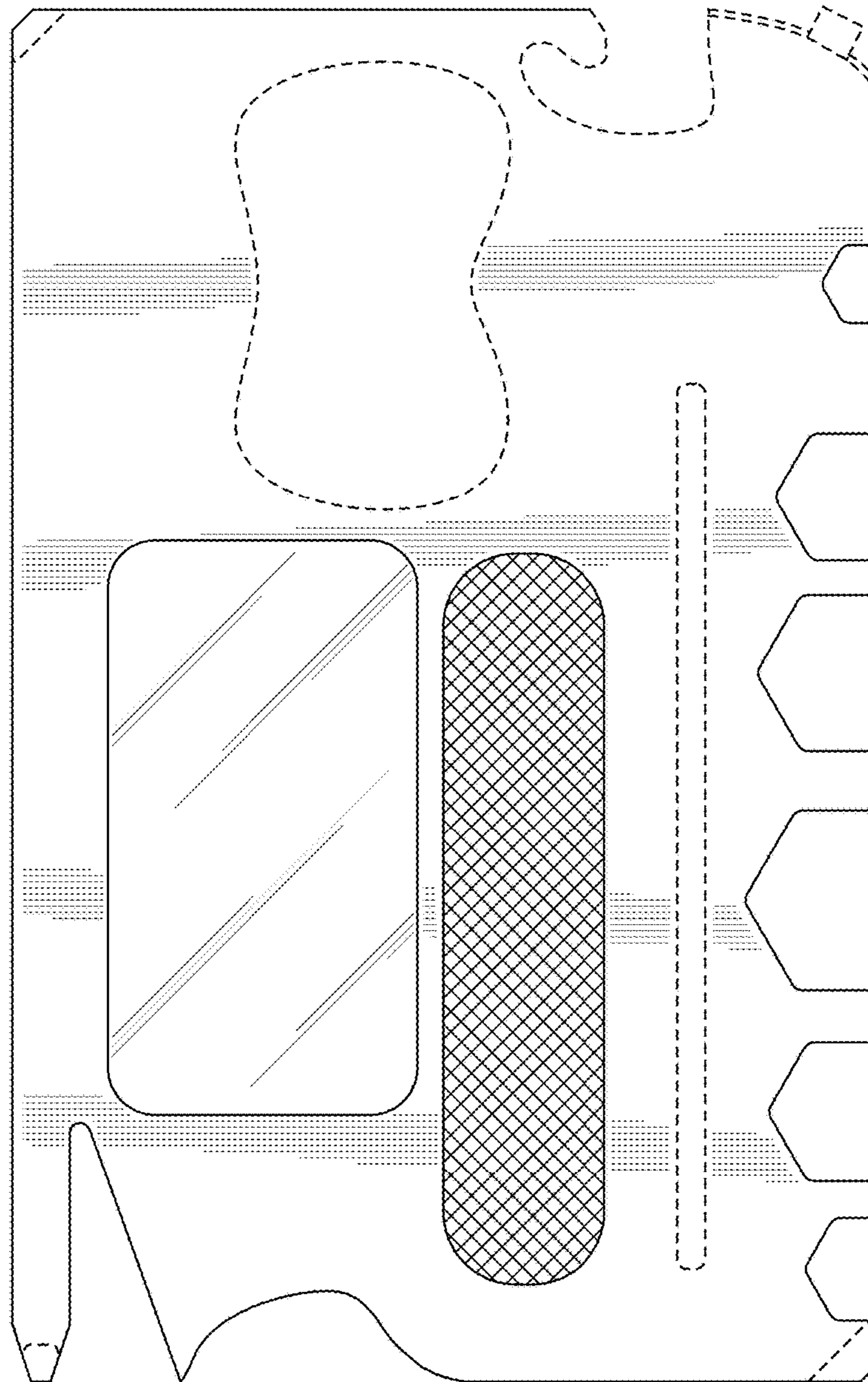

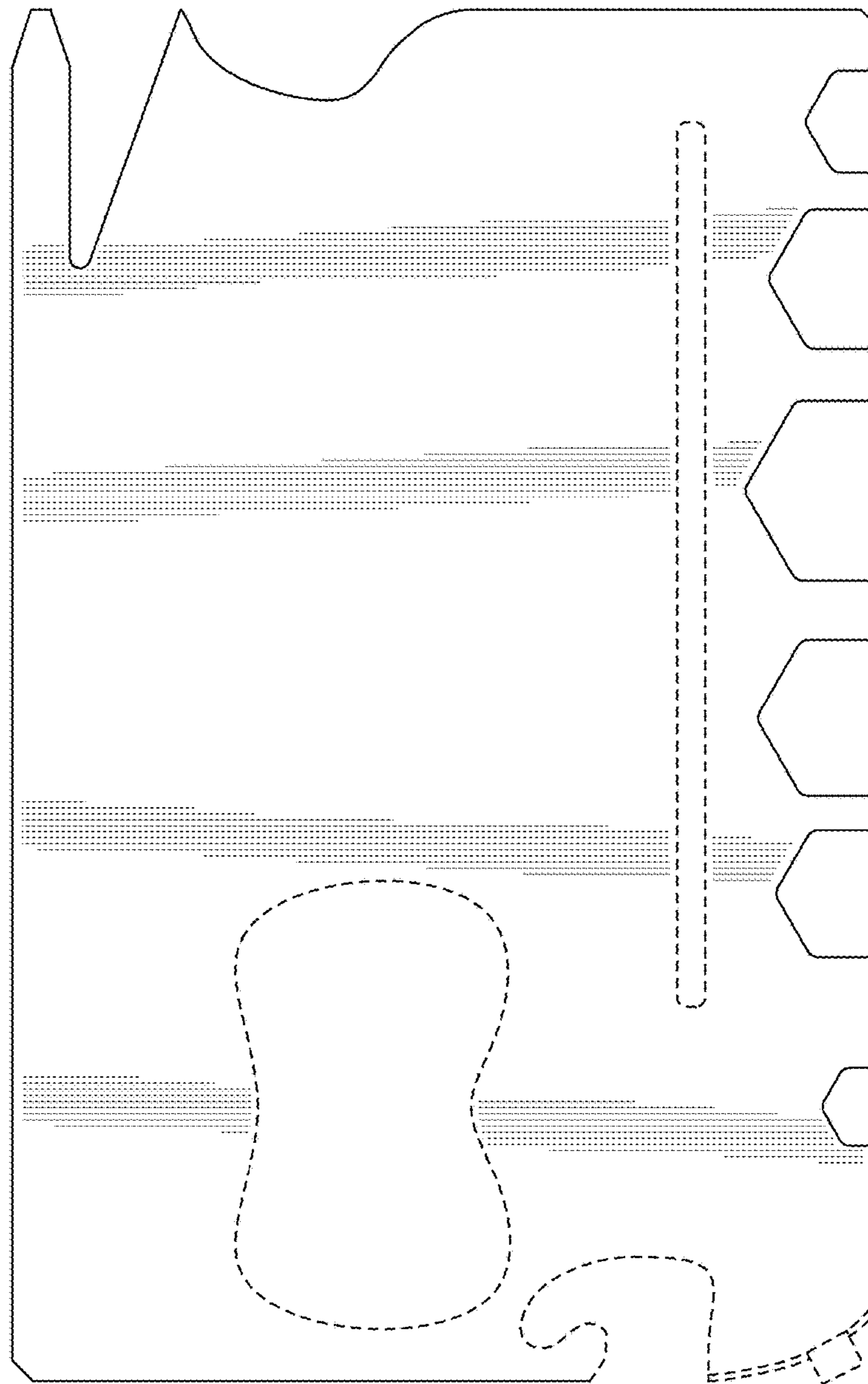

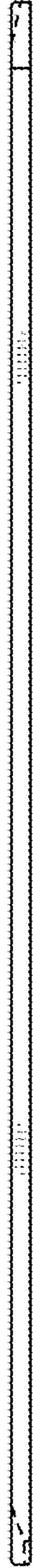

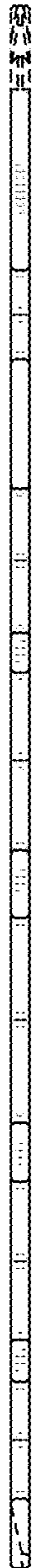

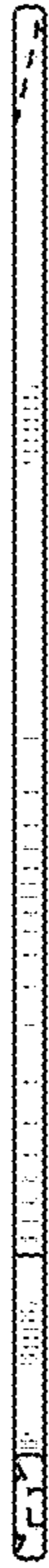

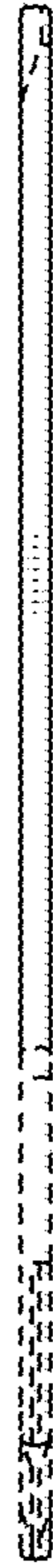
