(57) **CLAIM**

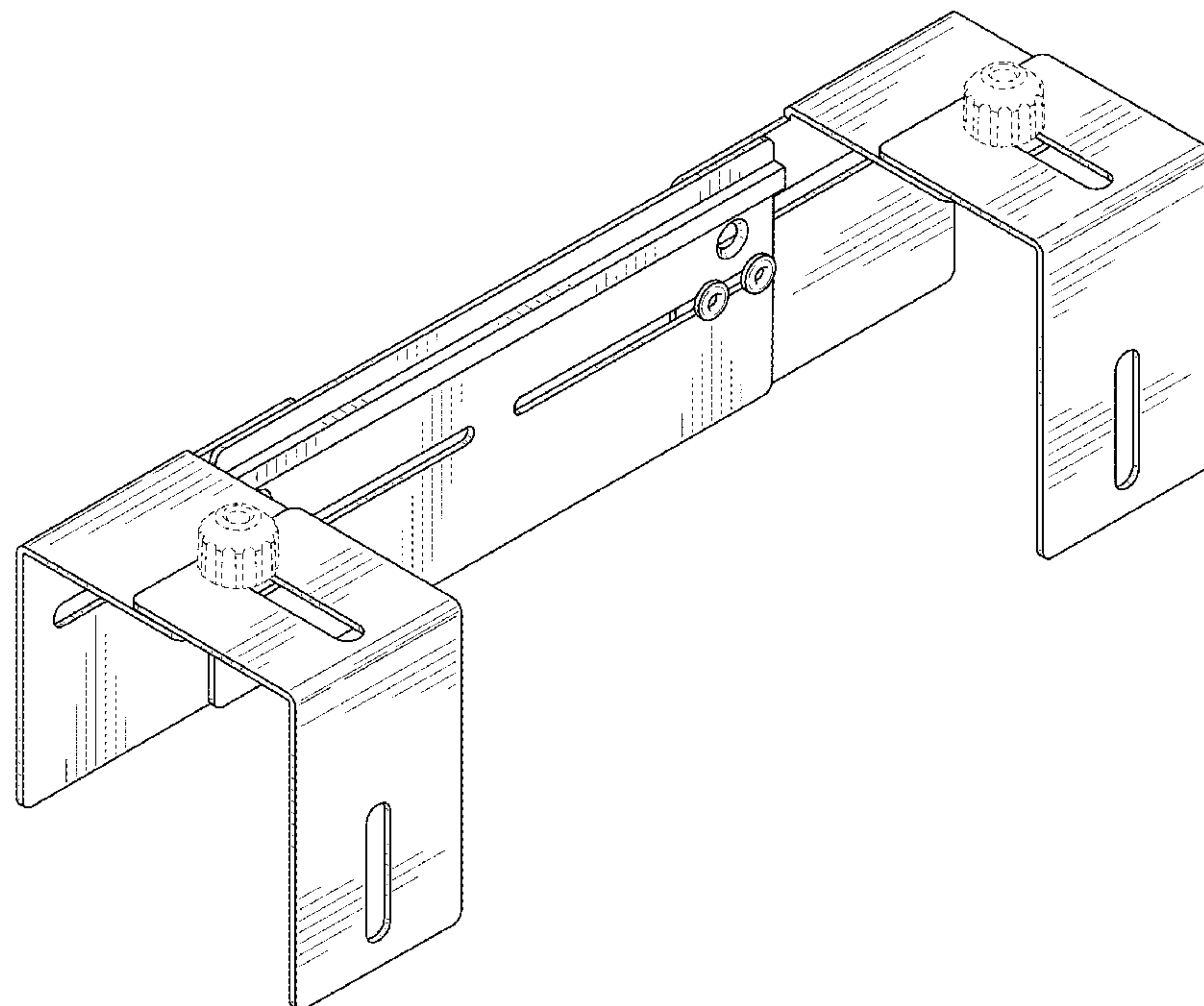
The ornamental design for a device mount, as shown and described.

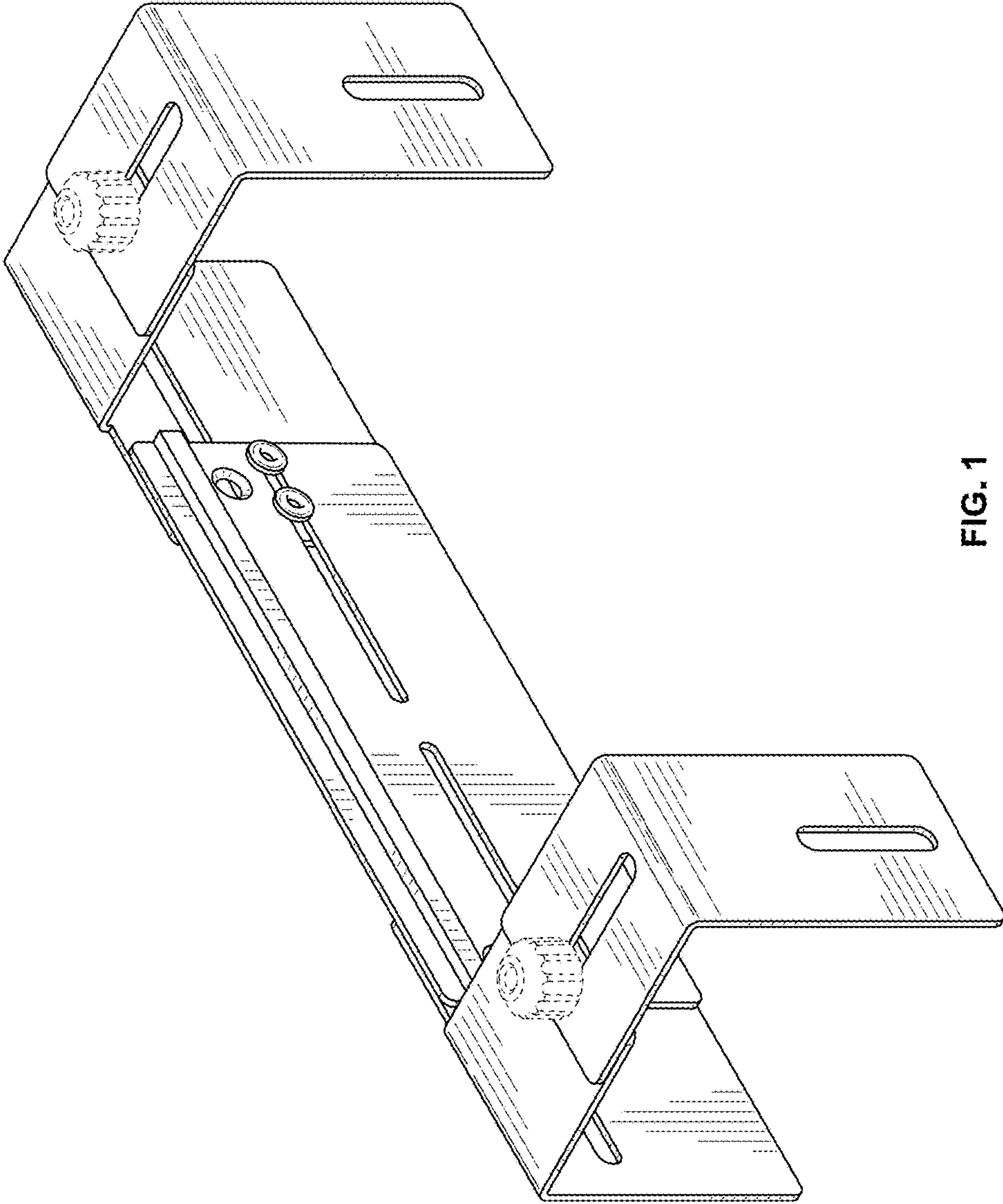

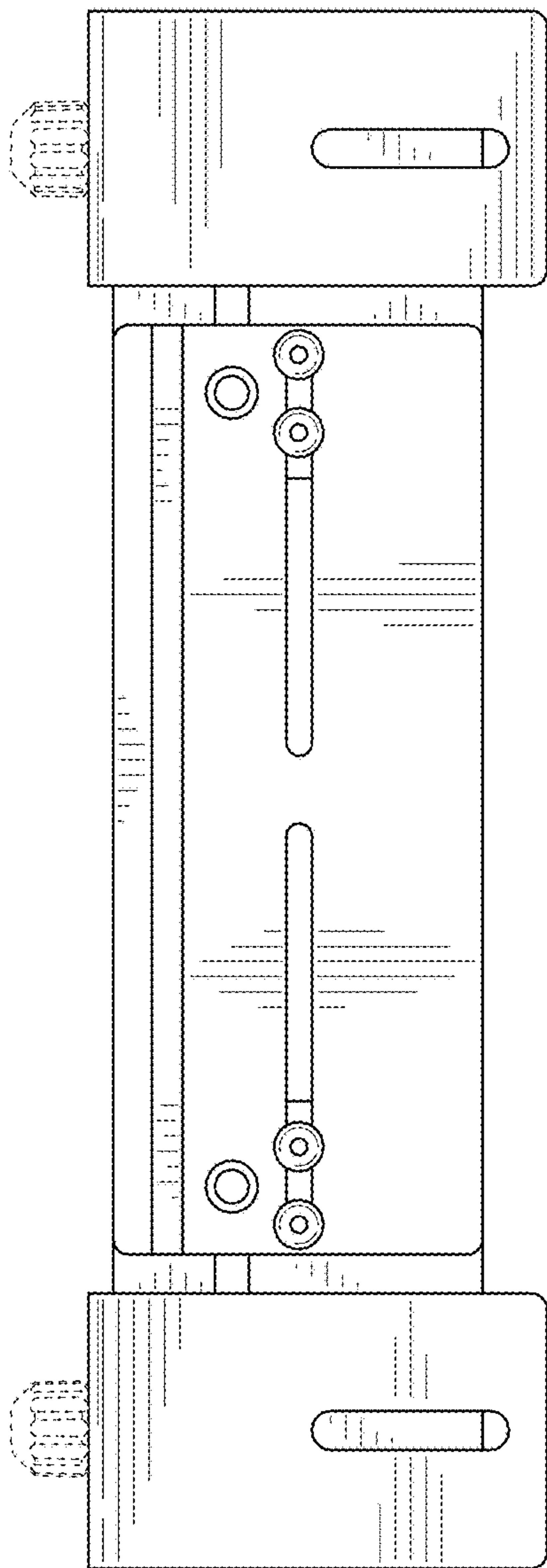

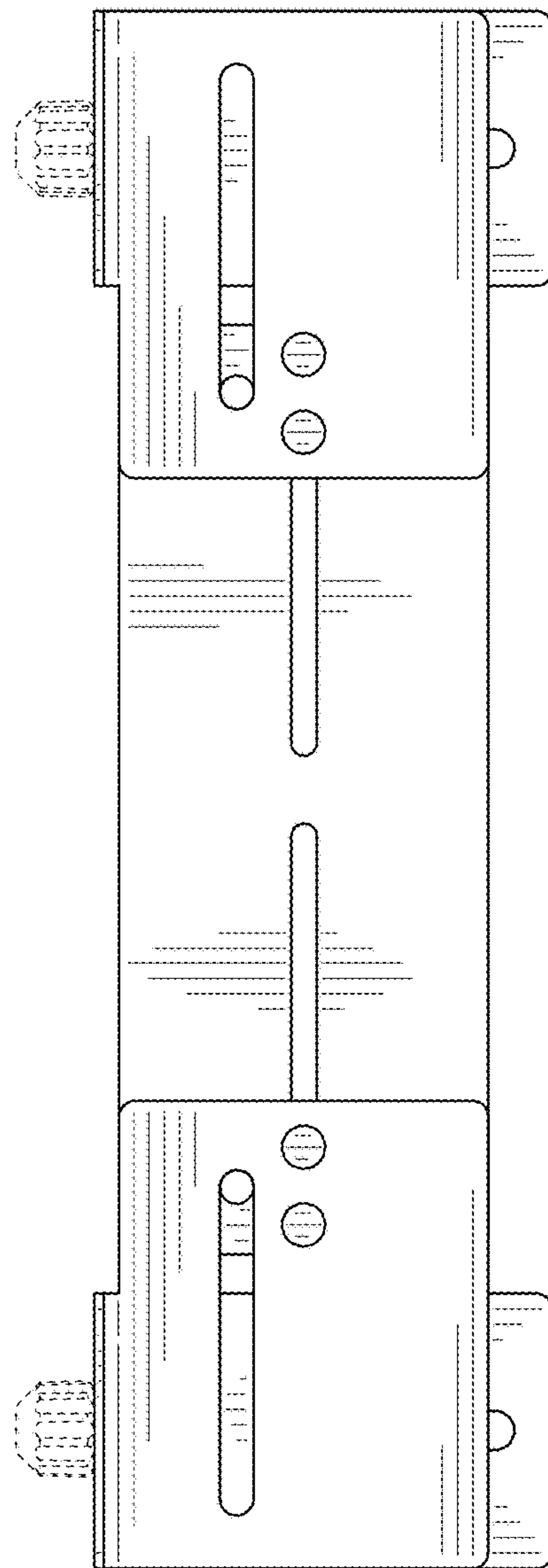

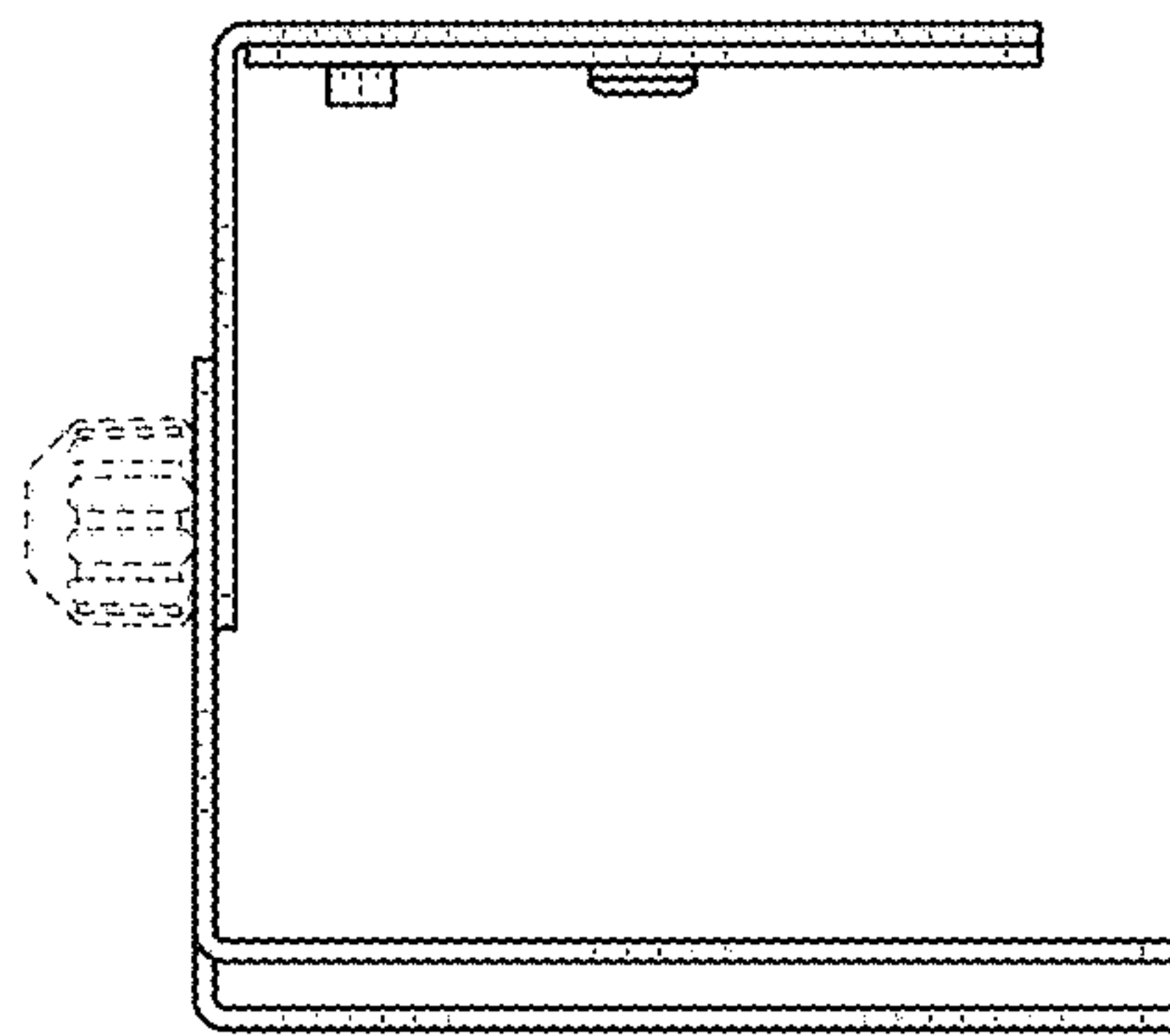

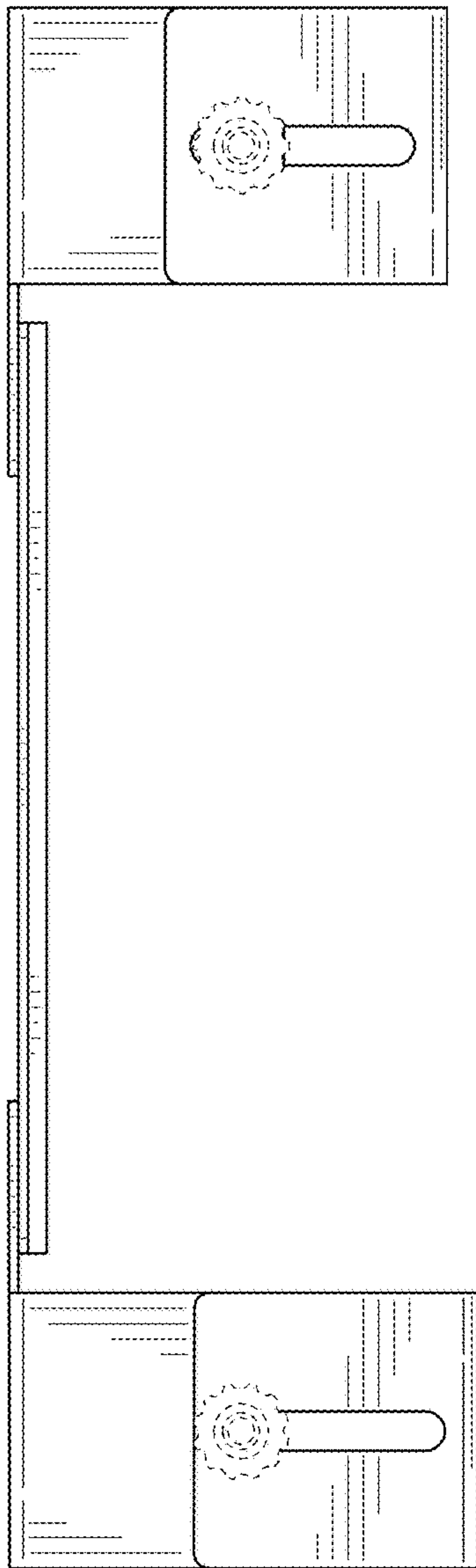

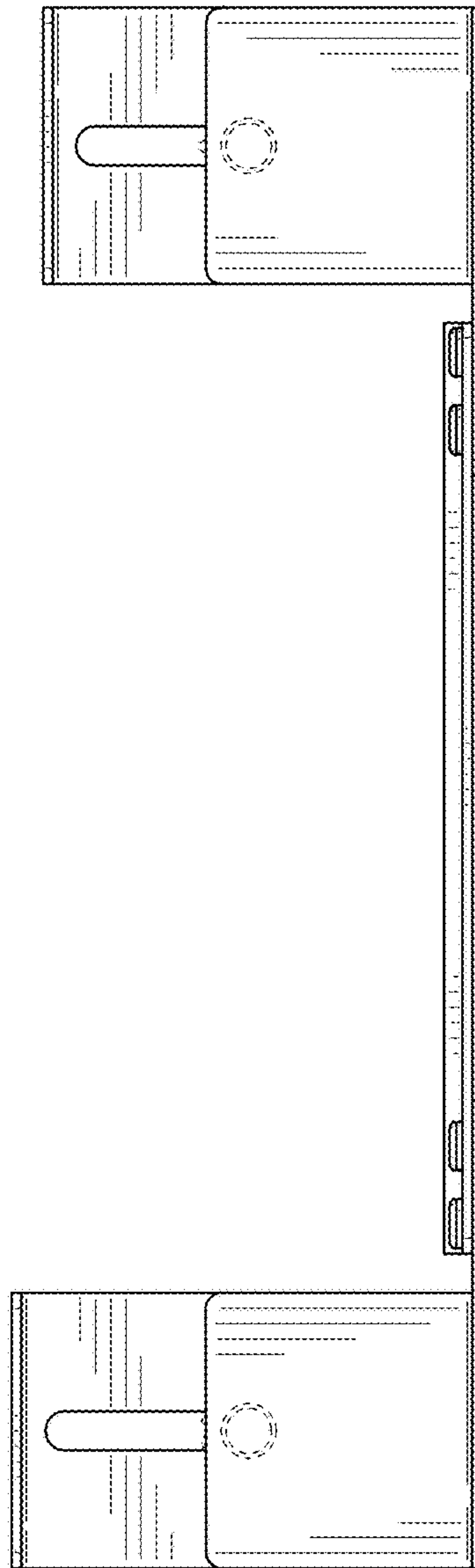
