(57) **CLAIM**

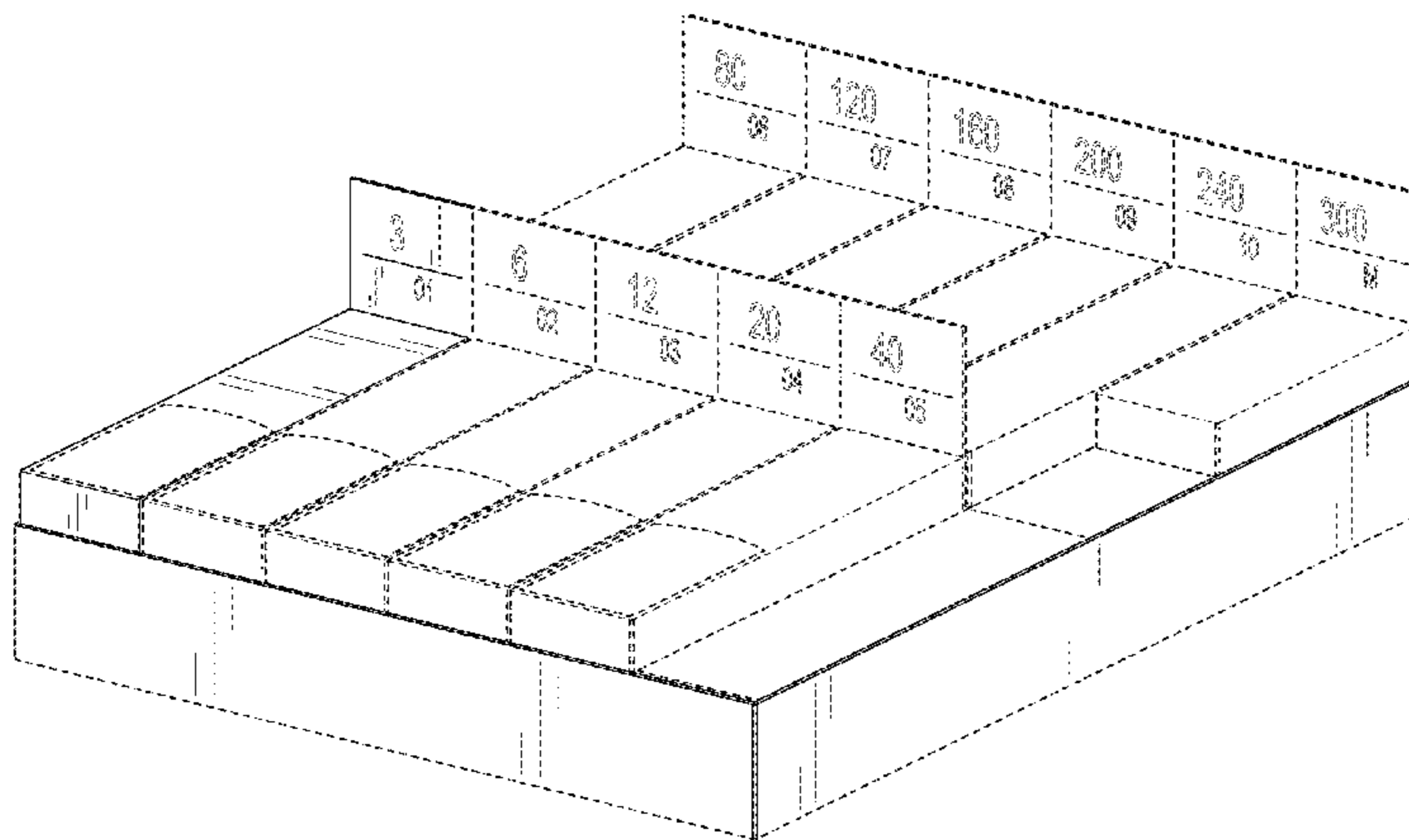
We claim the ornamental design for a box of boxes for
dispensing medicine, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a box of boxes for
dispensing medicine showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a side view thereof;
FIG. 5 is a side view of the opposite side of FIG. 4; and,
FIG. 6 is a top view thereof.

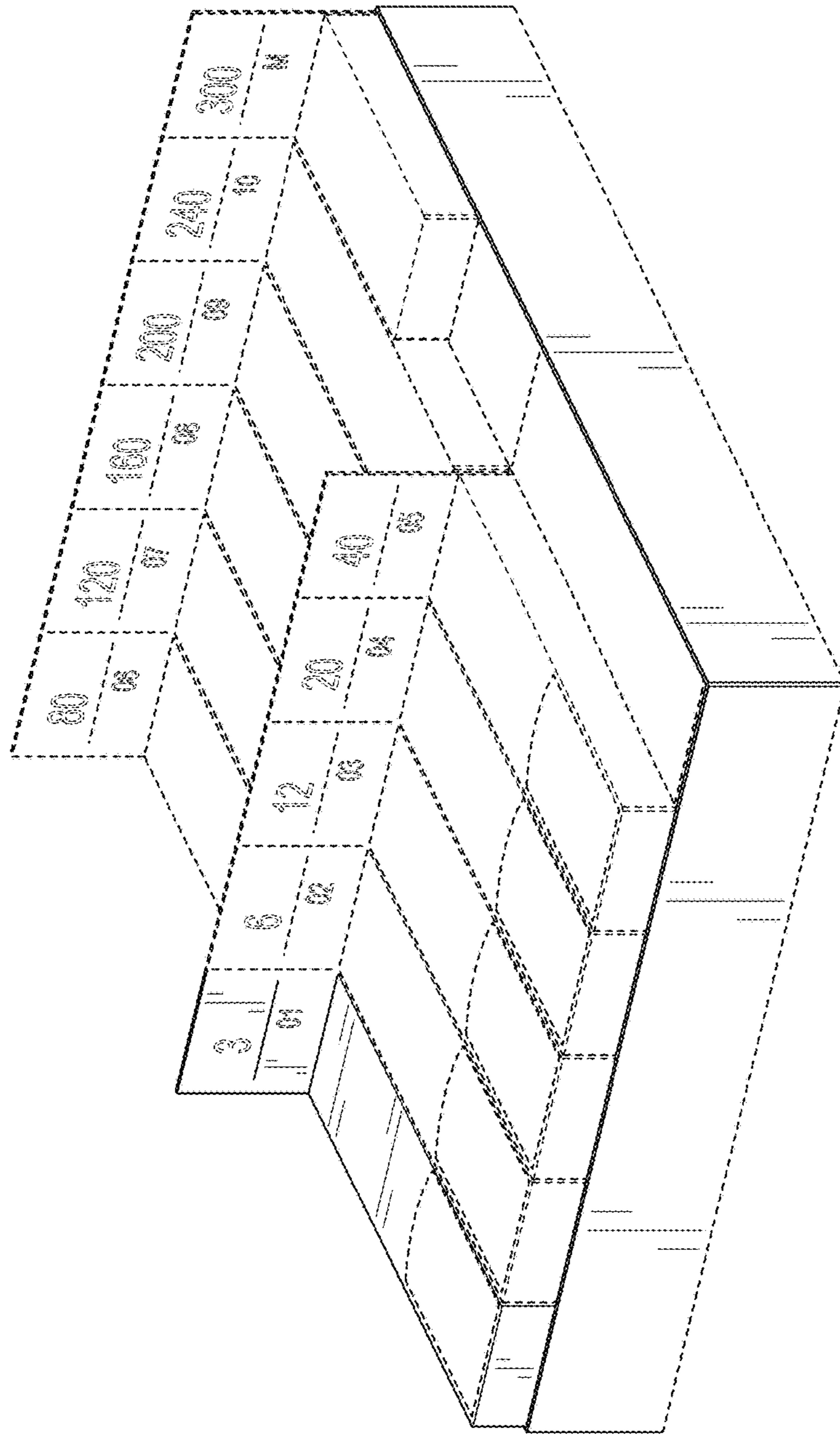

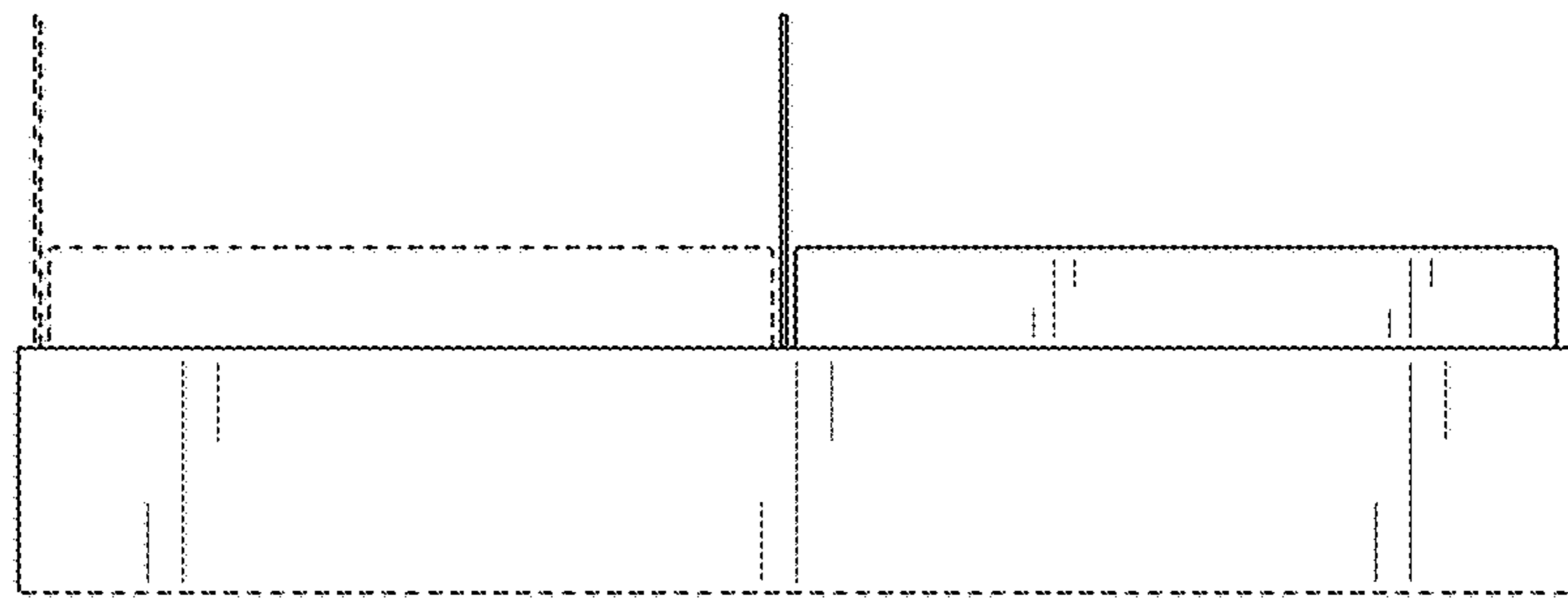

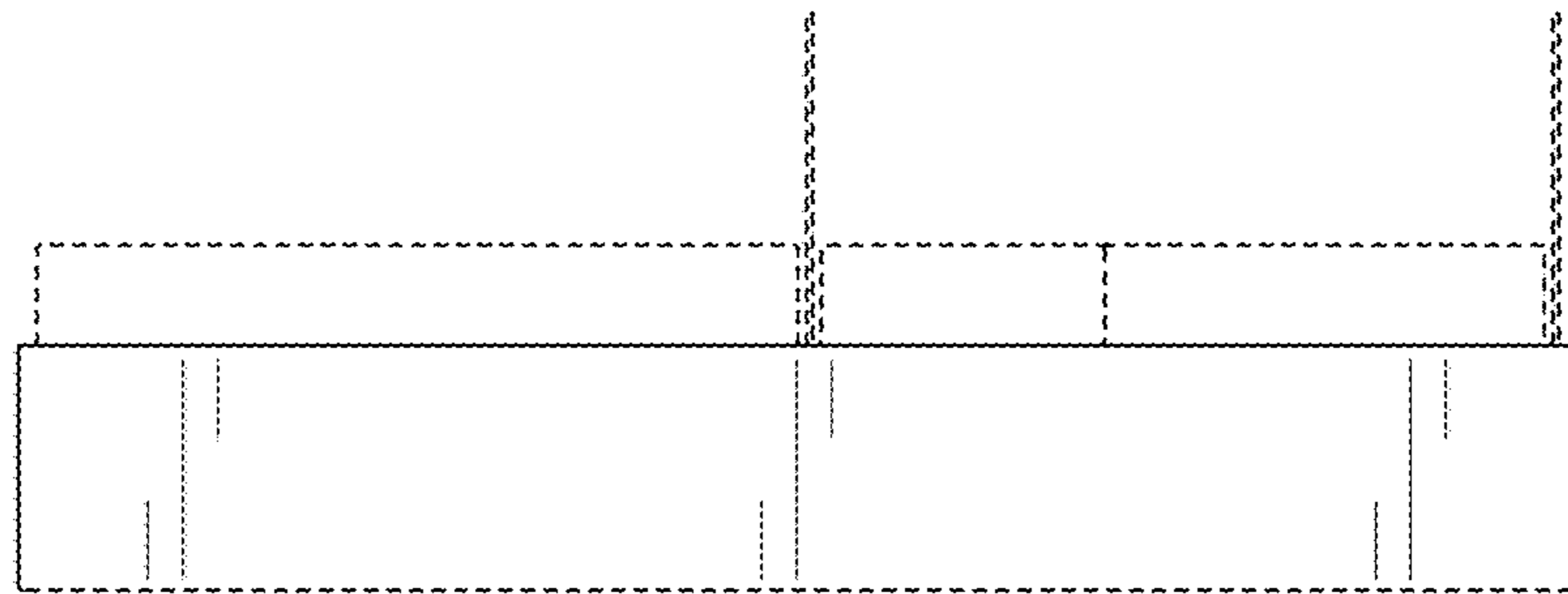

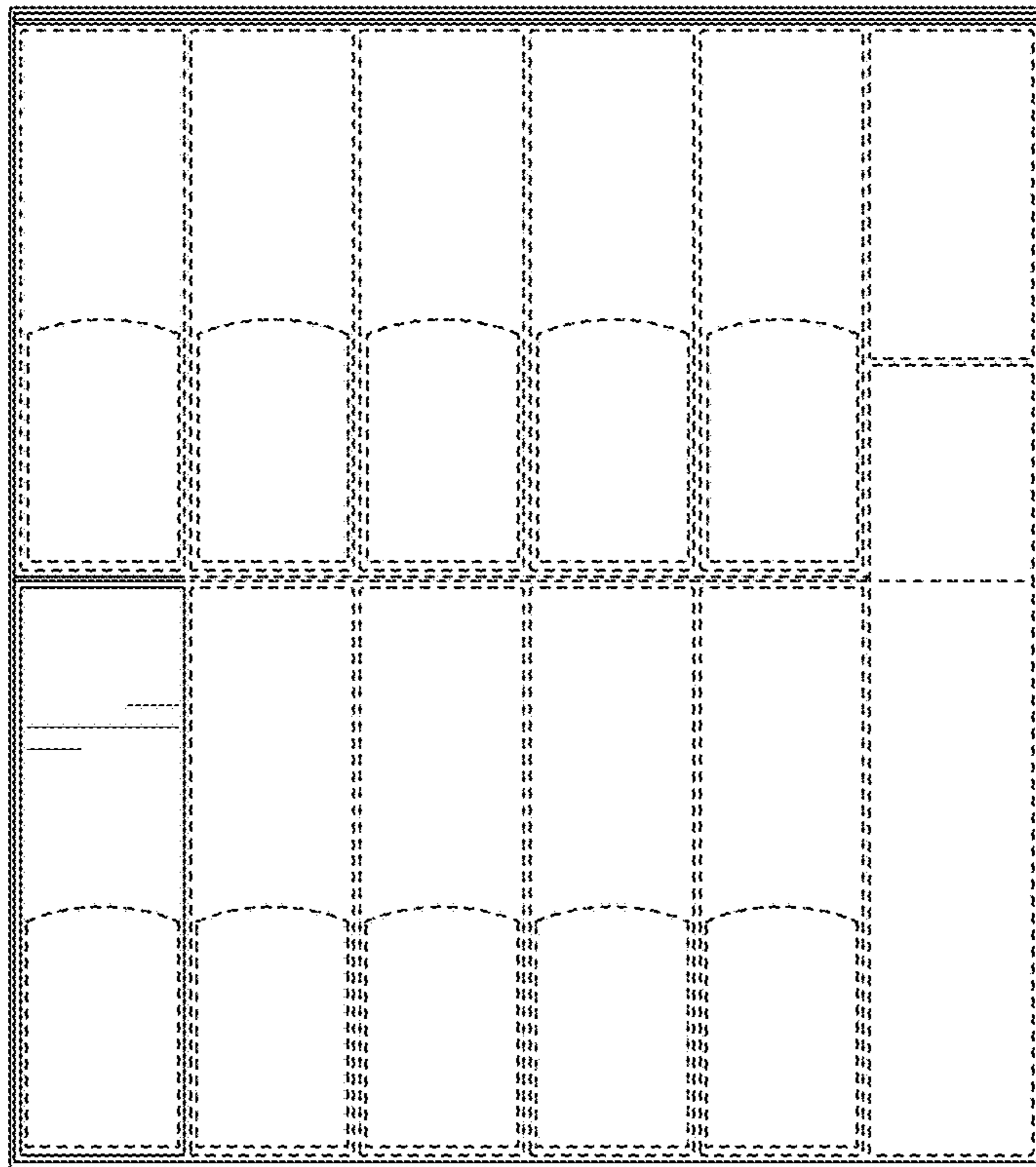
