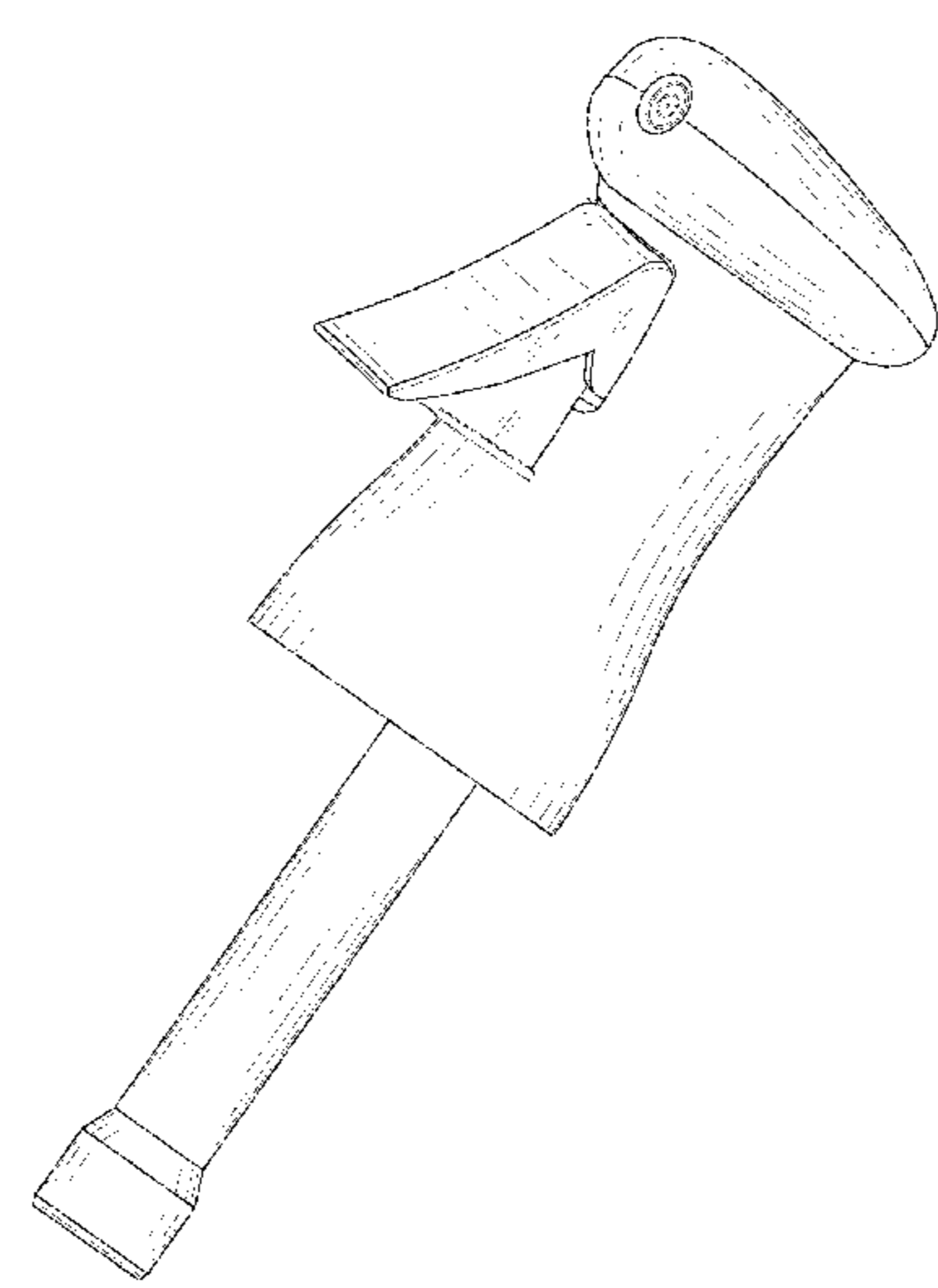

The ornamental design for a manual fluid sprayer device, as shown and described.

**DESCRIPTION**  
FIG. 1 is a front elevational view of the manual fluid sprayer device of the present invention;  
FIG. 2 is a right side elevational view of the manual fluid sprayer device of the present invention;  
FIG. 3 is a rear elevational view of the manual fluid sprayer device of the present invention;  
FIG. 4 is a left side elevational view of the manual fluid sprayer device of the present invention;  
FIG. 5 is a top plan view of the manual fluid sprayer device of the present invention;  
FIG. 6 is a bottom plan view of the manual fluid sprayer device of the present invention;

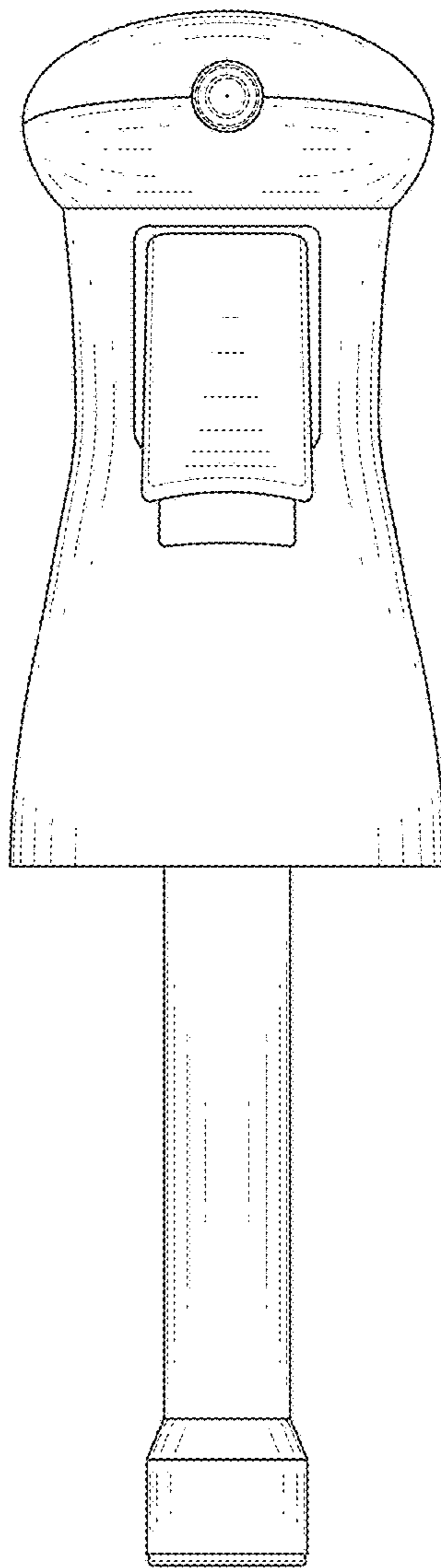

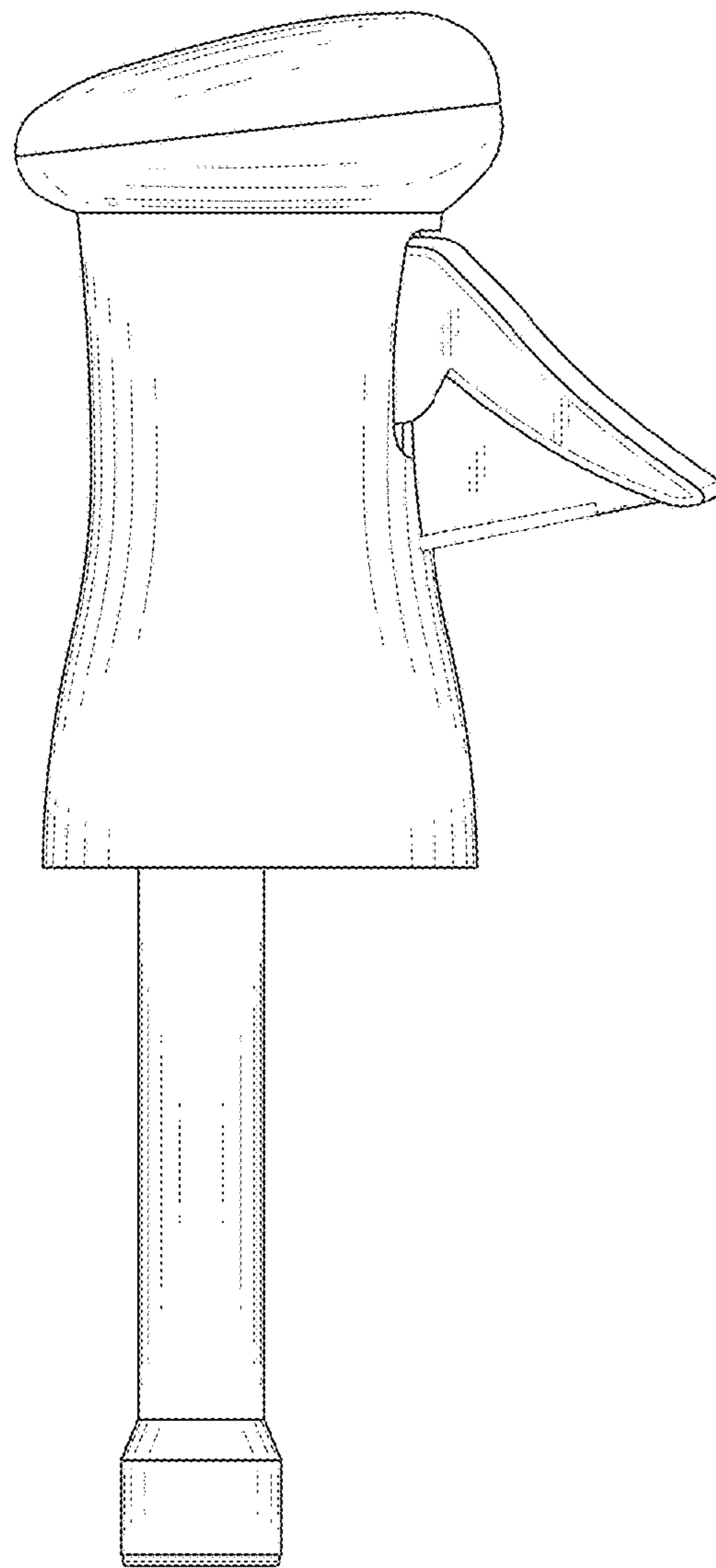

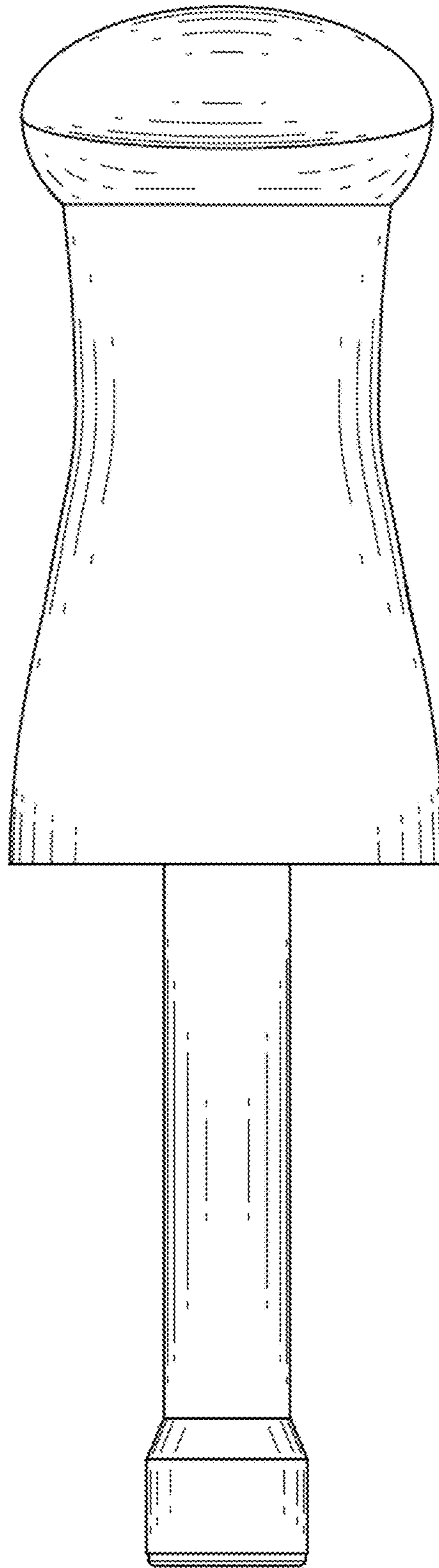

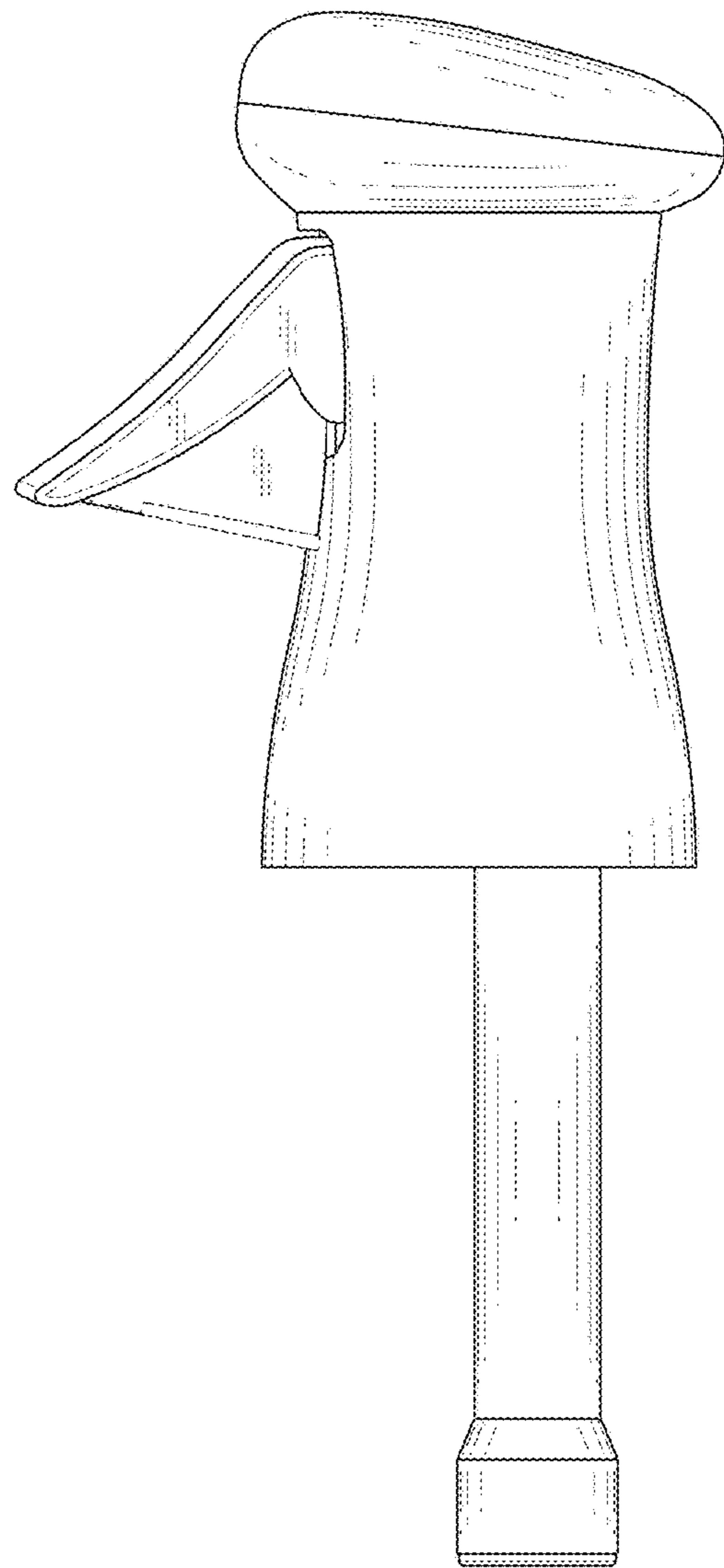

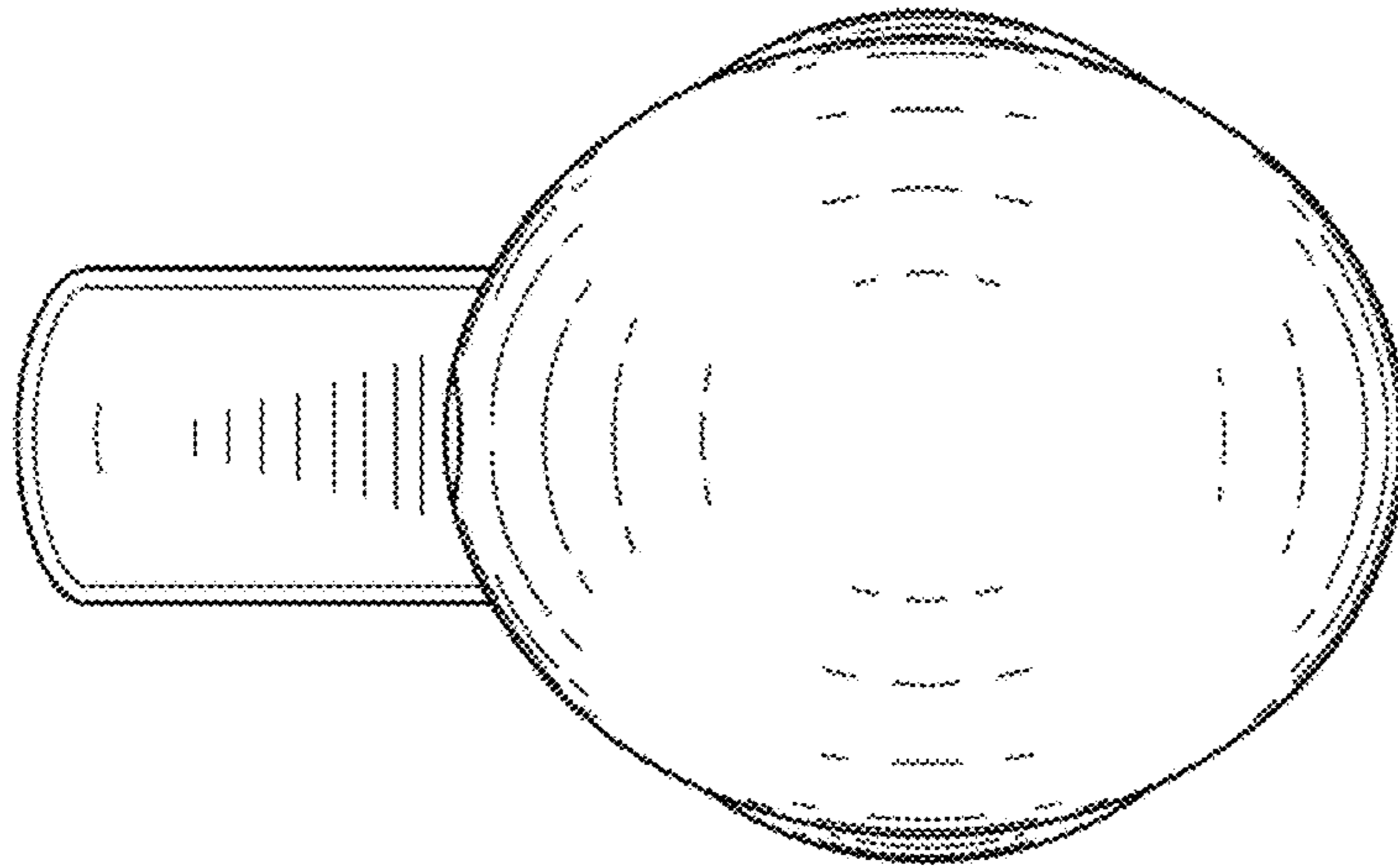

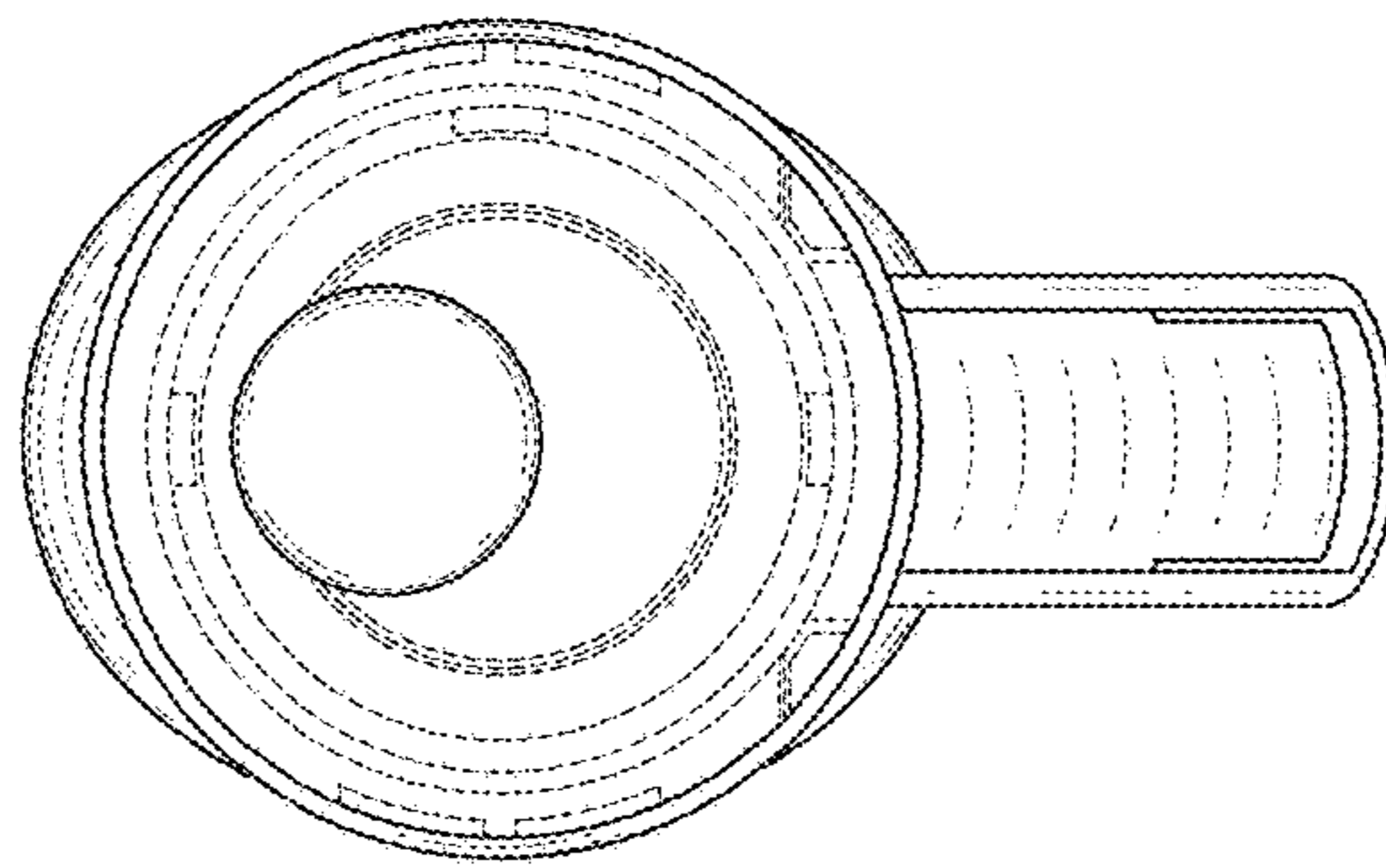

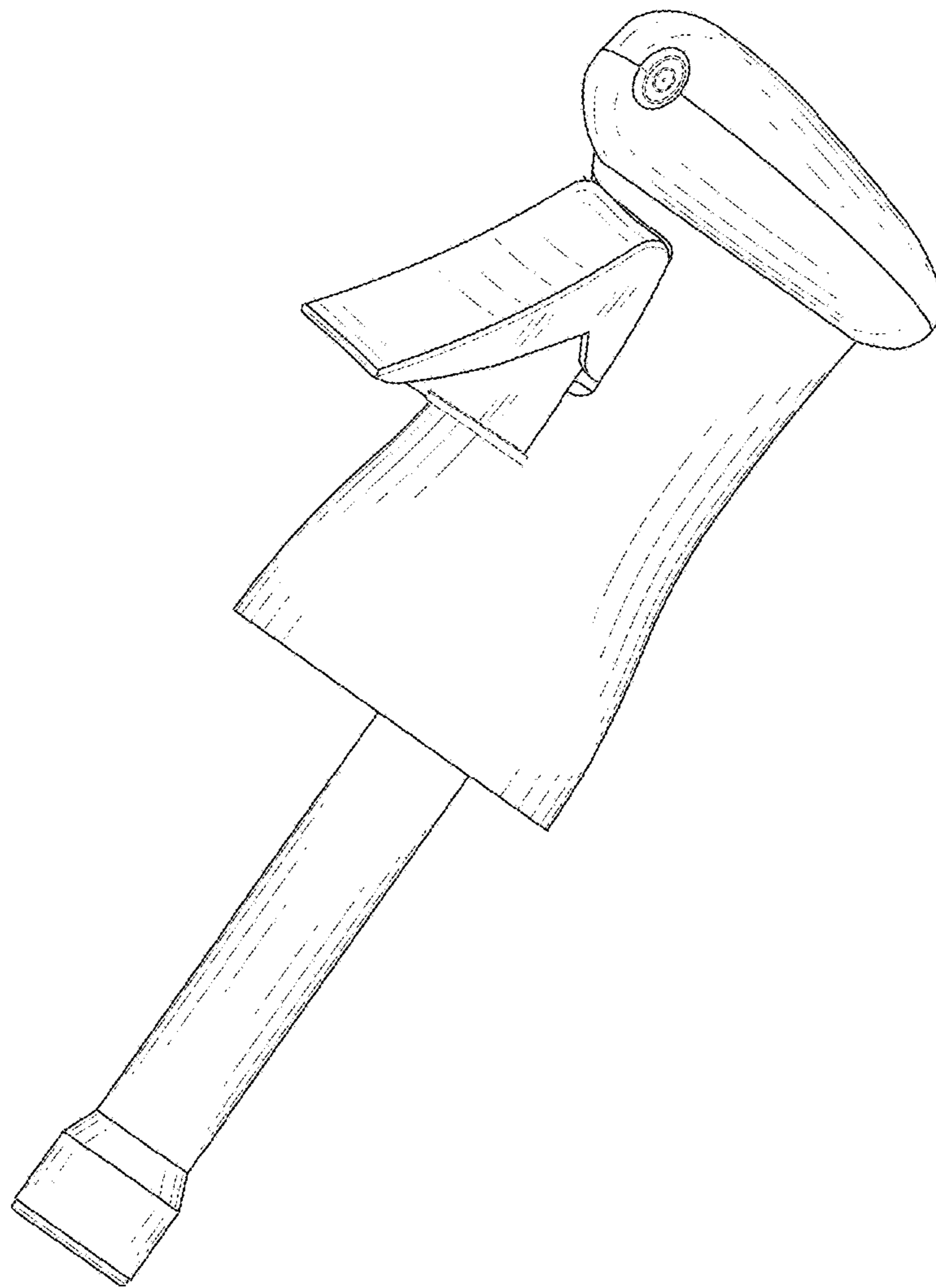

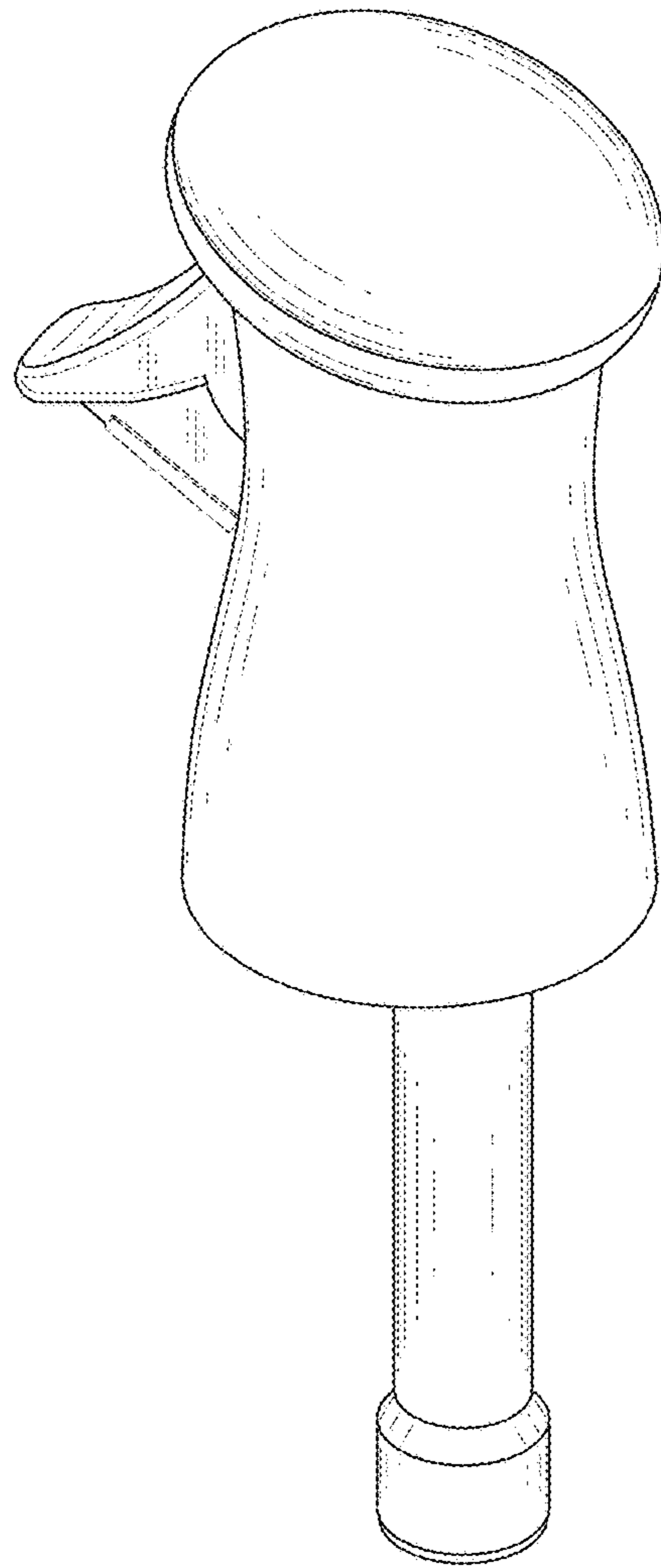
