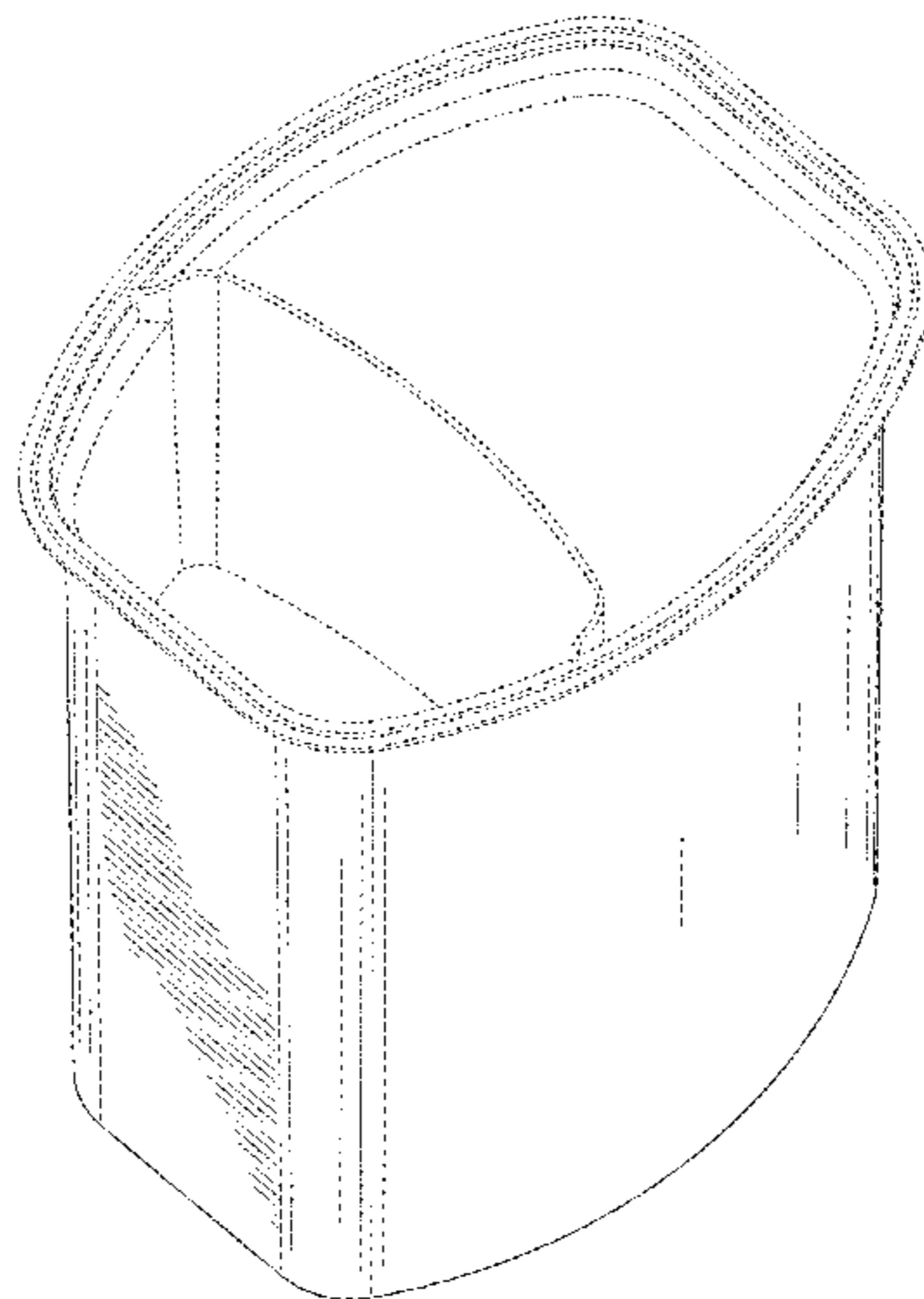
(57) **CLAIM**

I claim the ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the claimed design; FIG. 2 is a right side view of the claimed design of FIG. 1; FIG. 3 is a left side view of the claimed design of FIG. 1; FIG. 4 is a back view of the claimed design of FIG. 1; FIG. 5 is a front view of the claimed design of FIG. 1; FIG. 6 is a top view of the claimed design of FIG. 1; and, FIG. 7 is a bottom view of the claimed design of FIG. 1. The claim is directed to the solid lines and shaded surfaces, and any unshaded surfaces shown between the broken and solid lines form no part of the claimed design. The broken lines in the drawings depict portions of the container that form no part of the claimed design.

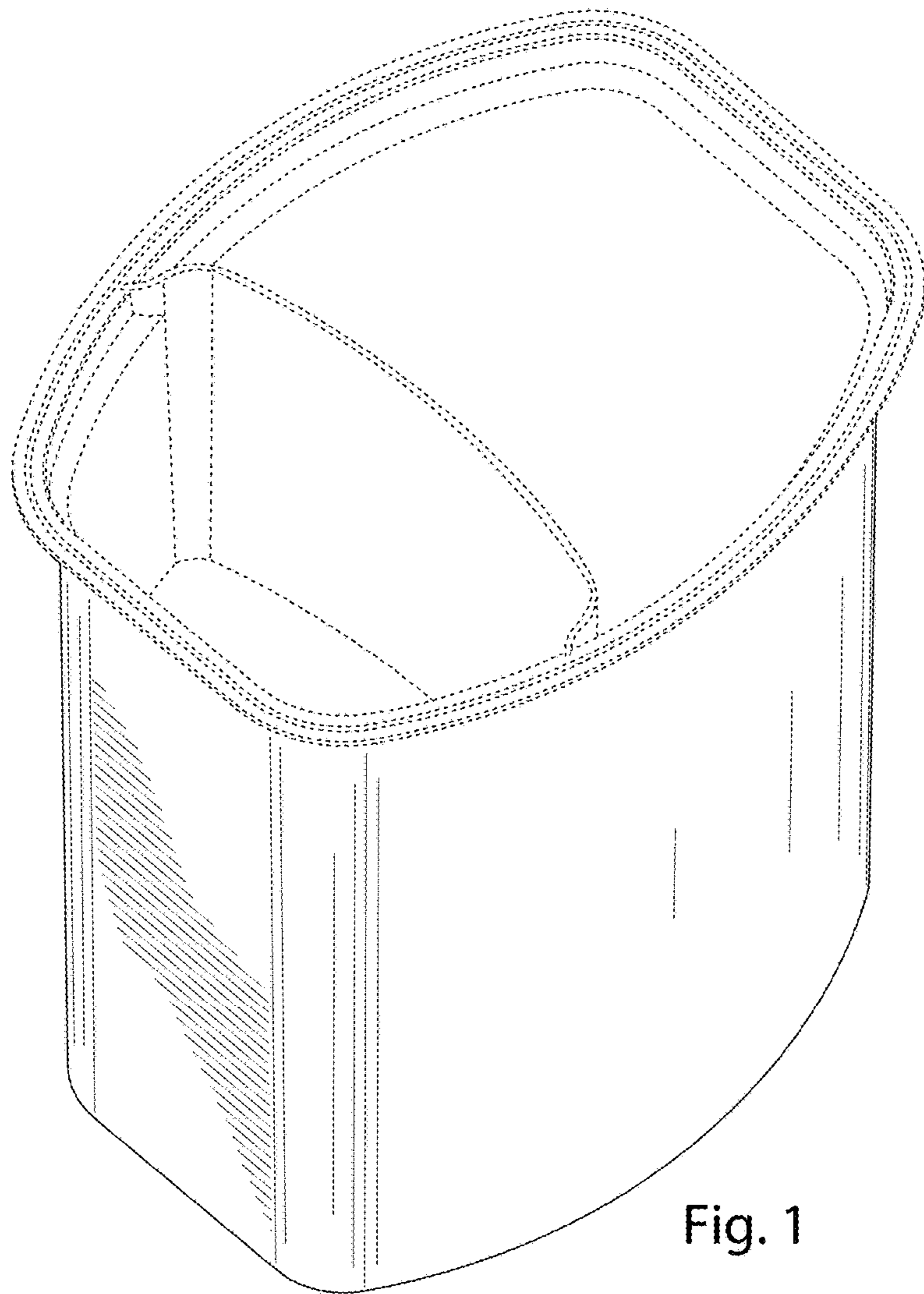

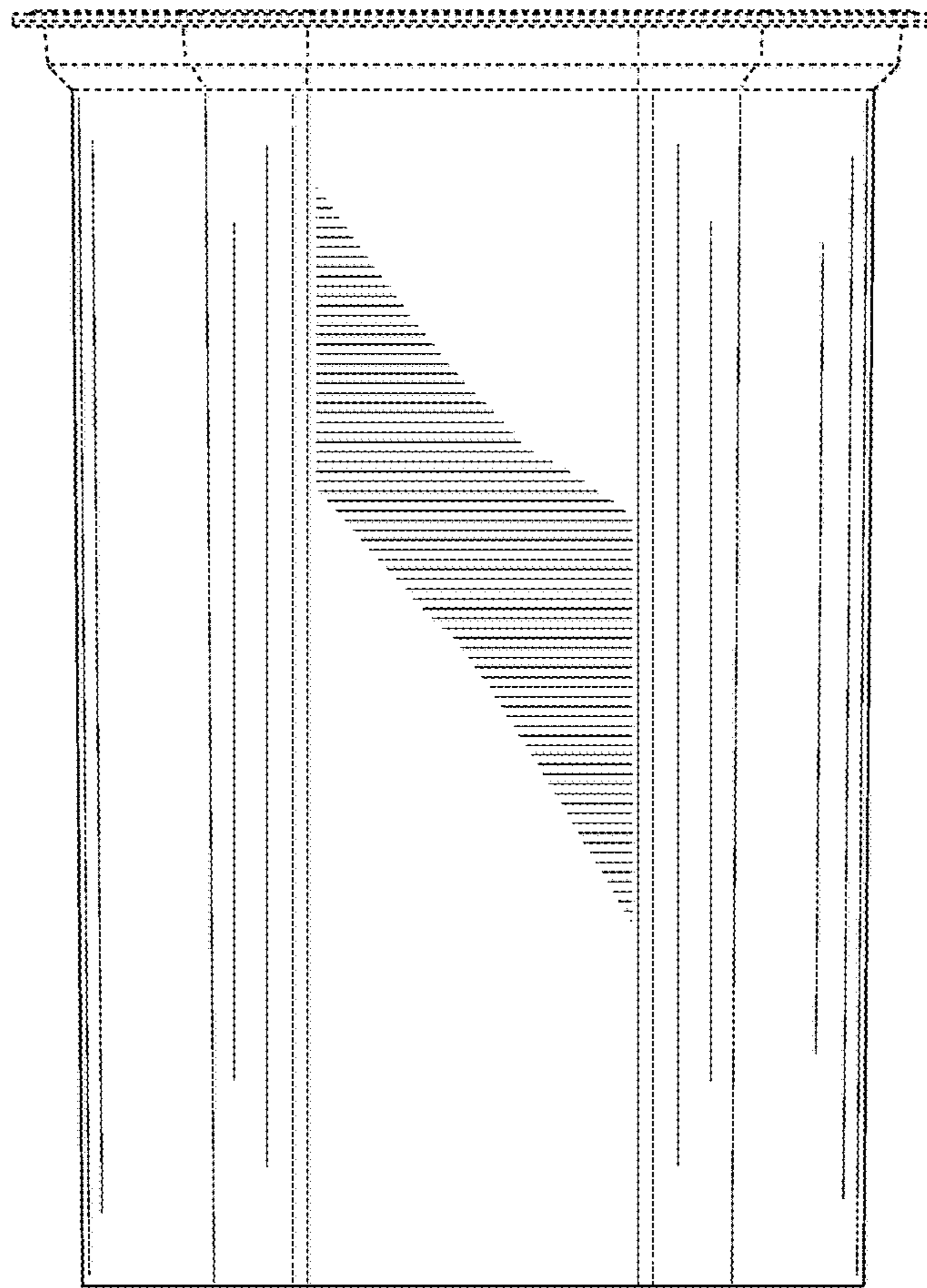

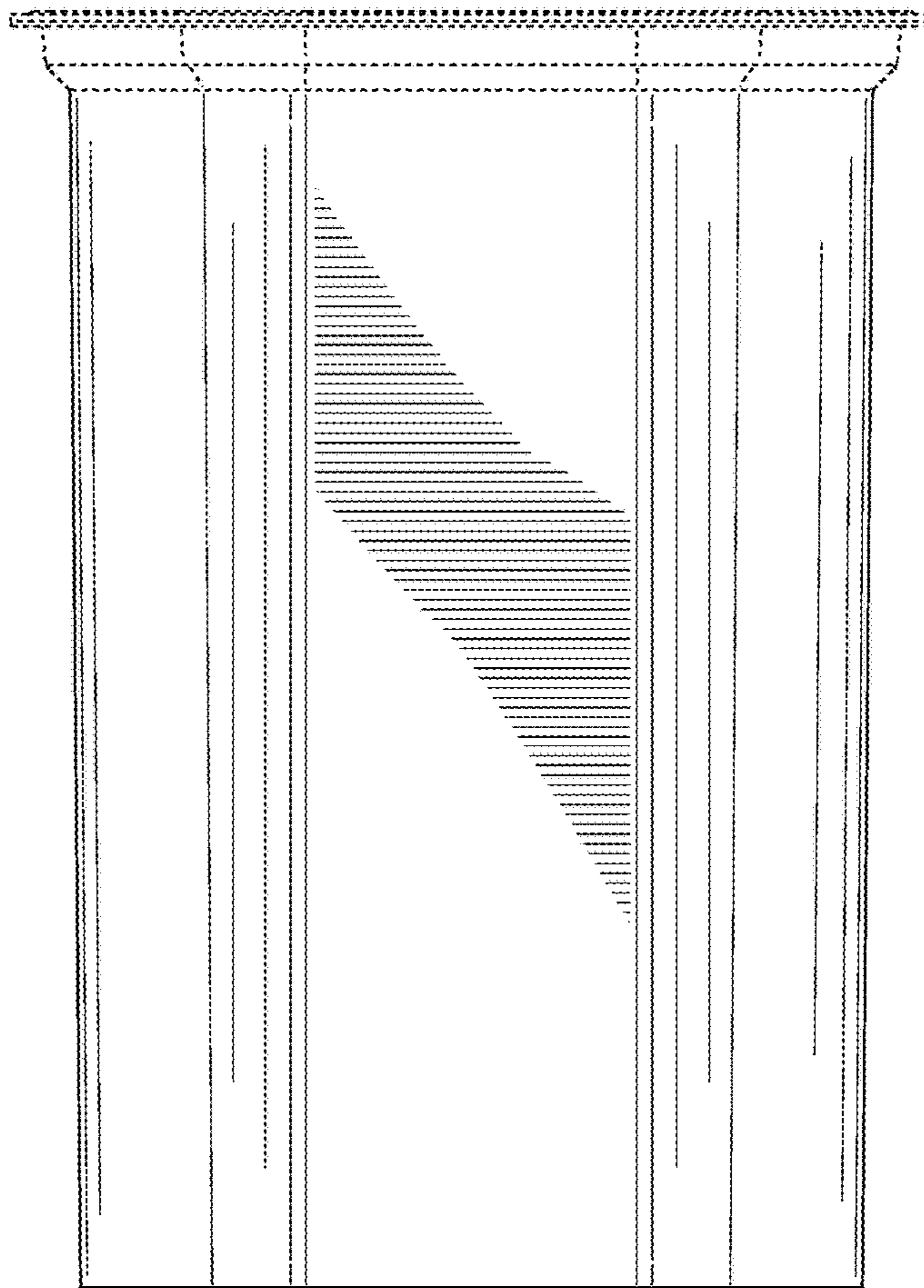

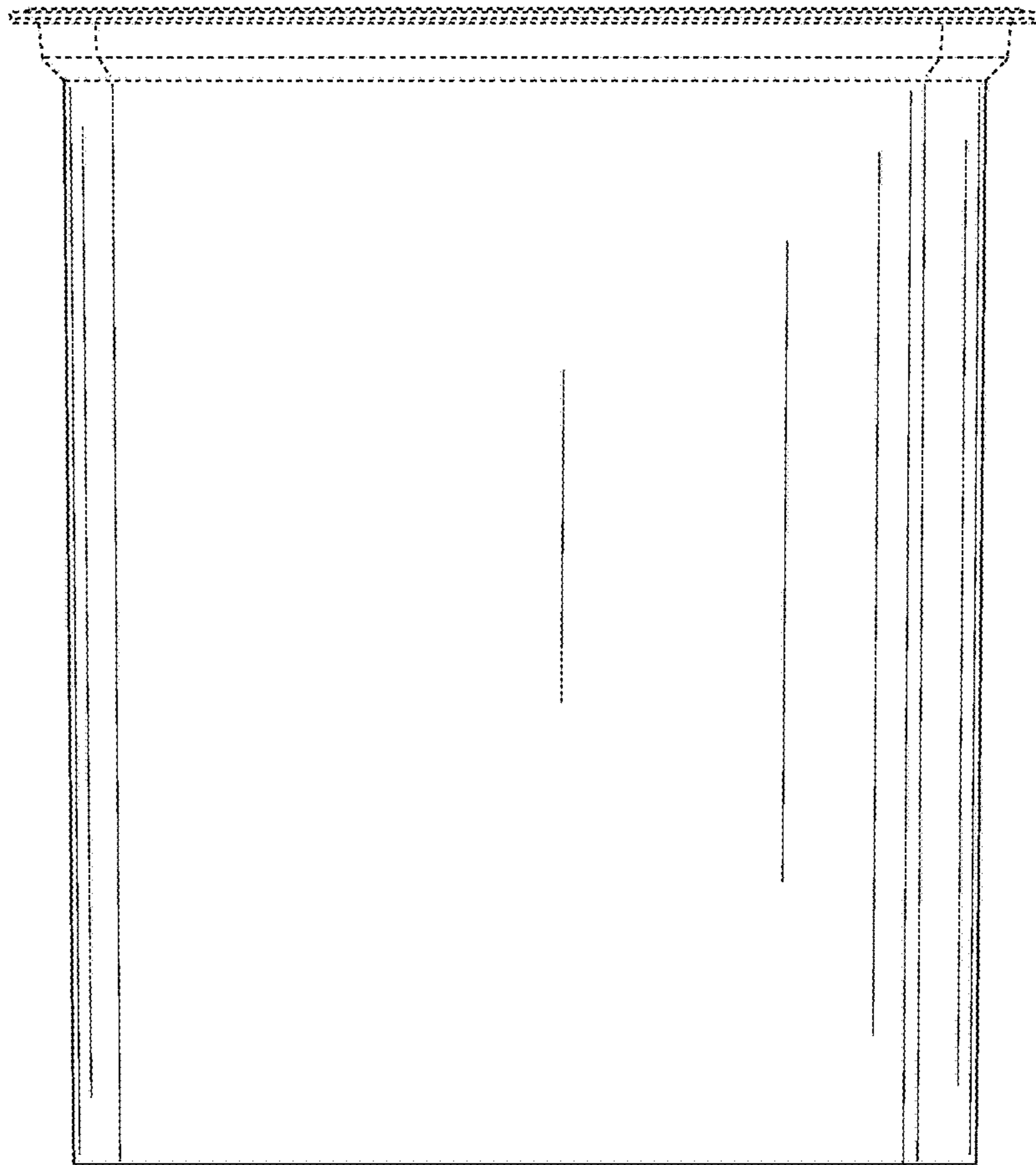

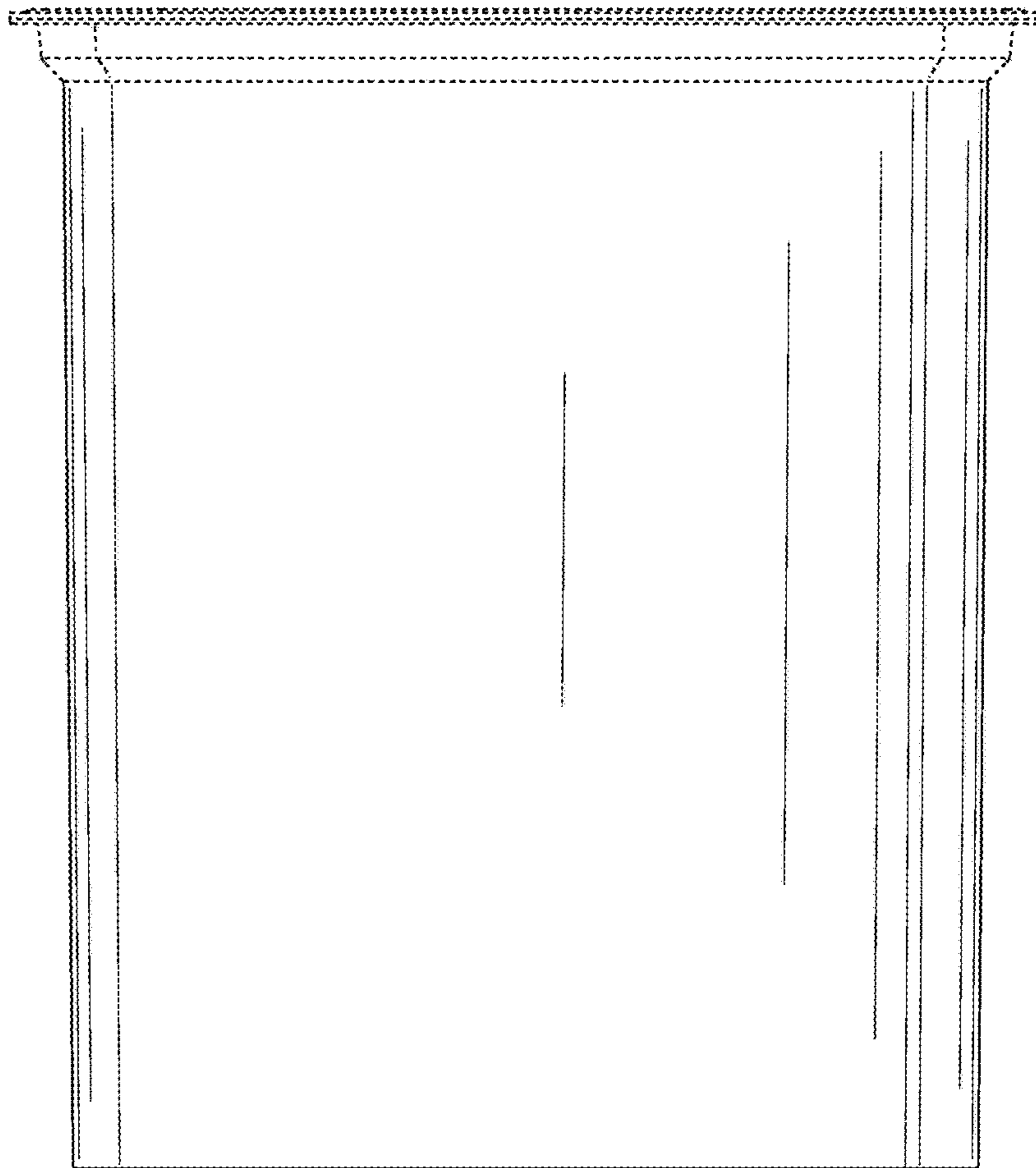

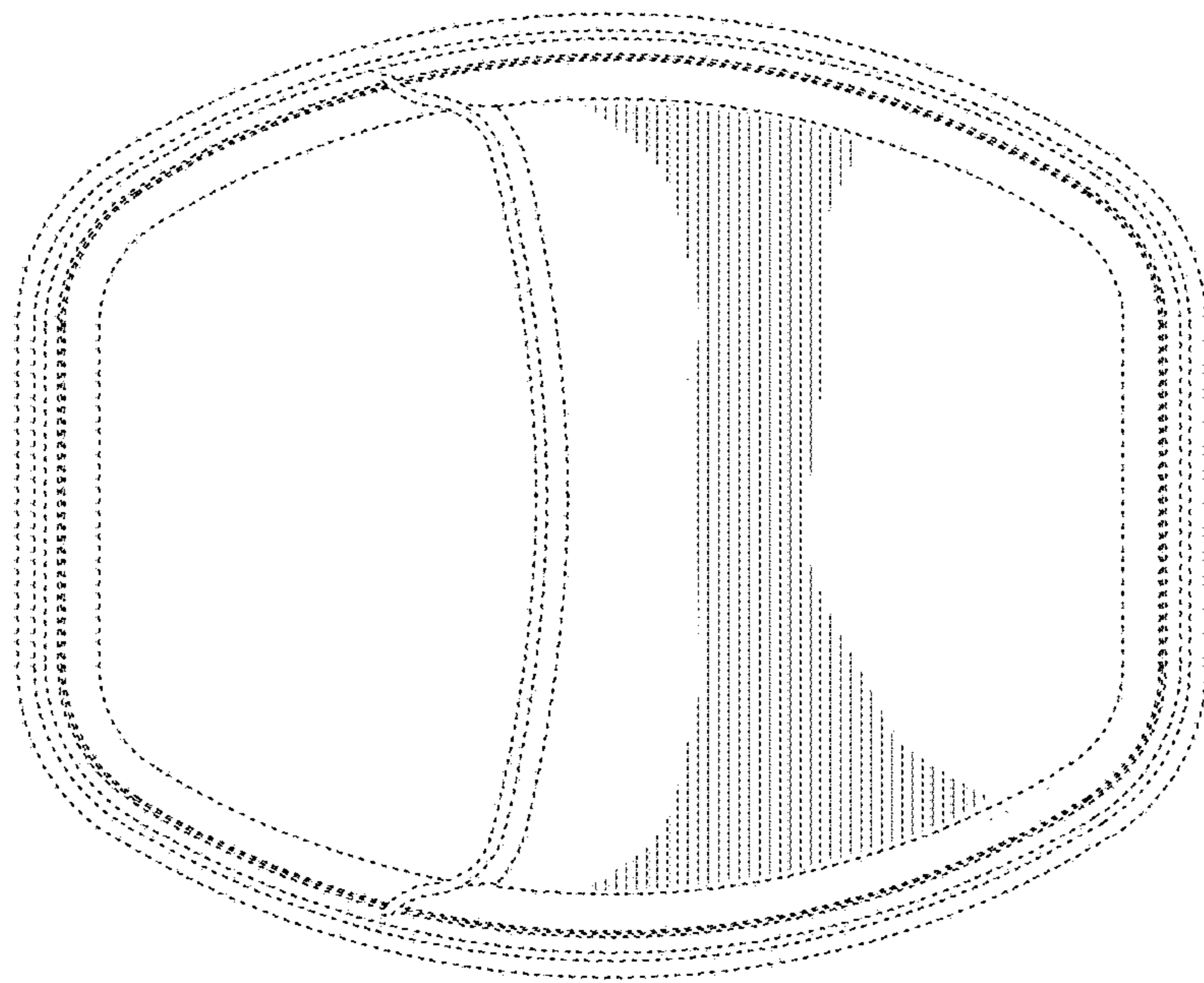

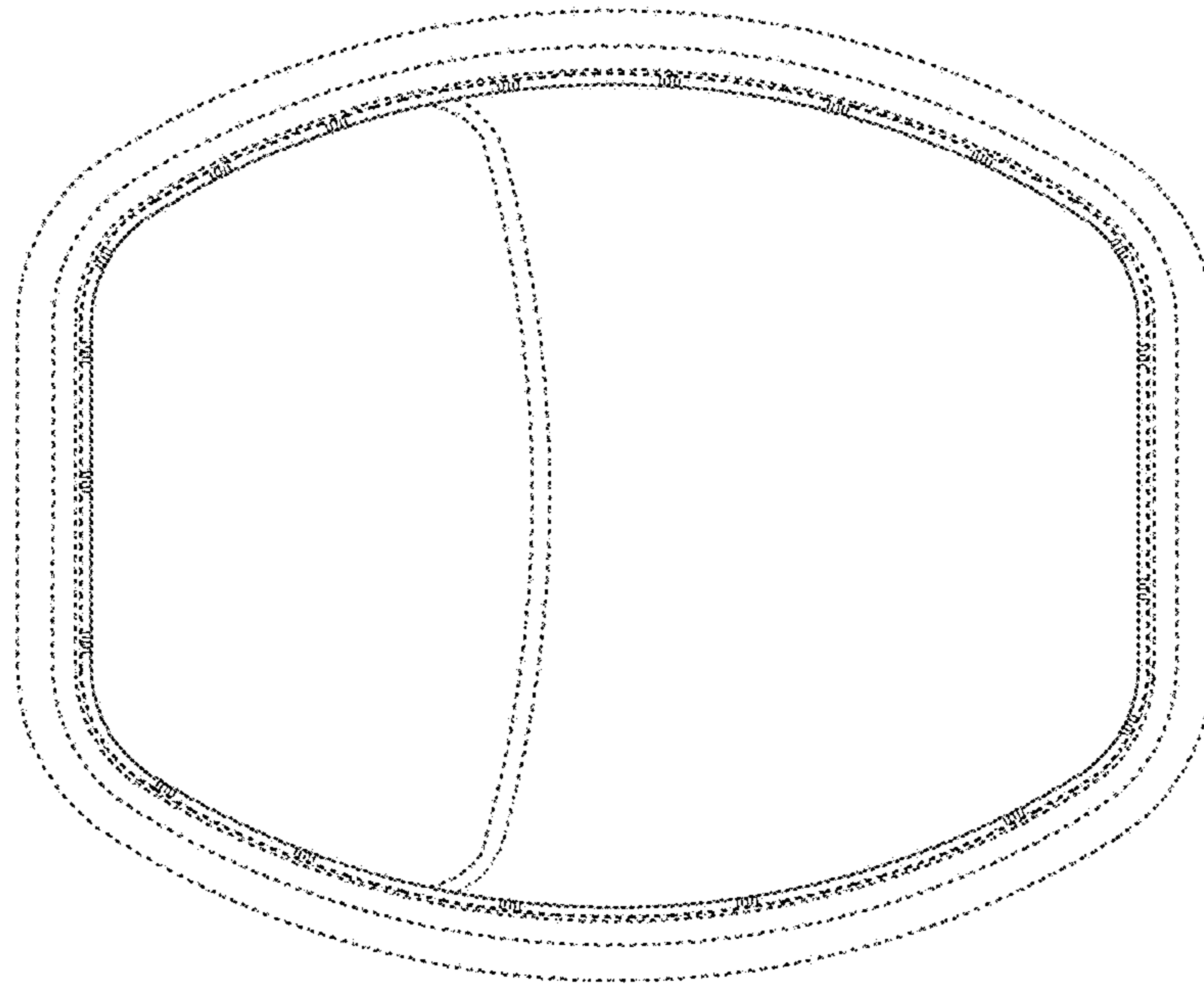
