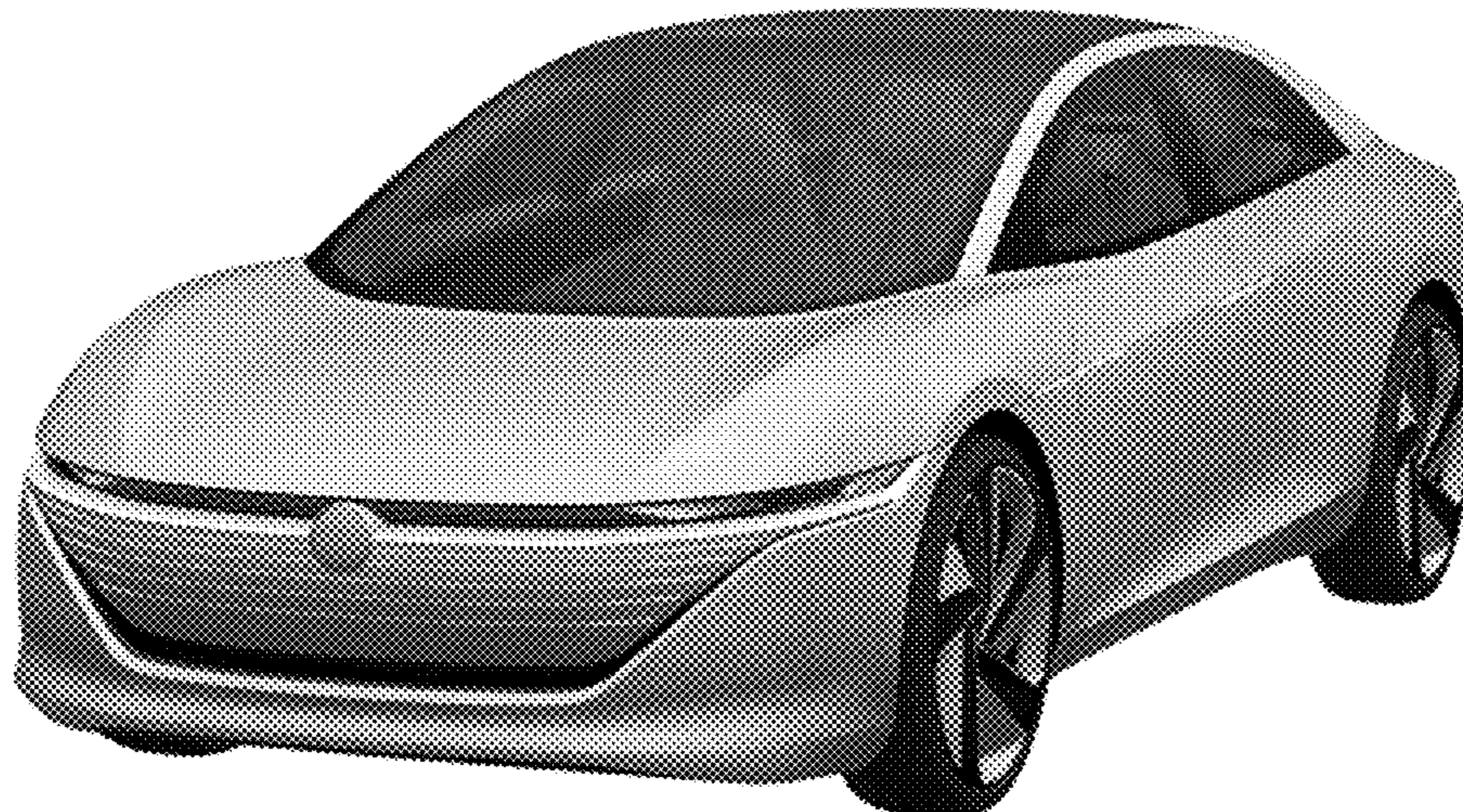
FIG. 1 is a front and right side perspective view of a motor vehicle showing our new design;

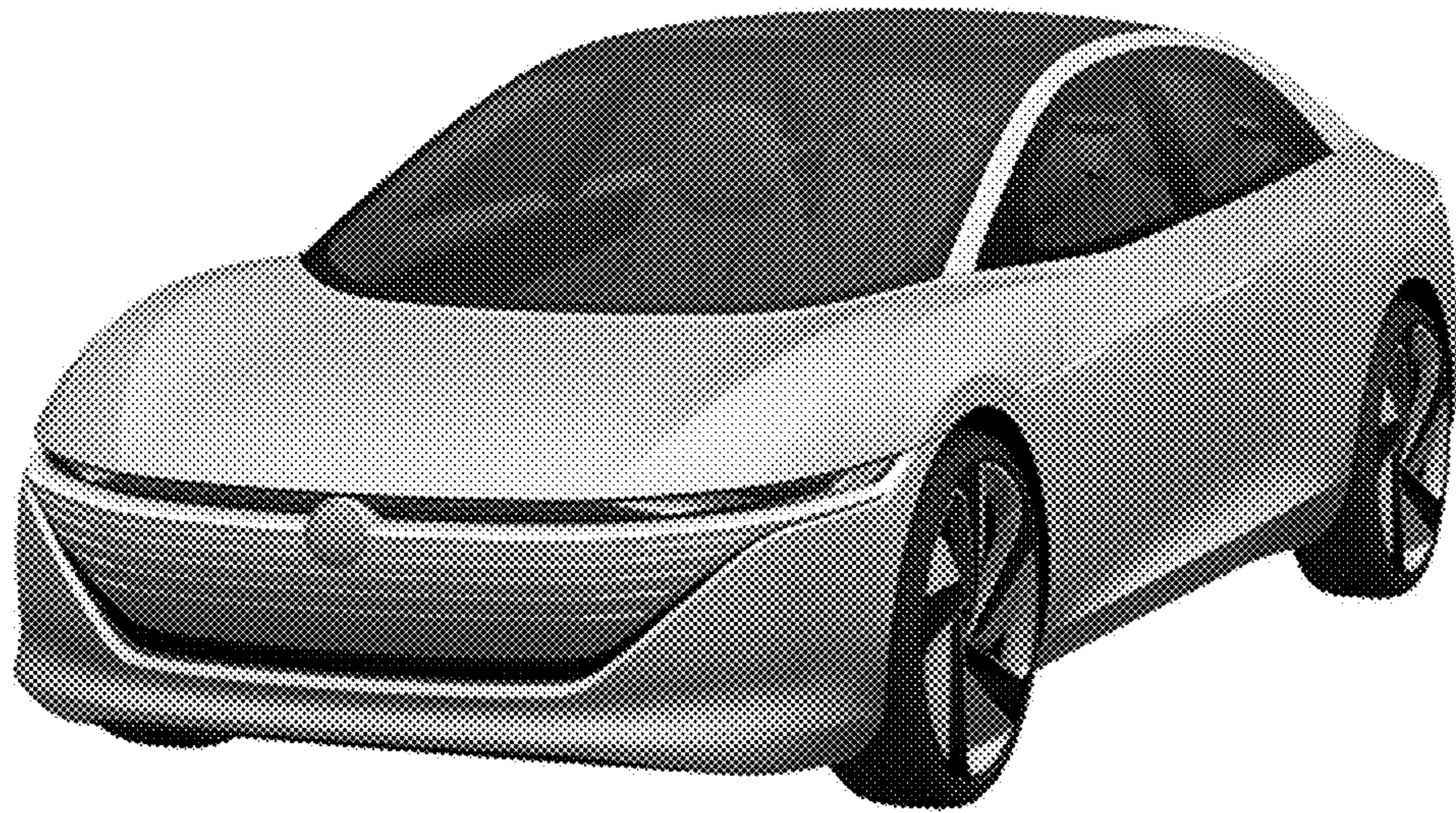

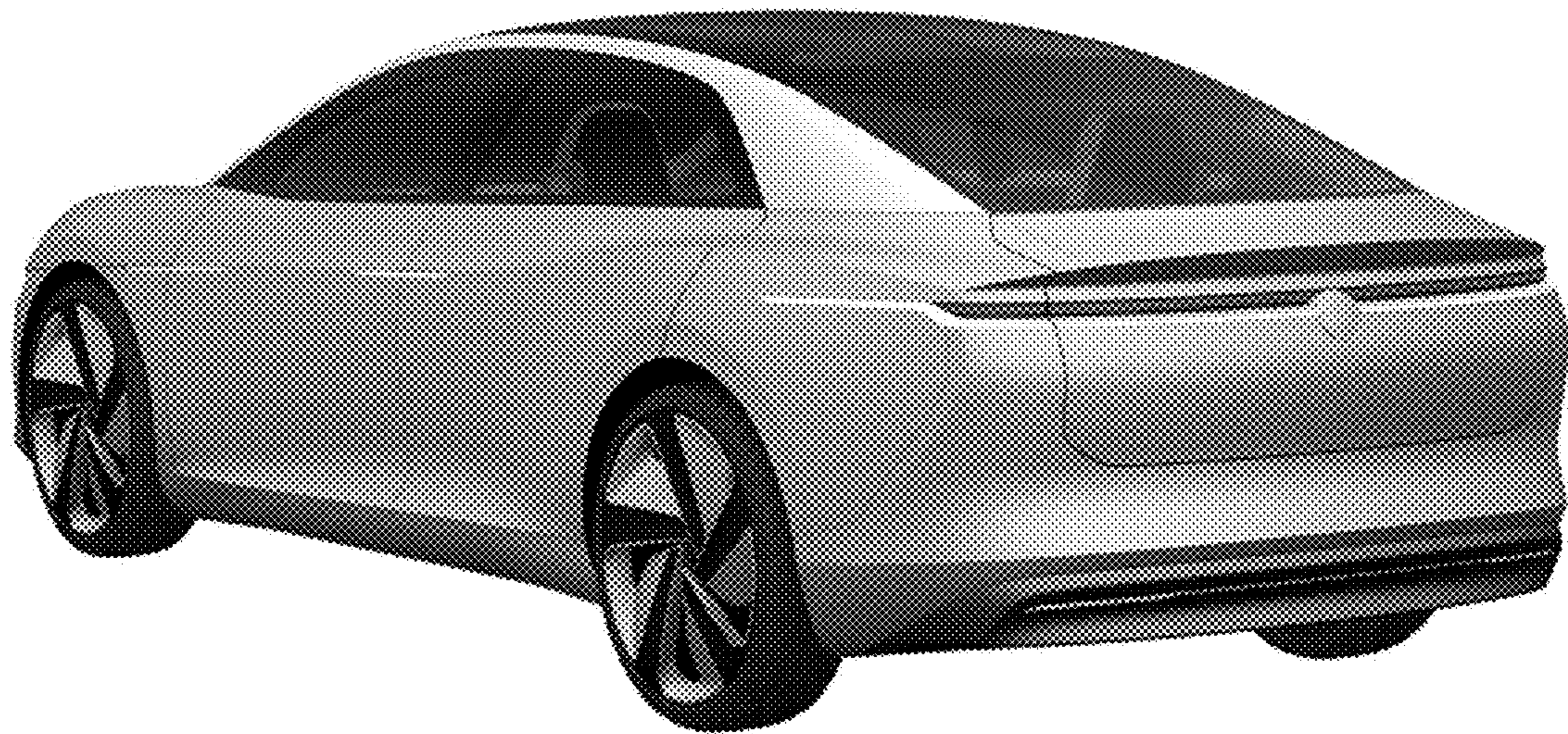
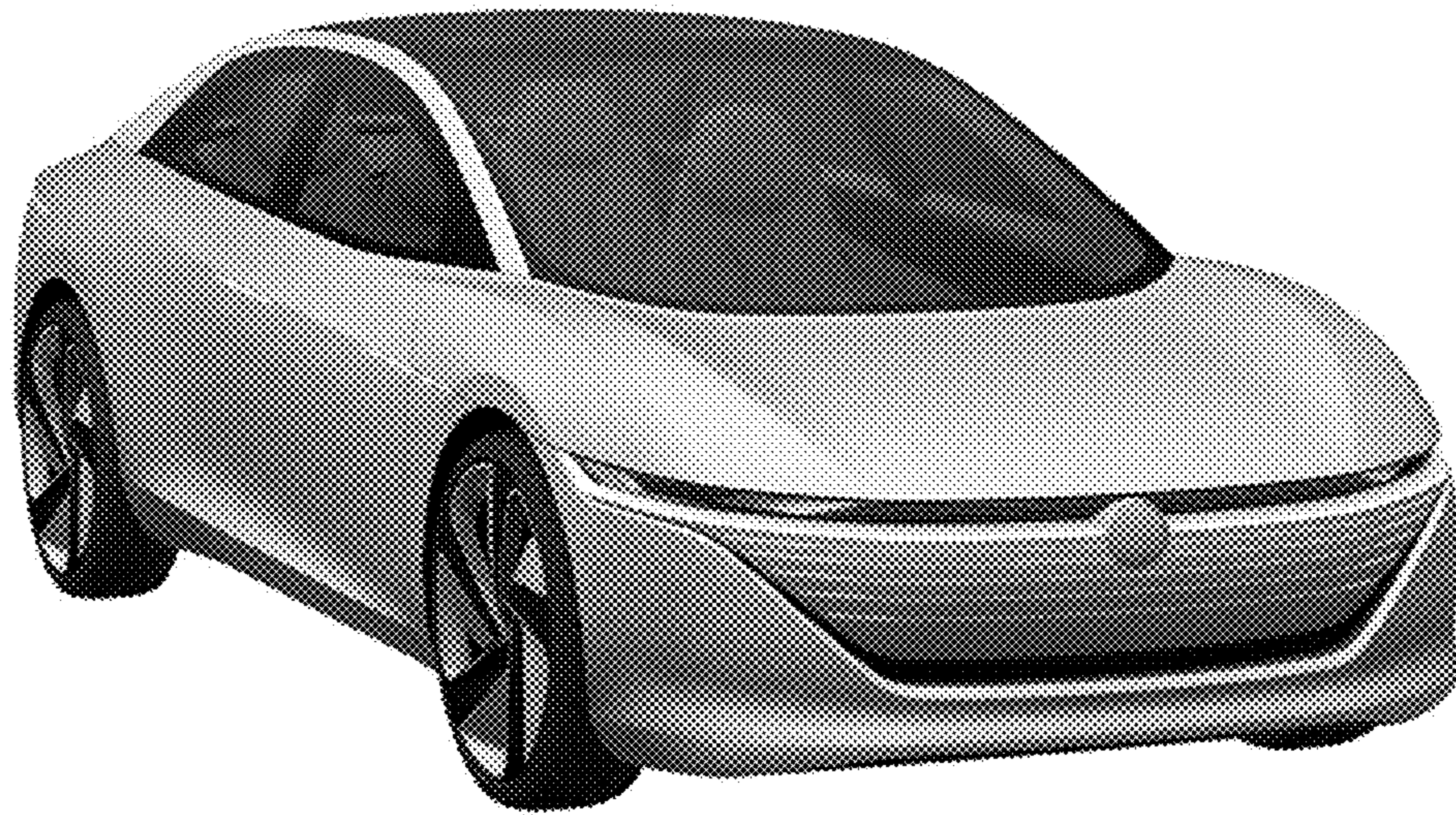
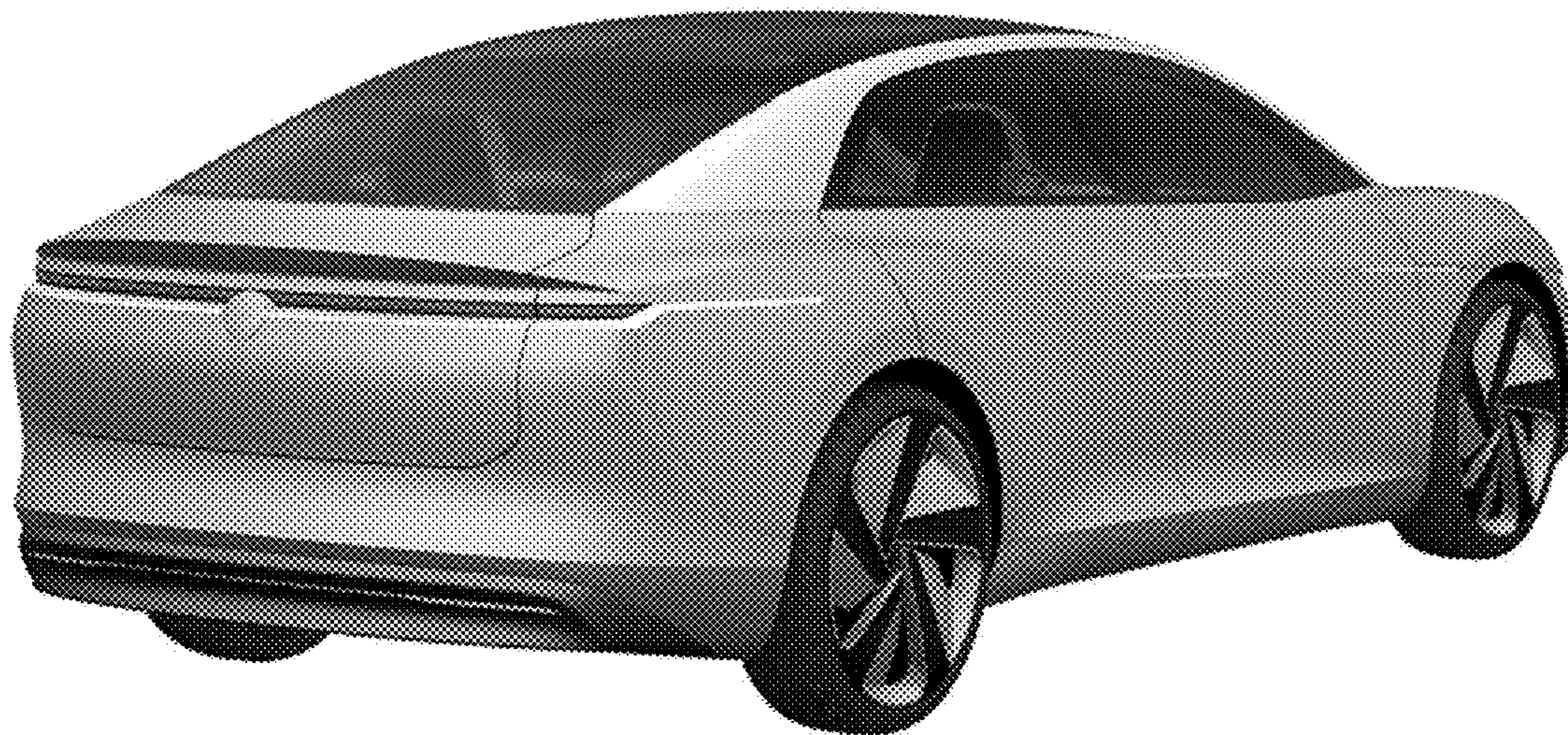

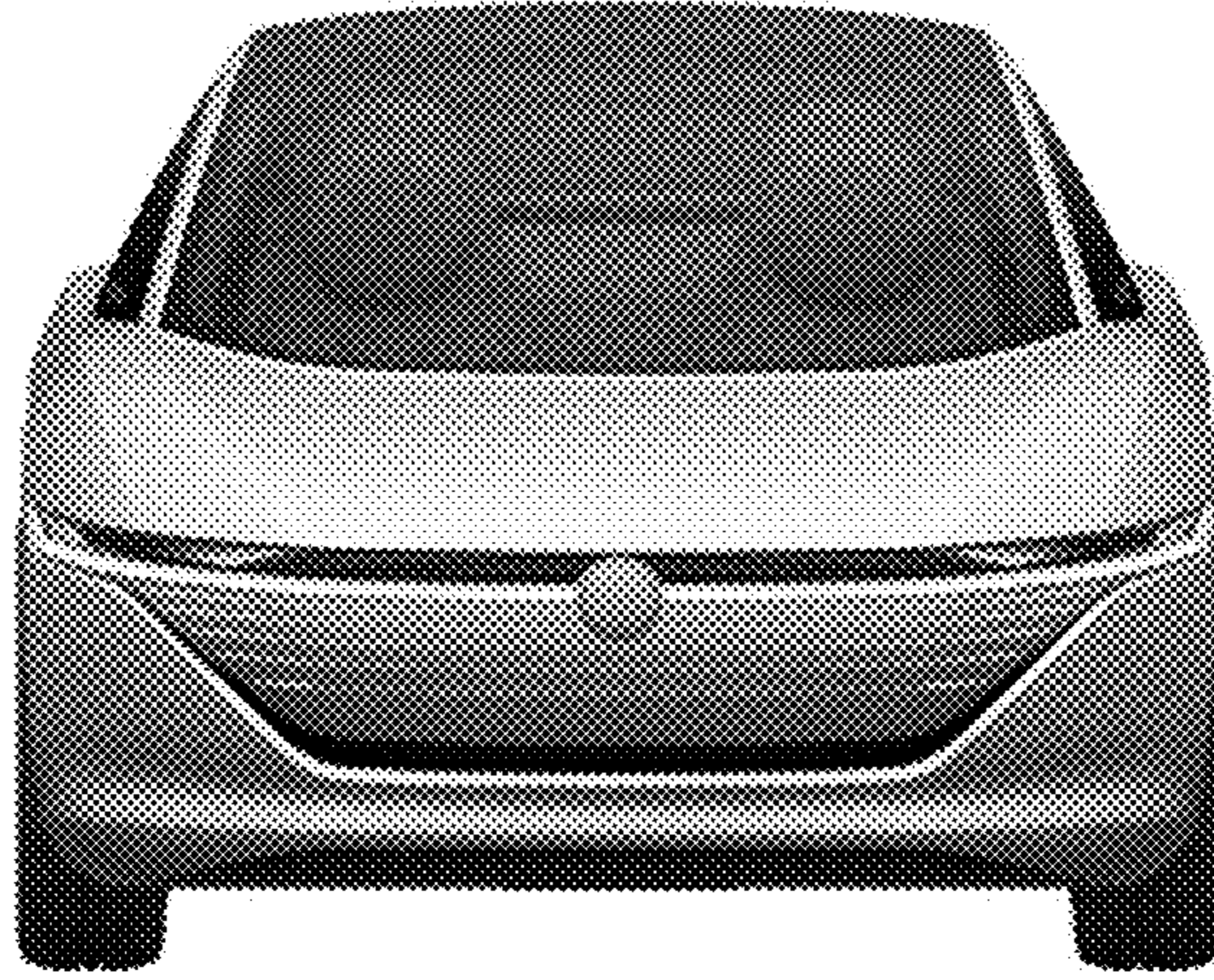

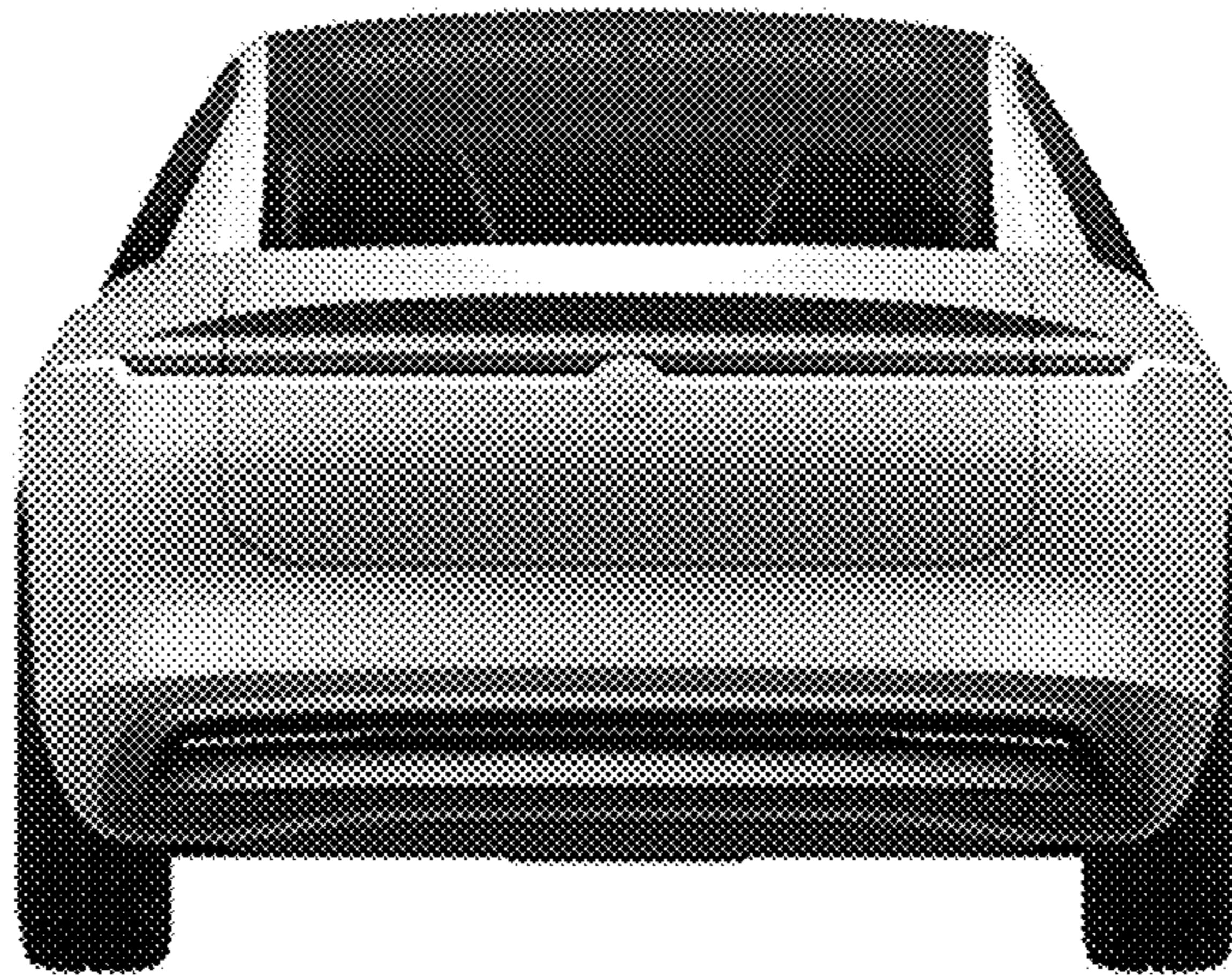

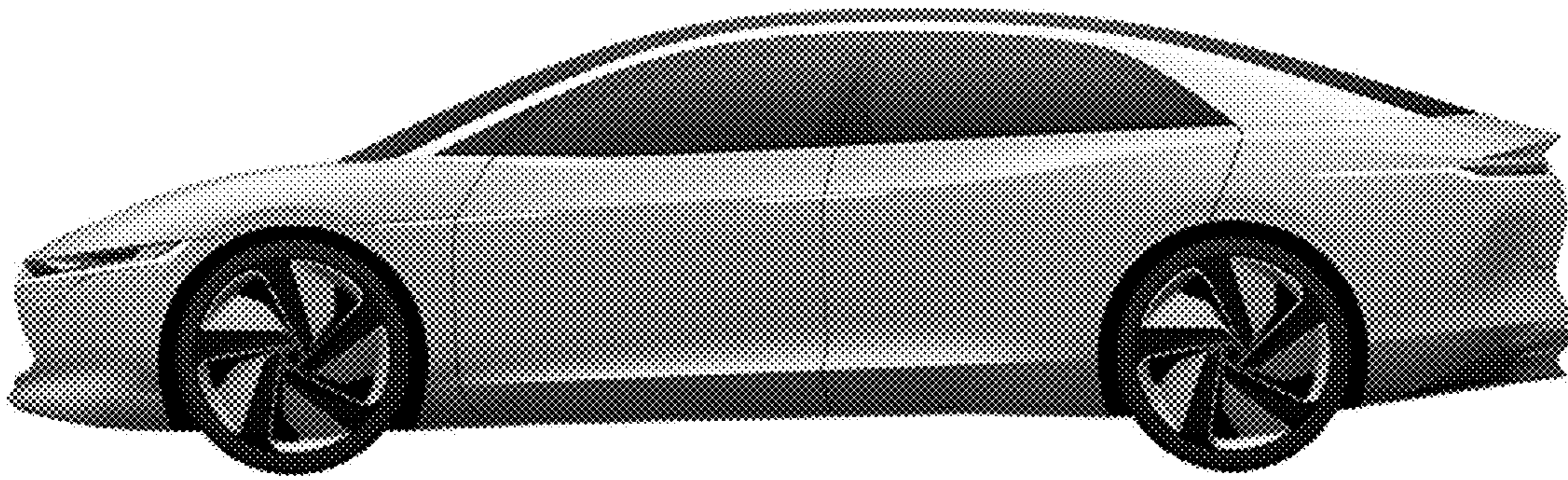

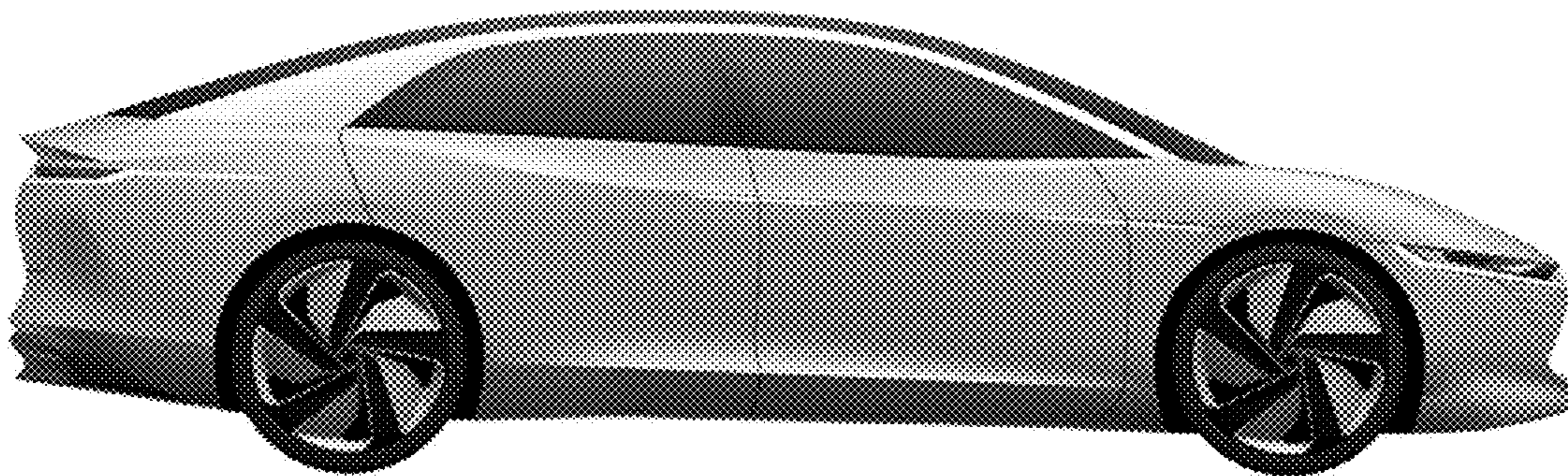

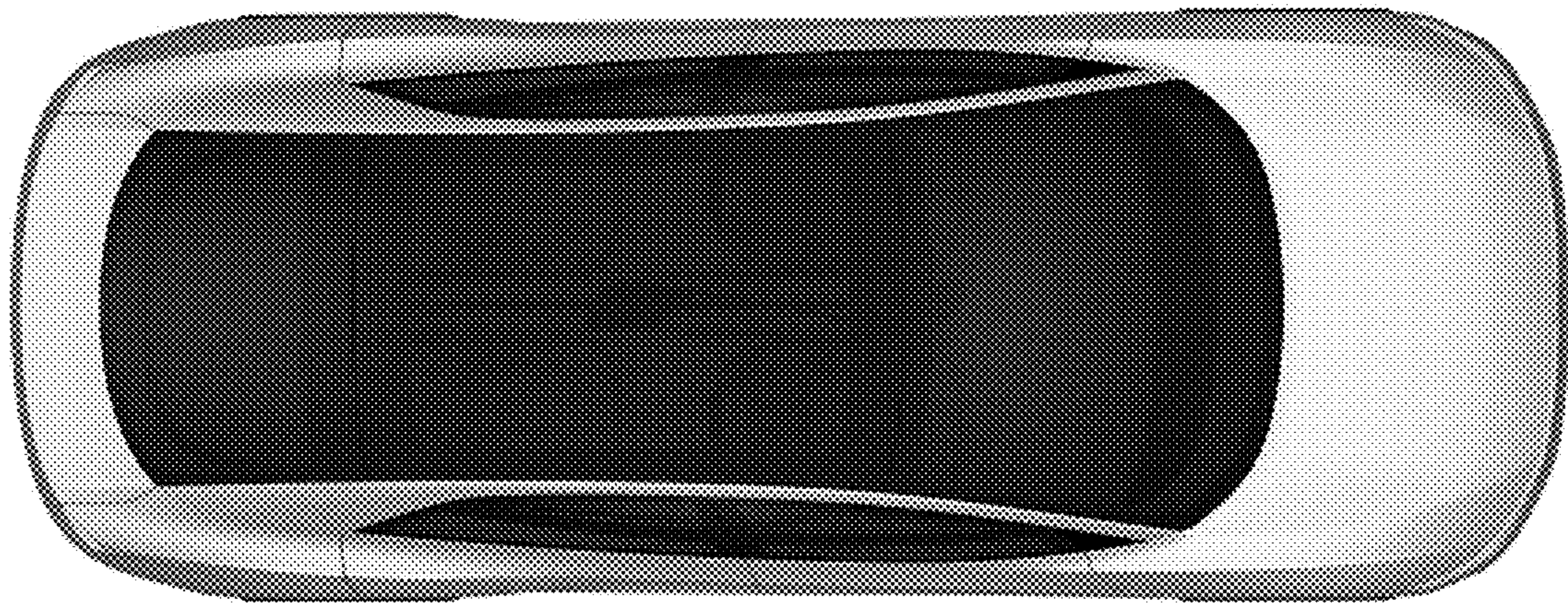
