(57) **CLAIM**

The ornamental design for a vehicle hood, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of a vehicle hood according to the present invention.

FIG. 2 is a front left perspective view of the vehicle hood shown in FIG. 1.

FIG. 3 is a rear left perspective view thereof.

FIG. 4 is a rear right perspective view thereof.

FIG. 5 is a front top perspective view thereof.

FIG. 6 is a rear top perspective view thereof.

FIG. 7 is an elevated left side perspective view thereof.

FIG. 8 is an elevated right side perspective view thereof.

FIG. 9 is a front view thereof.

FIG. 10 is a rear view thereof.

FIG. 11 is a left side view thereof.

FIG. 12 is a right side view thereof.

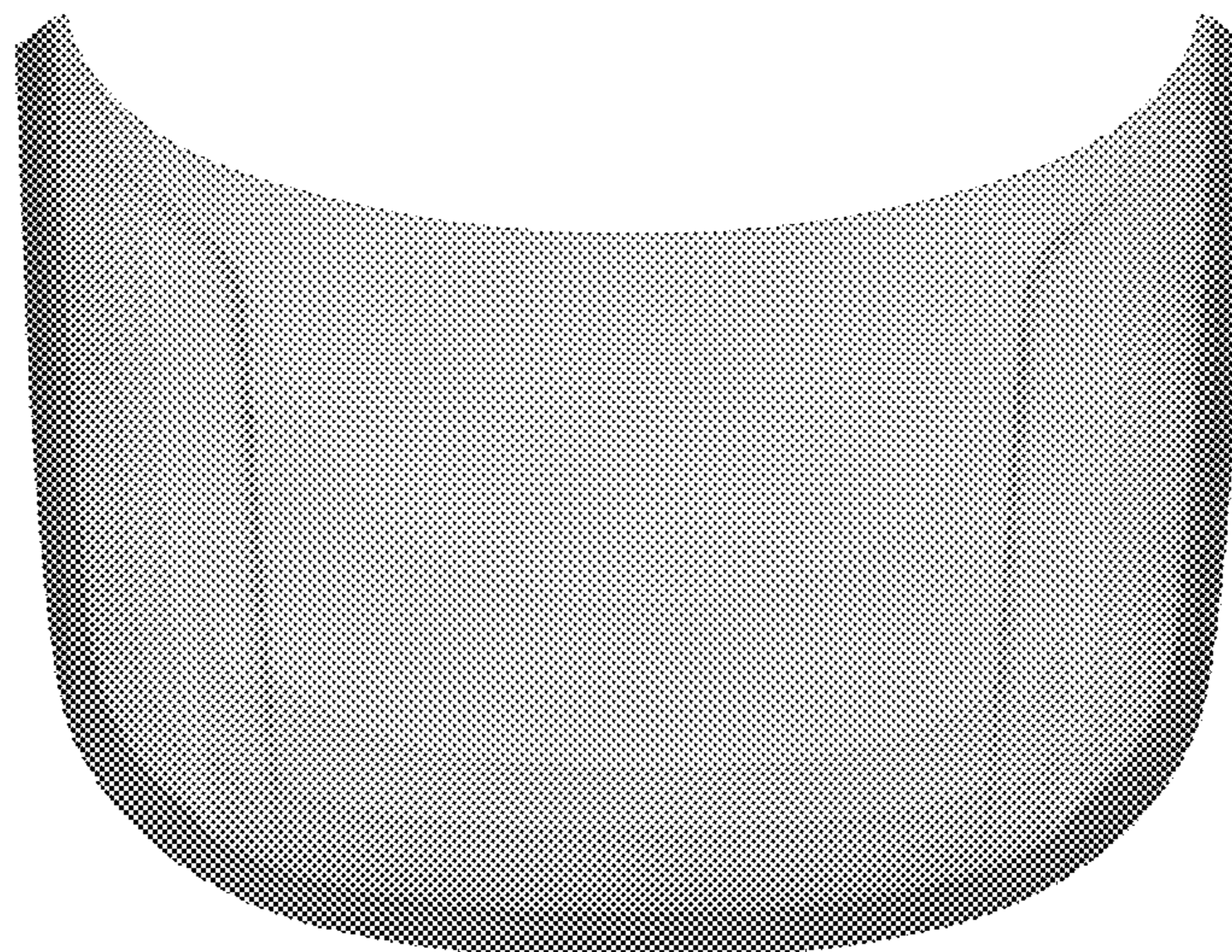
FIG. 13 is a top view thereof.

FIG. 14 is a bottom view thereof; and,

FIG. 15 is a top view of the vehicle hood shown in FIGS. 1-14, but mounted on a vehicle, with the rest of the vehicle shown in de-emphasized and half-tone portions so as to illustrate environmental structure.

More particularly, in FIG. 15, the inventive vehicle hood is shown within the broken line, and the elements shown outside the broken line form no part of the claimed invention, but are instead included to show environmental aspects thereof.

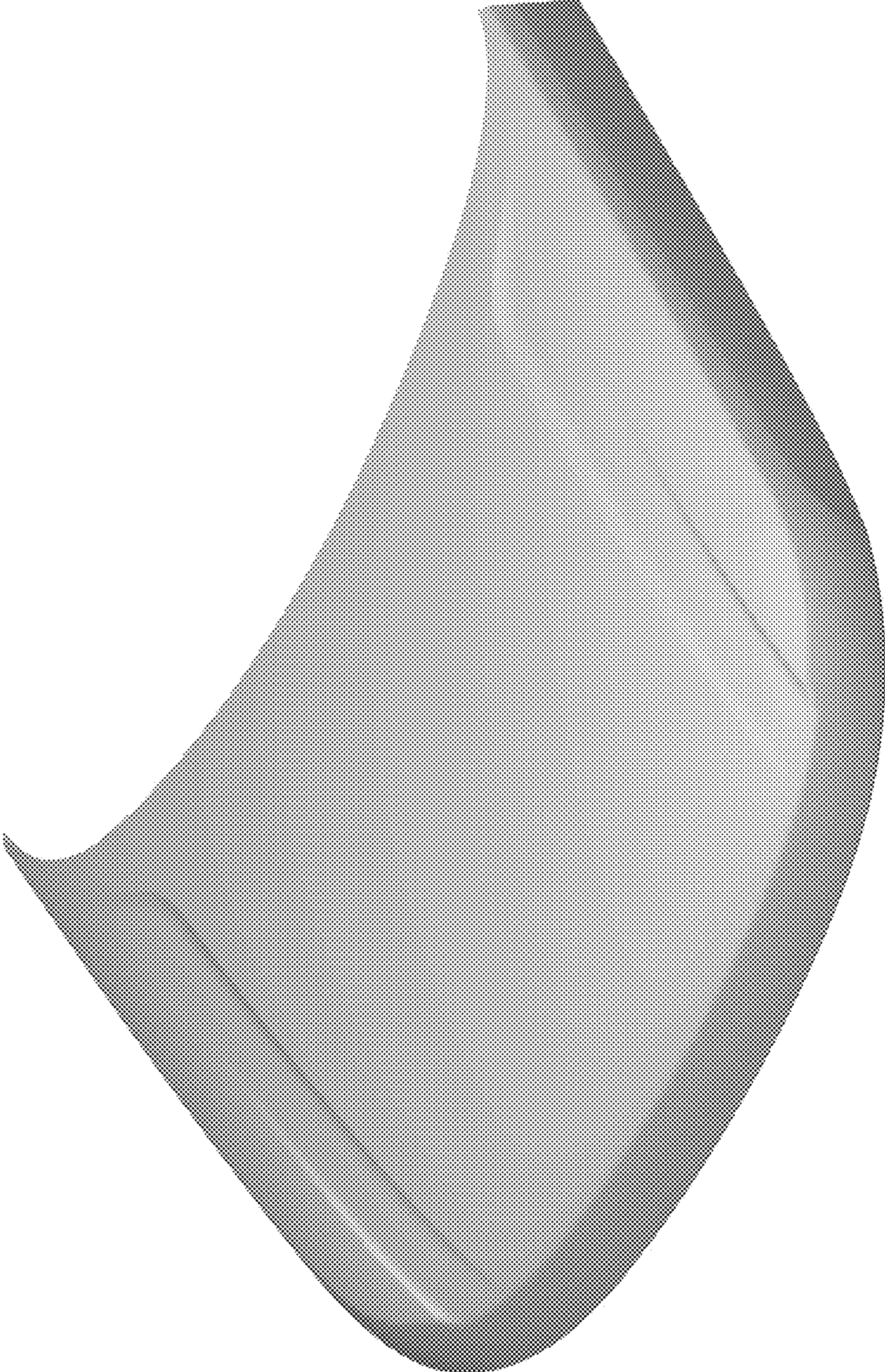

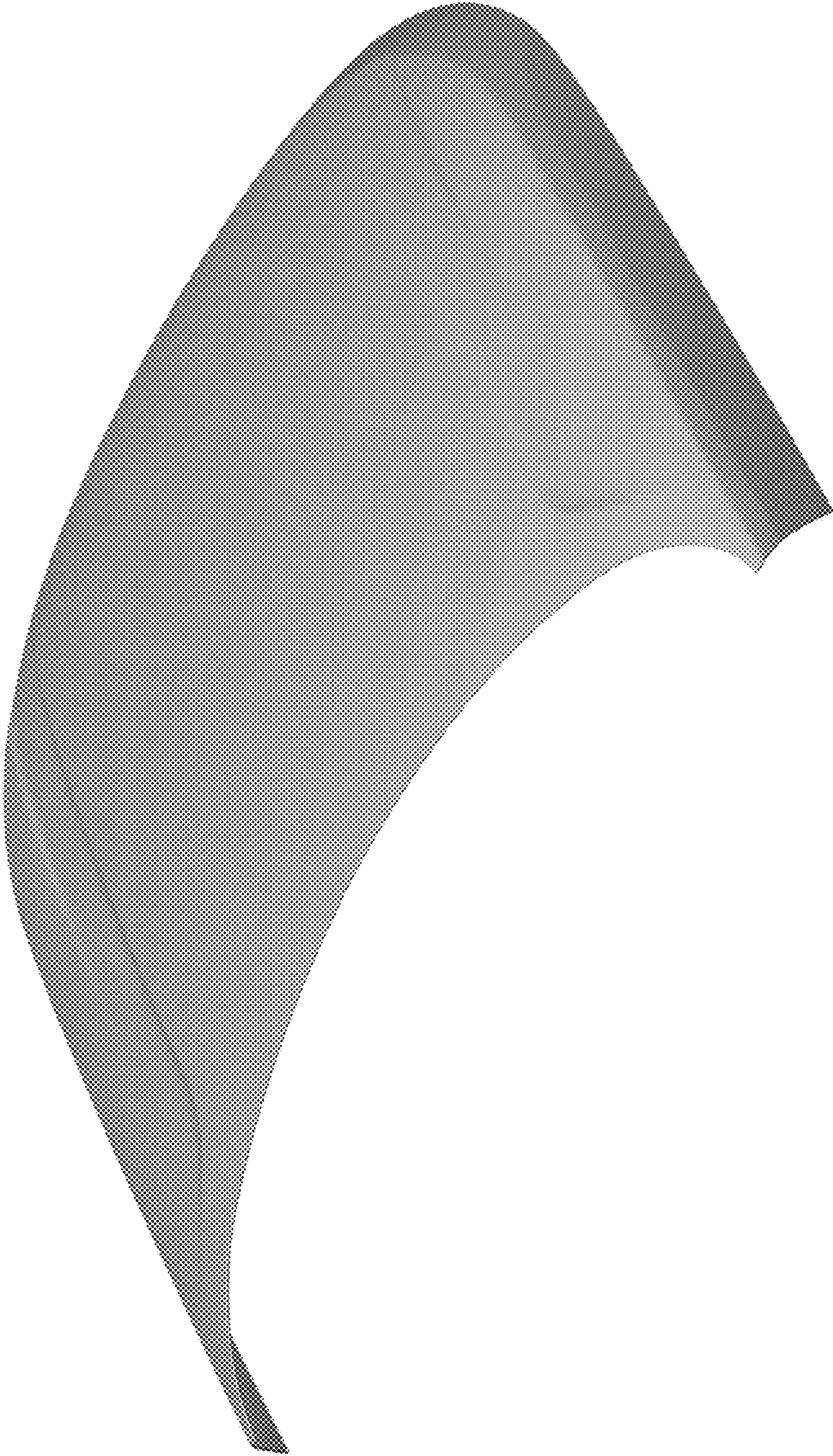

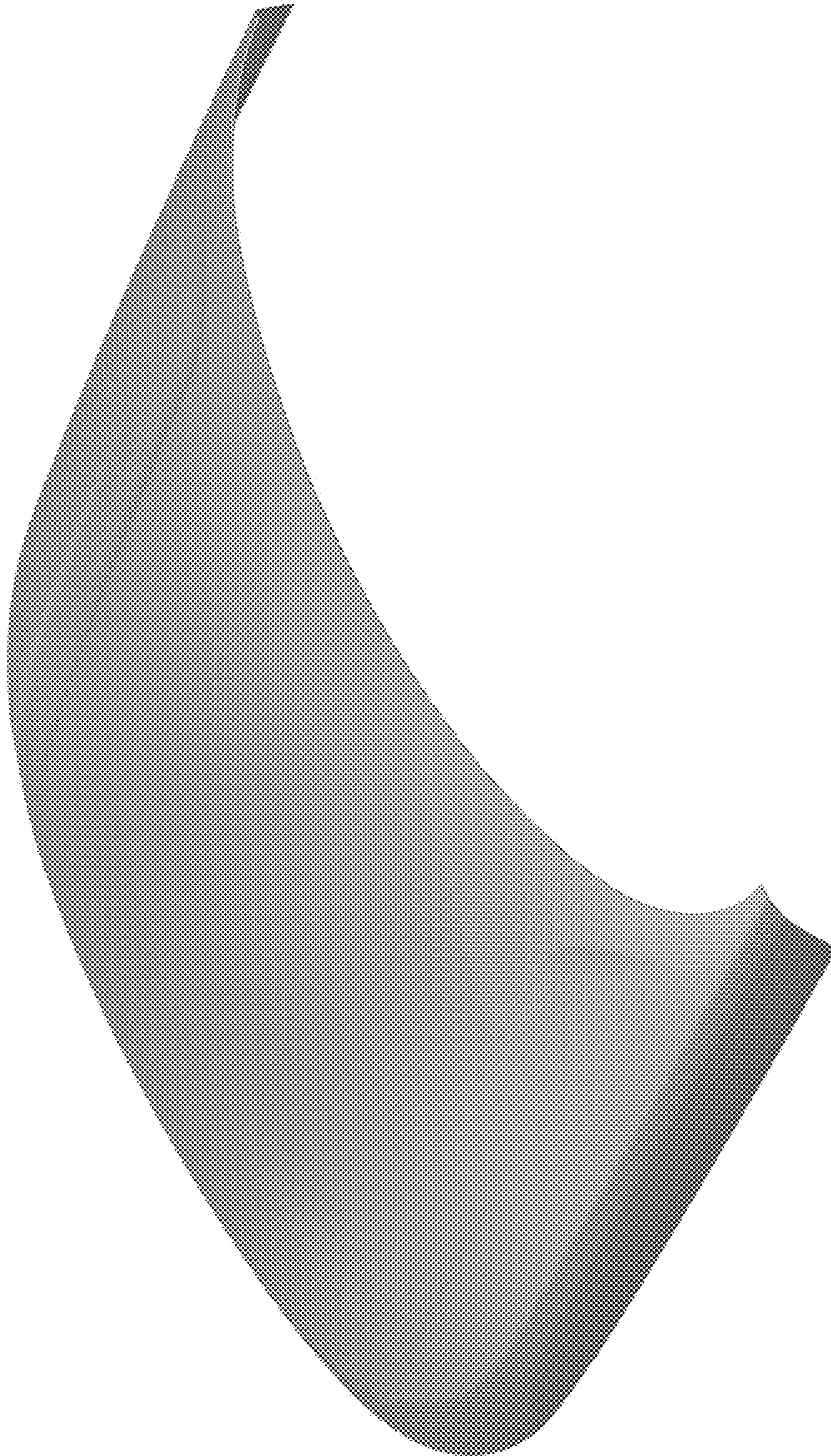

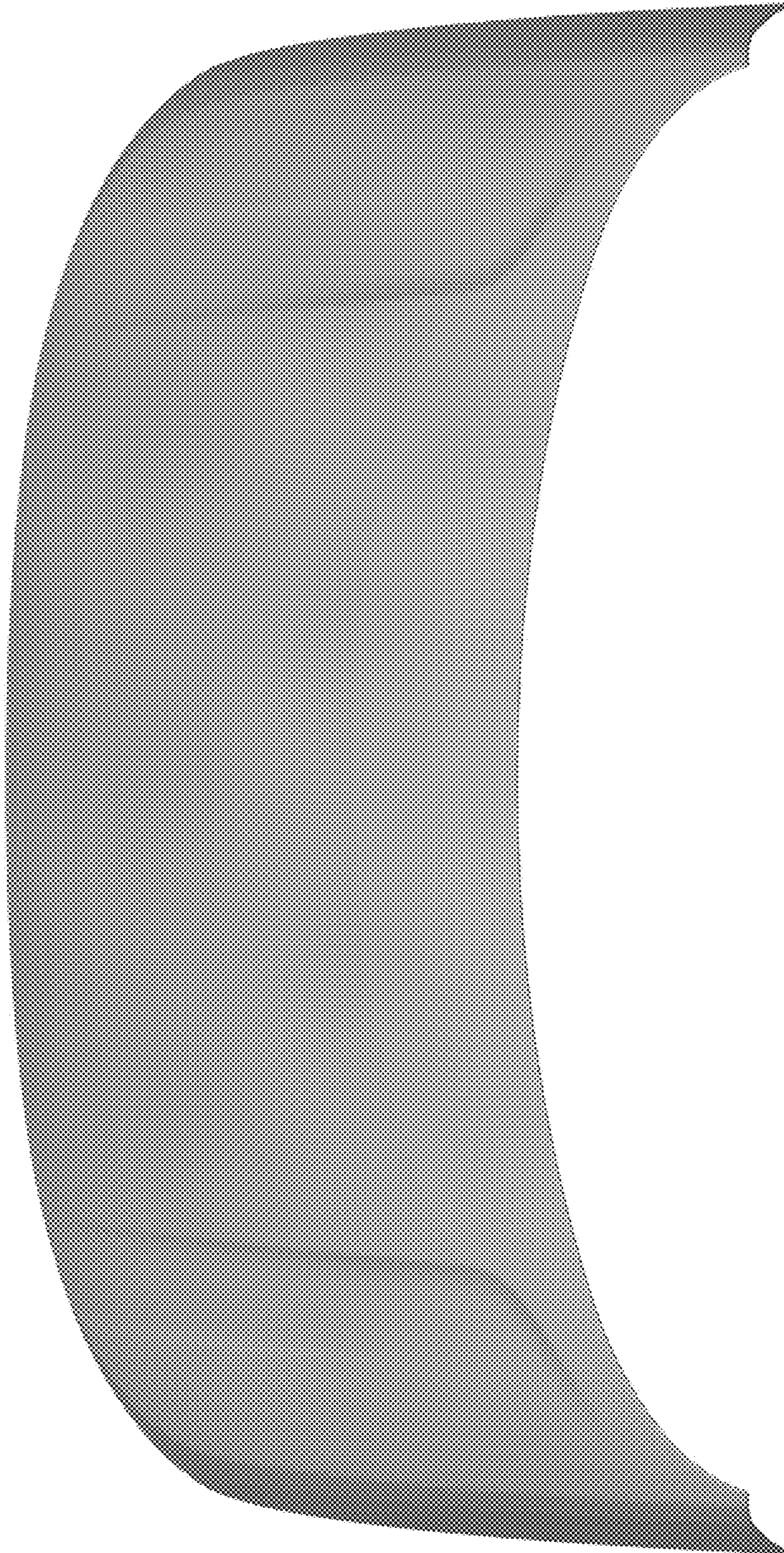

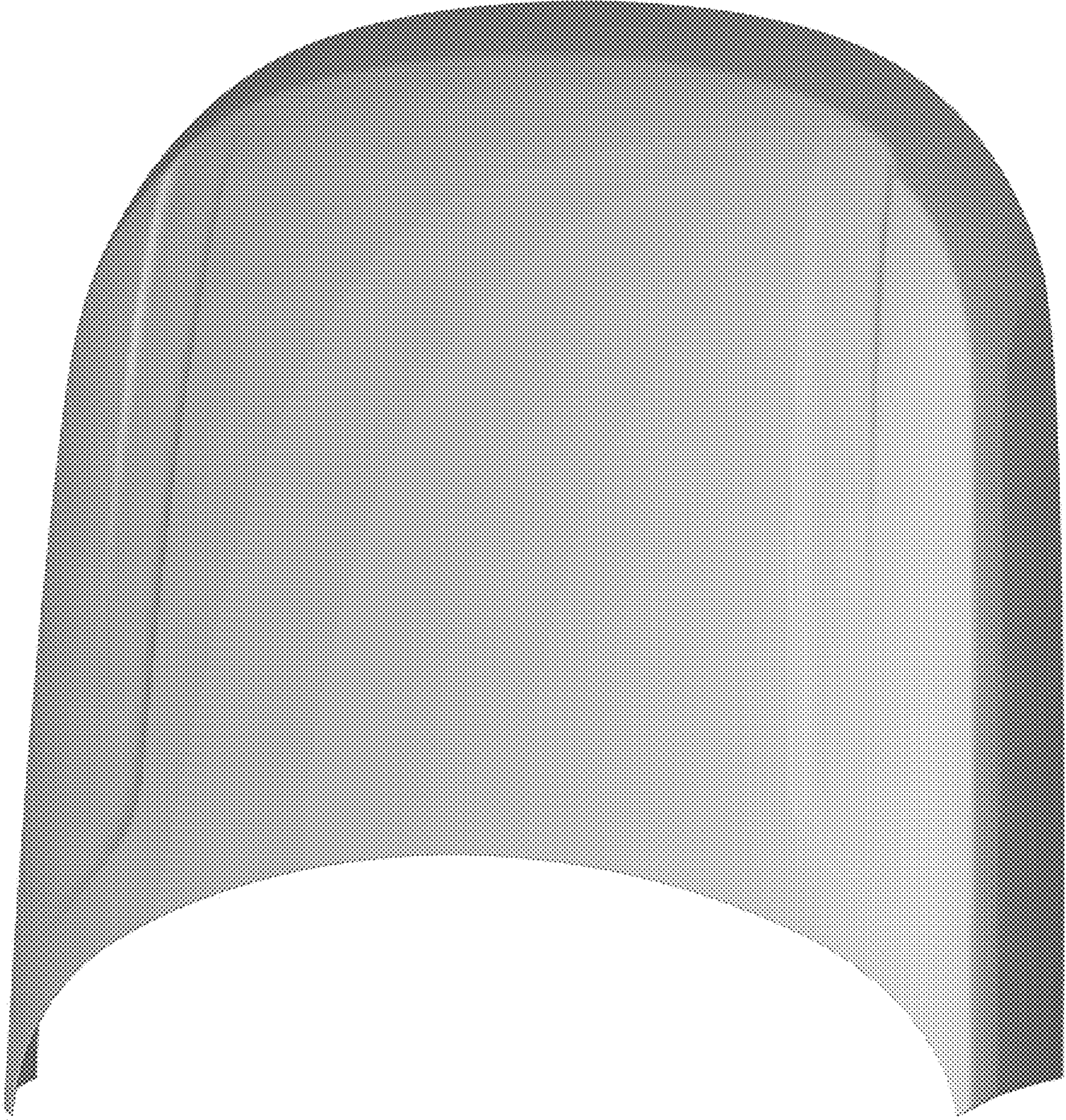

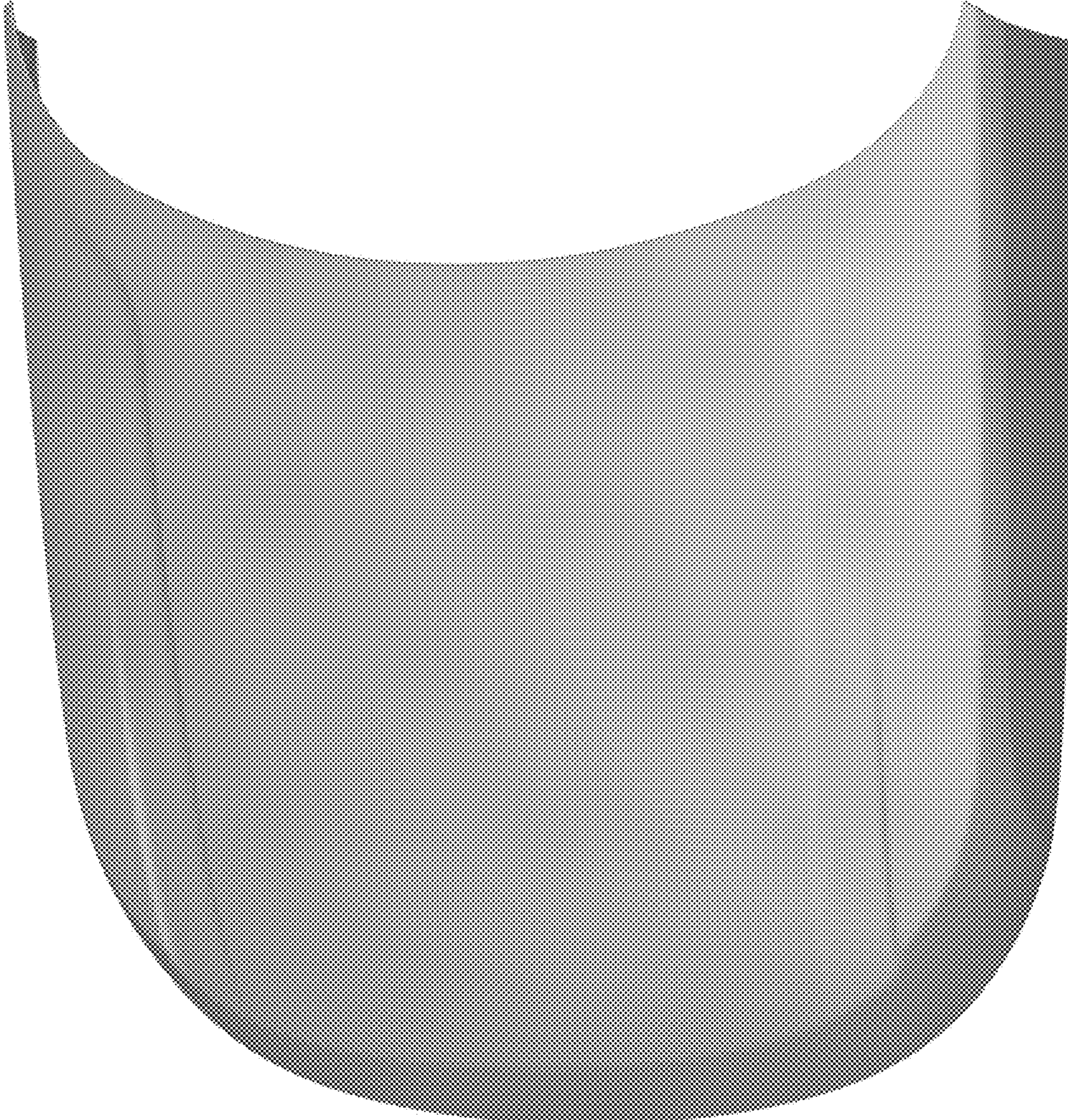

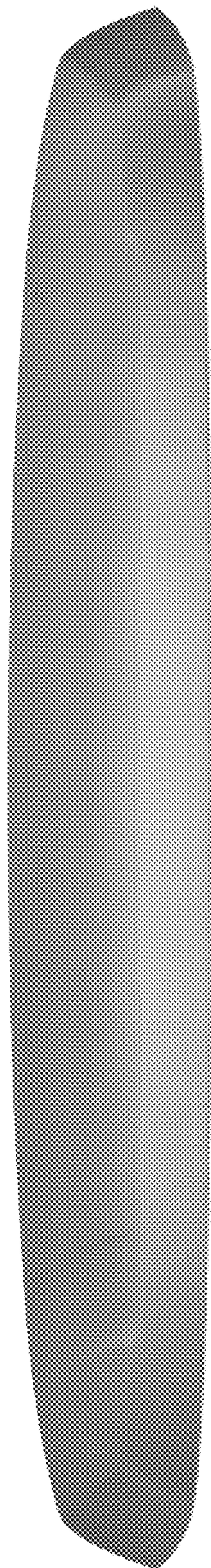

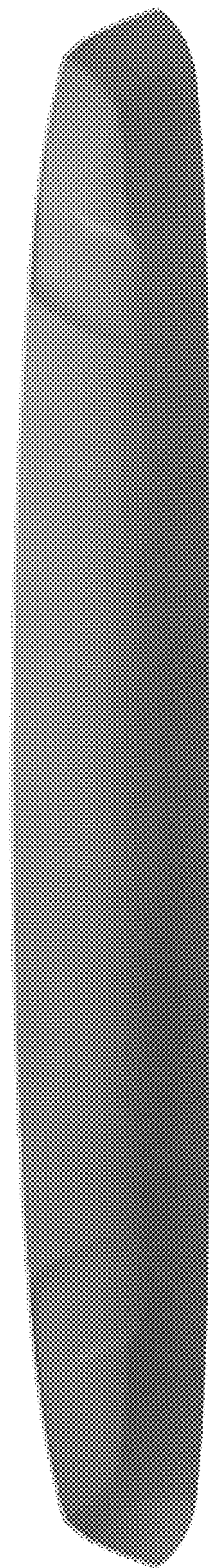

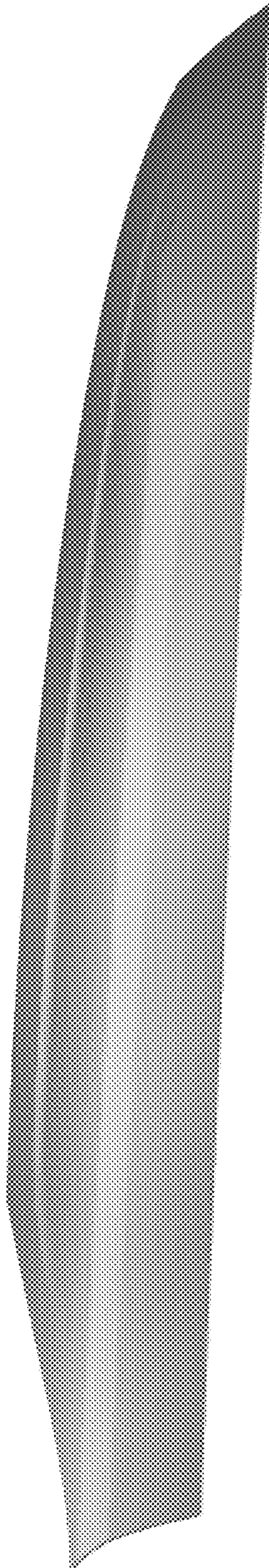

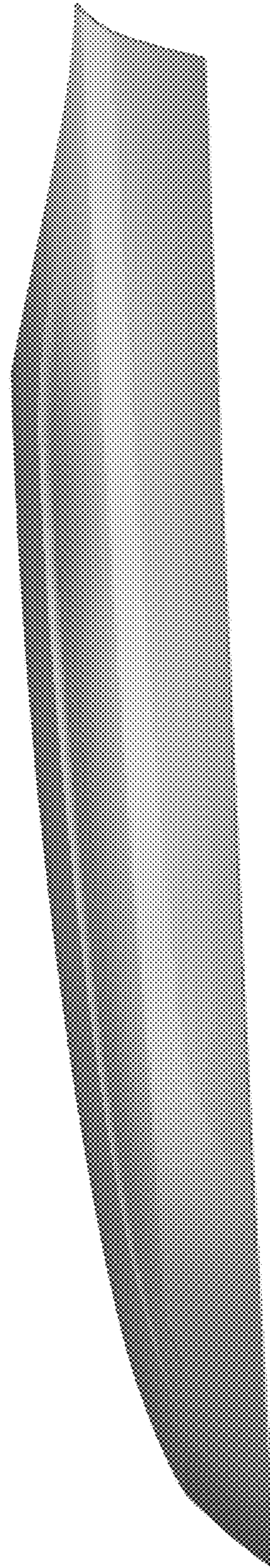

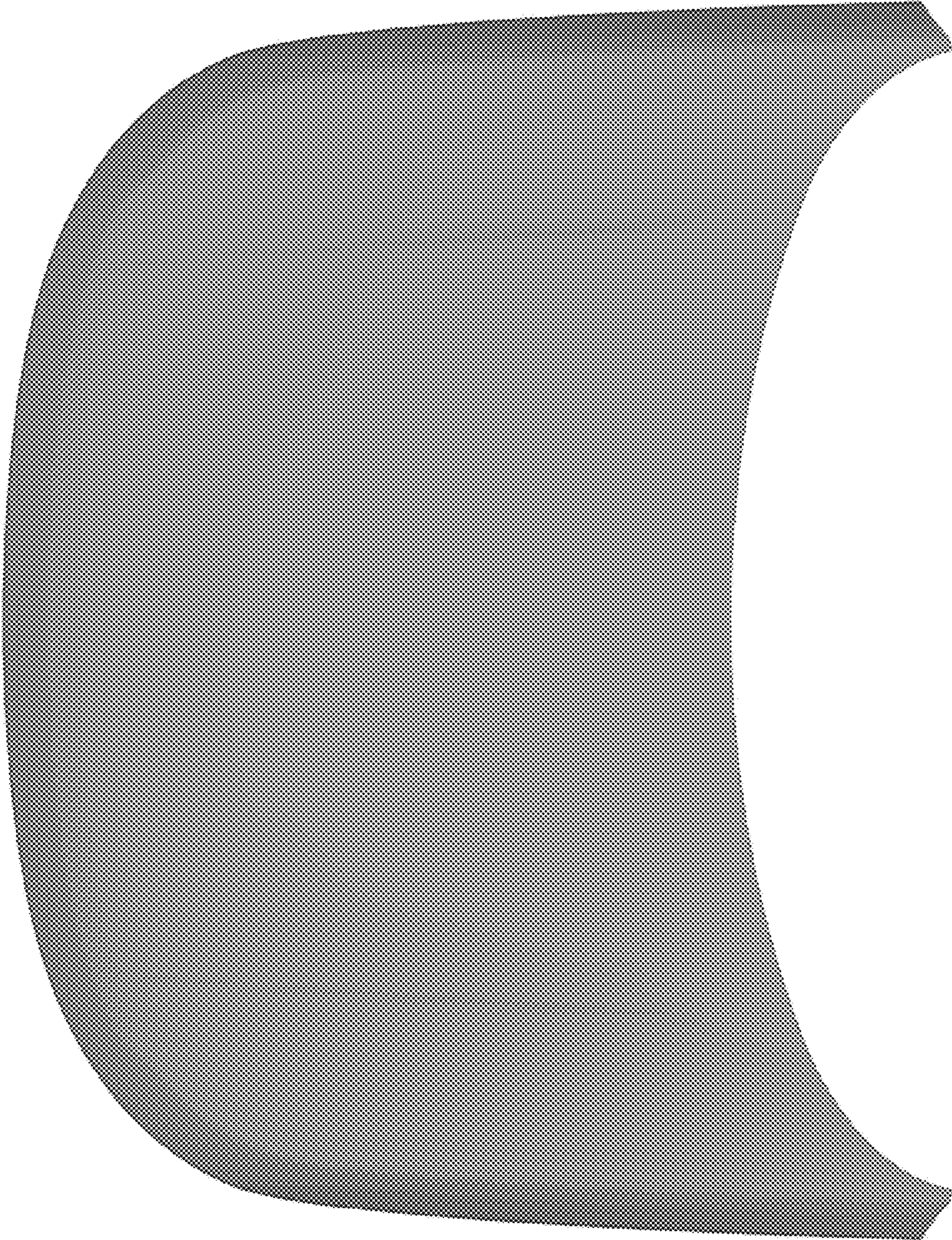

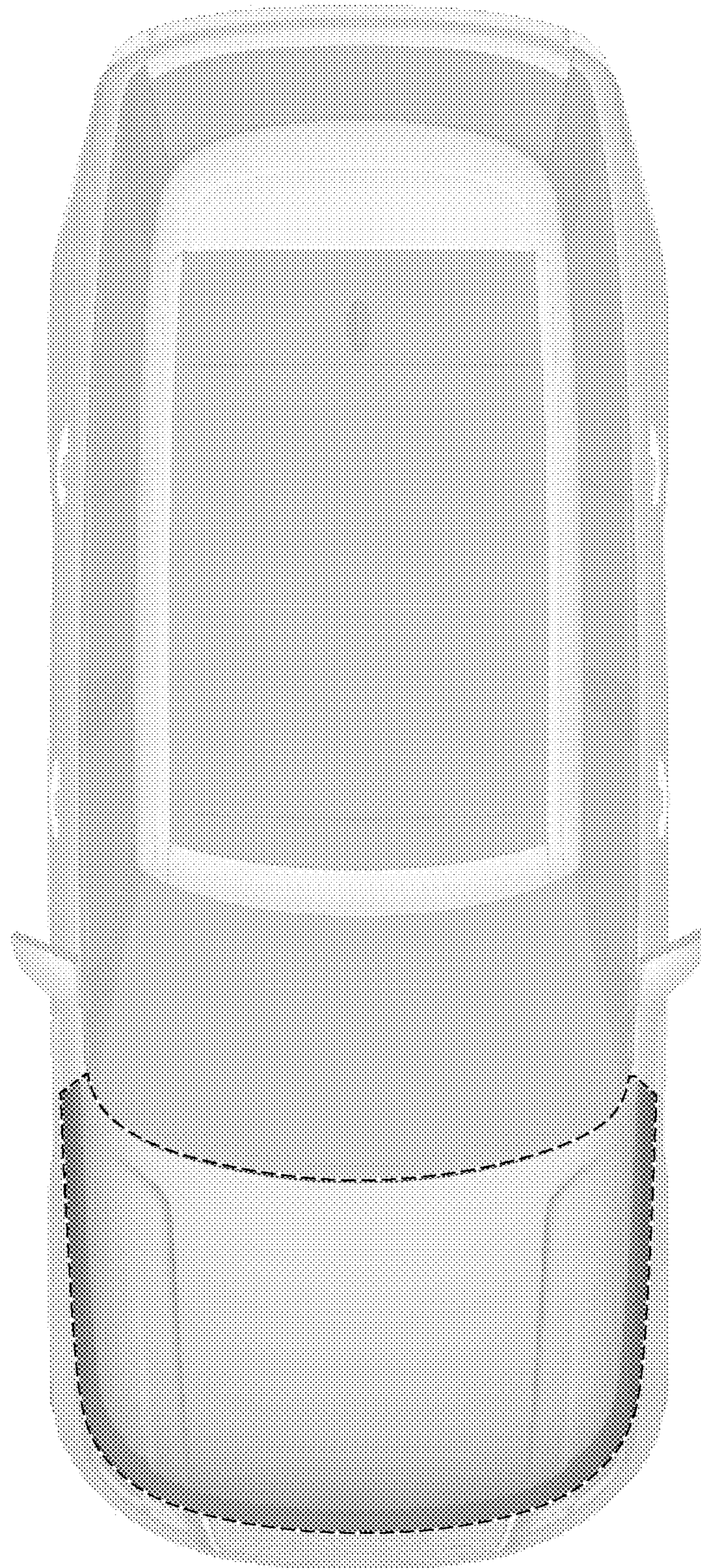
