**DESCRIPTION**

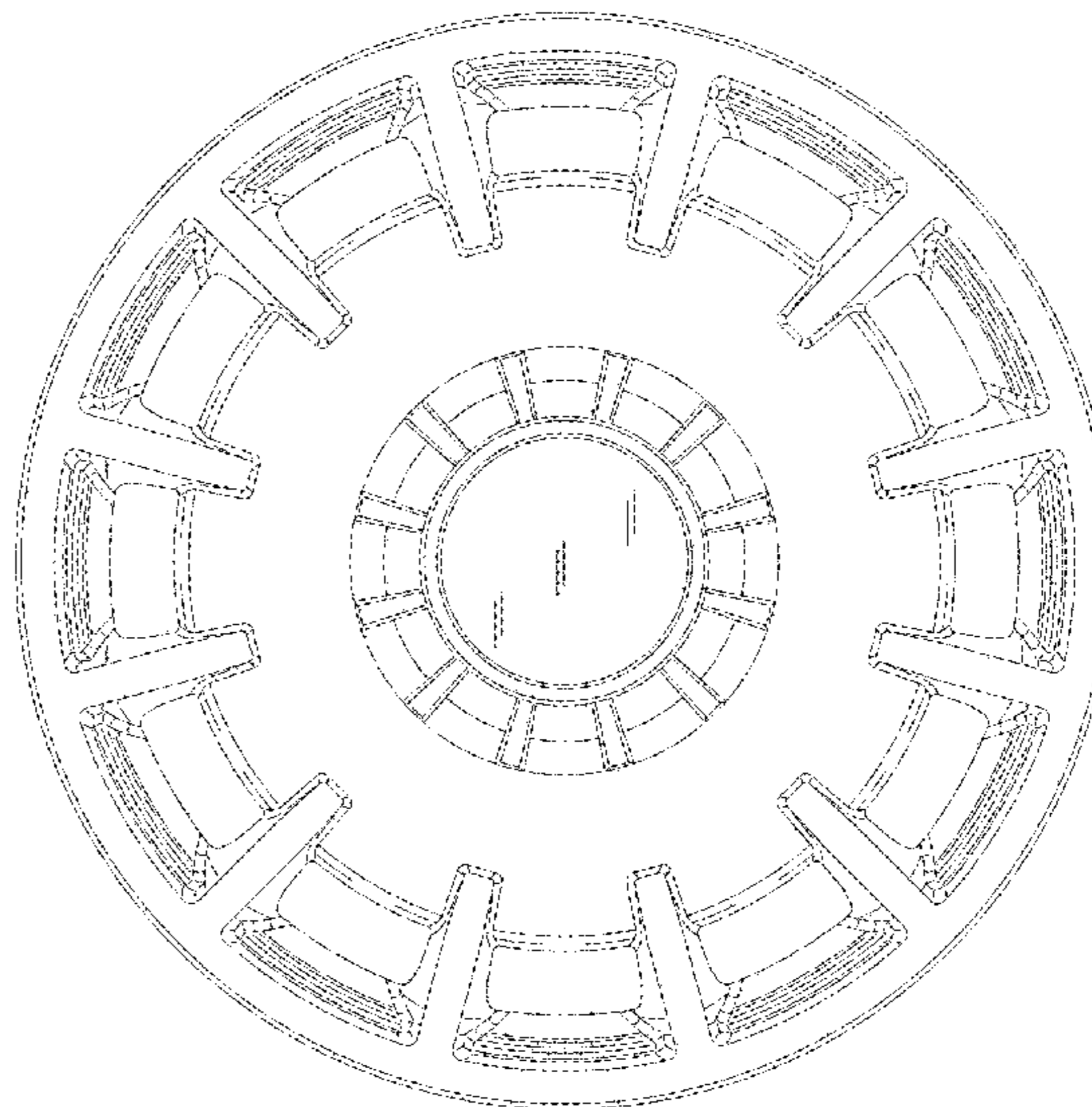
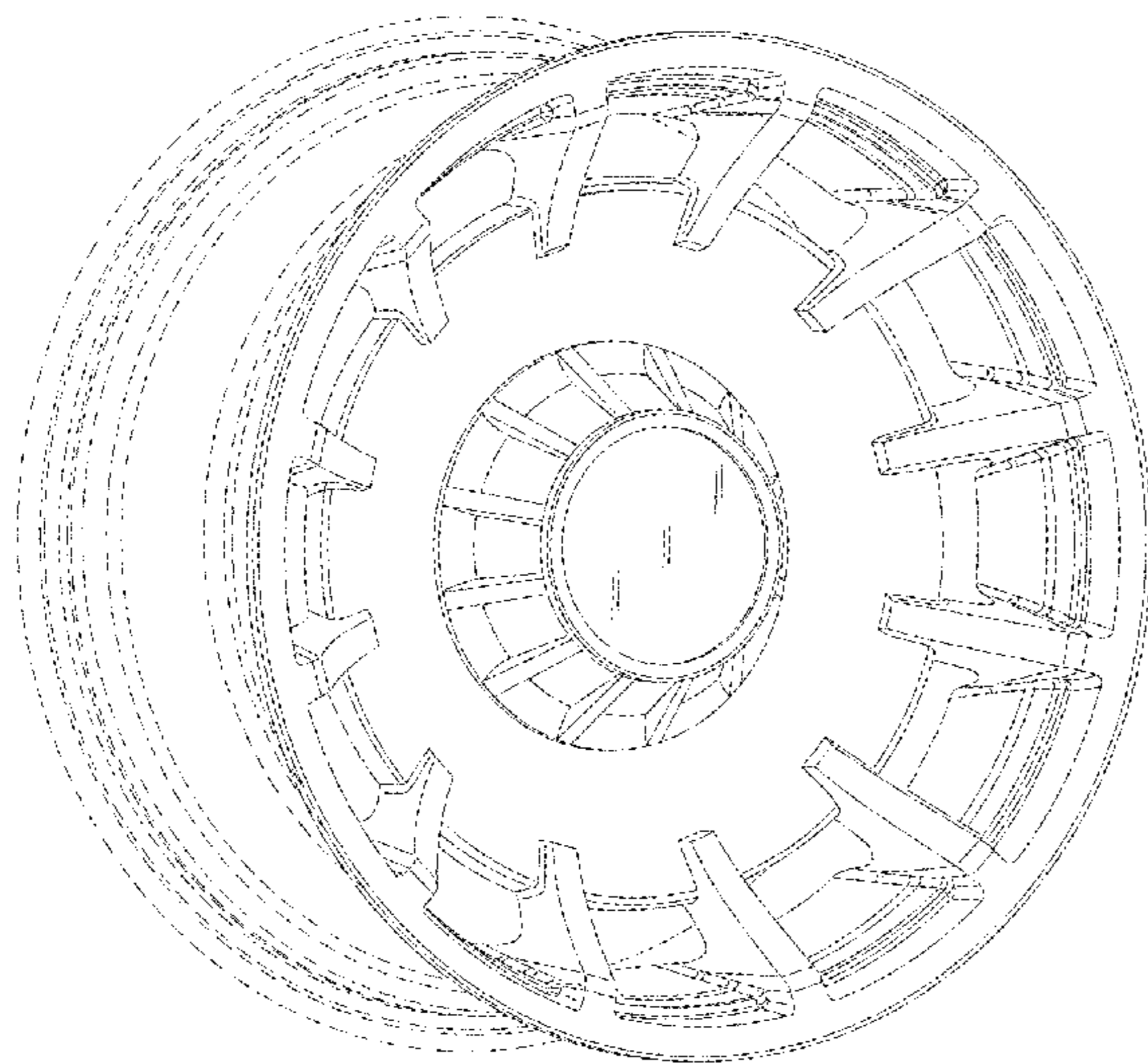
FIG. 1 is a perspective view of a wheel assembly according to an embodiment of the invention, showing a wheel upon which a tire may be mounted and a hubcap assembly disposed thereon;

FIG. 2 is an elevation view of the wheel assembly of FIG. 1; and,

FIG. 3 is an exploded diagram of the wheel assembly of FIGS. 1 and 2.

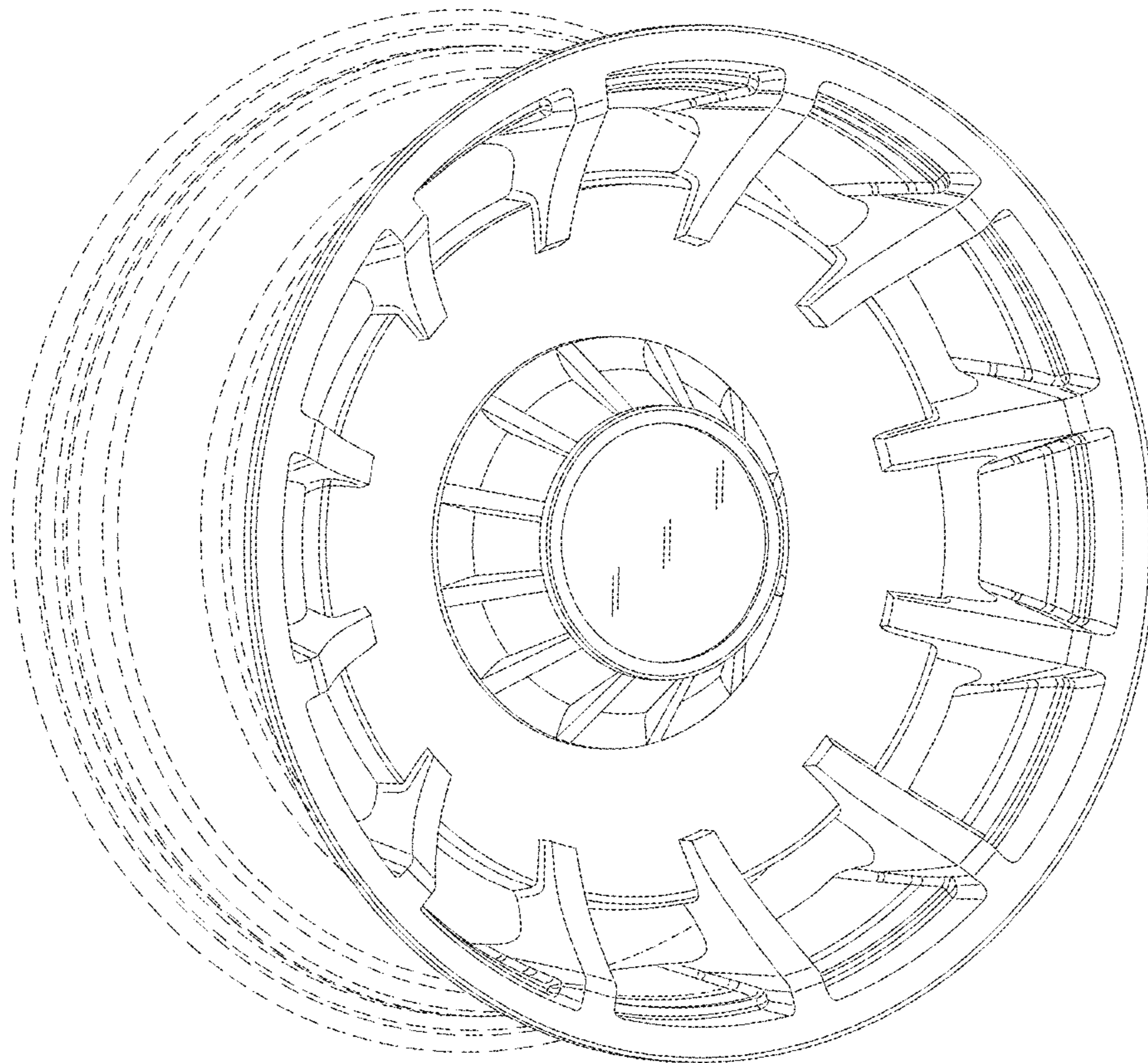

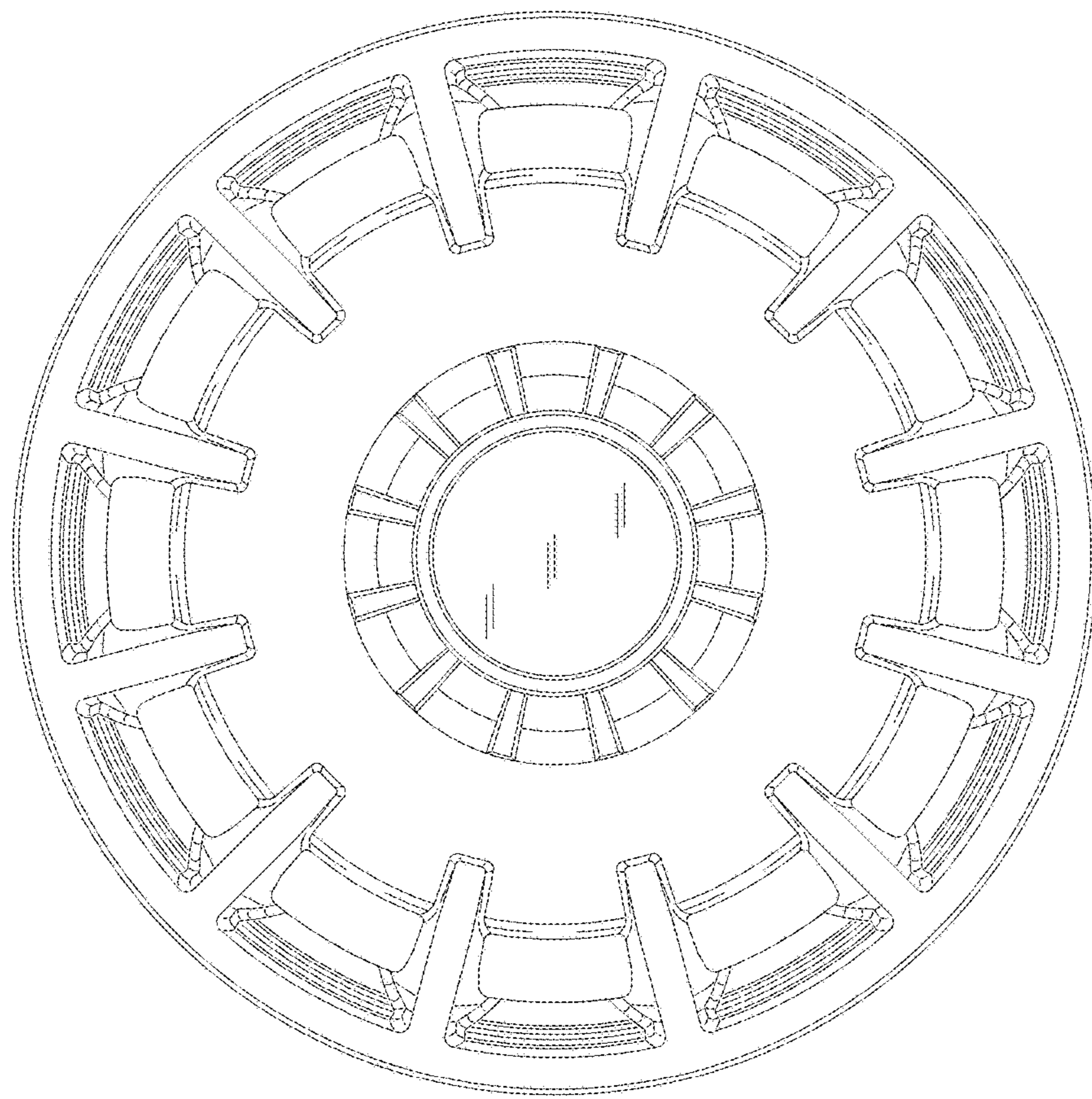

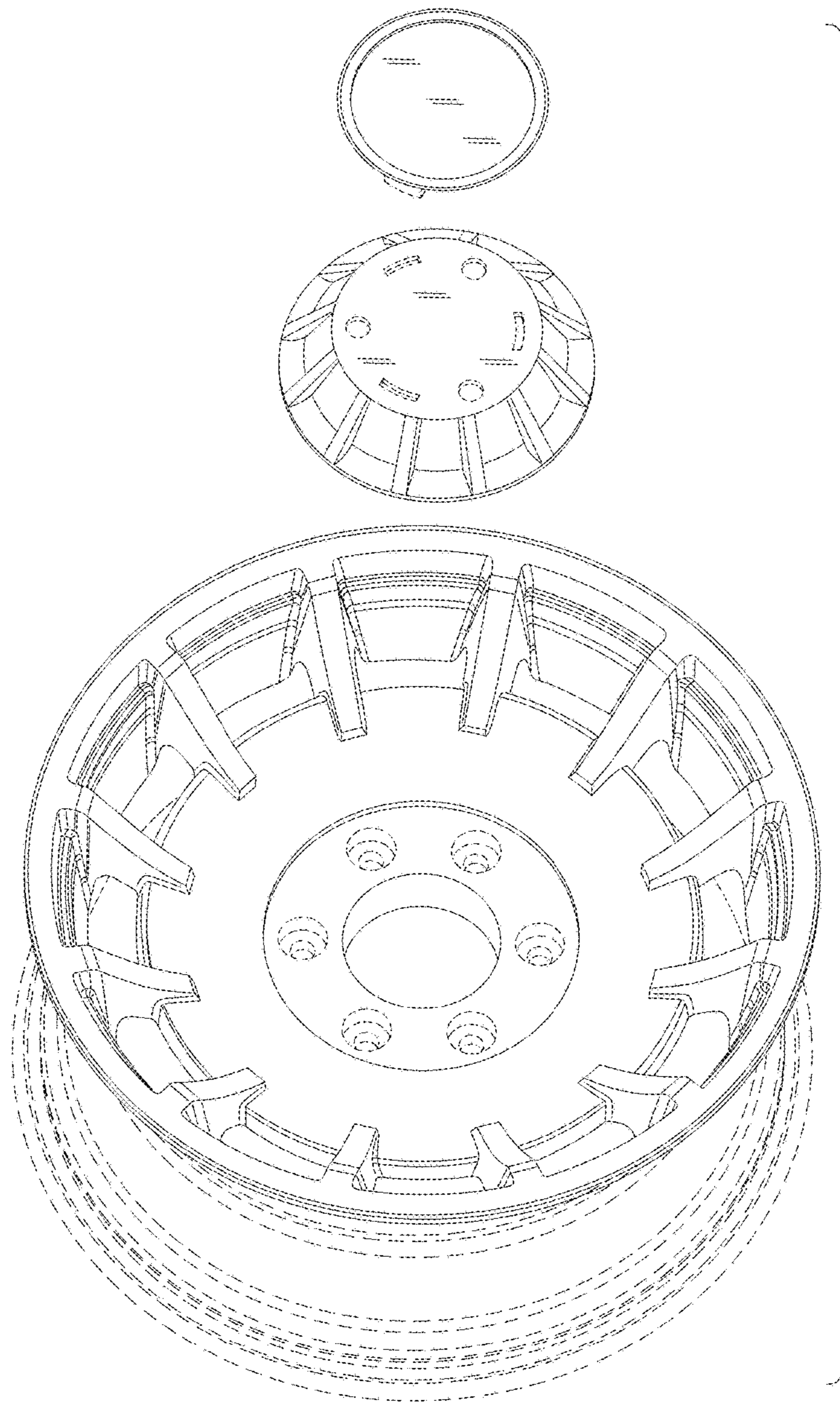
