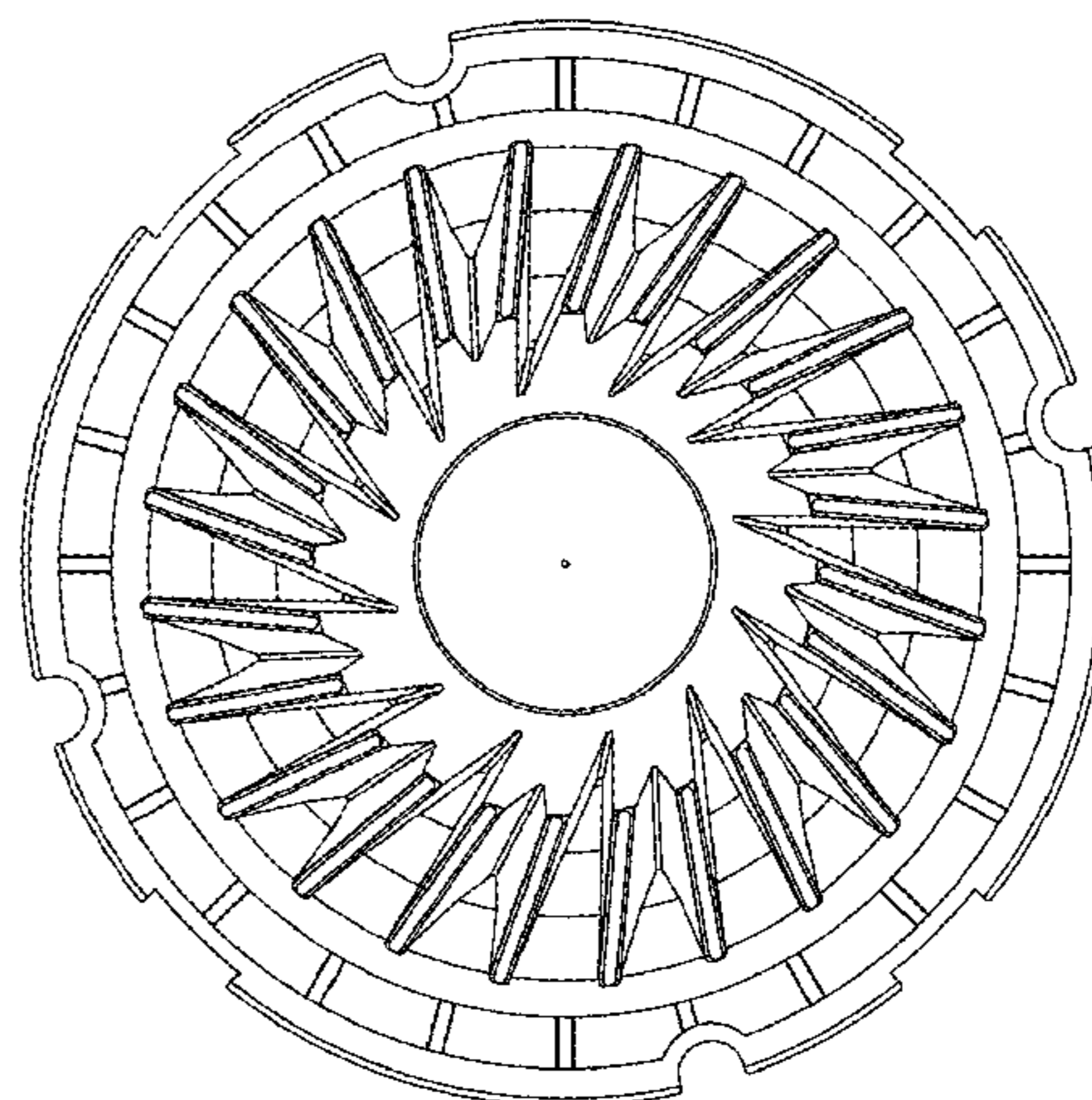
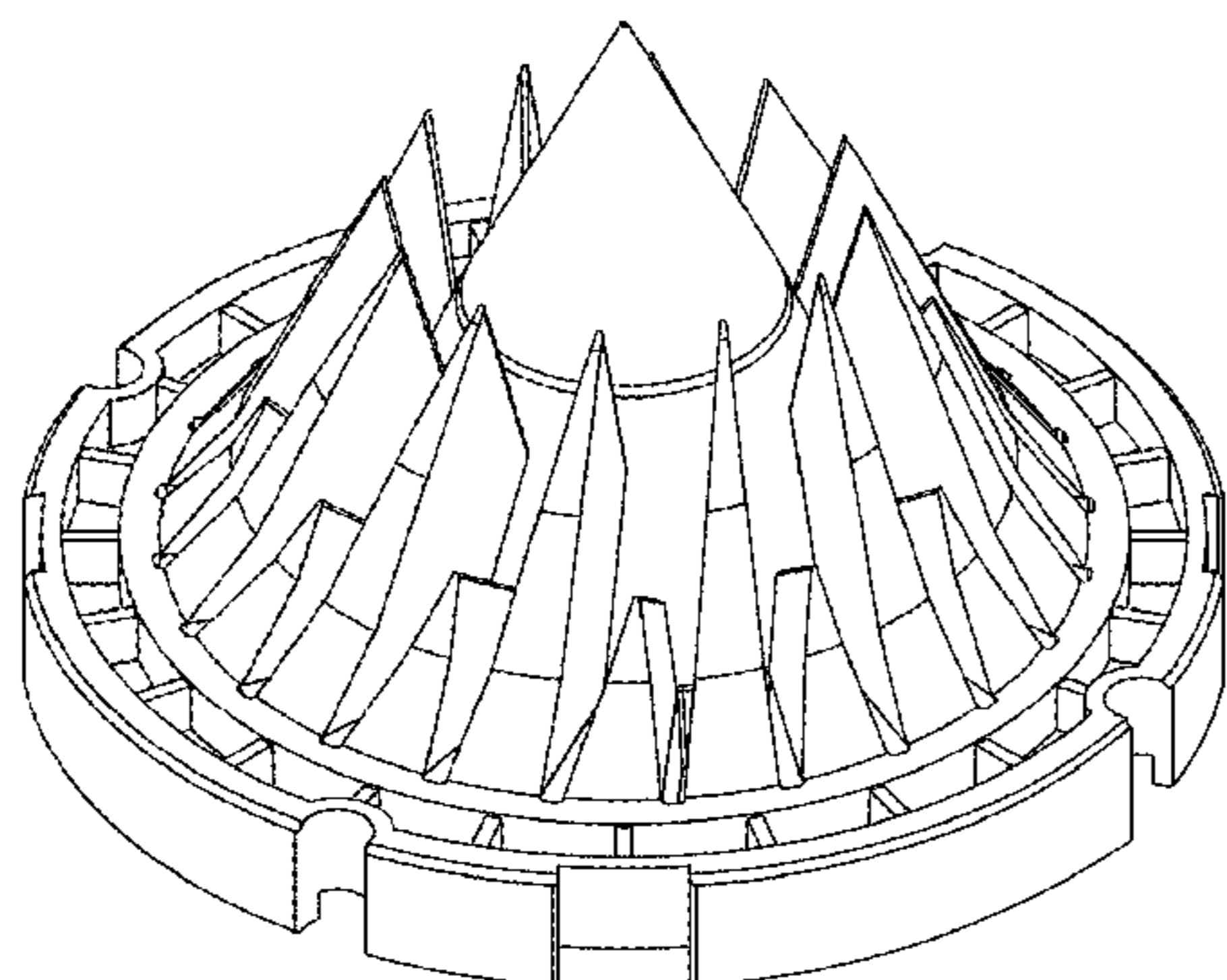
(57) **CLAIM**

I claim, the ornamental design for a phase plug for loudspeaker, as shown and described.

**DESCRIPTION**

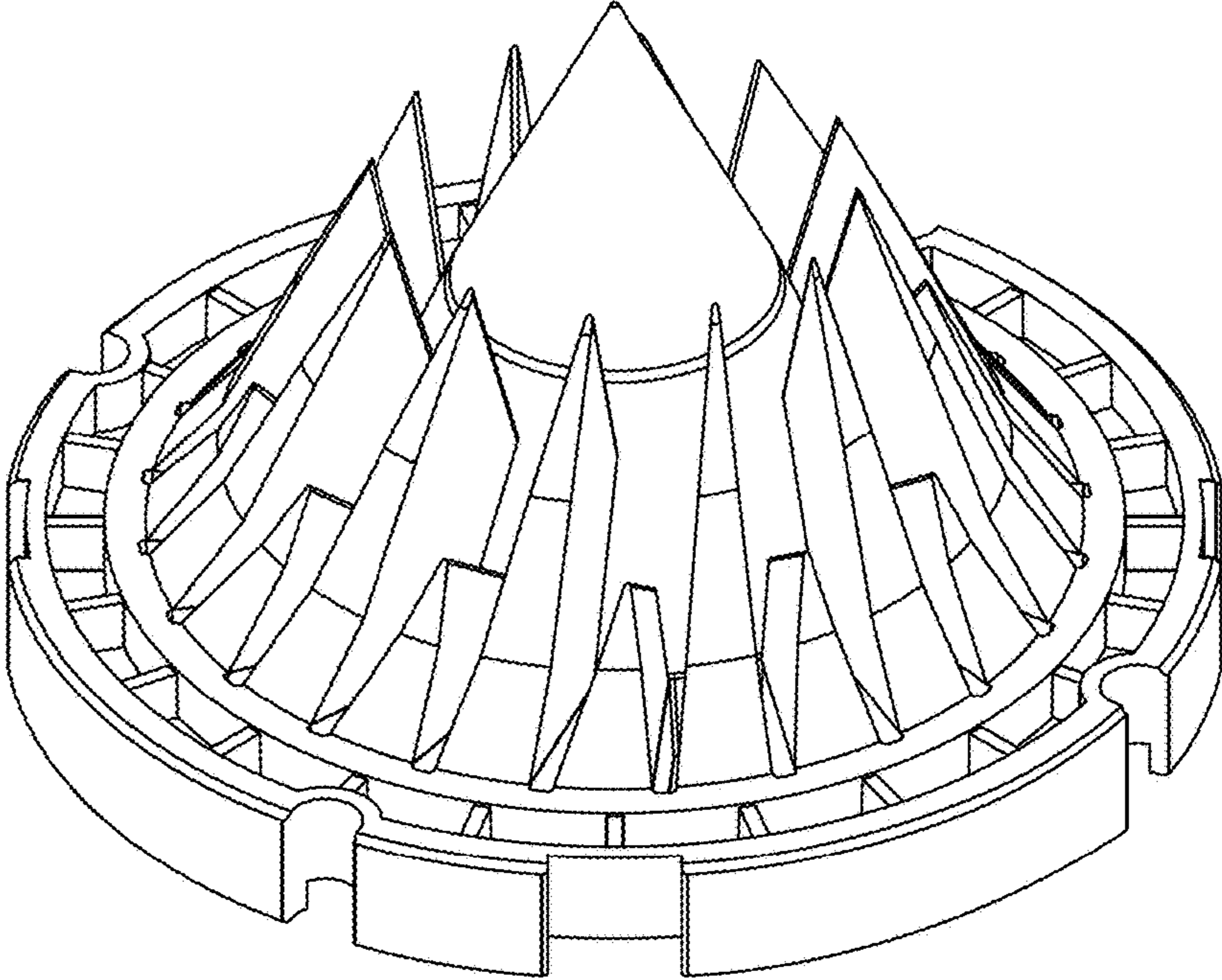

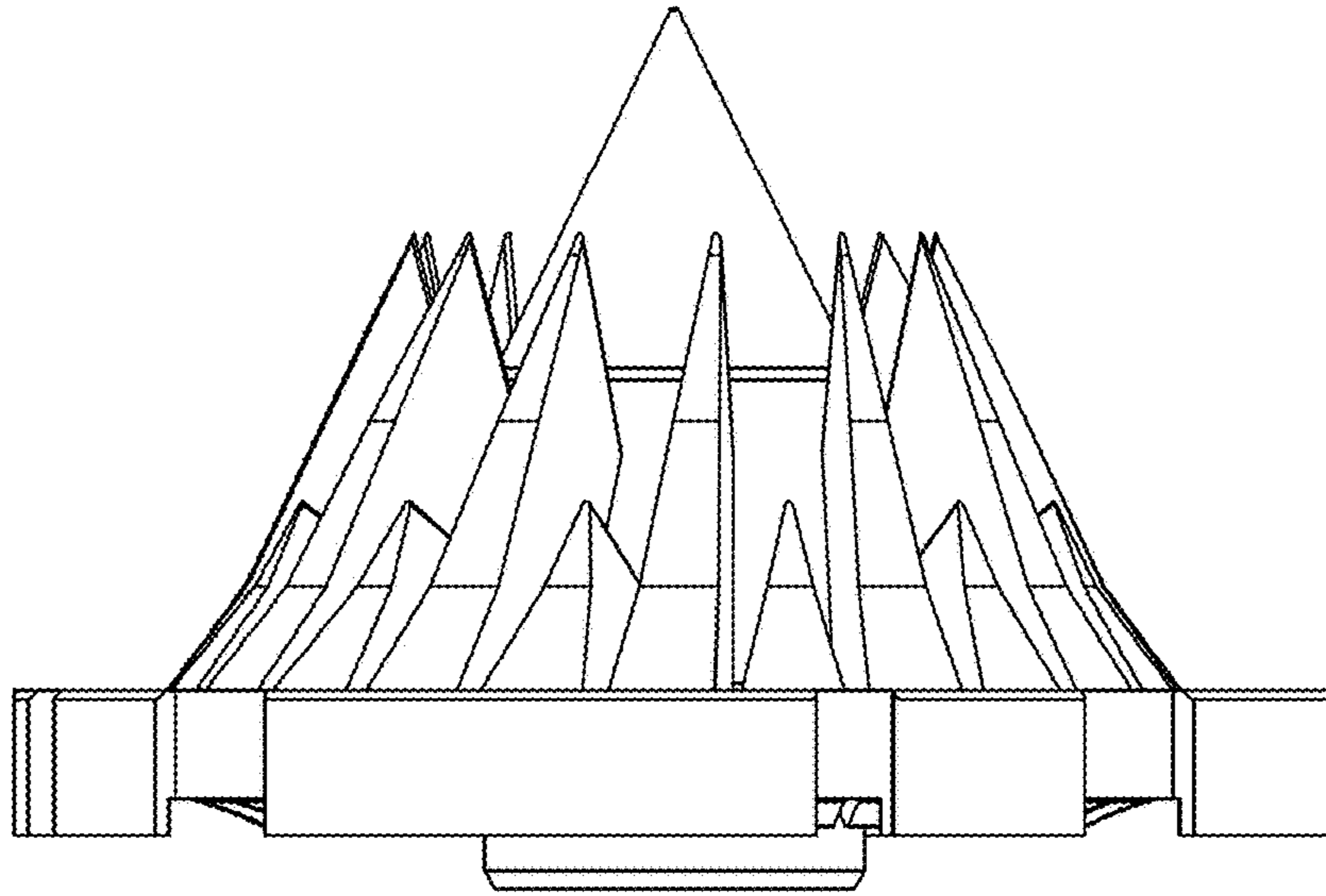

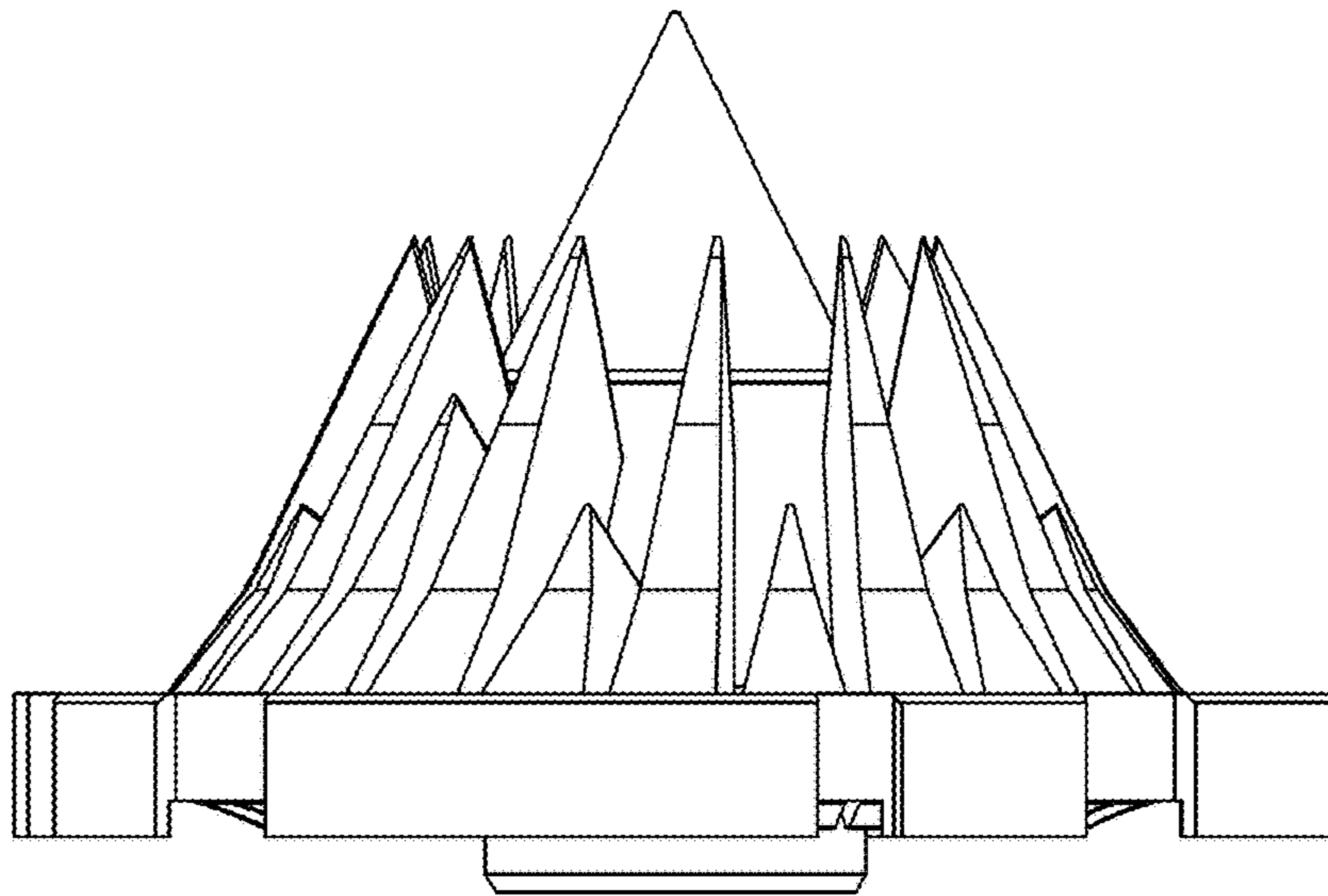

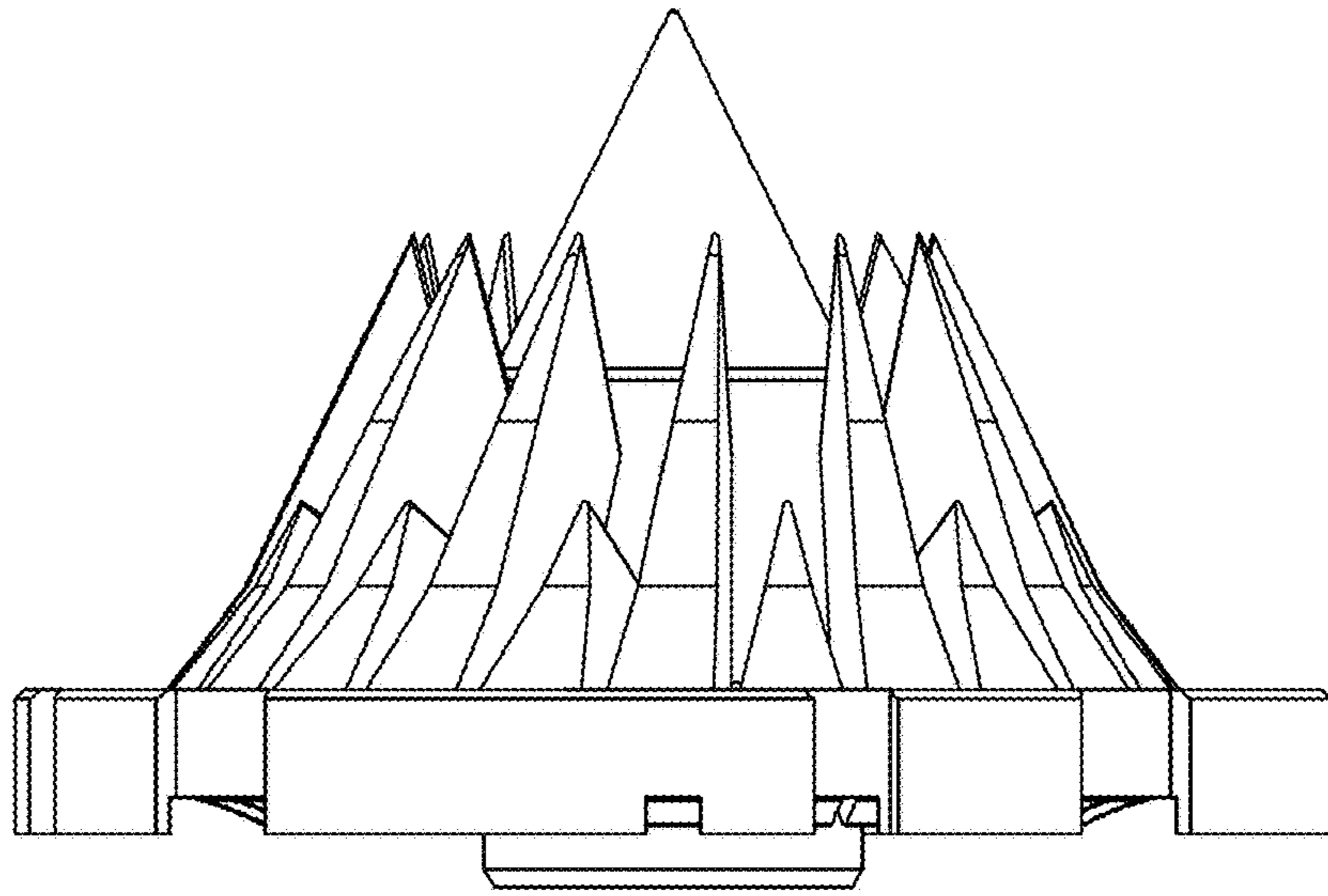

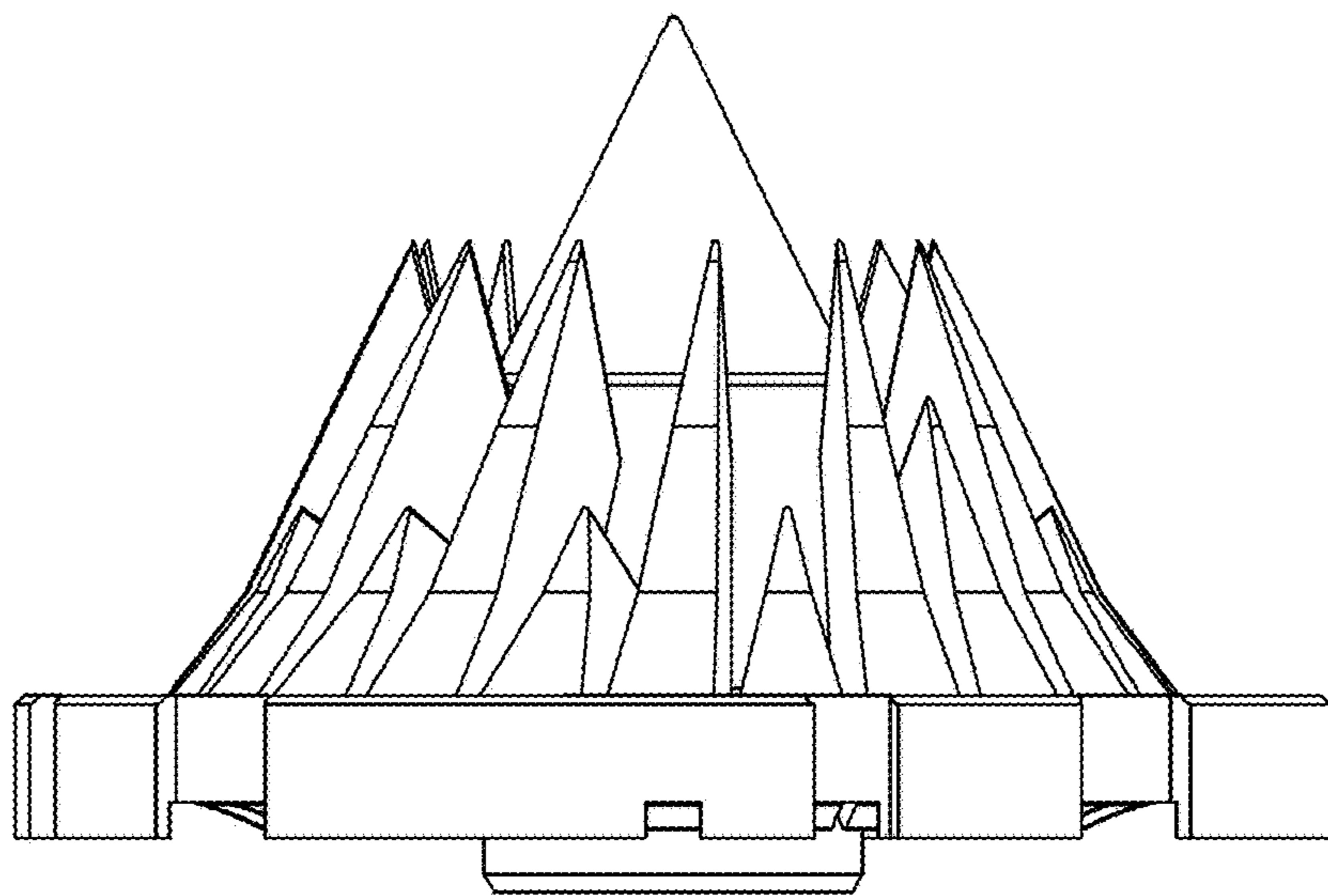

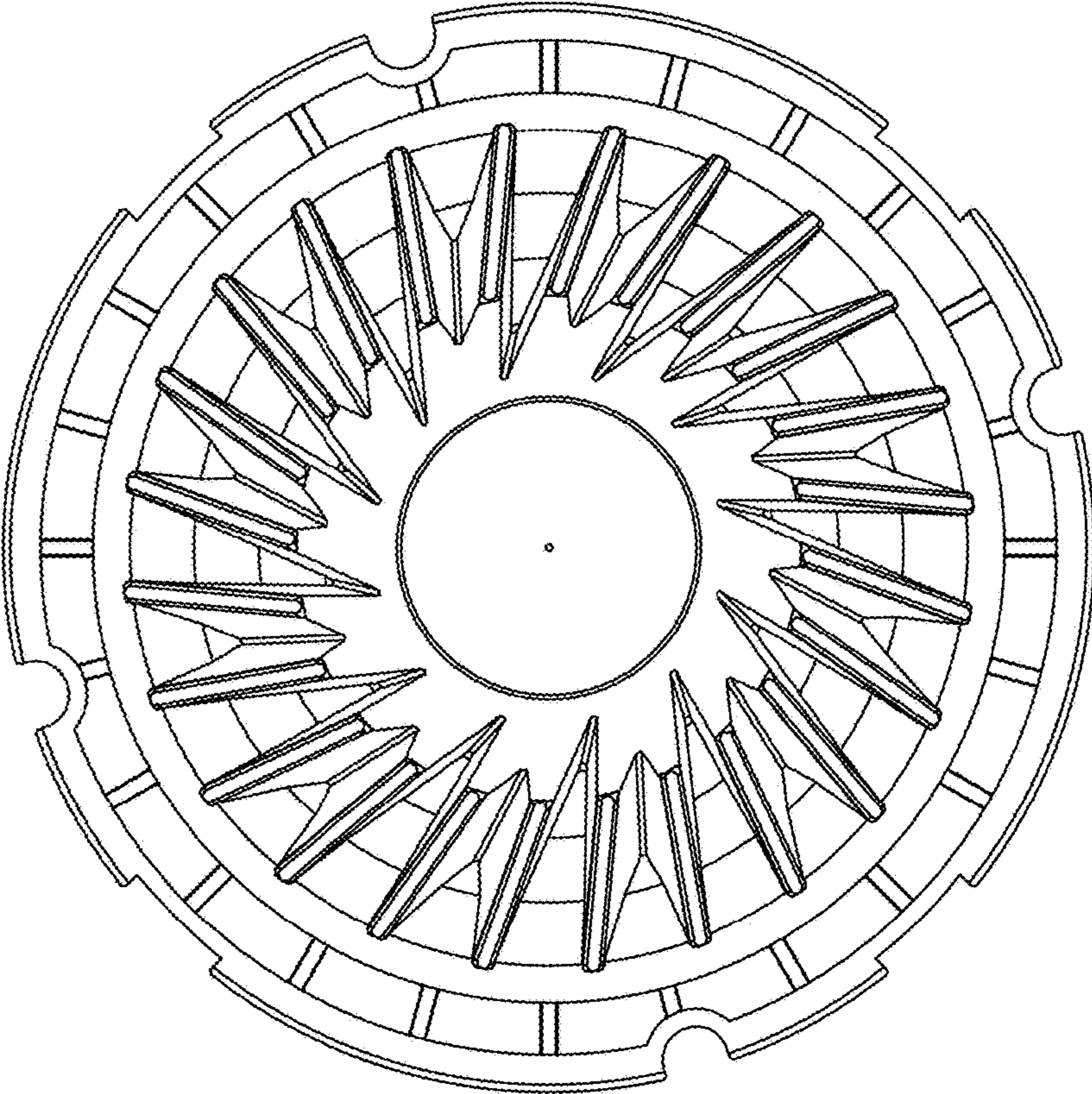

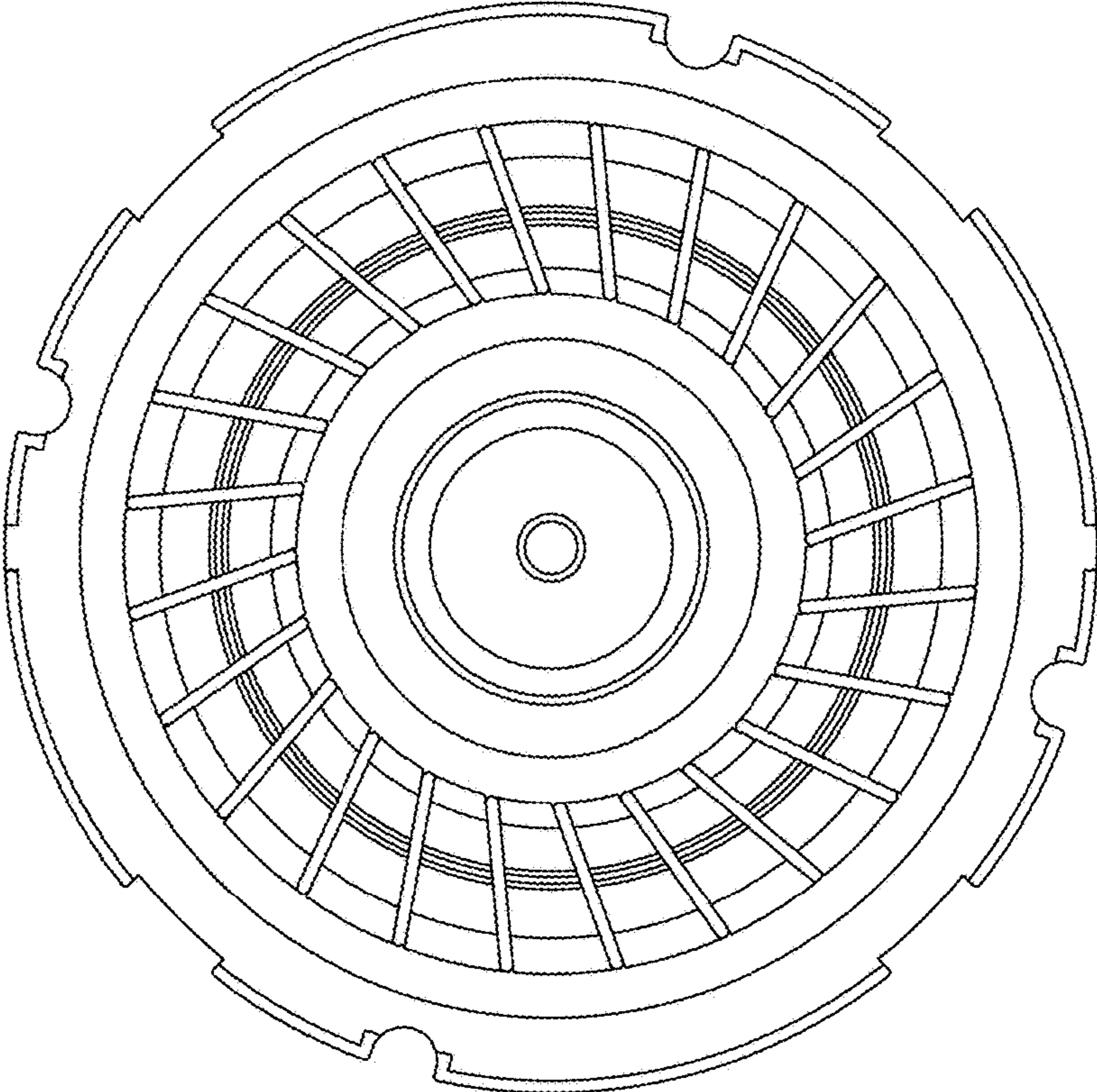

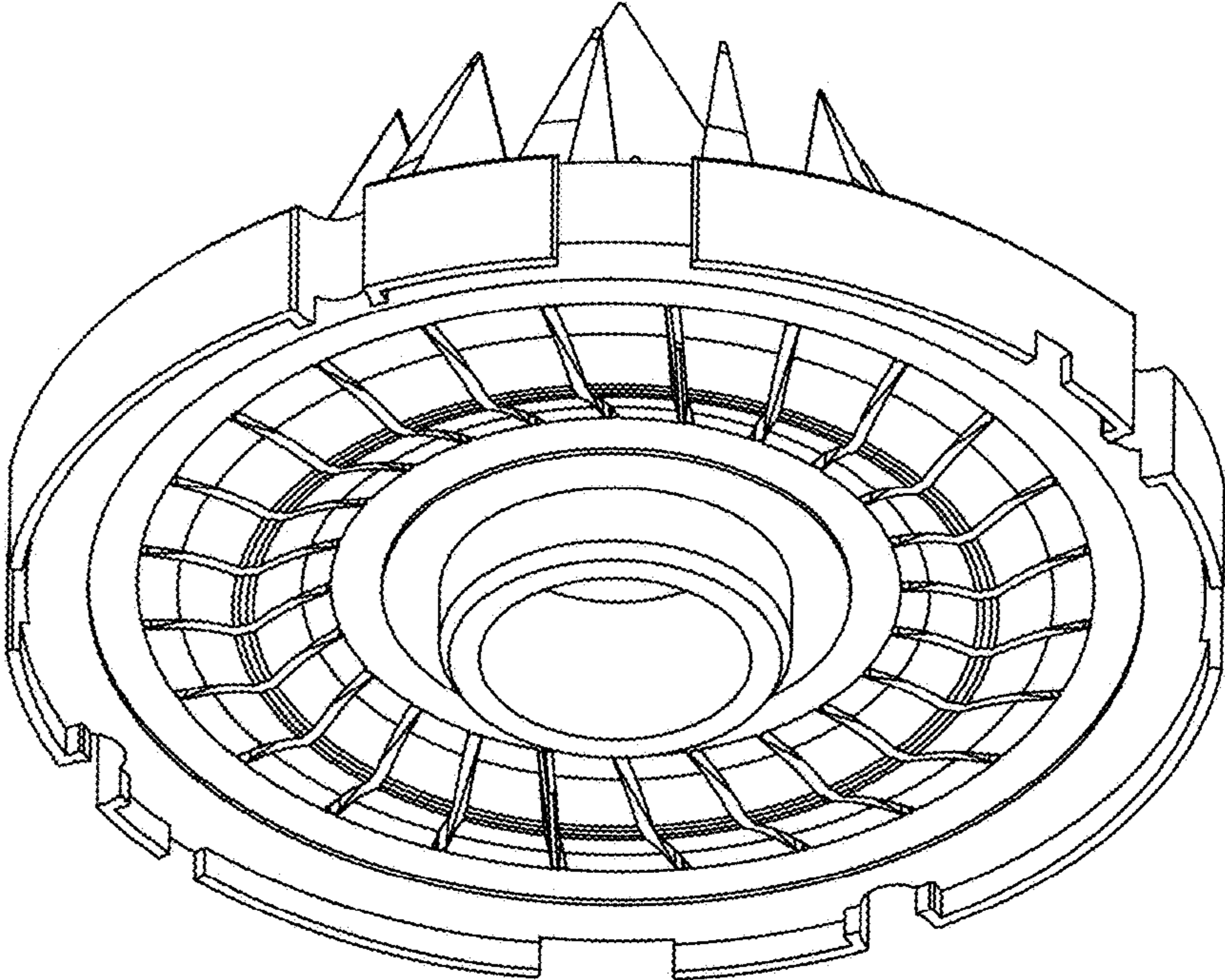
