We claim, the ornamental design for a vending tray, as shown and described.

DESCRIPTION

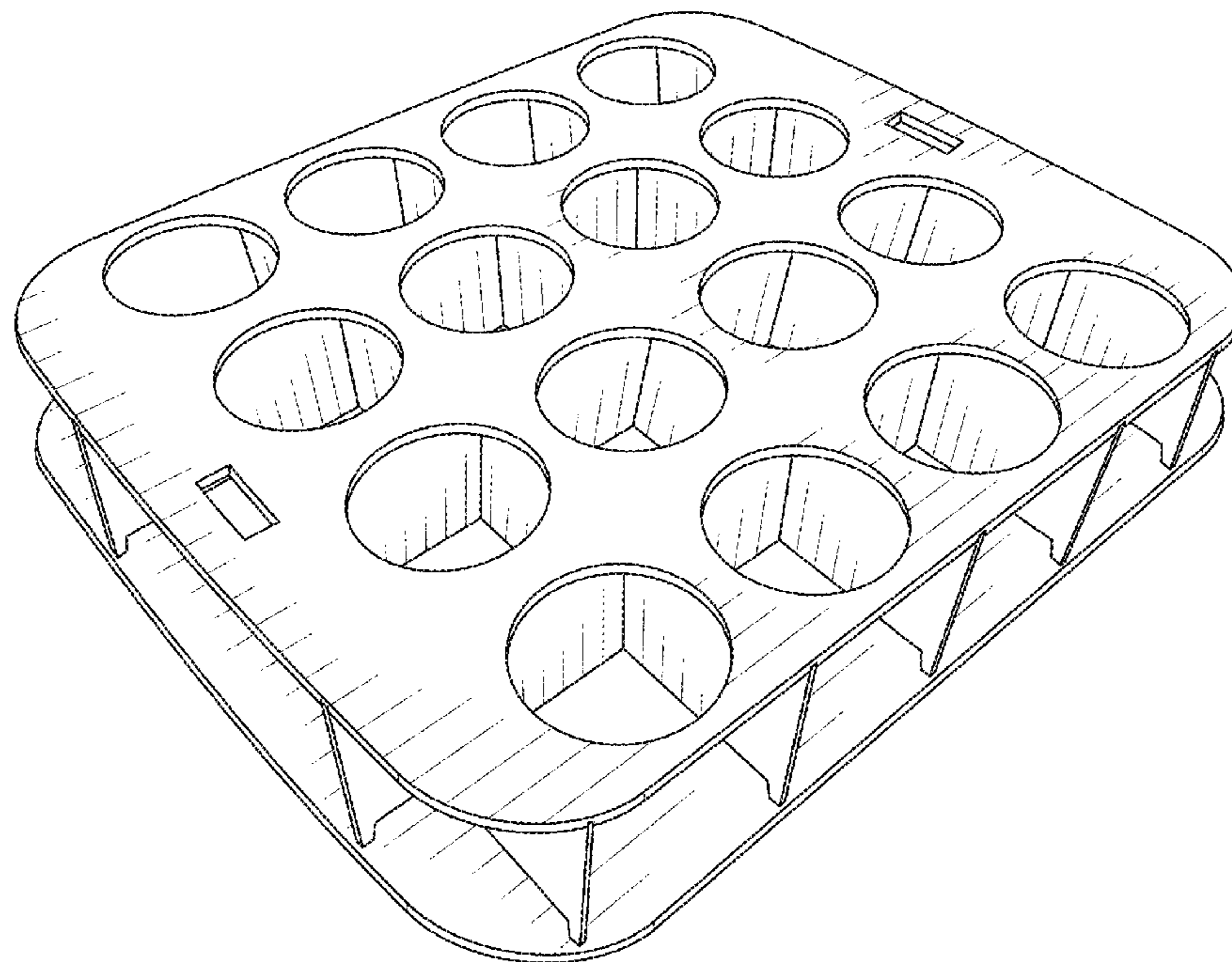
FIG. 1 is a perspective view of a vending tray, showing our new design;
 FIG. 2 is another perspective view of a vending tray shown in an environment of use;
 FIG. 3 is a first side elevation view of FIG. 1, the opposite side being a mirror image thereof;

 FIG. 5 is a top plan view thereof; and,

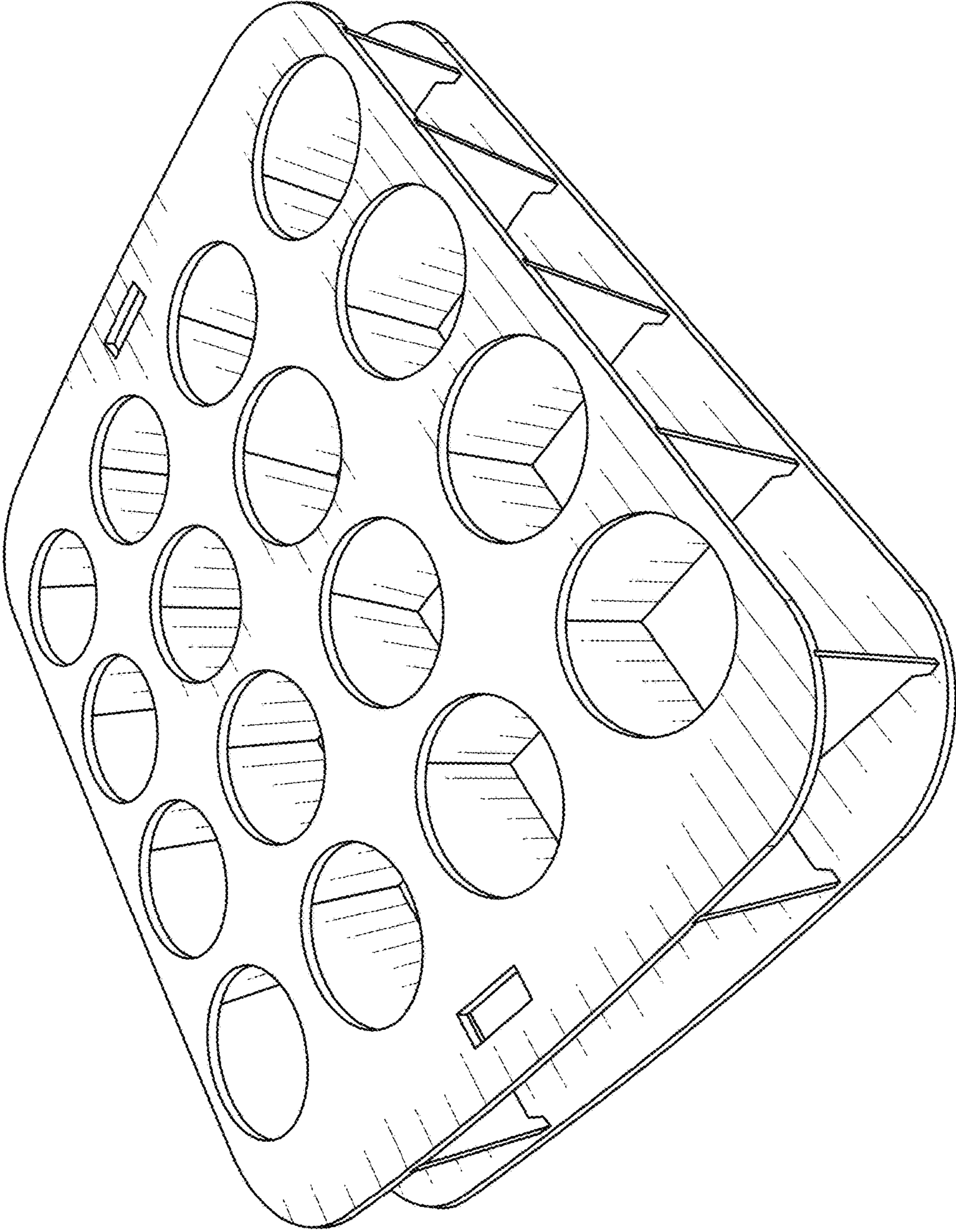

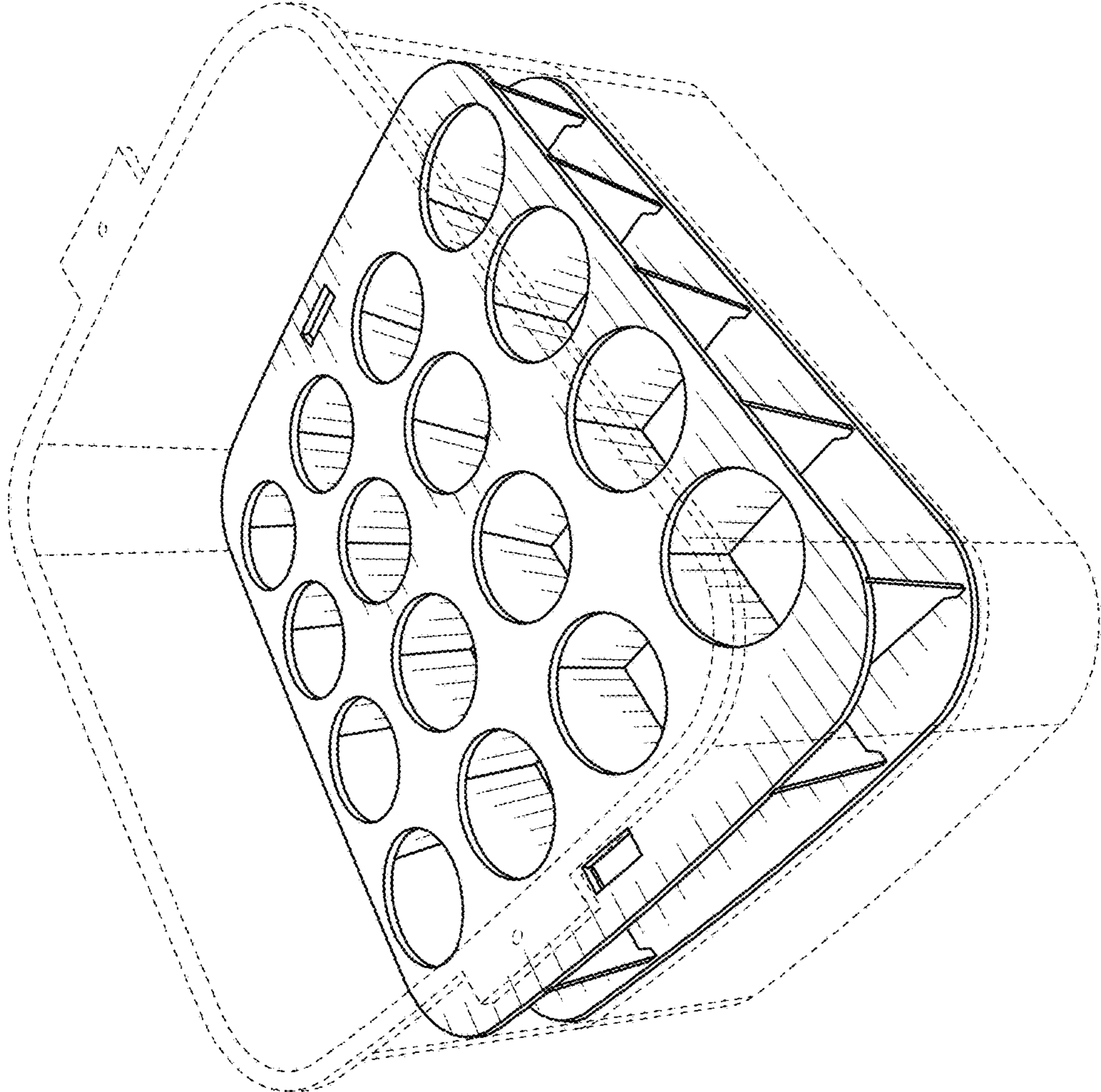

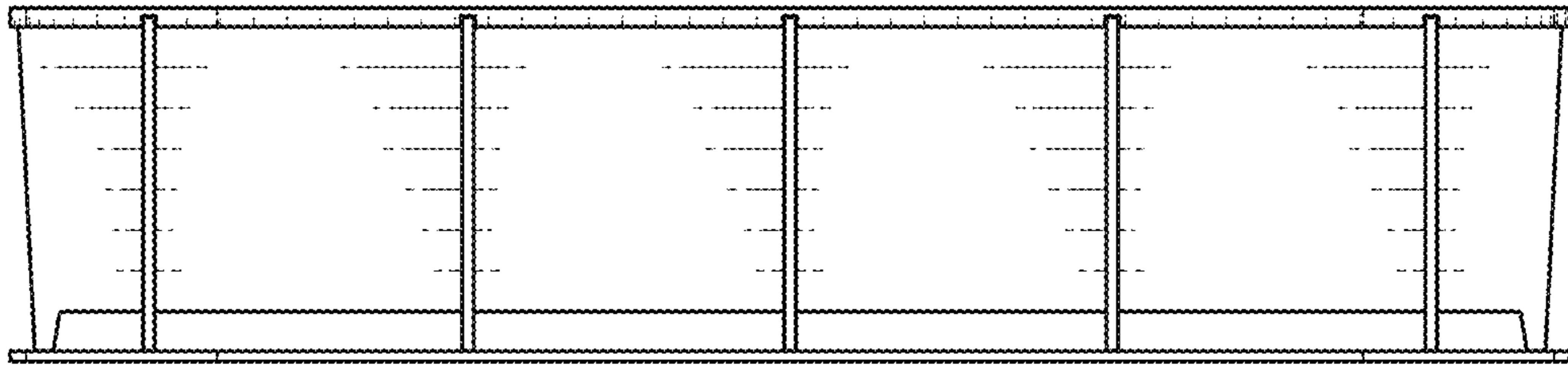

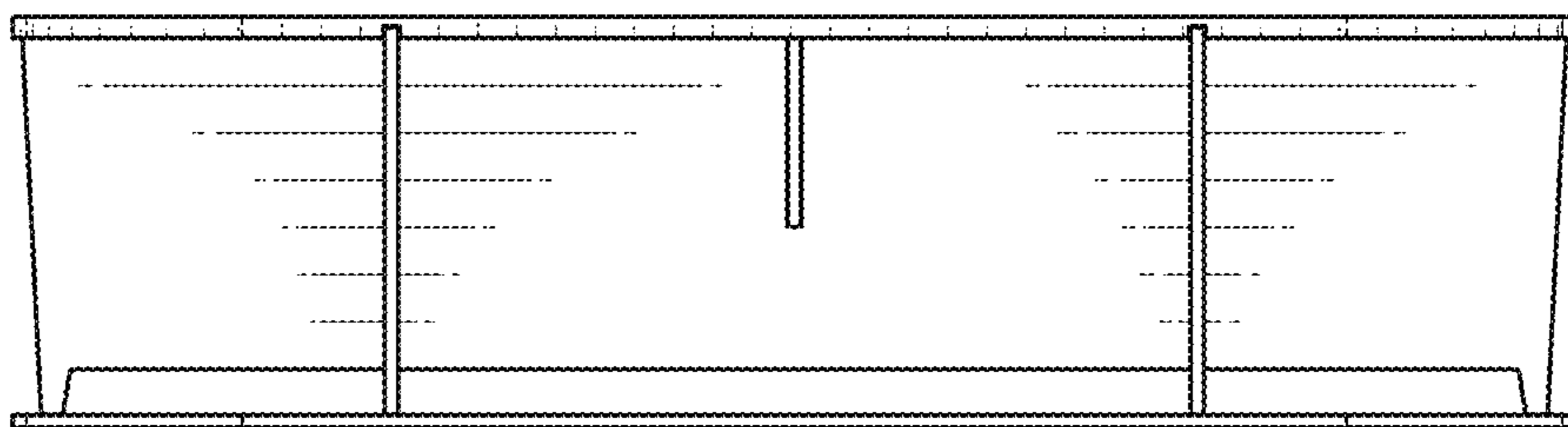

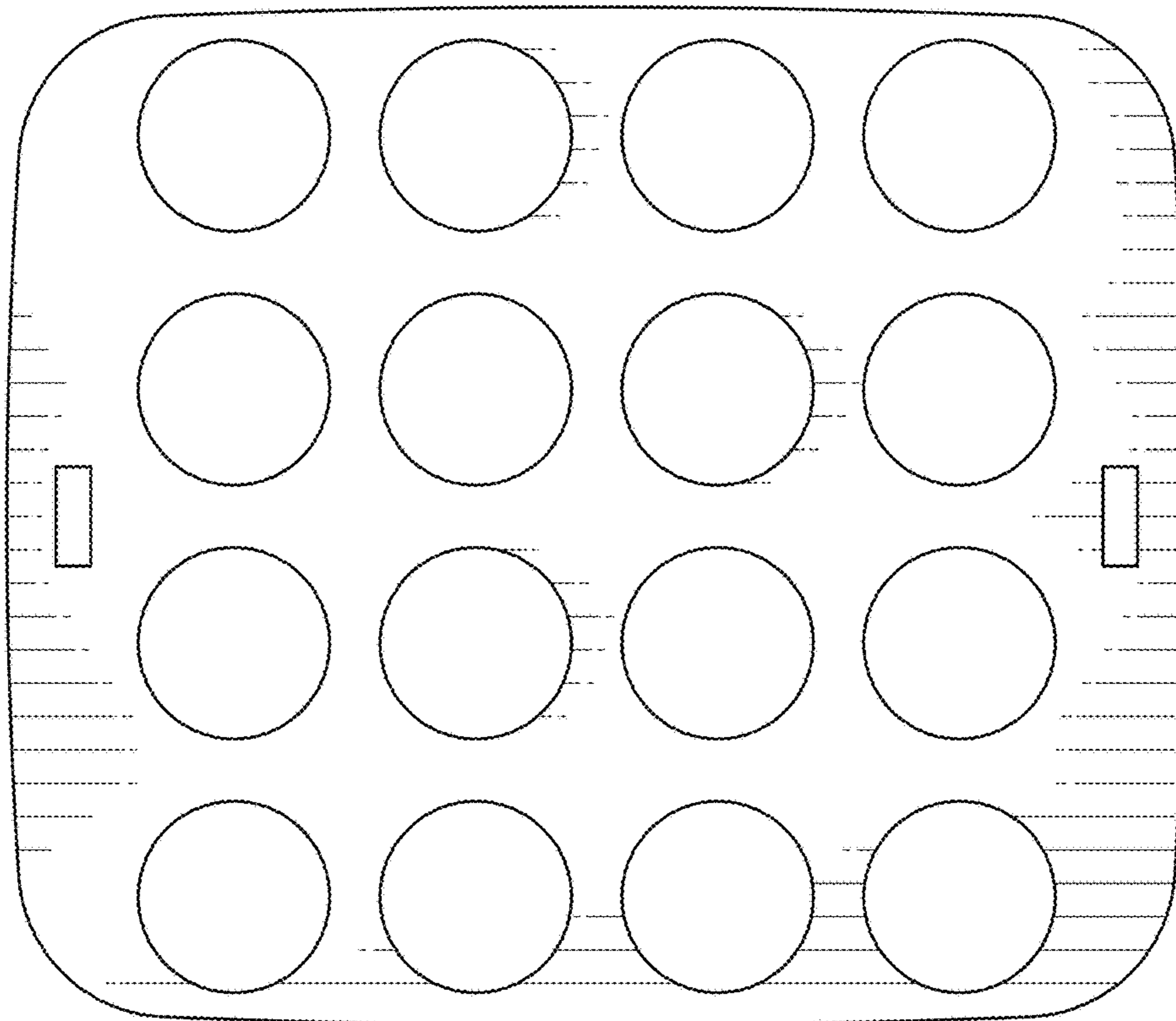
