(57) **CLAIM**

The ornamental design for a face plate for a video game controller, as shown and described.

DESCRIPTION

FIG. 1 is a top, rear and right perspective view of a face plate for a video game controller embodying my new design; FIG. 2 is a top view thereof; FIG. 3 is a bottom view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a front view thereof; FIG. 6 is a left side view thereof; and, FIG. 7 is a right side view thereof.

The broken lines in the drawings depict portions of the face plate for a video game controller that form no part of the claimed design.

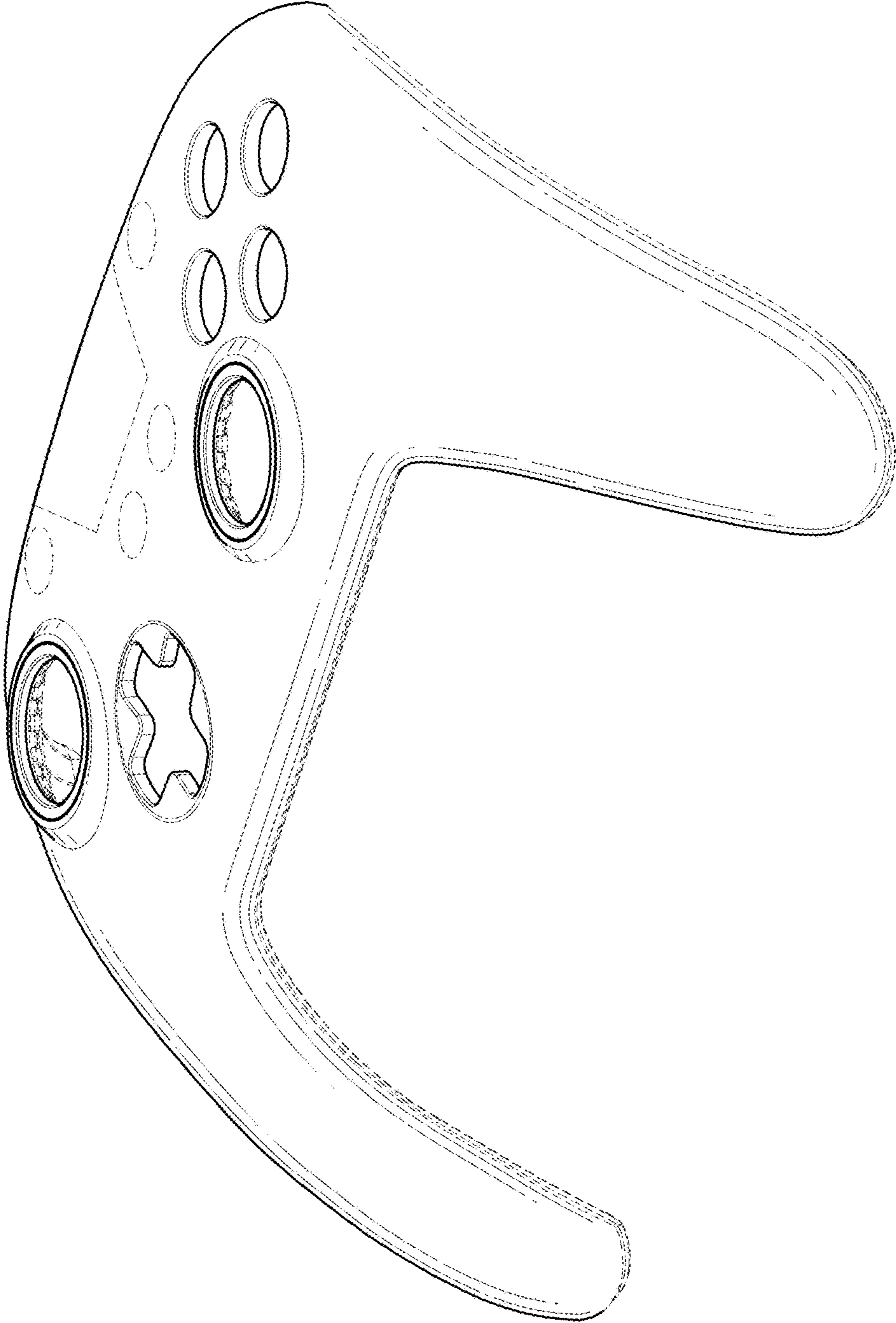

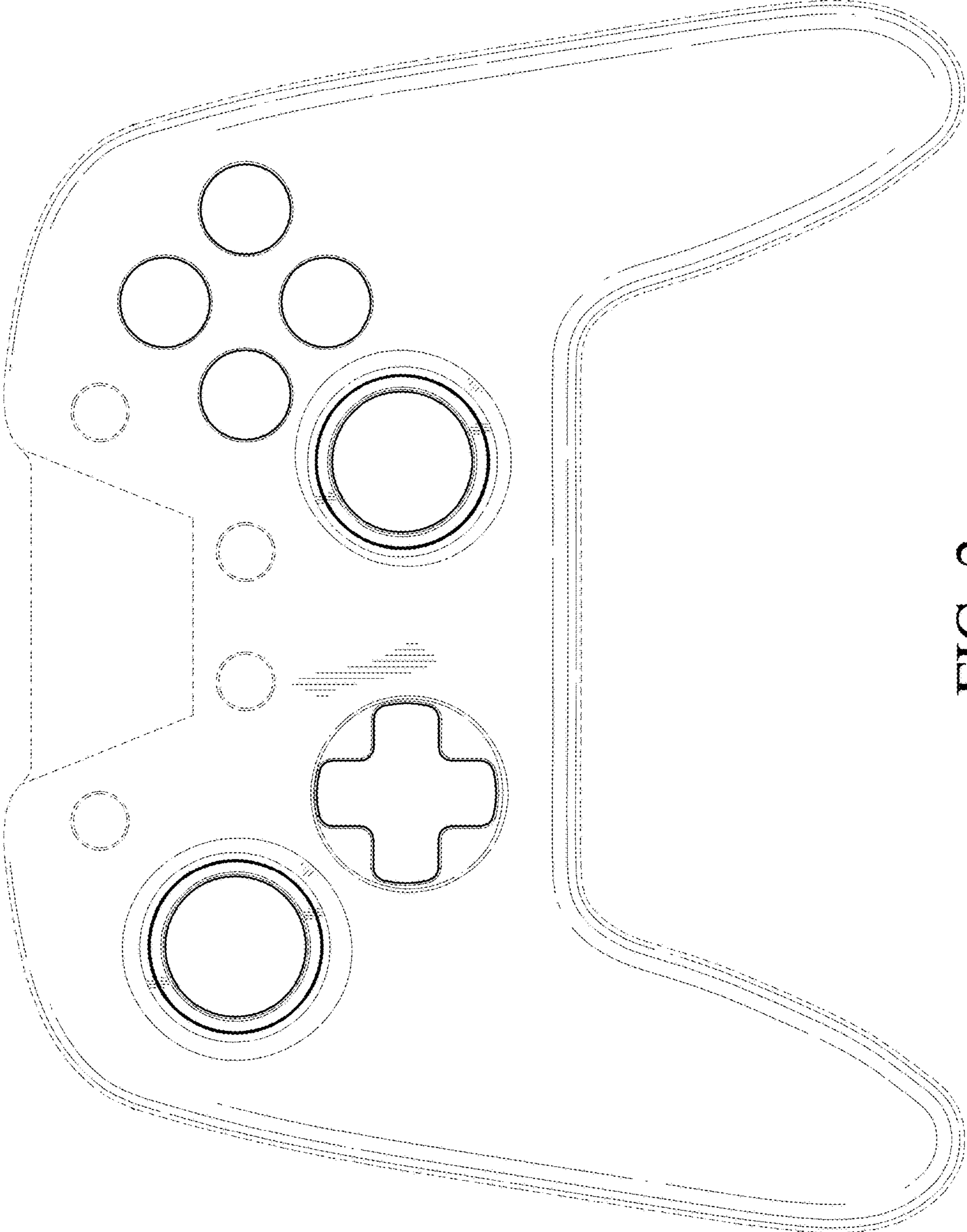

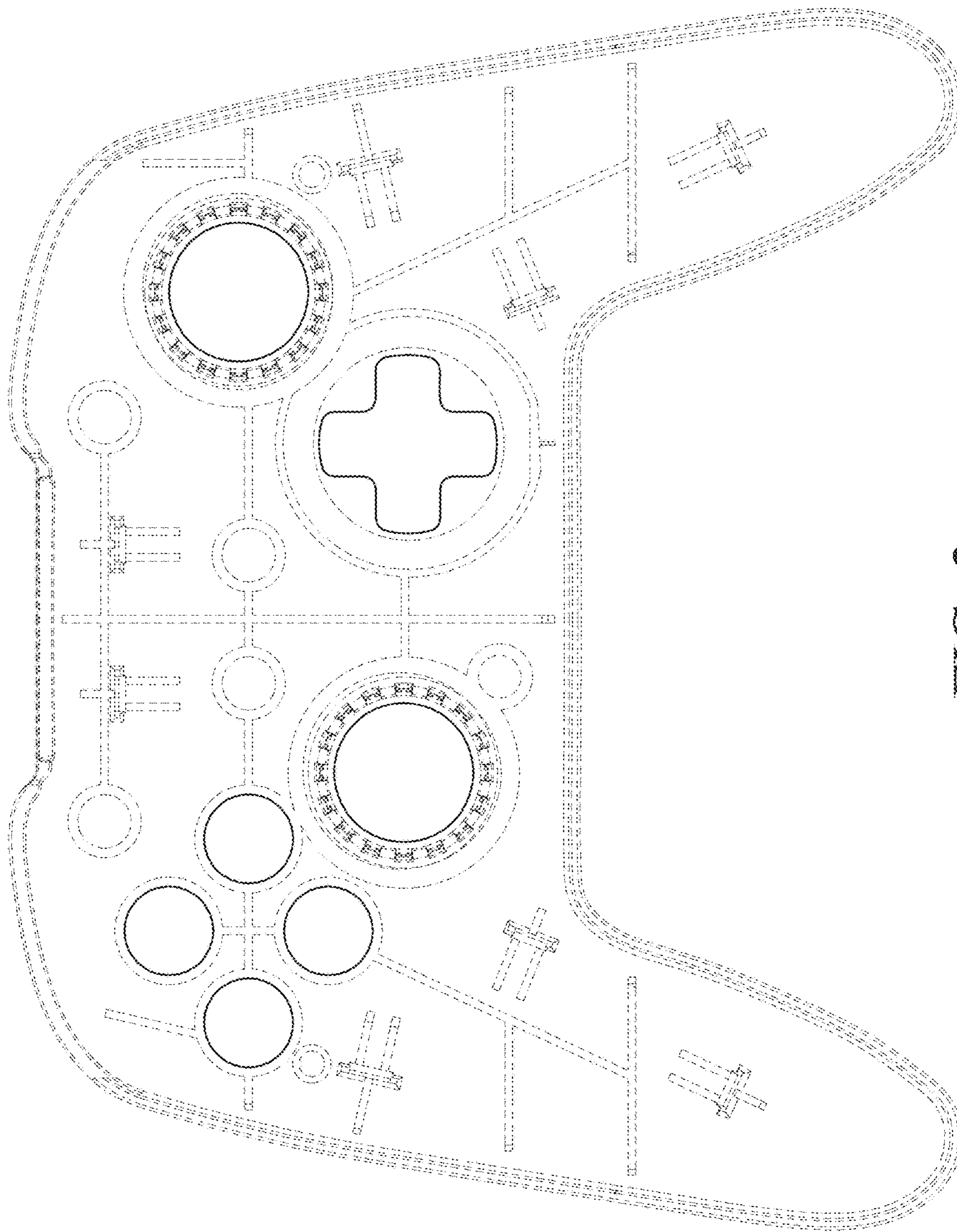

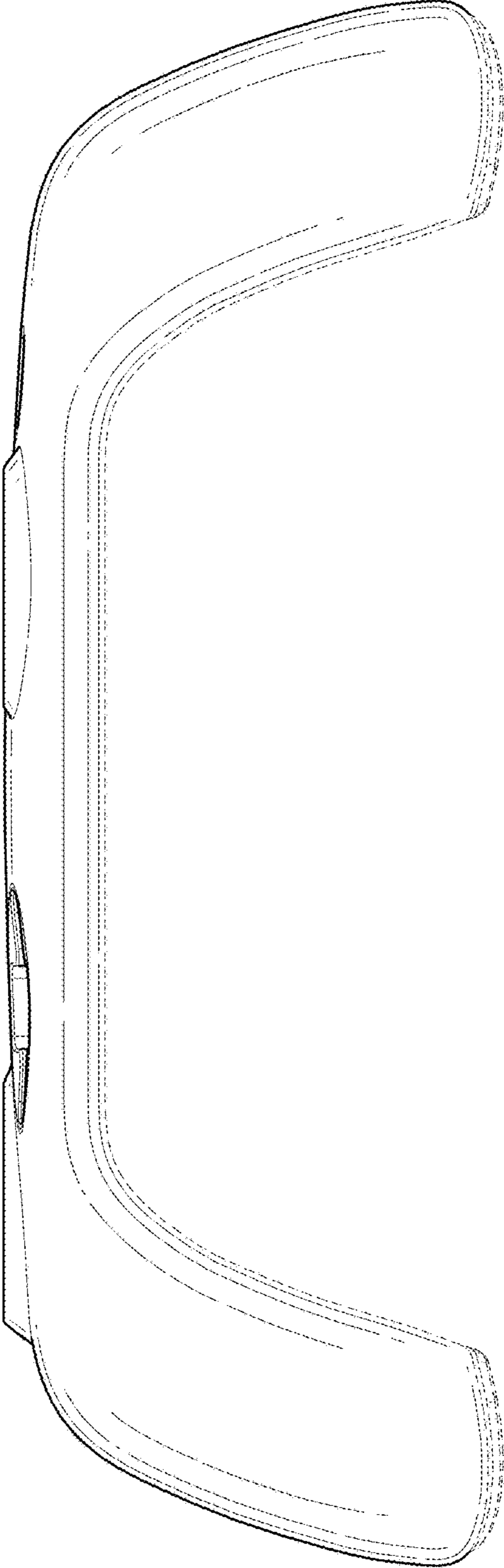

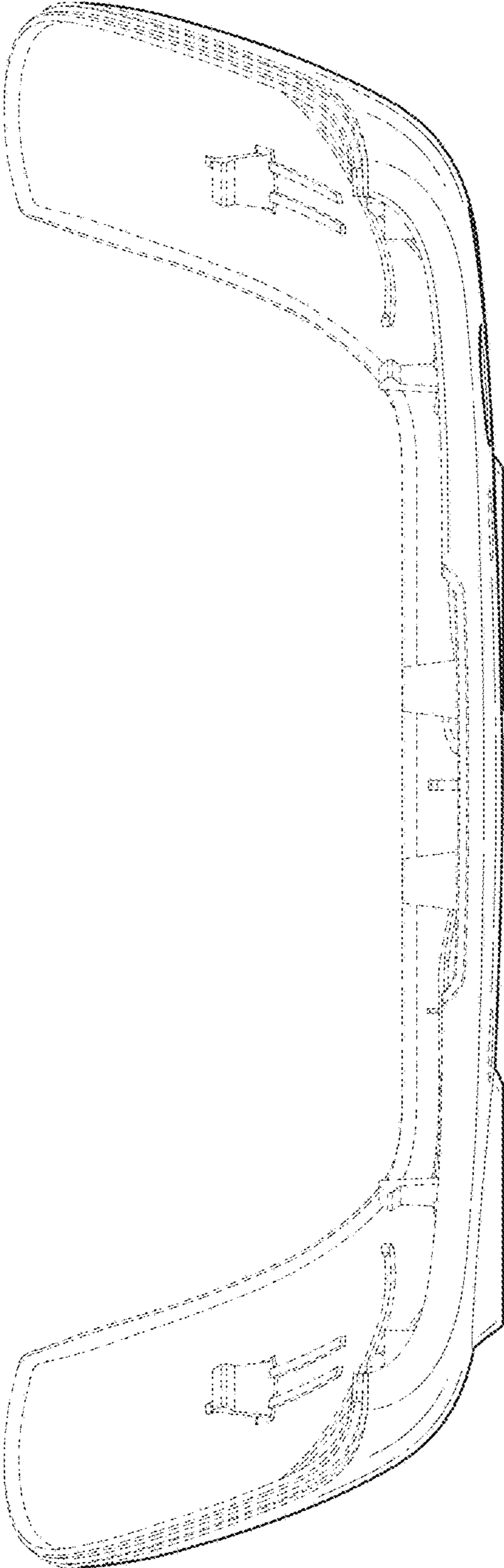

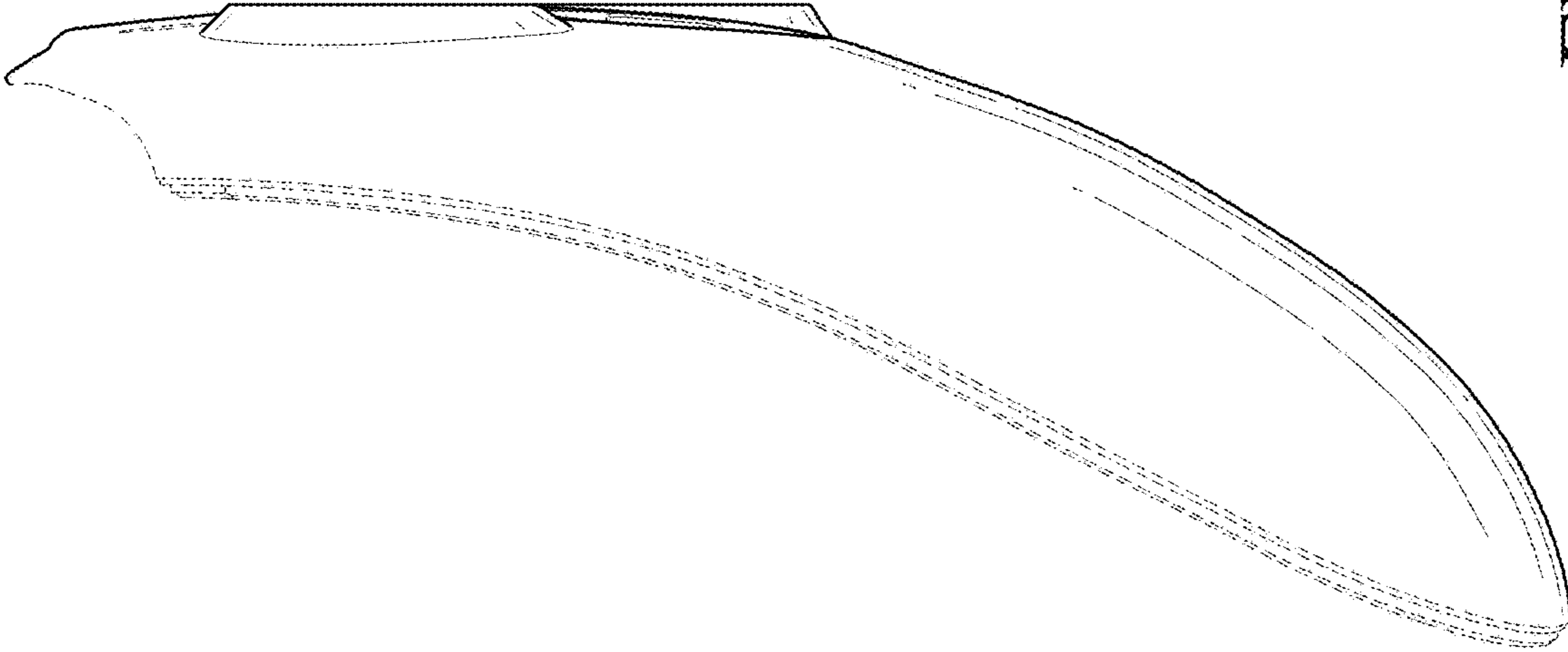

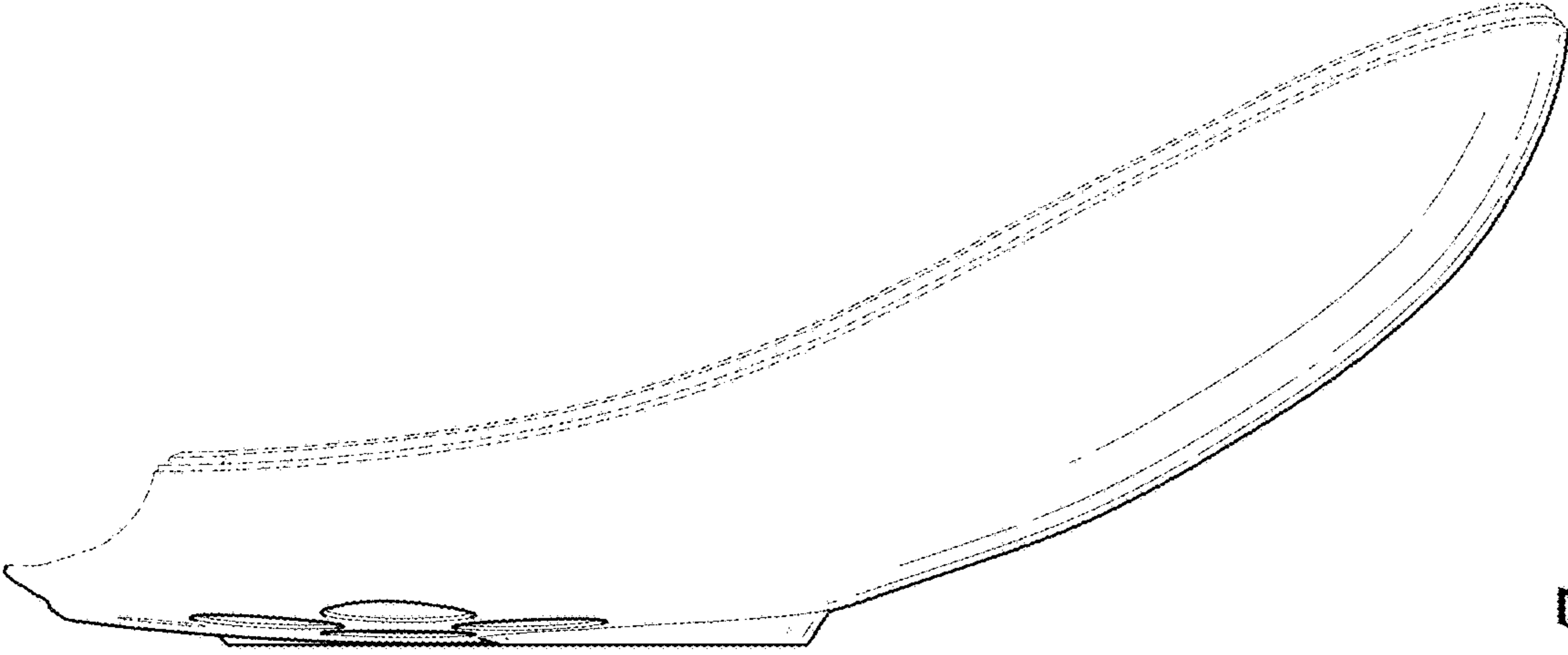
