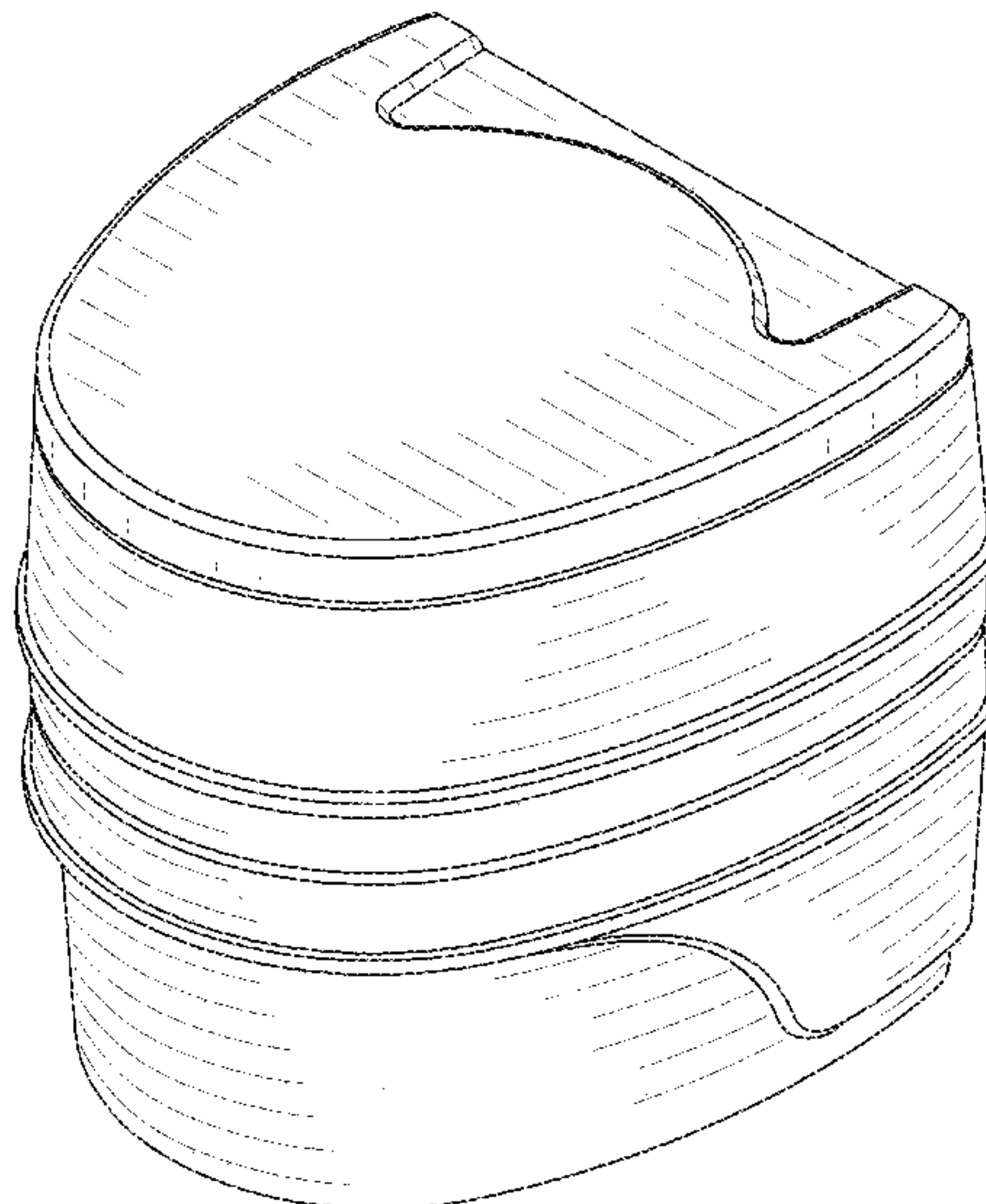
FIG. 1 is a Front, Top, Right perspective view of a portable toilet, showing our new design;

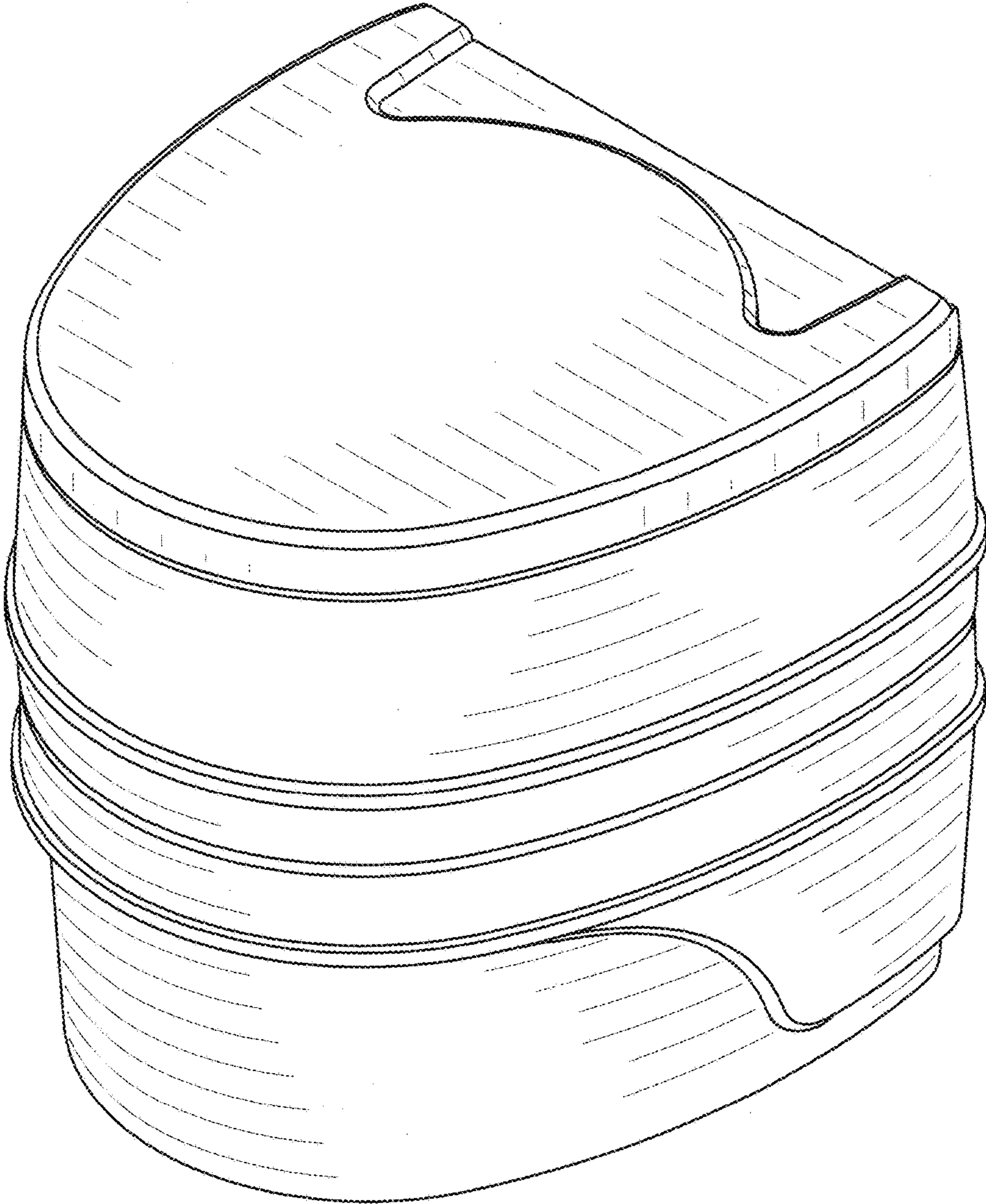

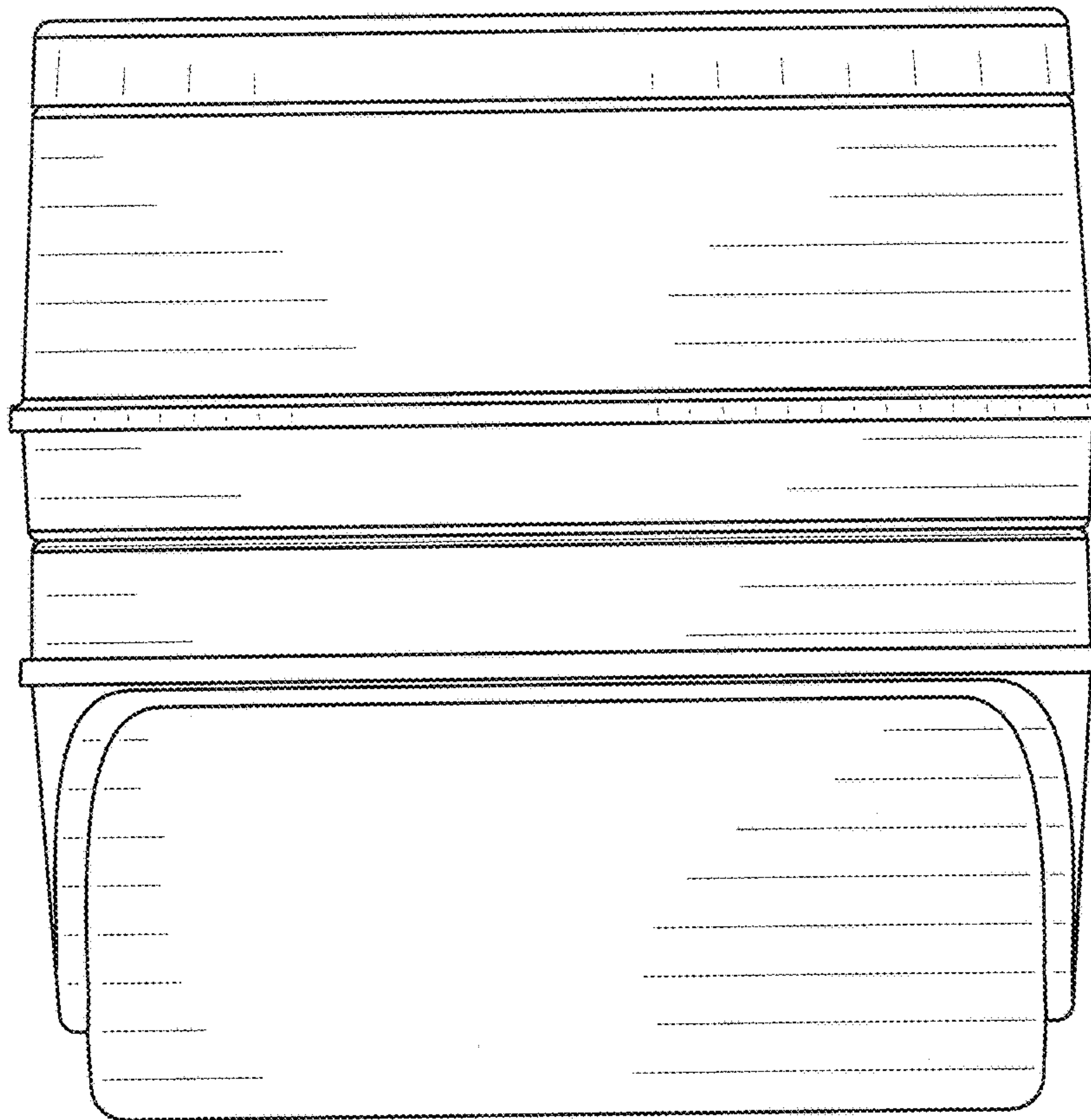

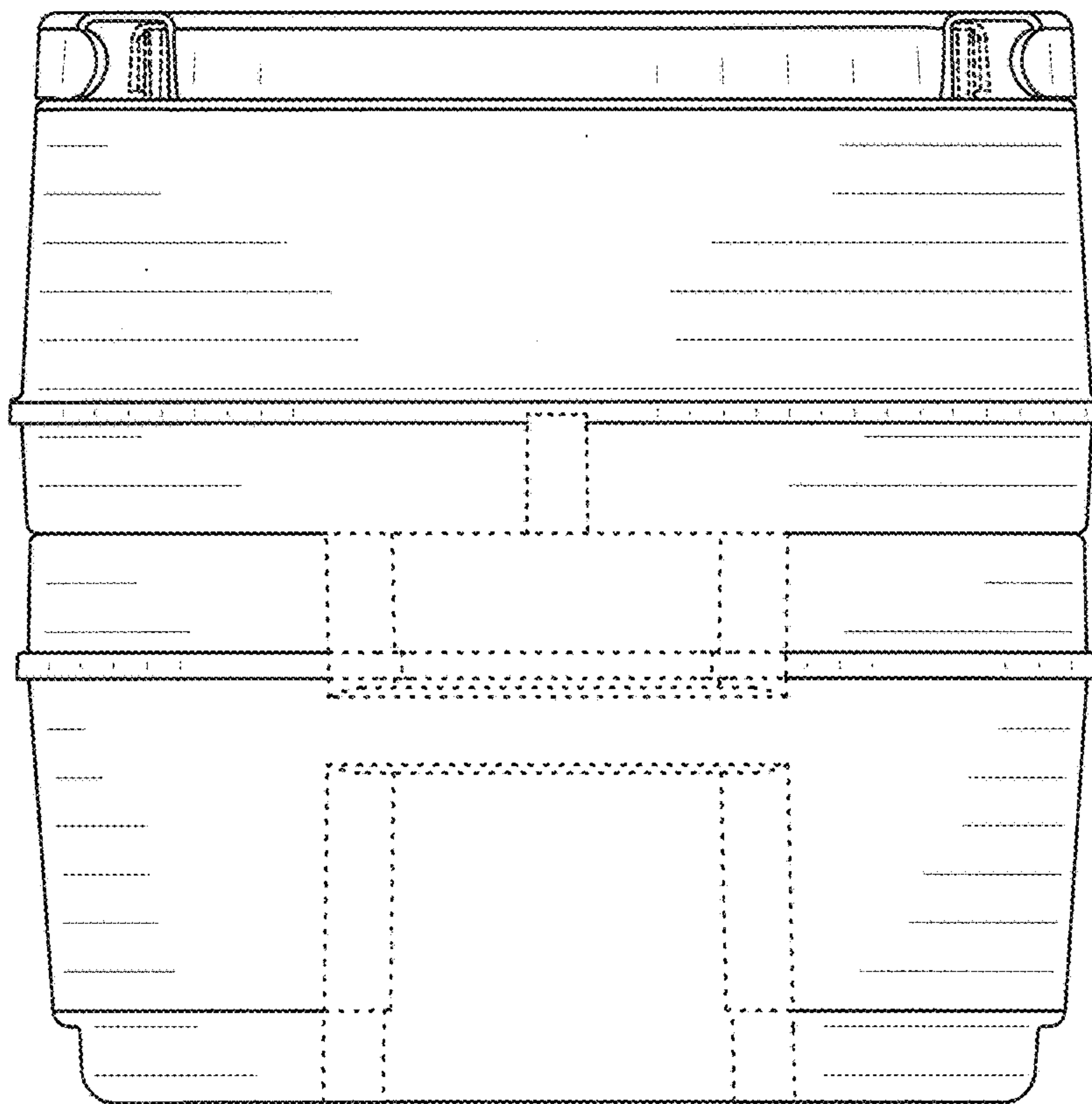

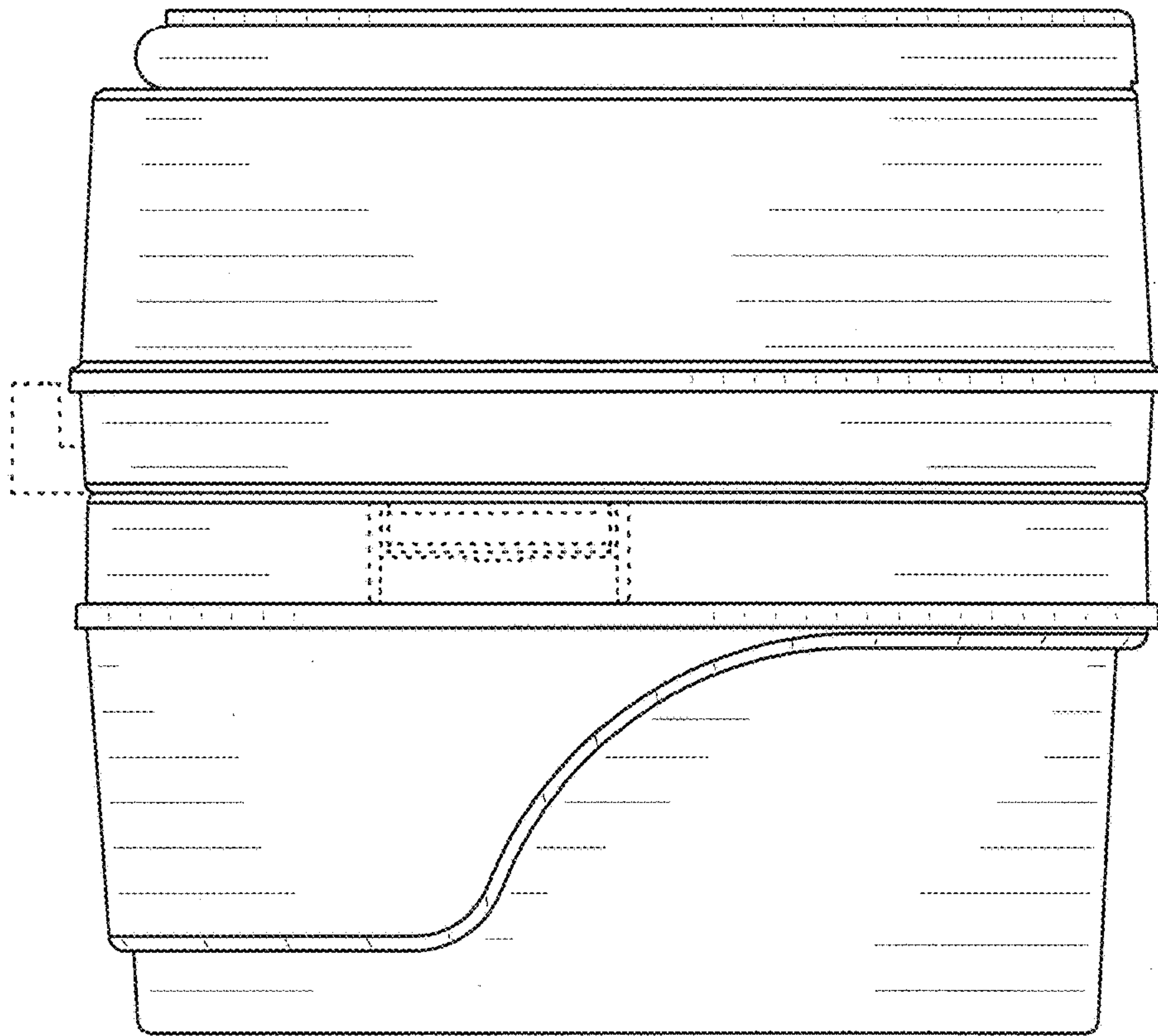

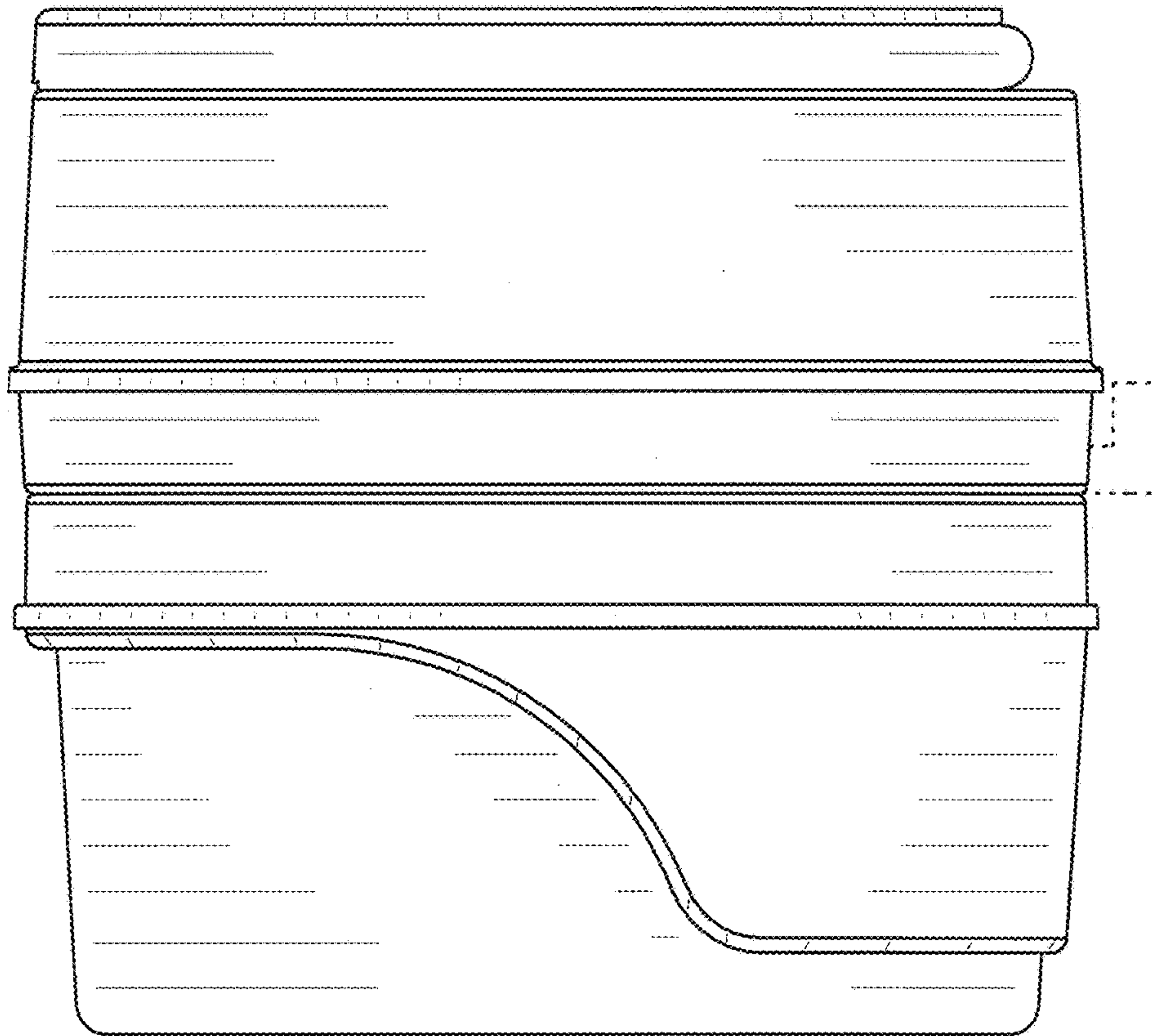

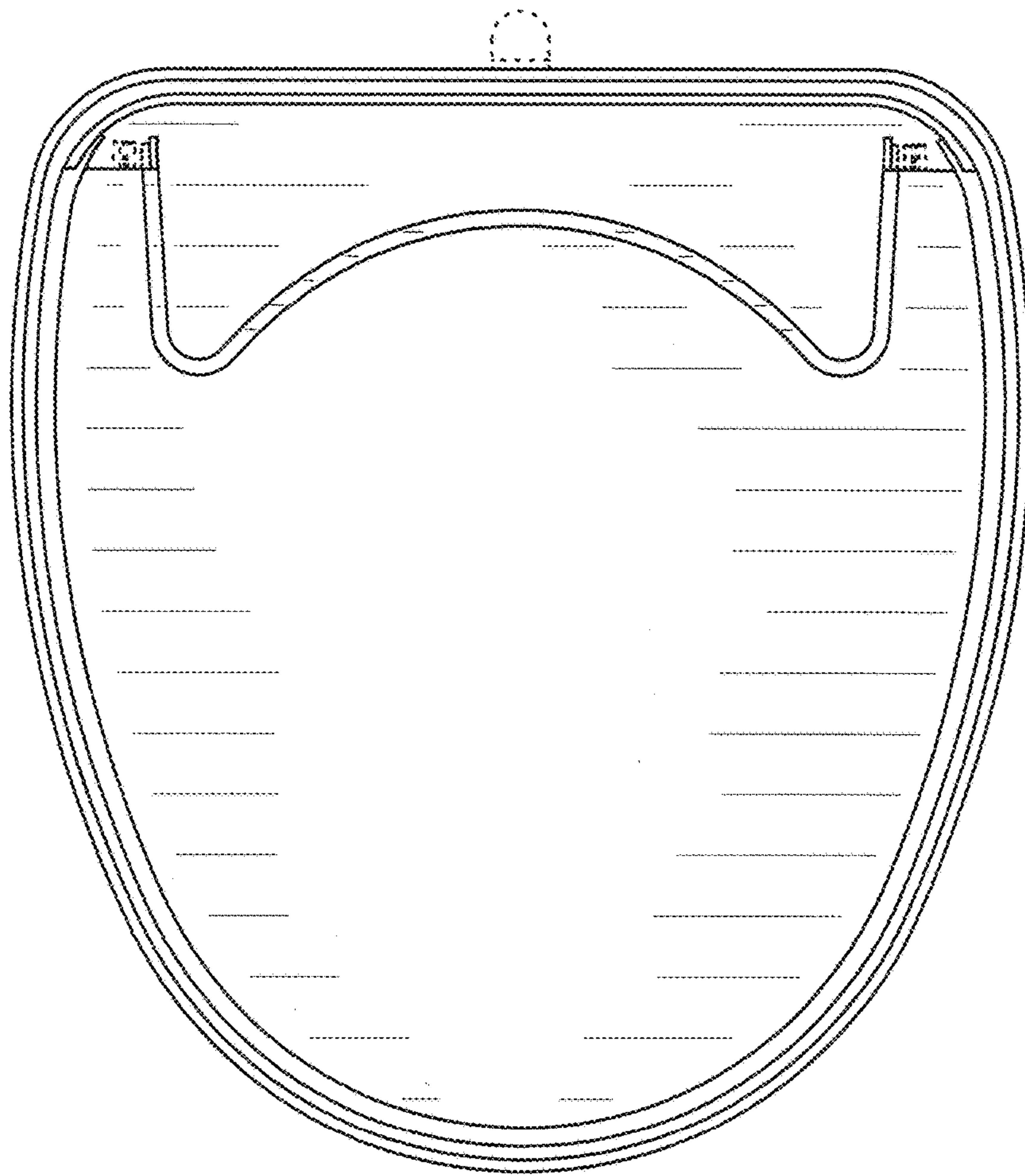

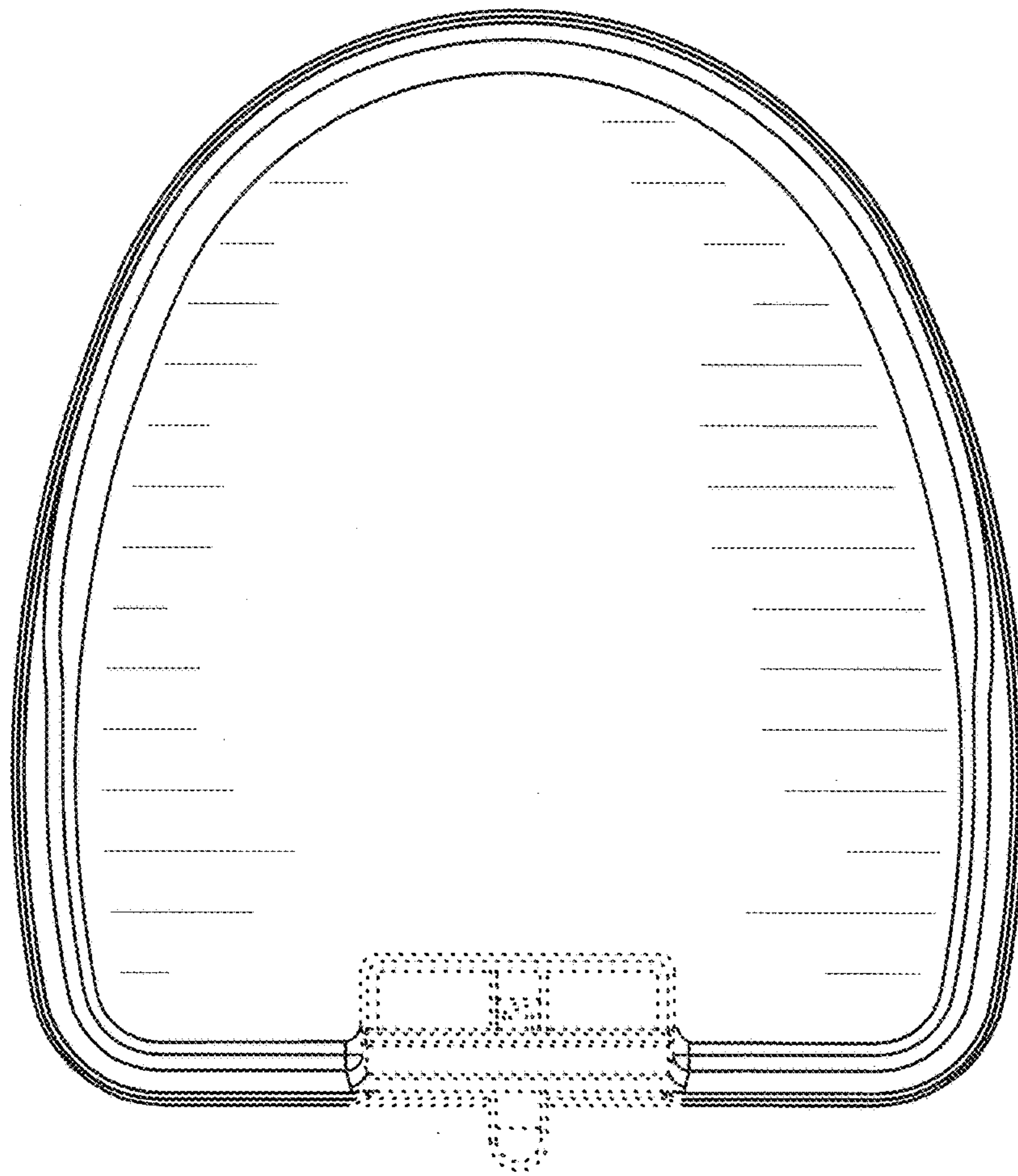

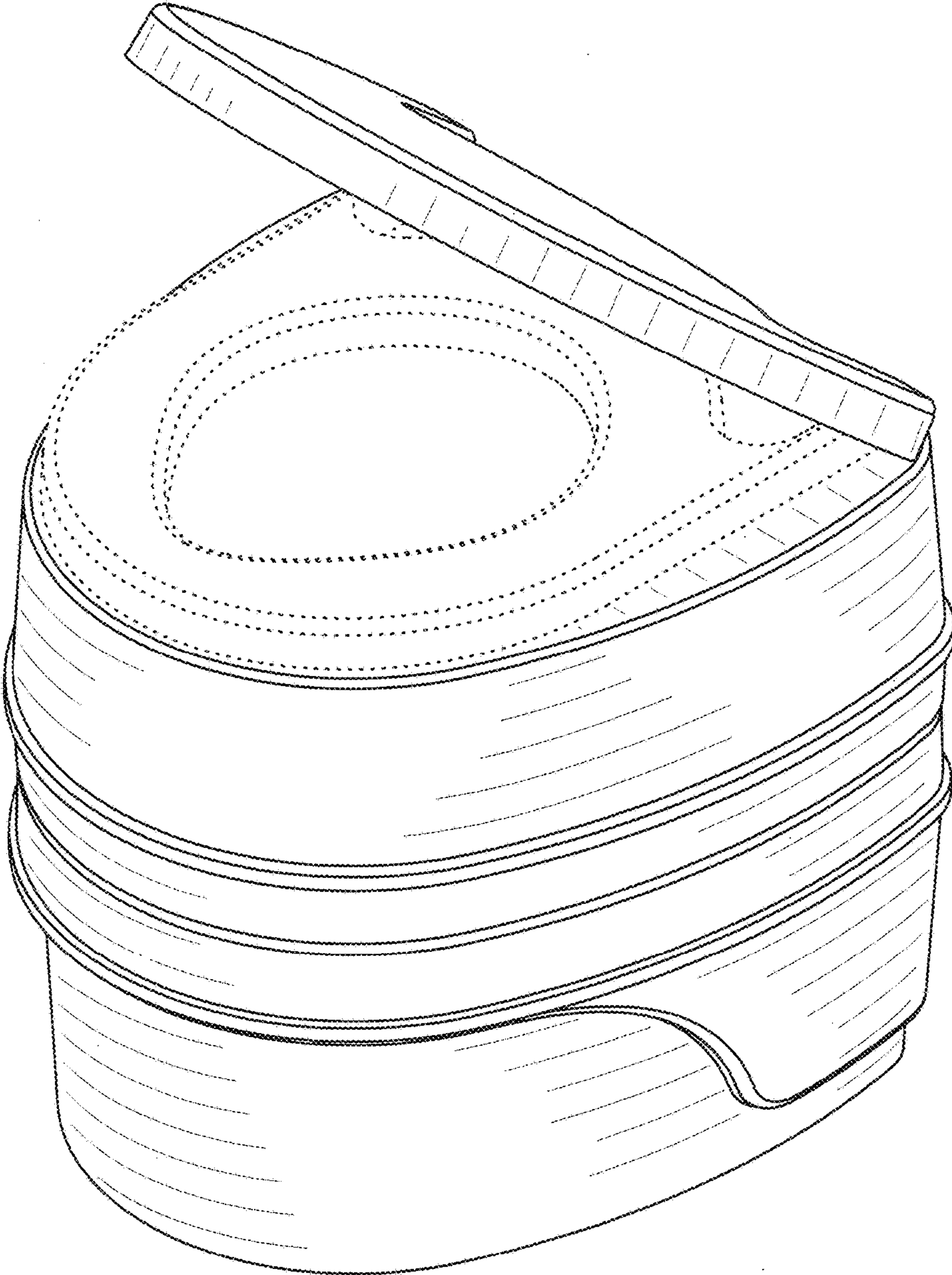
