FIG. 1.4 is a front elevation view.

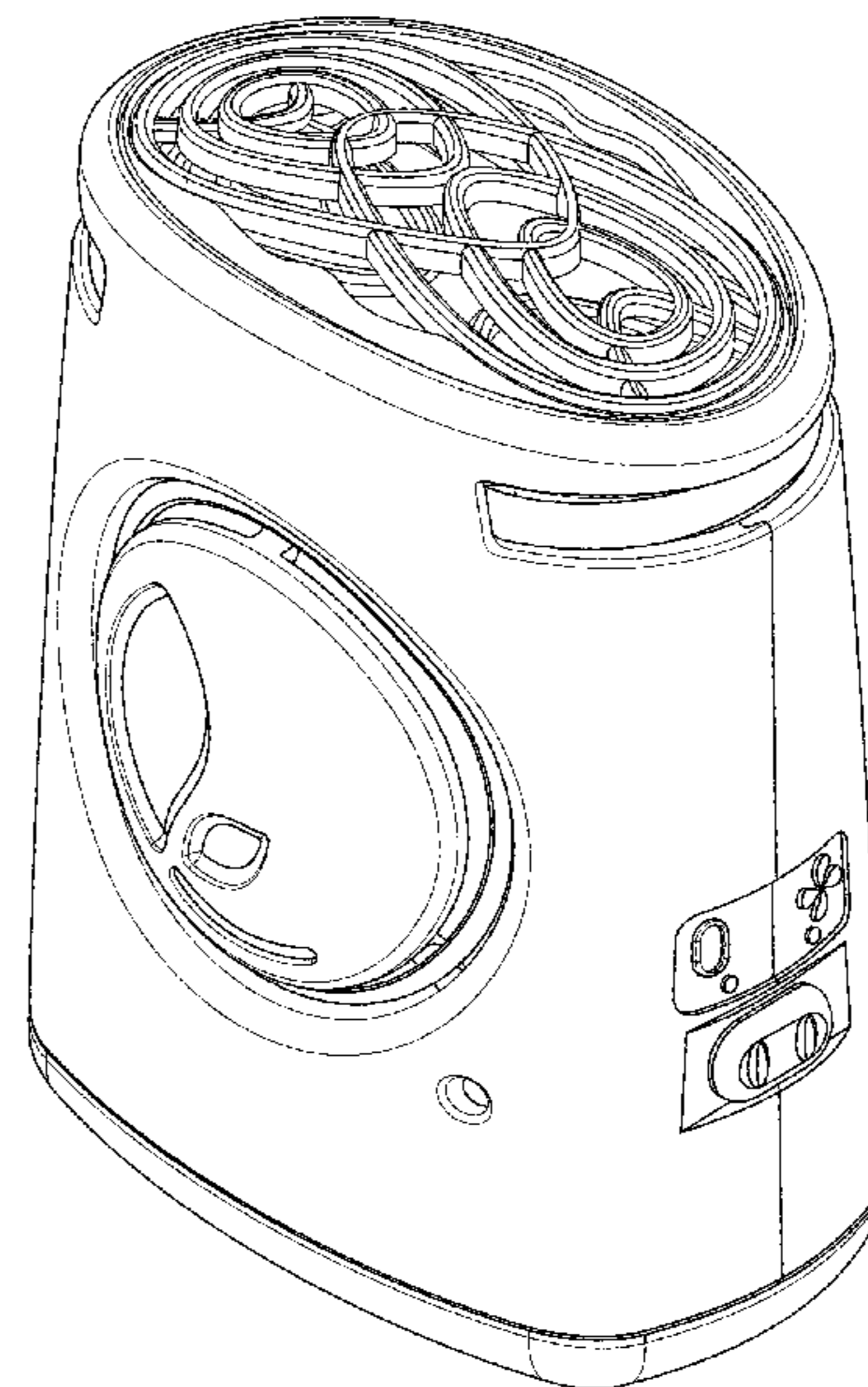
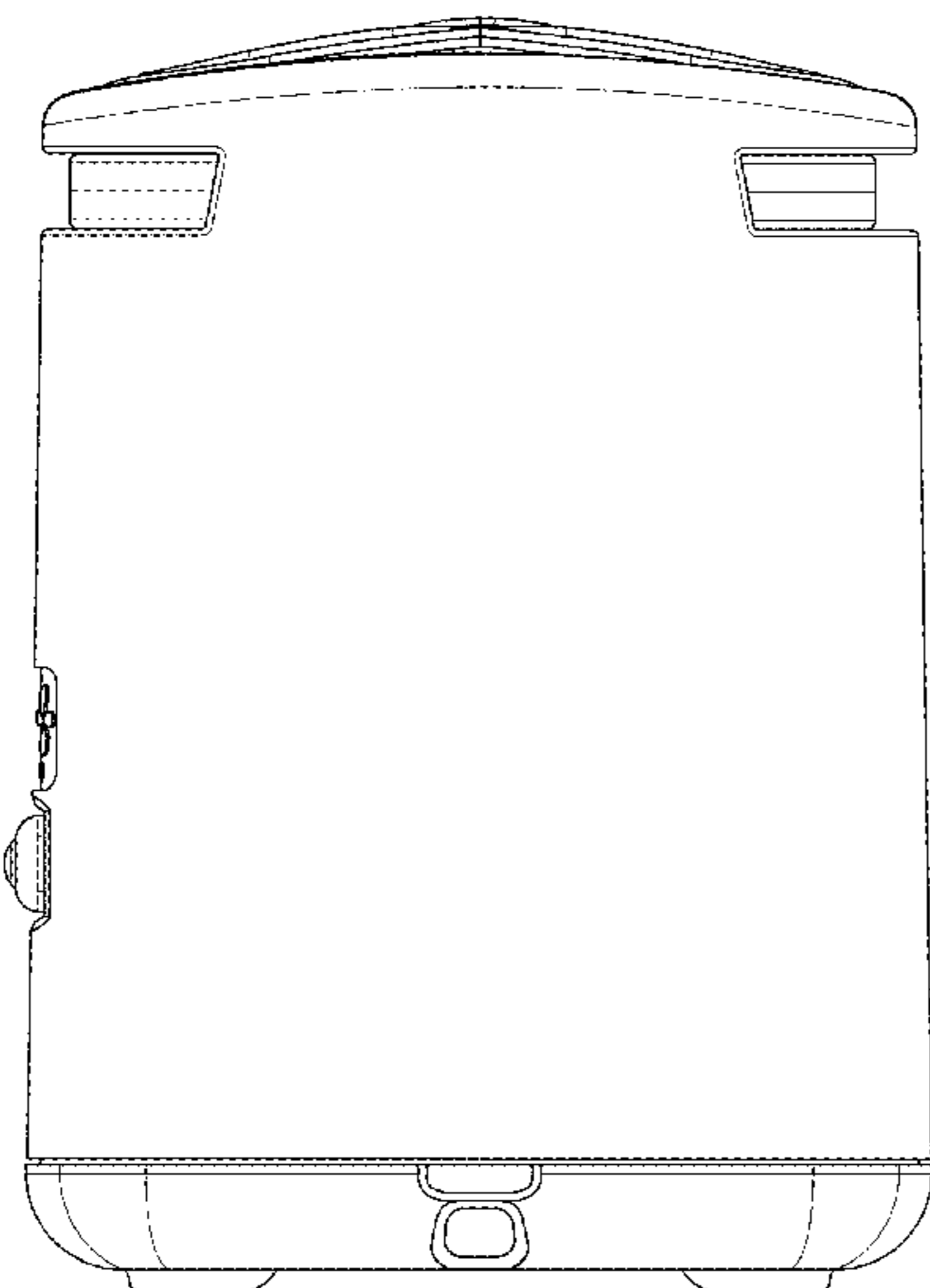
FIG. 1.5 is a top, front and right side perspective view.

FIG. 1.6 is a top plan view.

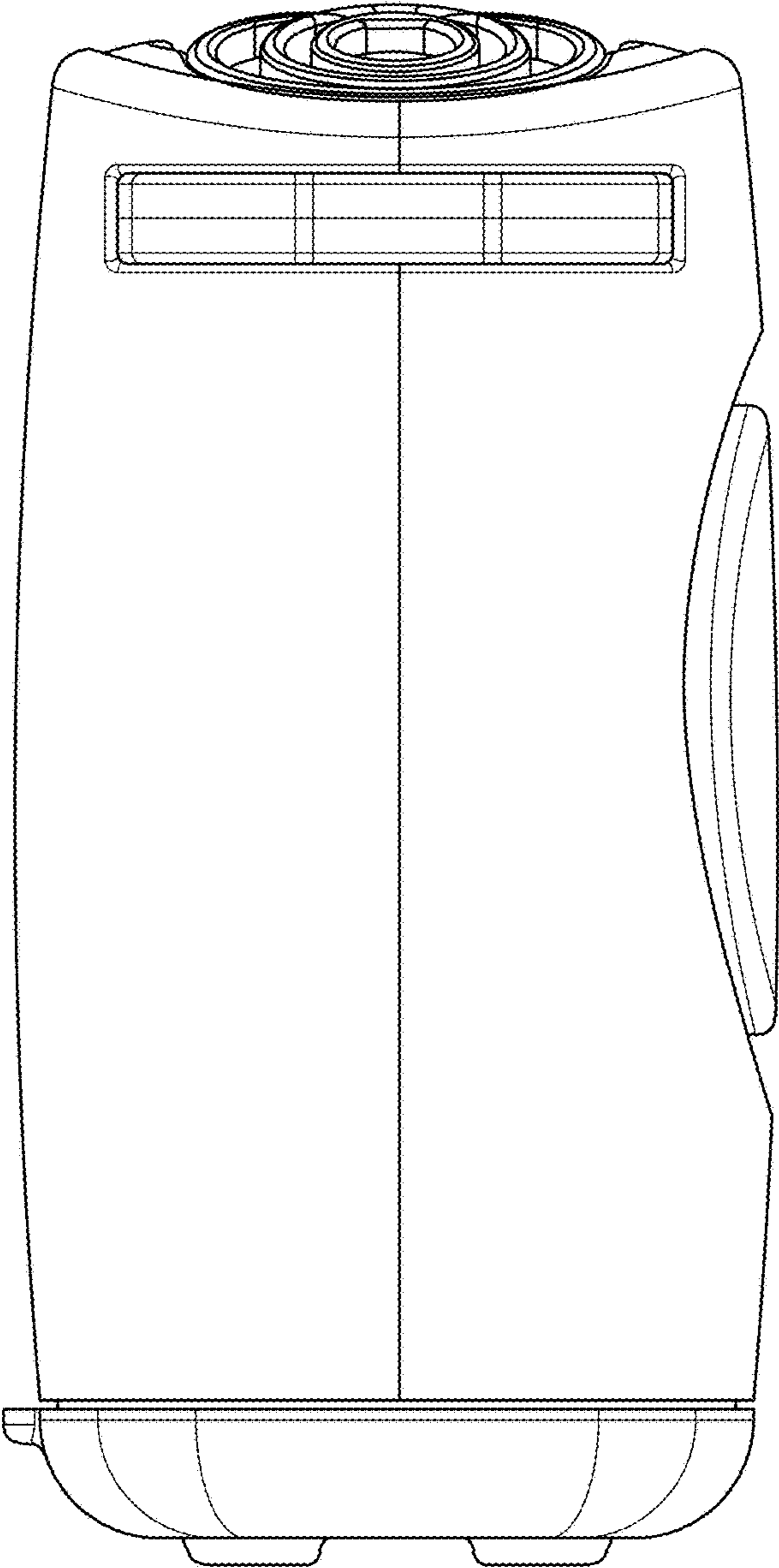
FIG. 1.7 is a bottom plan view.

The broken lines shown in the Drawings represent unclaimed portions of the air freshener and form no part of the claimed design.

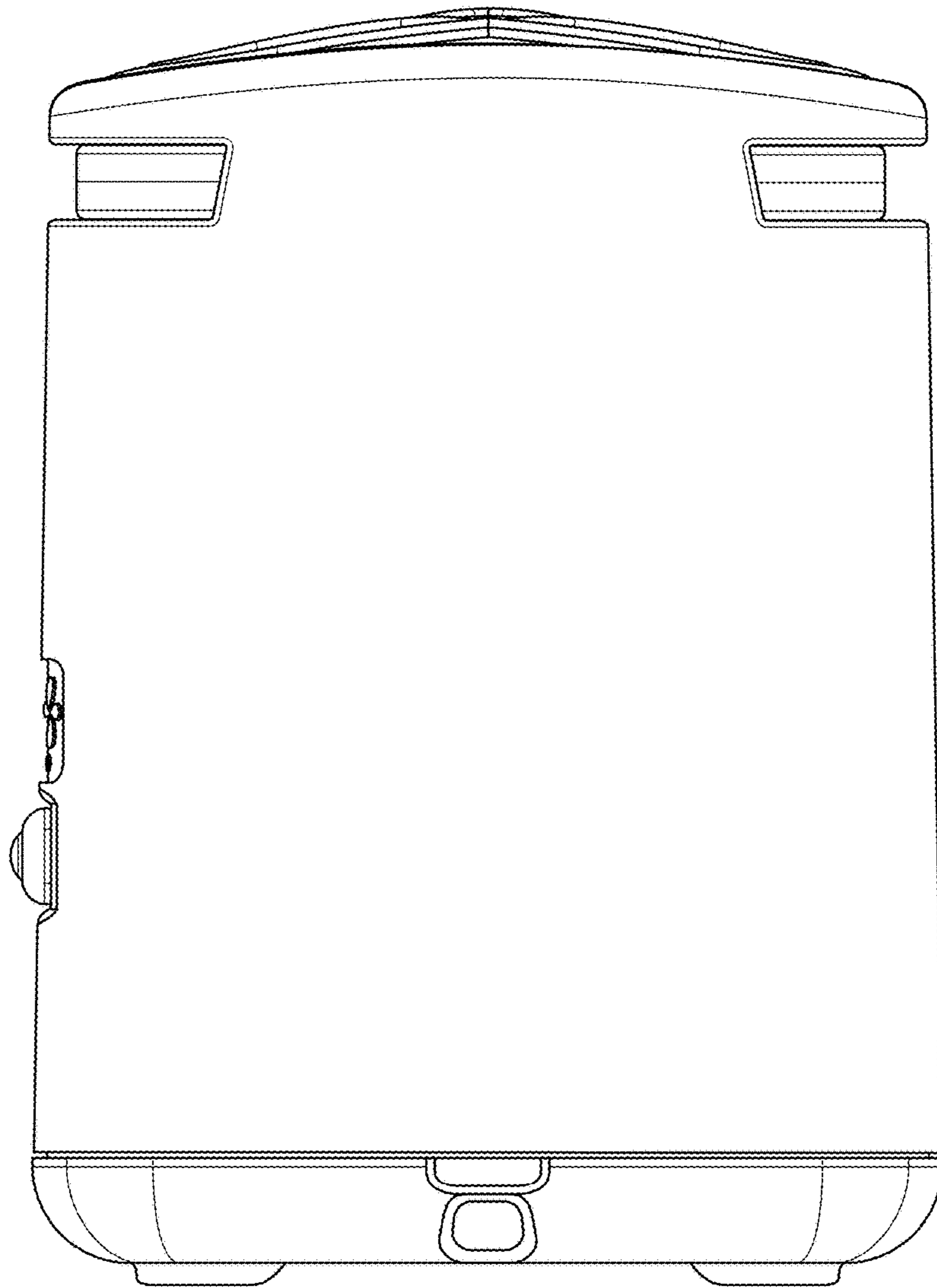

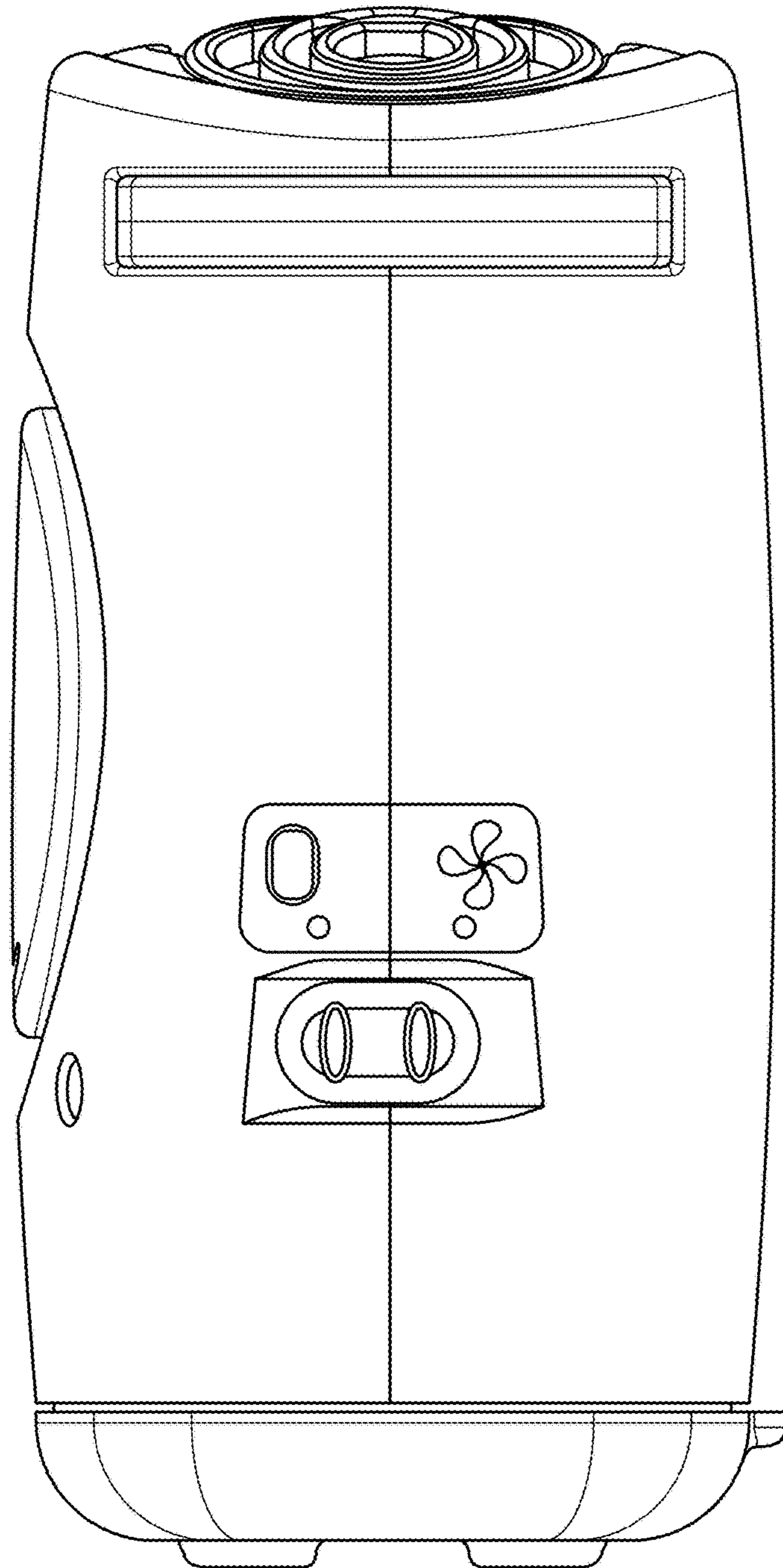

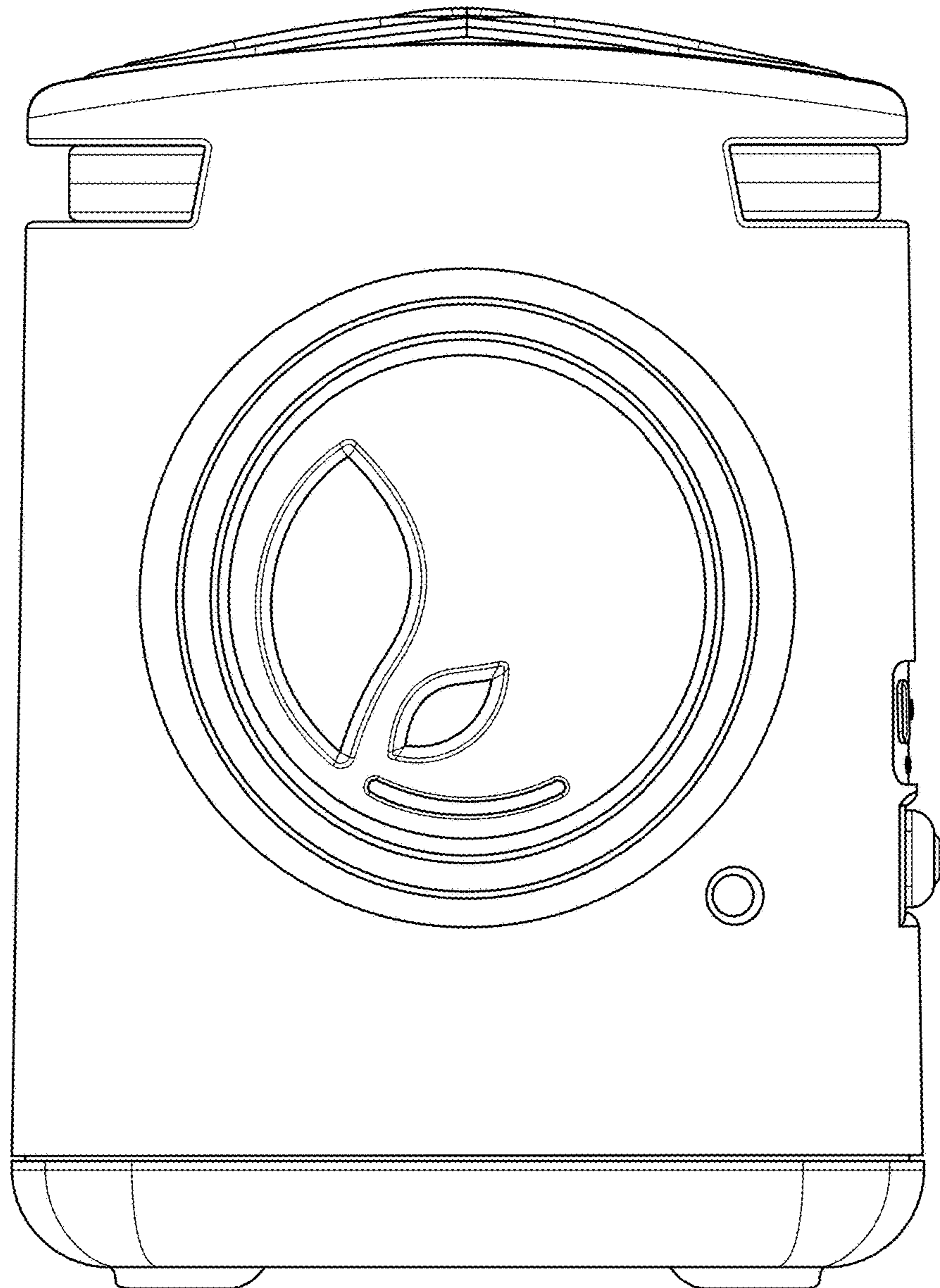

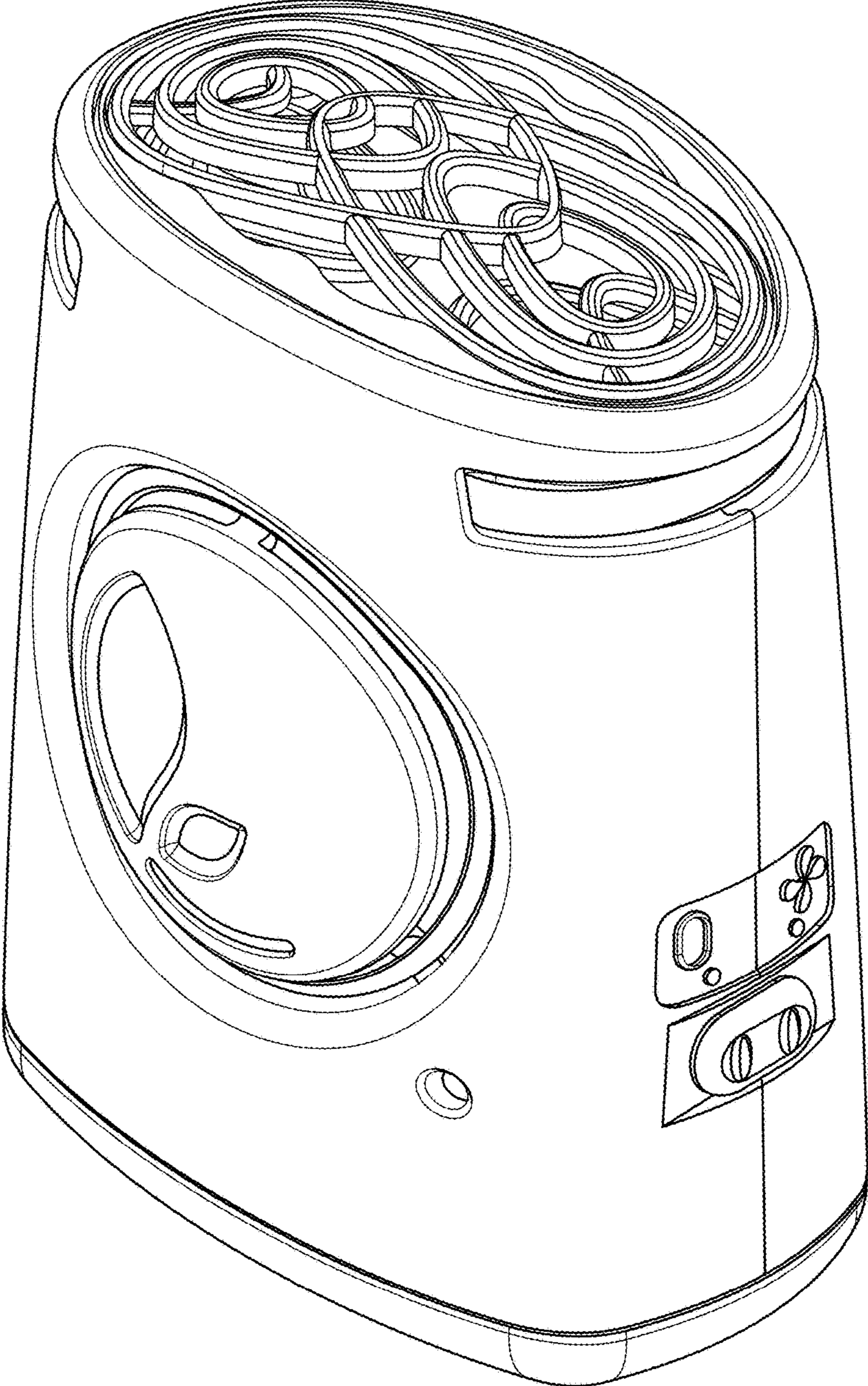

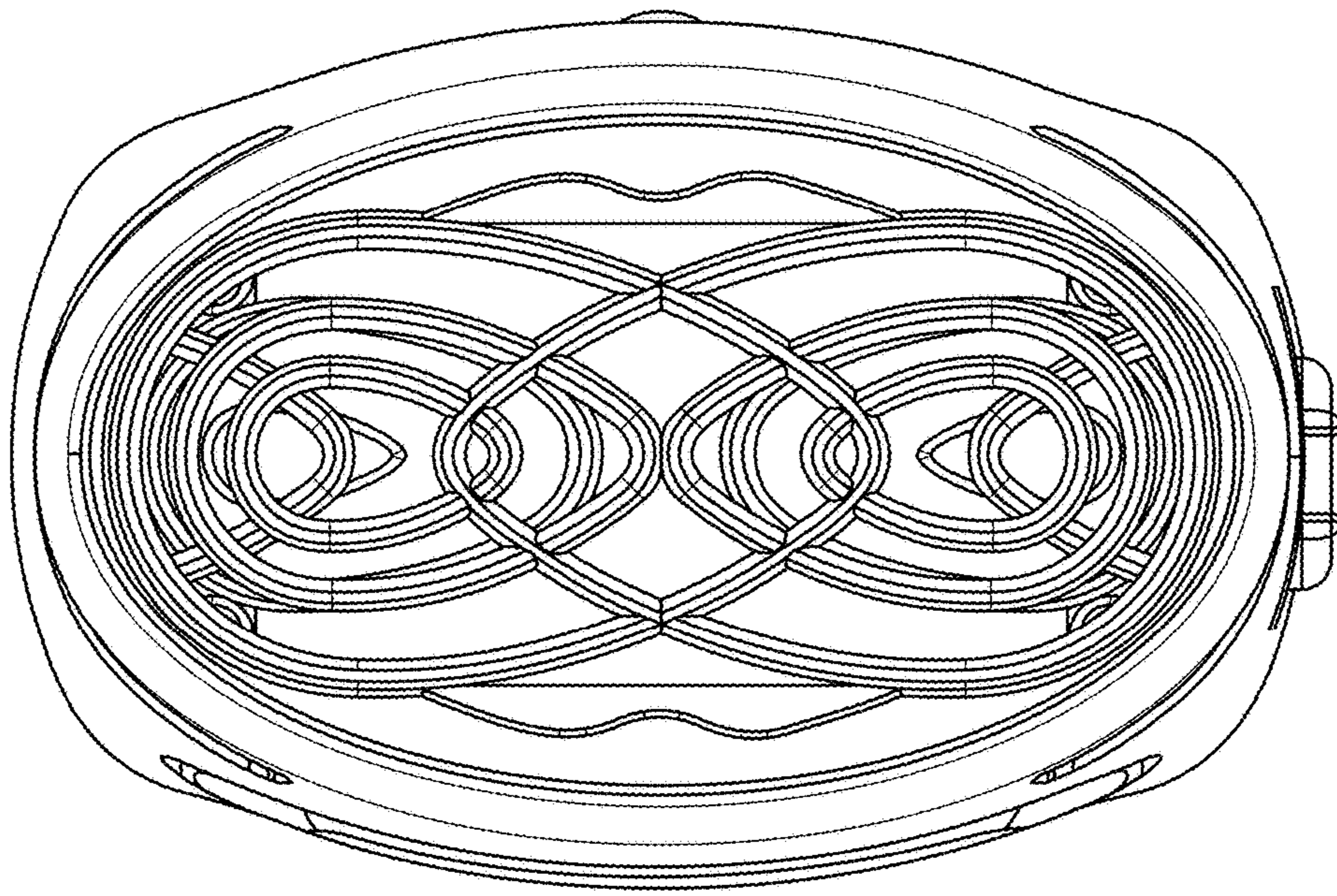
