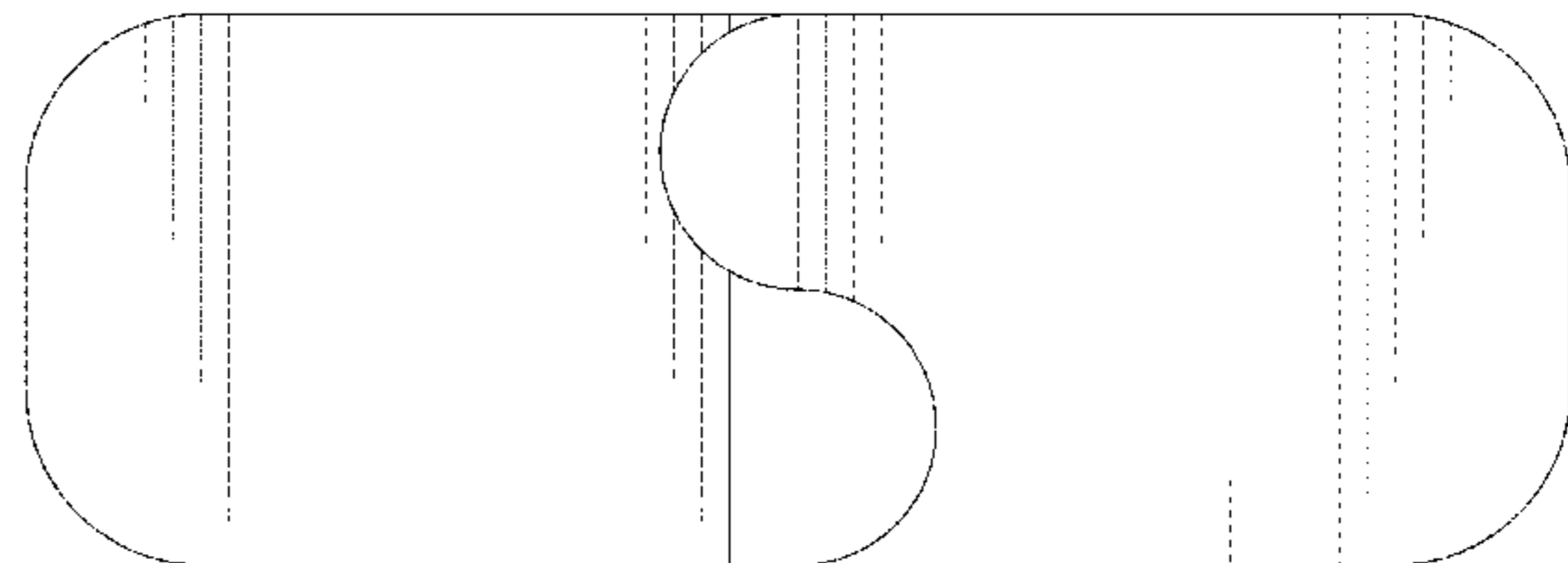
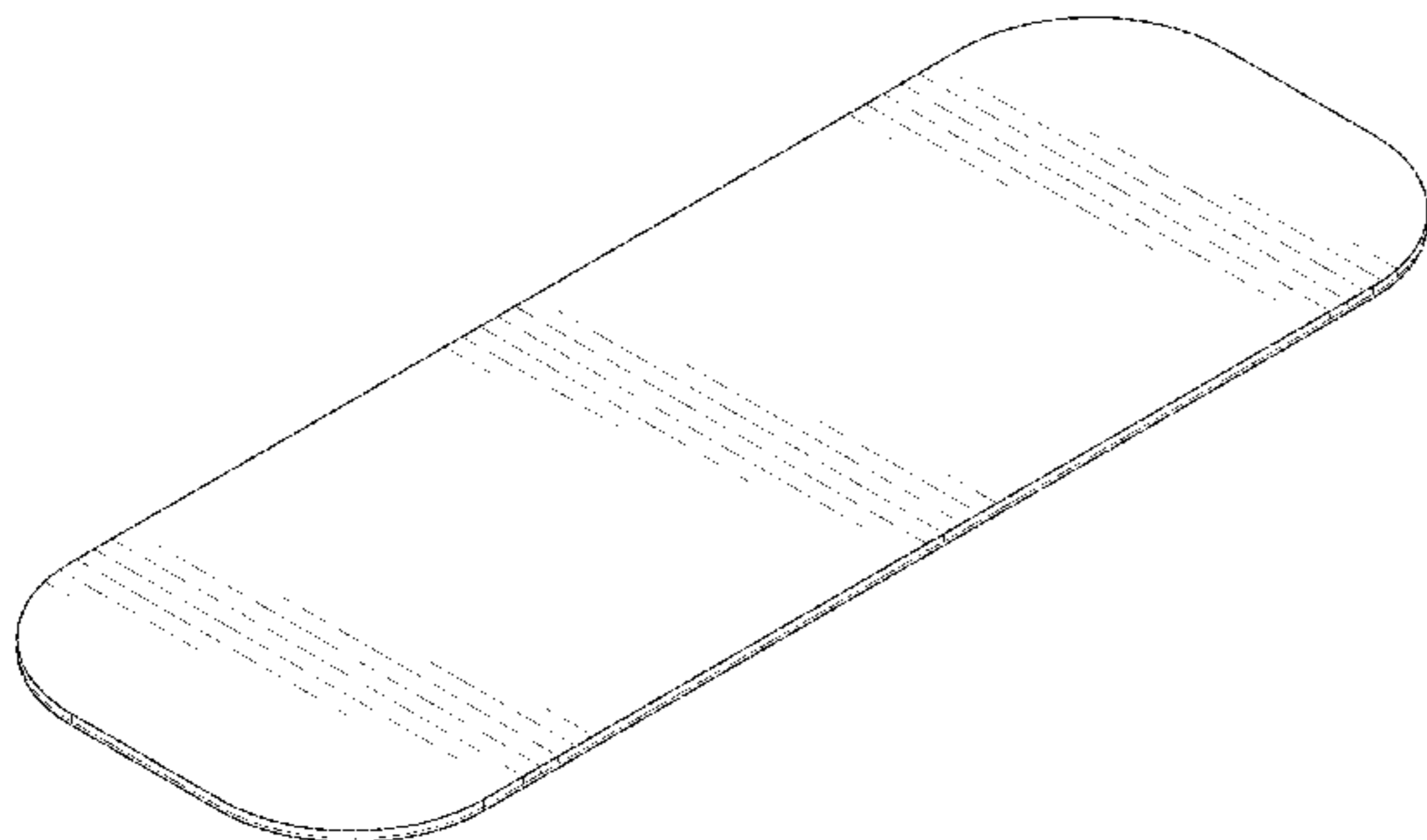
(57) **CLAIM**

The ornamental design for an adhesive tape with removable backing, as shown and described.

DESCRIPTION

FIG. 1 is an upper perspective view of adhesive tape with removable backing;
FIG. 2 is a top view of the adhesive tape with removable backing shown in FIG. 1;
FIG. 3 is a bottom view of the adhesive tape with removable backing shown in FIG. 1;

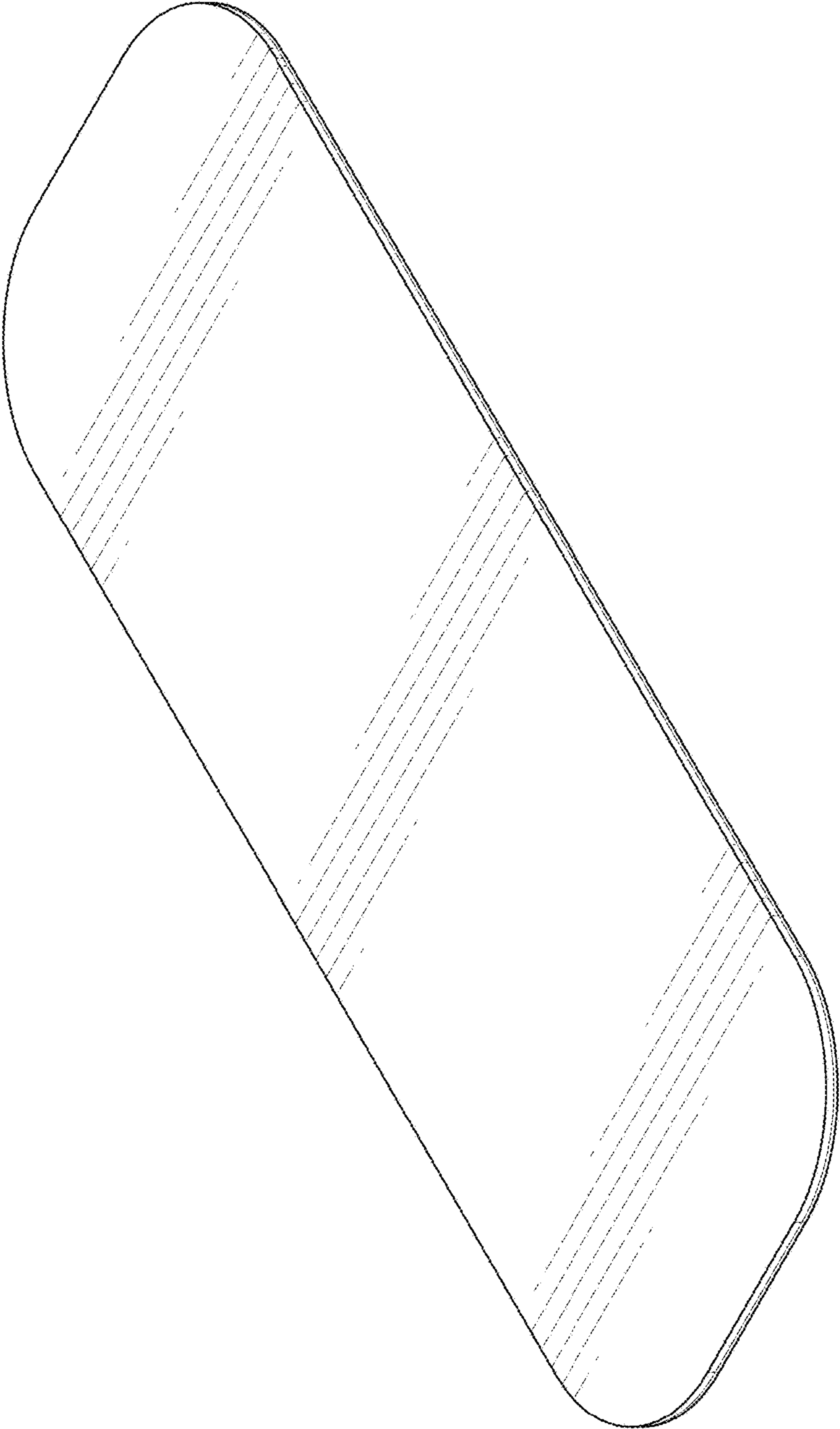

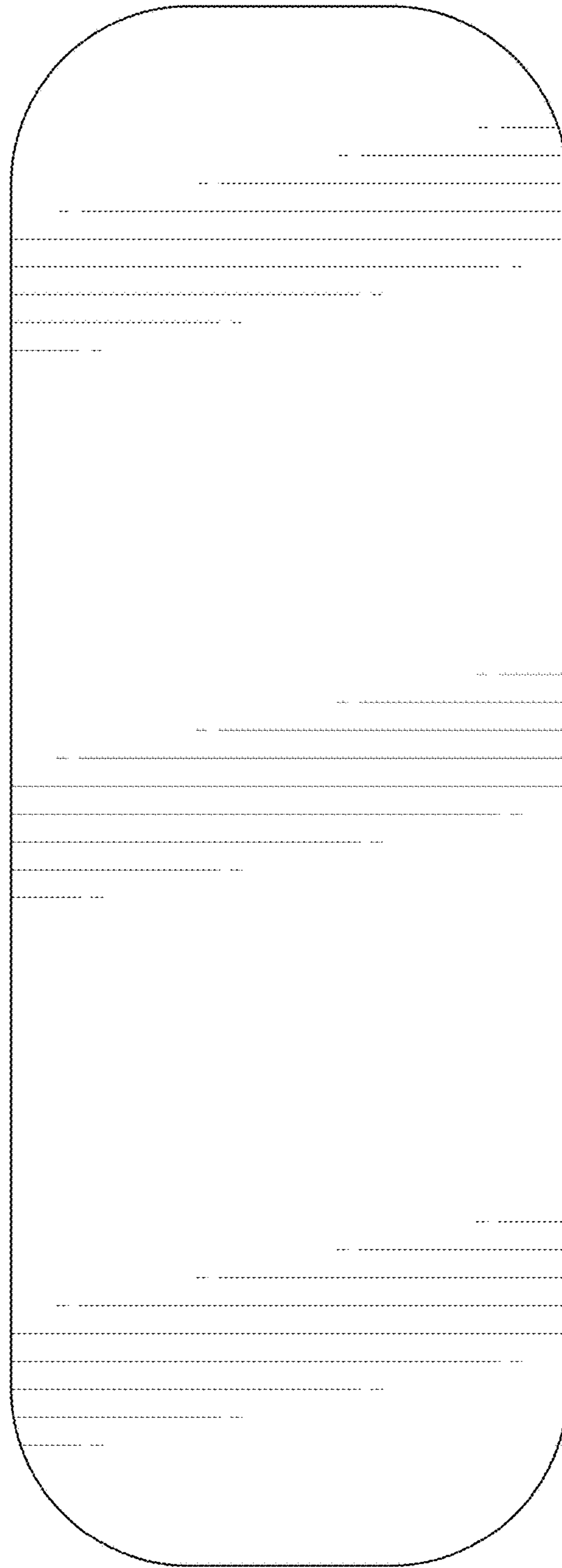

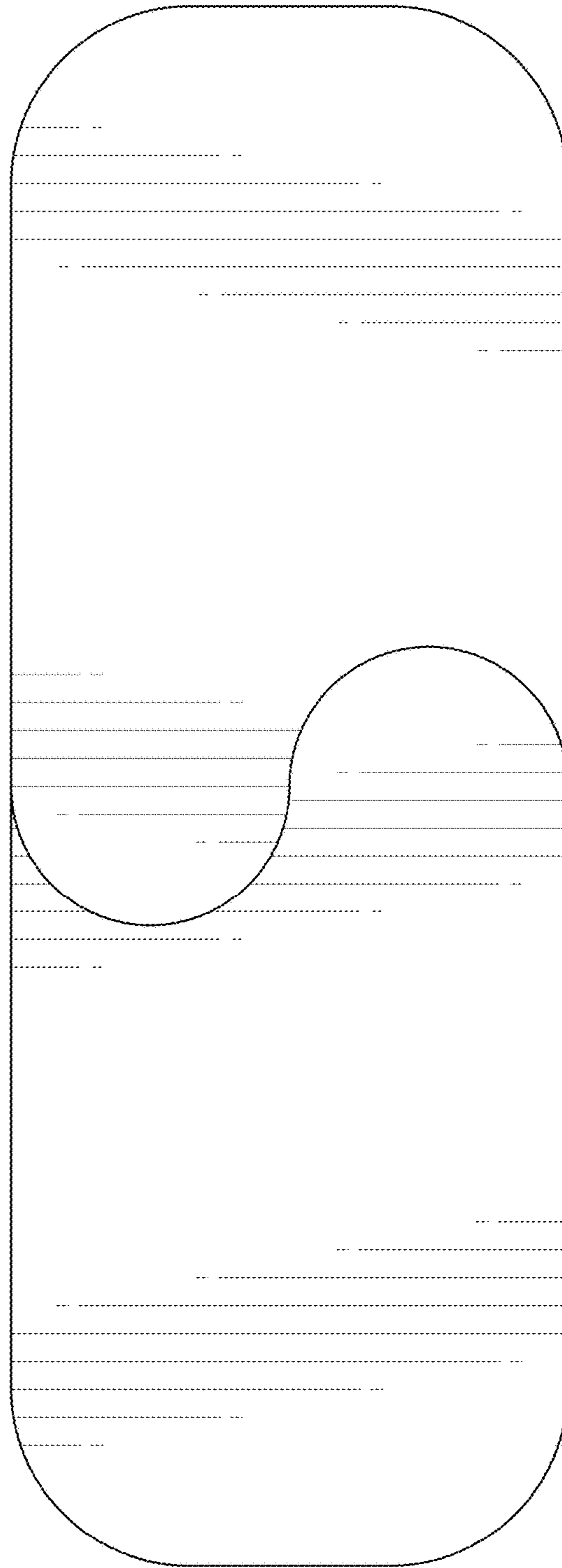

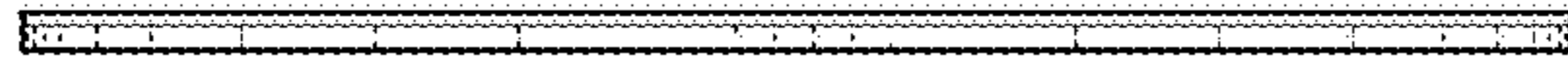

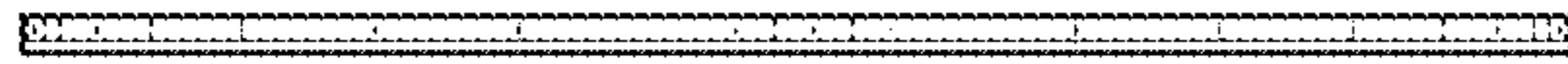

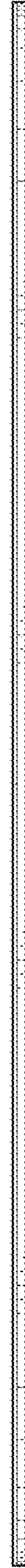

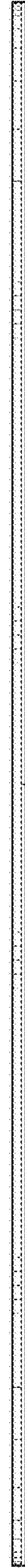
