shown.

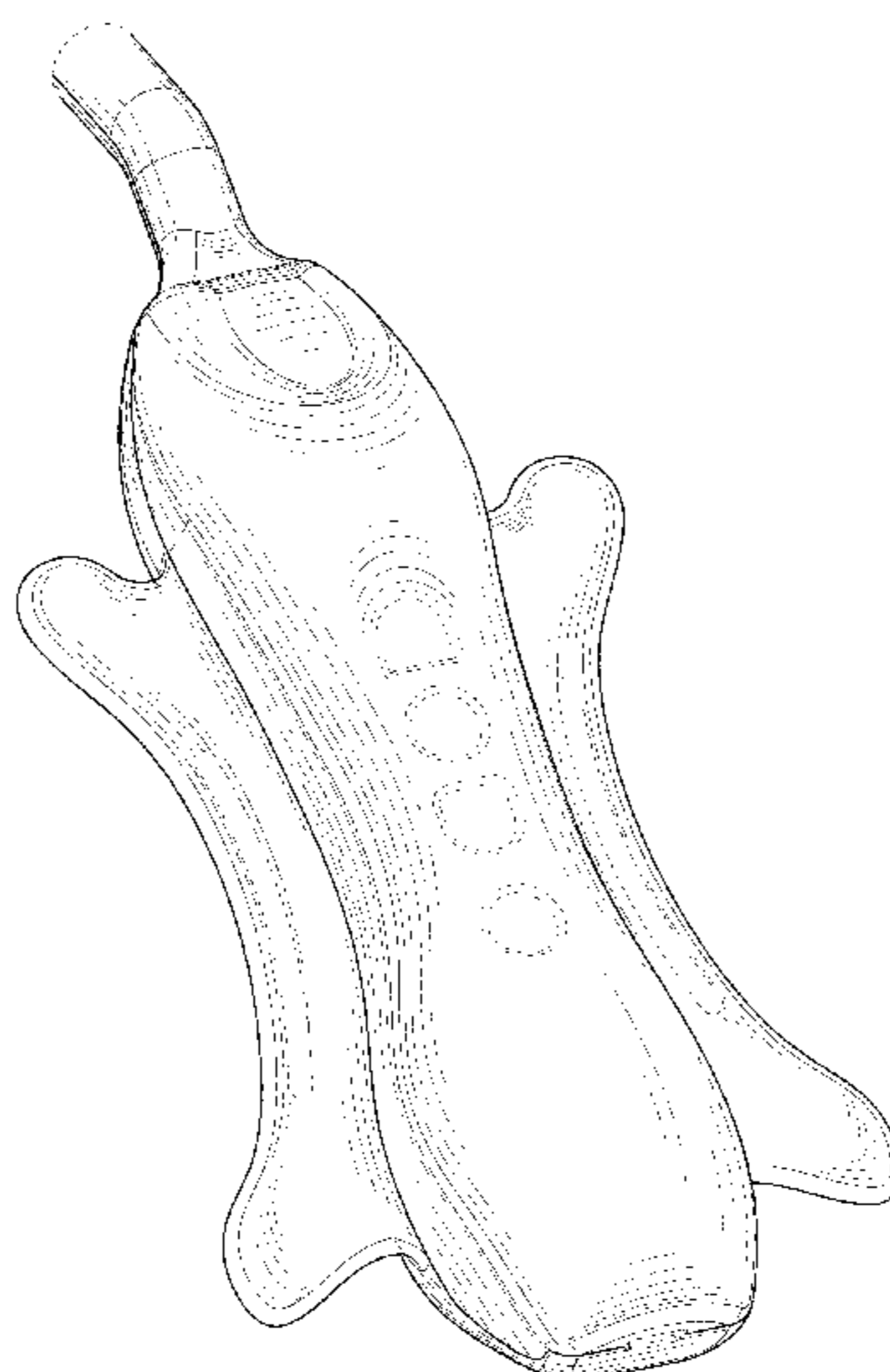
**DESCRIPTION**

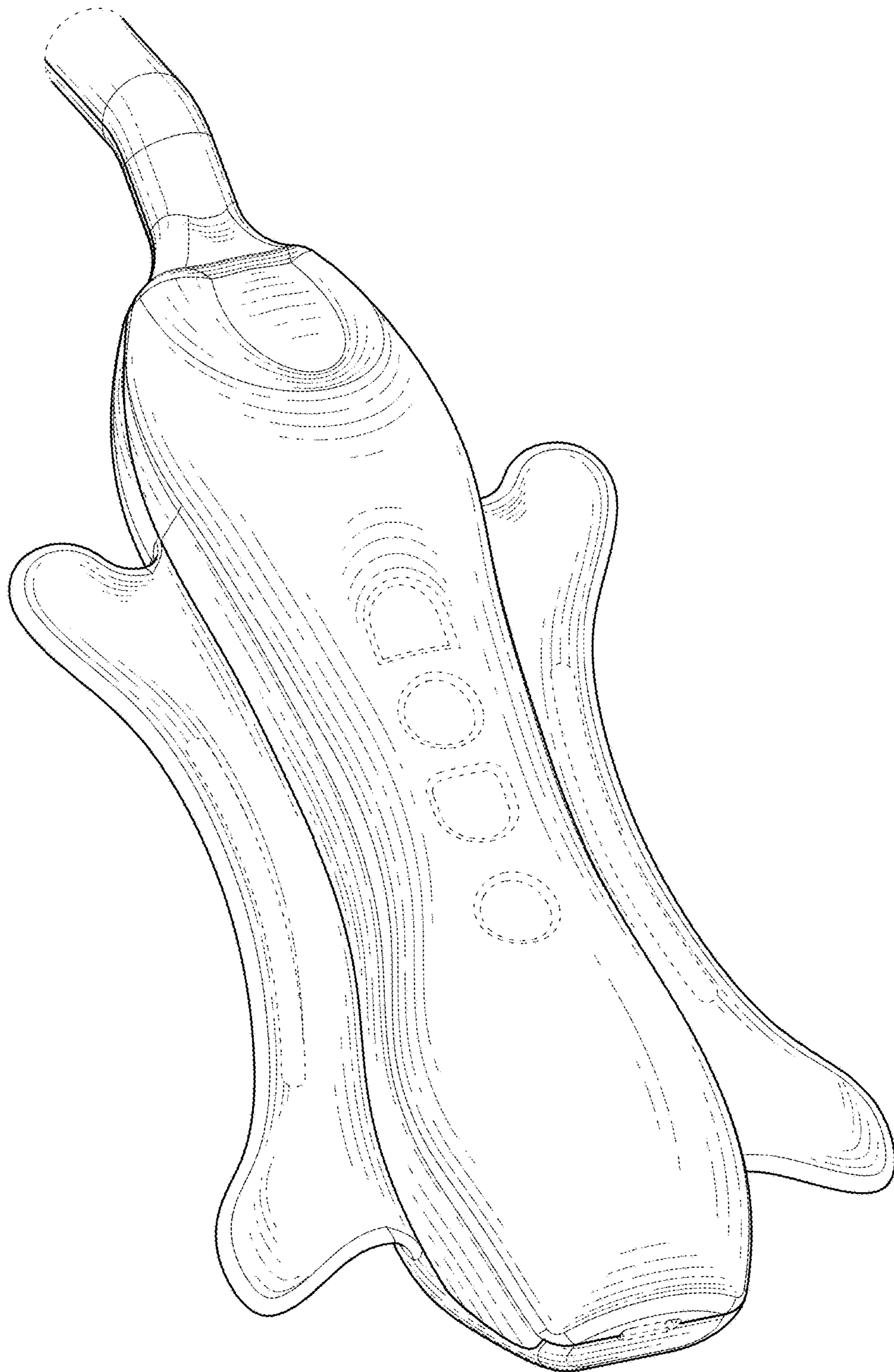

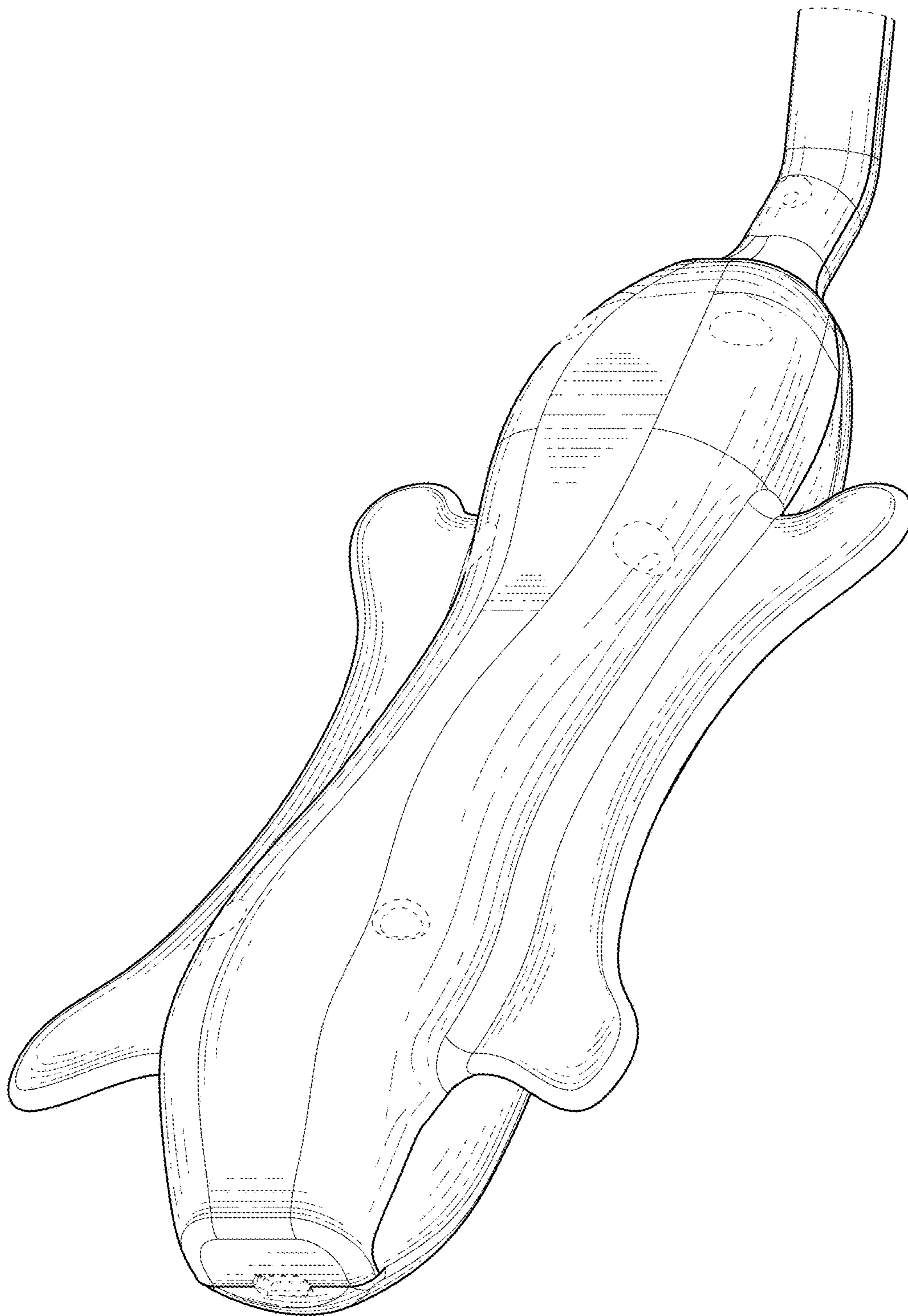
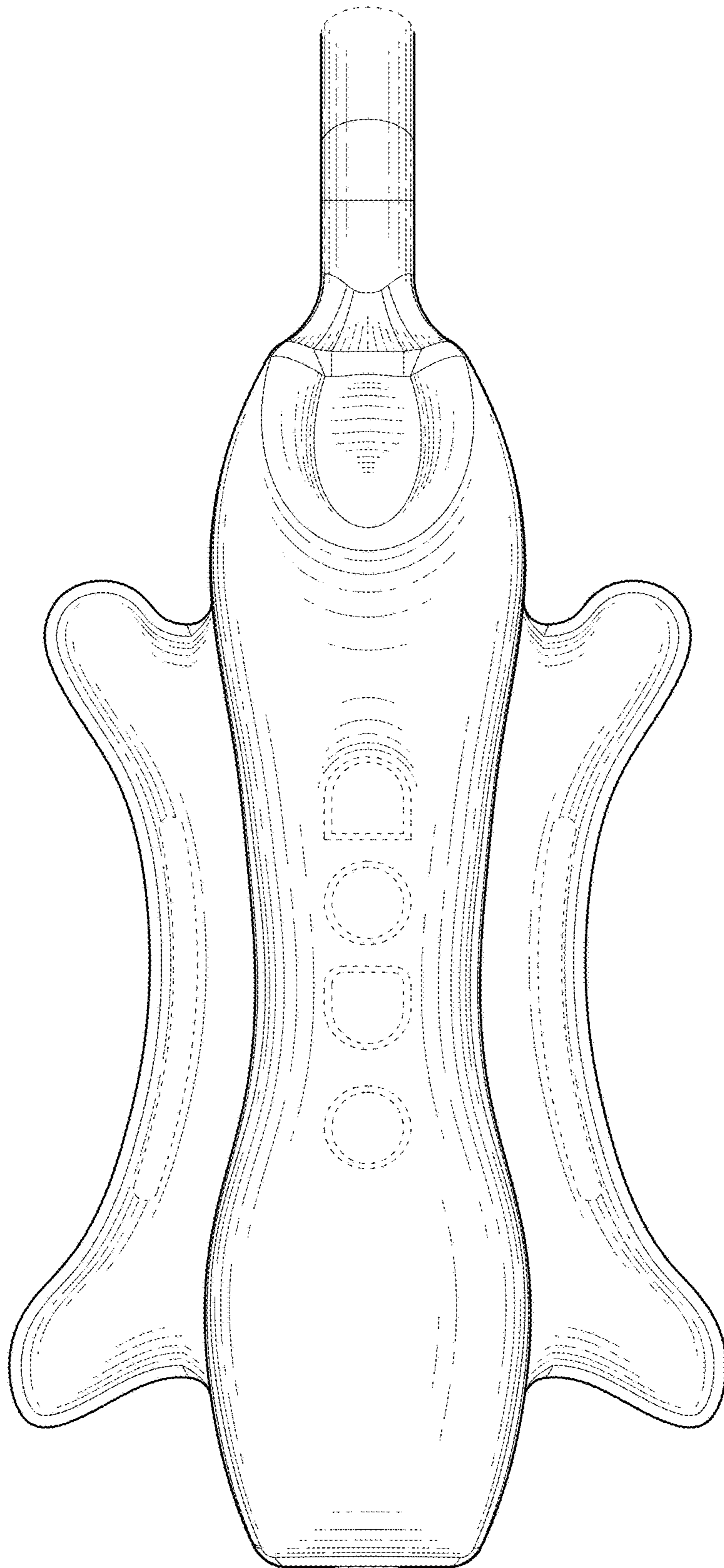
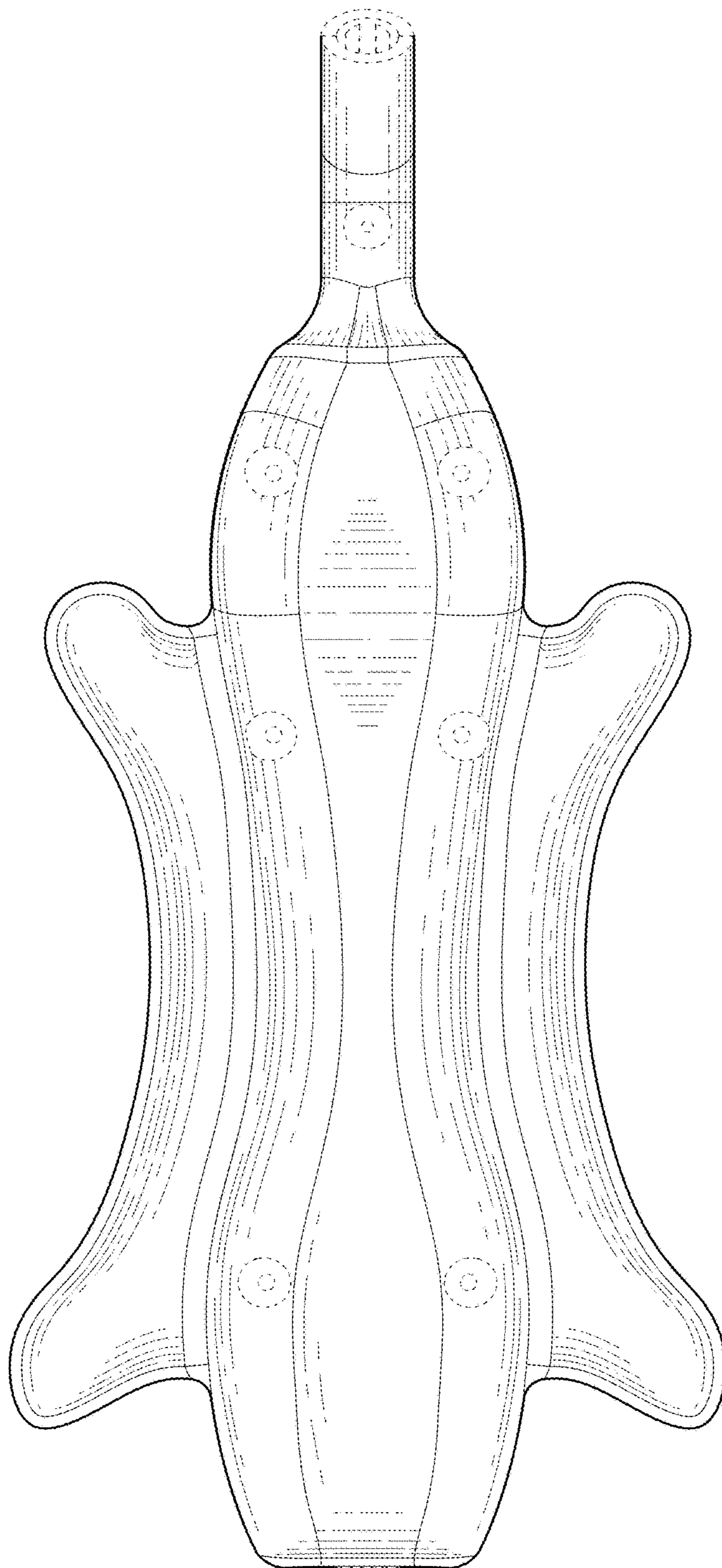


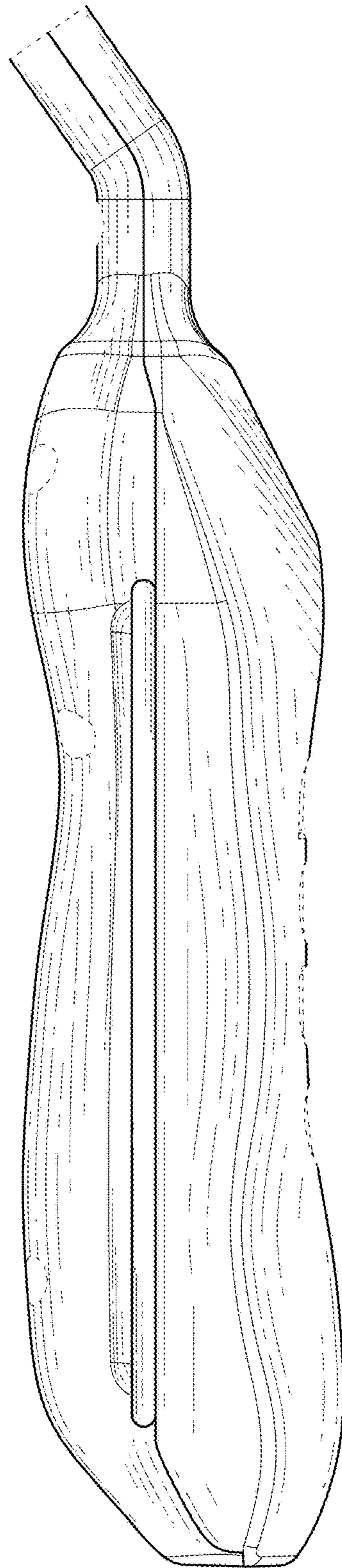

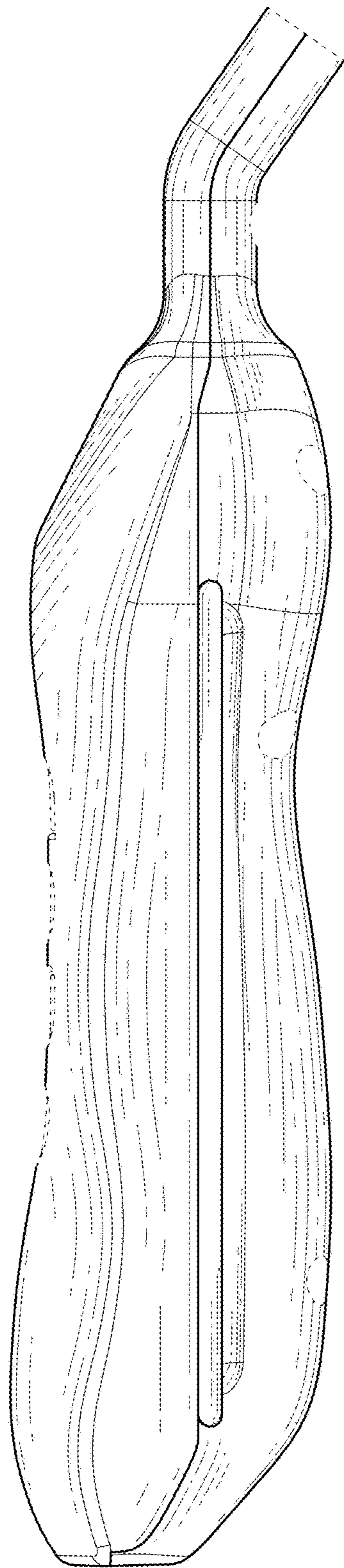

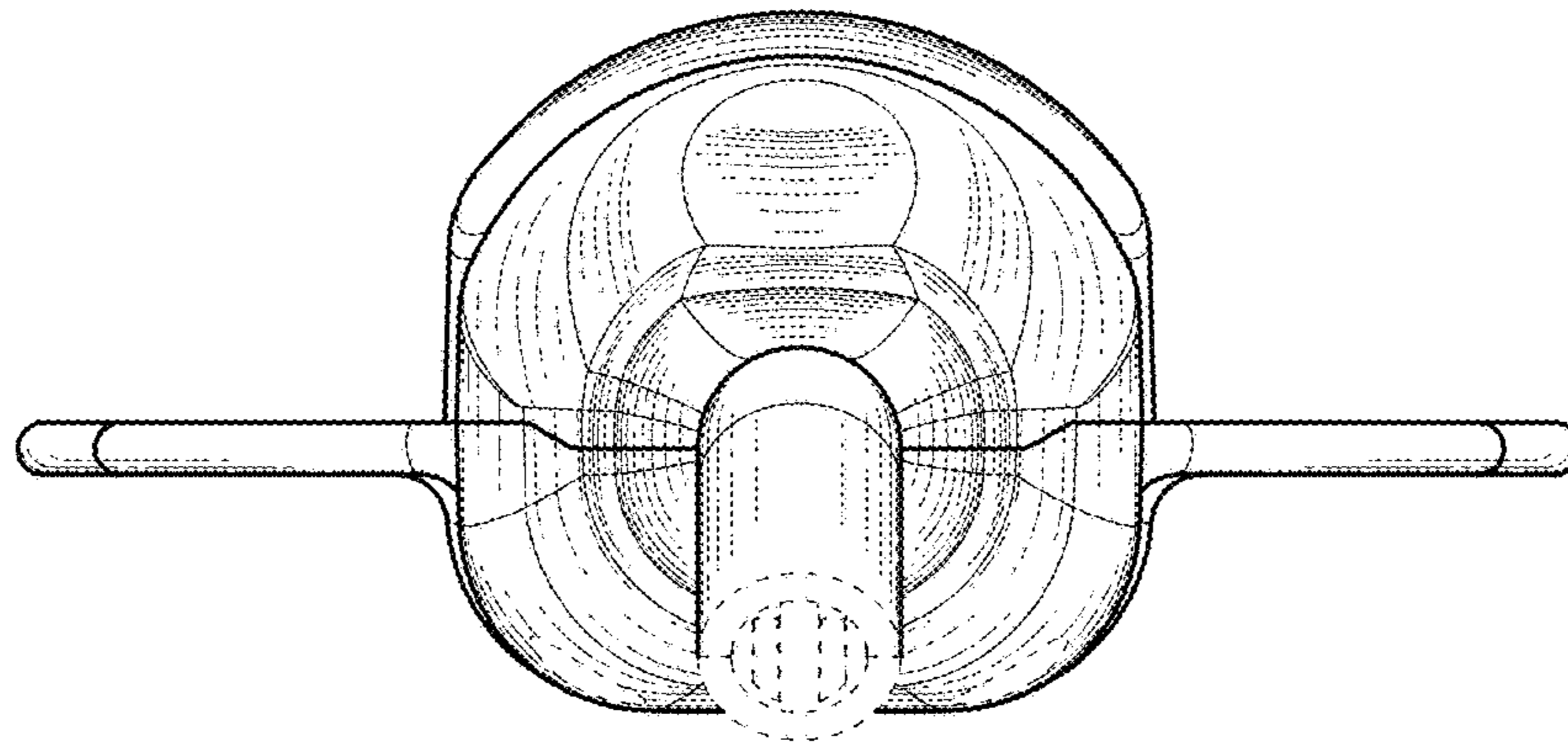

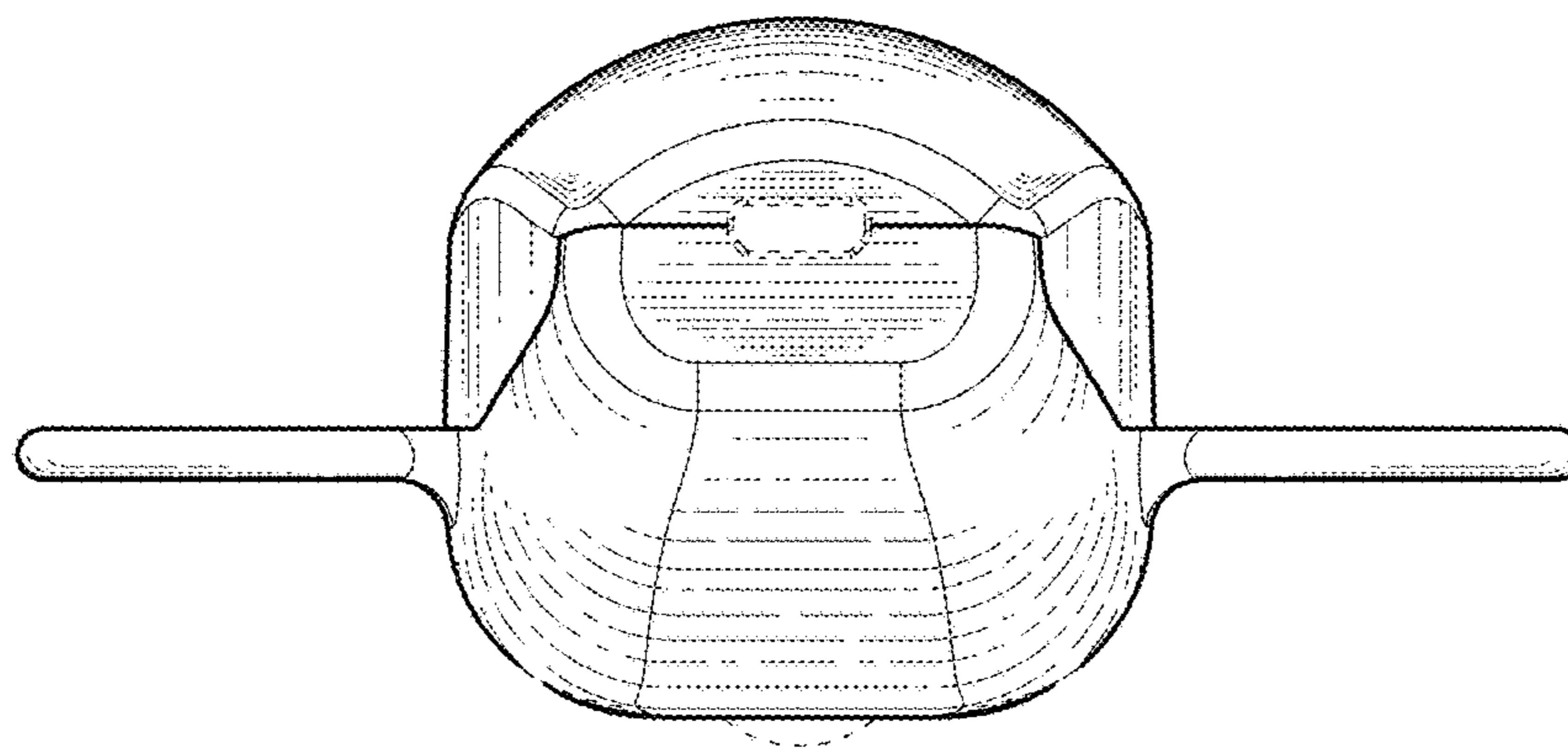
