1.3: Top

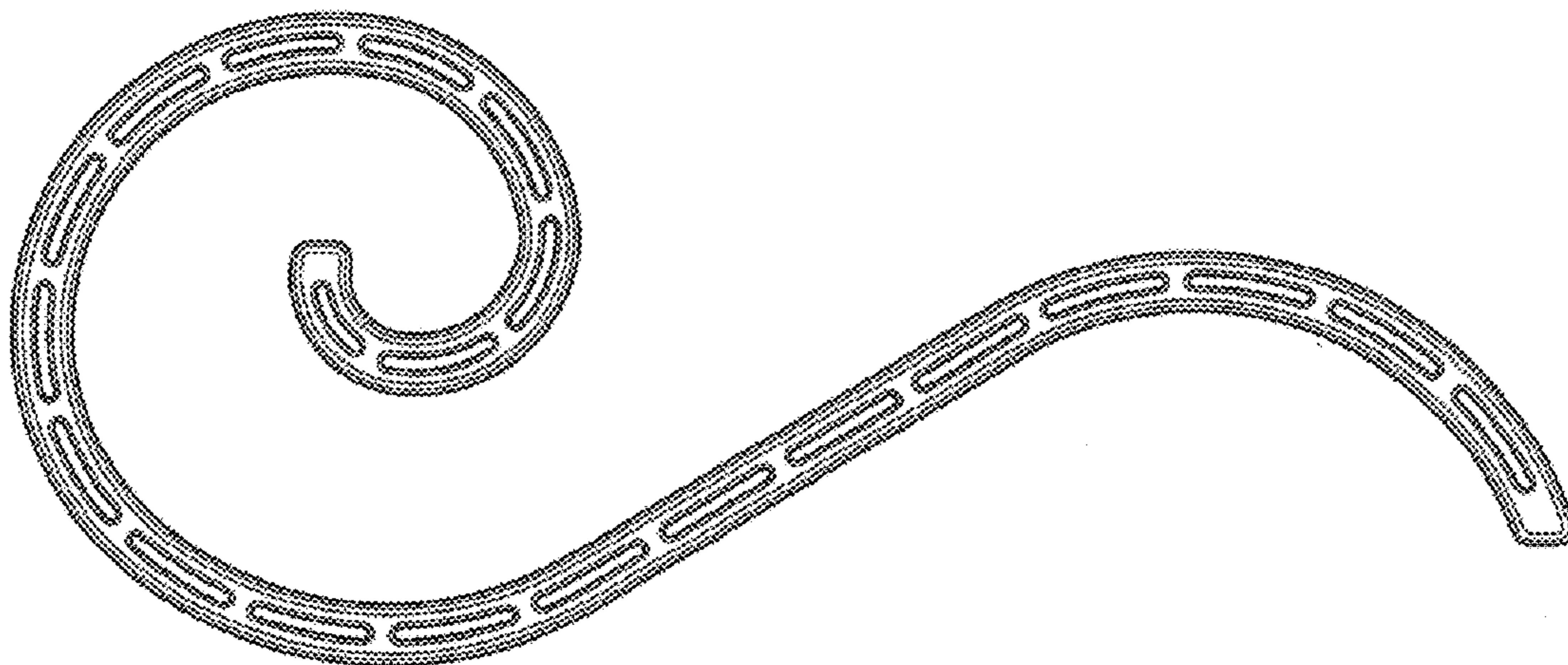
1.4: Bottom

1.5: Right

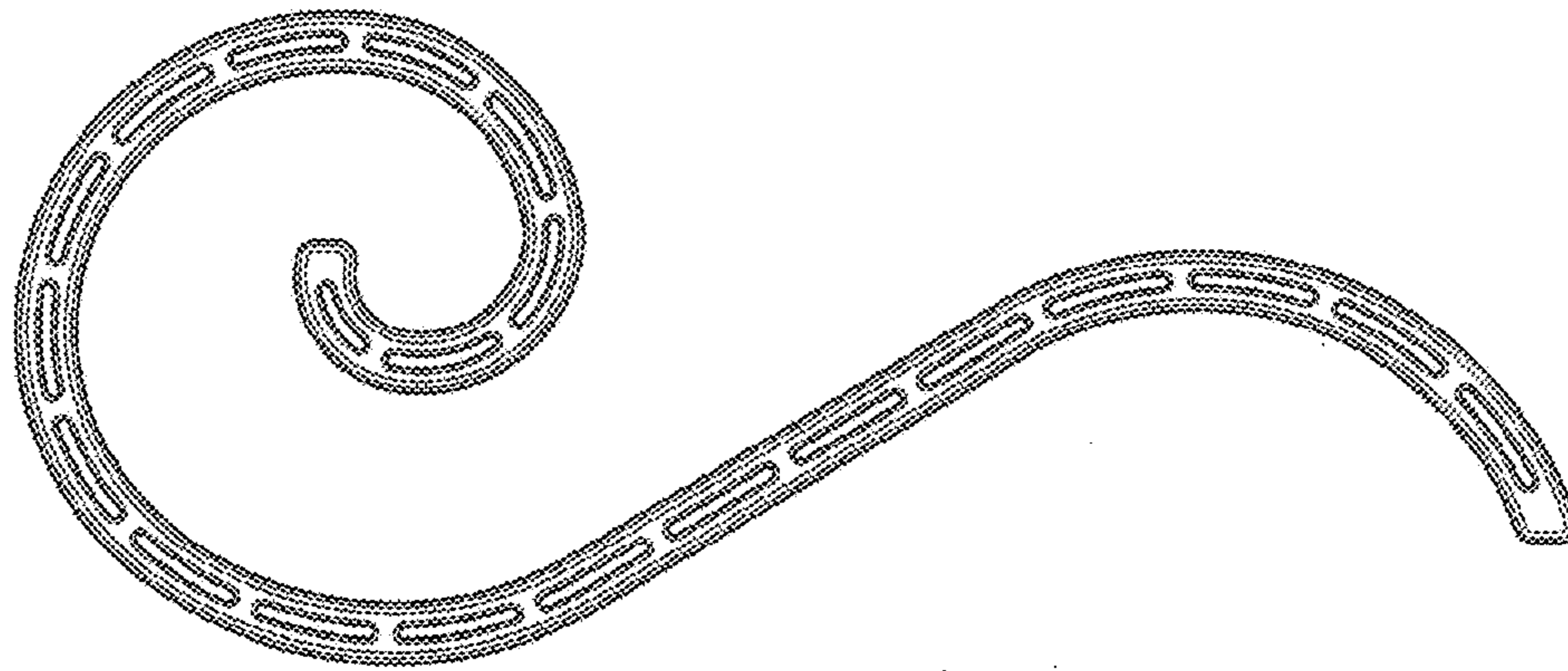
1.6: Left

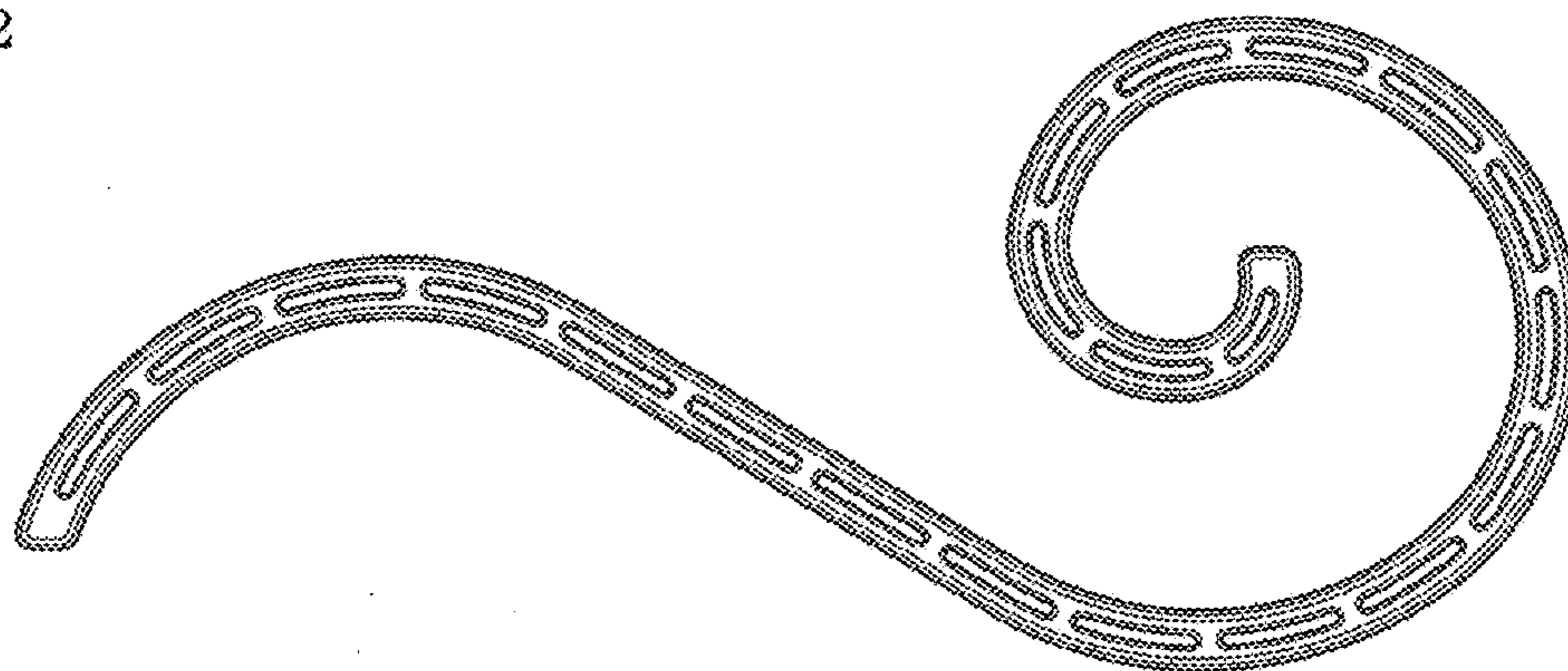

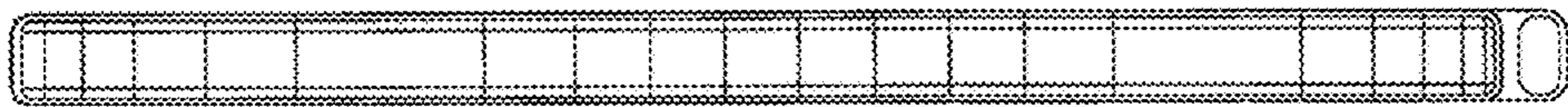

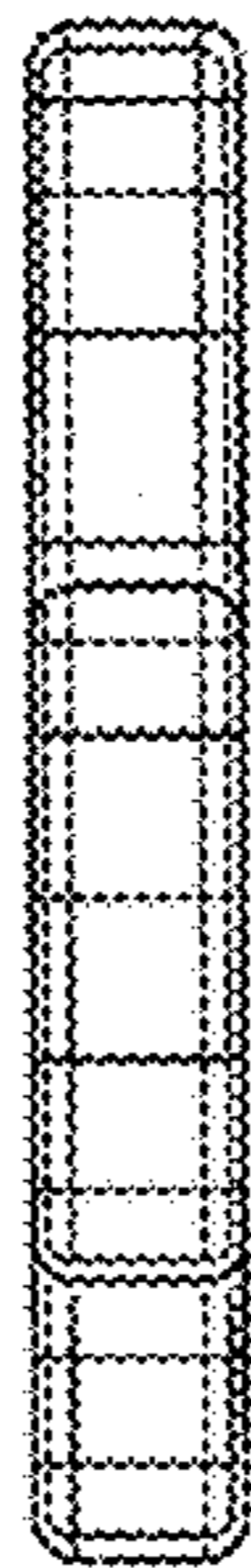
