(57) **CLAIM**

The ornamental design for a tray for dental instruments and components with protective case, as shown and described.

DESCRIPTION

FIG. 1 is an exploded view of a tray for dental instruments and components with protective case, comprising a top portion of the protective case, a face plate, a tray for dental instruments and components, and a bottom portion of the protective case, showing our new design.

FIG. 2 is a rear elevational view of the tray for dental instruments and components with protective case when assembled.

FIG. 3 is a front elevational view thereof.

FIG. 4 is a top perspective view thereof.

FIG. 5 is a left side elevational view thereof.

FIG. 6 is a right side elevational view thereof.

FIG. 7 is a top plan thereof.

FIG. 8 is a bottom plan view of the face plate portion of a tray for dental instruments and components with protective case, shown separately to disclose details of the article not otherwise discernible from the drawings.

FIG. 9 is top plan view thereof.

FIG. 10 is a top perspective view thereof.

FIG. 11 is a front elevational view thereof.

FIG. 12 is a left side elevational view thereof.

FIG. 13 is a rear elevational view thereof.

FIG. 14 is a right side elevational view thereof.

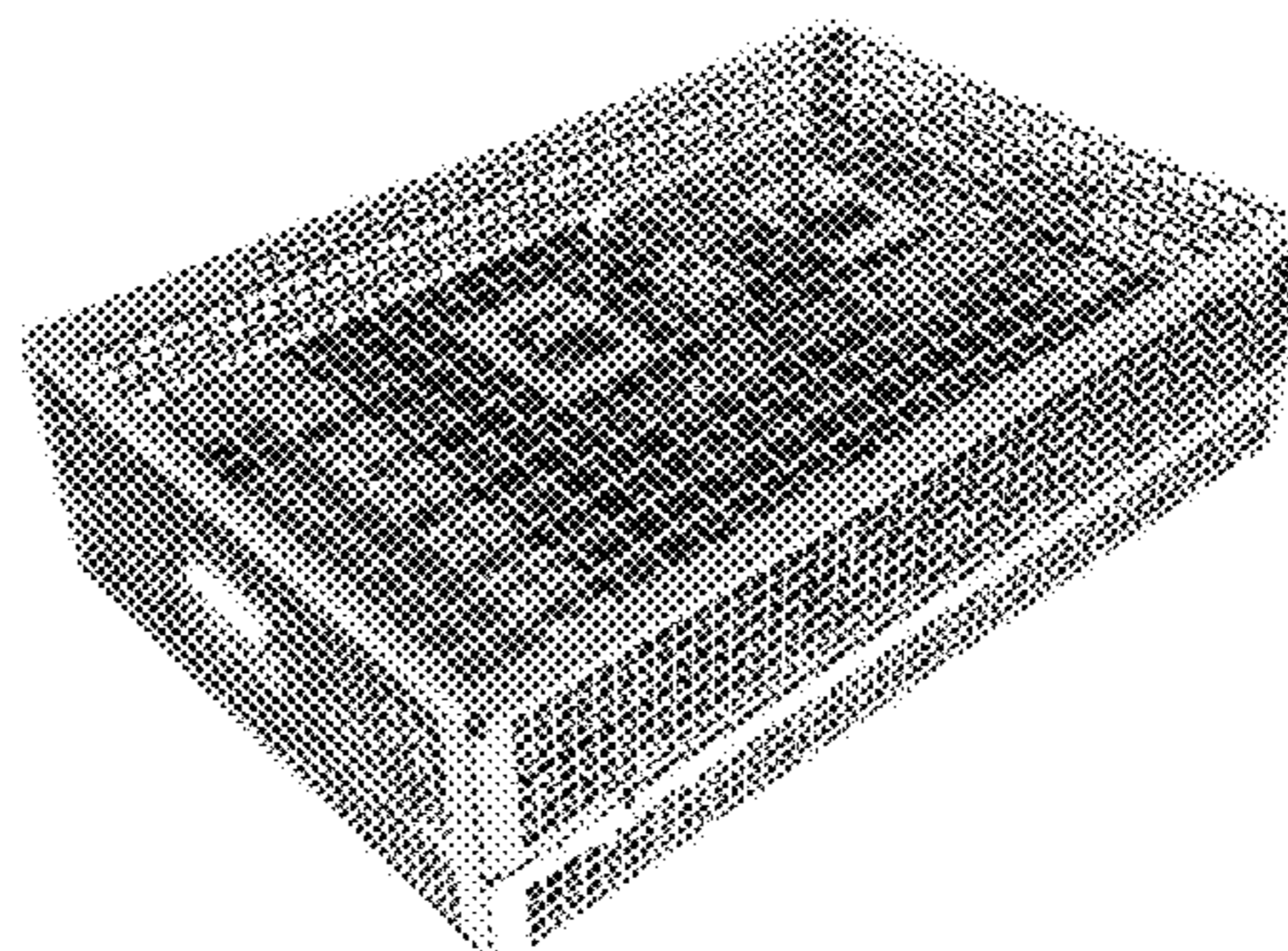
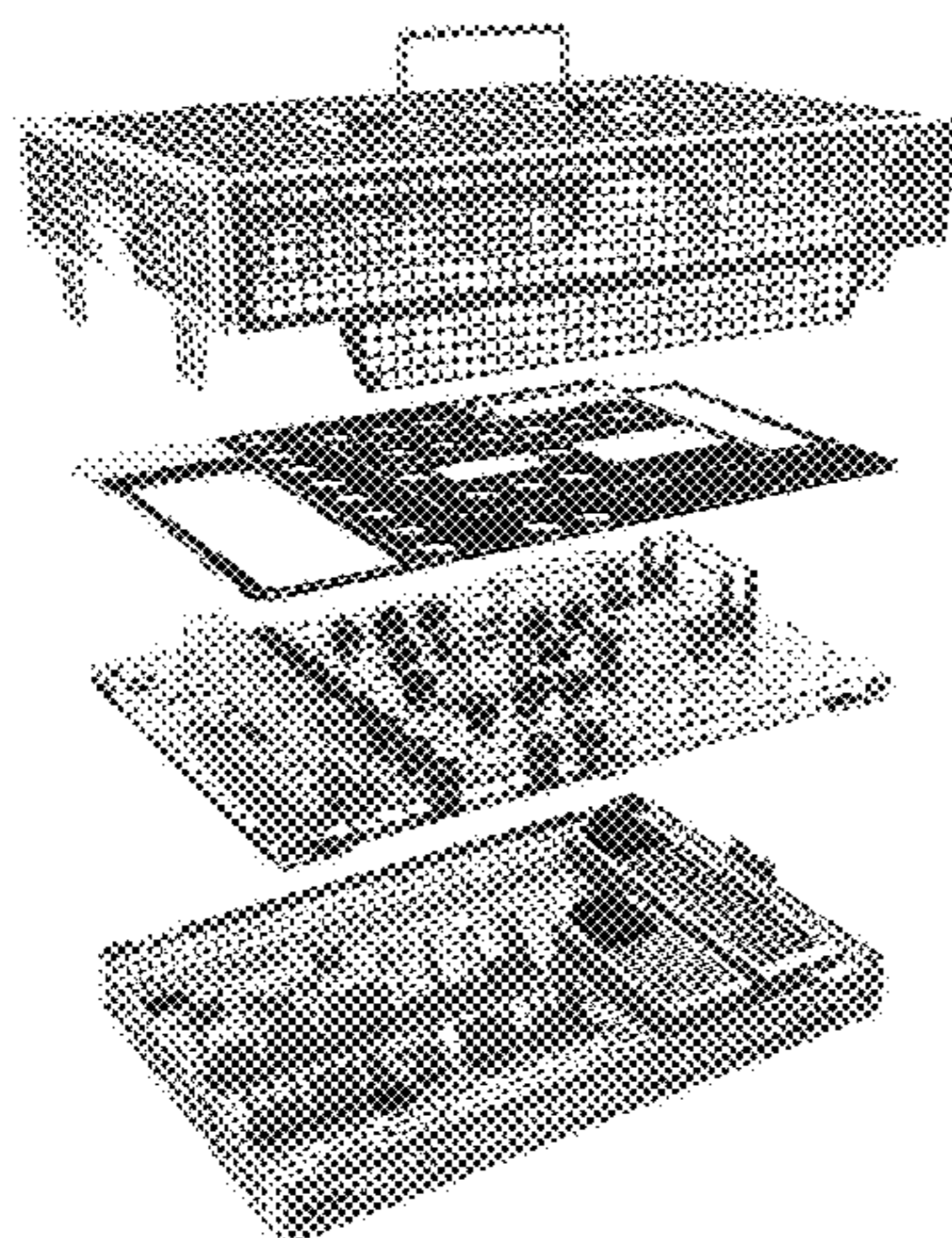

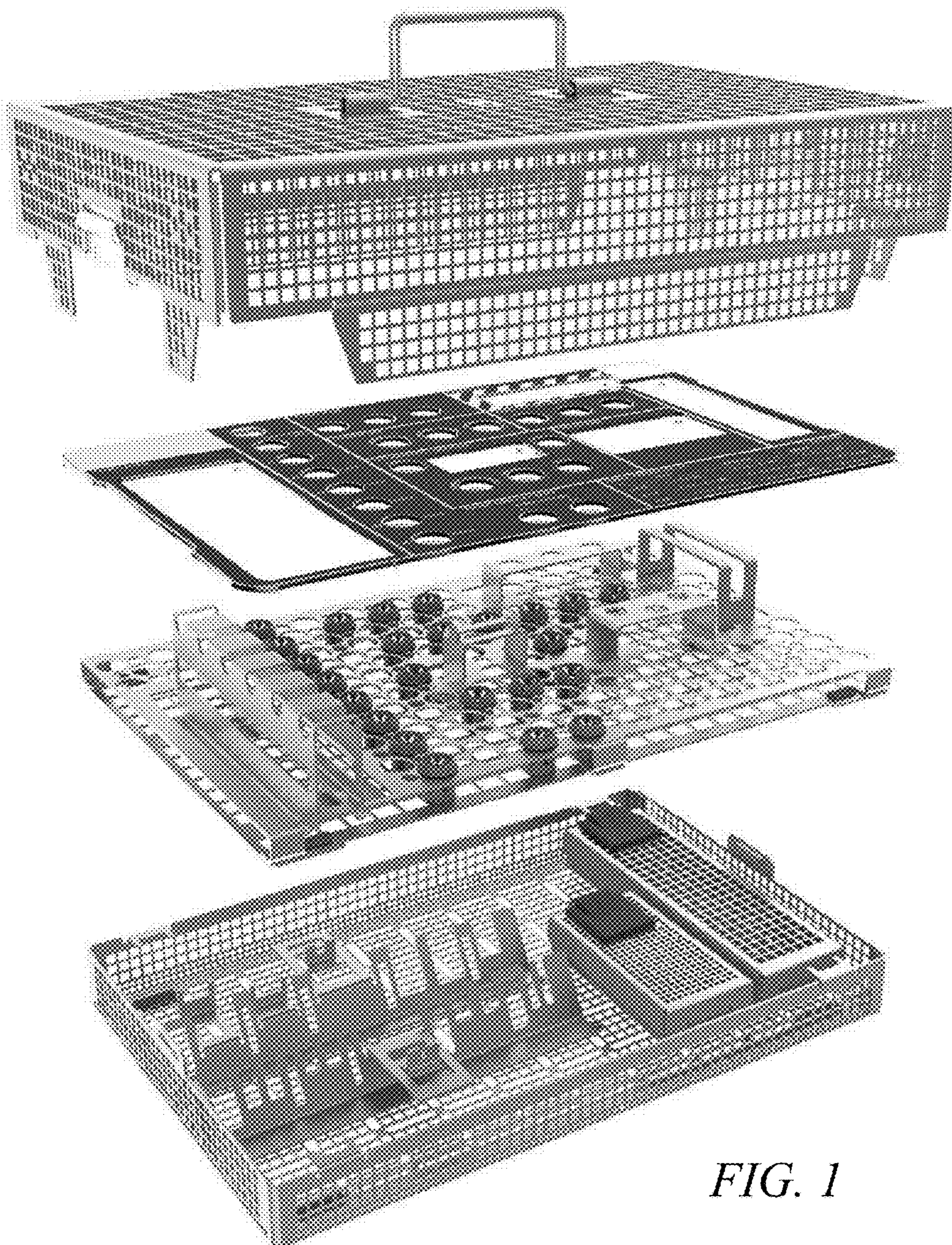

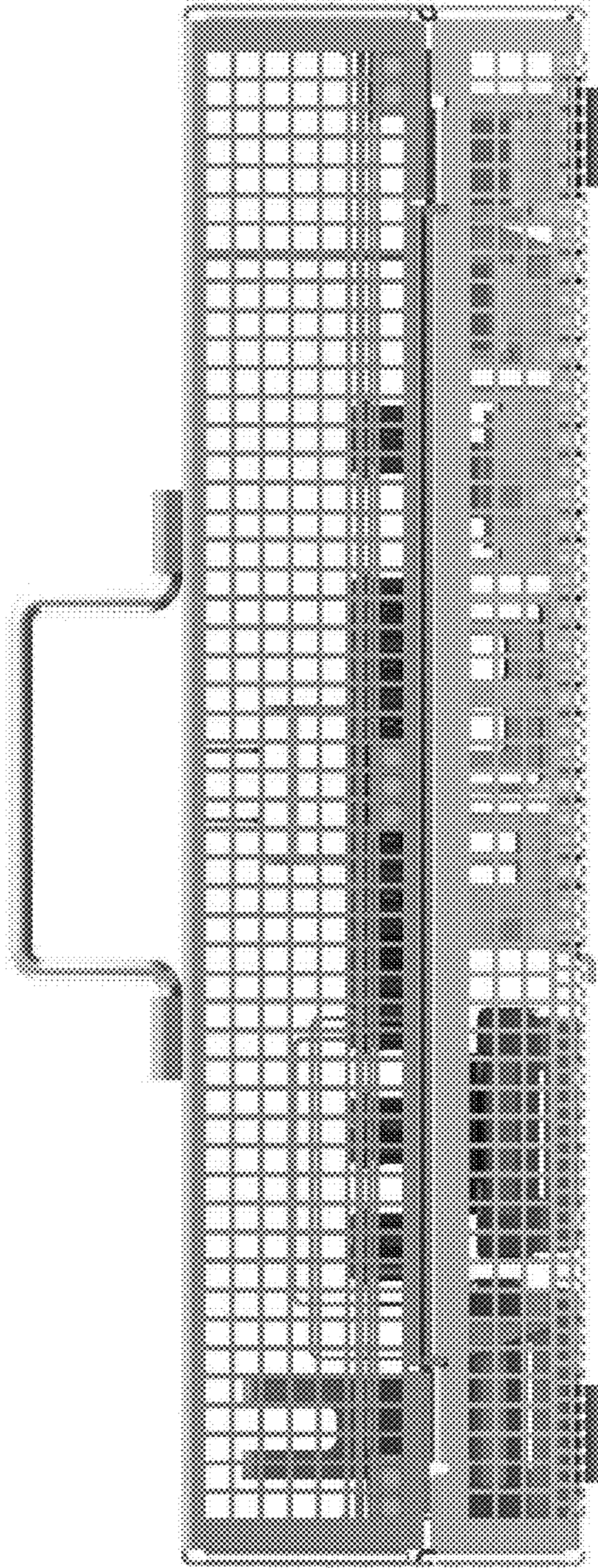

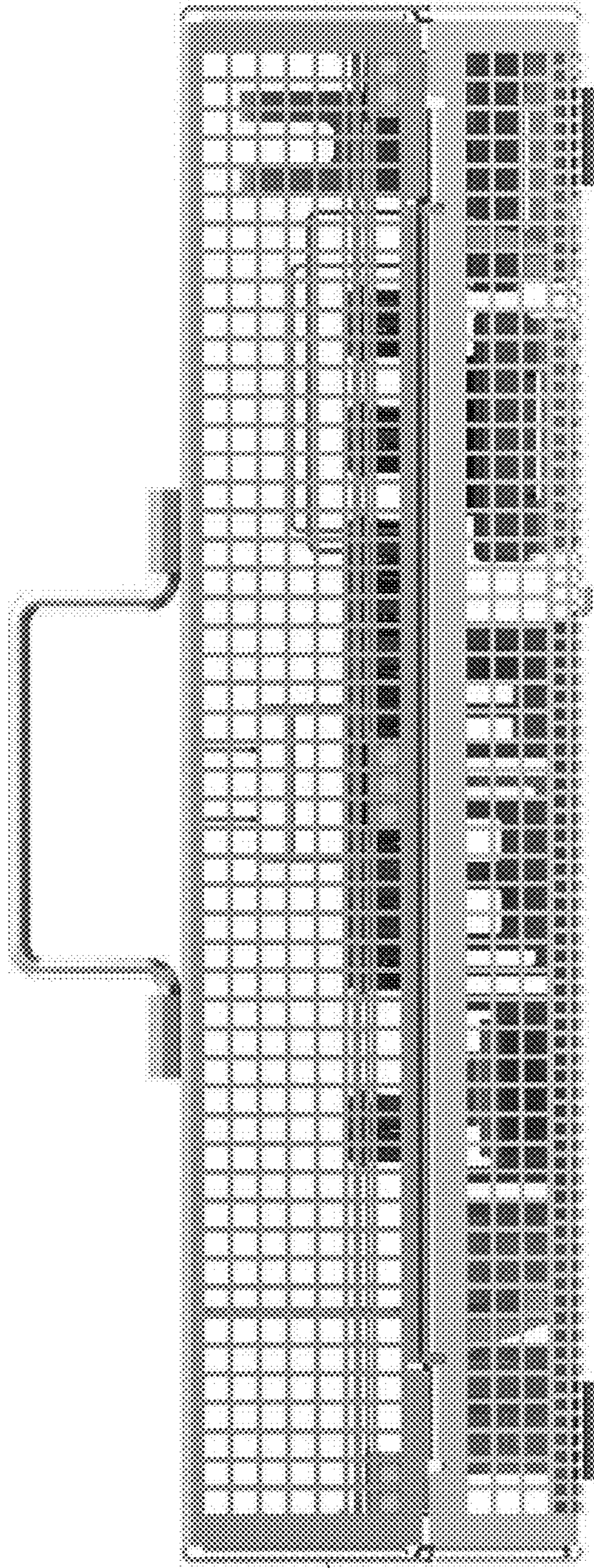

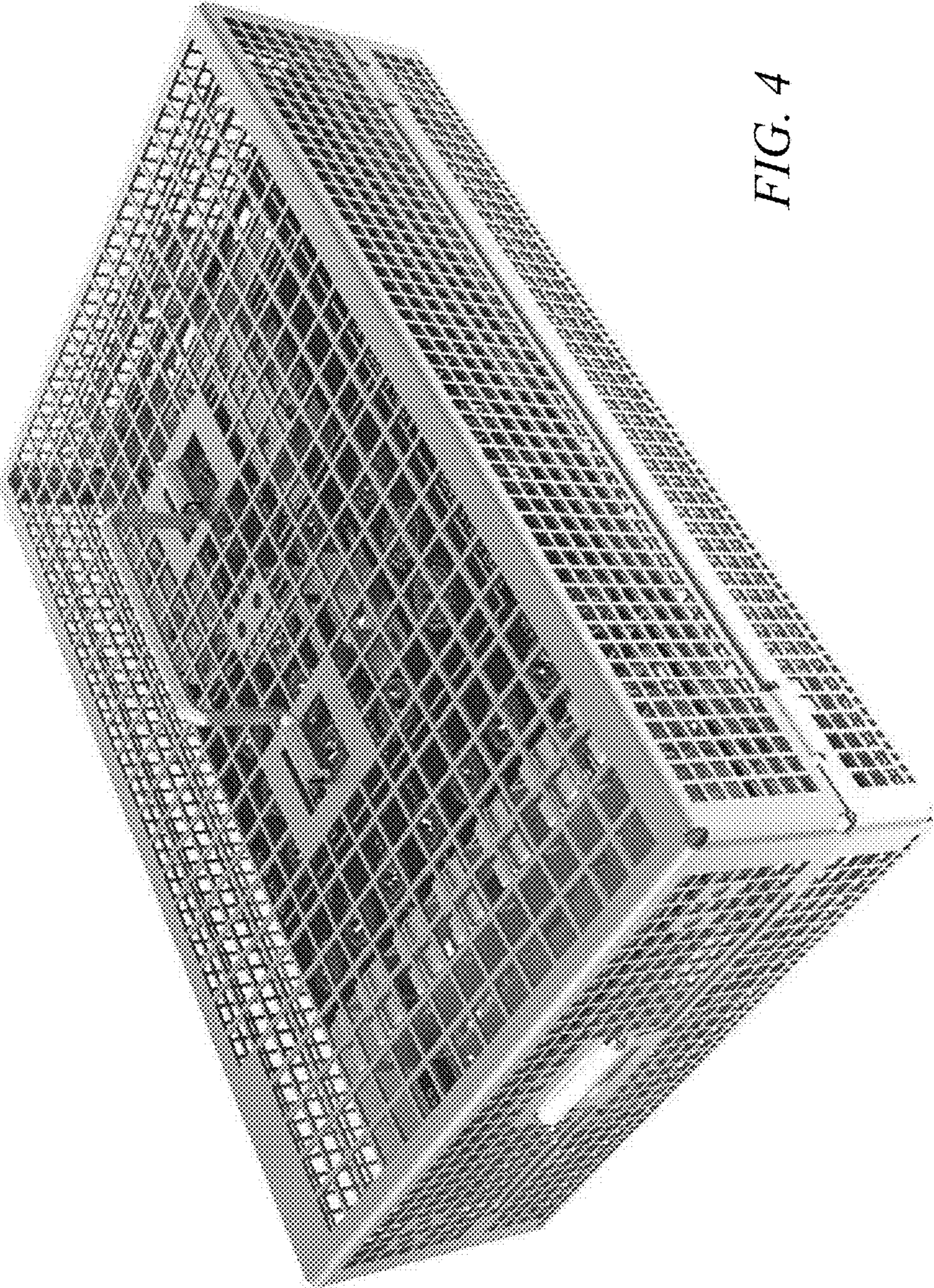

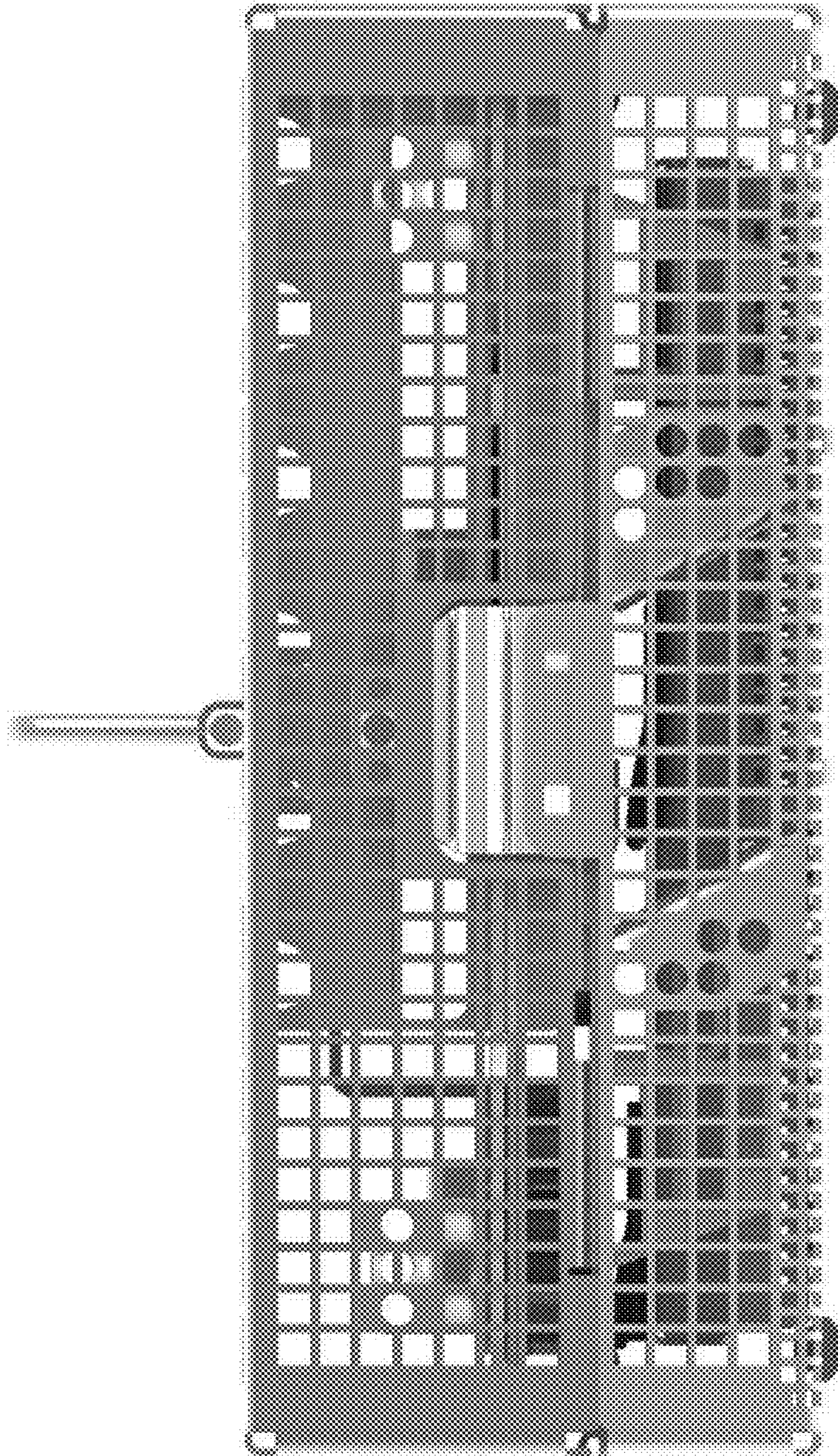

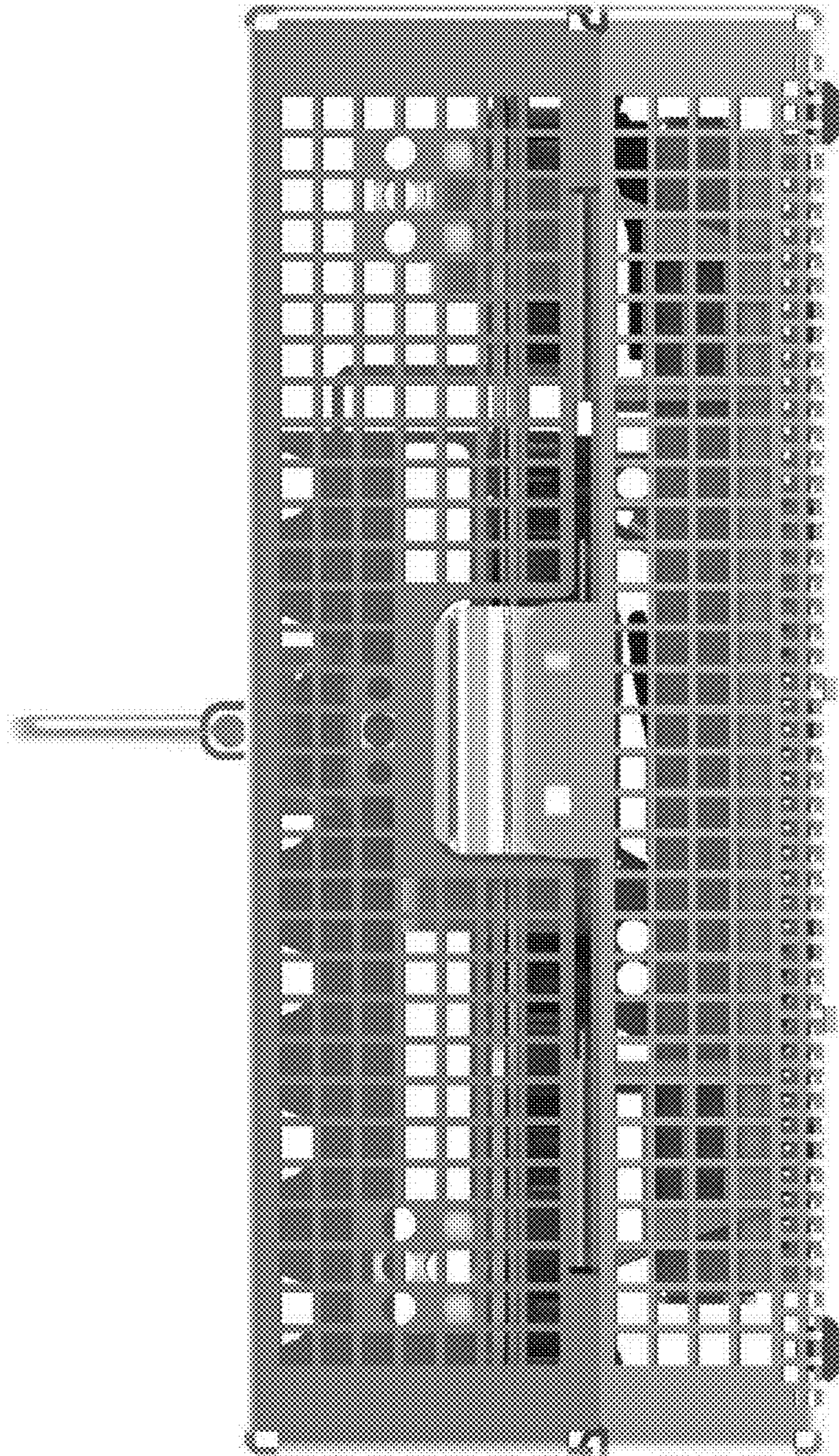

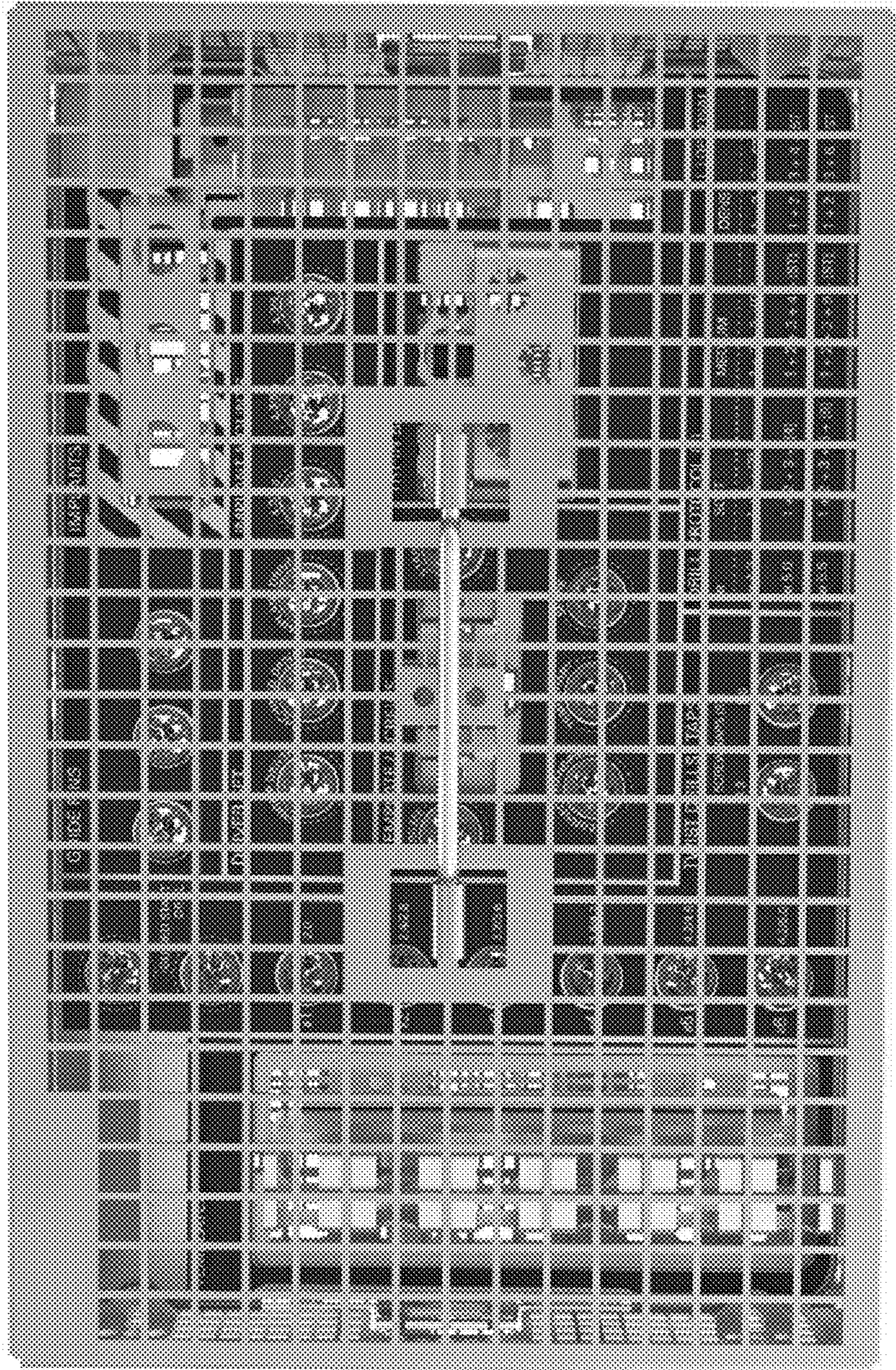

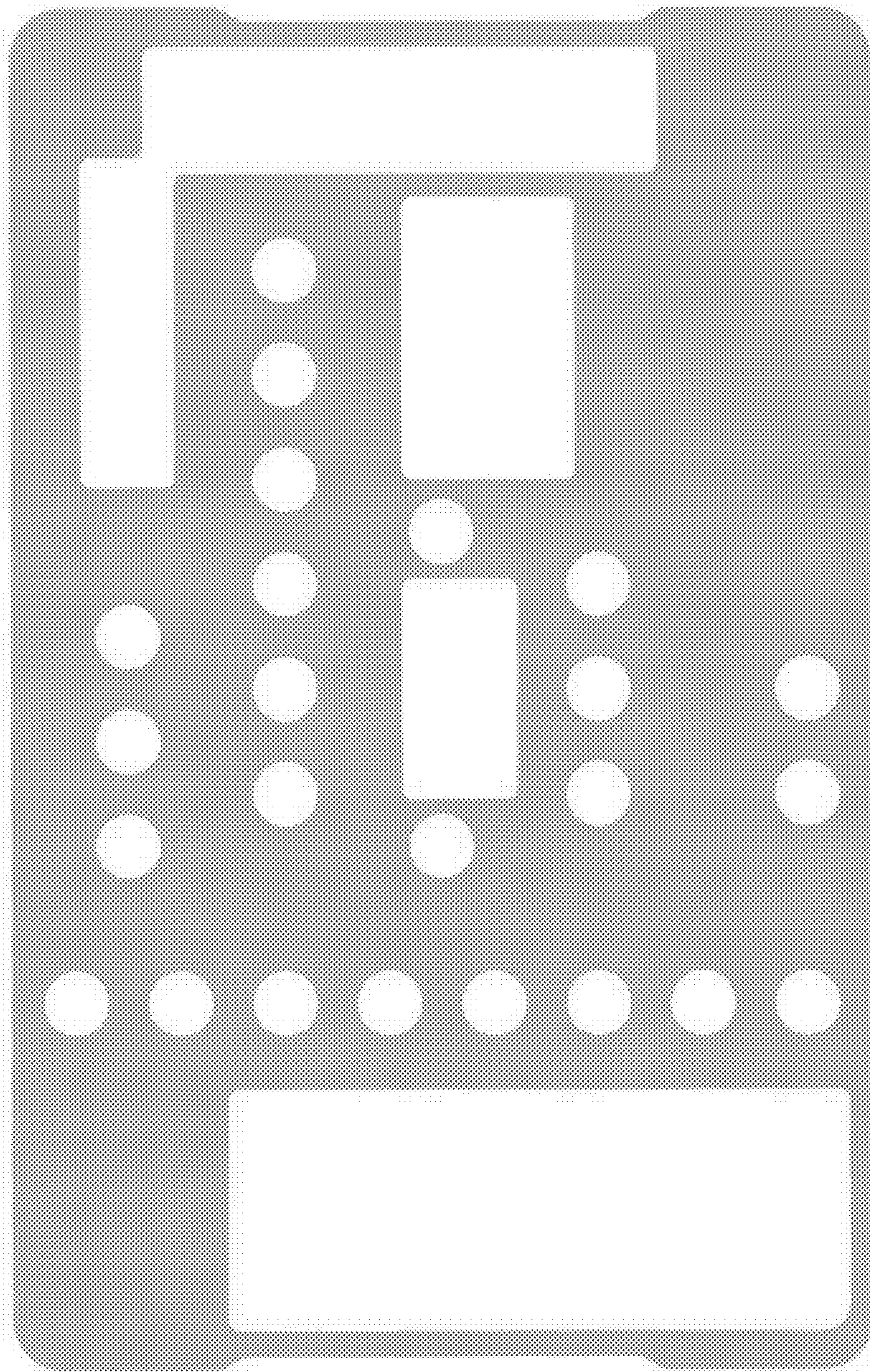

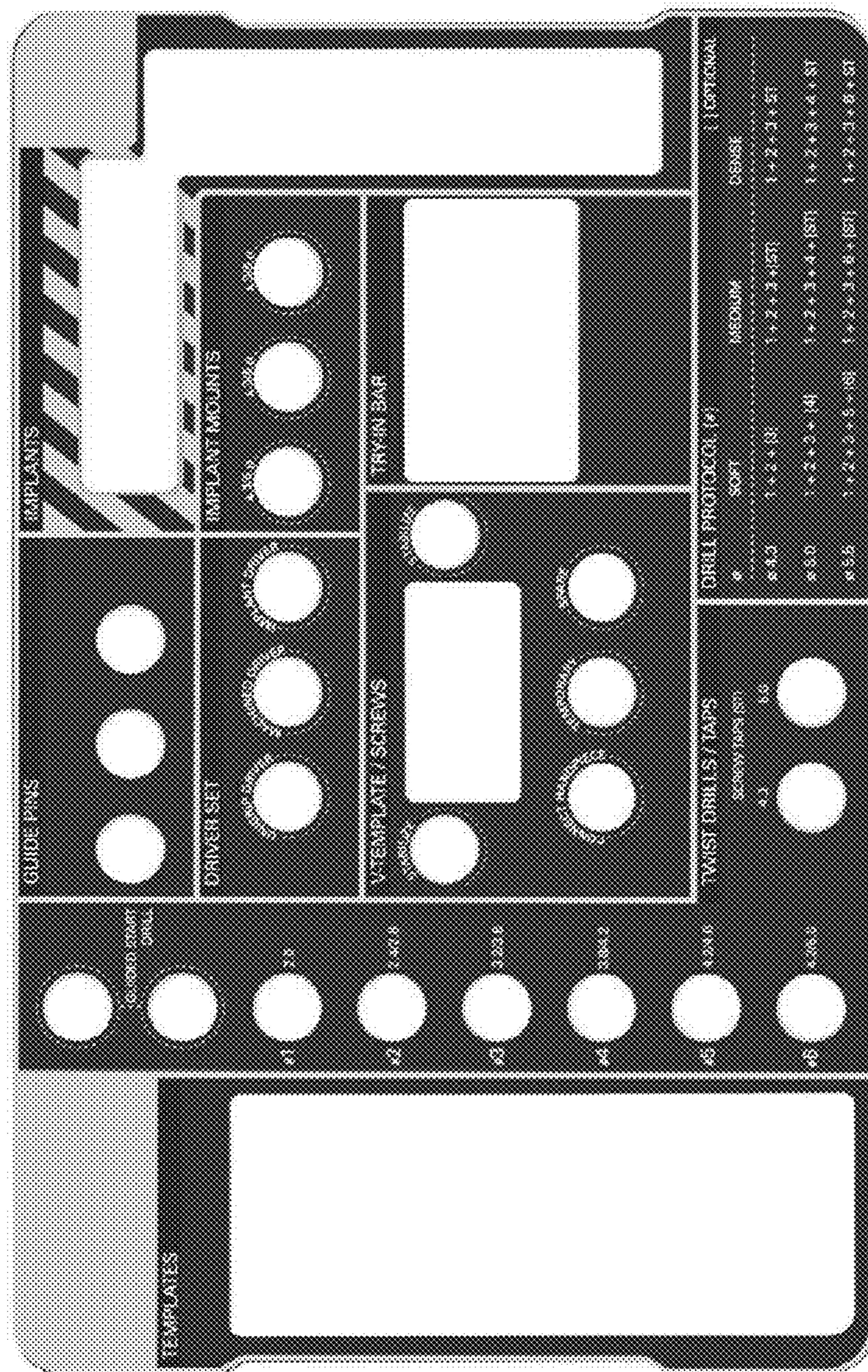

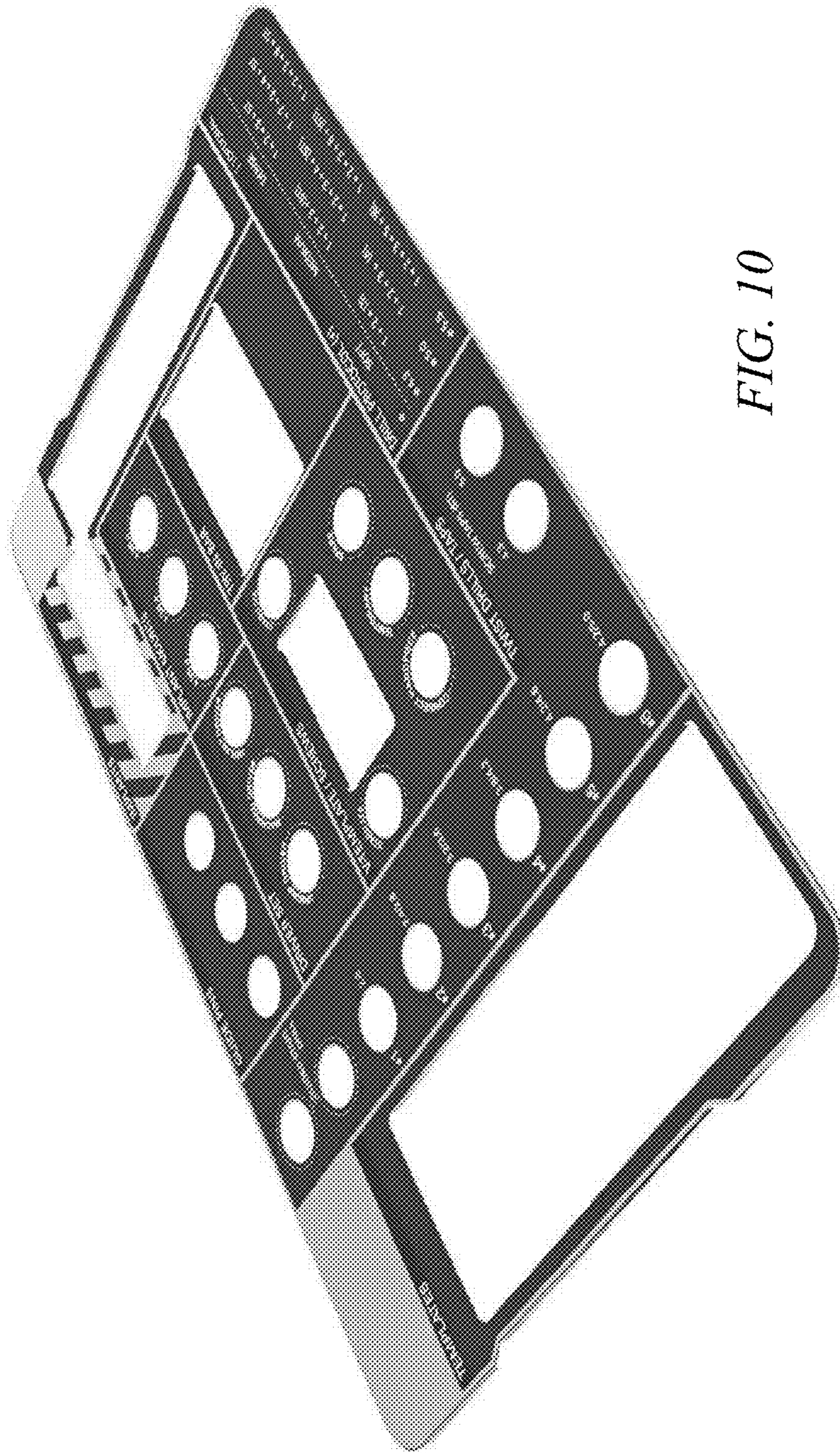

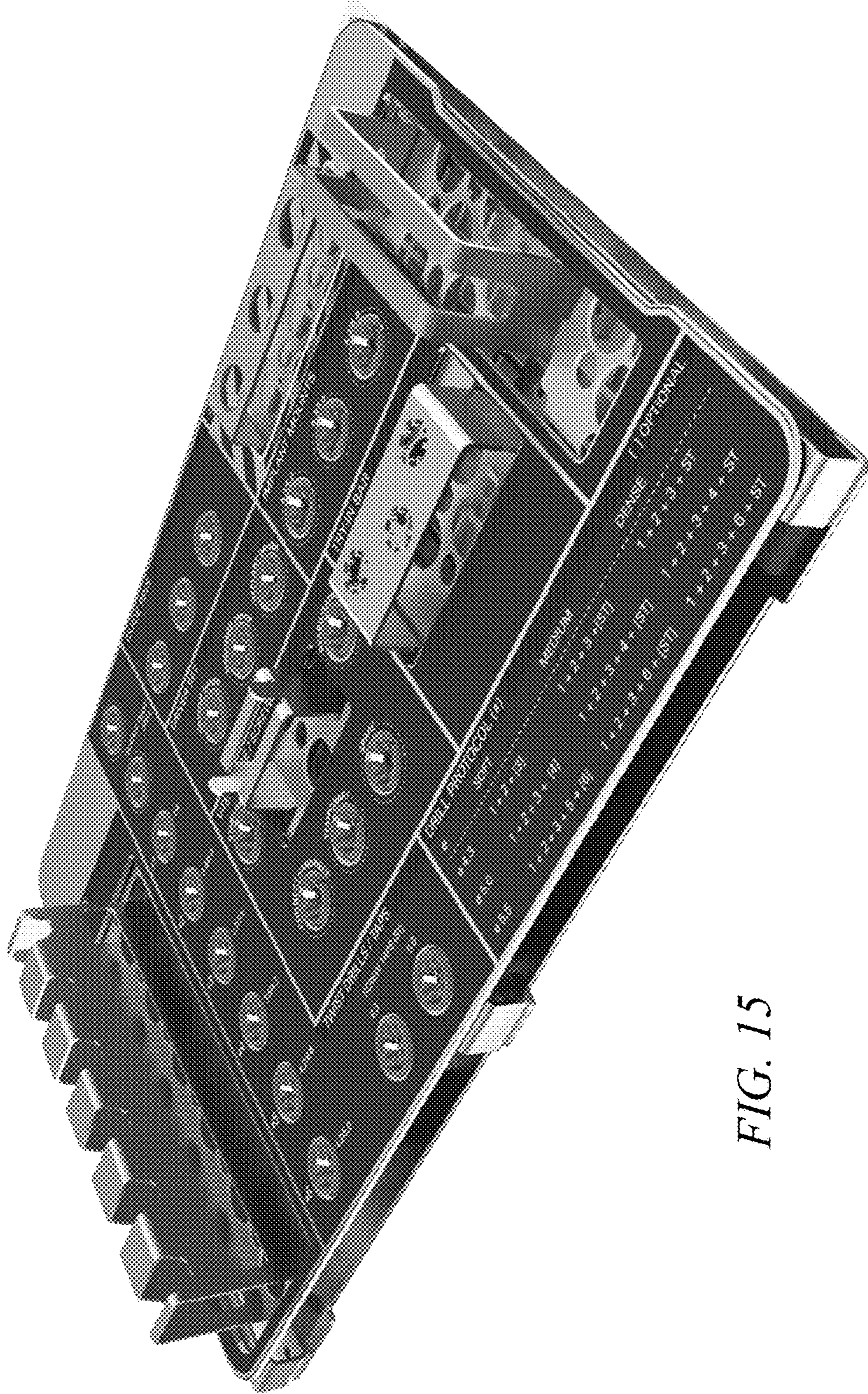

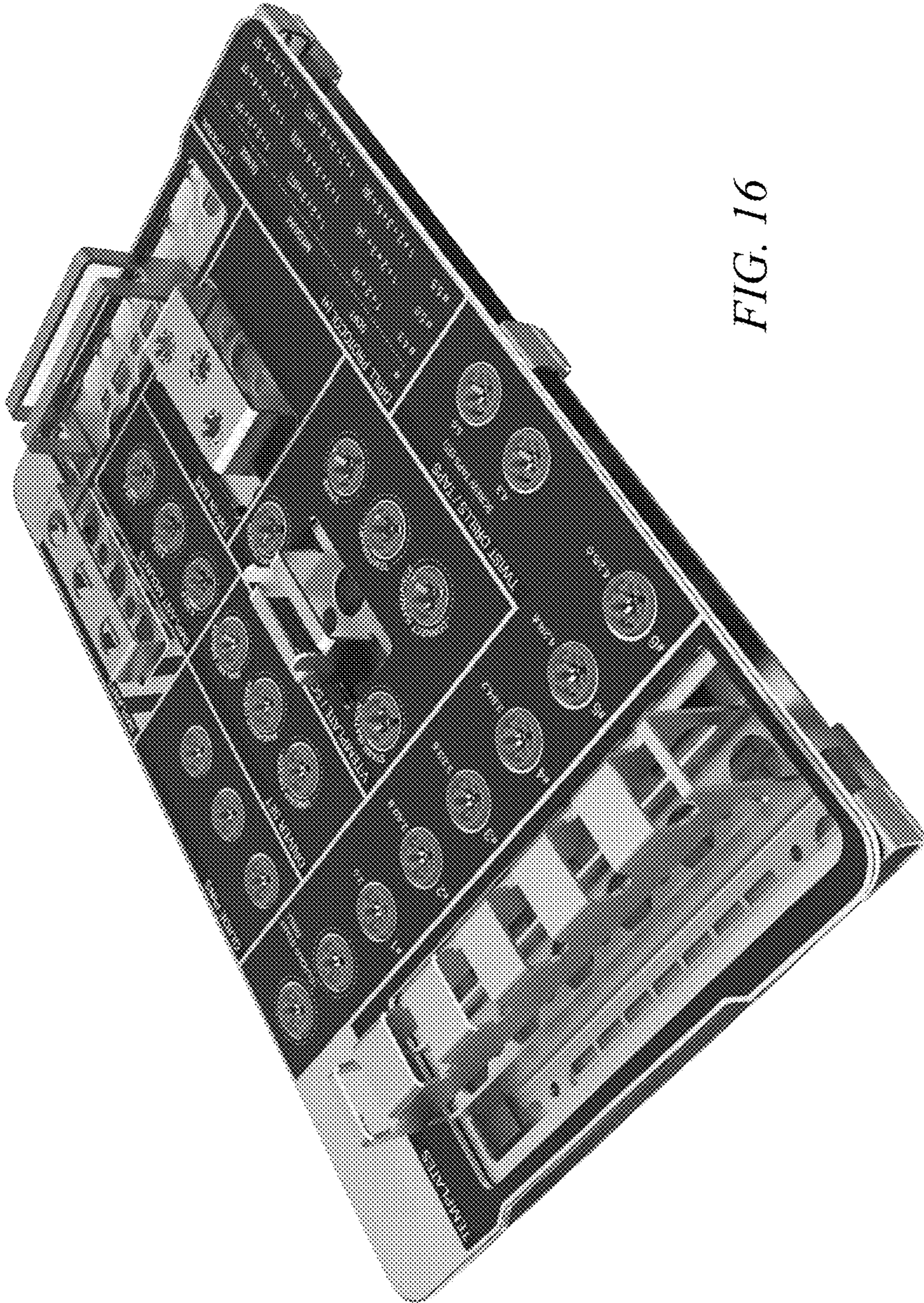

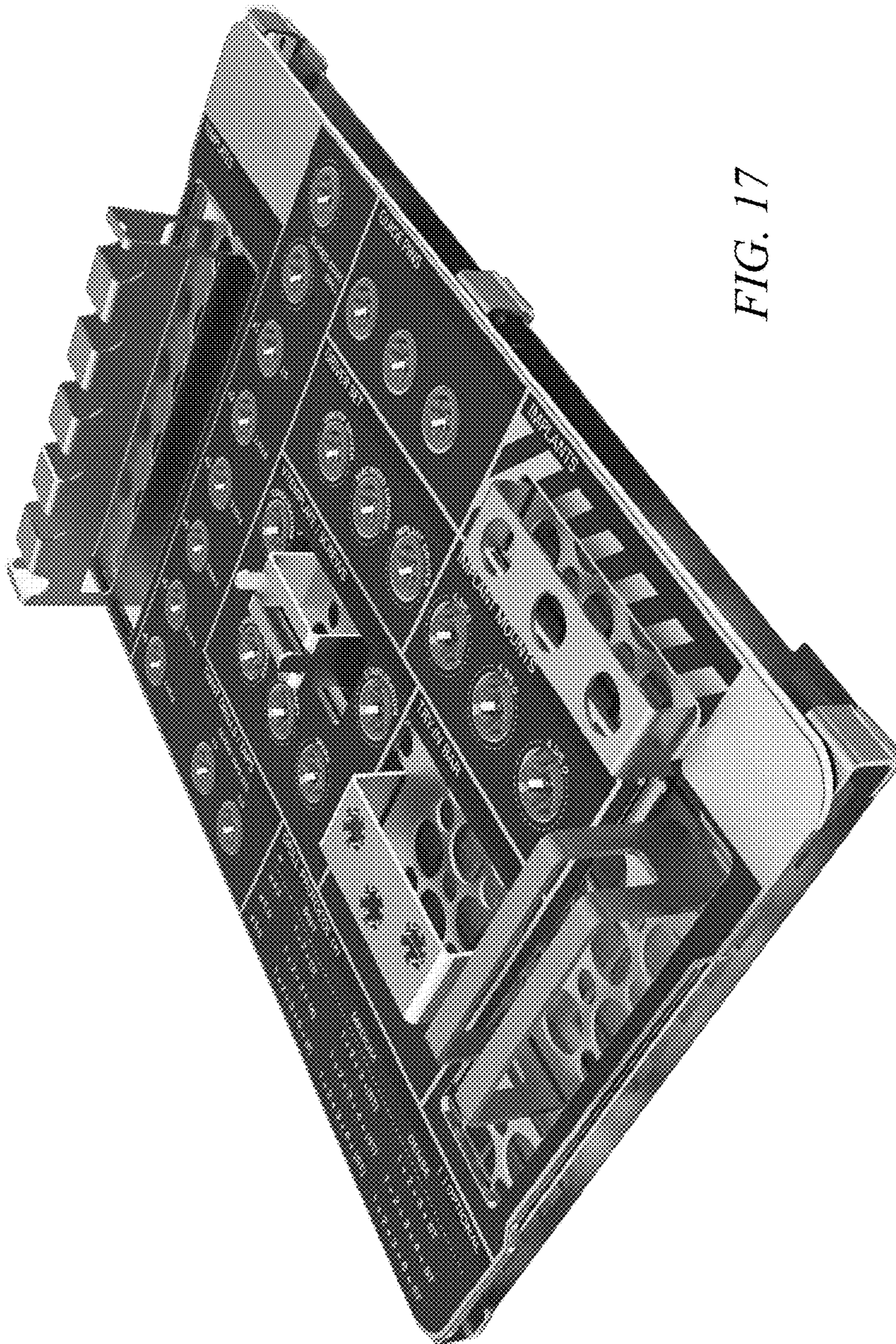

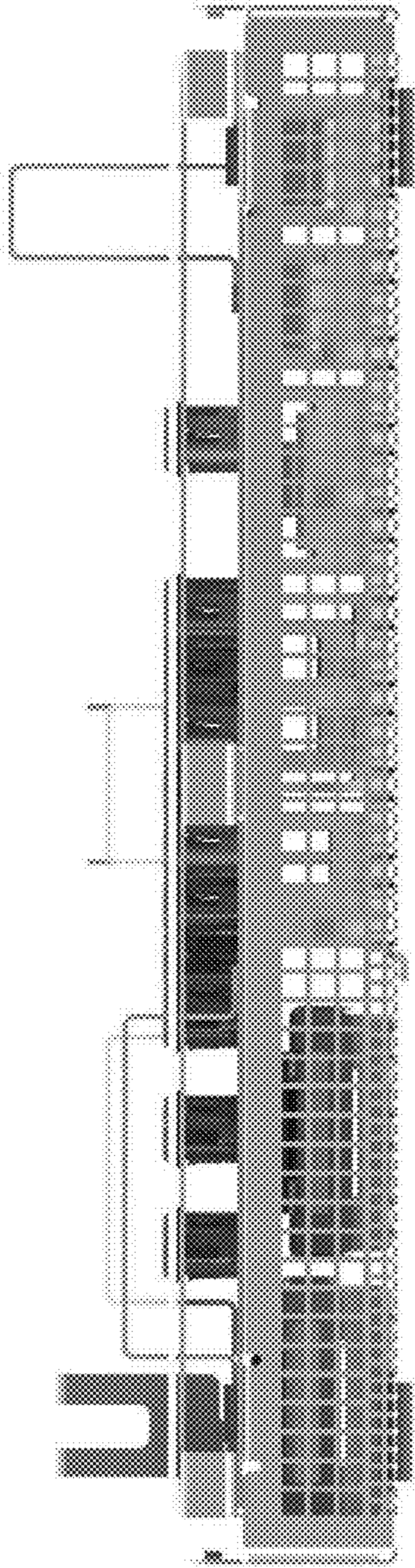

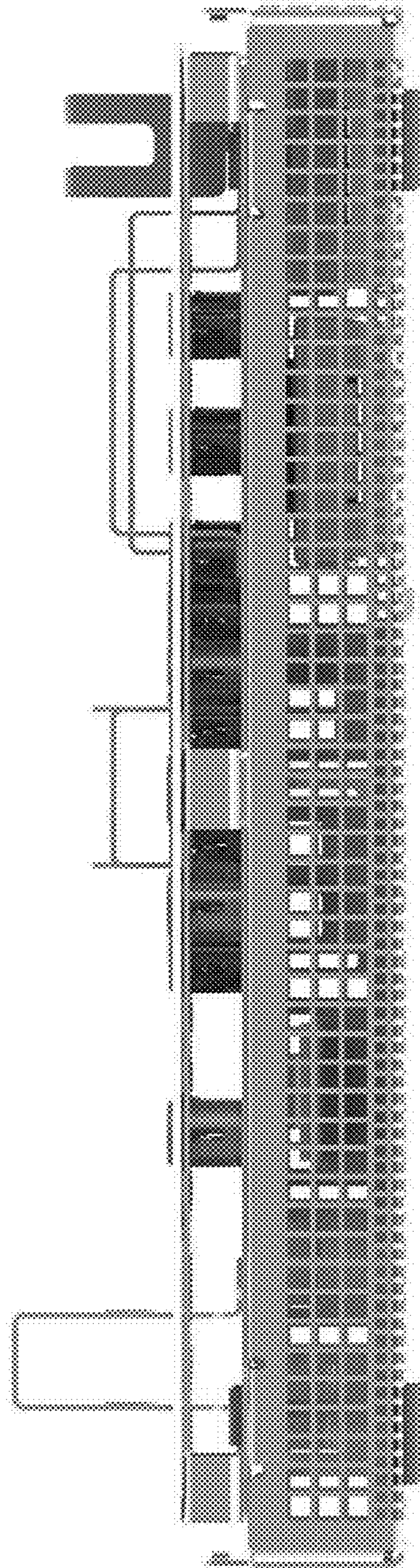

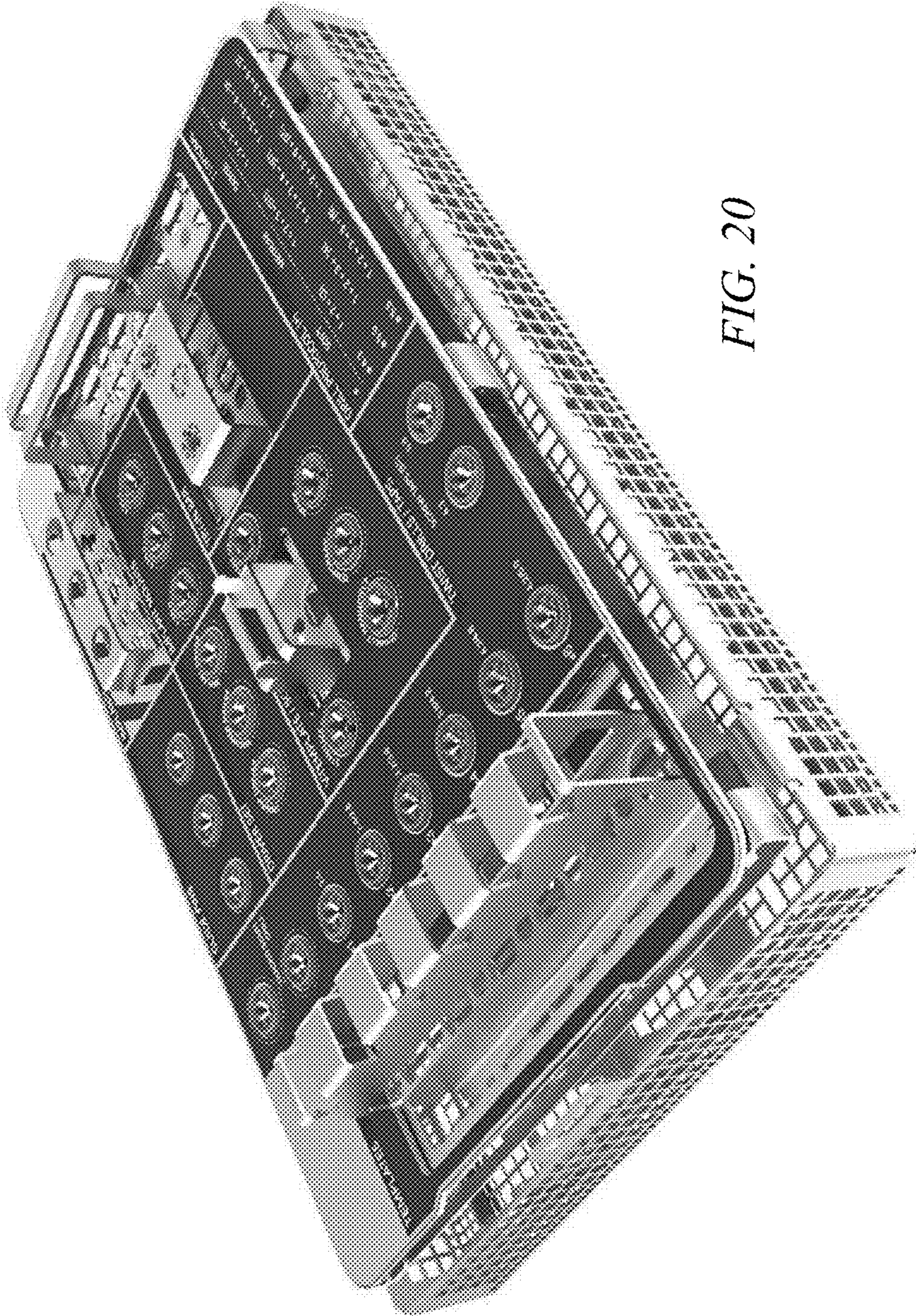

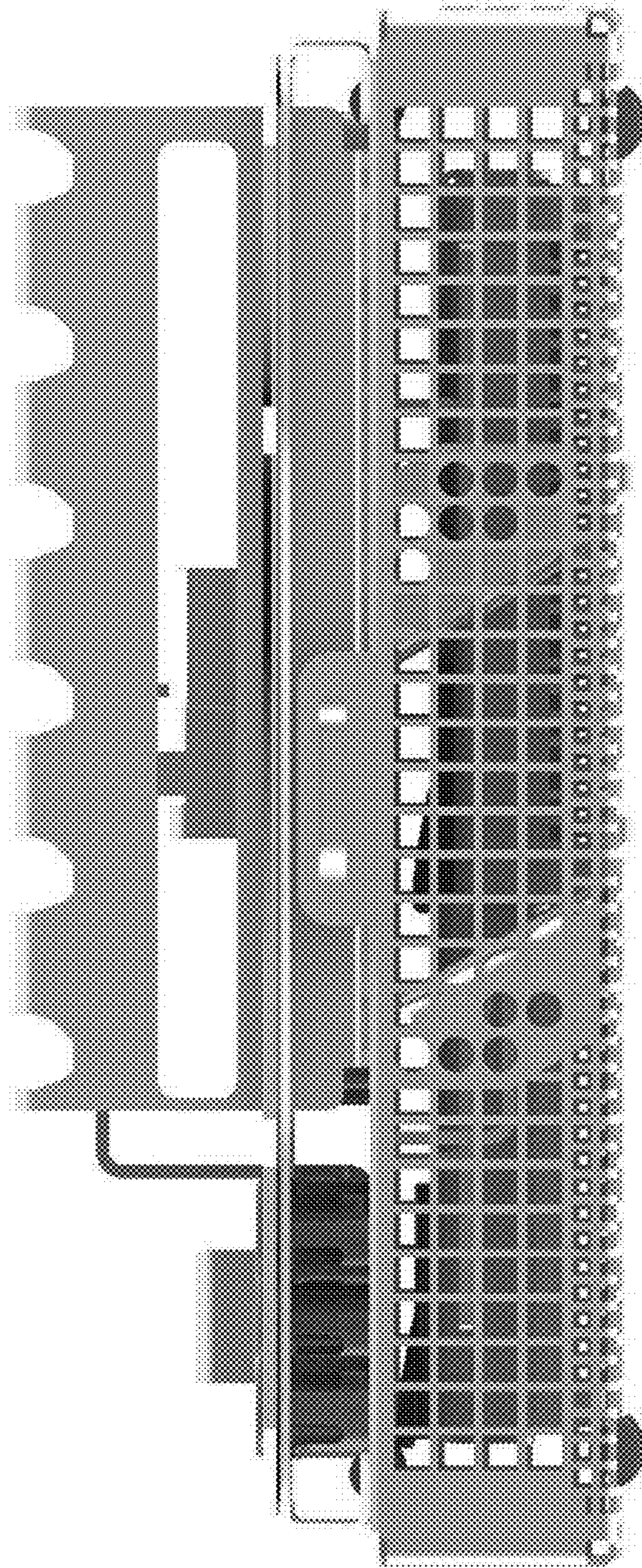

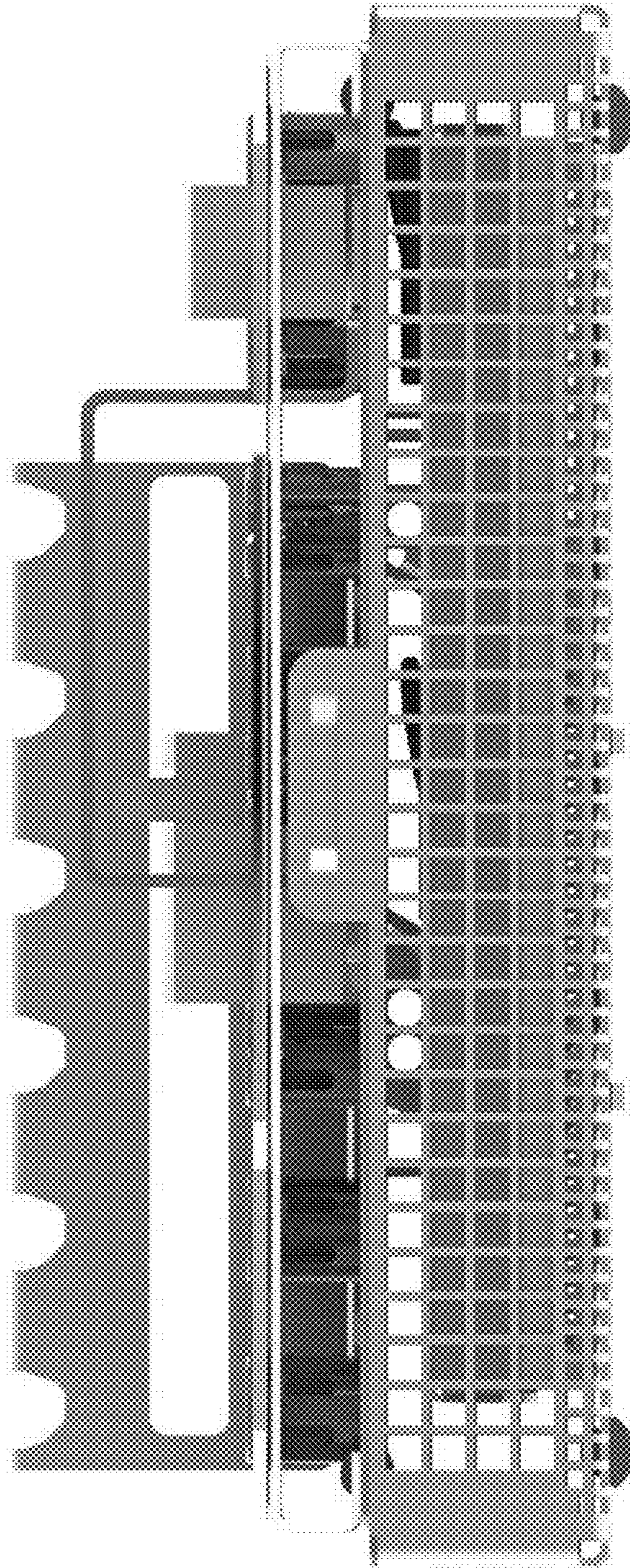

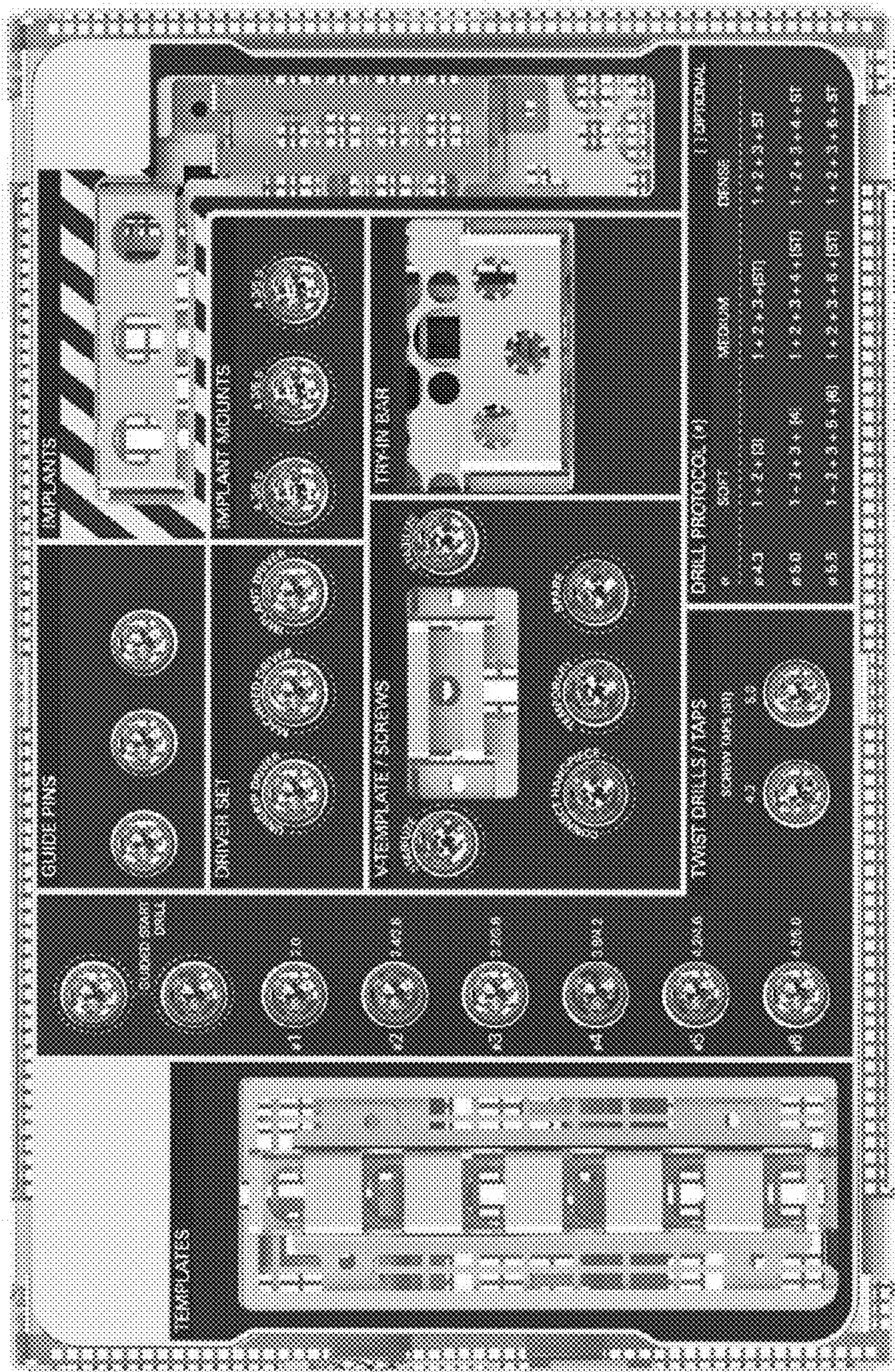
