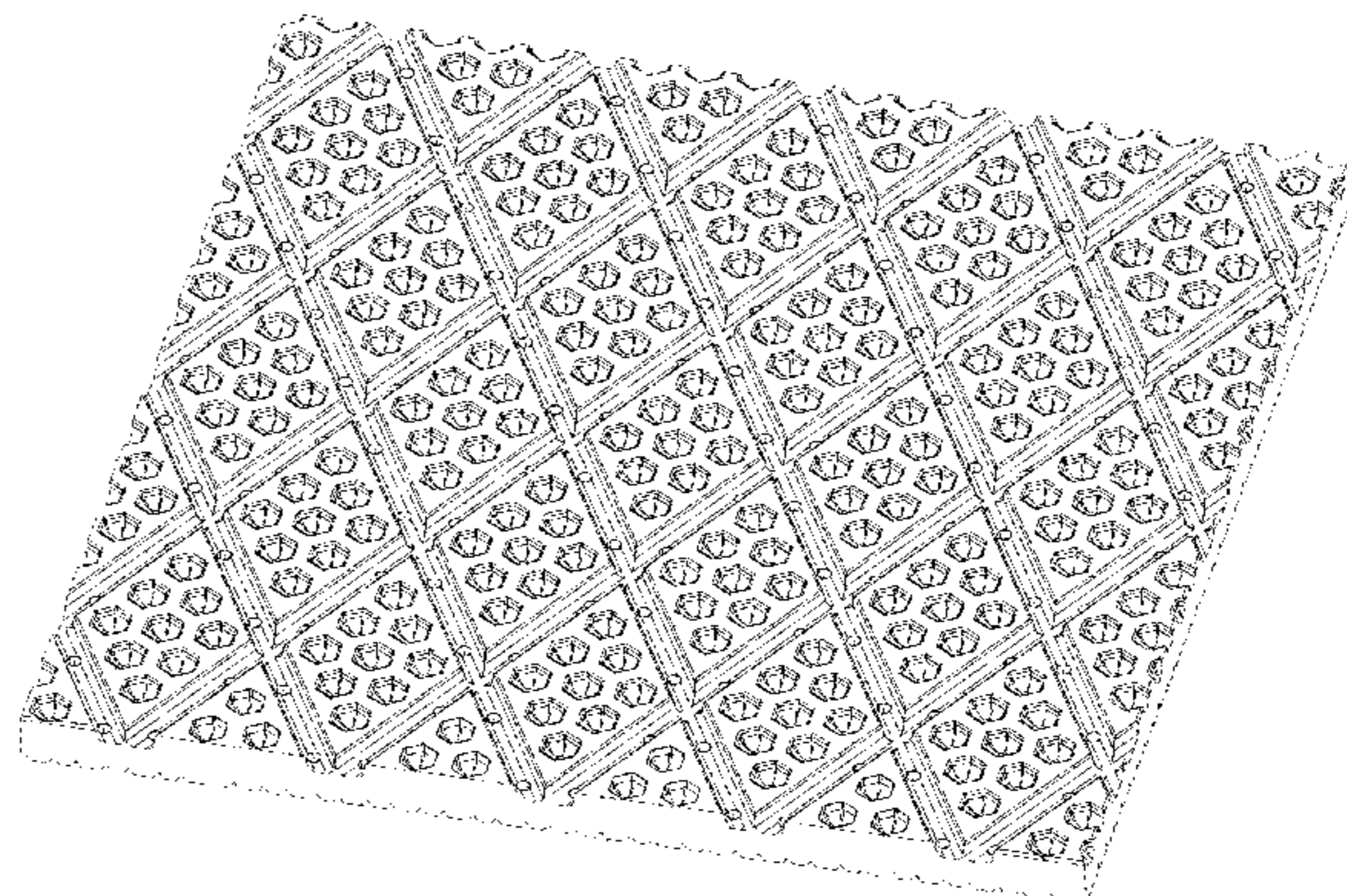
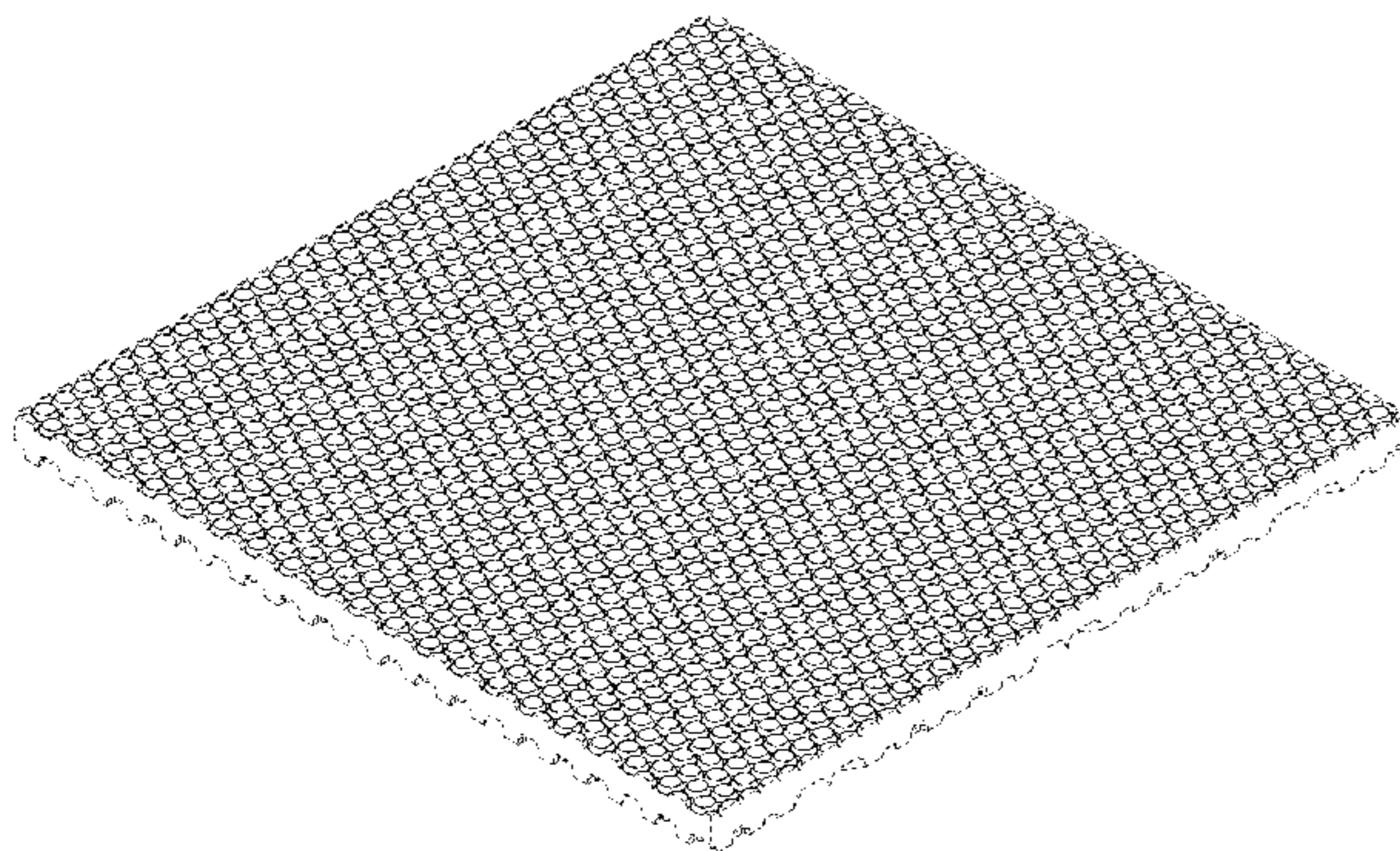
The ornamental design for a turf underlayment, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a turf underlayment according to the design;
FIG. 2 is a bottom perspective view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is an enlarged view as indicated in FIG. 3;
FIG. 5 is a bottom plan view of the turf underlayment; and
FIG. 6 is an enlarged view as indicated in FIG. 5;
FIG. 7 is a front edge view of the turf underlayment;
FIG. 8 is a right side edge view thereof;
FIG. 9 is a rear edge view thereof; and
FIG. 10 is a left side edge view thereof.

The broken lines shown in the drawings are for the purposes of illustrating portions of the article that form no part of the claimed design. The dot-dash lines represent the designation of enlargement views and form no part of the claimed design.

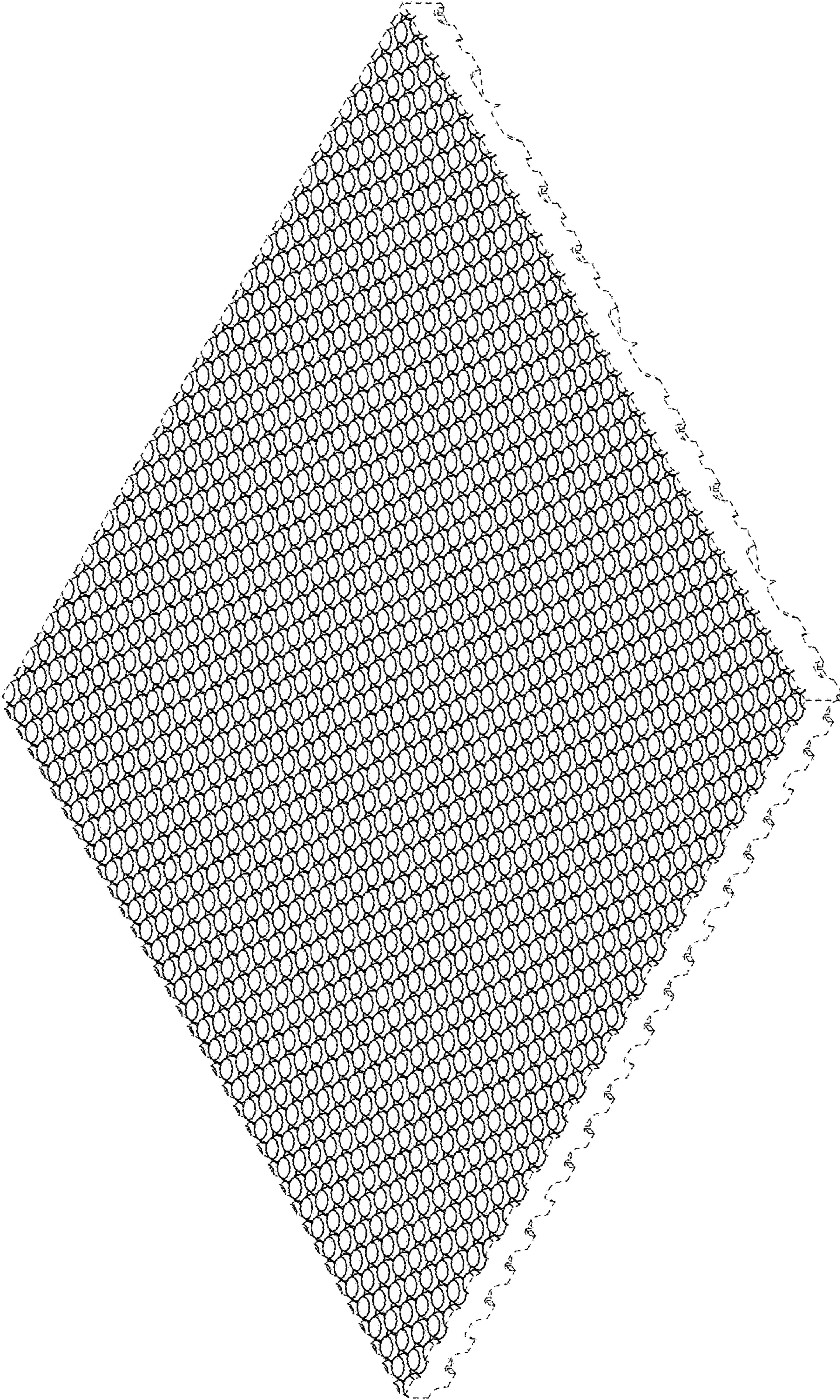

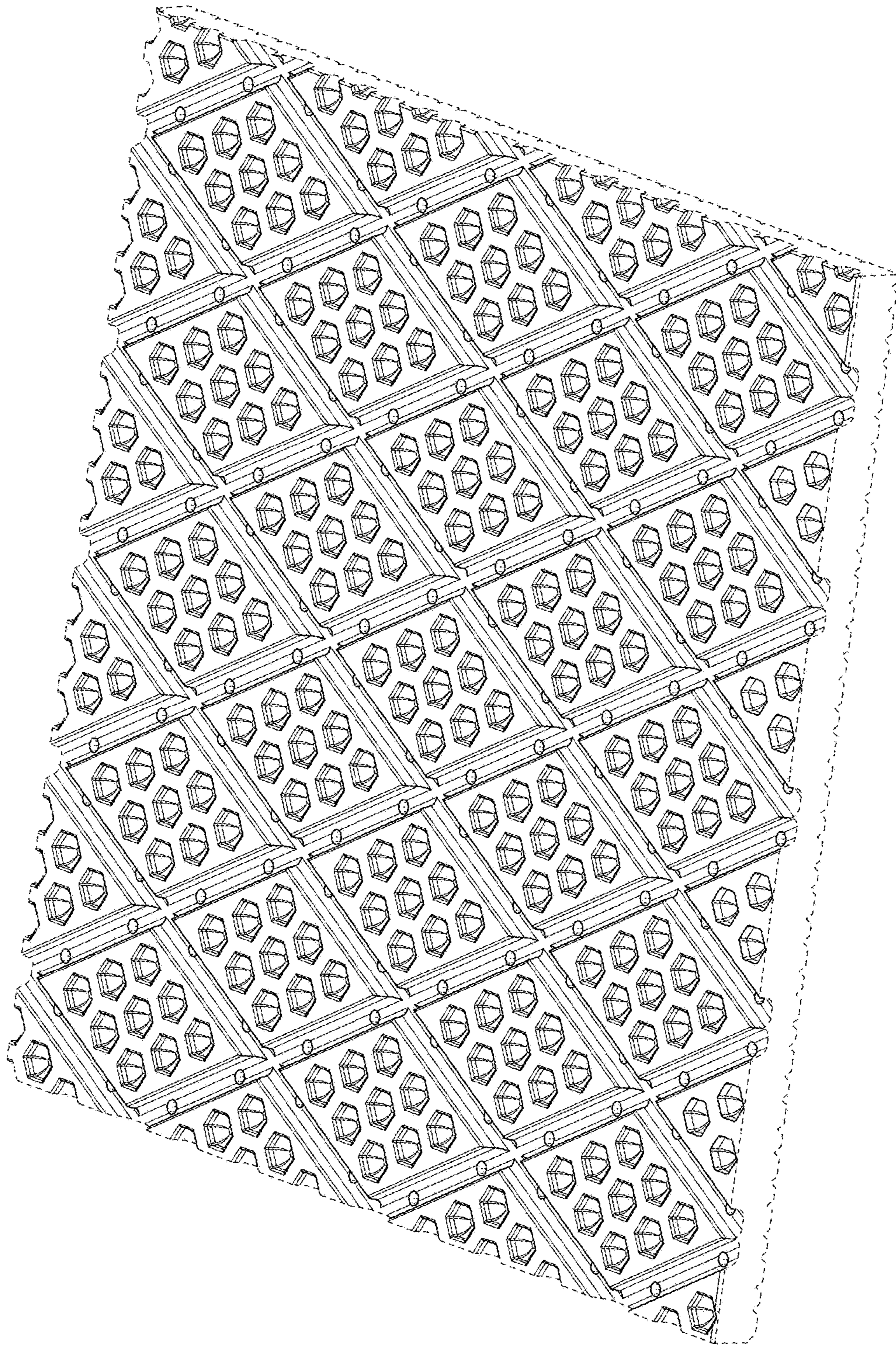

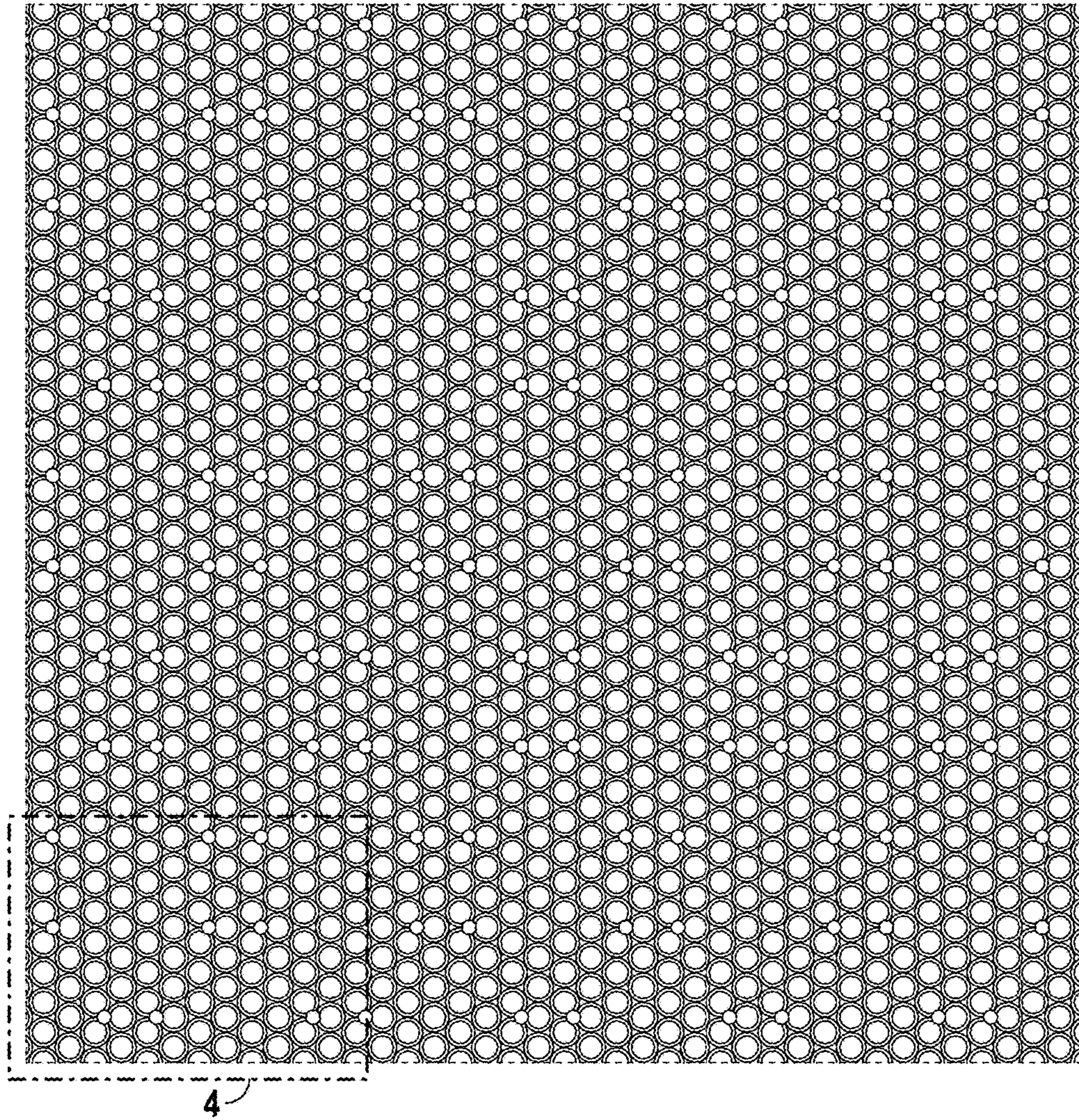

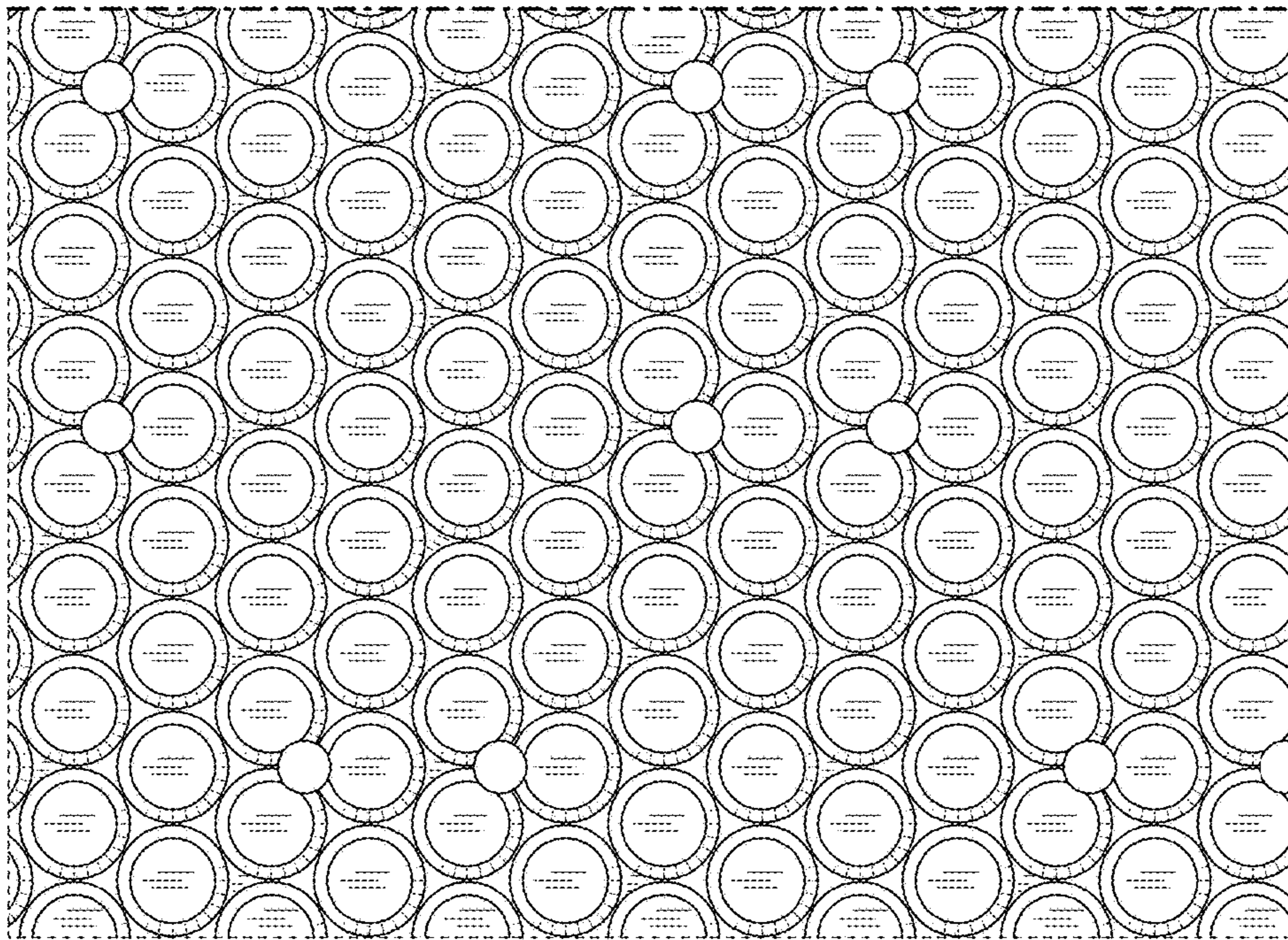

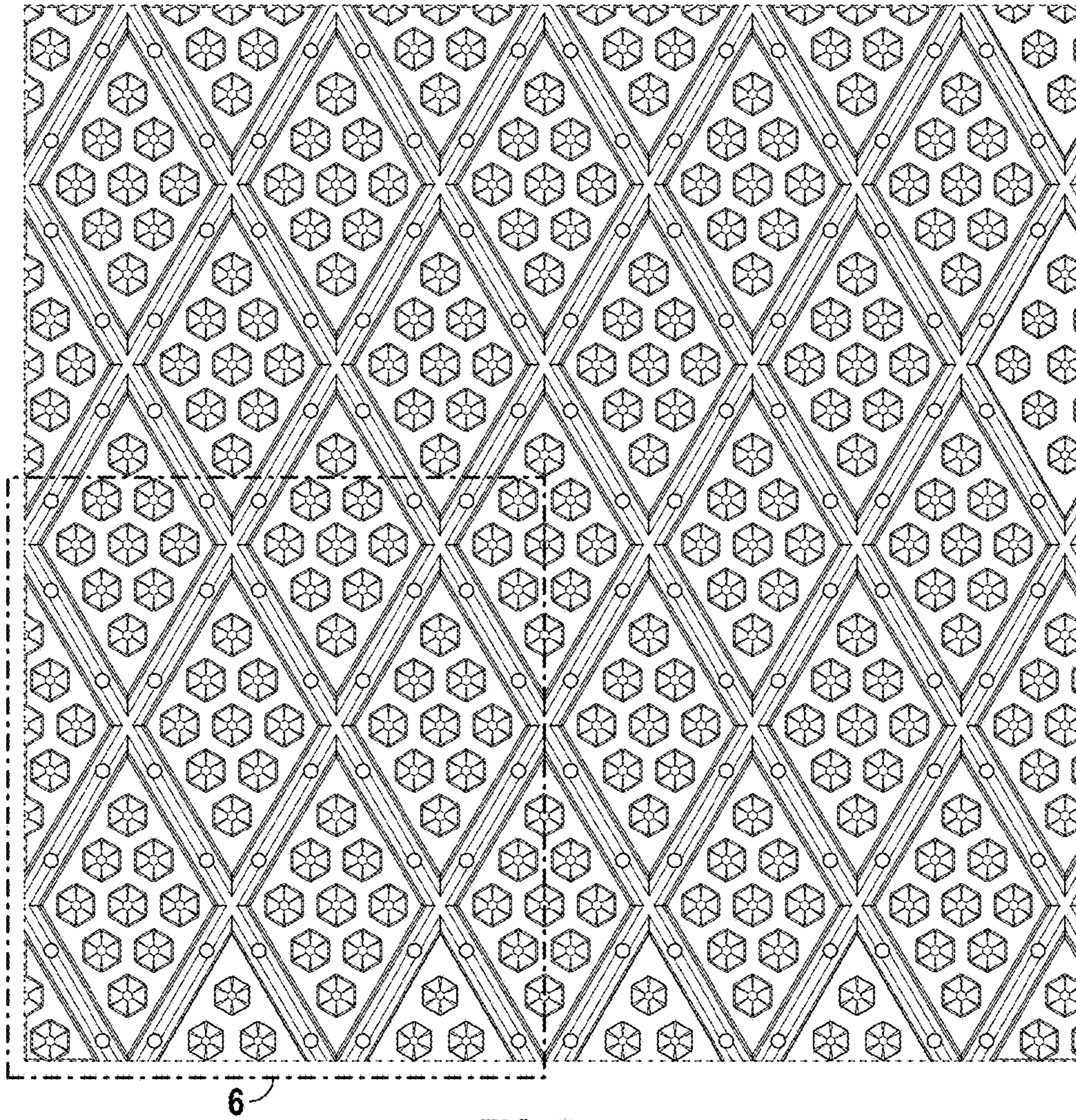

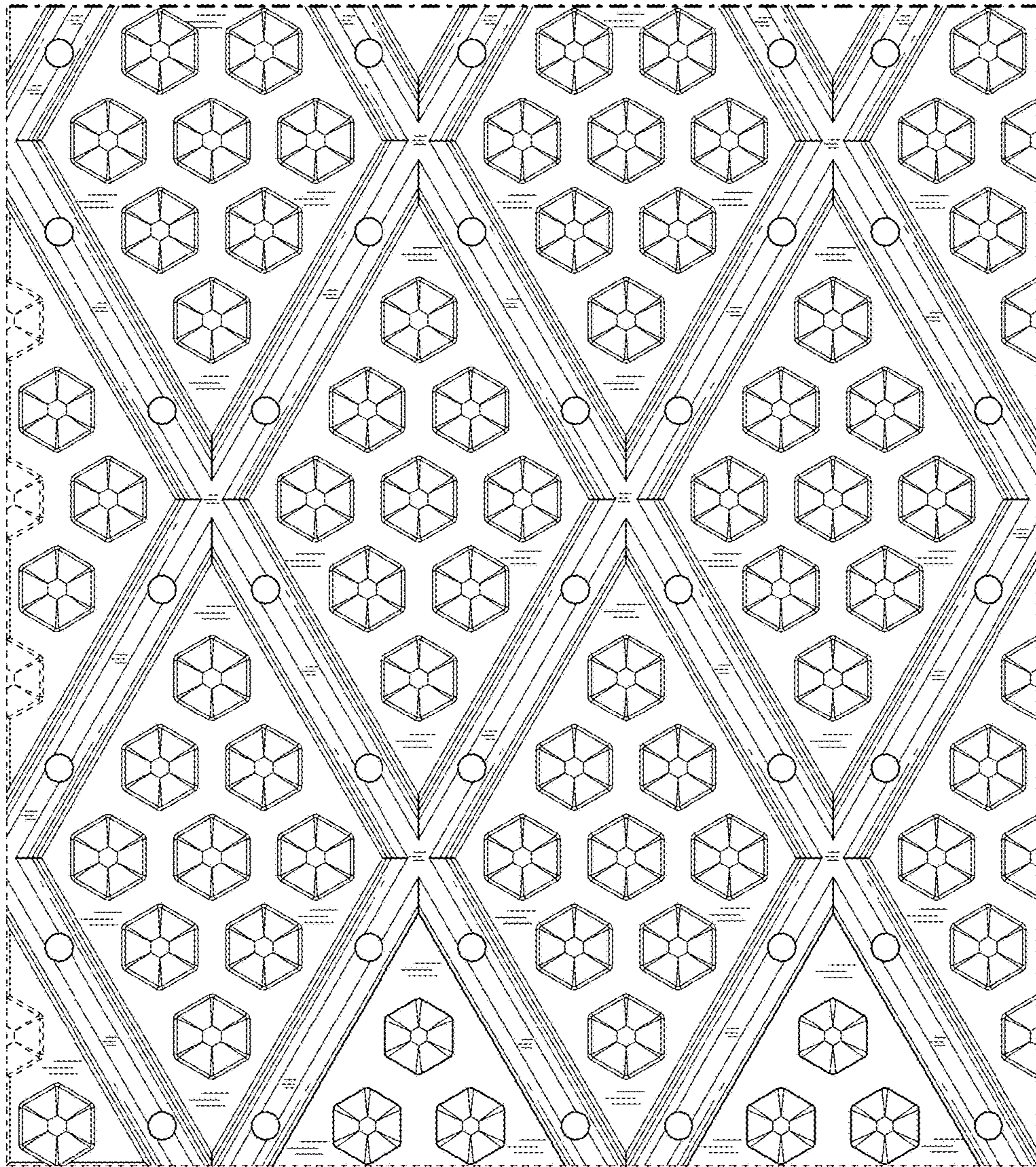

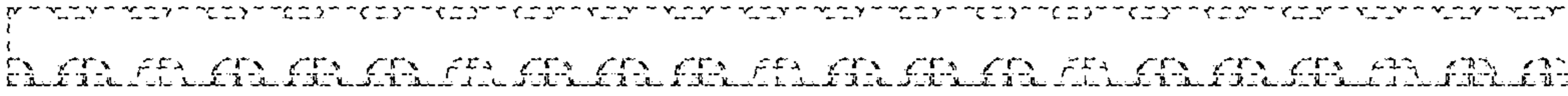

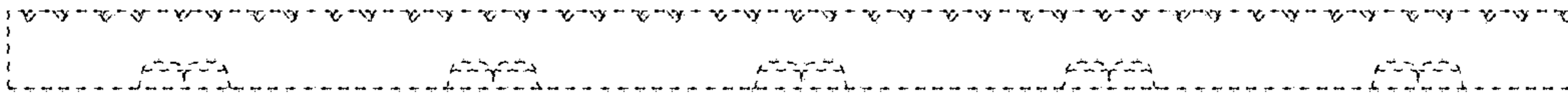

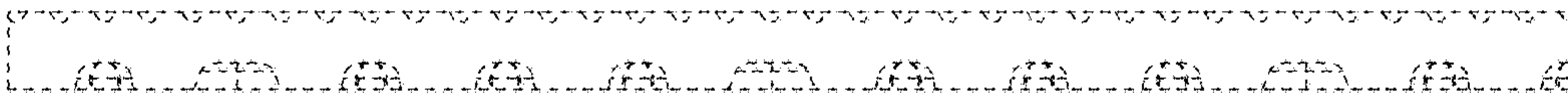

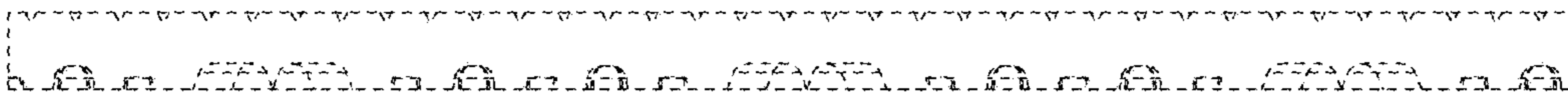
