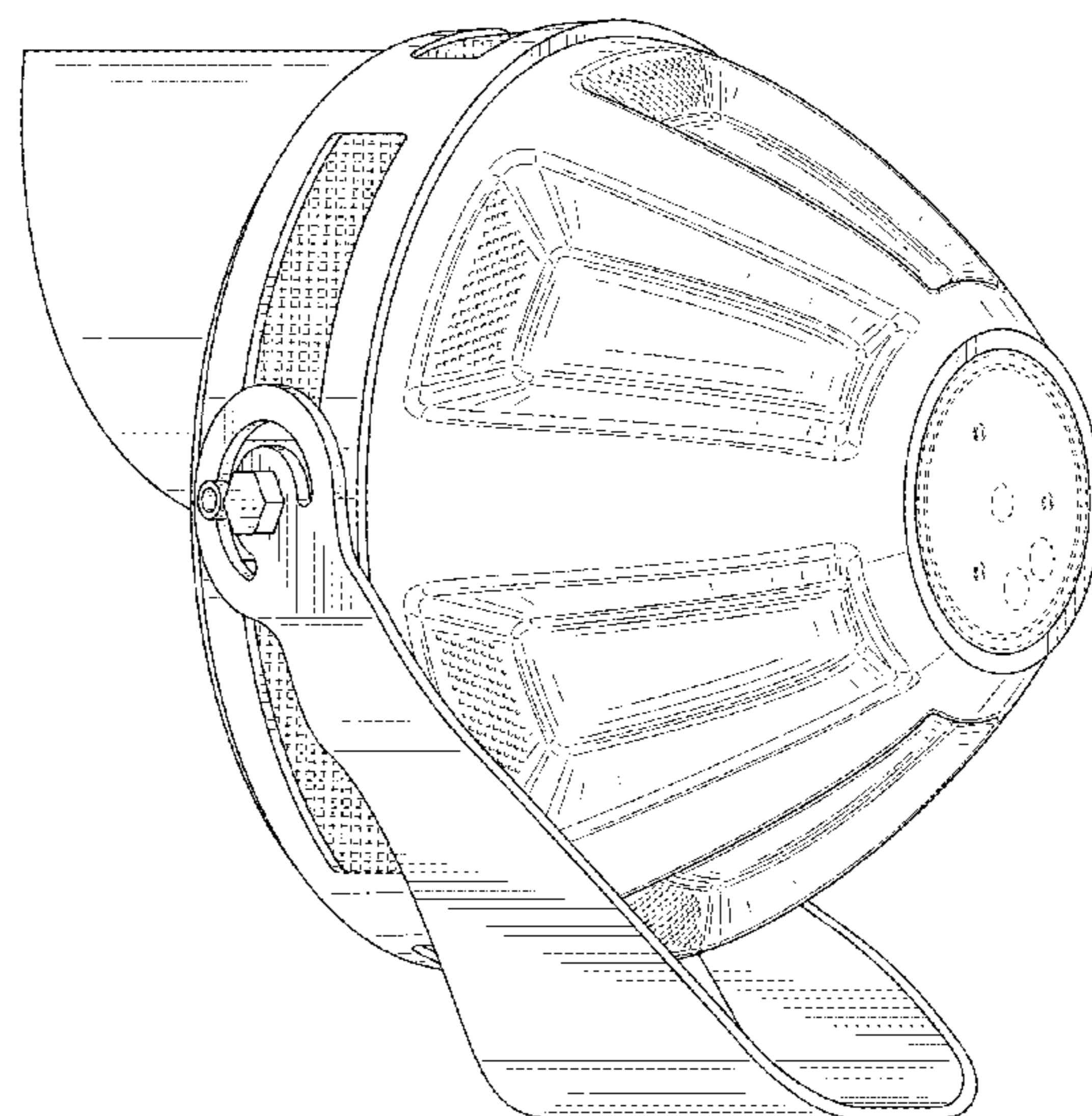
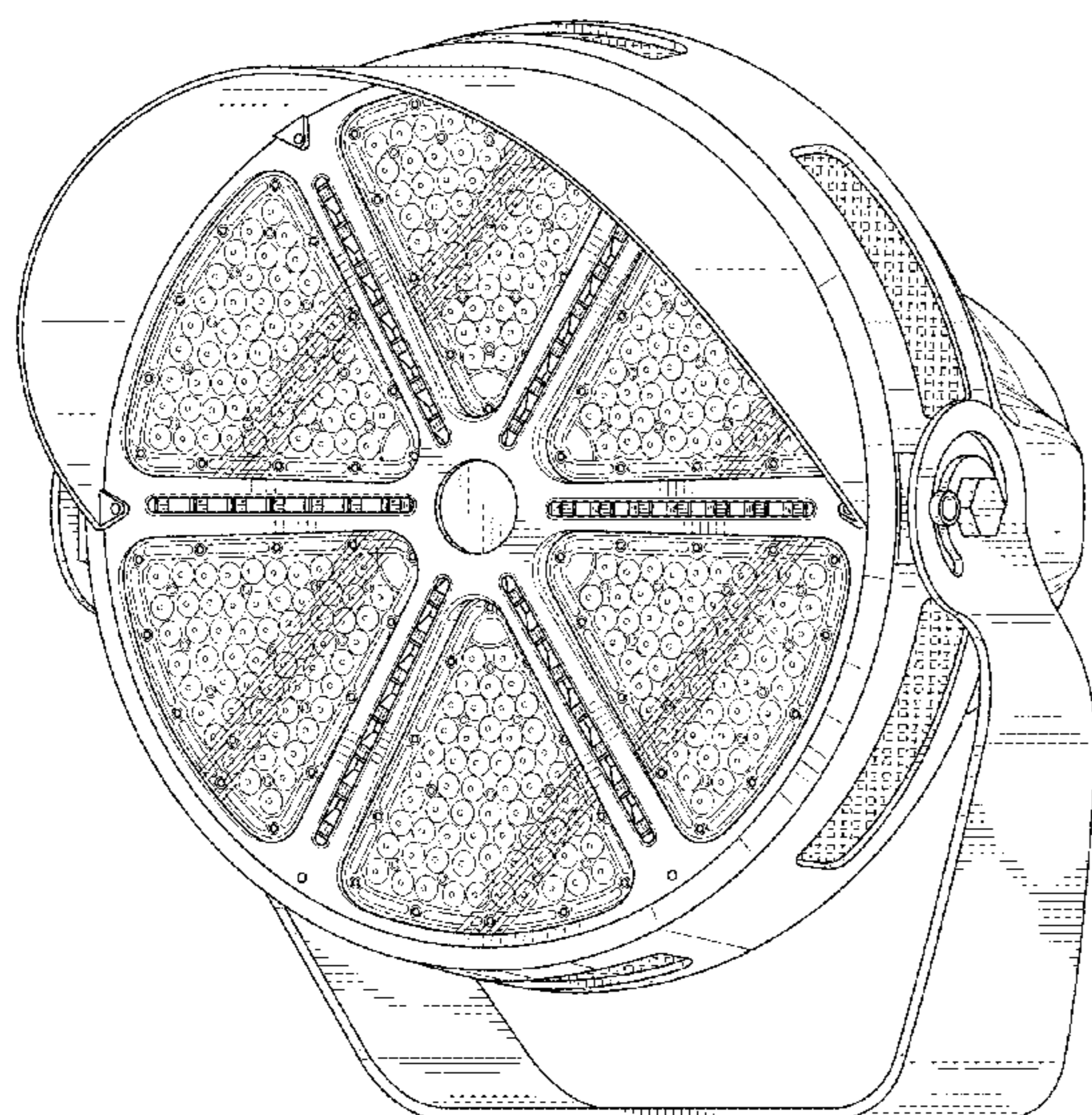
(57) **CLAIM**

The ornamental design for a lamp, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of another embodiment of a lamp showing my new design.
FIG. 2 is a rear perspective view of the lamp as shown in FIG. 1 showing my new design.
FIG. 3 is a front elevation view of the lamp as shown in FIG. 1 showing my new design.
FIG. 4 is a rear elevation view of the lamp as shown in FIG. 1 showing my new design.

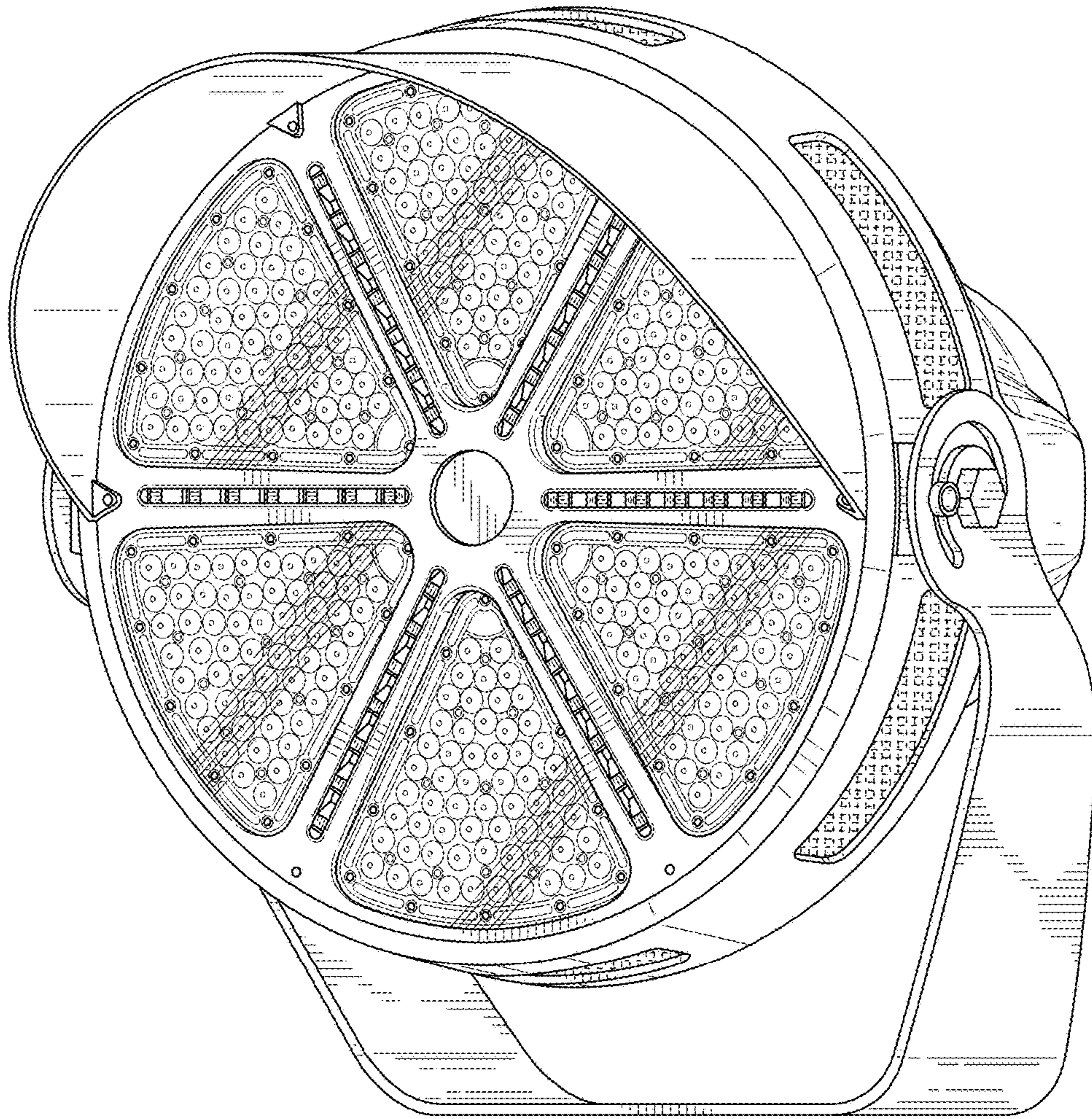

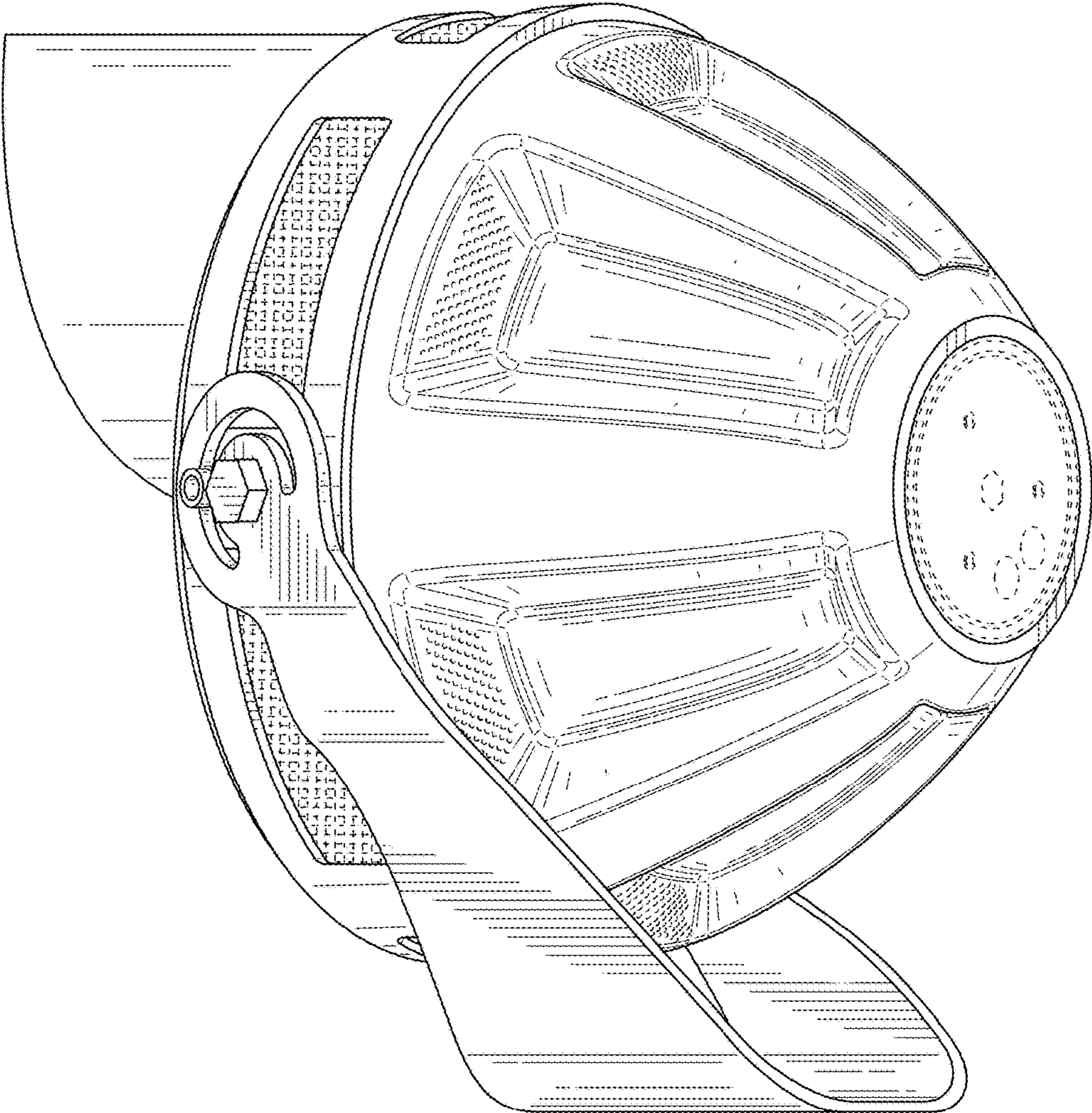

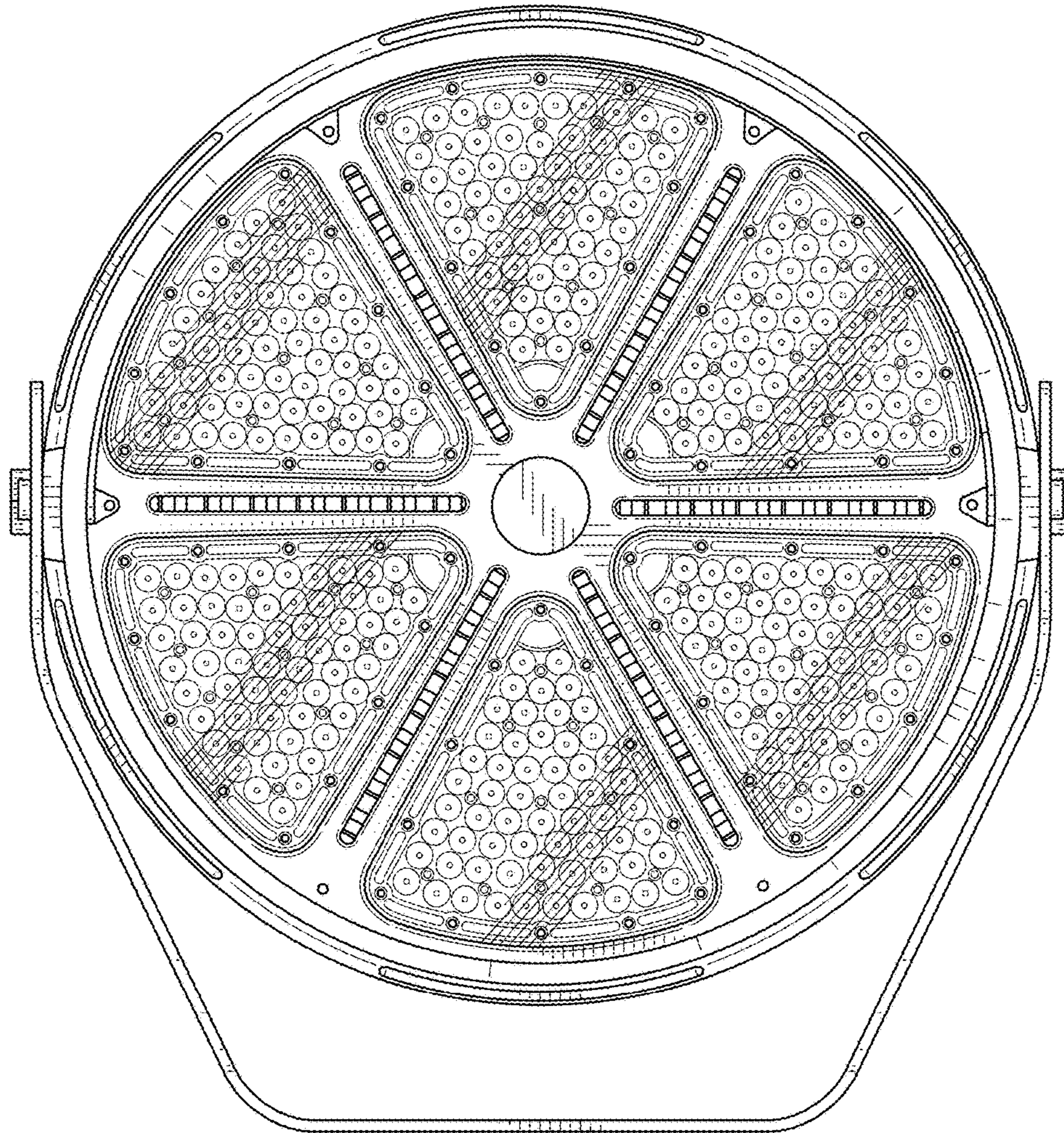

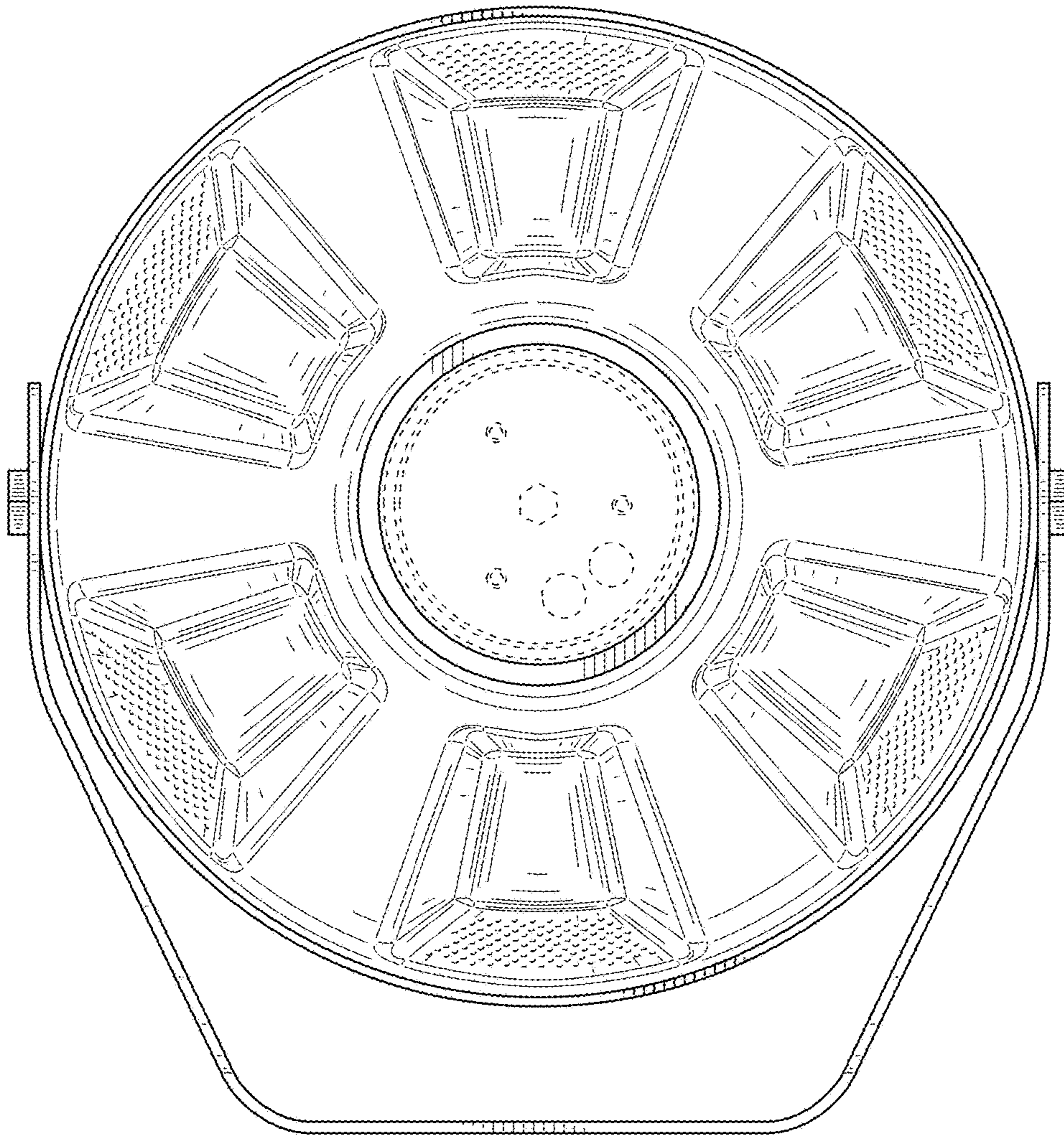

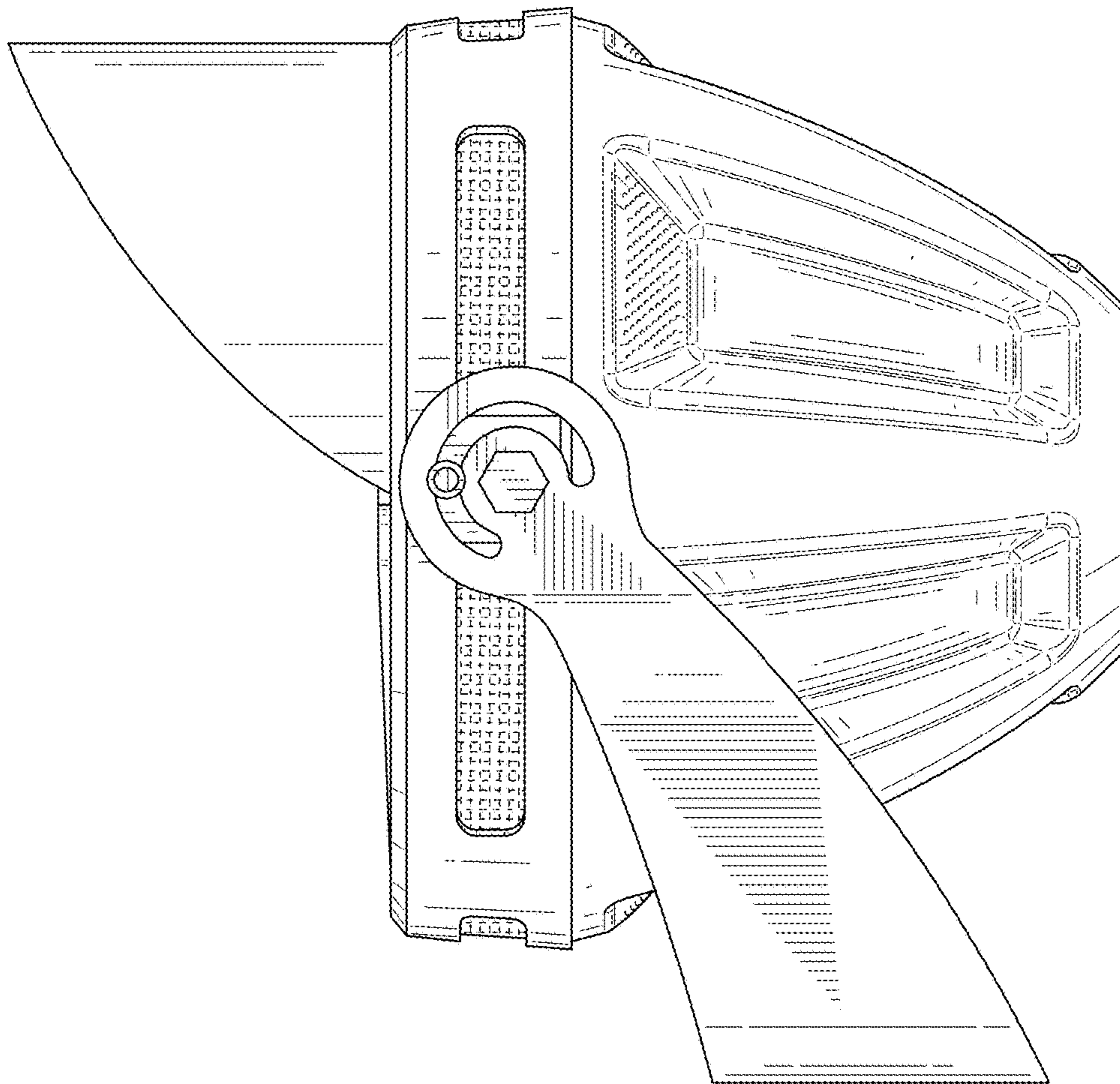

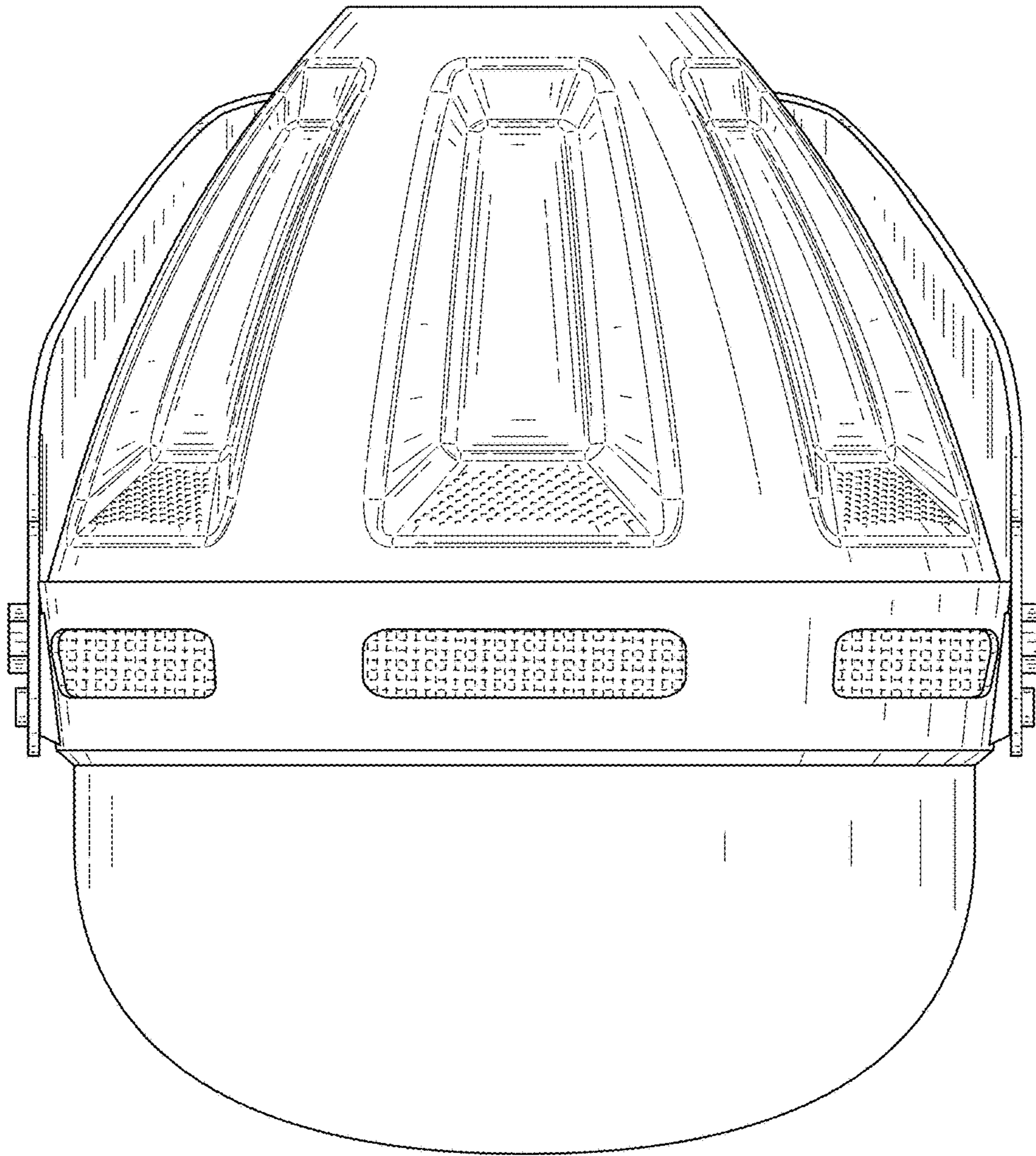

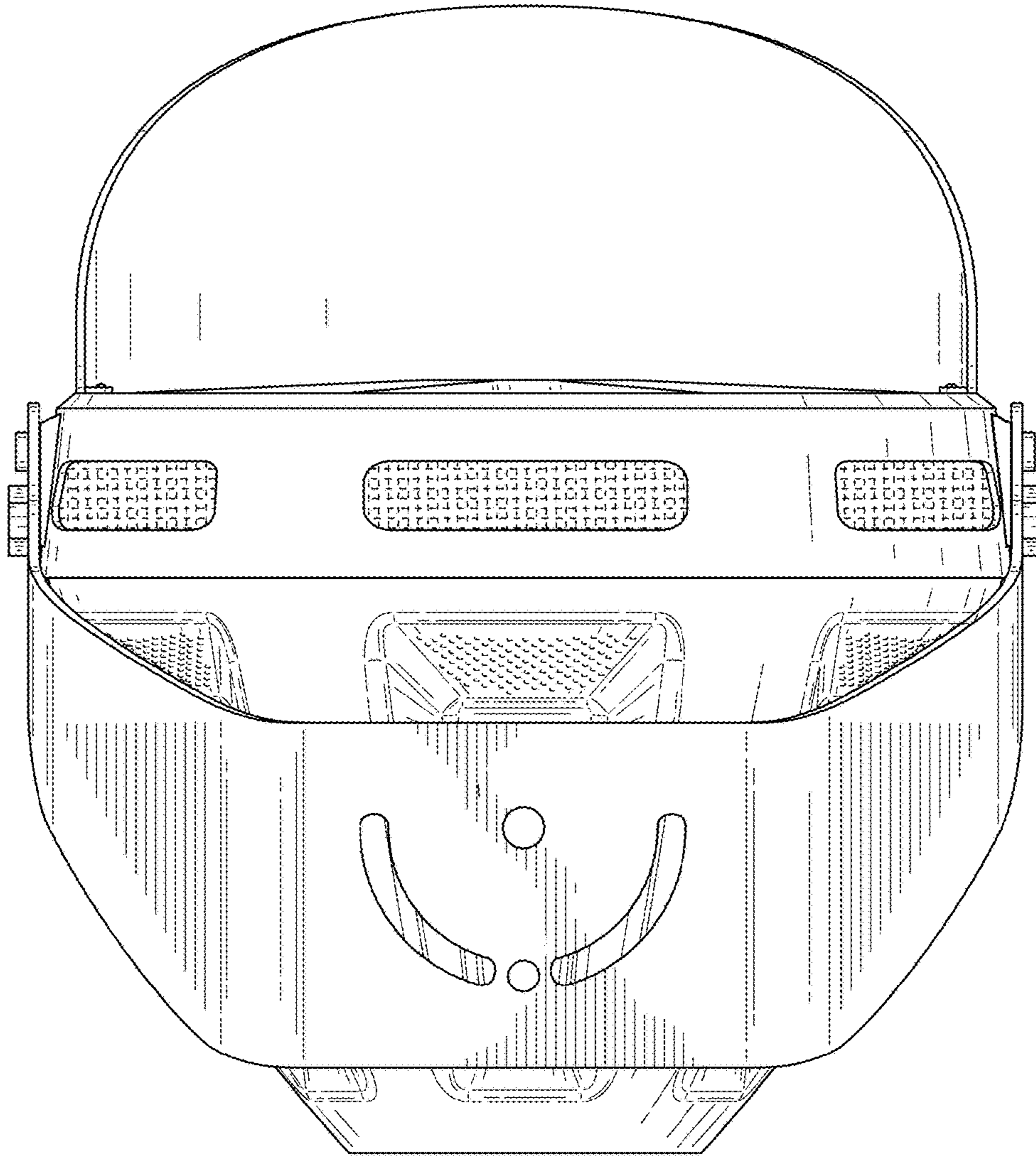
