FIG. 1 is a top view of a right hand welding glove showing my new design, a left hand welding glove being a mirror image thereof.

FIG. 2 is a bottom view of the right hand welding glove showing my new design, the left hand welding glove being a mirror image thereof.

FIG. 3 is a first left side view of the right hand welding glove showing my new design with fingers raised, the left hand welding glove being a mirror image thereof.

FIG. 4 is a second left side view of the right hand welding glove showing my new design with fingers straight, the left hand welding glove being a mirror image thereof.

FIG. 5 is a third left side view of the right hand welding glove showing my new design with fingers lowered, the left hand welding glove being a mirror image thereof.

FIG. 6 is a left side and top view of the right hand welding glove showing my new design, the left hand welding glove being a mirror image thereof.

FIG. 7 is a right side view of the right hand welding glove showing my new design, the left hand welding glove being a mirror image thereof.

FIG. 8 is a right side and top view of the right hand welding glove showing my new design, the left hand welding glove being a mirror image thereof.

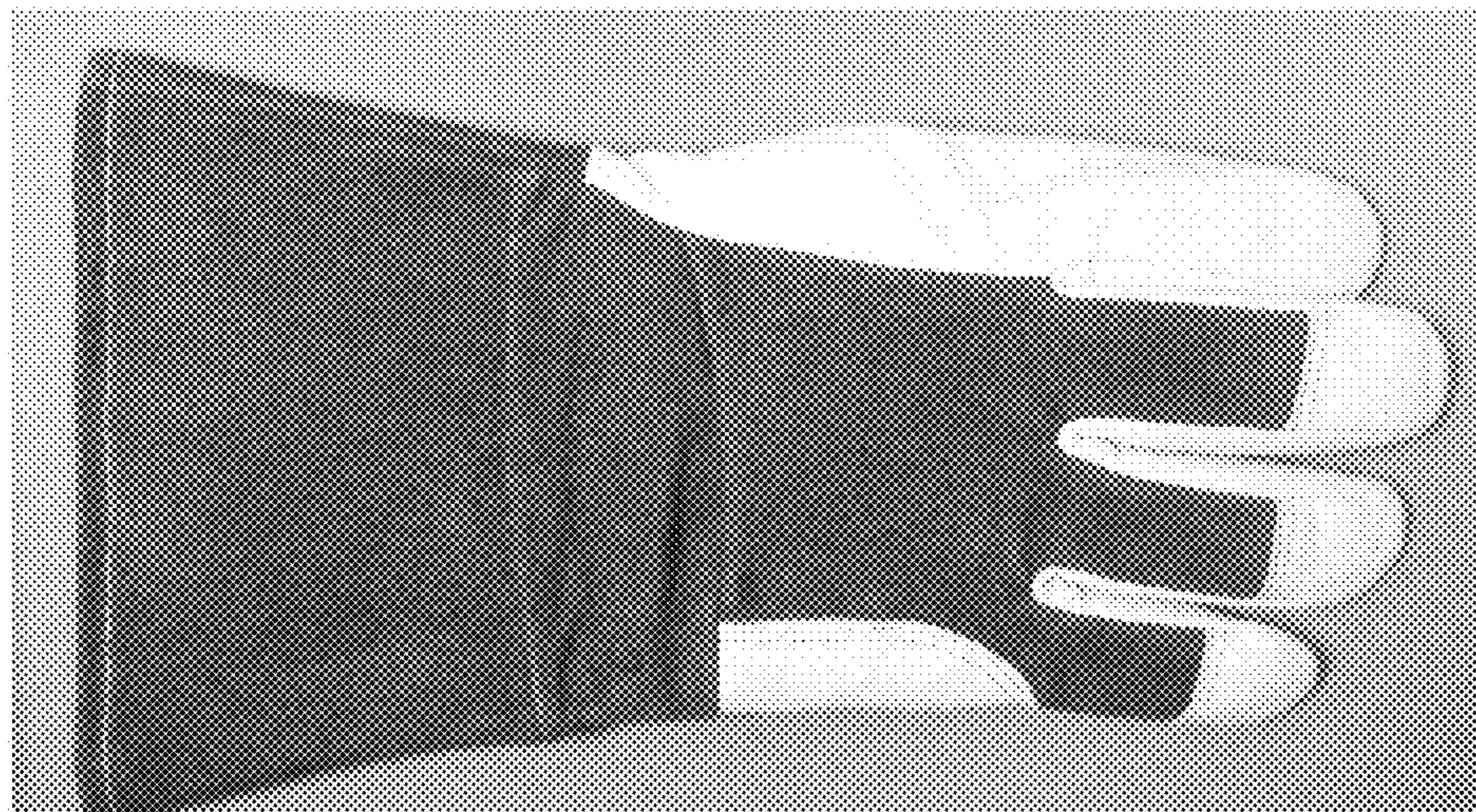
FIG. 9 is a second right side and top view of the right hand welding glove showing my new design, the left hand welding glove being a mirror image thereof.

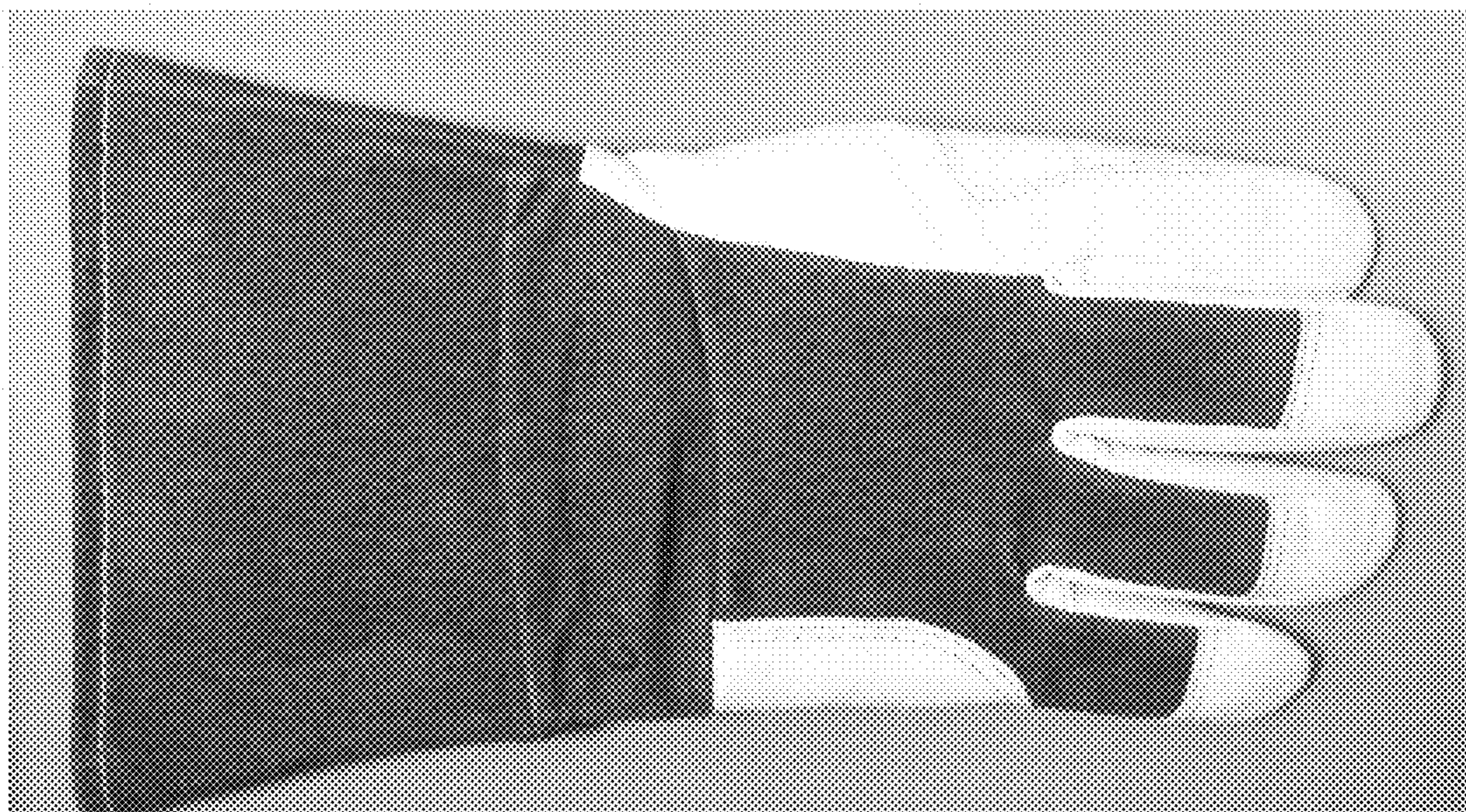

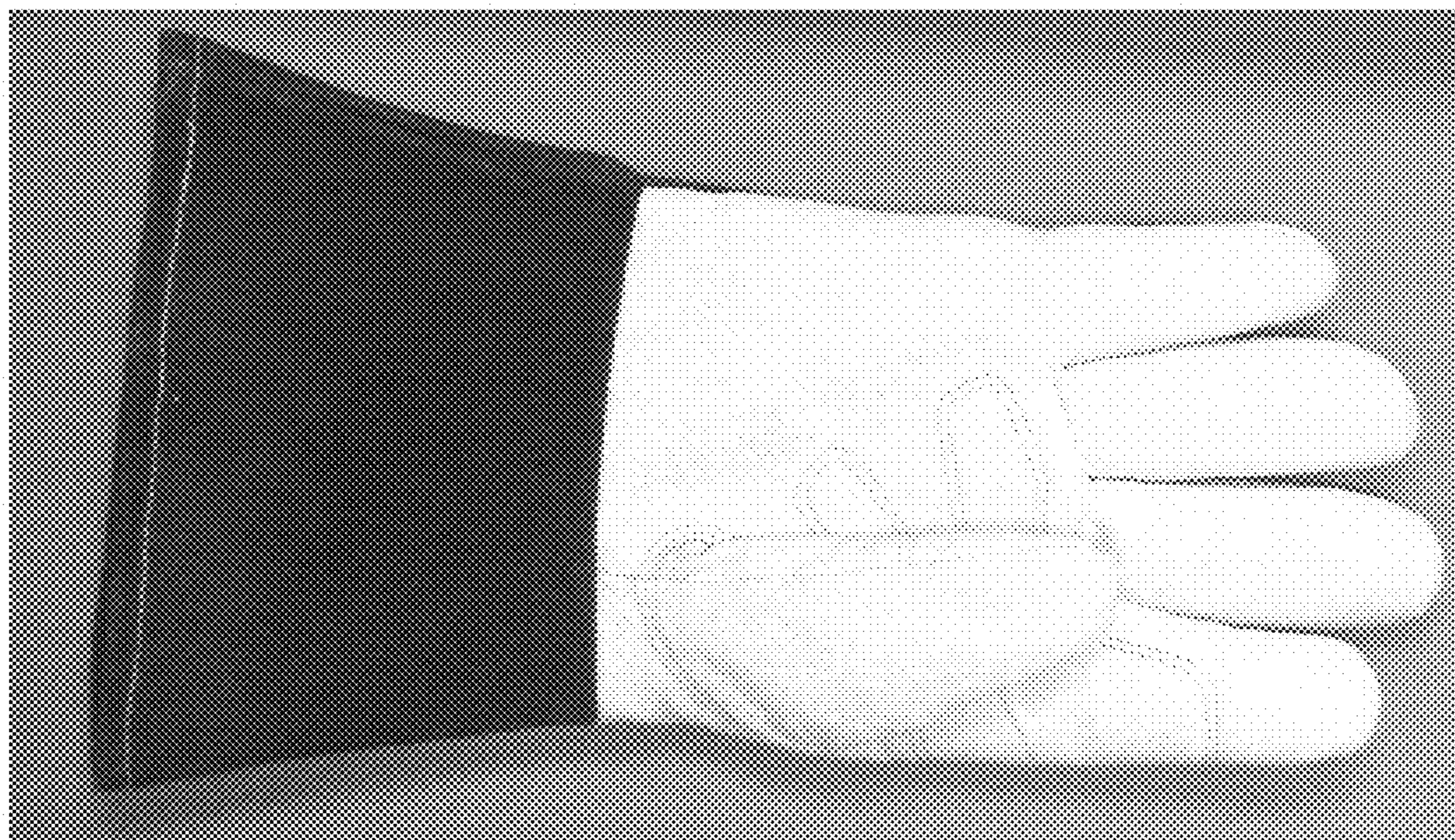

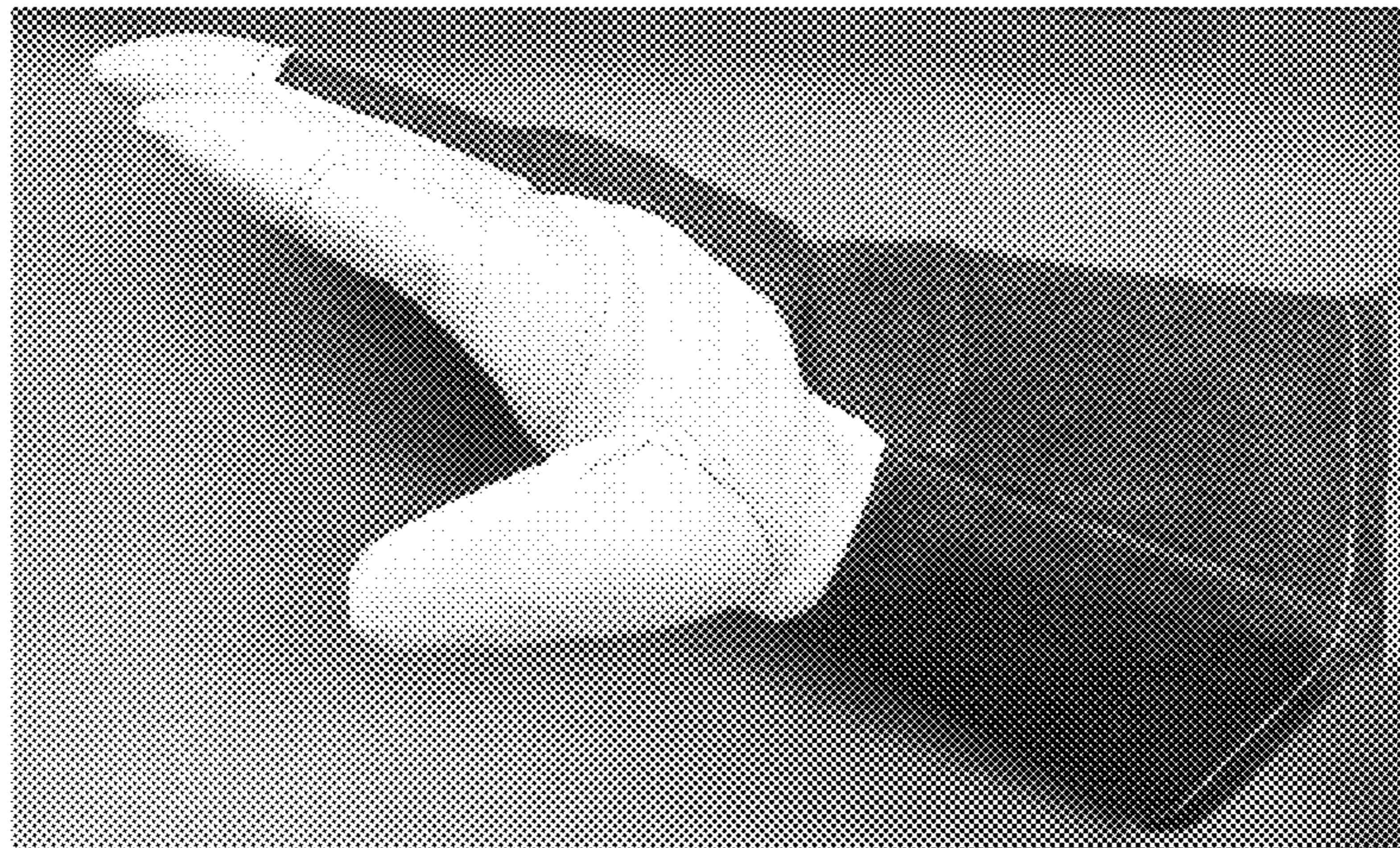

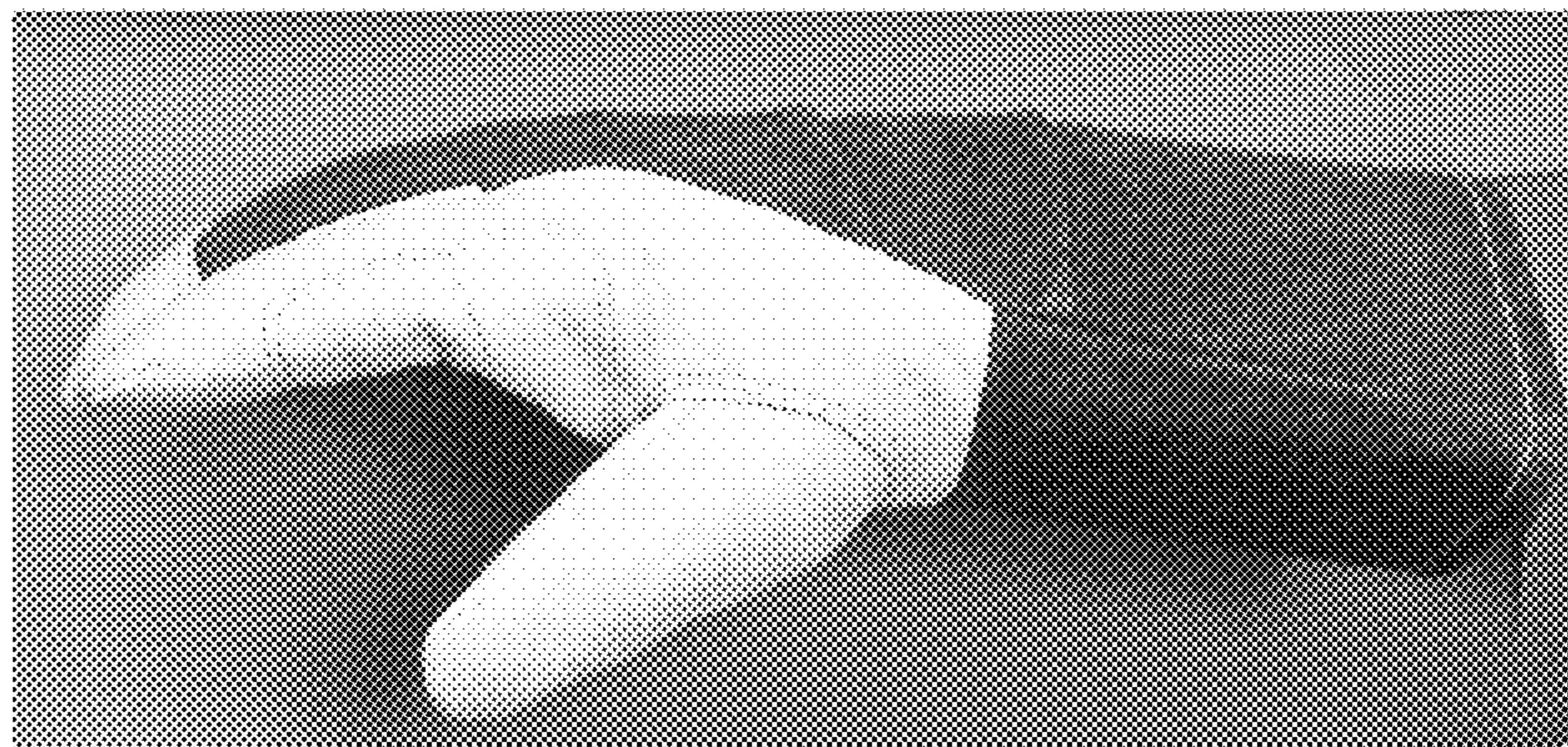

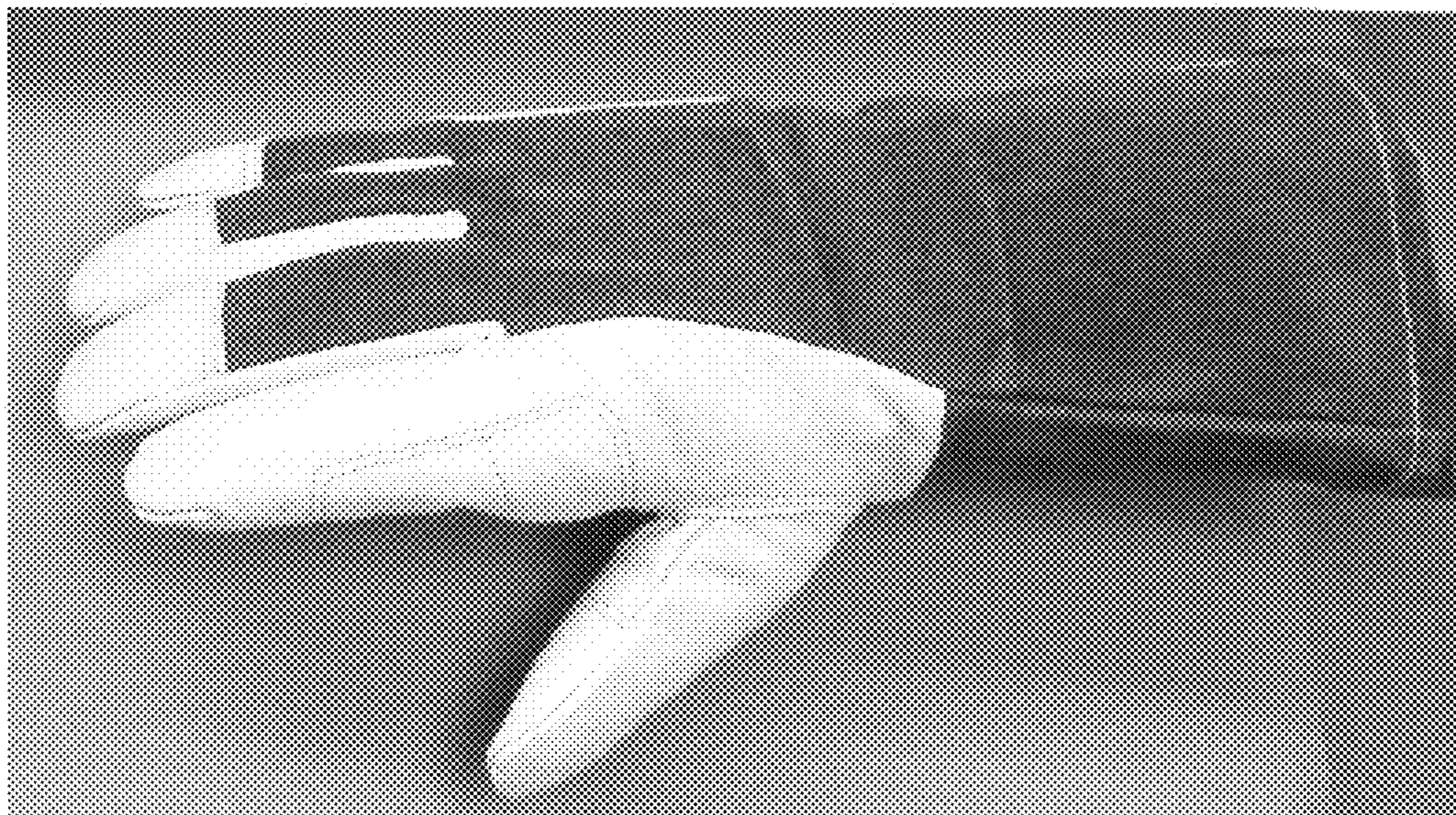

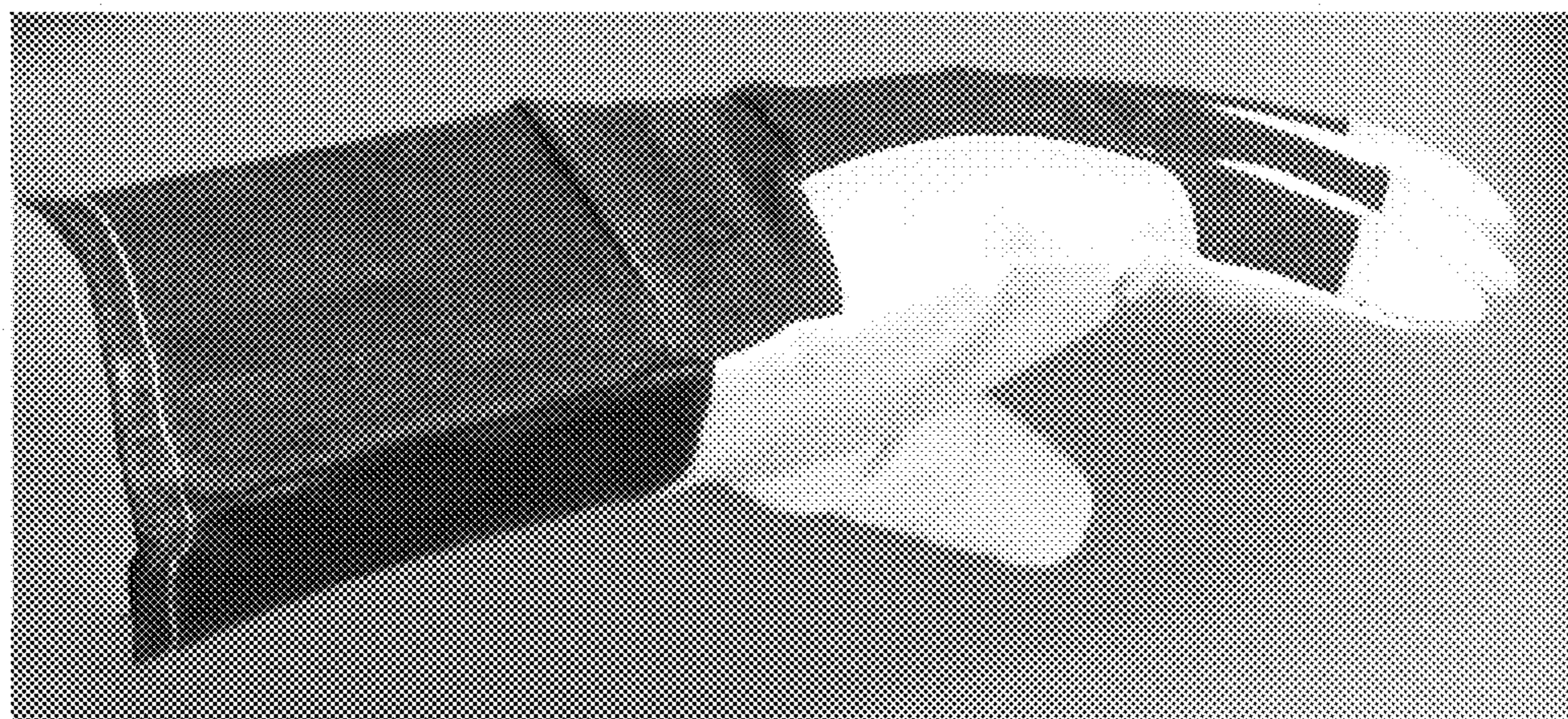

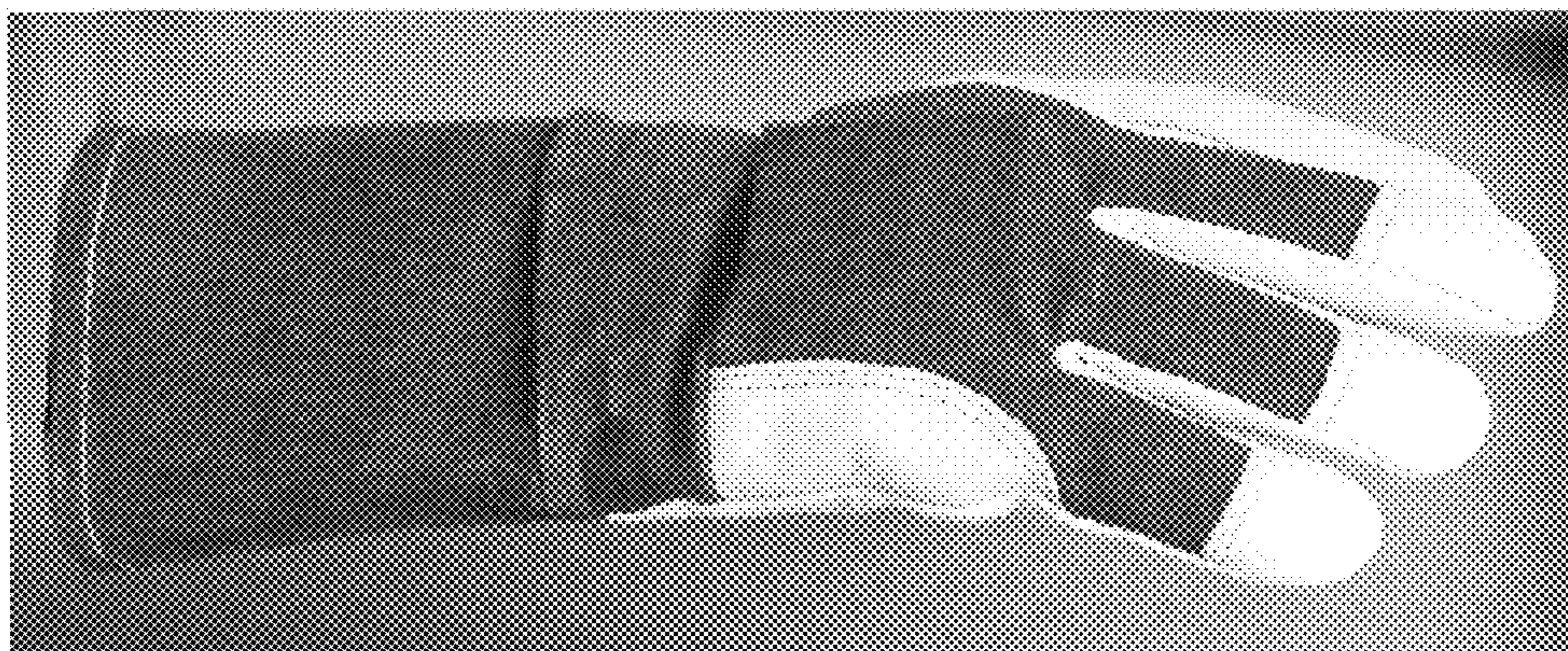

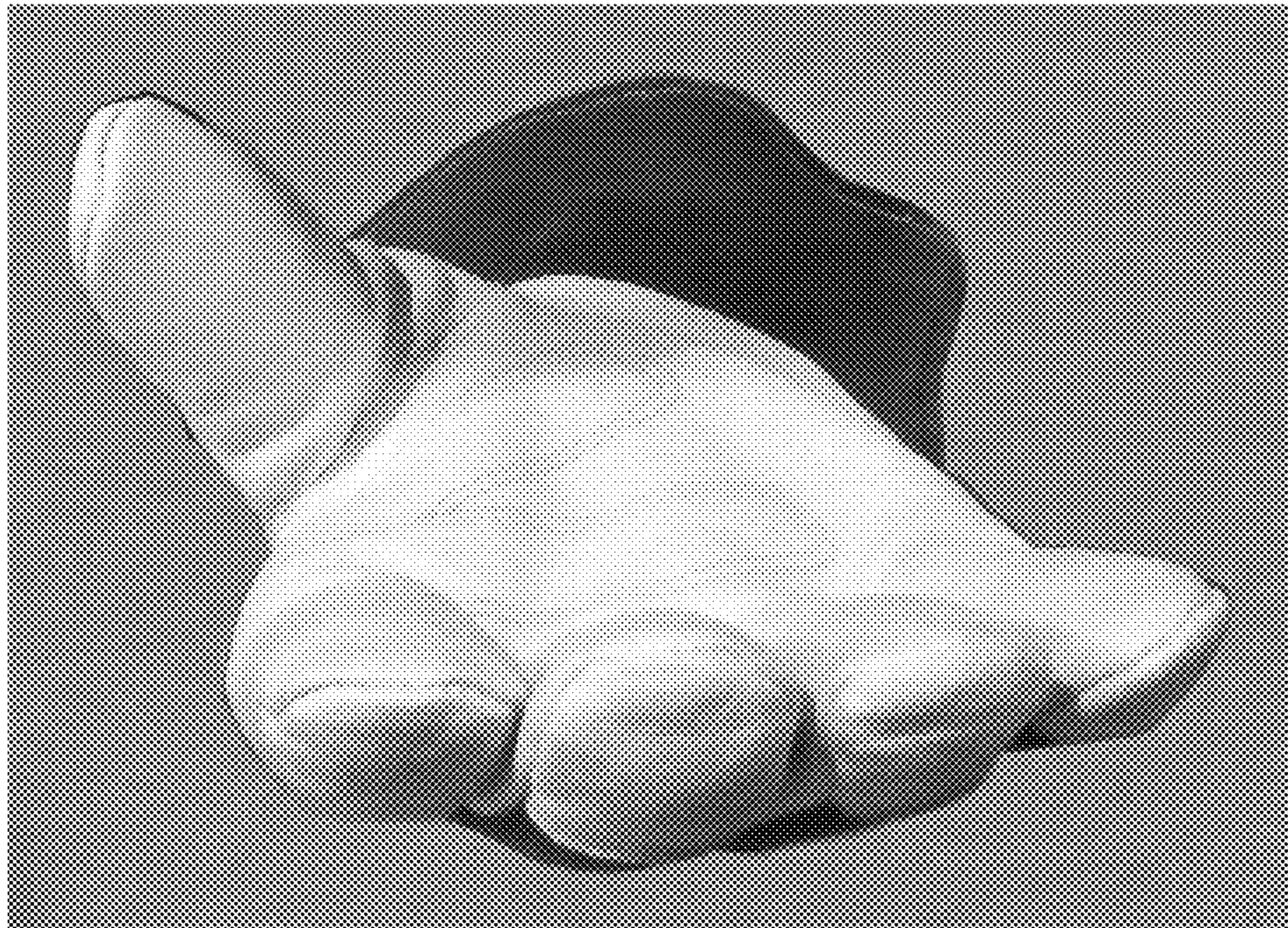

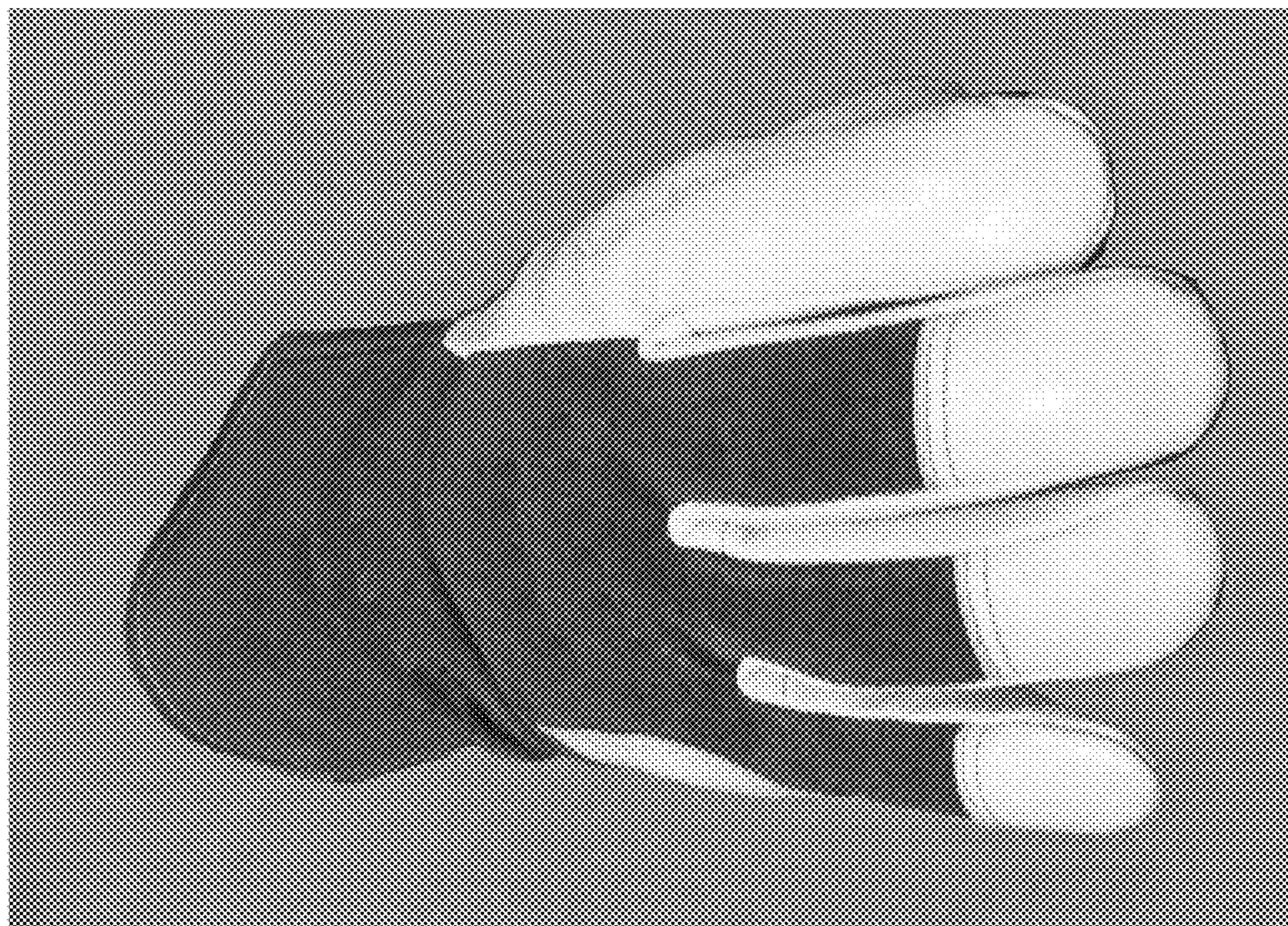

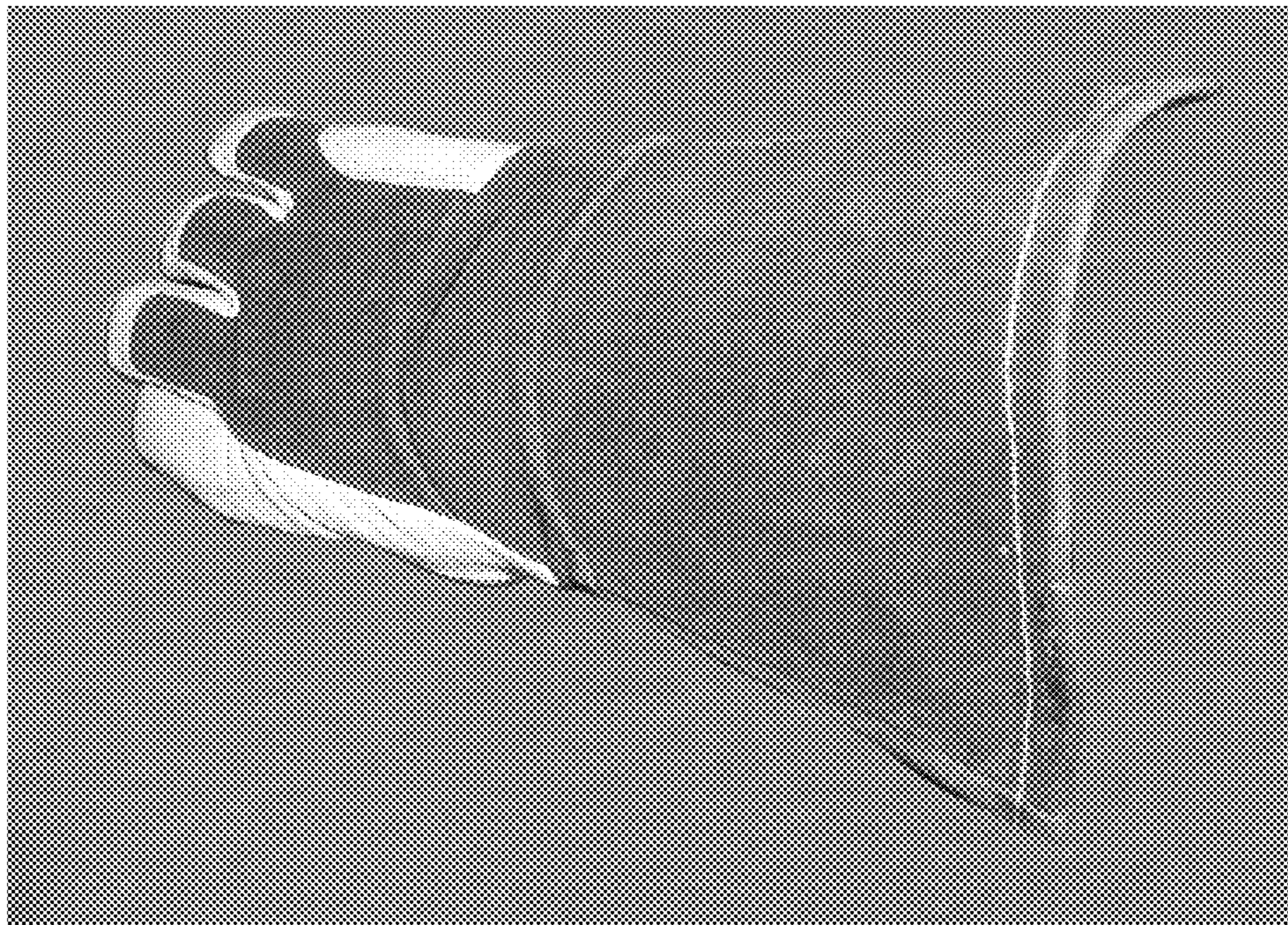
