(57) **CLAIM**

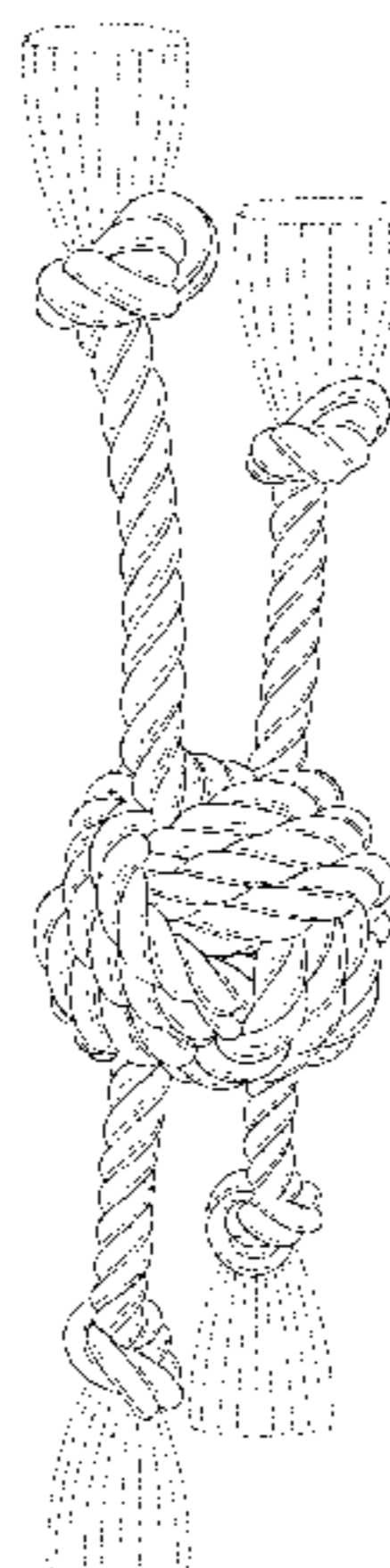
We claim the ornamental design for a knotted rope toy, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of the knotted rope toy.
FIG. 2 is a front elevational view of the knotted rope toy.
FIG. 3 is a rear elevational view of the knotted rope toy.
FIG. 4 is a left elevational view of the knotted rope toy.
FIG. 5 is a right elevational view of the knotted rope toy.
FIG. 6 is a top plan view of the knotted rope toy; and,
FIG. 7 is a bottom plan view of the knotted rope toy.
The broken lines in the drawings illustrate portions of the knotted rope toy that form no part of the claimed design.

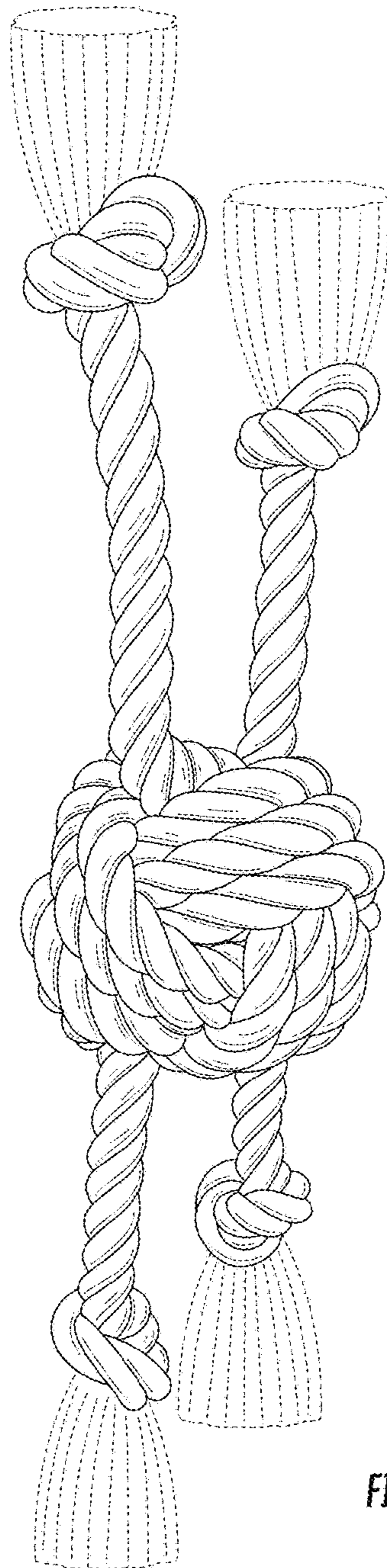

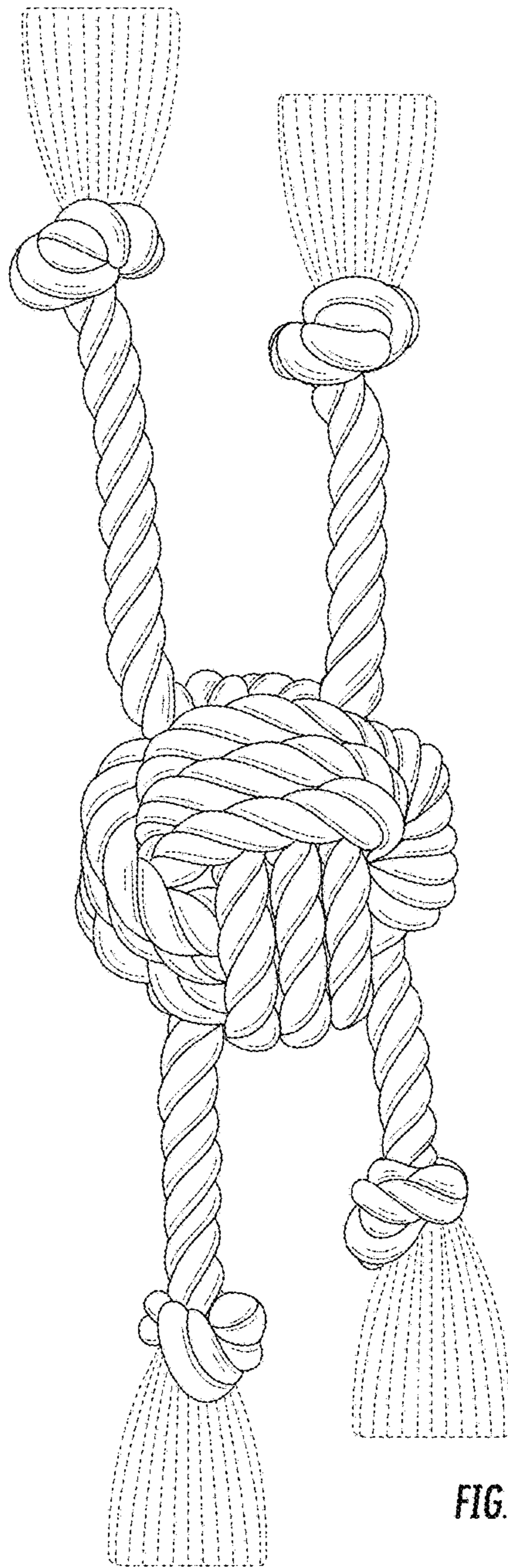
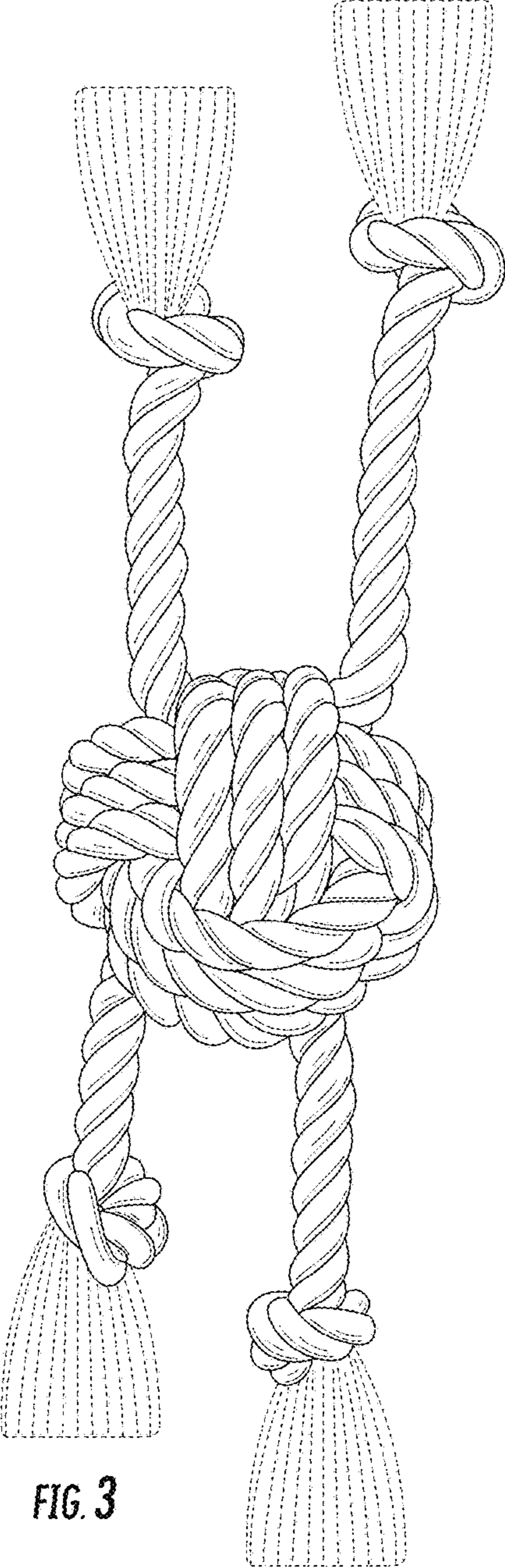

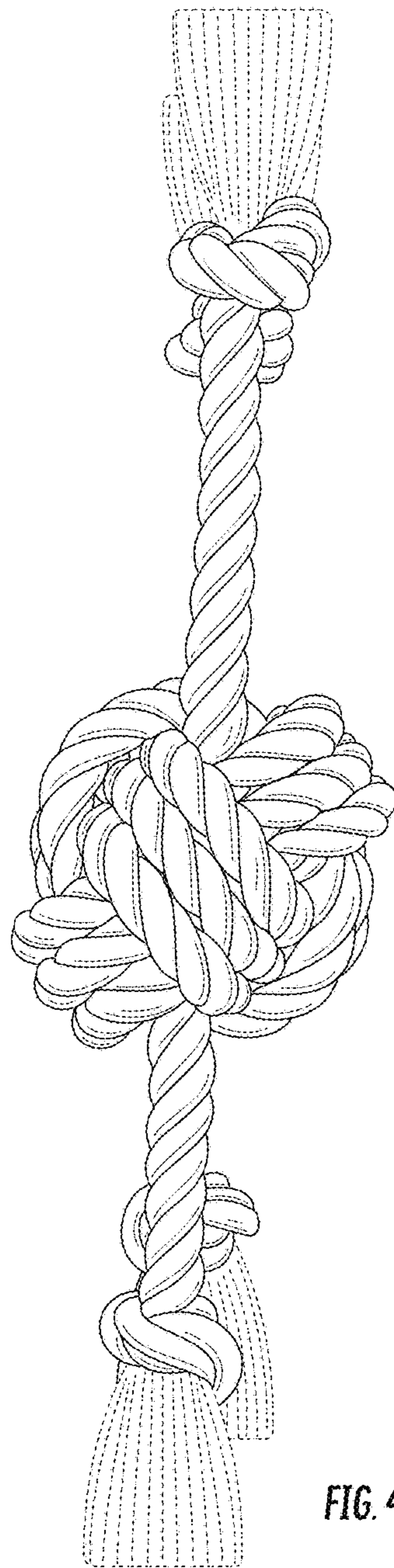

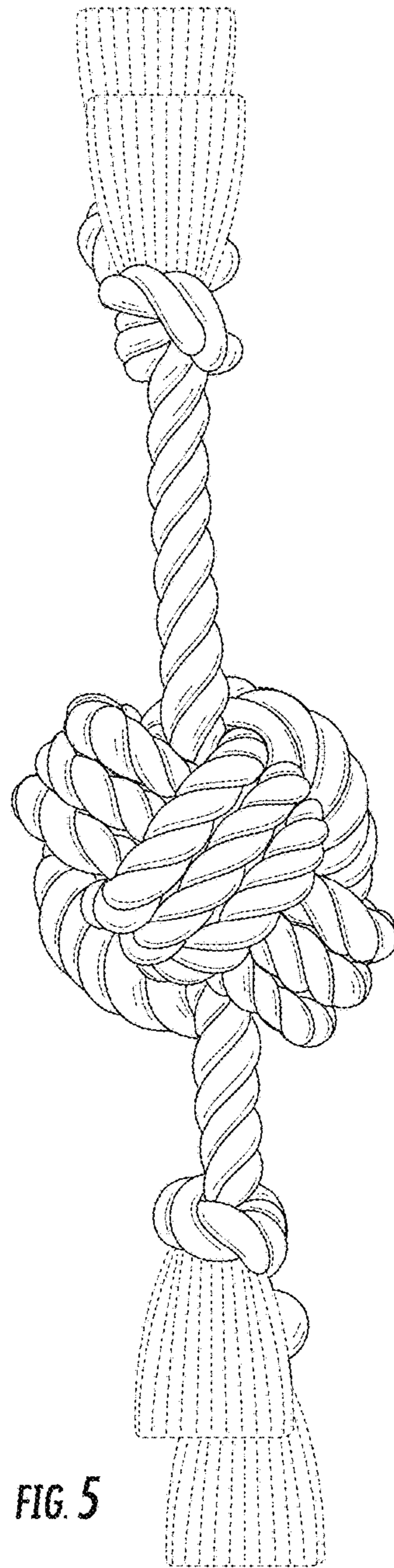

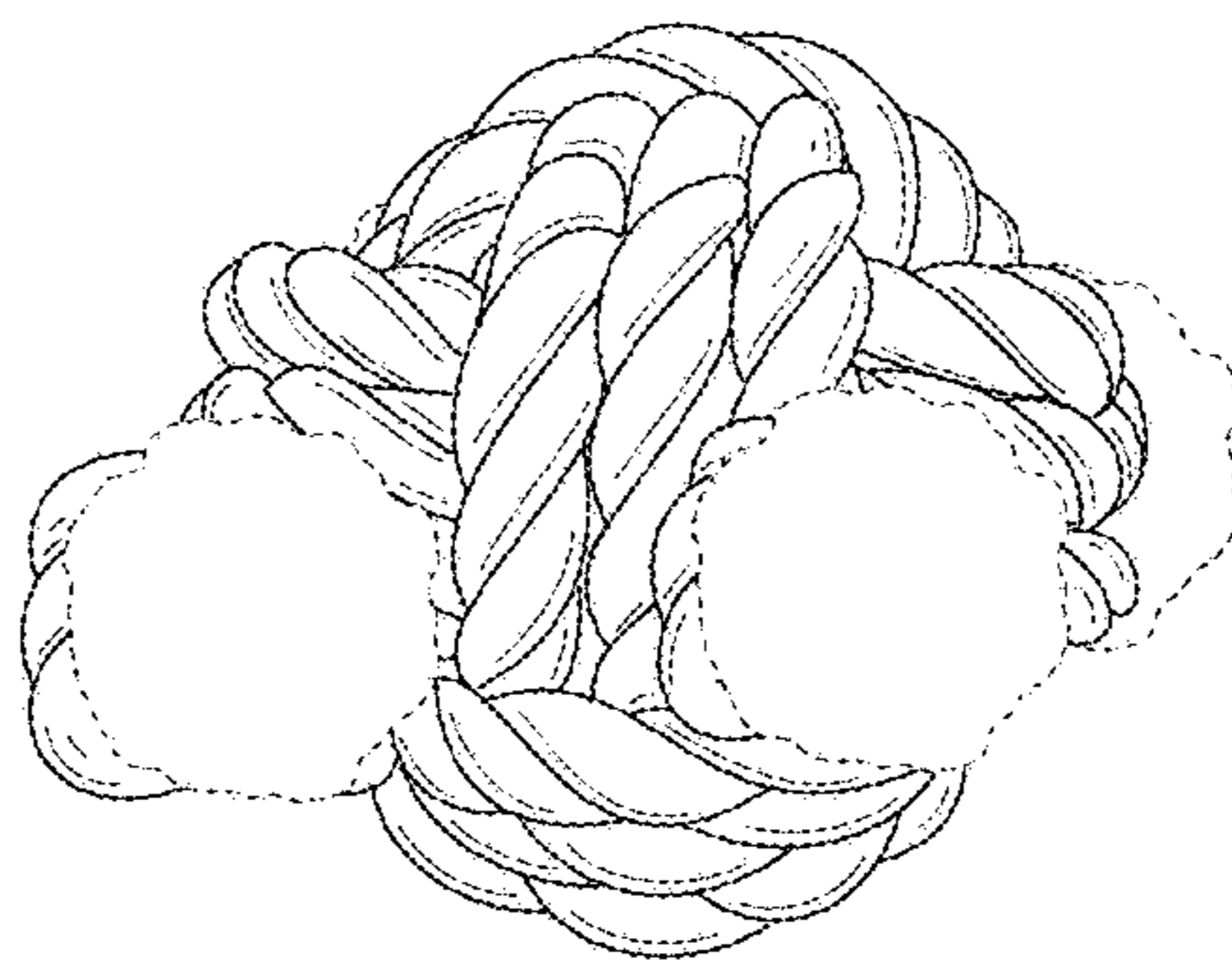

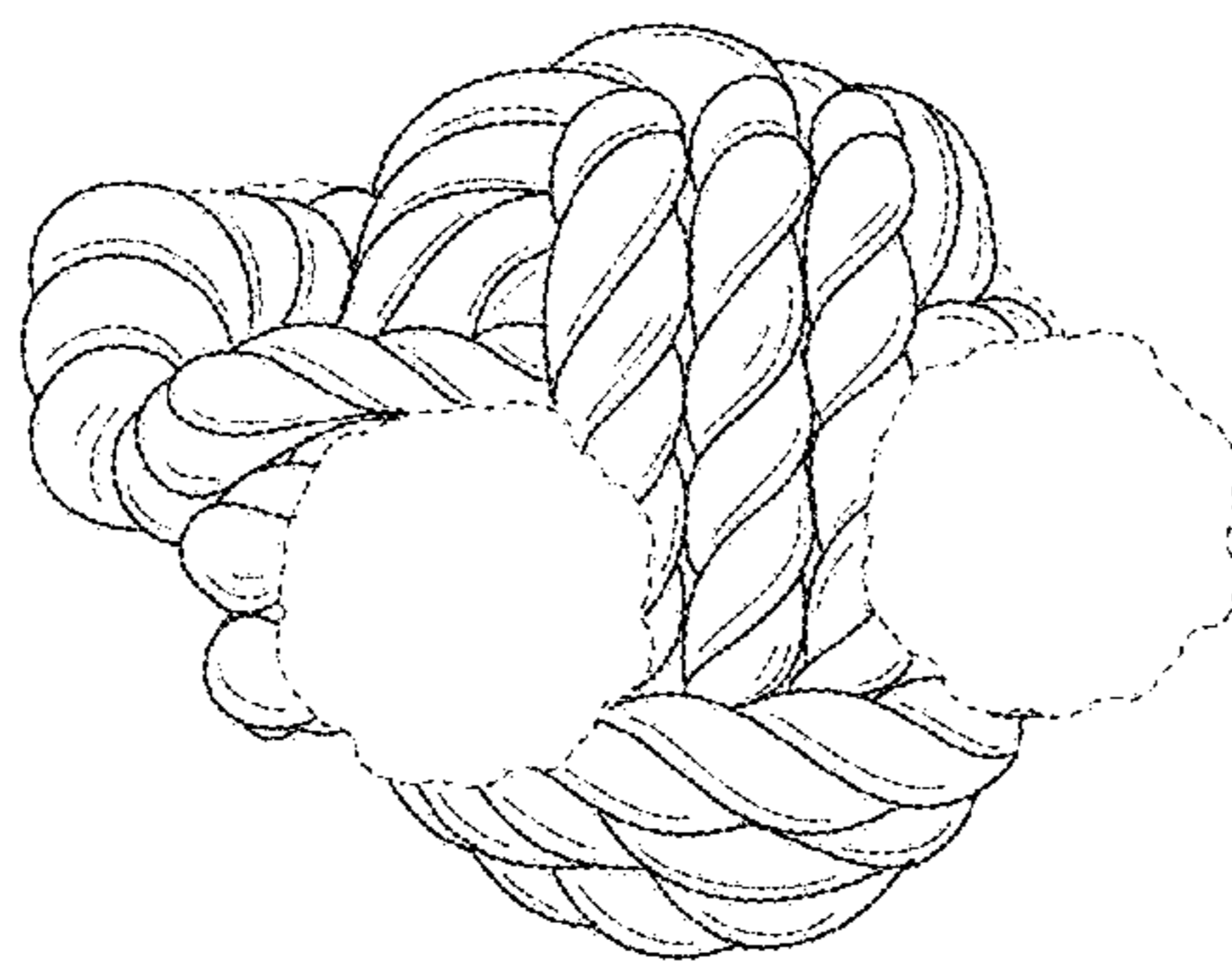
