DESCRIPTION

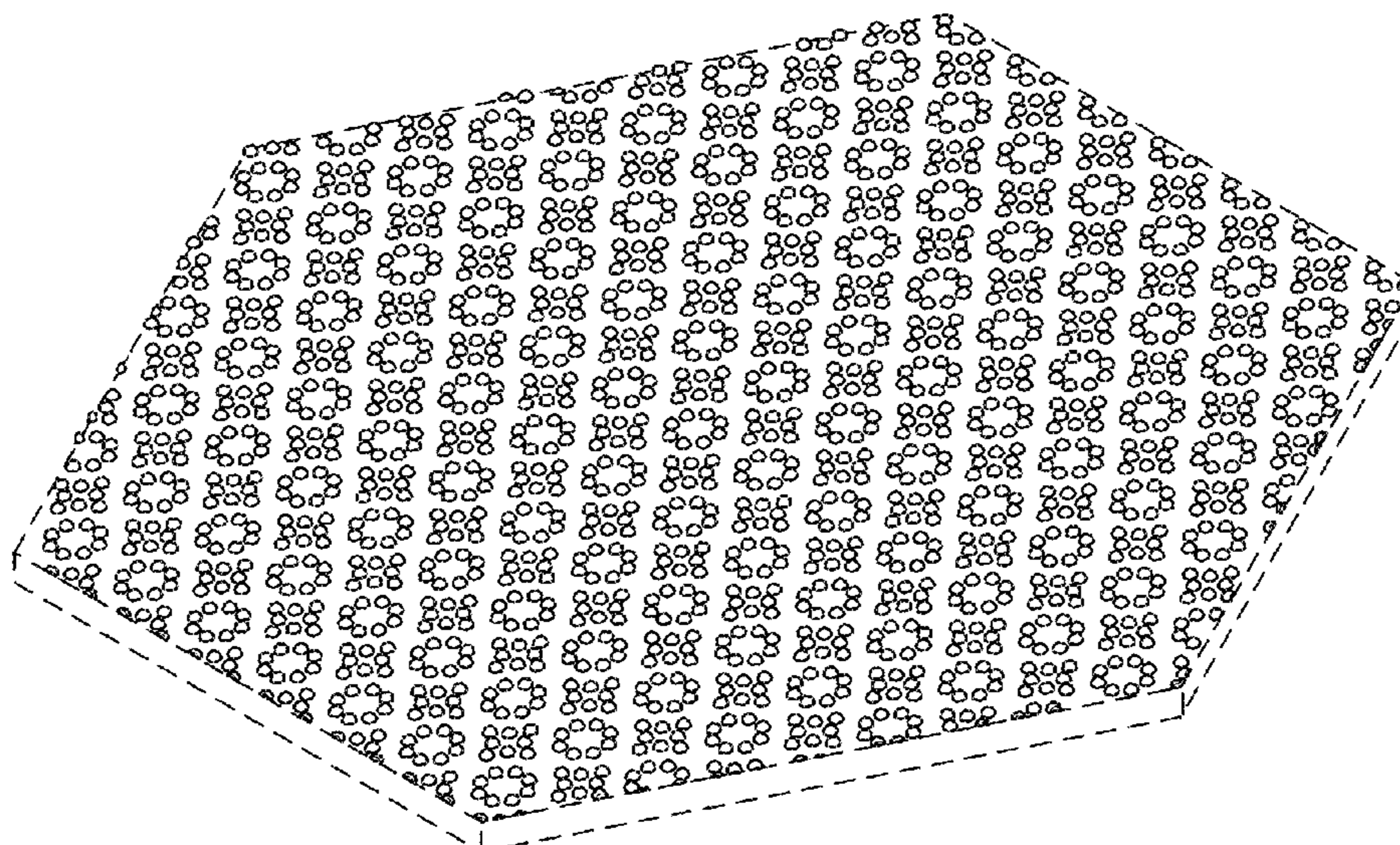
FIG. 1 is an orthogonal view showing the new design for a scouring pad. The scouring pad in FIGS. 1-5 has a hexagonal shape.

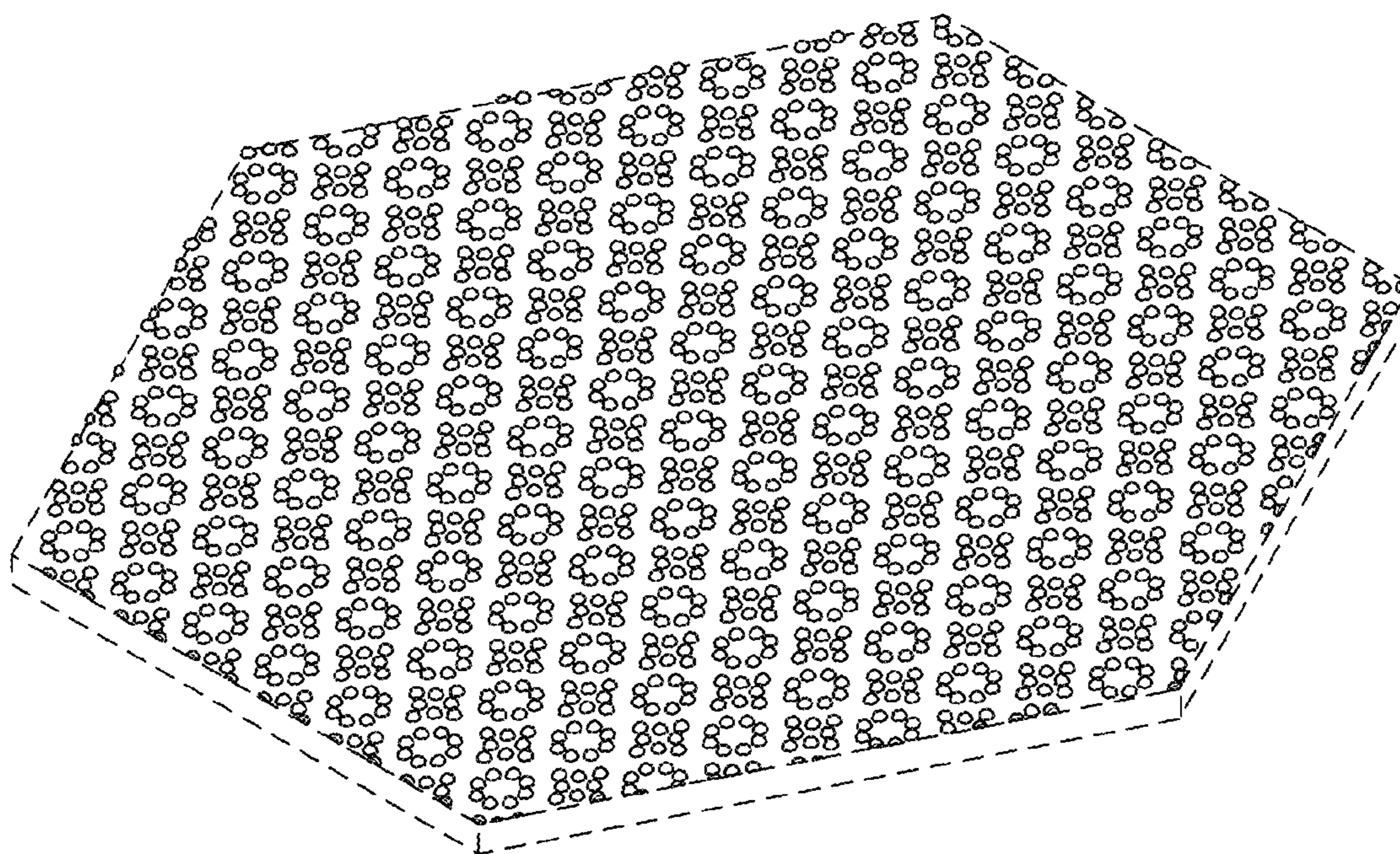

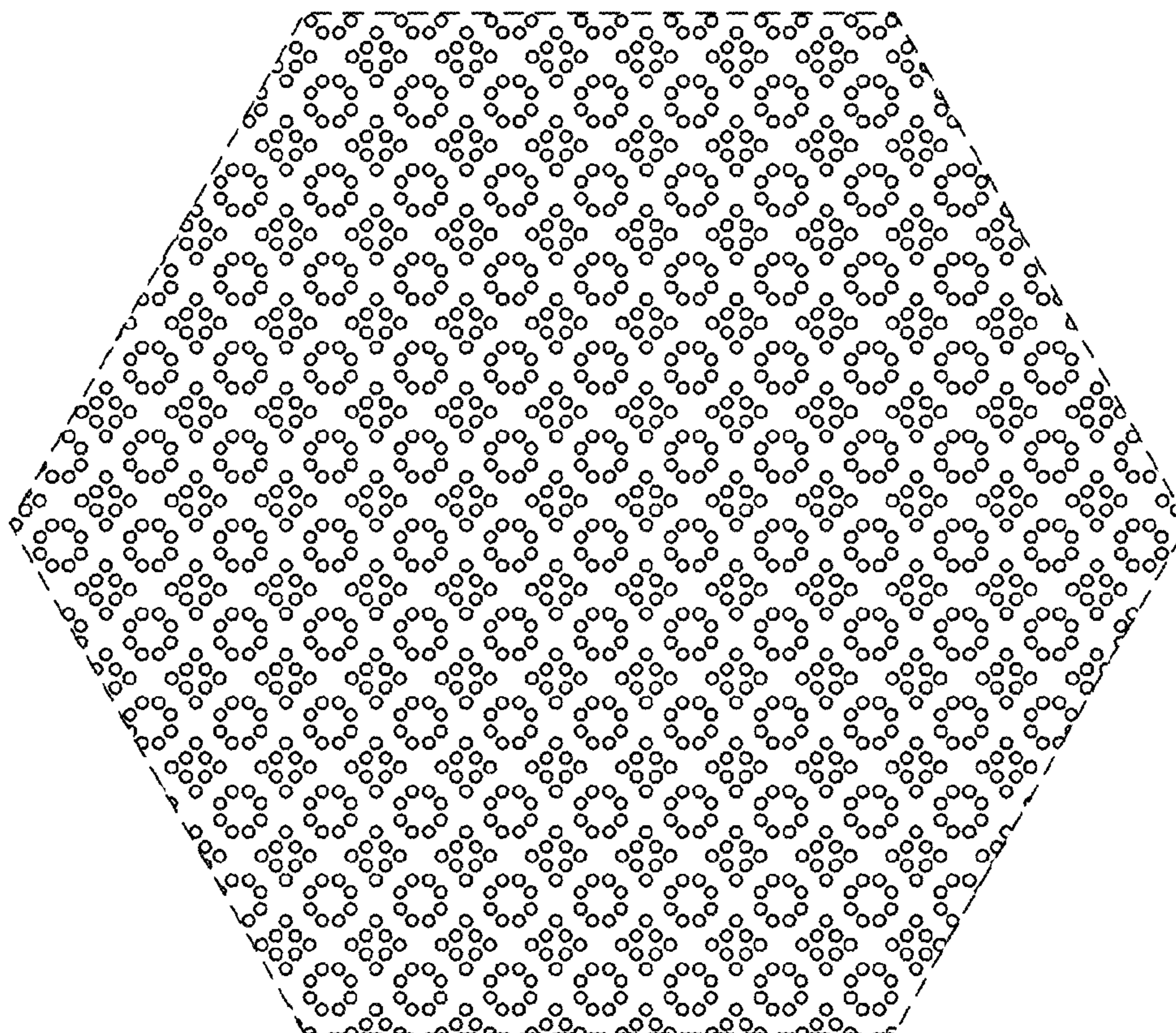

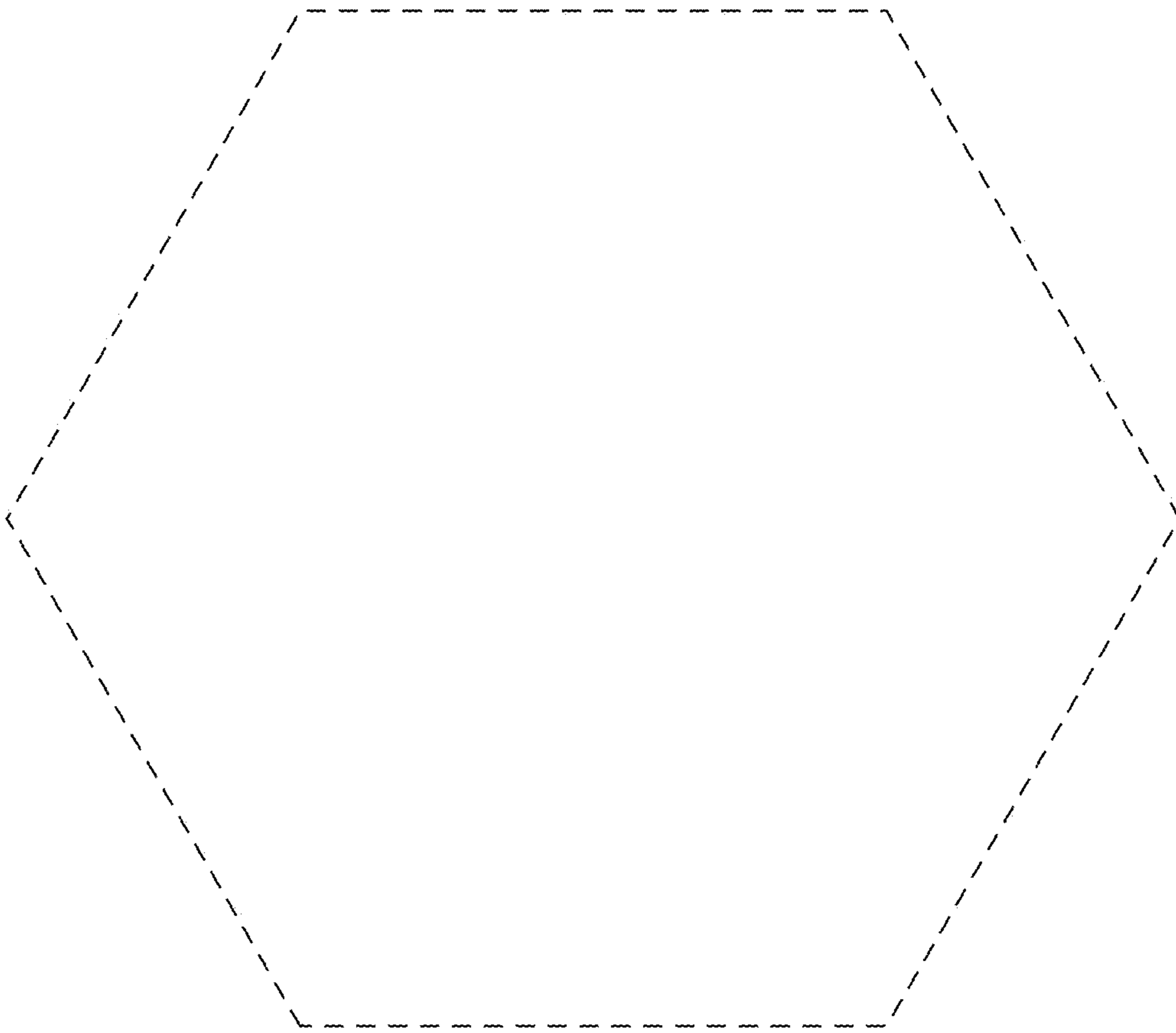
