(57) **CLAIM**

The ornamental design for a tool grip, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a tool grip according to the present disclosure;  
FIG. 2 is a bottom perspective view of the tool grip of FIG. 1;  
FIG. 3 is a first side view of the tool grip of FIG. 1;  
FIG. 4 is a second, opposite side view of the tool grip of FIG. 1;  
FIG. 5 is a front view of the tool grip of FIG. 1, the rear view being a mirror image thereof;  
FIG. 6 is a top view of the tool grip of FIG. 1; and,  
FIG. 7 is a bottom view of the tool grip of FIG. 1.  
The broken lines depict portions of the tool grip in which the design is embodied that are not considered part of the claimed design.

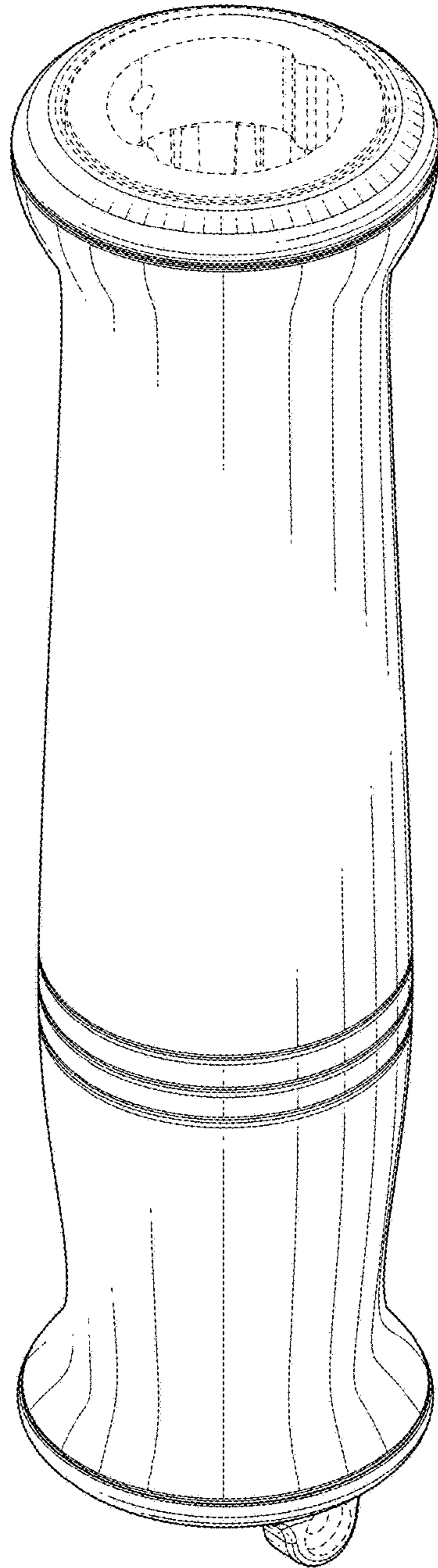

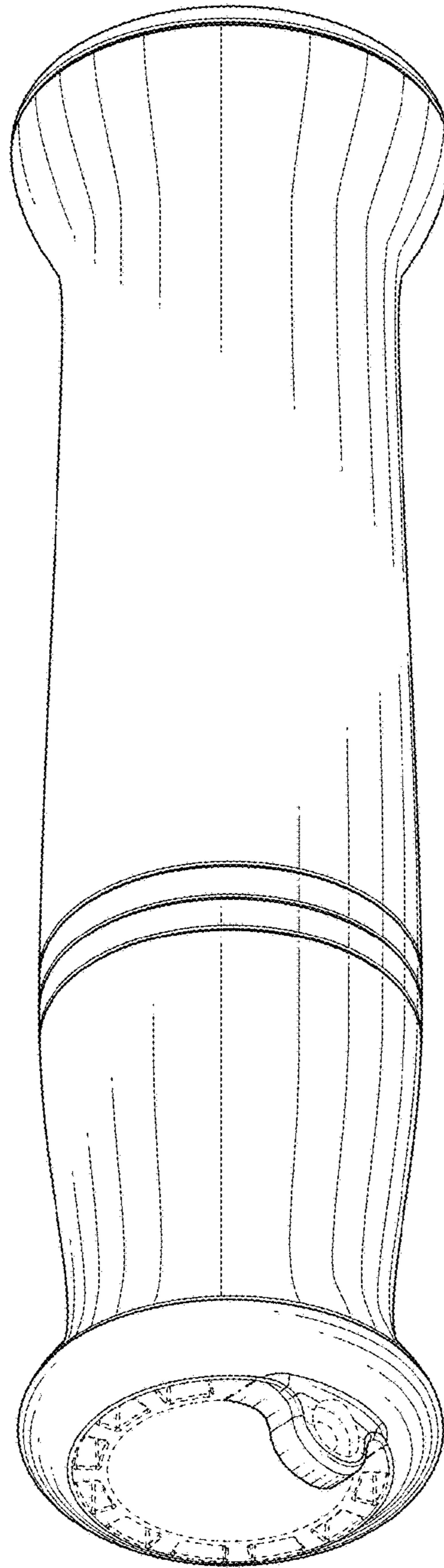

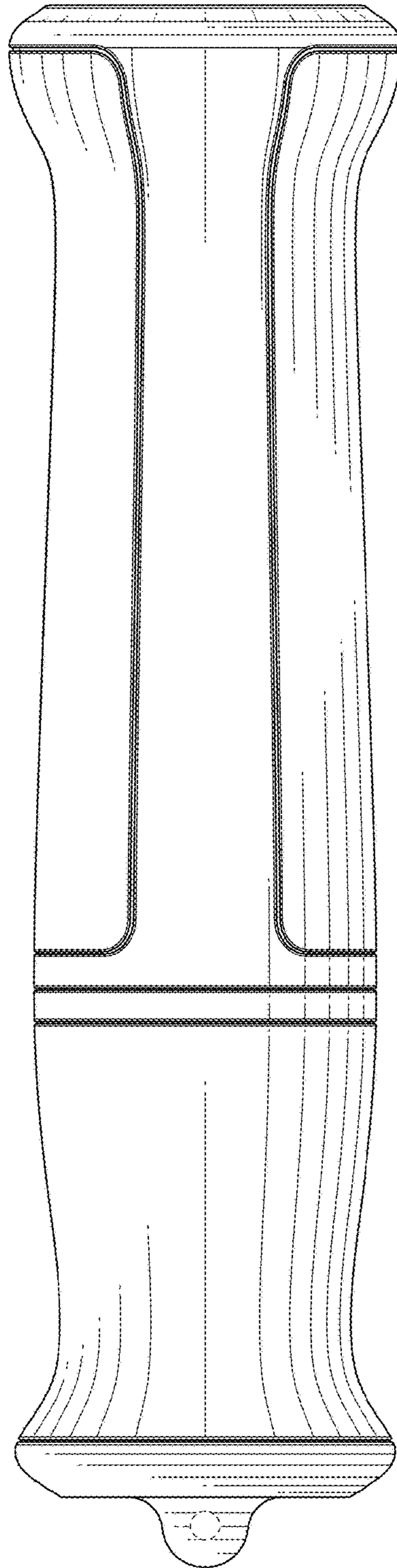

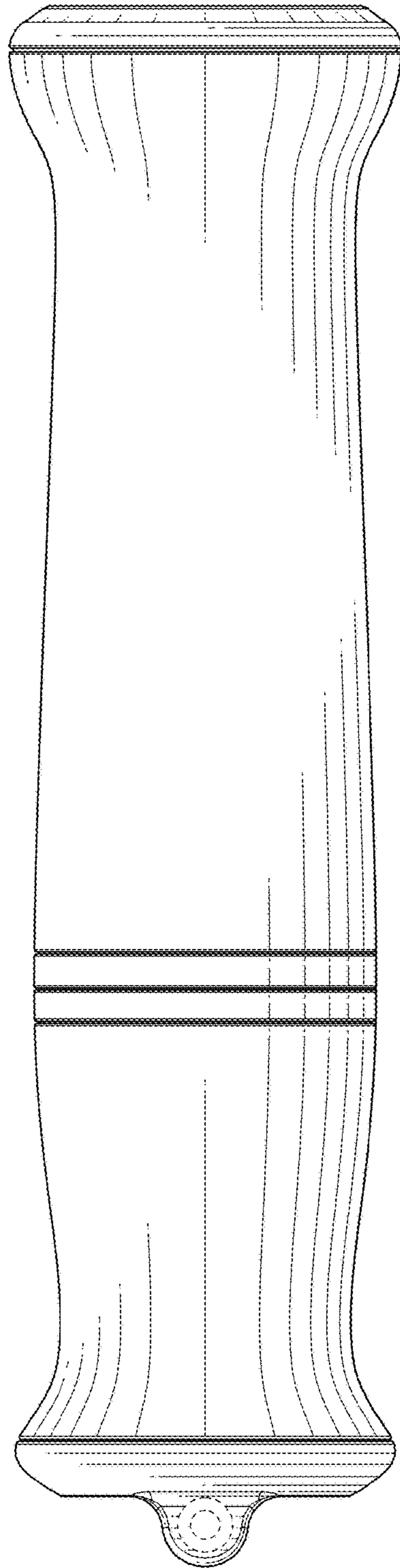

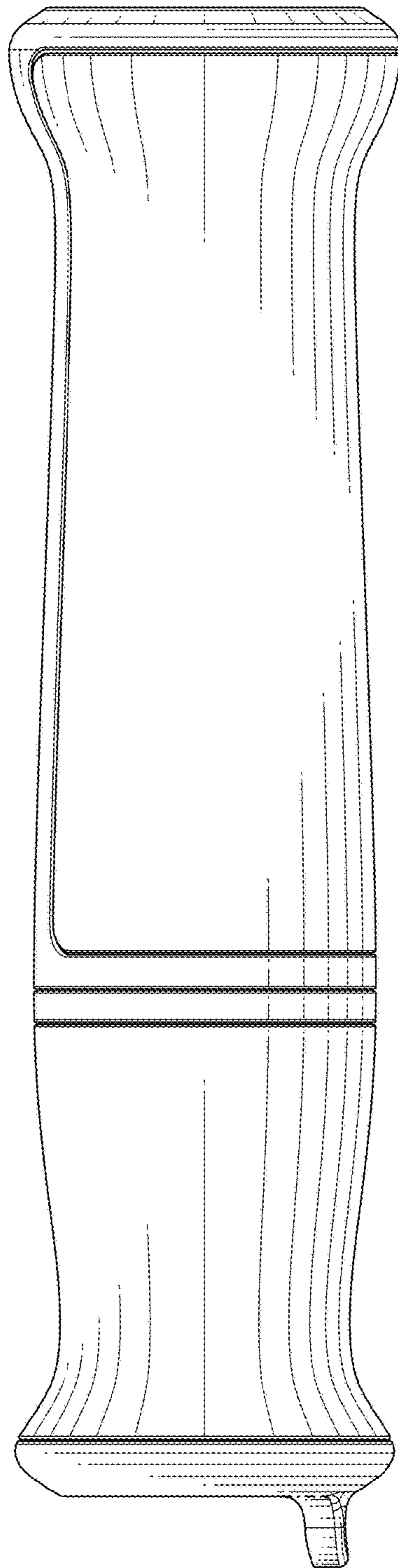

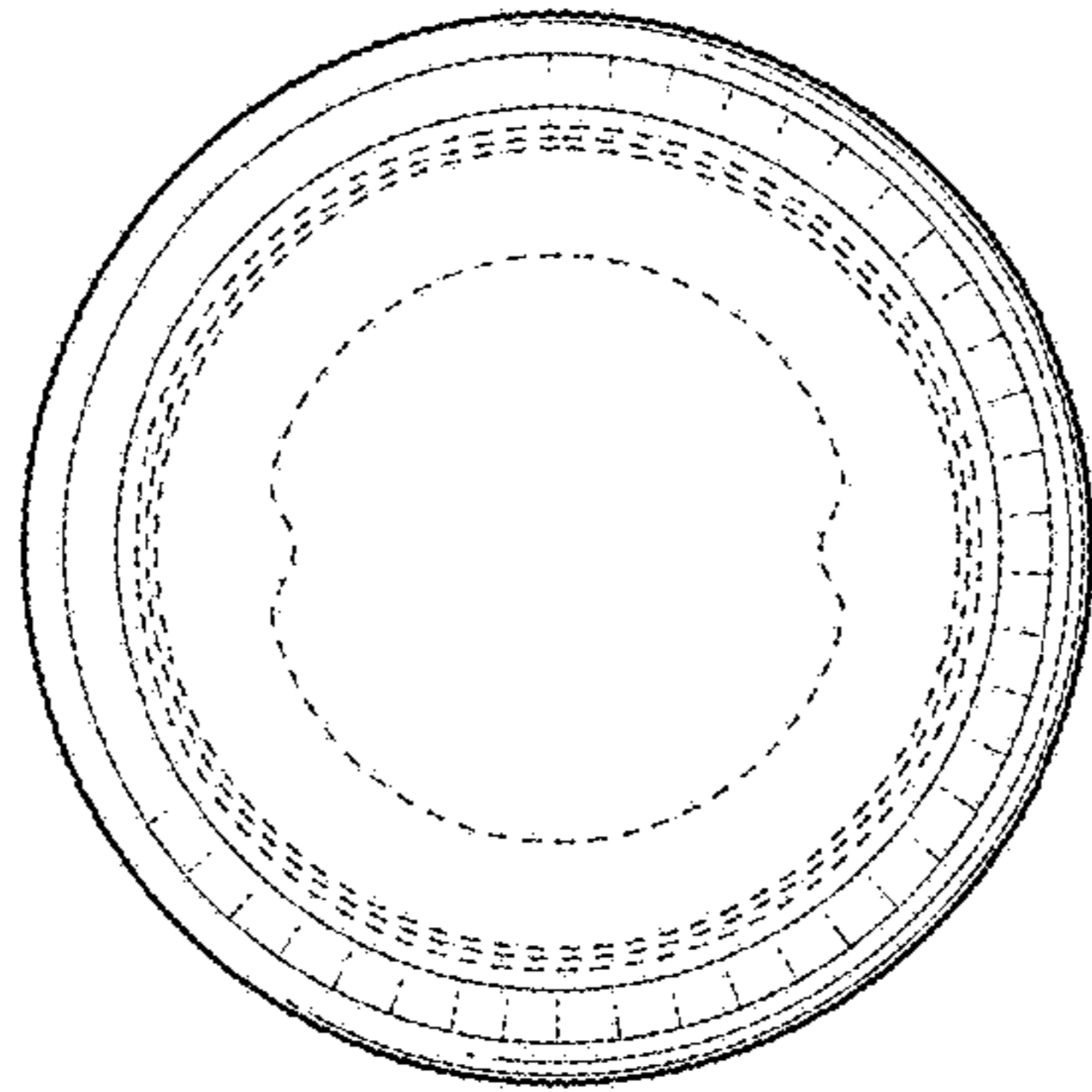

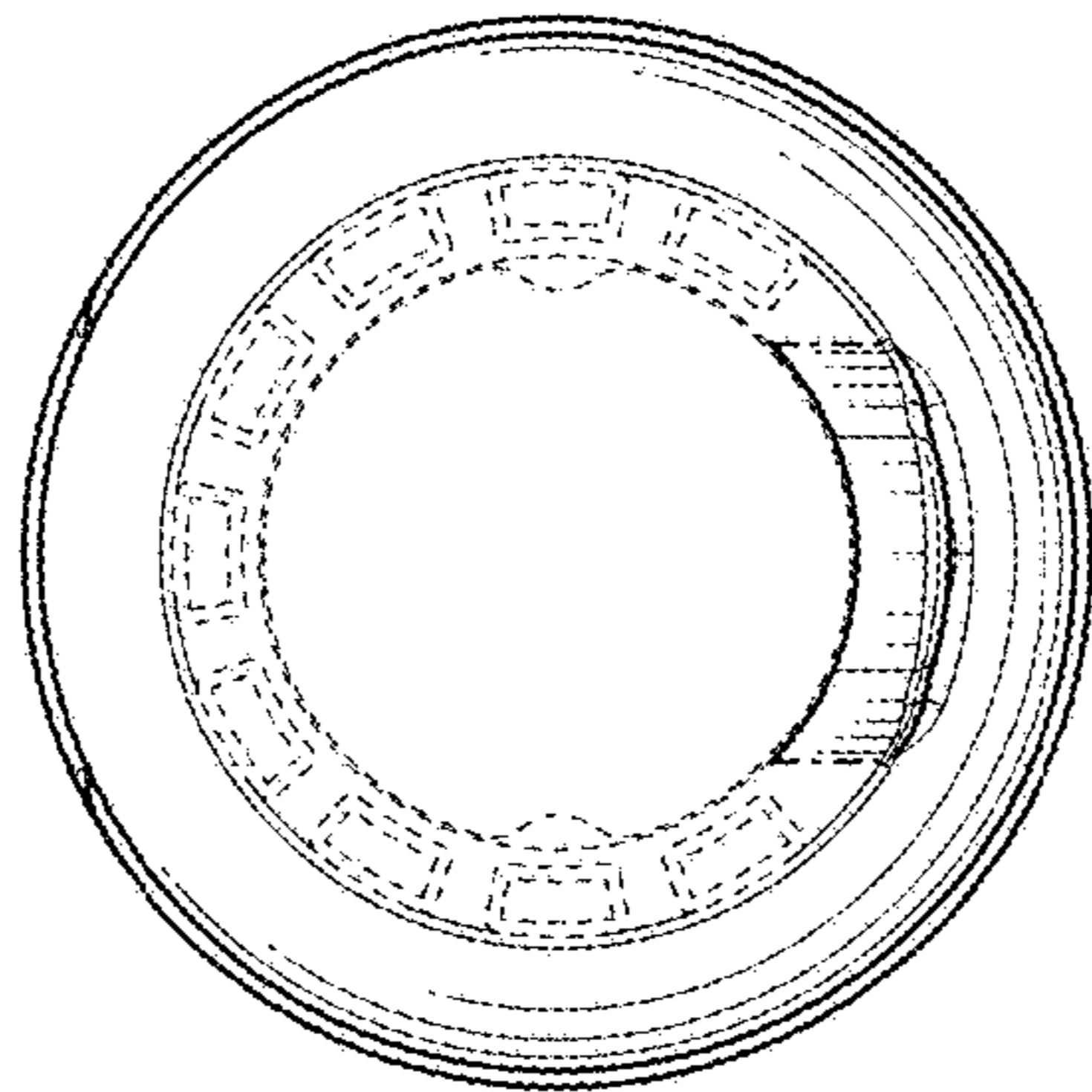
