(57) **CLAIM**

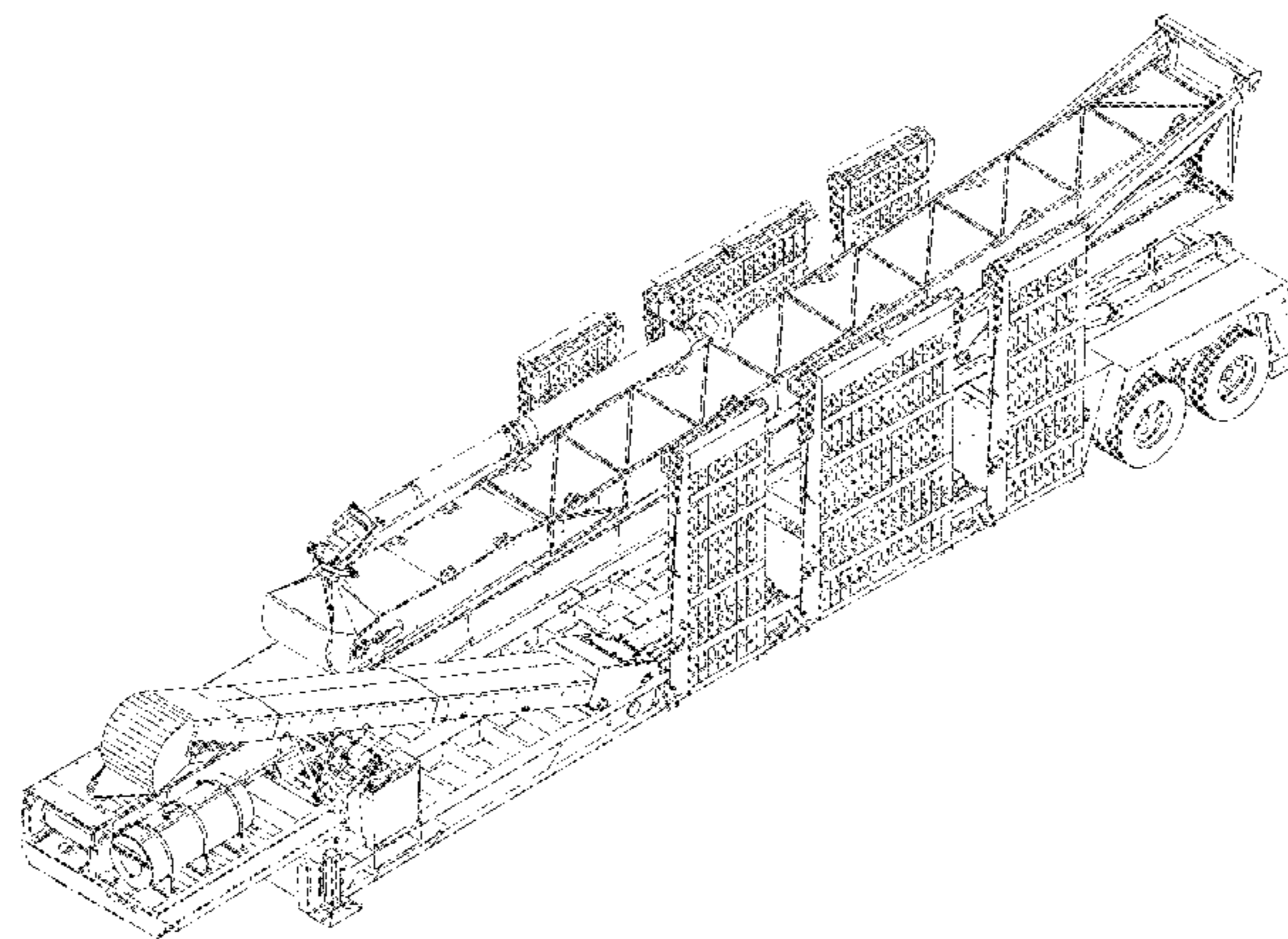
The ornamental design for a portable drive-over conveyor, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from a top, front and left side of portable drive-over conveyor showing my new design; FIG. 2 is a perspective view from the top, rear and left side thereof; FIG. 3 is a perspective view from the top, rear and right side thereof; FIG. 4 is a perspective view from the top, front, and right side thereof; FIG. 5 is a perspective view from a bottom, front and left side thereof; FIG. 6 is a perspective view from the bottom, rear and left side thereof; FIG. 7 is a perspective view from the bottom, rear and right side thereof; FIG. 8 is a perspective view from the bottom, front, and right side thereof; FIG. 9 is a left side elevational view thereof; FIG. 10 is a rear elevational view shown at a larger scale thereof; FIG. 11 is a right side elevational view thereof; FIG. 12 is a front elevational view shown at a larger scale thereof; FIG. 13 a top plan view thereof; and, FIG. 14 is a bottom plan view thereof.

The broken lines shown in the figures are for the purpose of illustrating portions of the portable drive-over conveyor, which form no part of the claimed design.

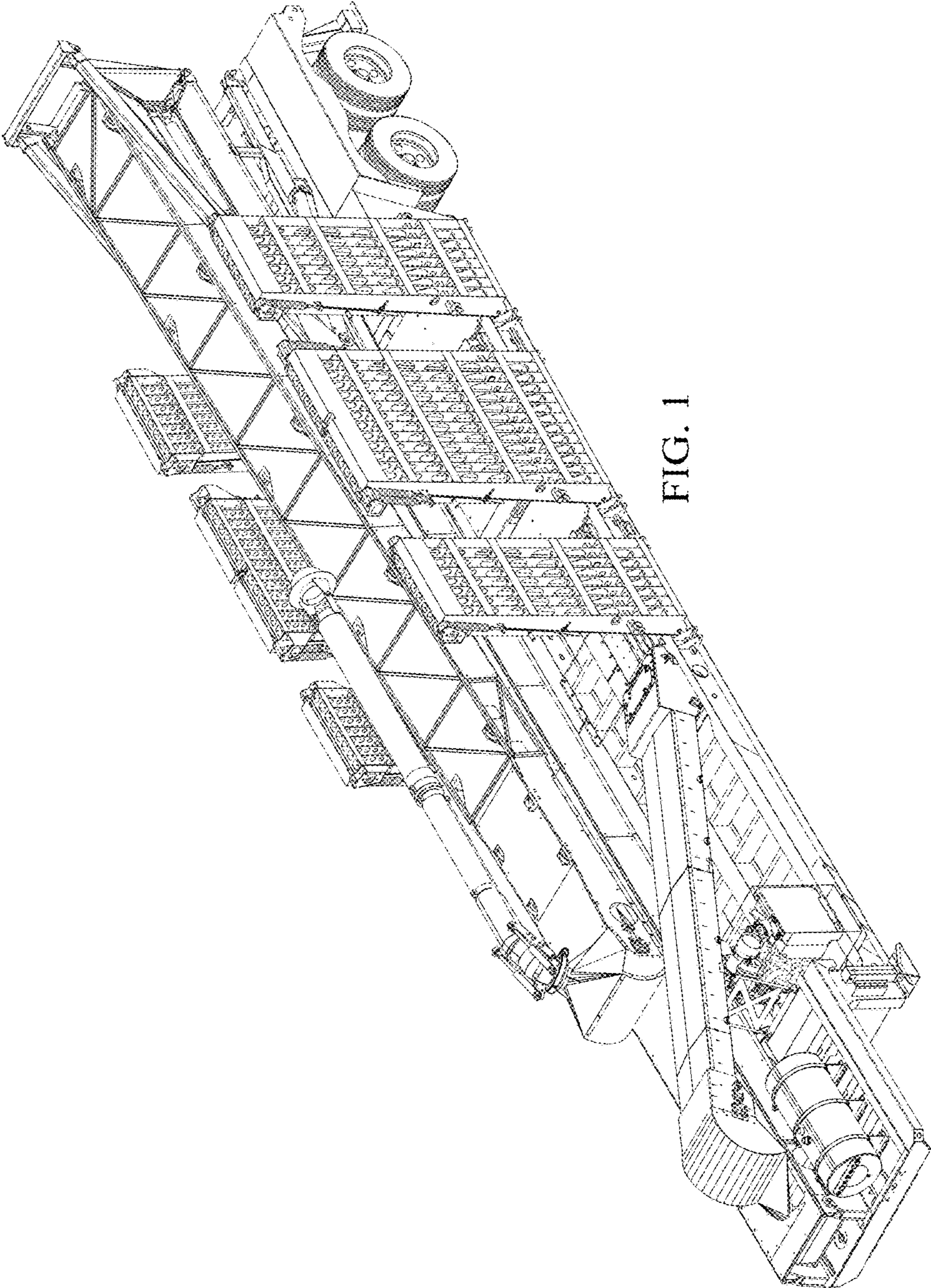

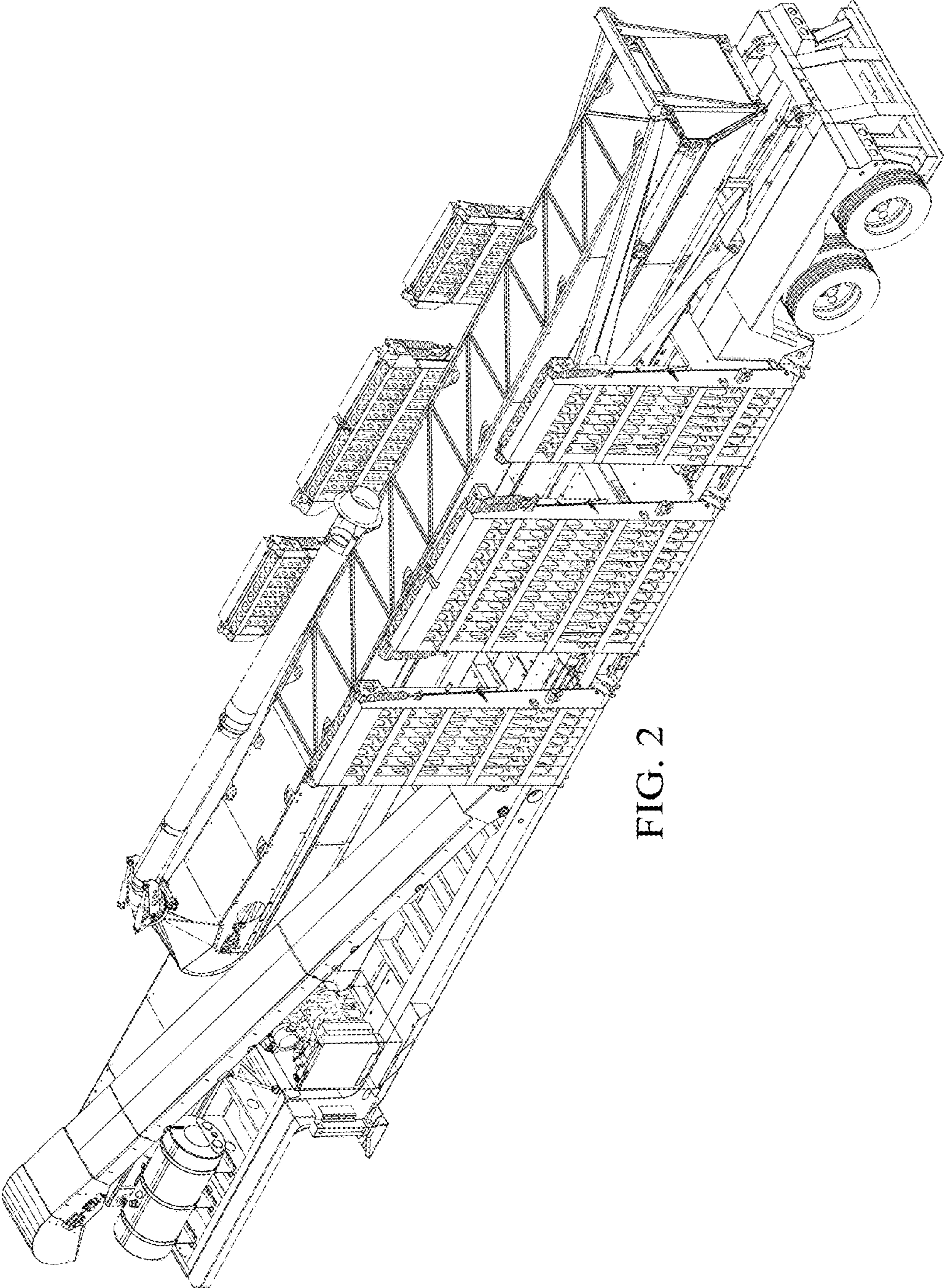

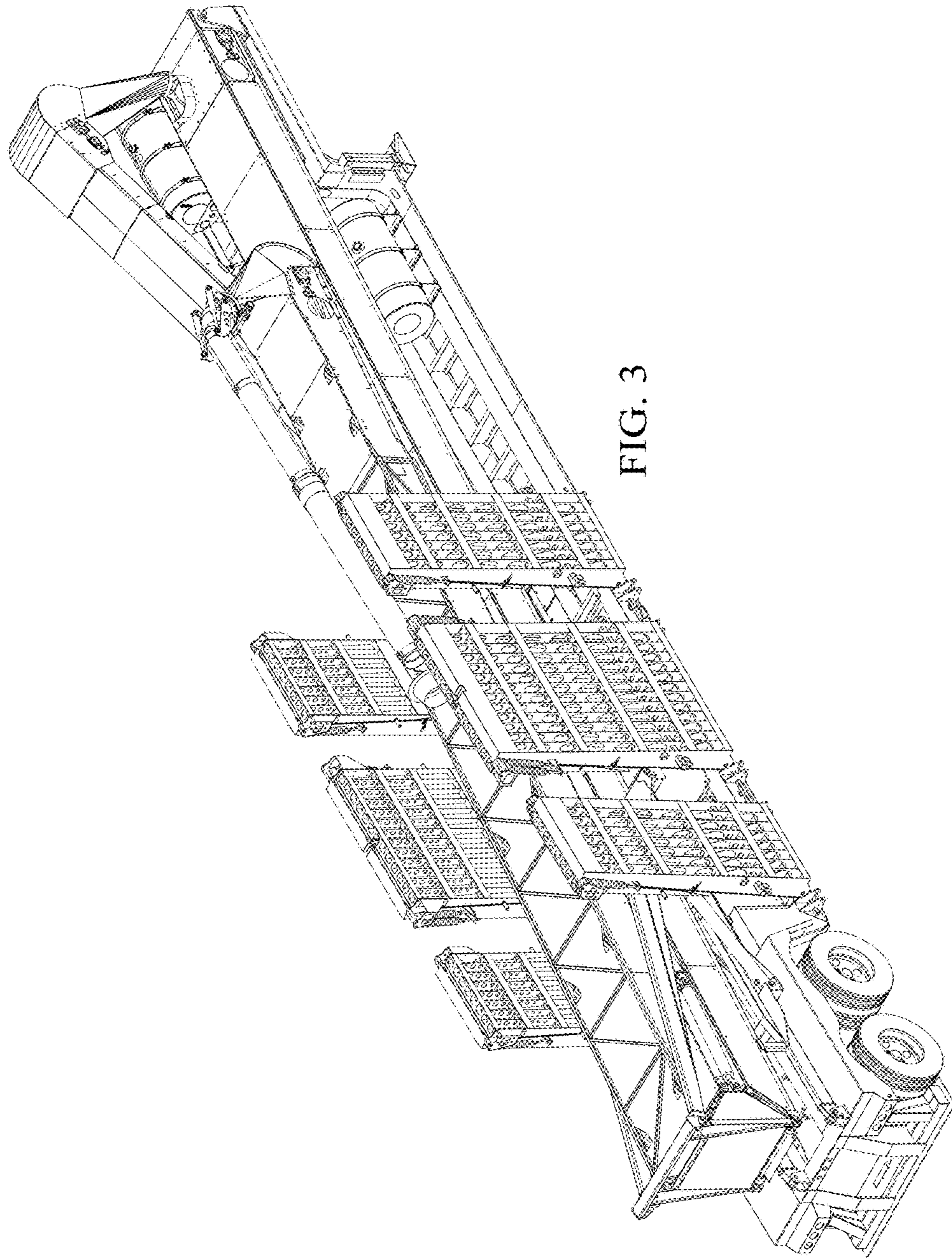

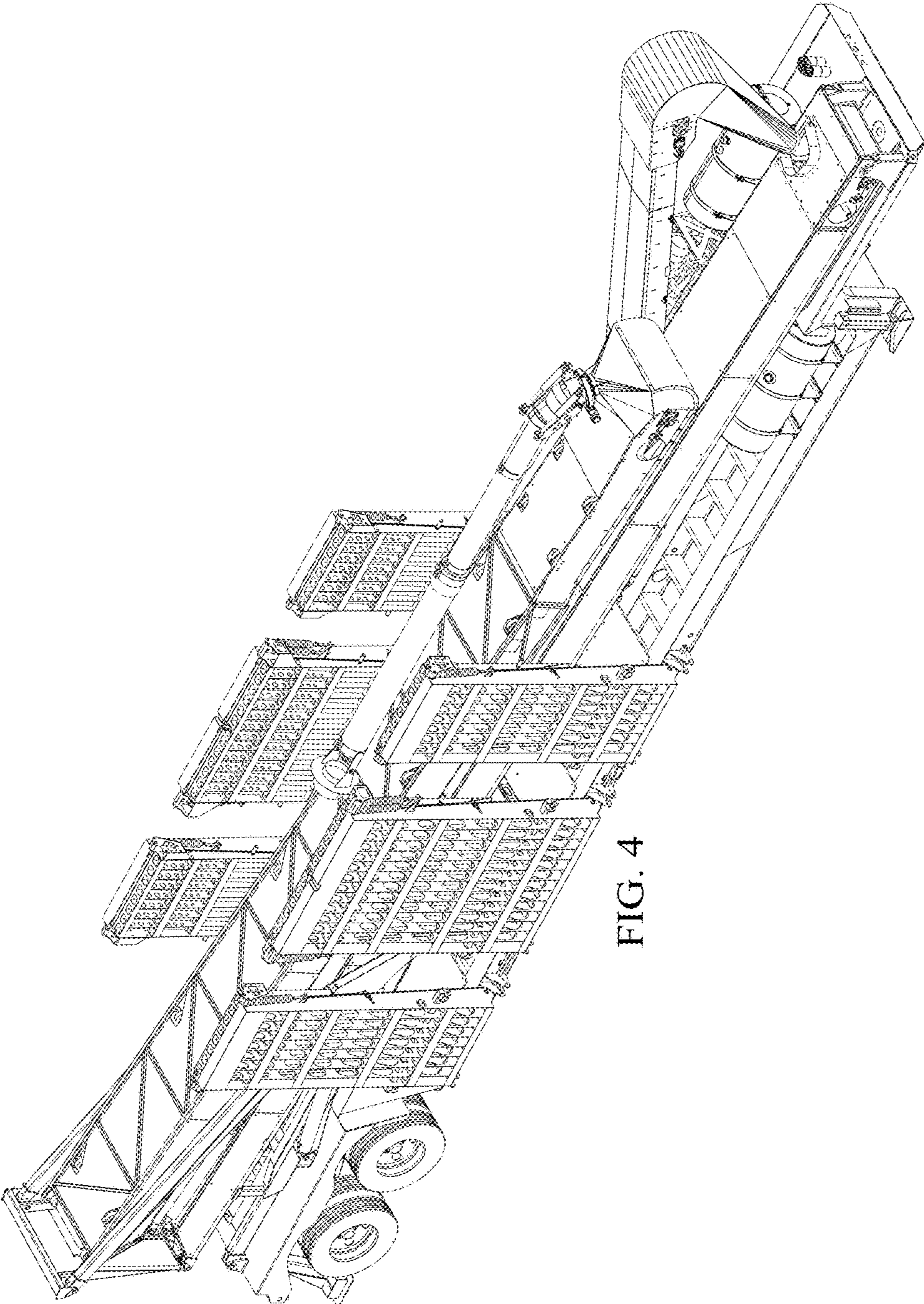

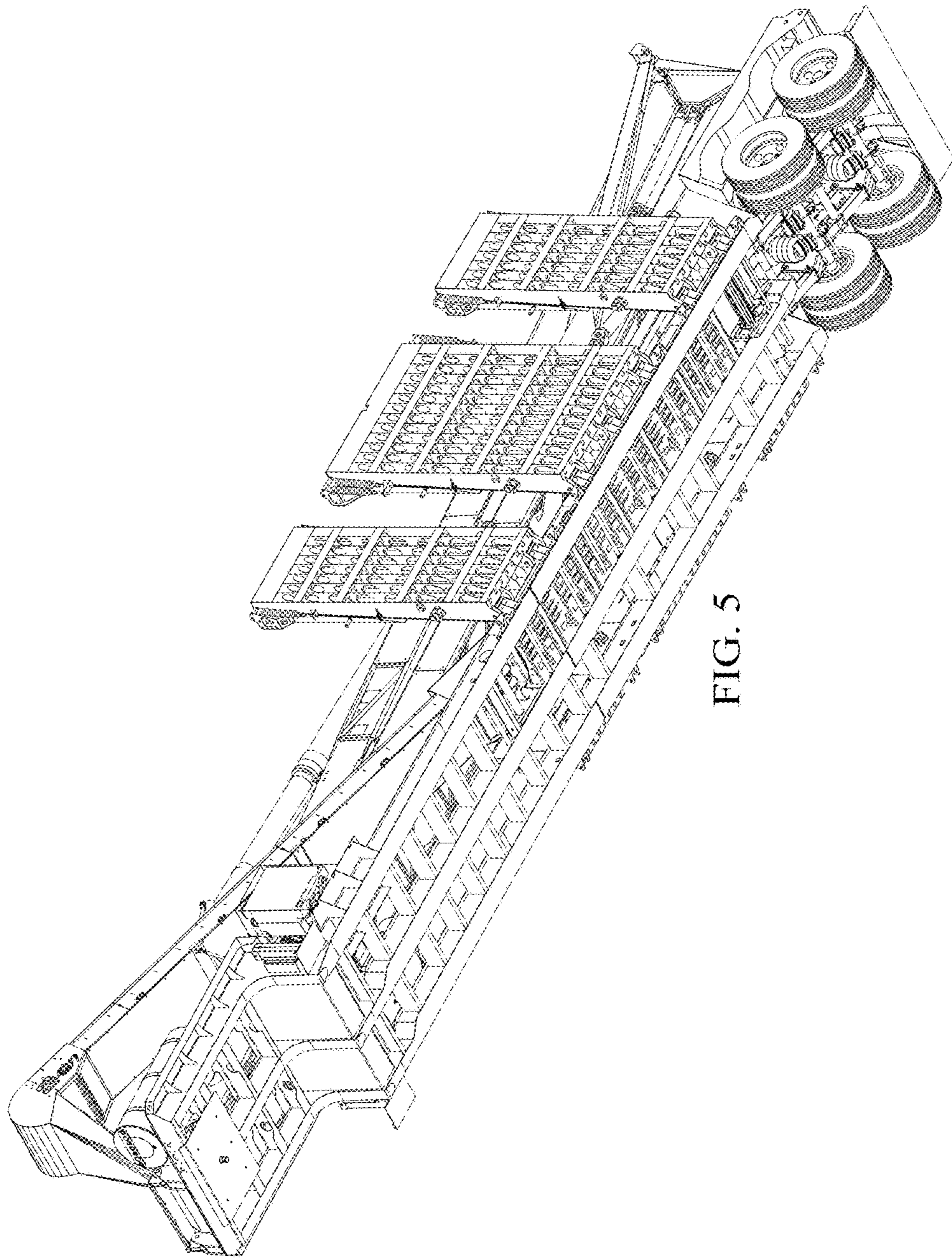

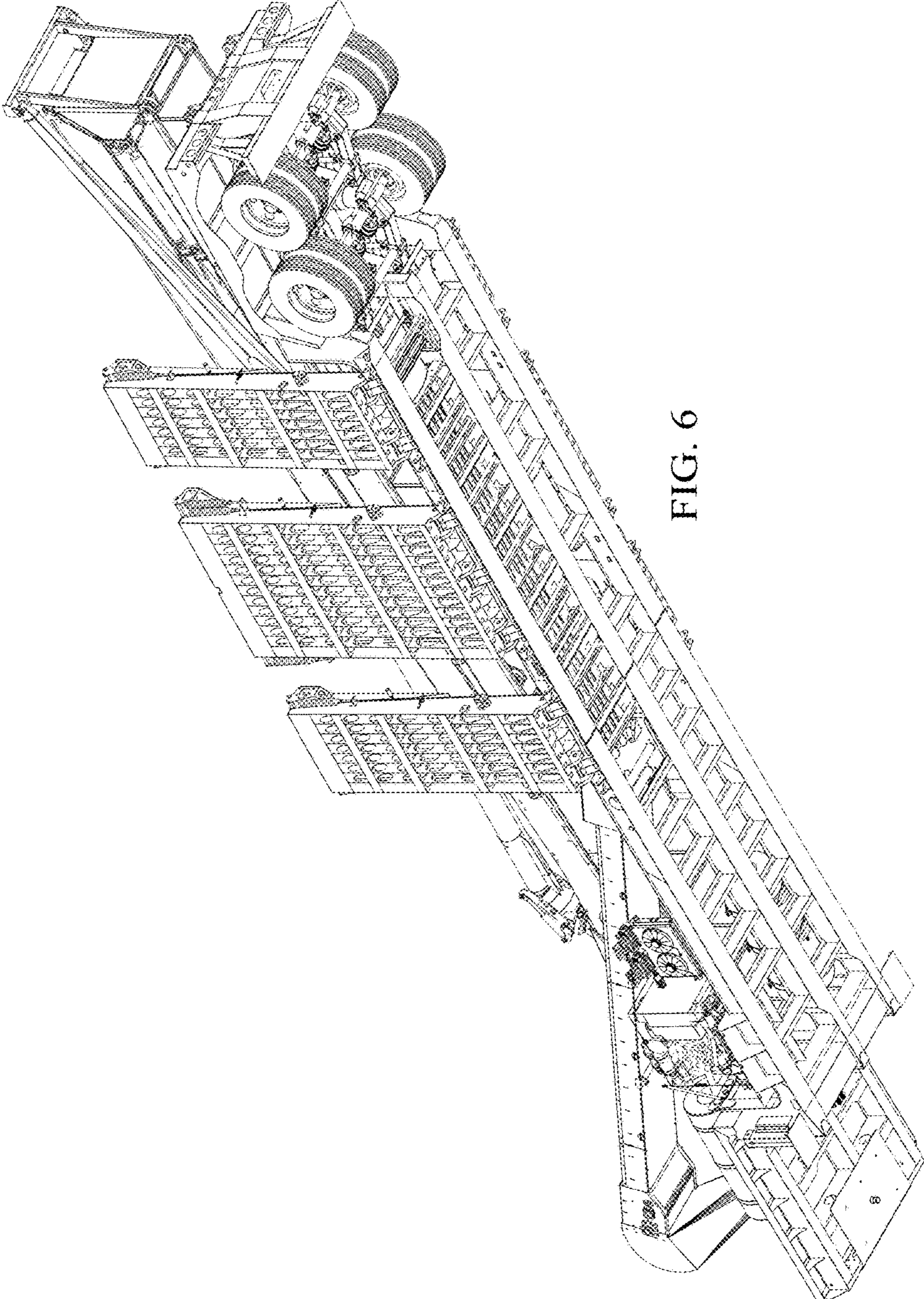

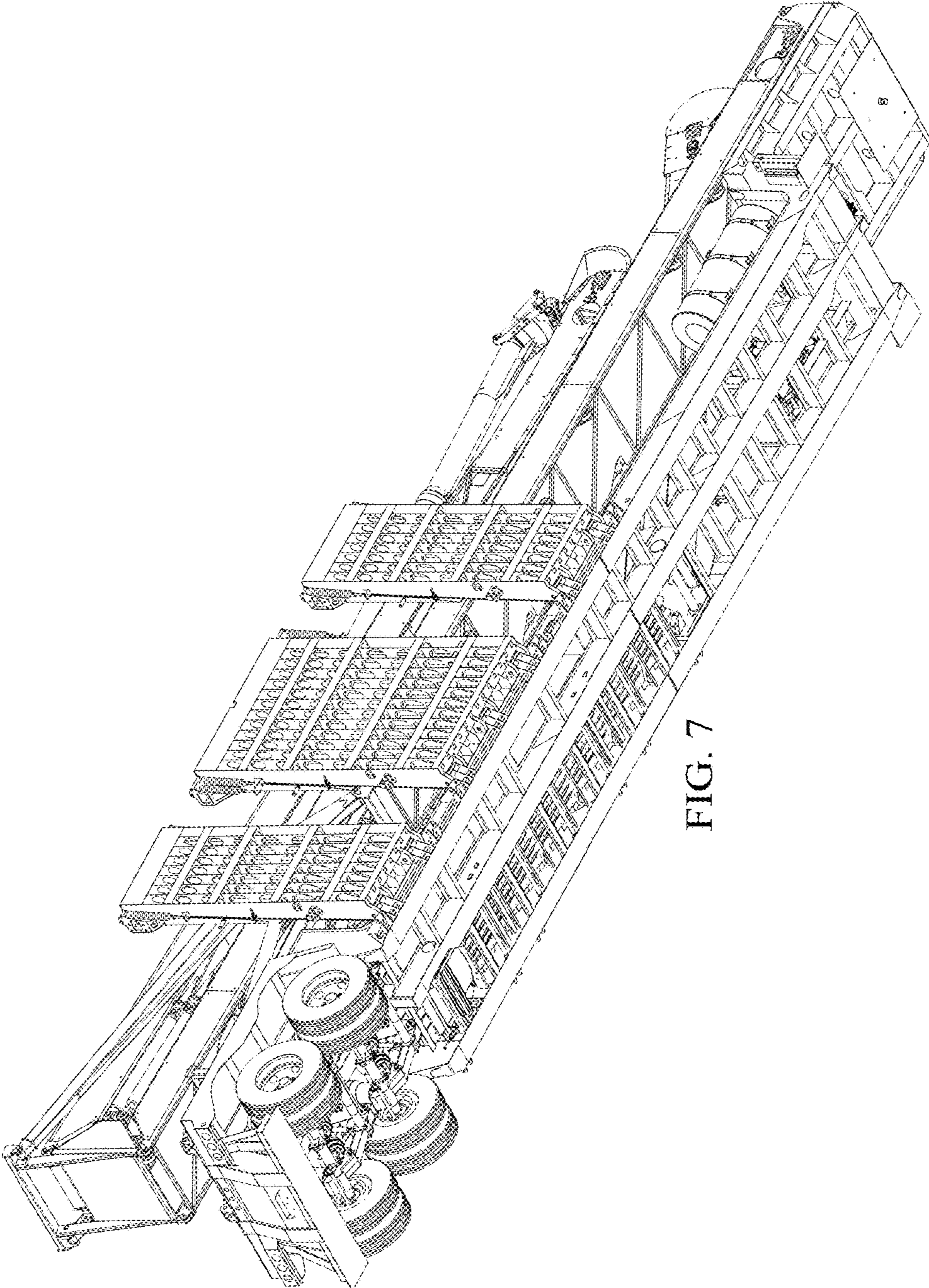

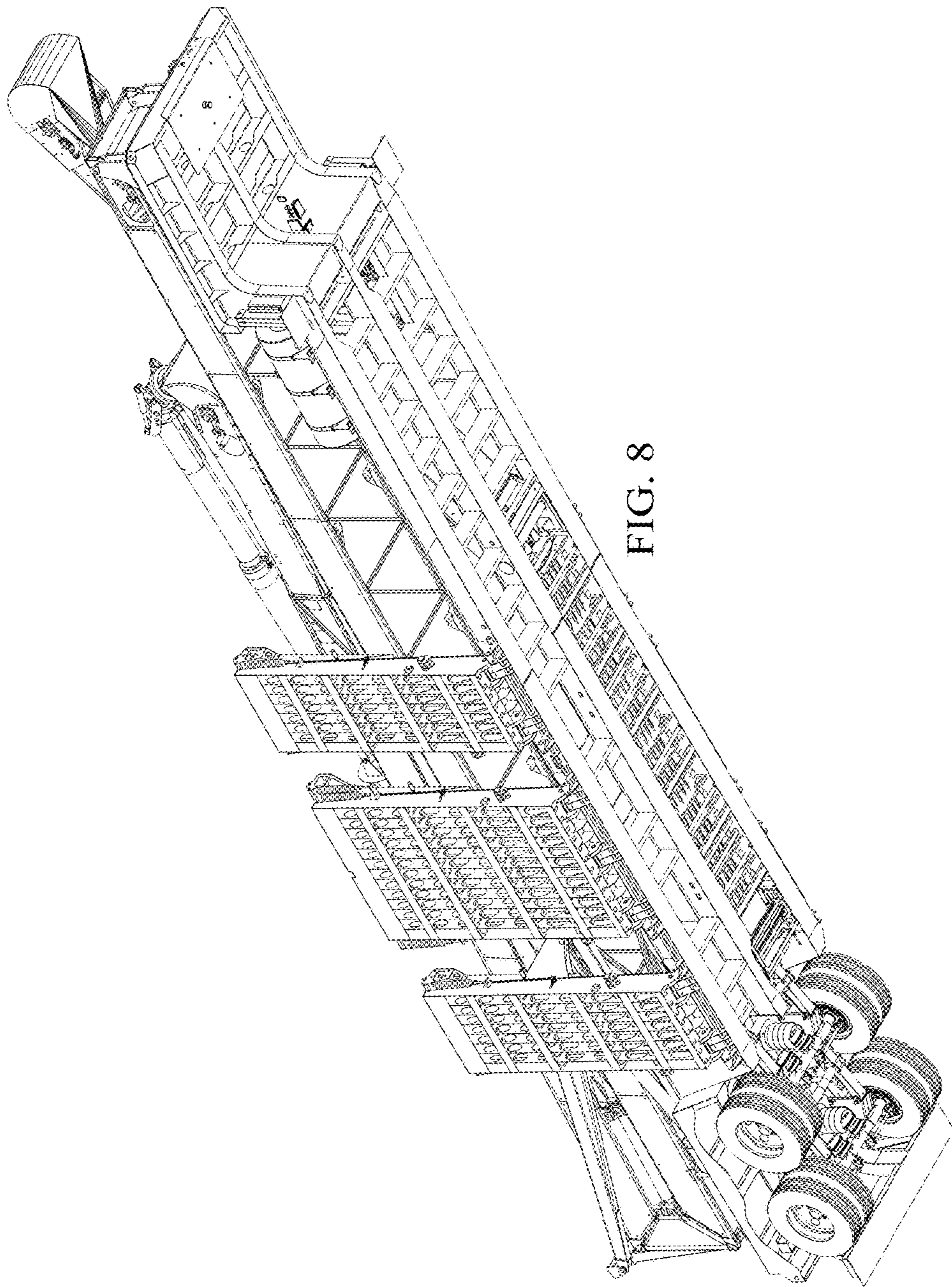

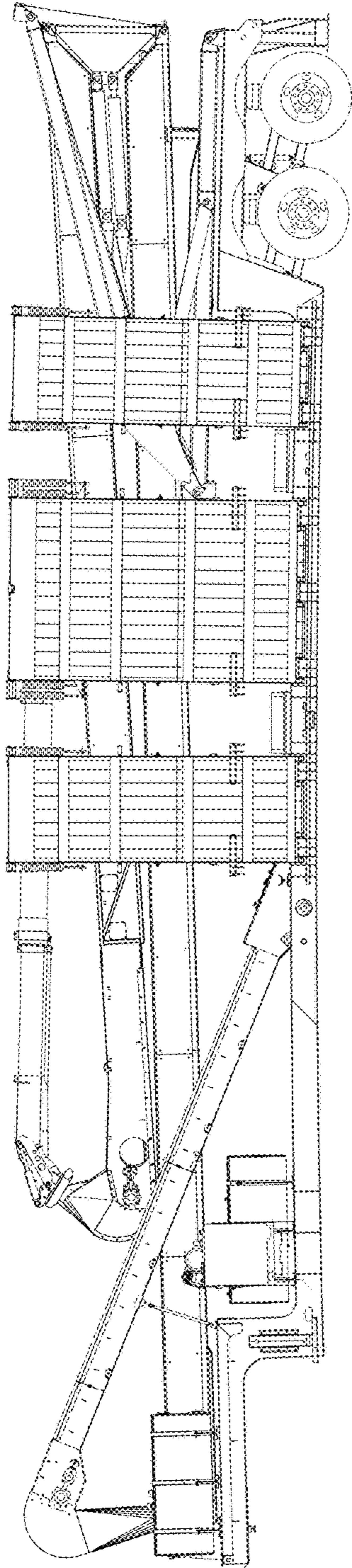

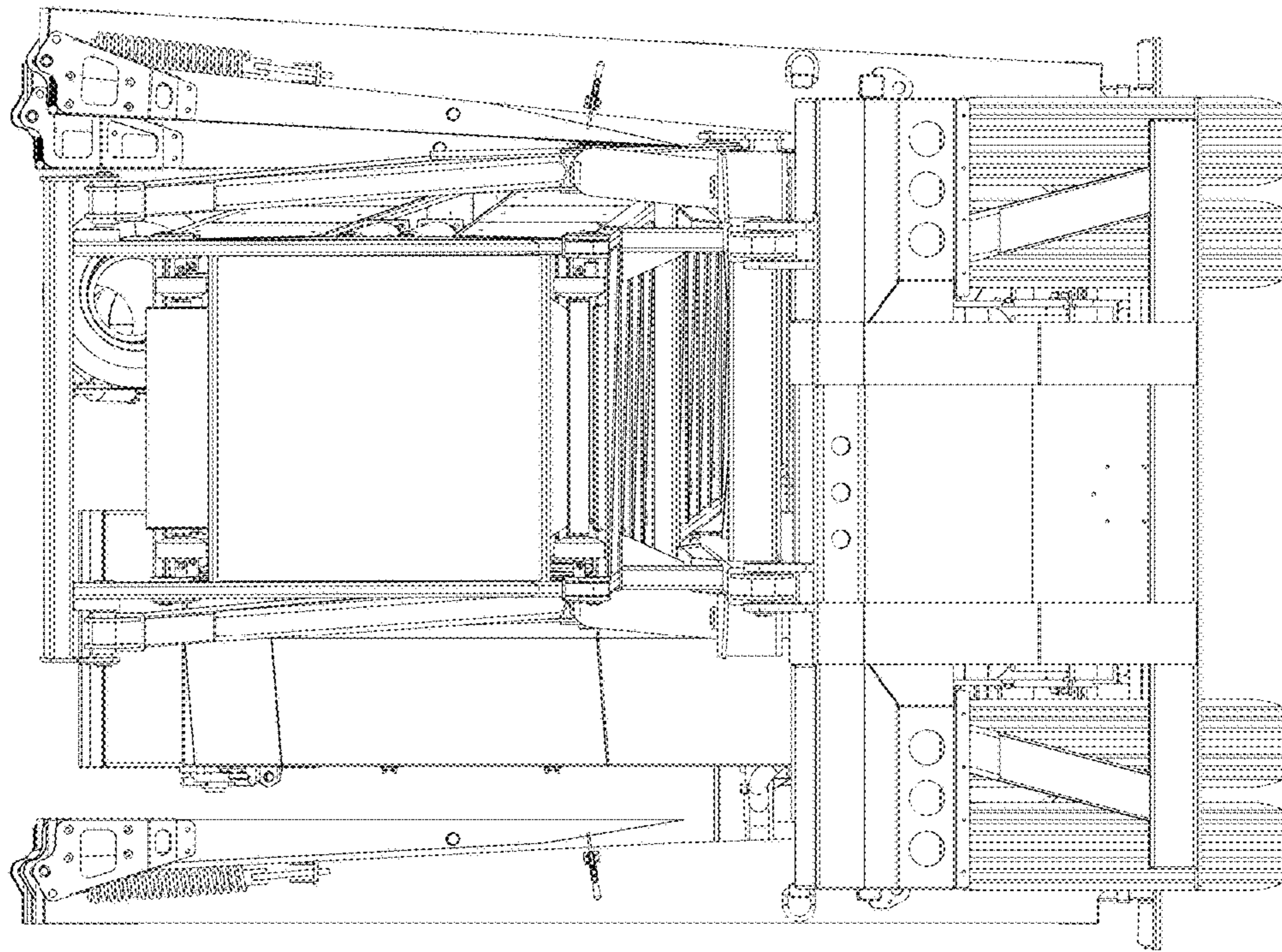

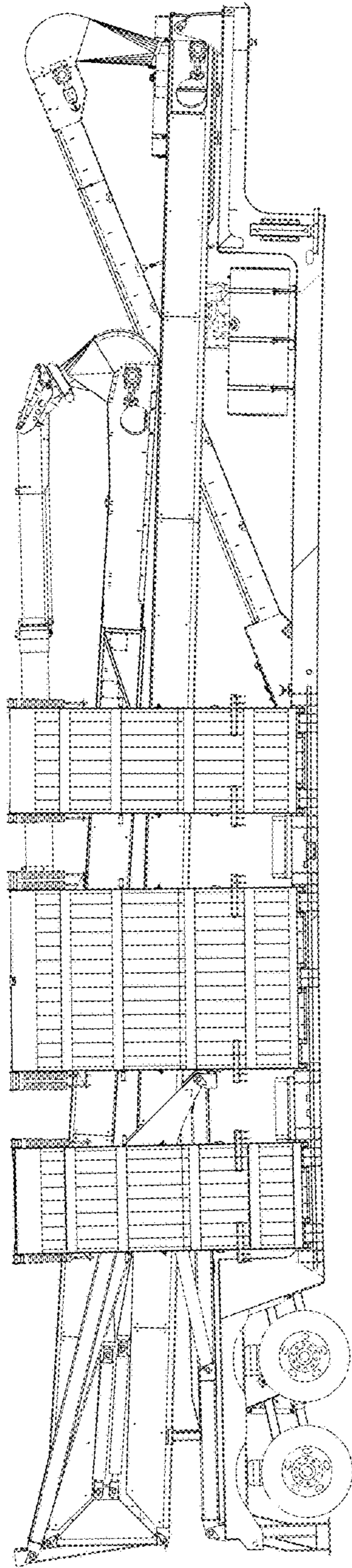

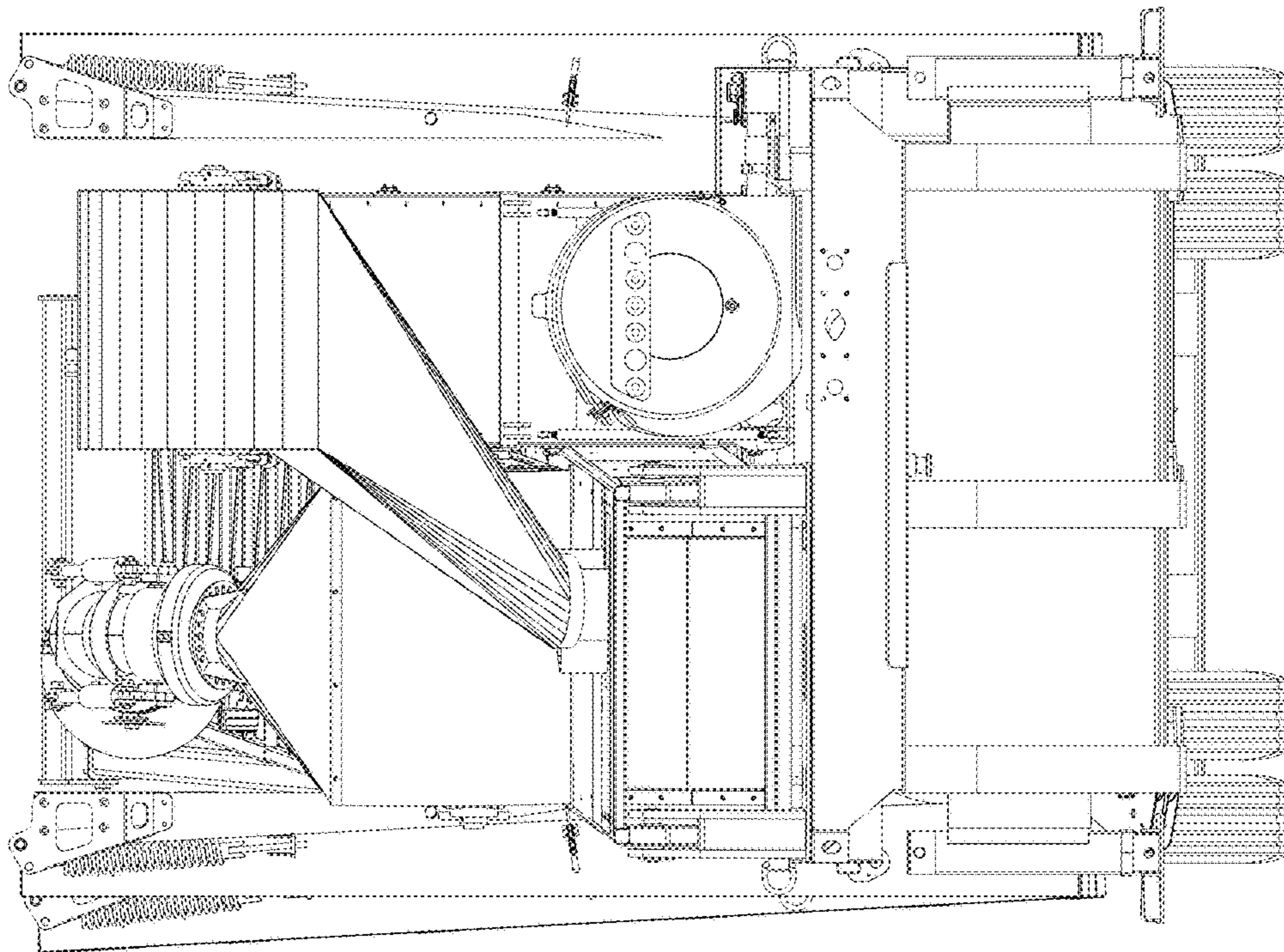

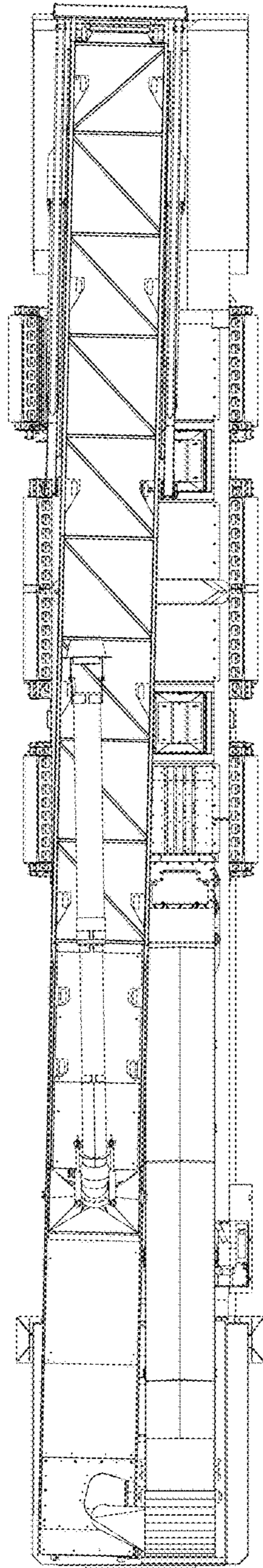

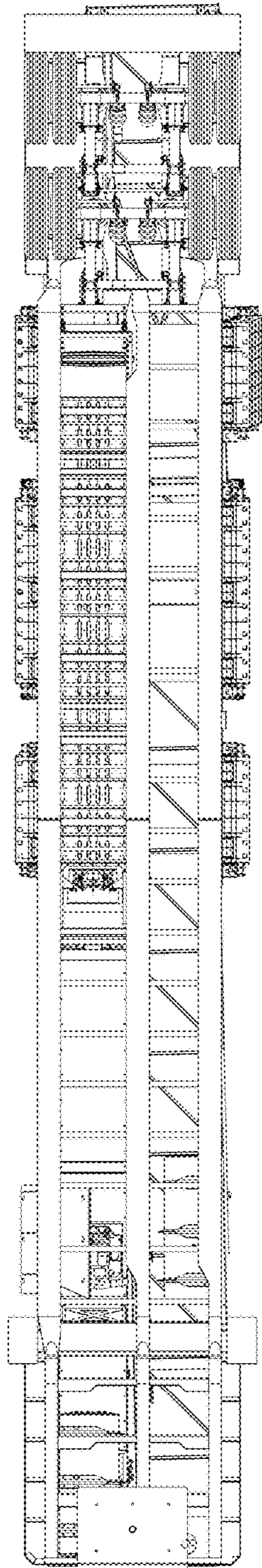
