(57) **CLAIM**

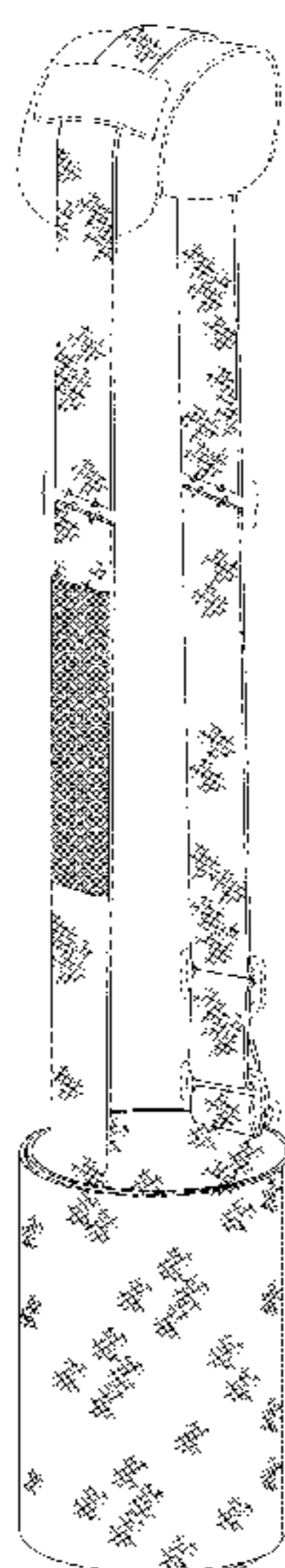
The ornamental design for a beverage container sling with pocket, as shown and described.

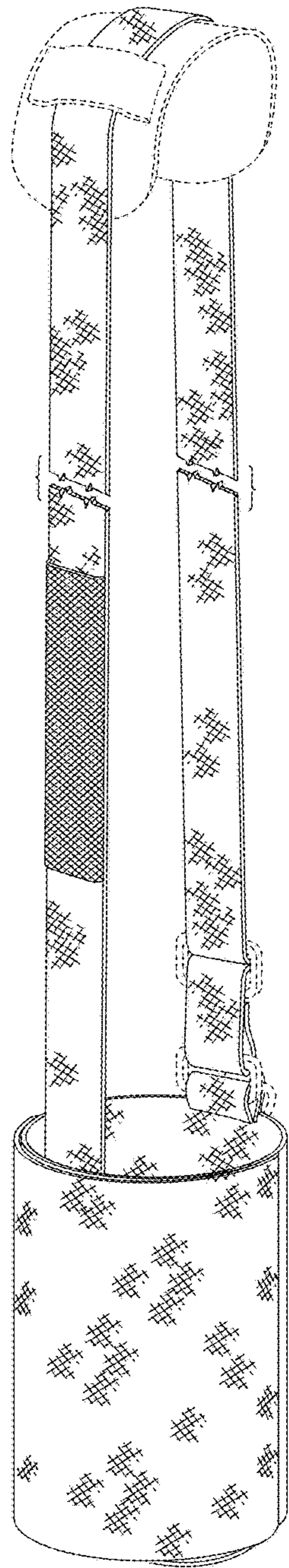

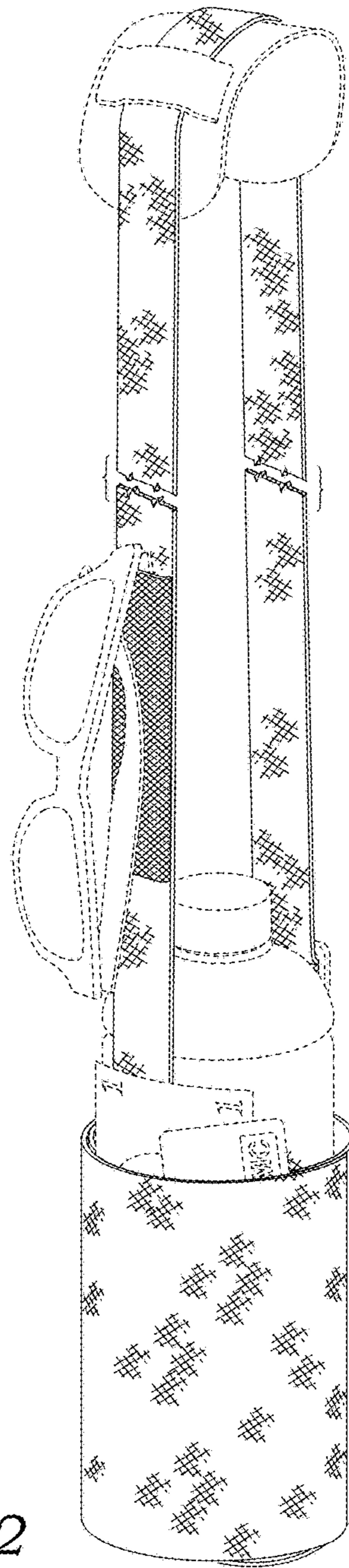

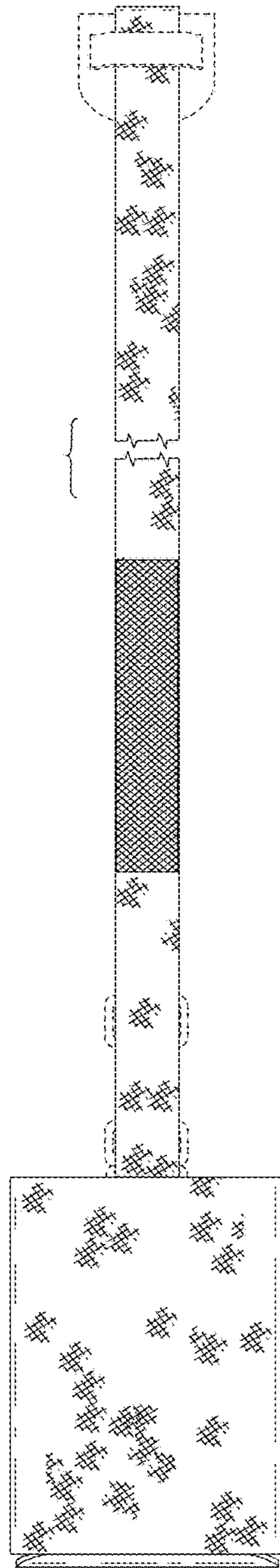

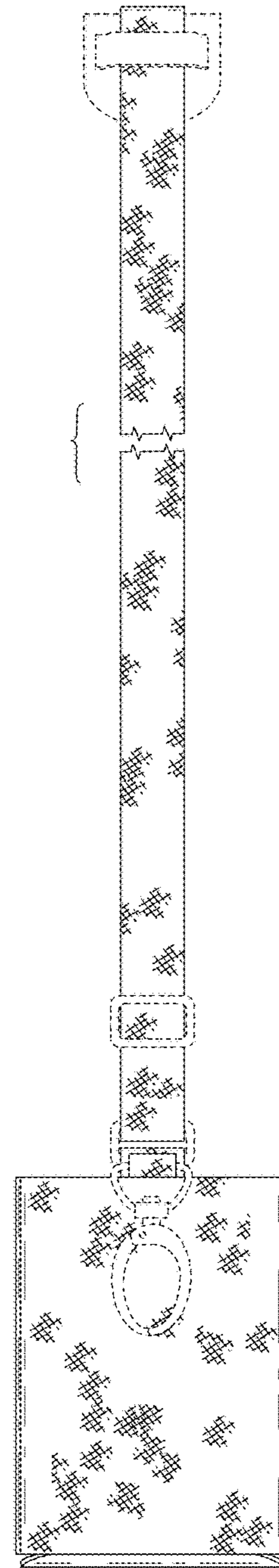

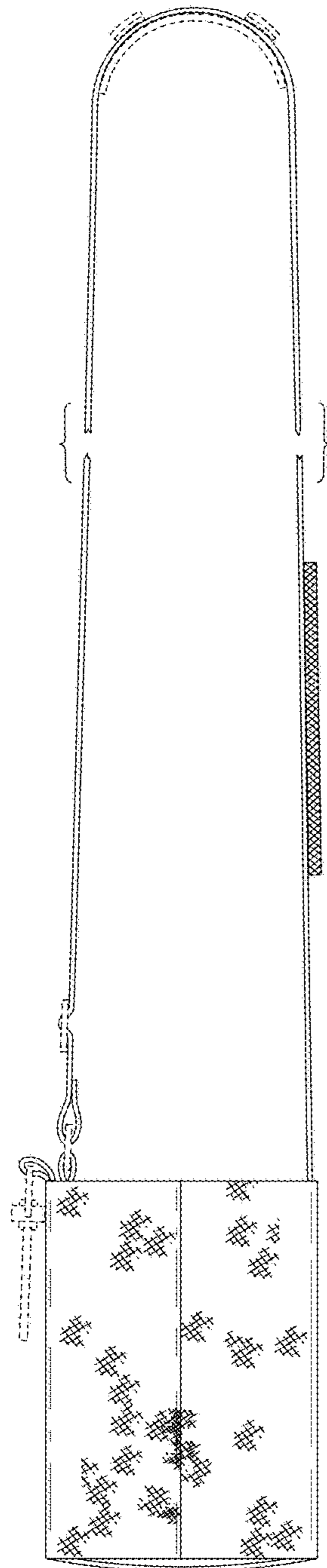

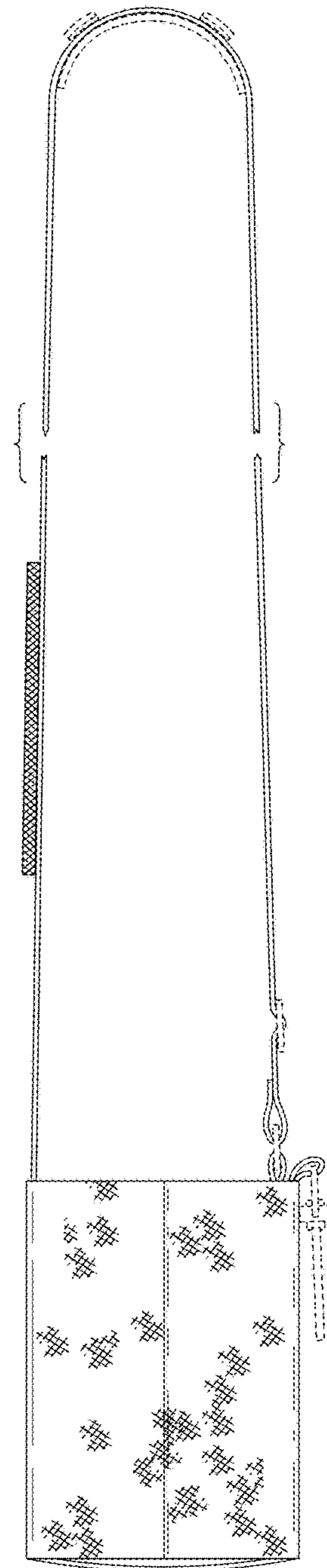

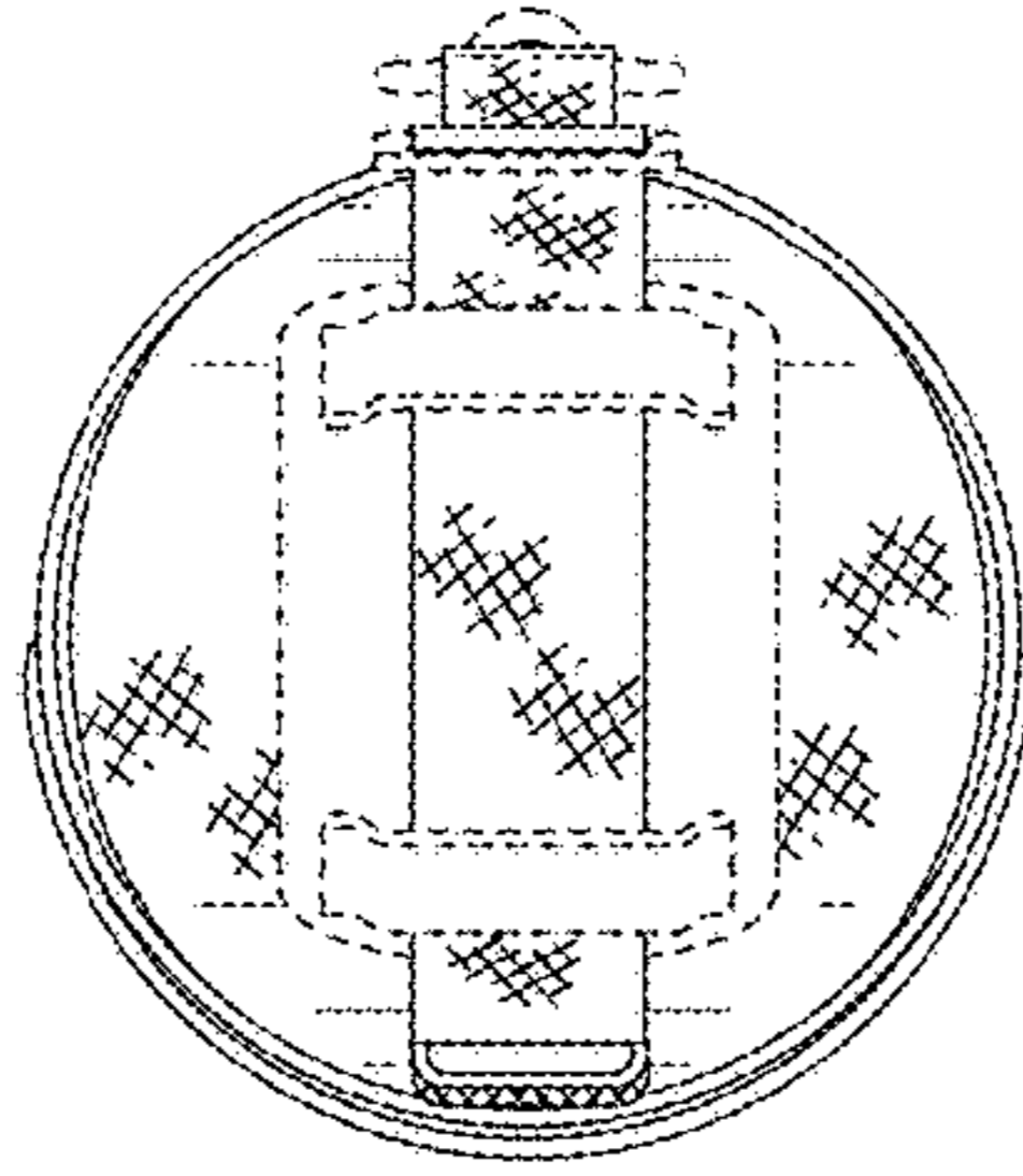

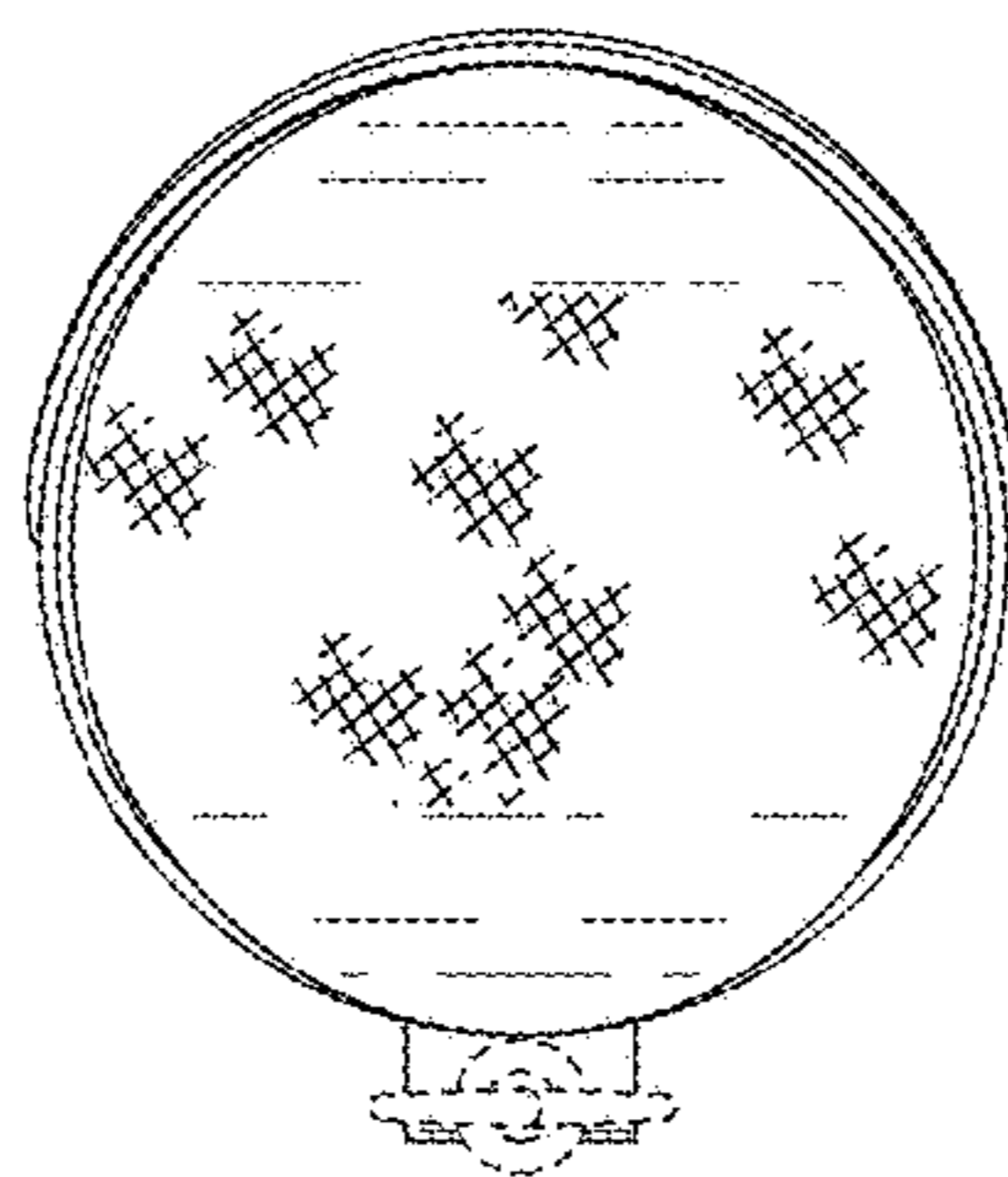
