DESCRIPTION

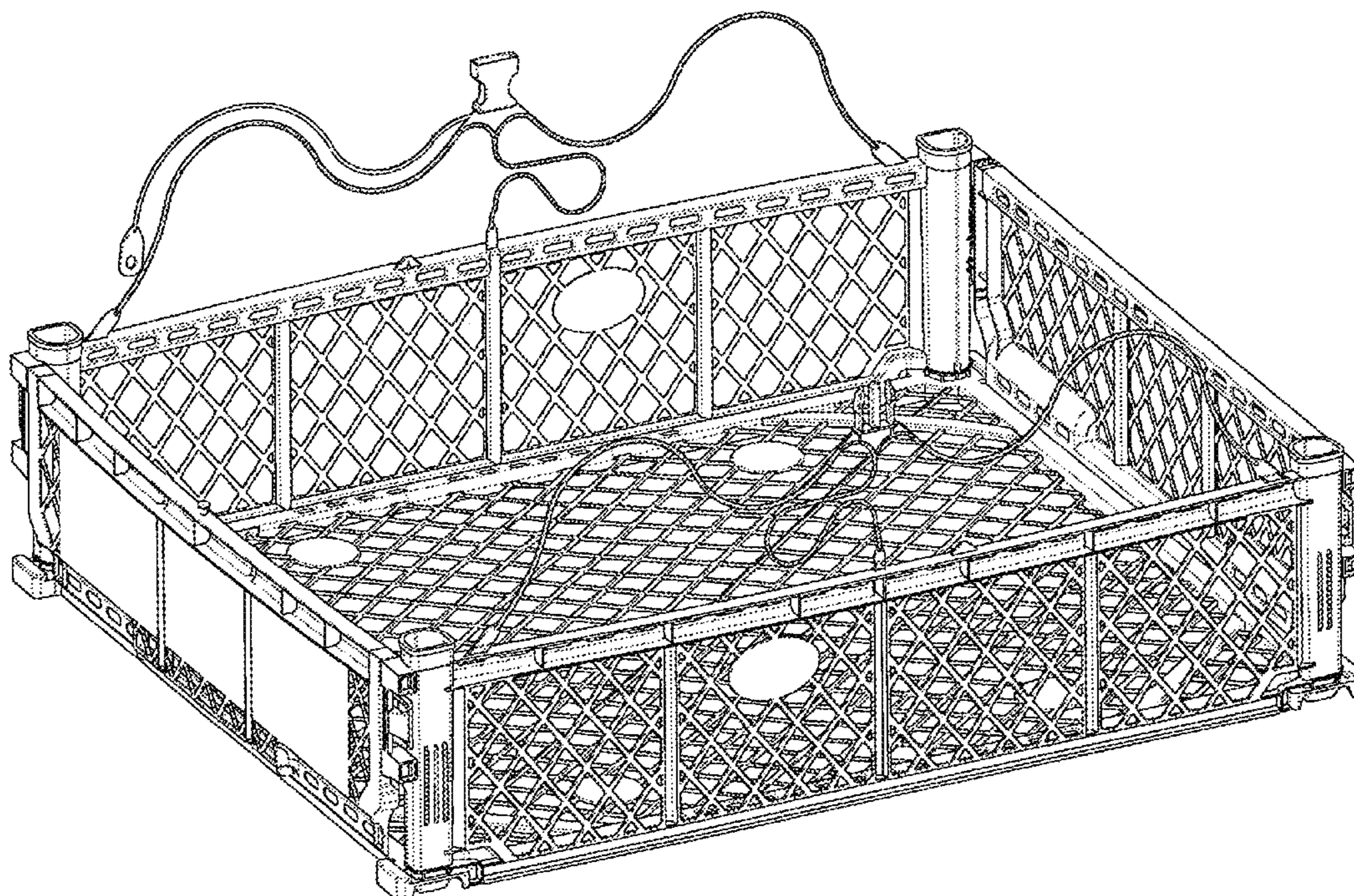
FIG. 1 is a front perspective view of a plastic container showing my new design;

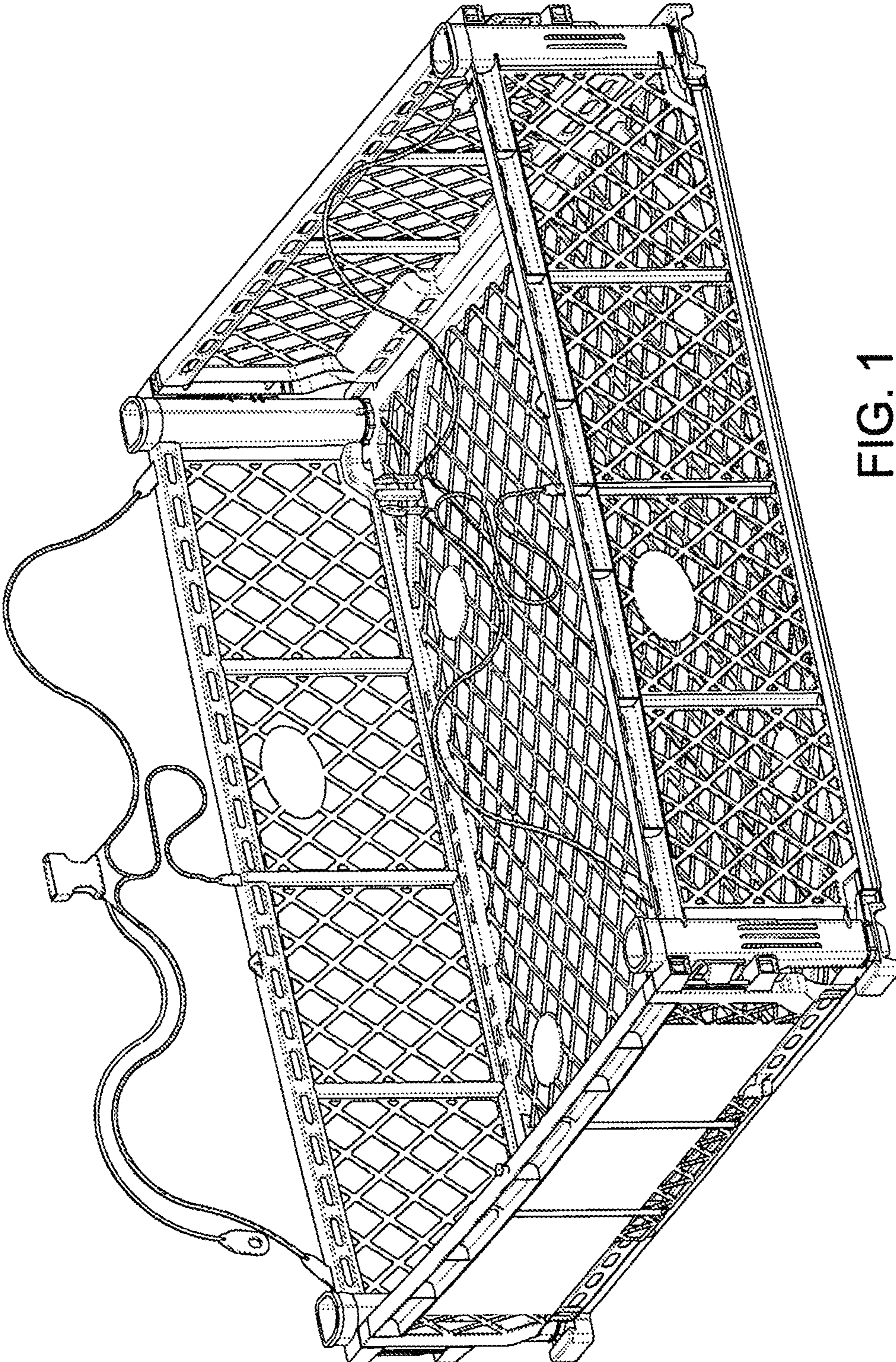

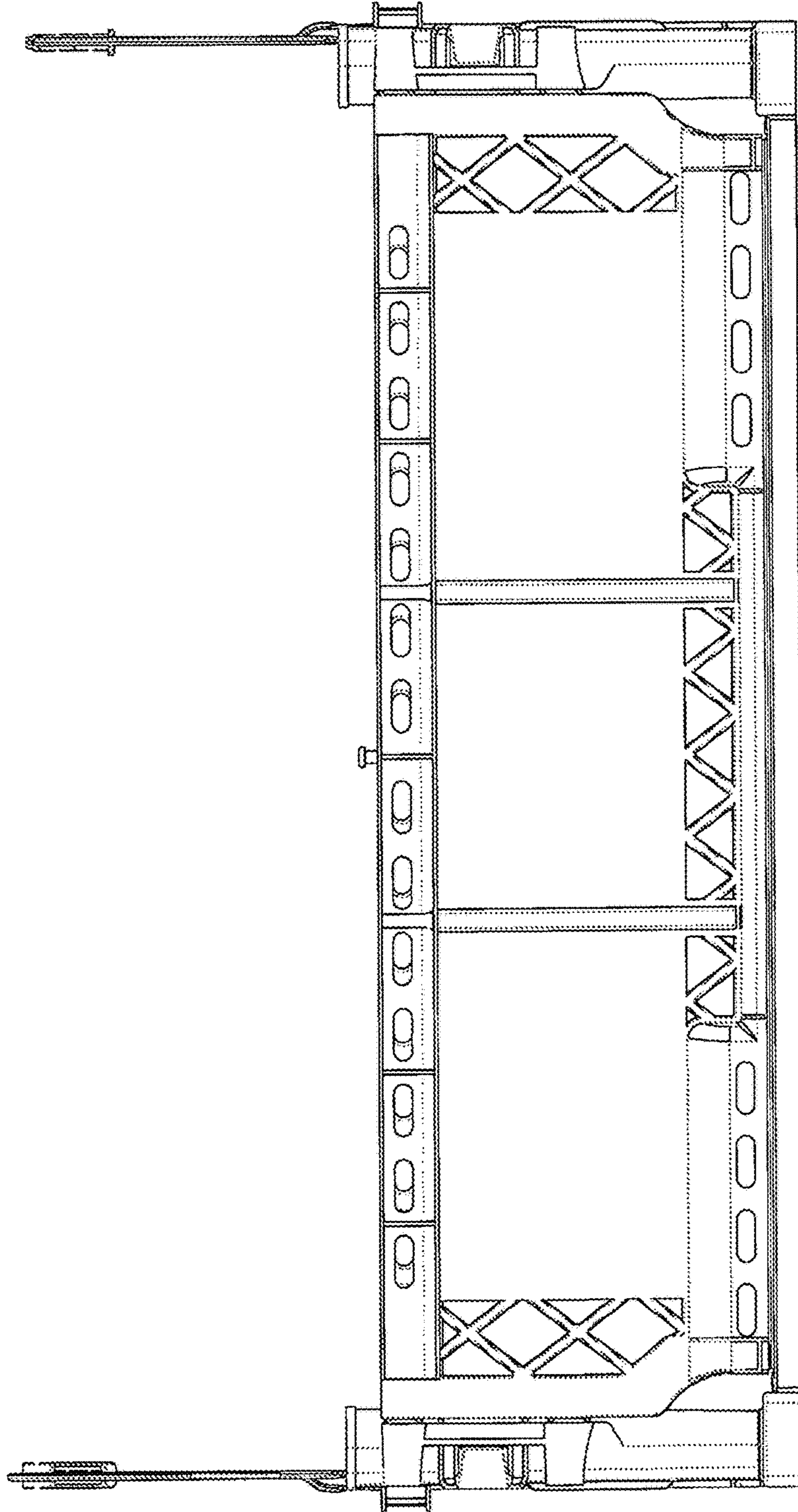

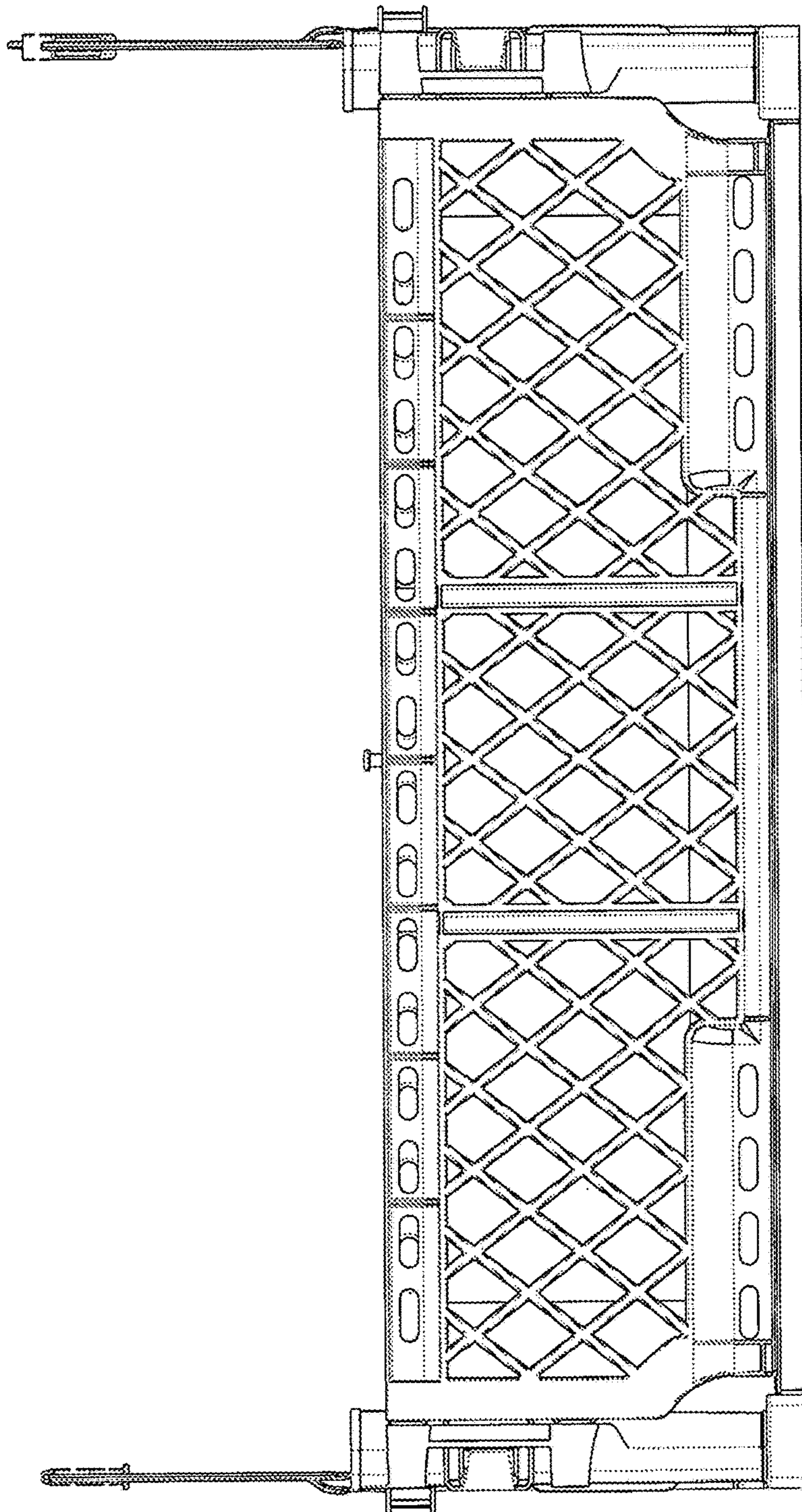

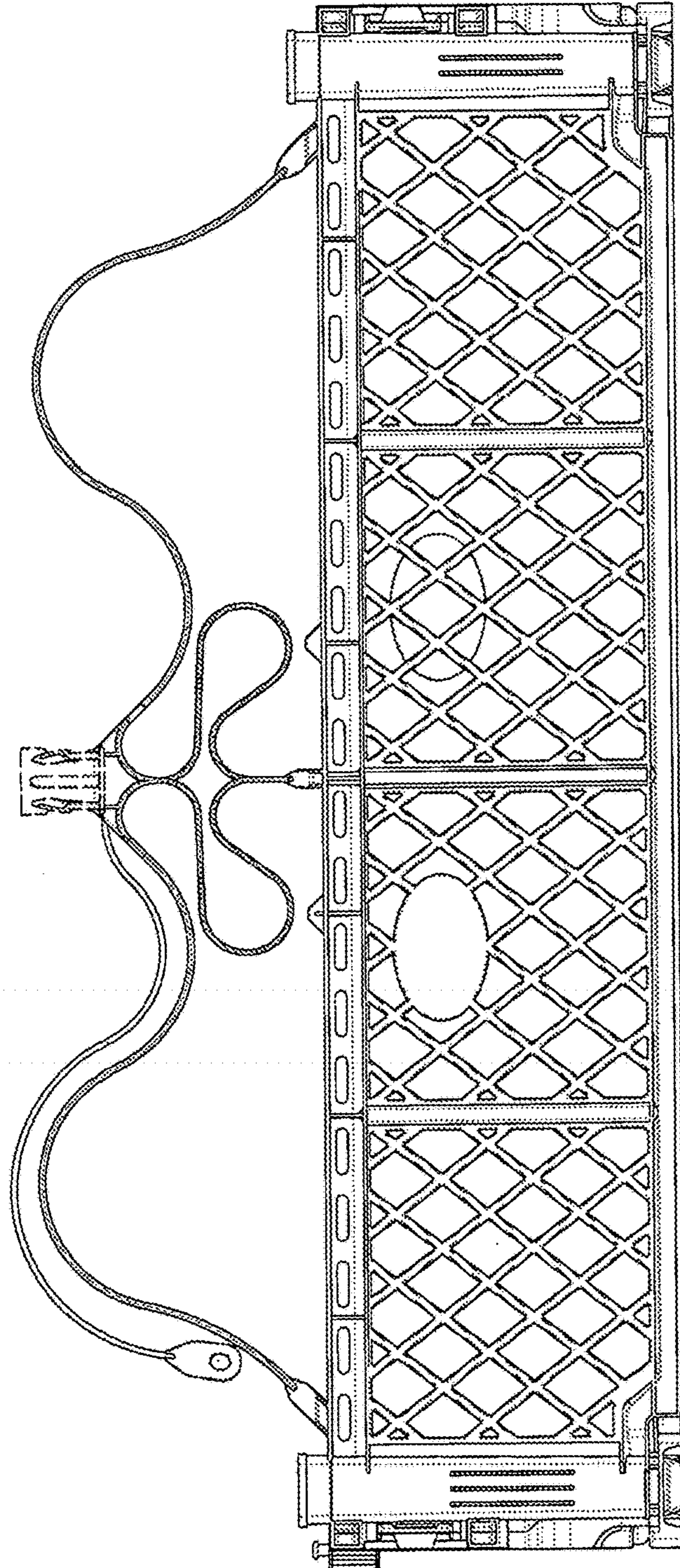

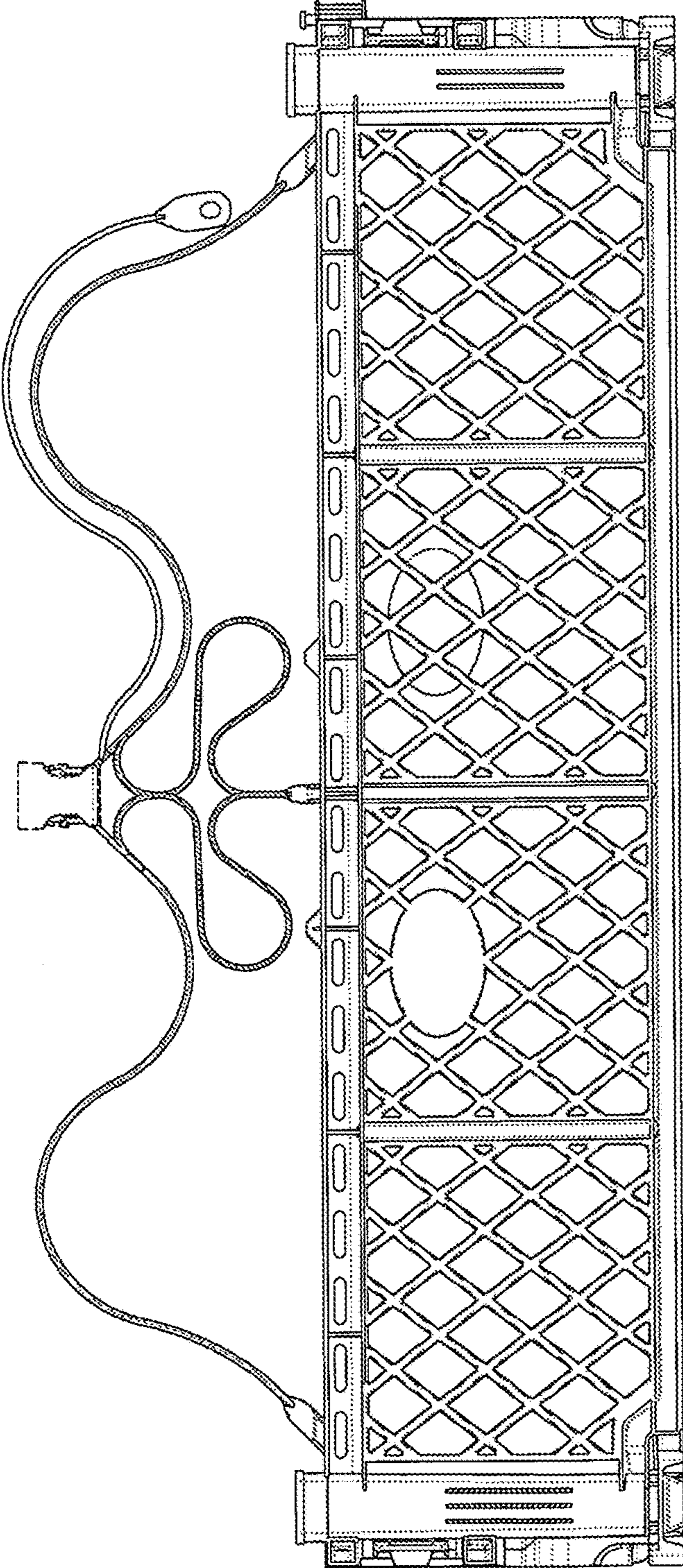

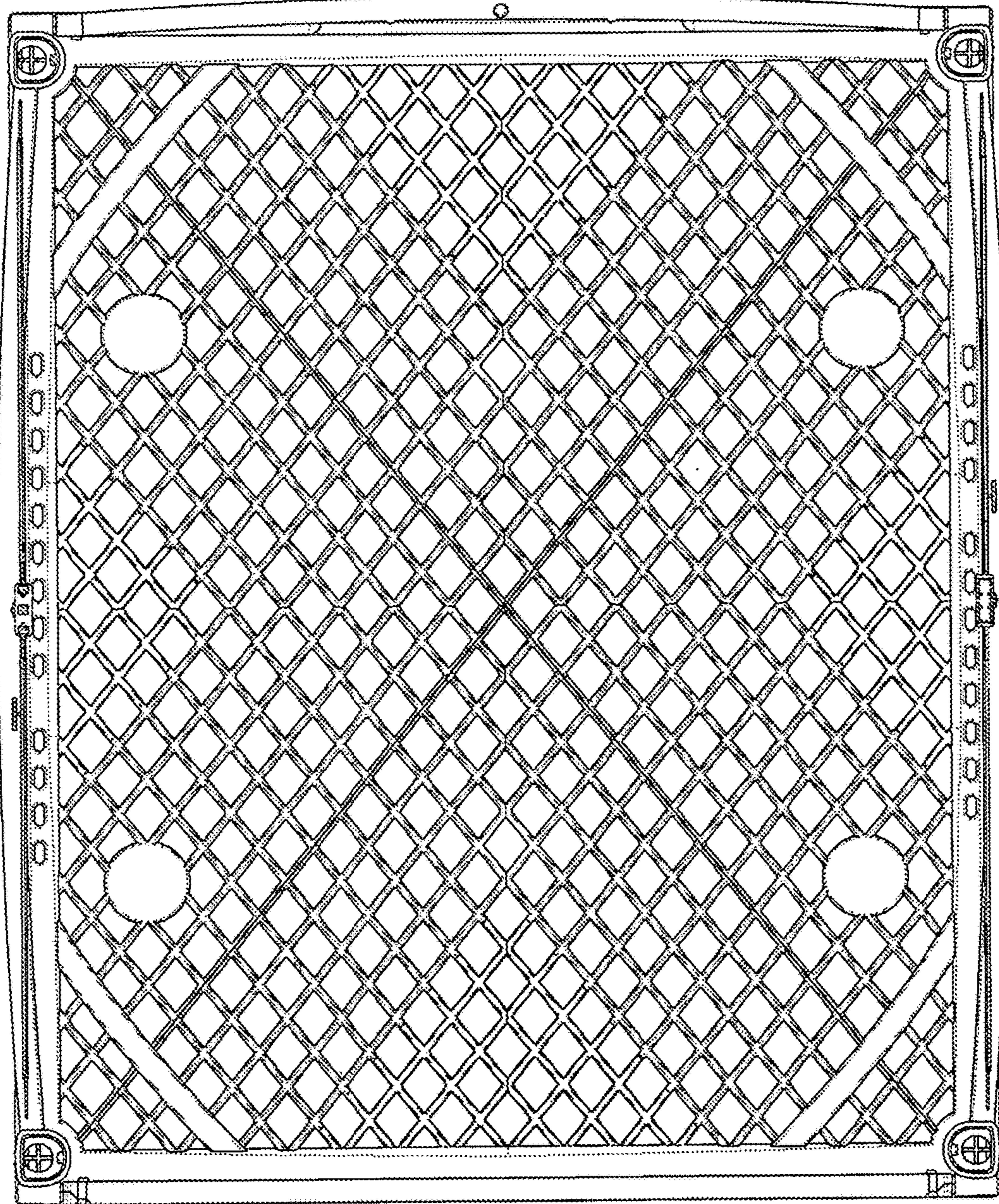

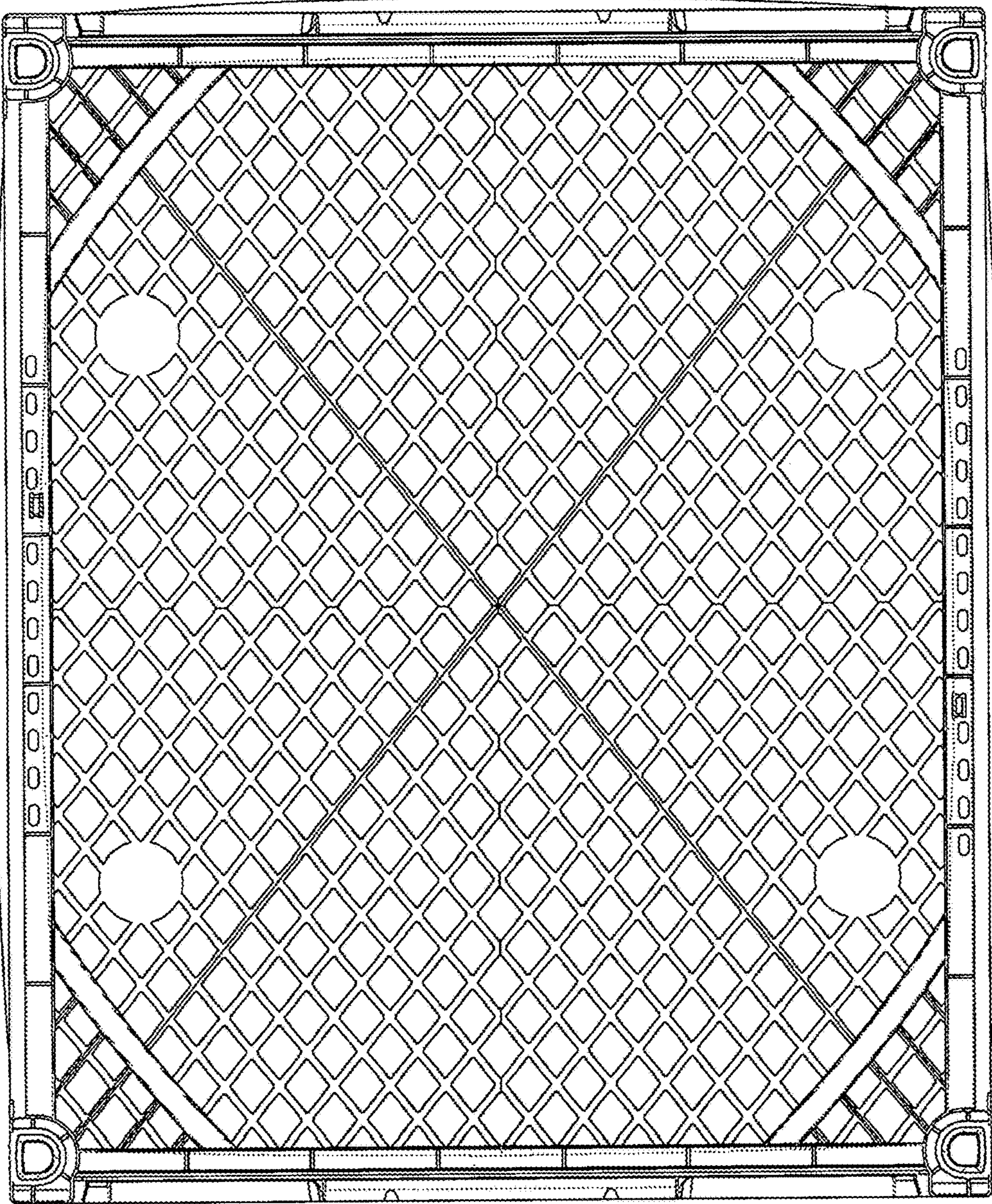
