DESCRIPTION

FIG. 1 is a front, right side, perspective view of a blender body showing our new design;
FIG. 2 is a front view thereof;

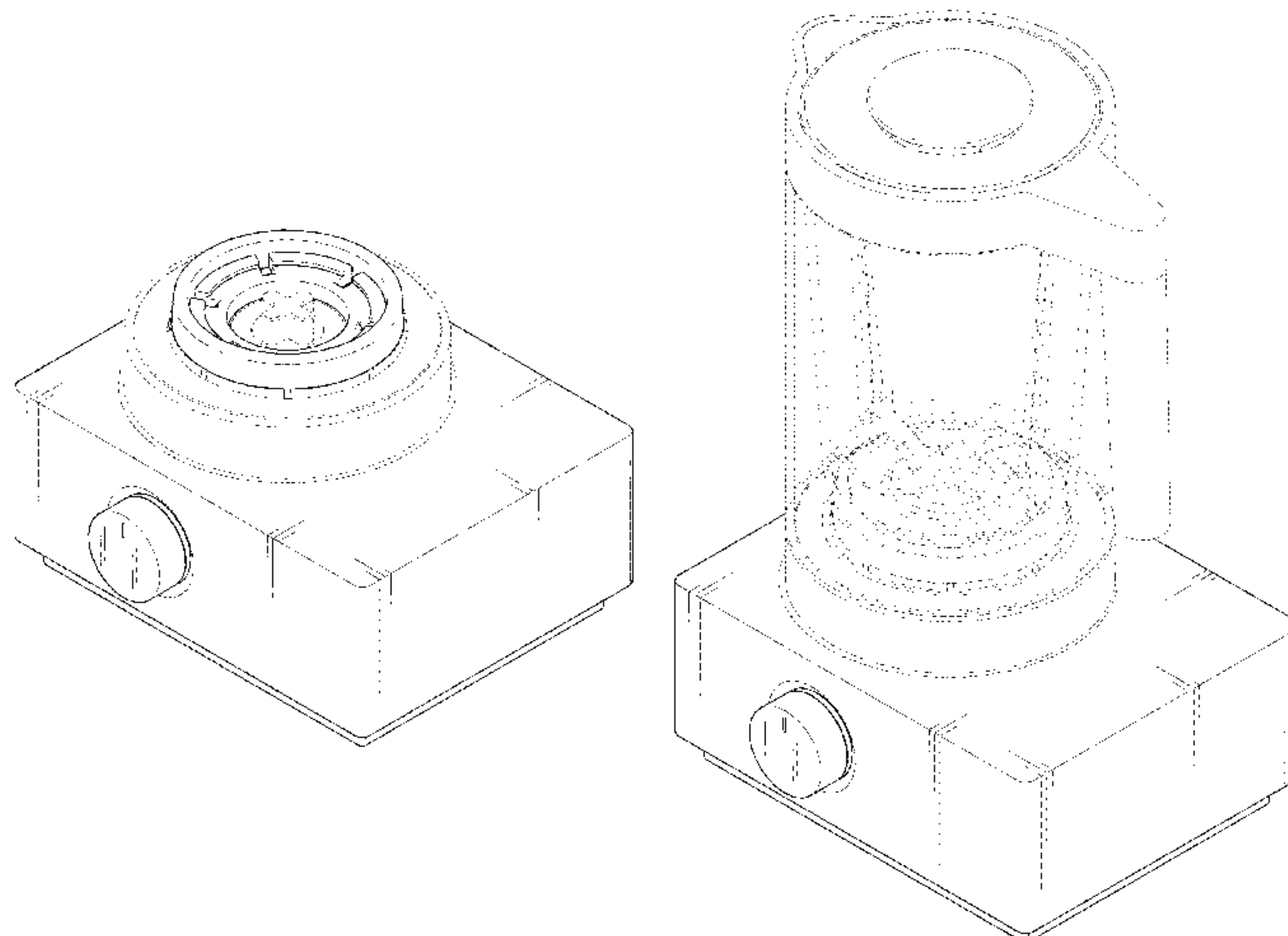

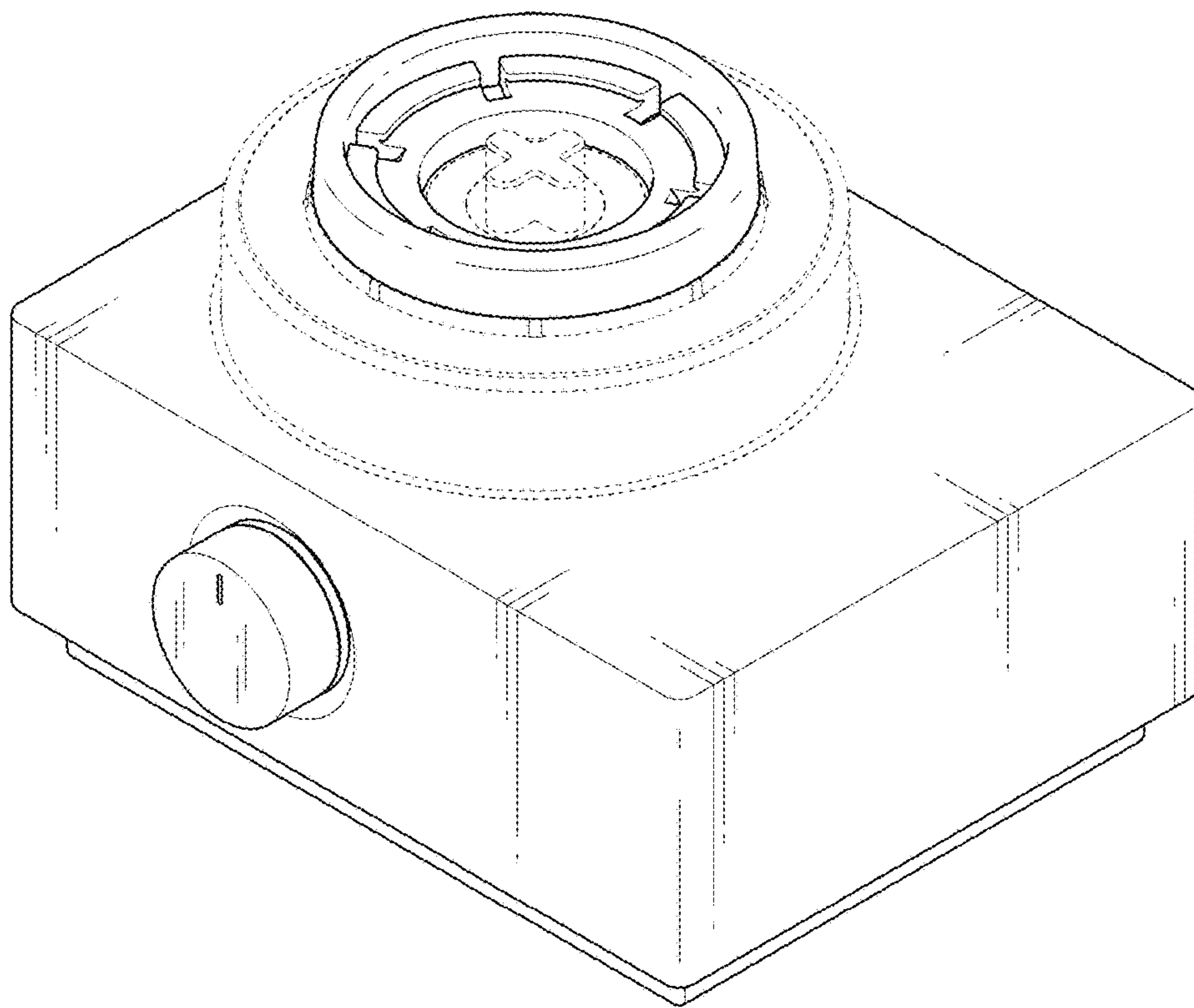

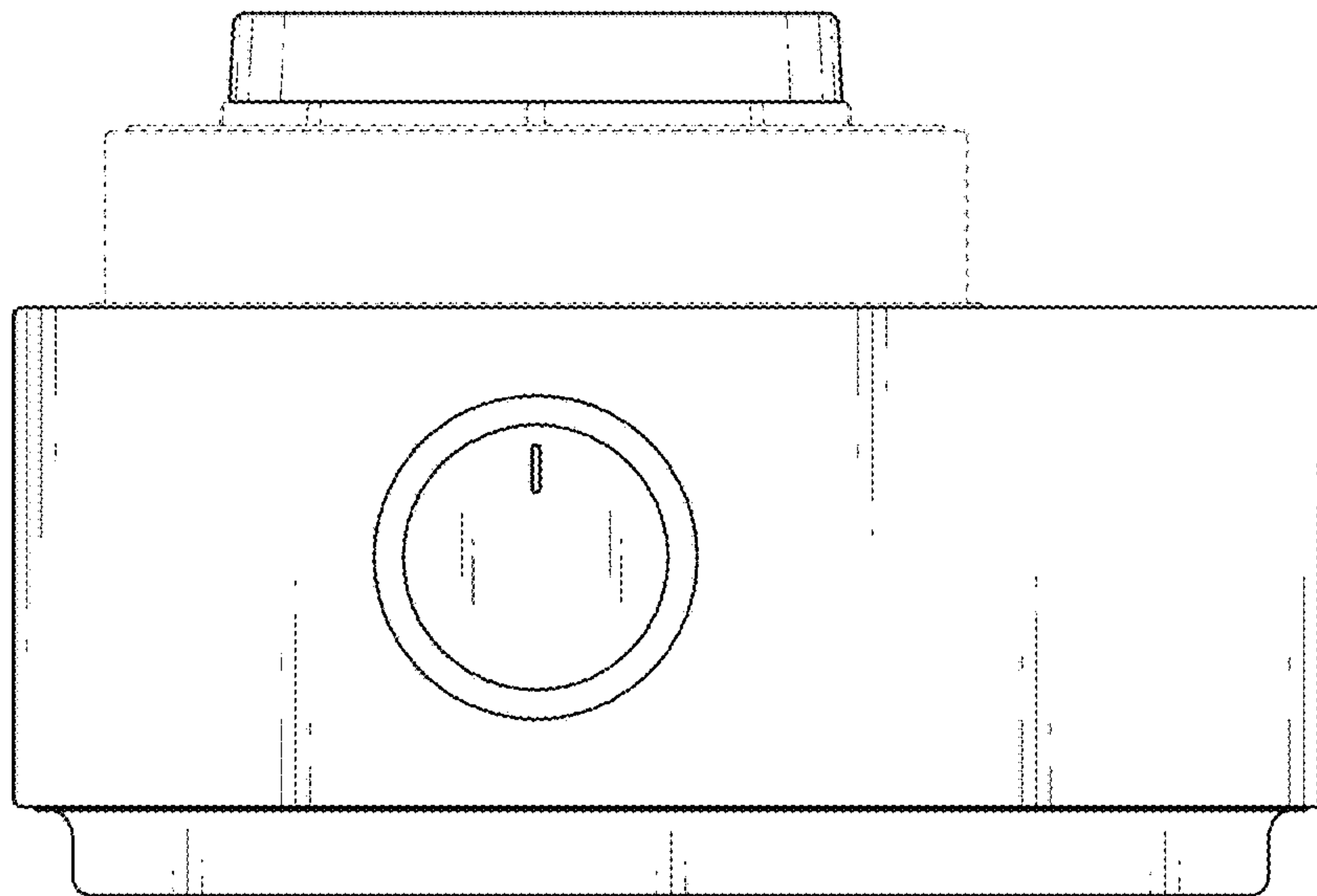

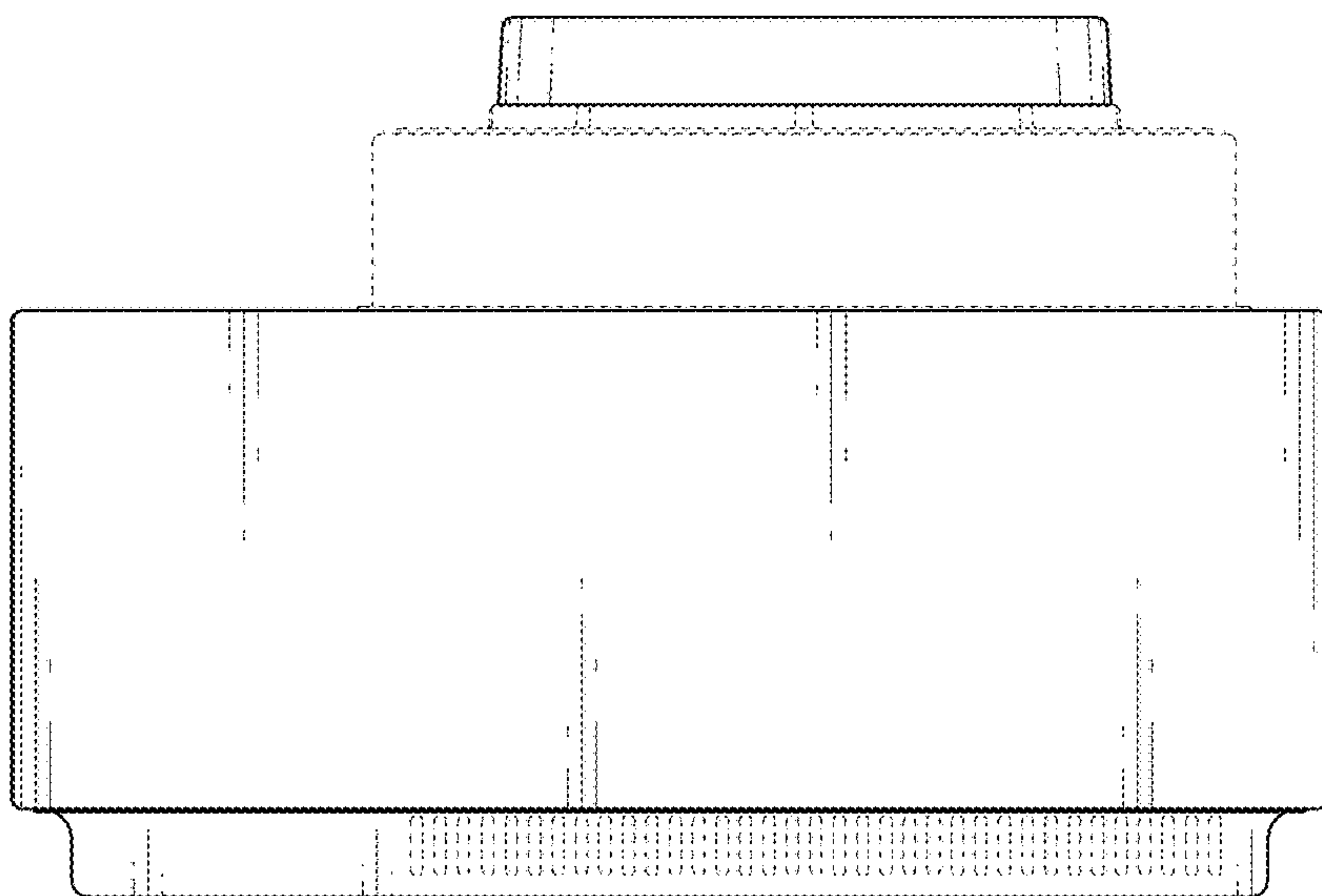

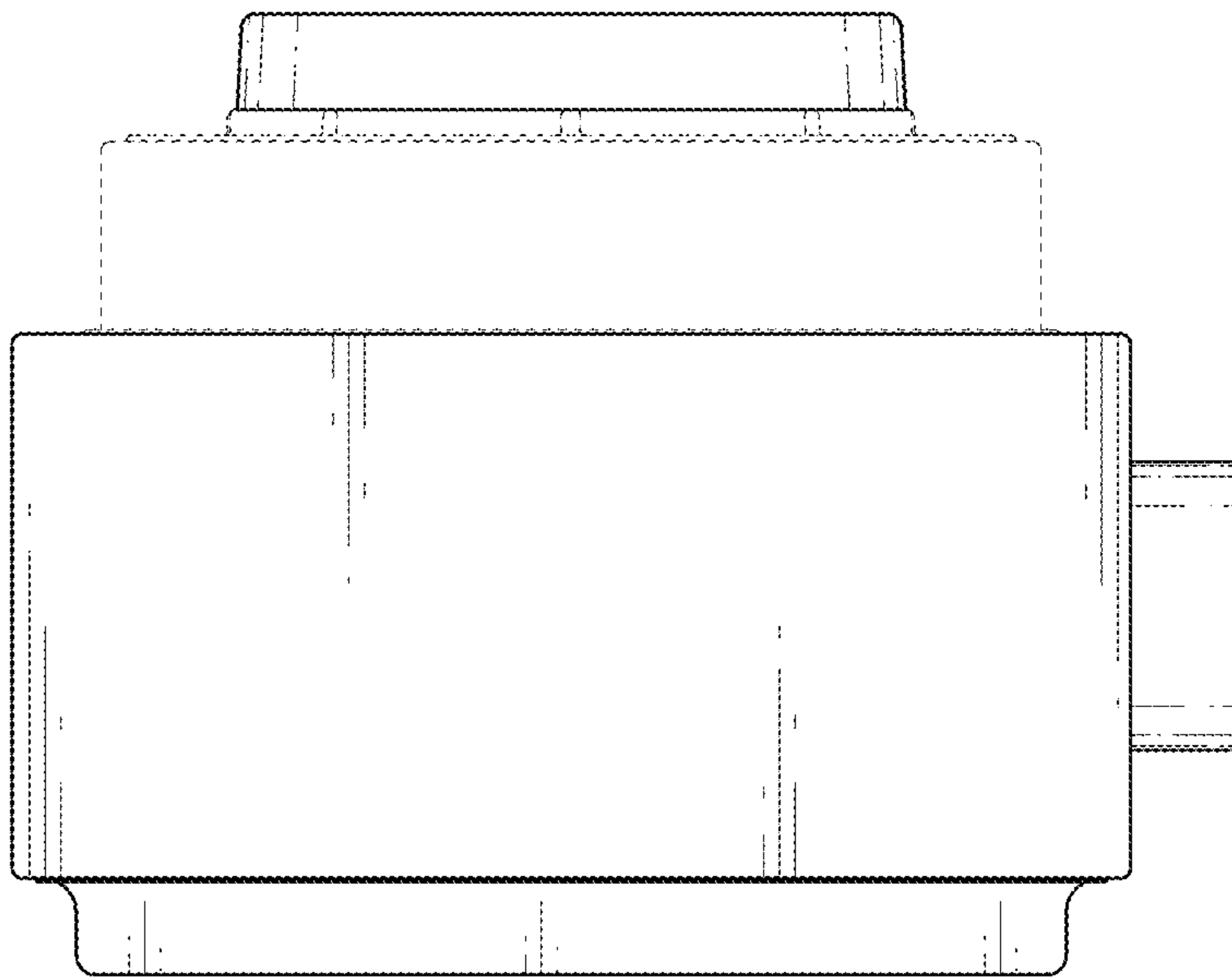

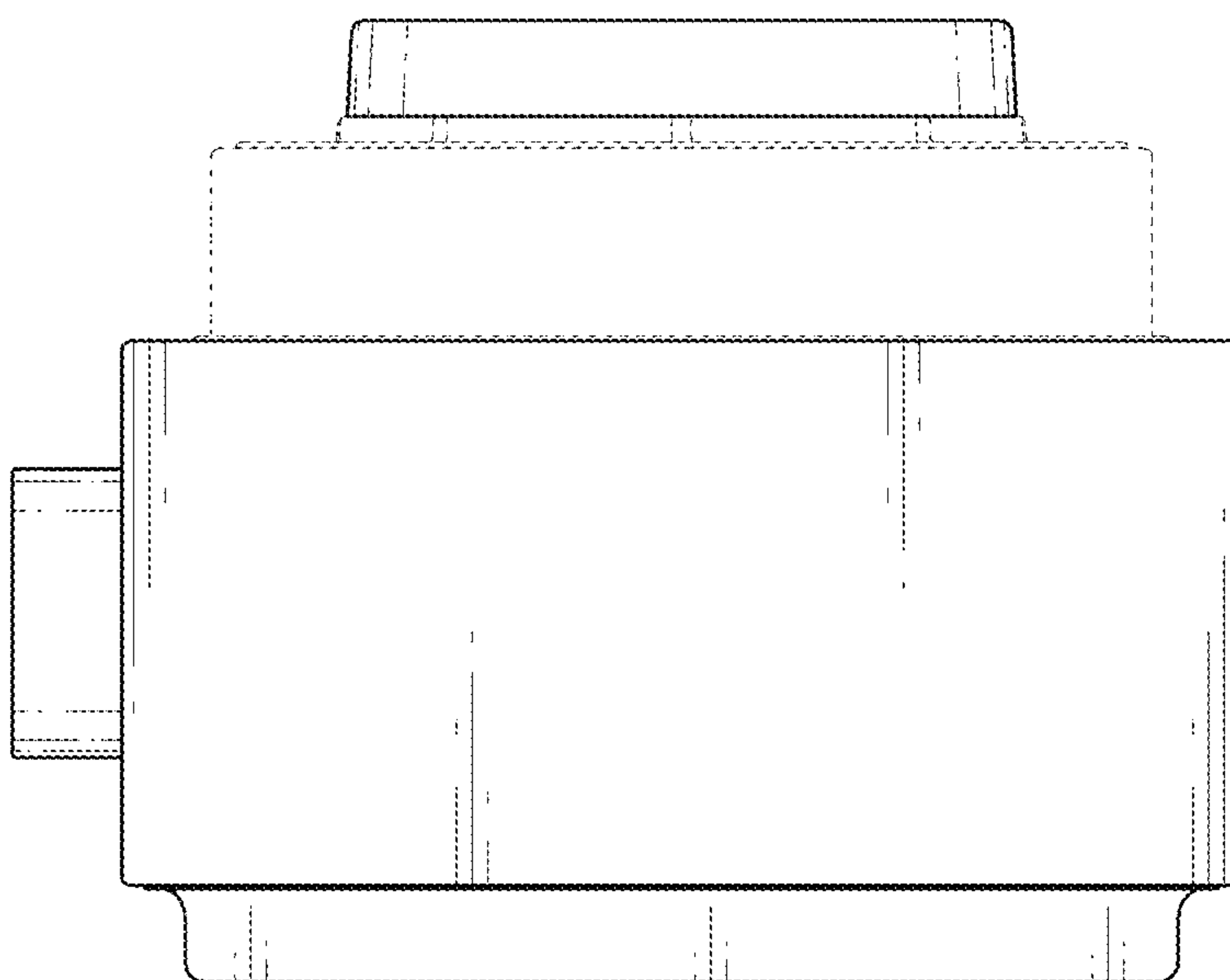

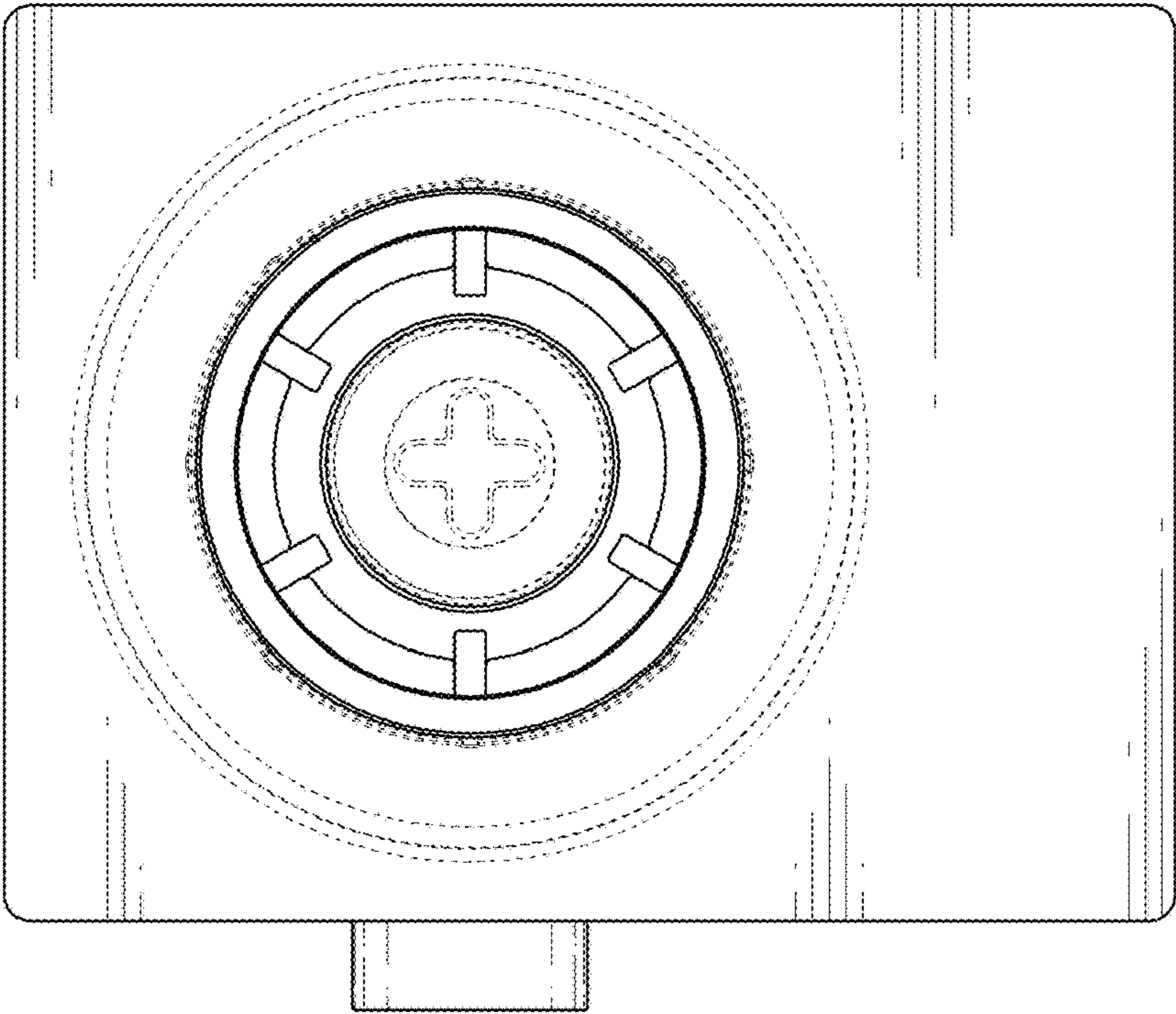

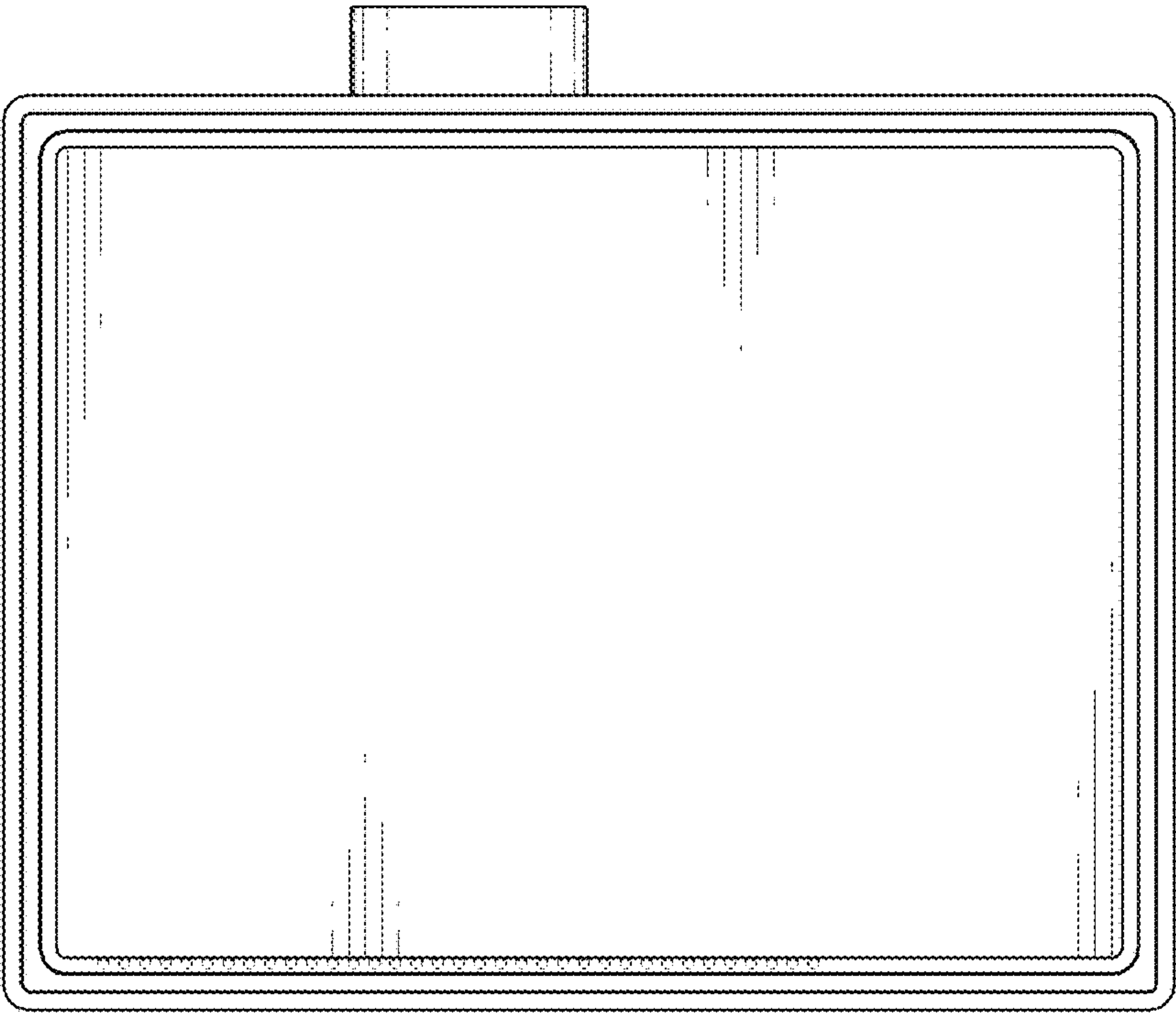
