The broken lines in the drawings represent unclaimed portions of the design.

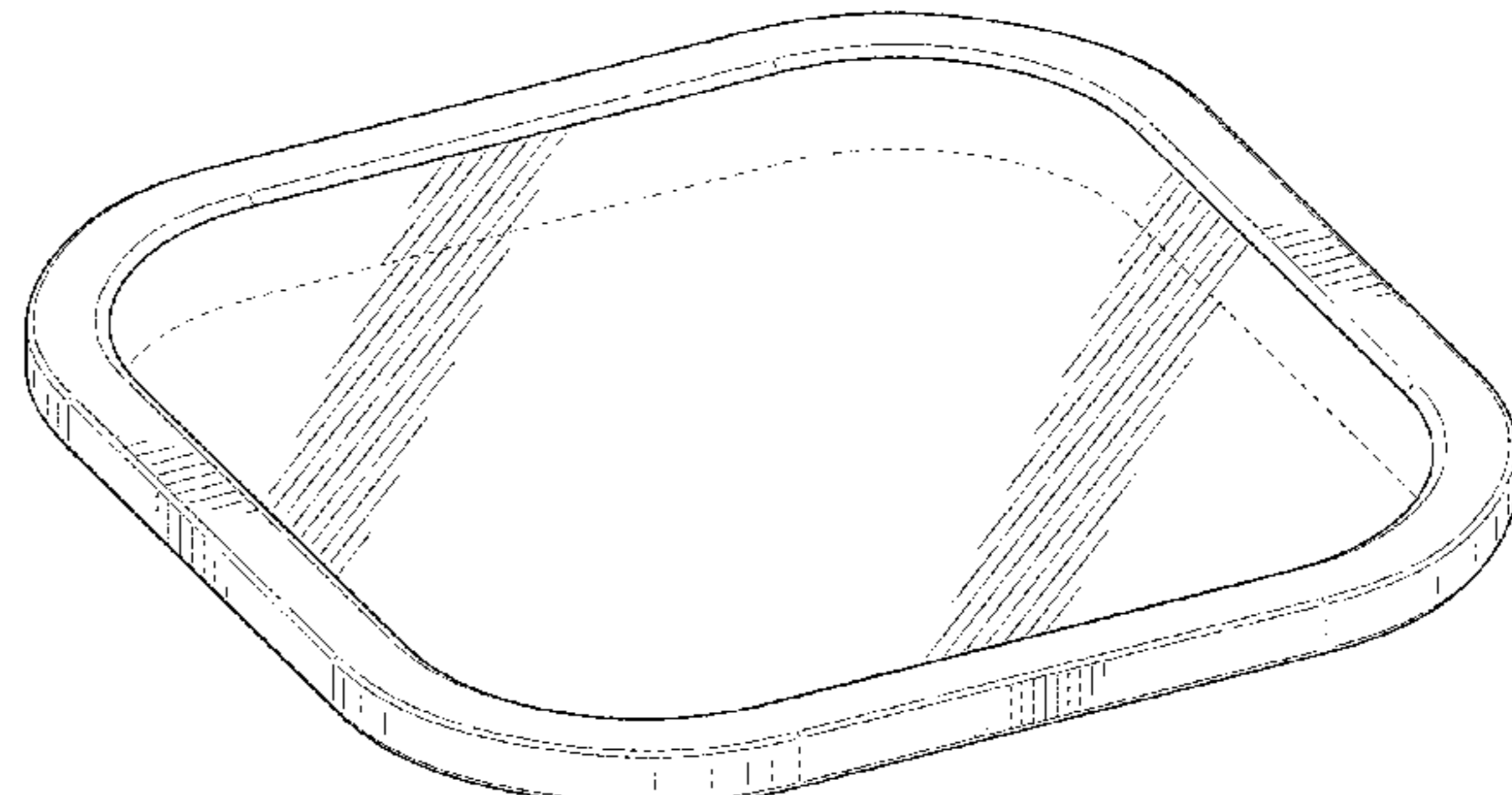
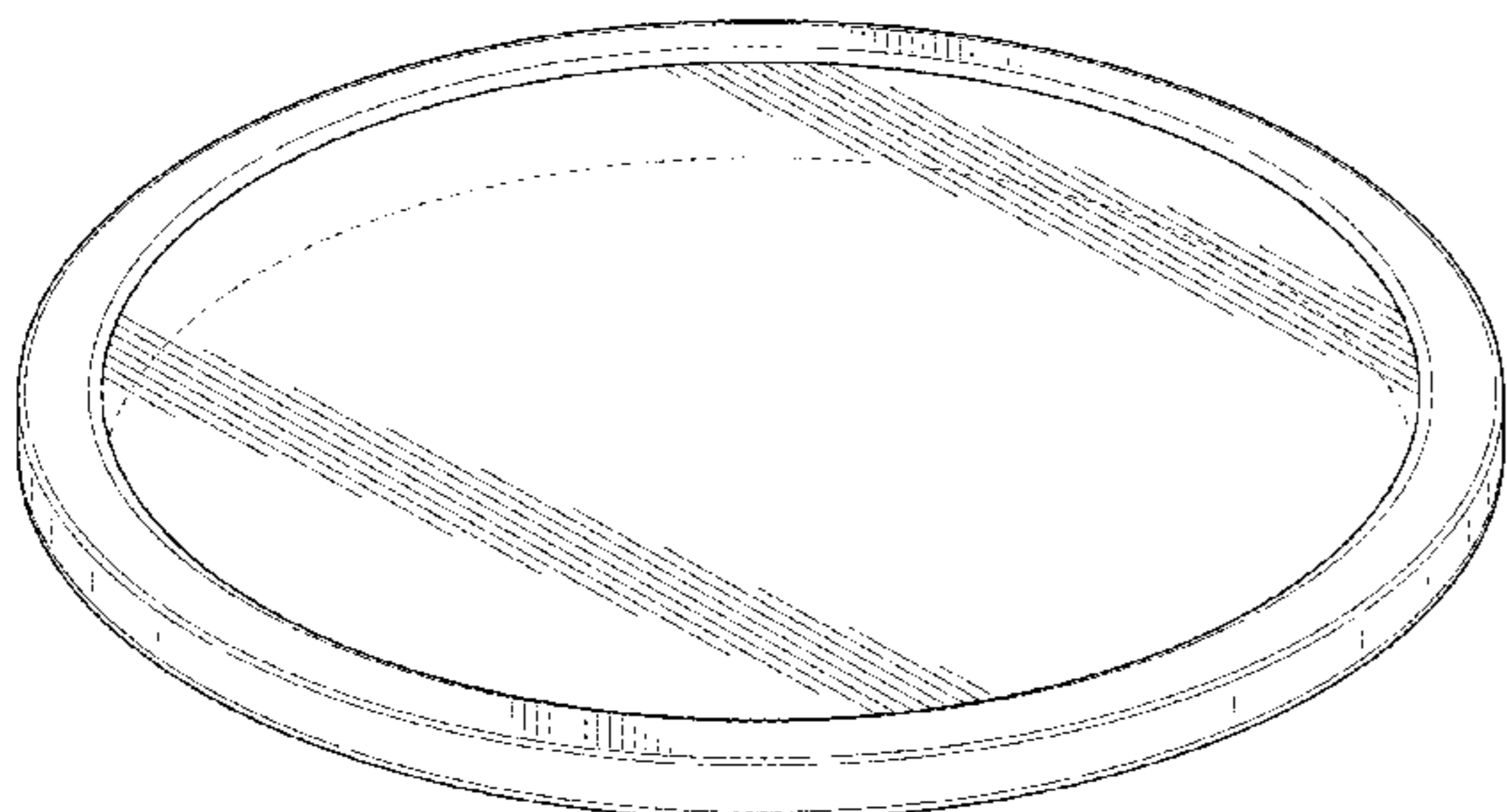

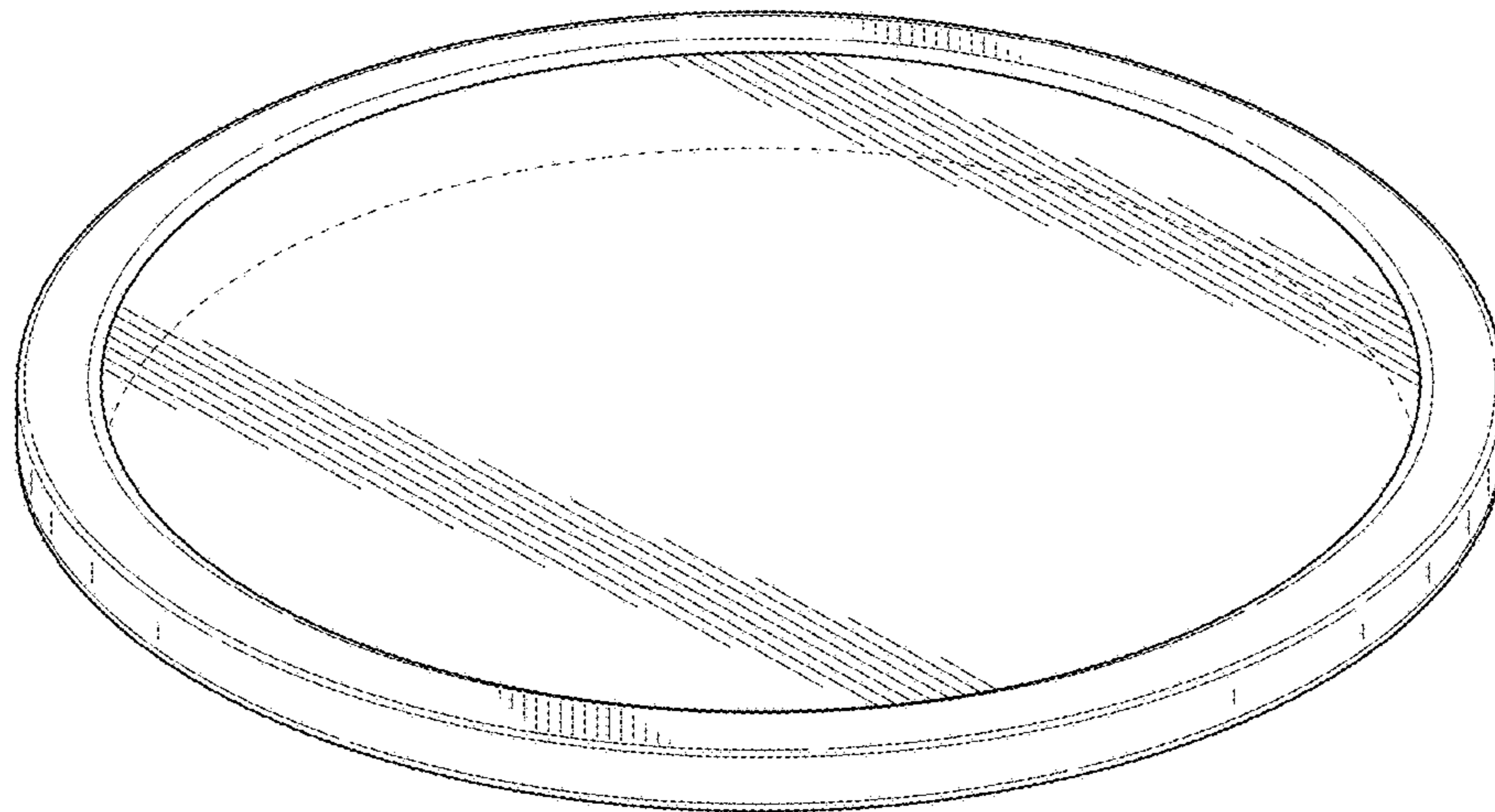

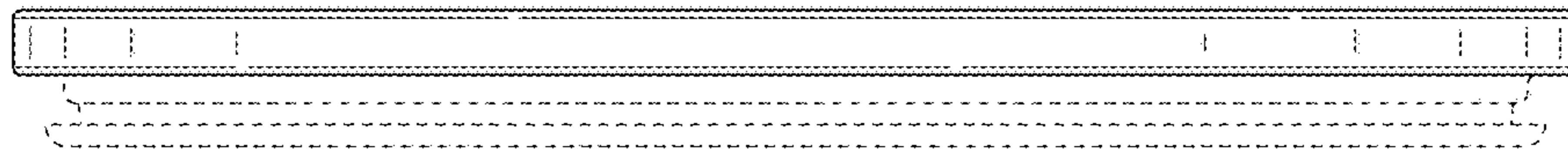

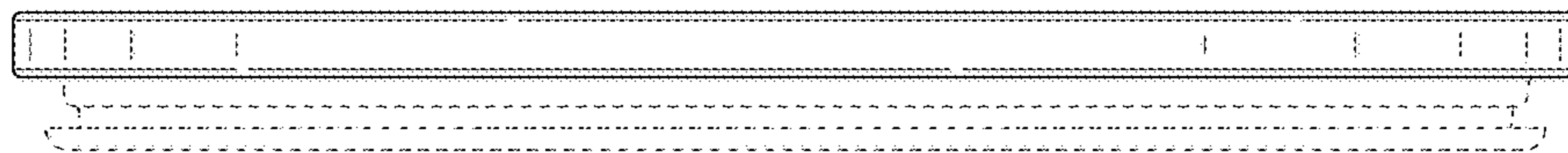

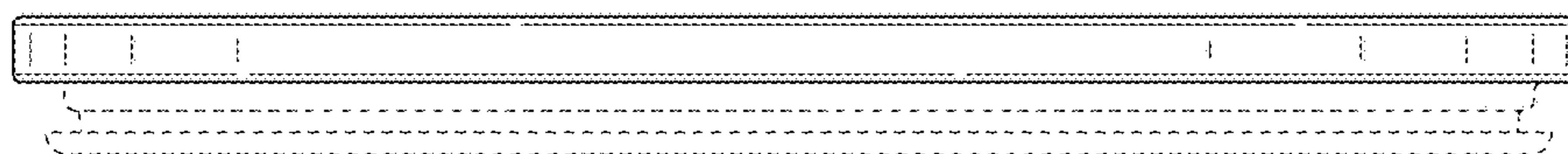

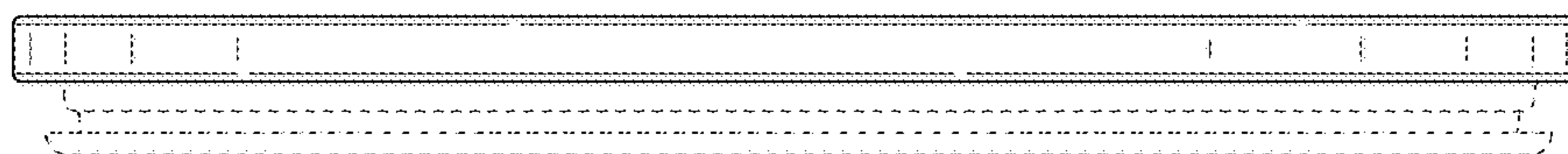

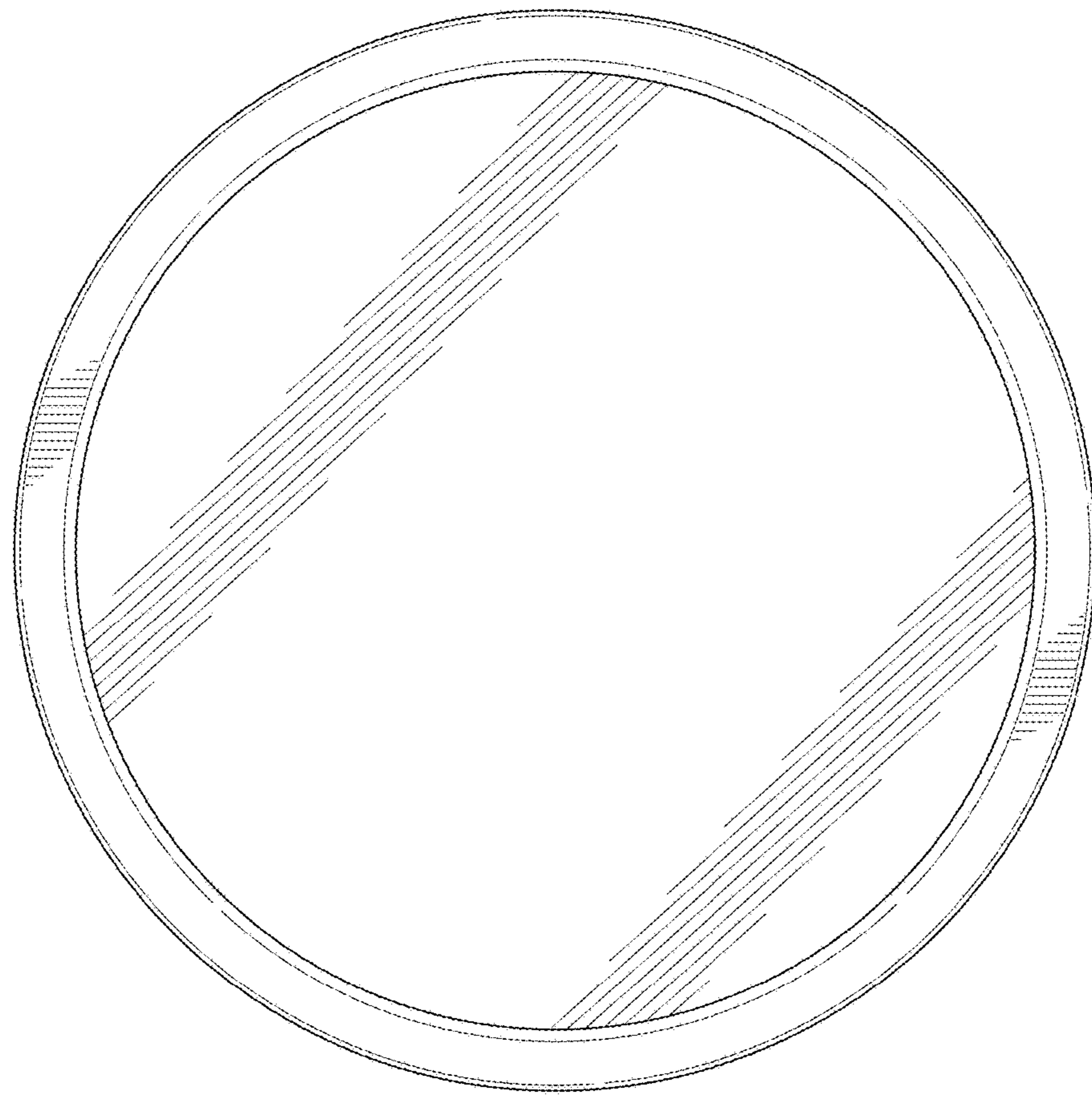

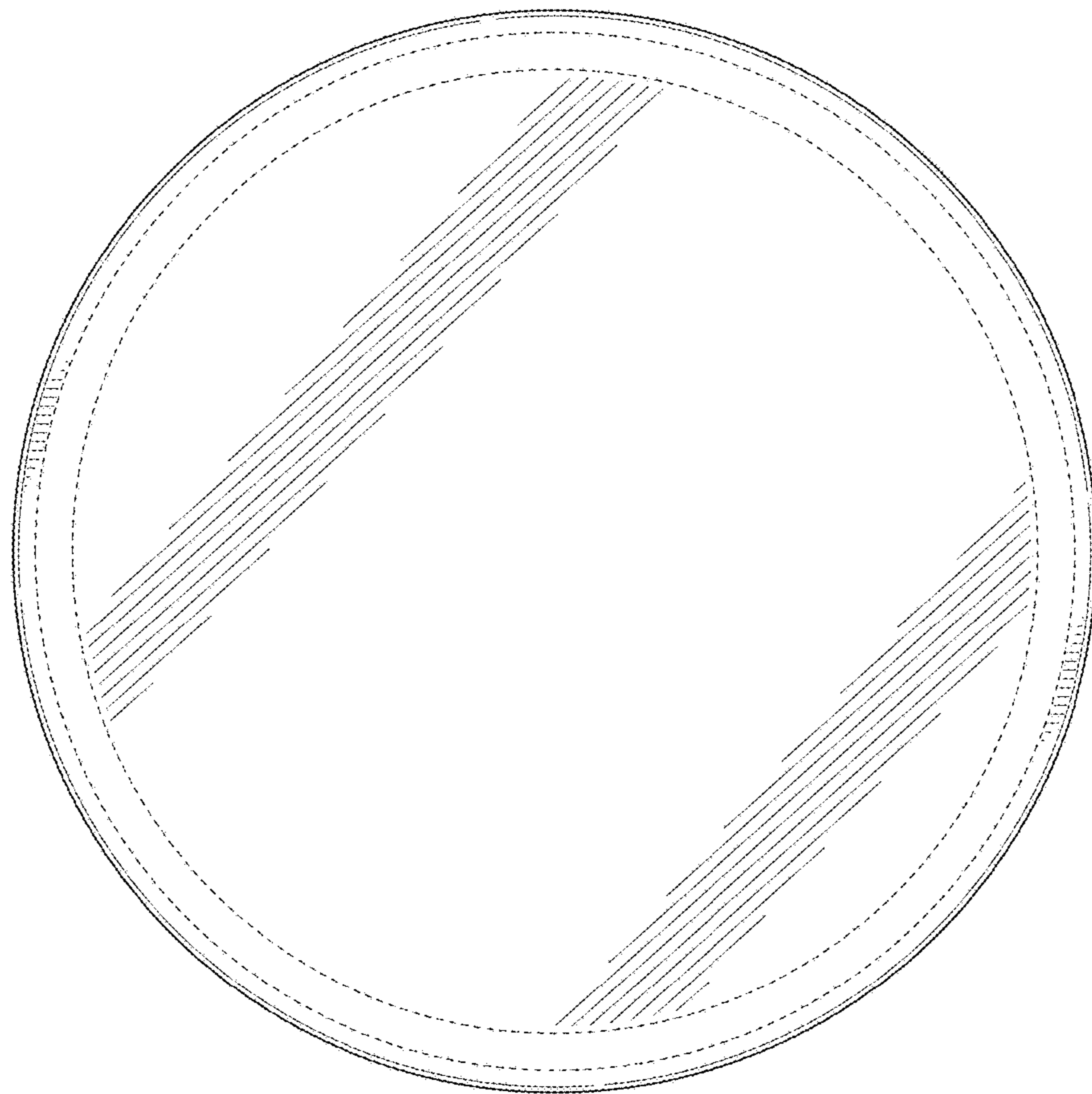

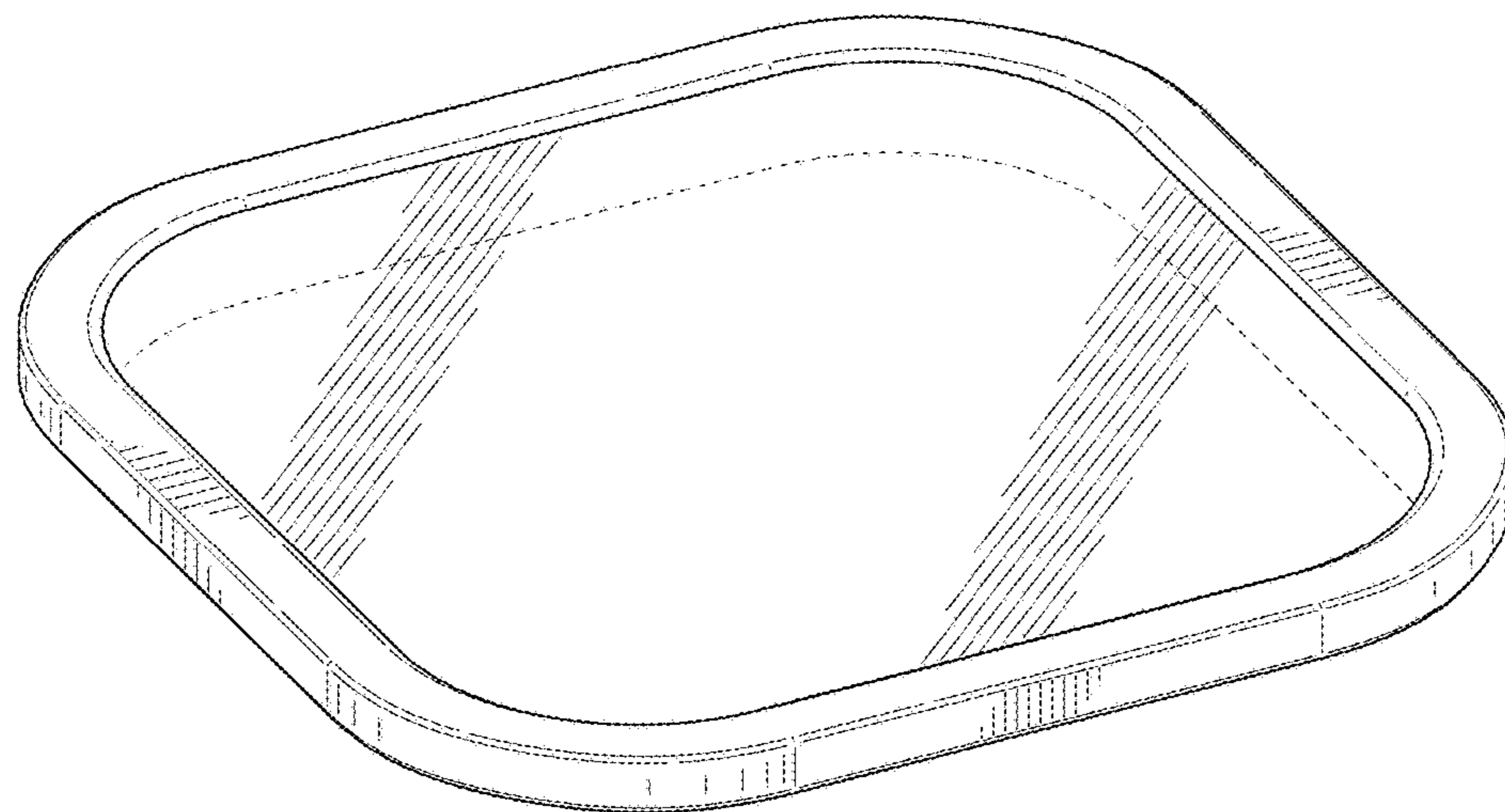

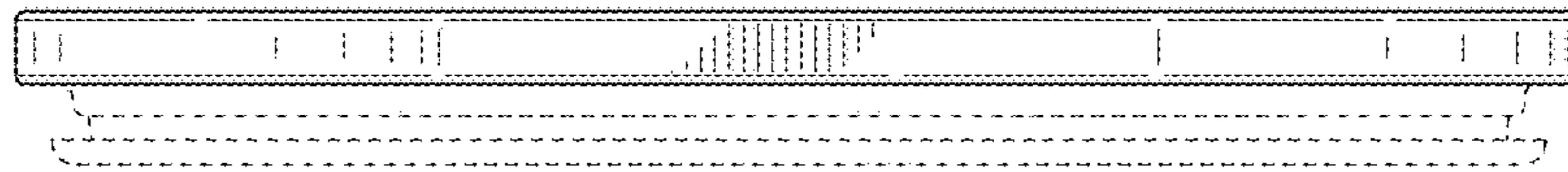

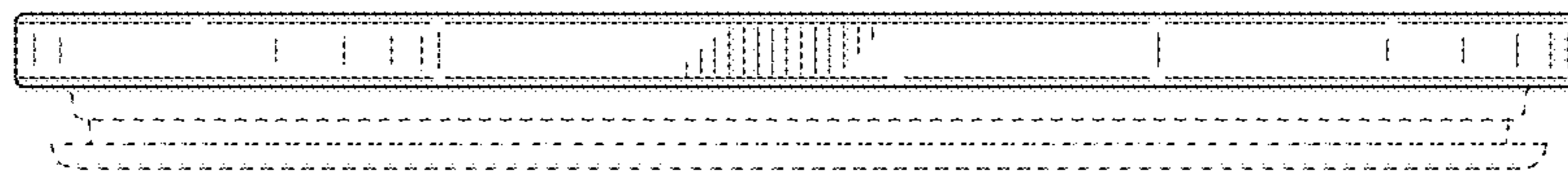

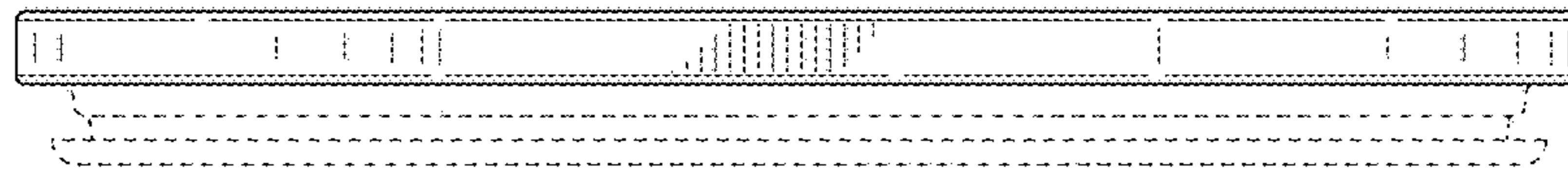

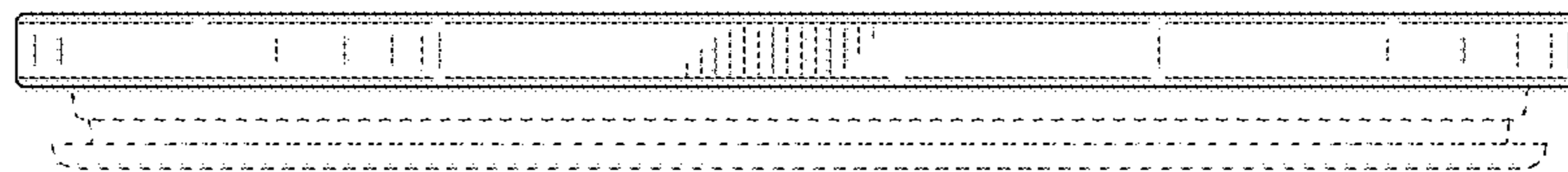

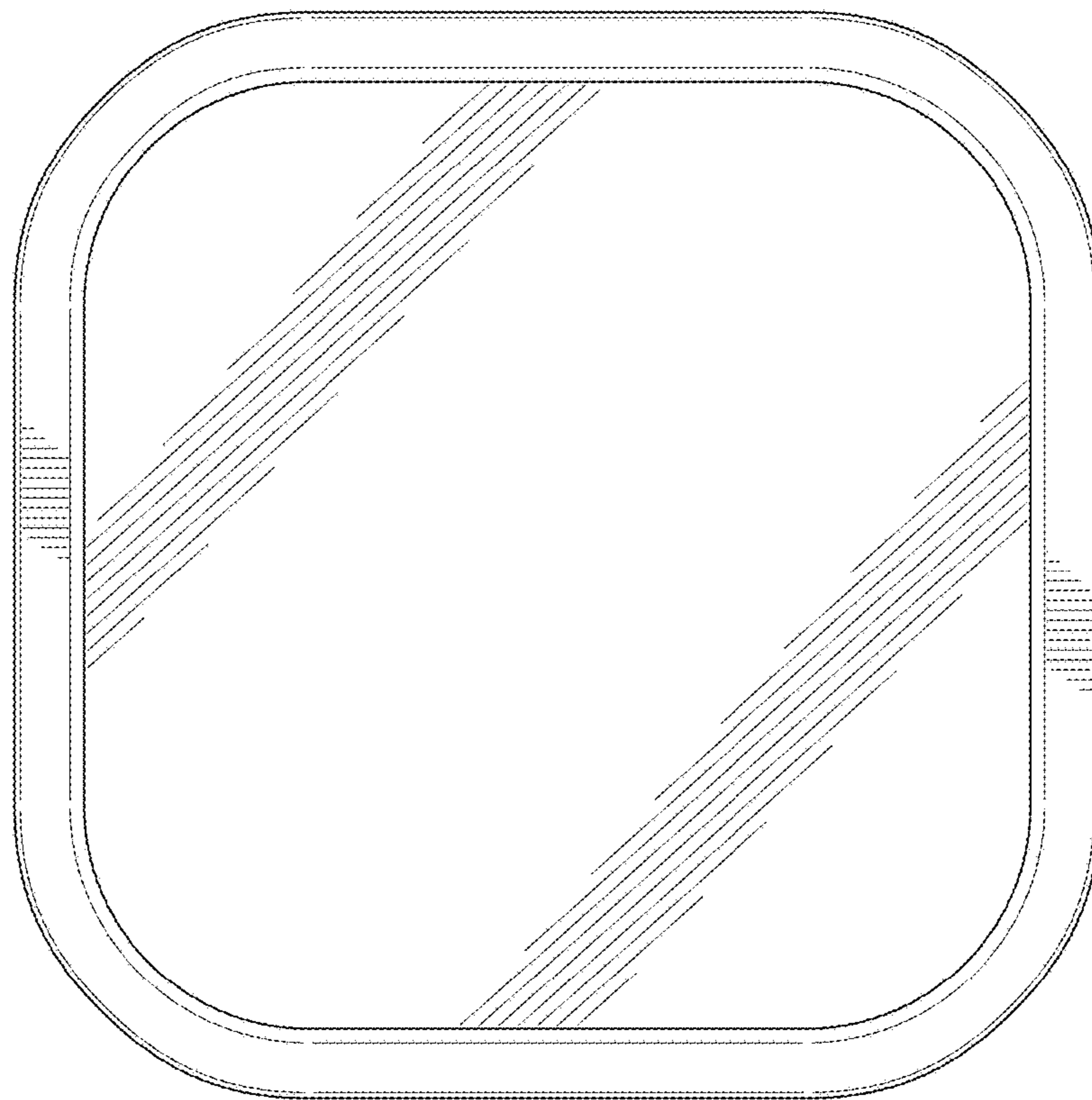

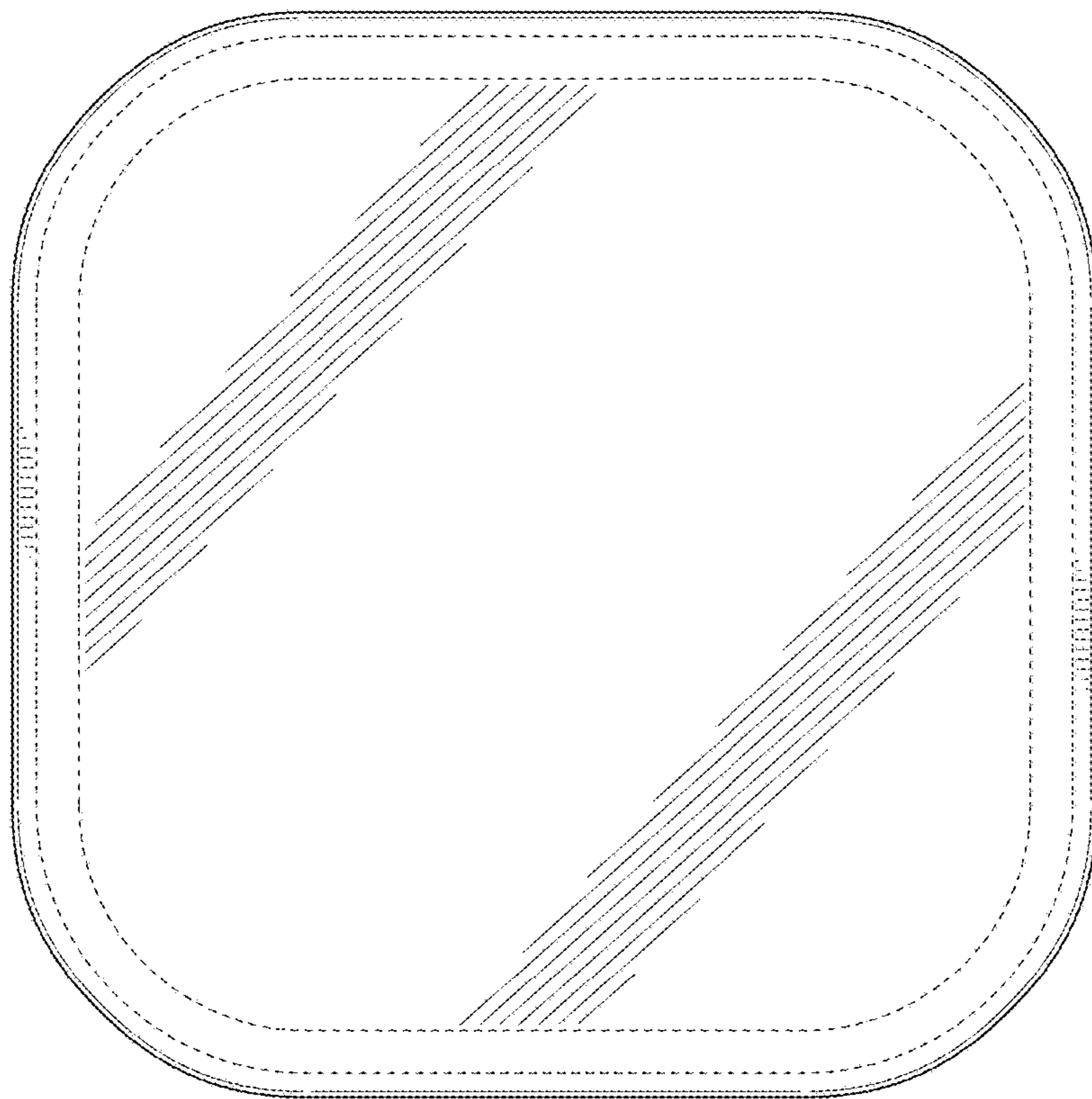

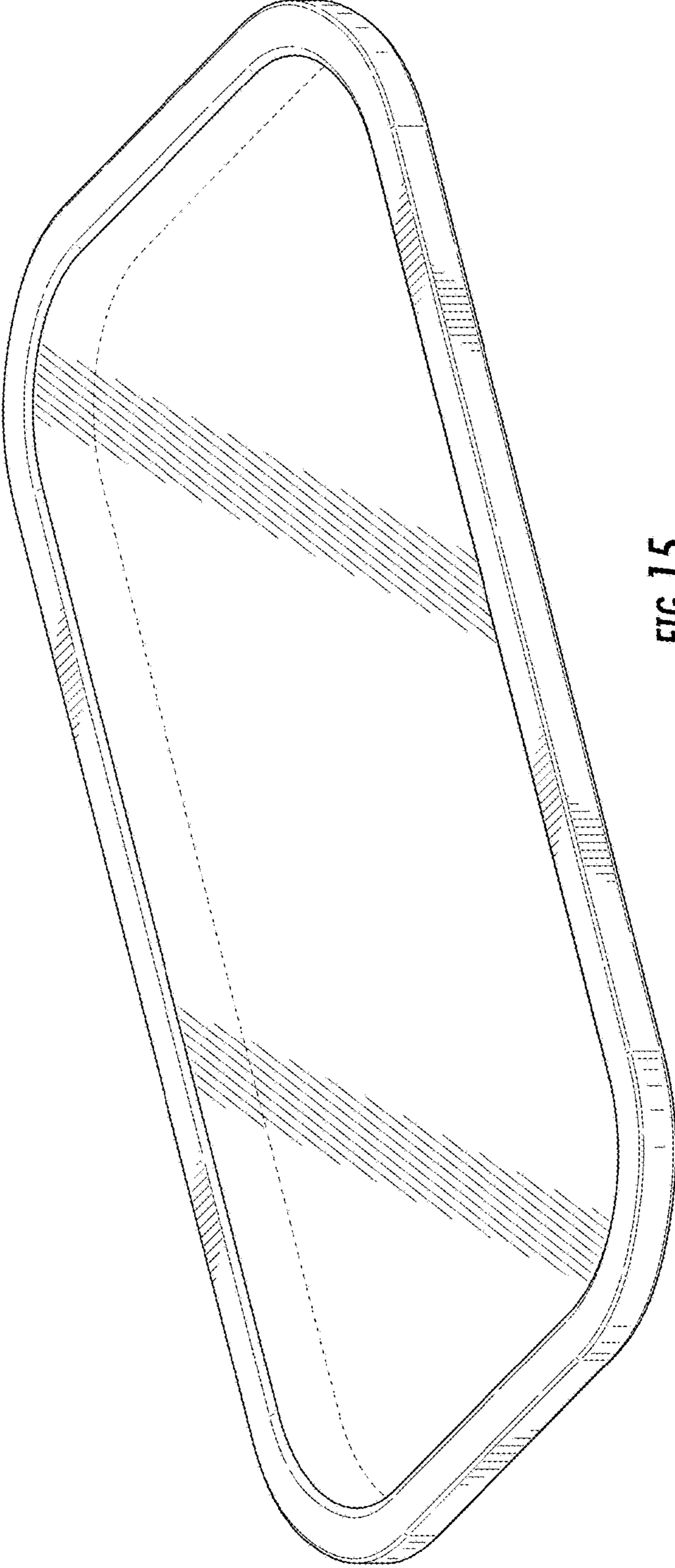

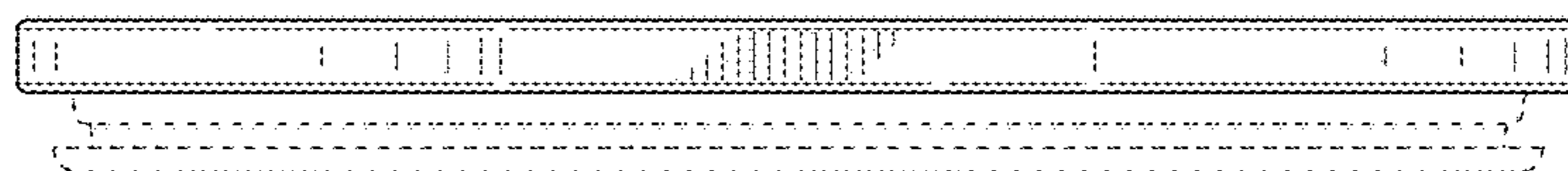

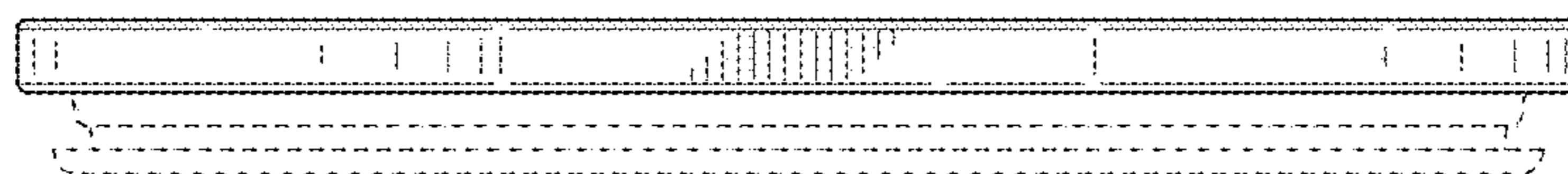

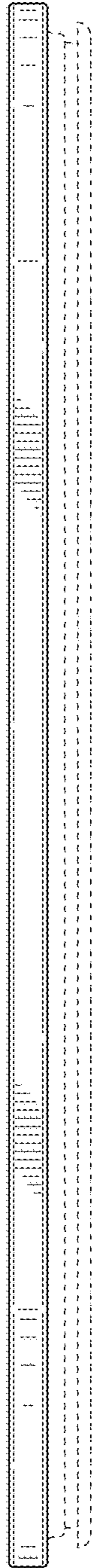

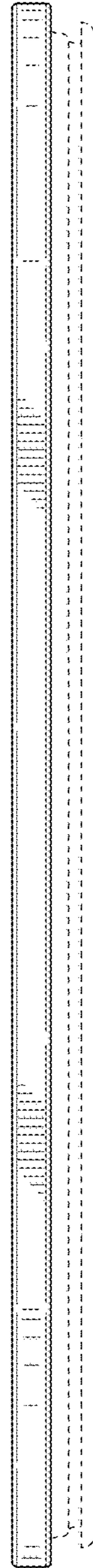

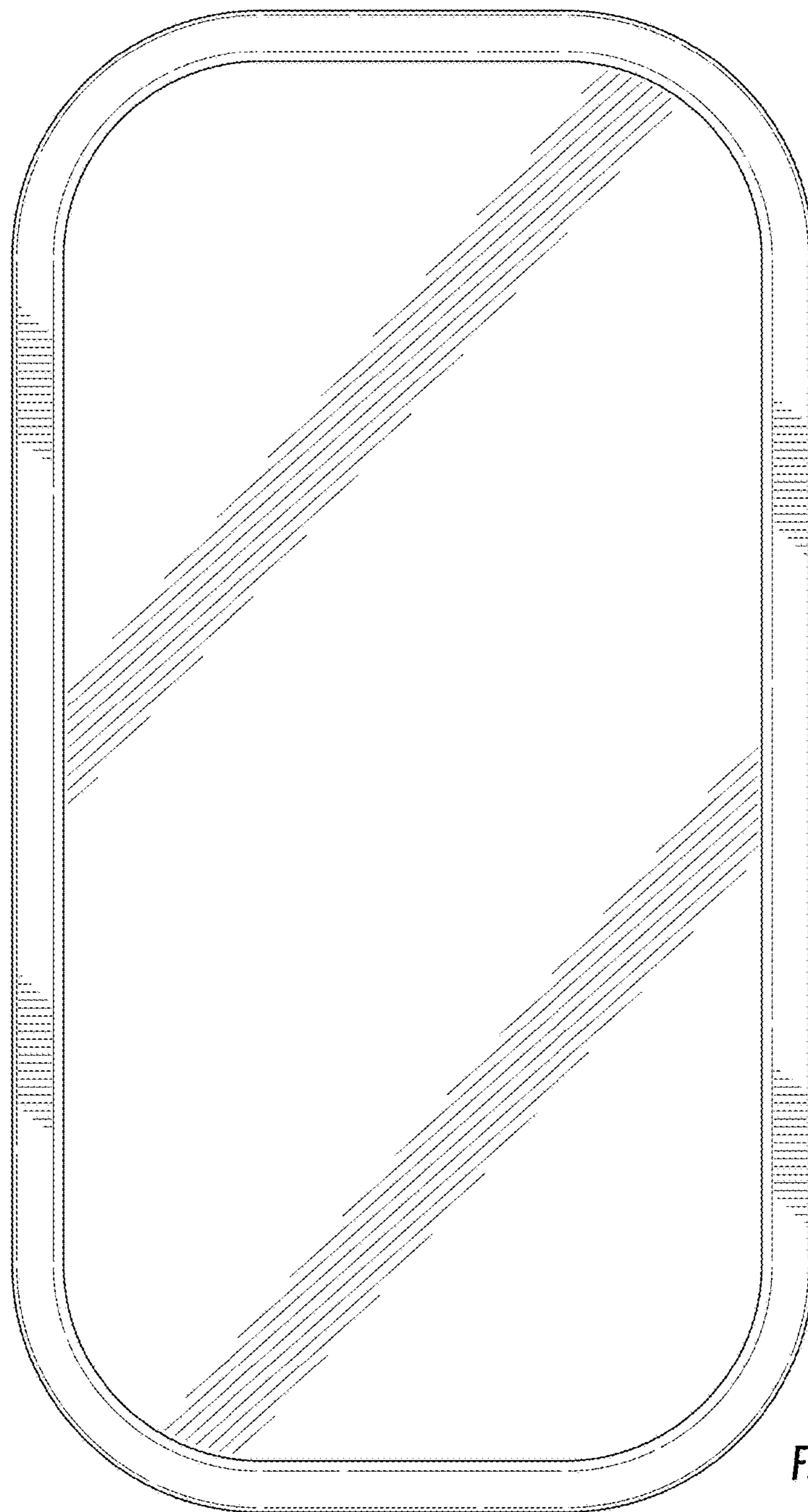

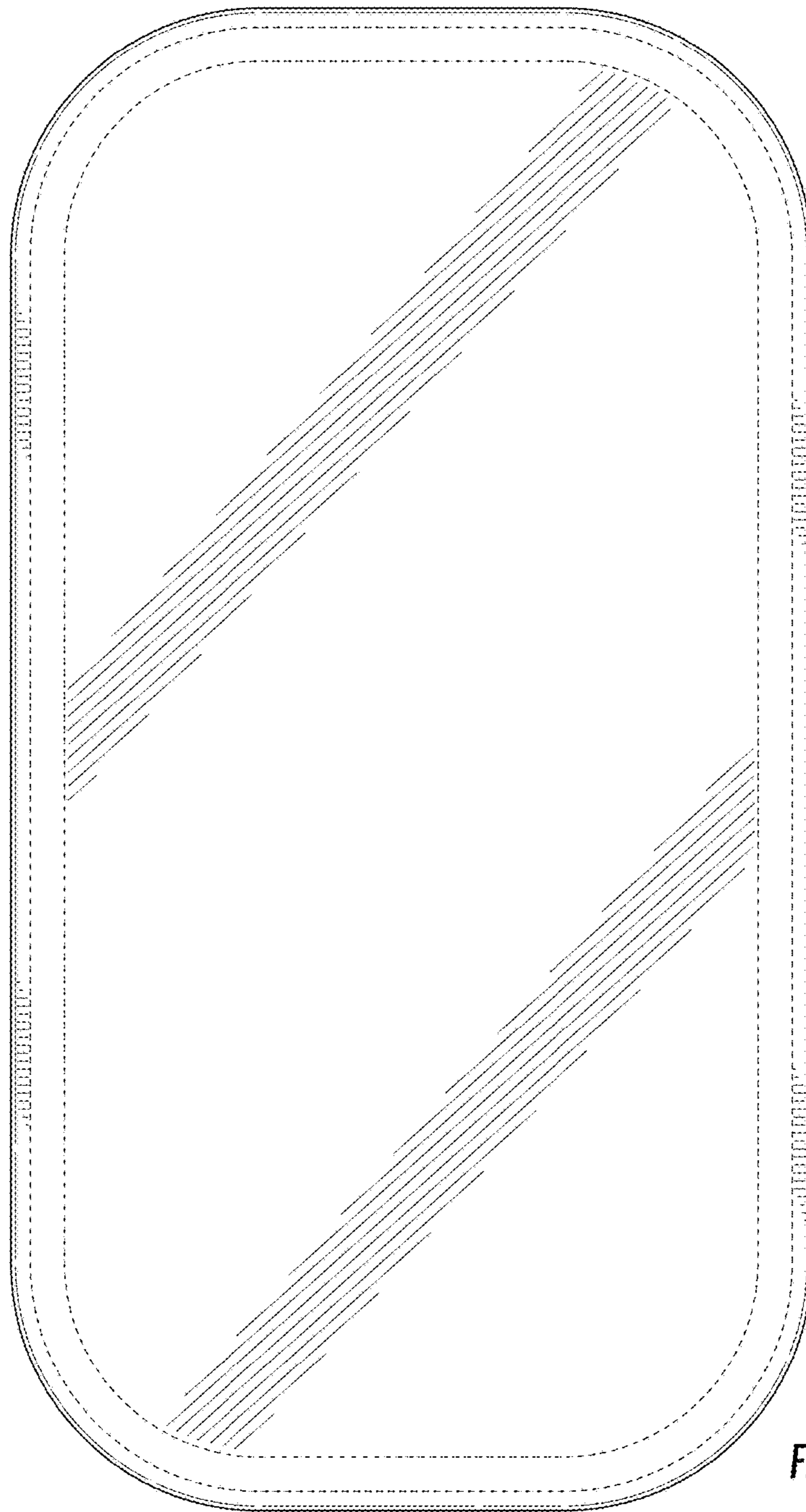
