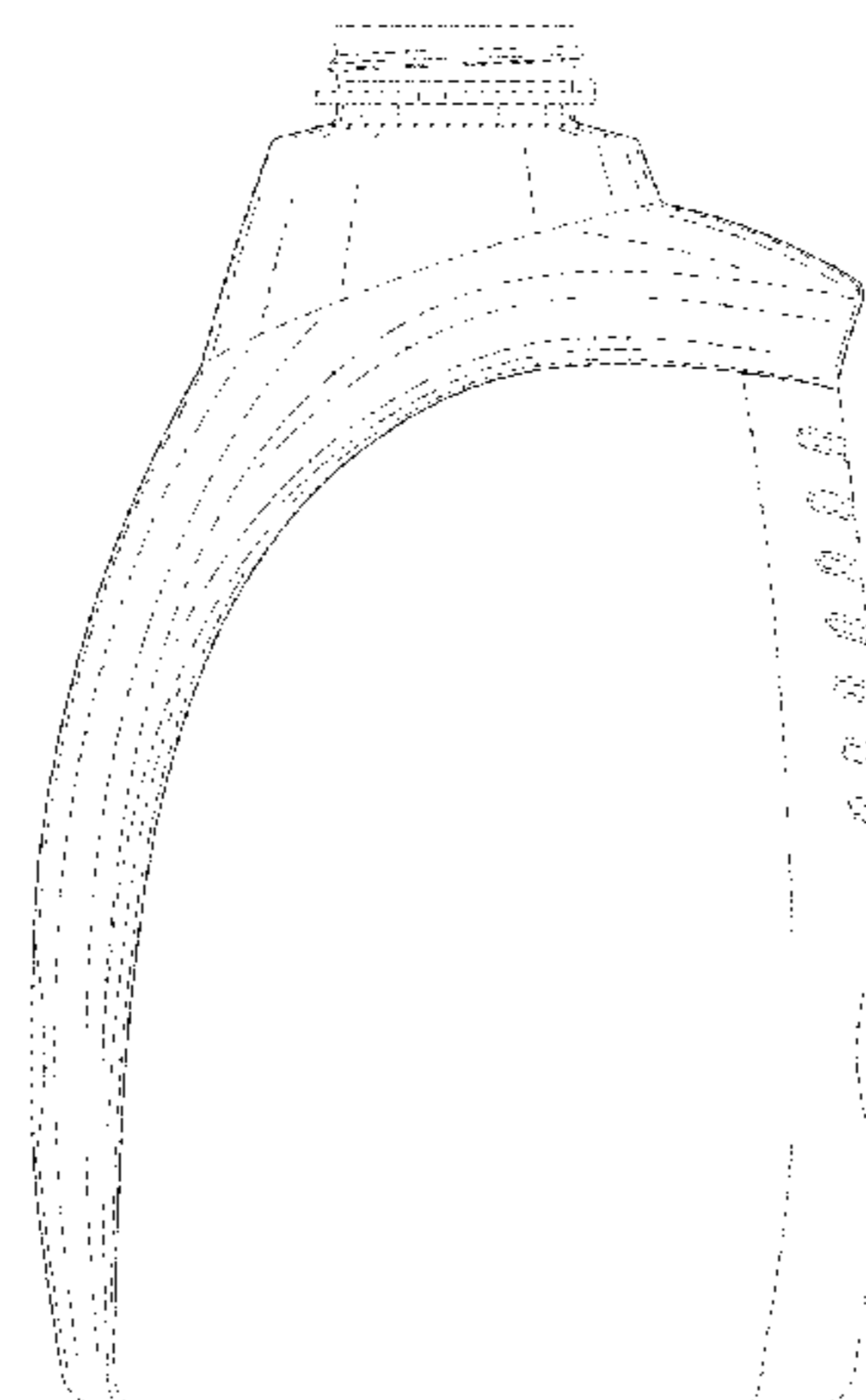
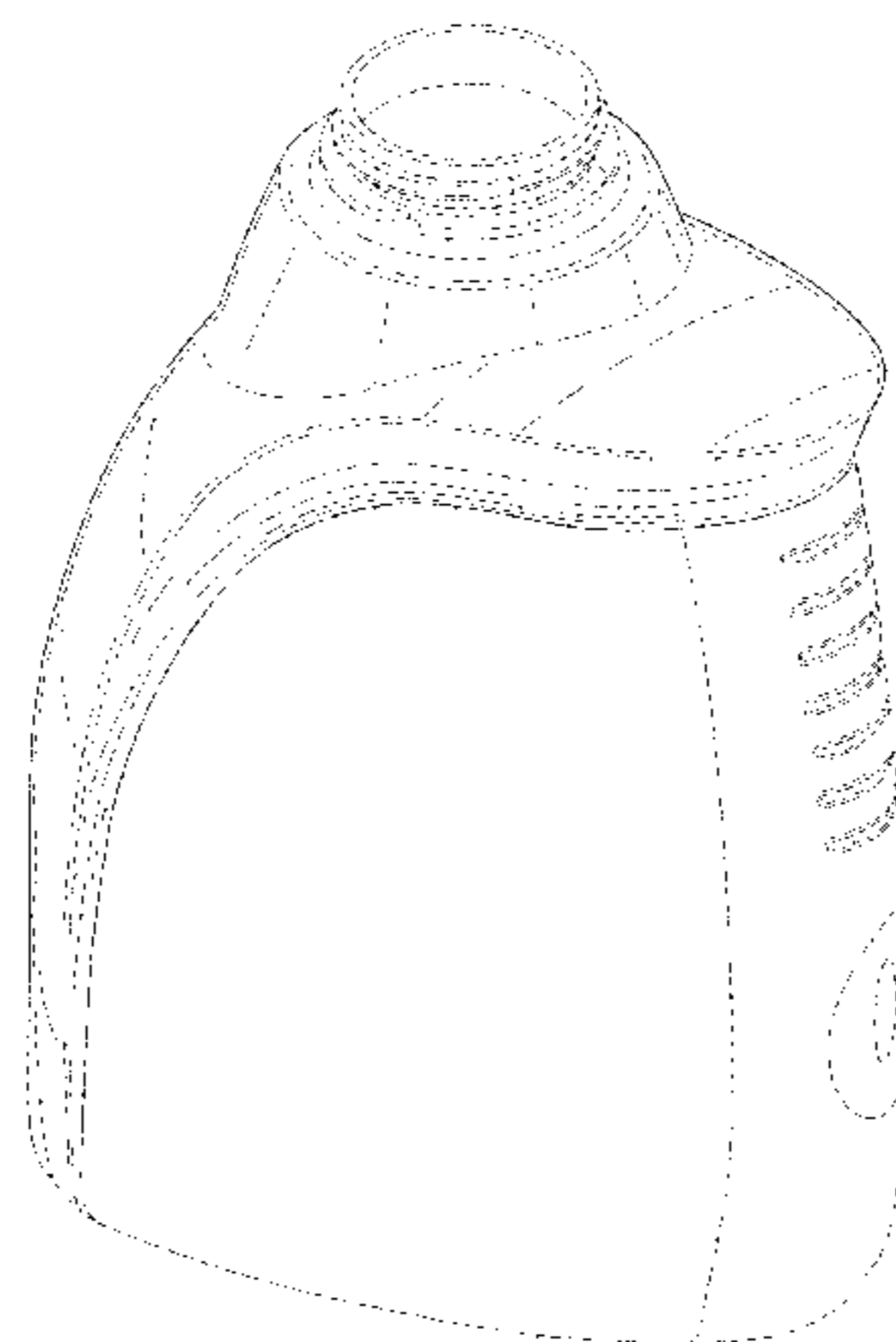
(57) **CLAIM**

The ornamental design for a liquid container, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, left side perspective view of an embodiment of a liquid container showing our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a top, rear, right side perspective view thereof; and, FIG. 9 is a bottom, front, left side perspective view thereof. The evenly-dashed broken lines in the drawings illustrate the portions of the liquid container that form no part of the claim. The dot-dash broken lines in the drawings define the bounds of the claim and form no part thereof.

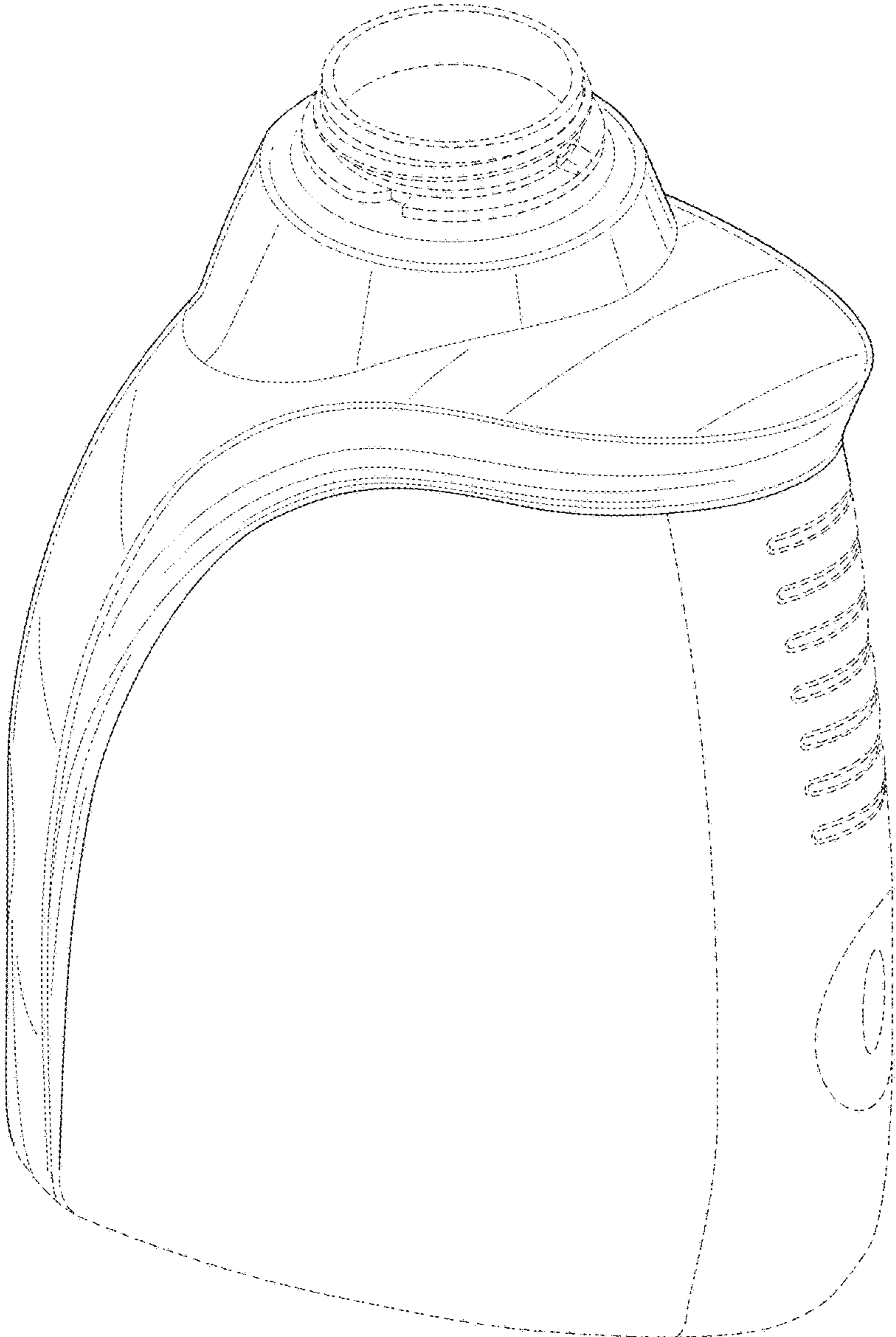

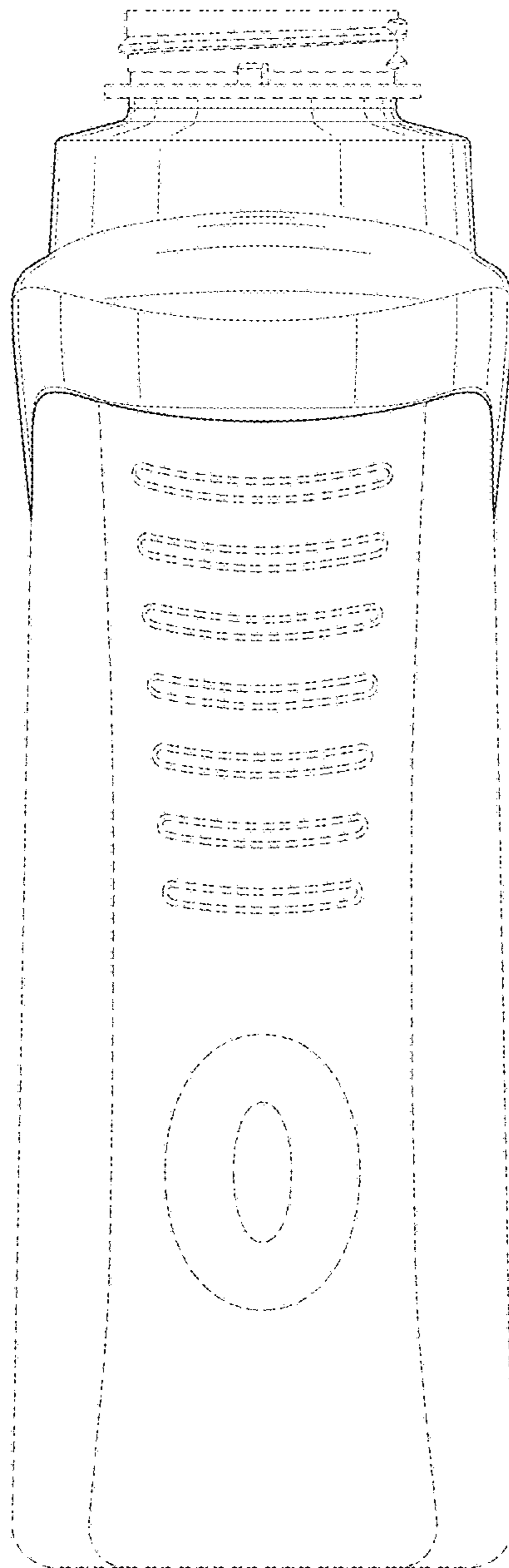

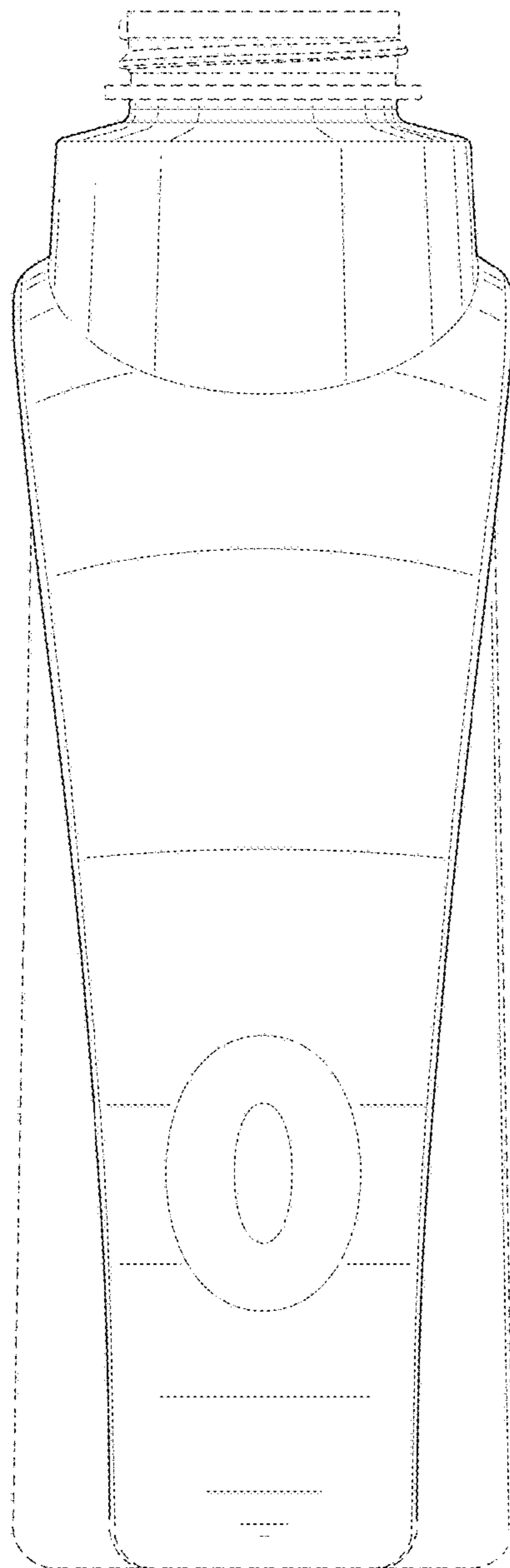

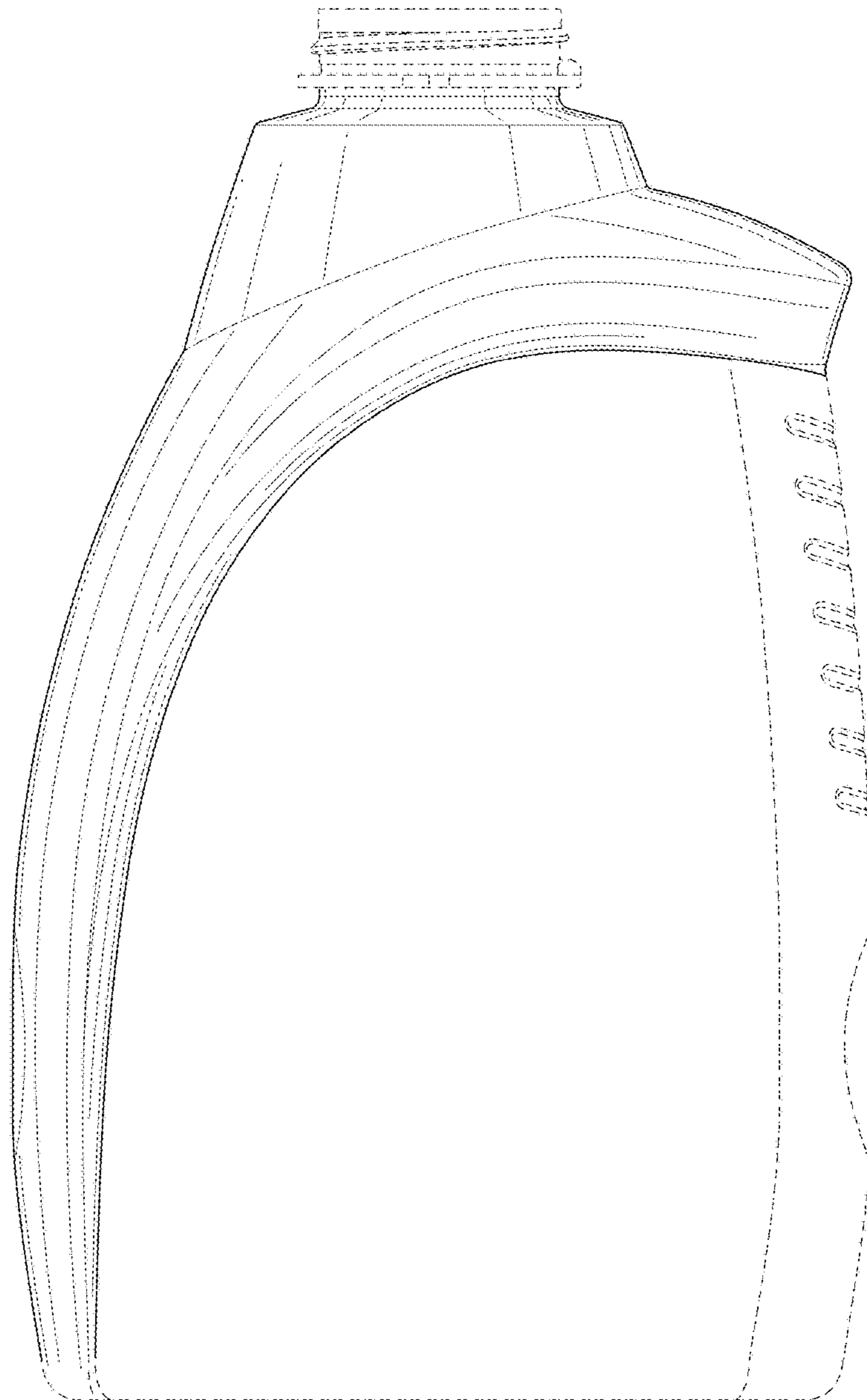

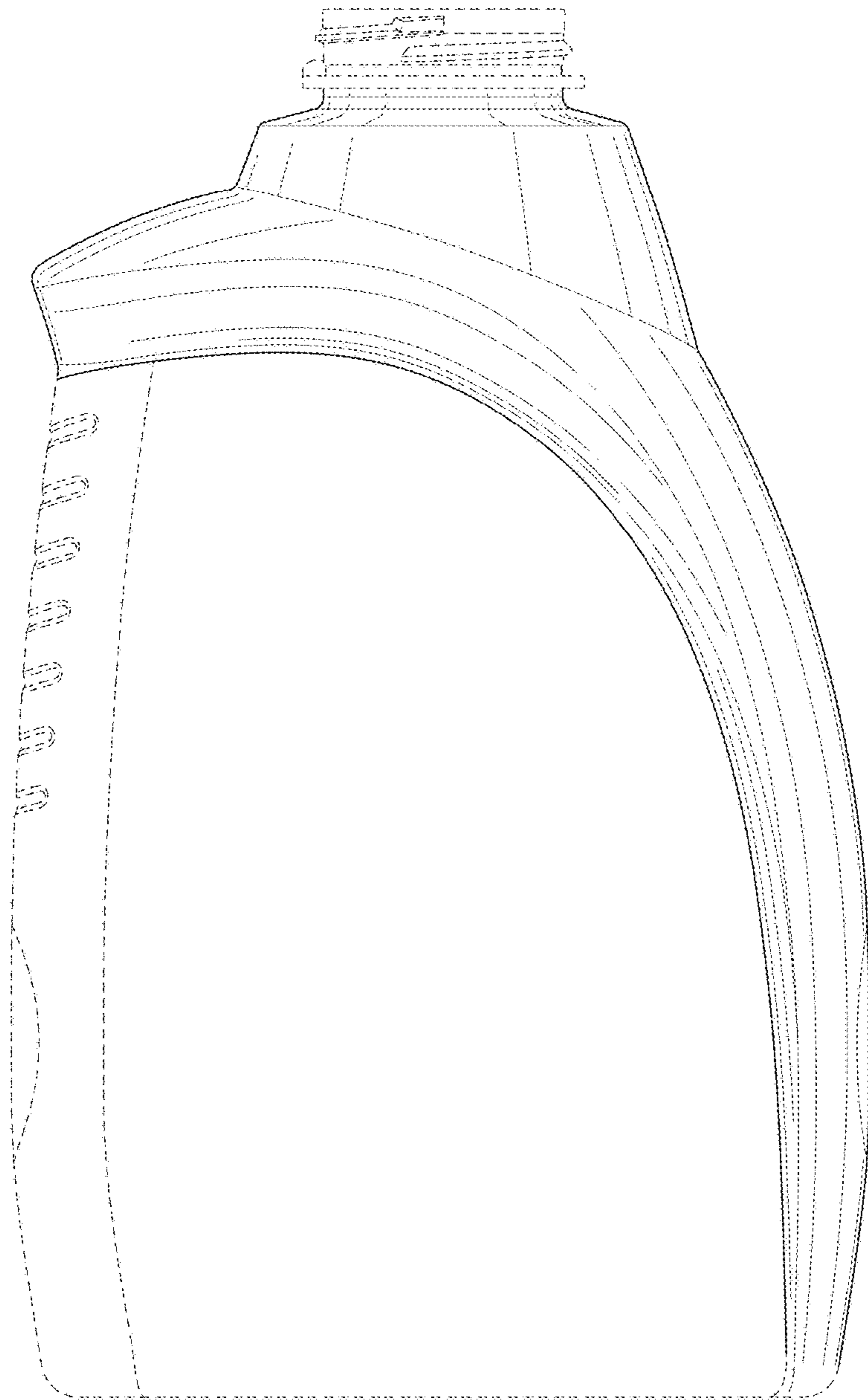

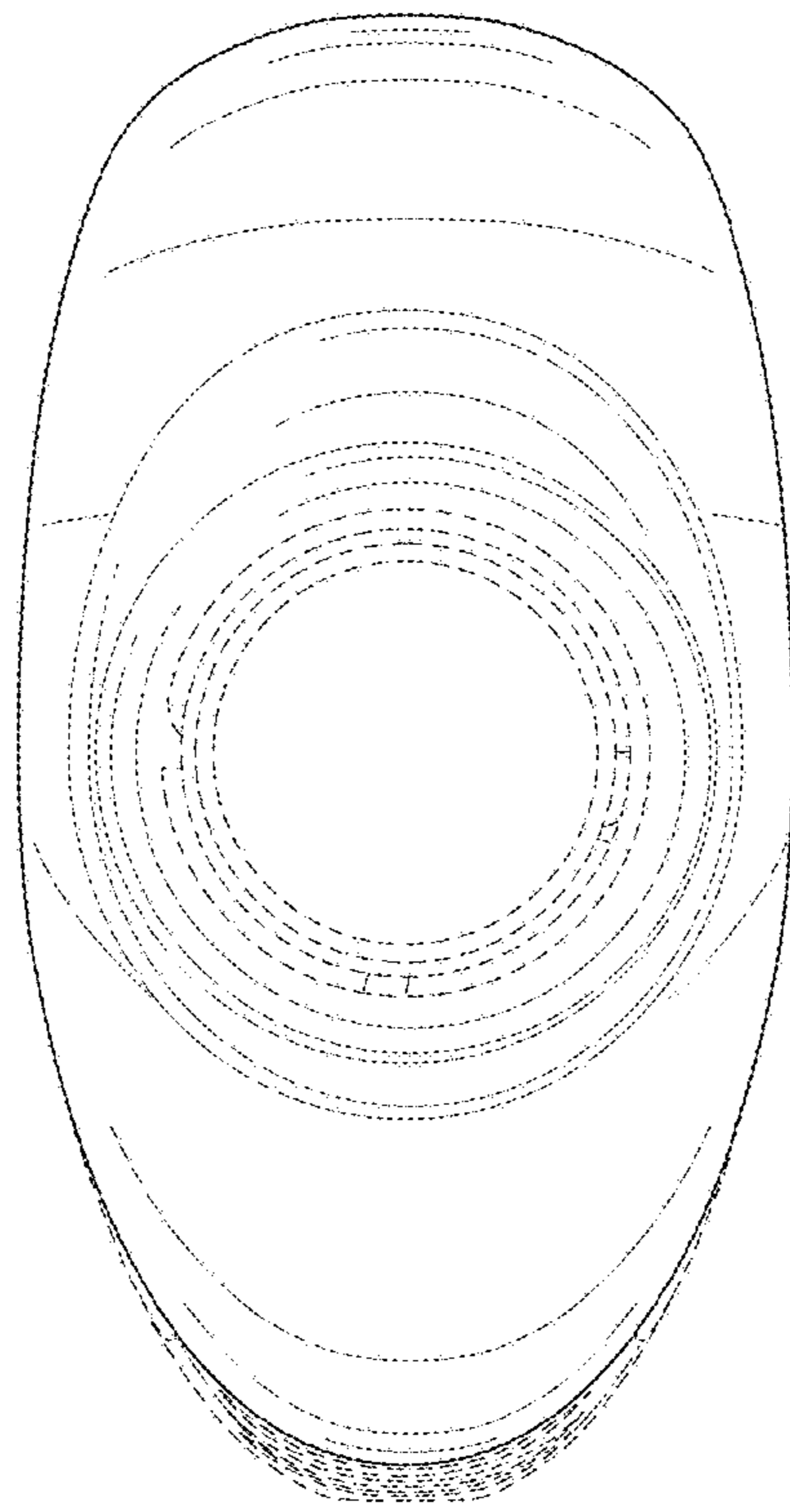

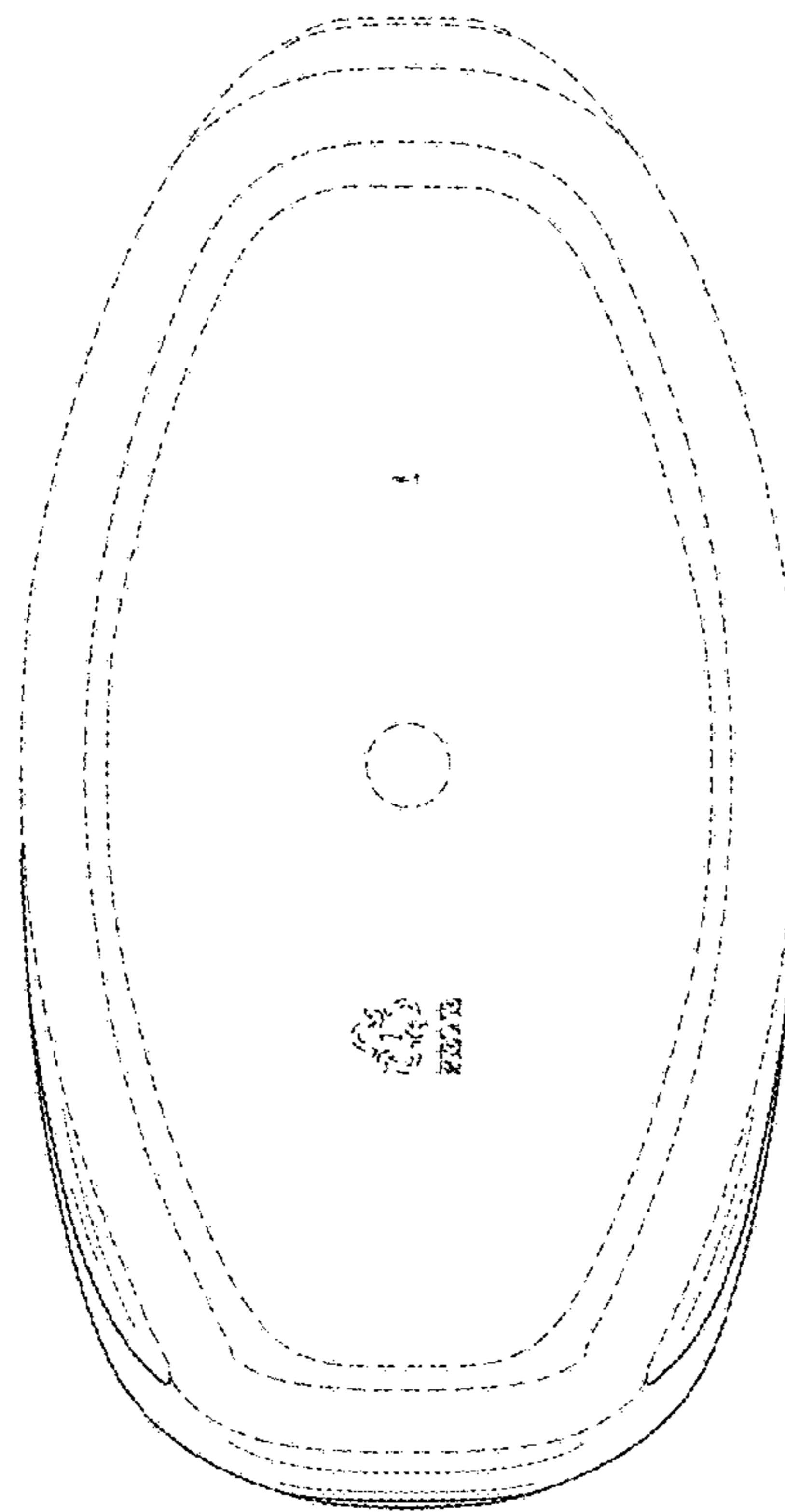

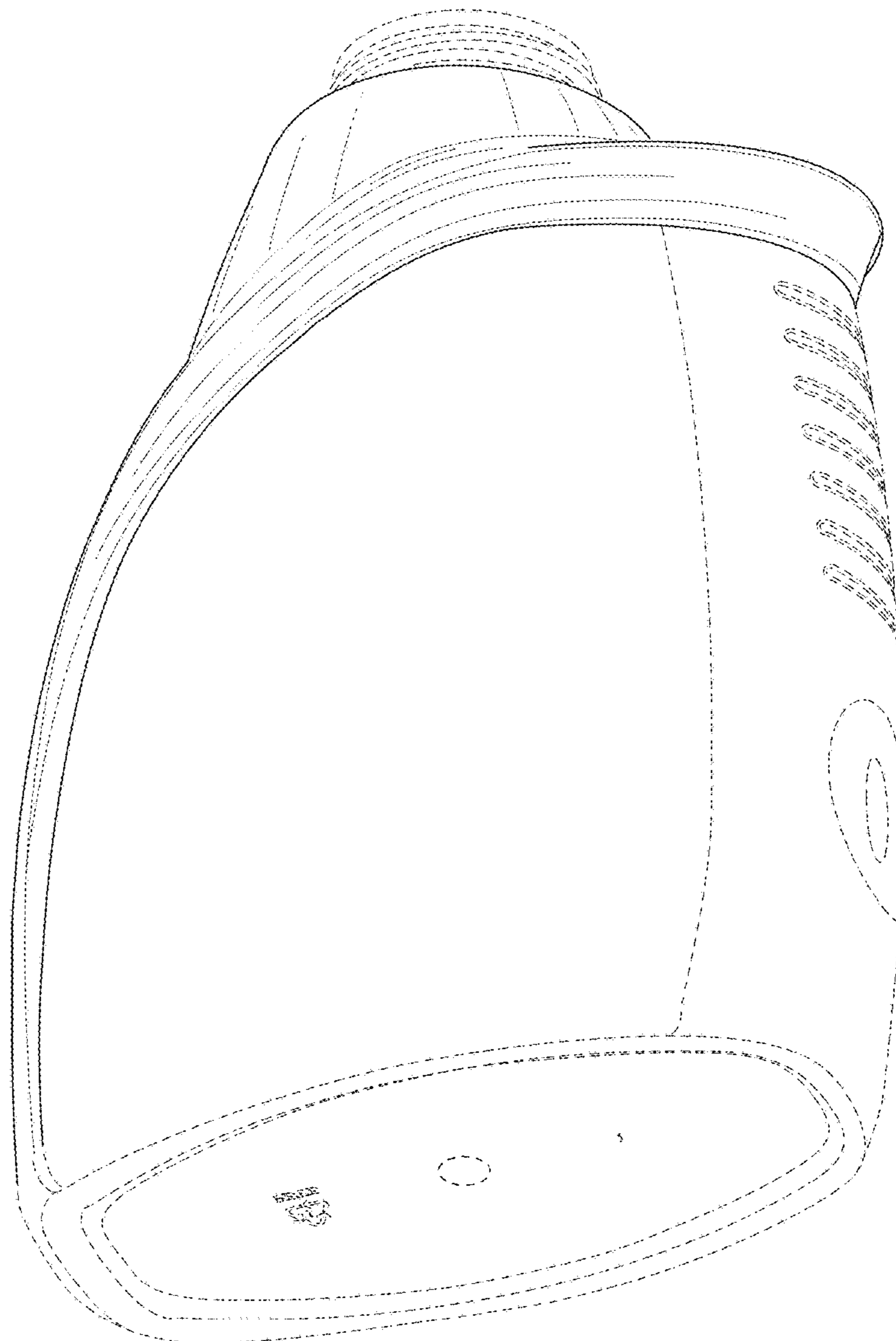
