FIG. 1 is a front view of a meter panel showing my new design;

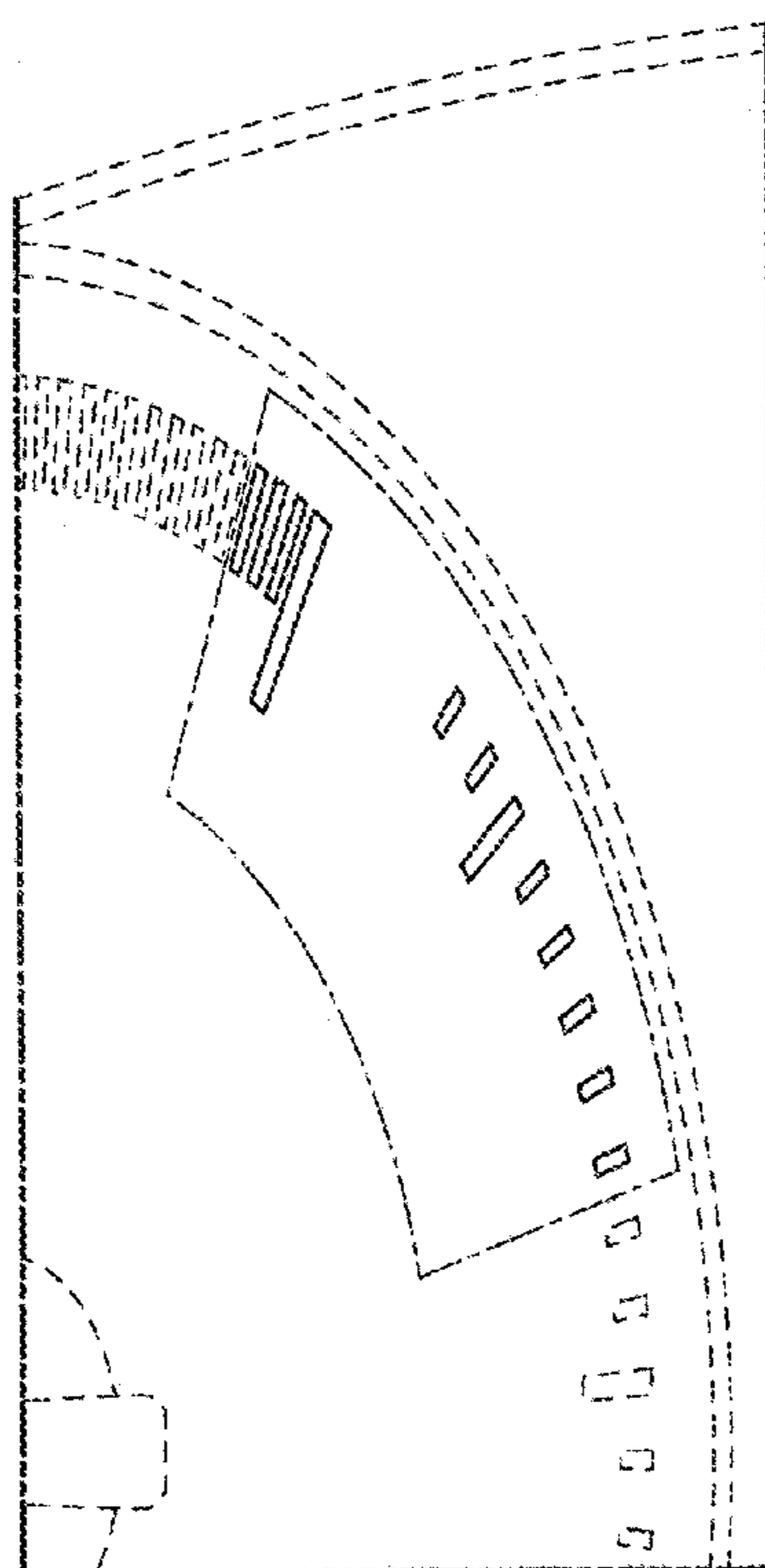
FIG. 2 is a right side view thereof;

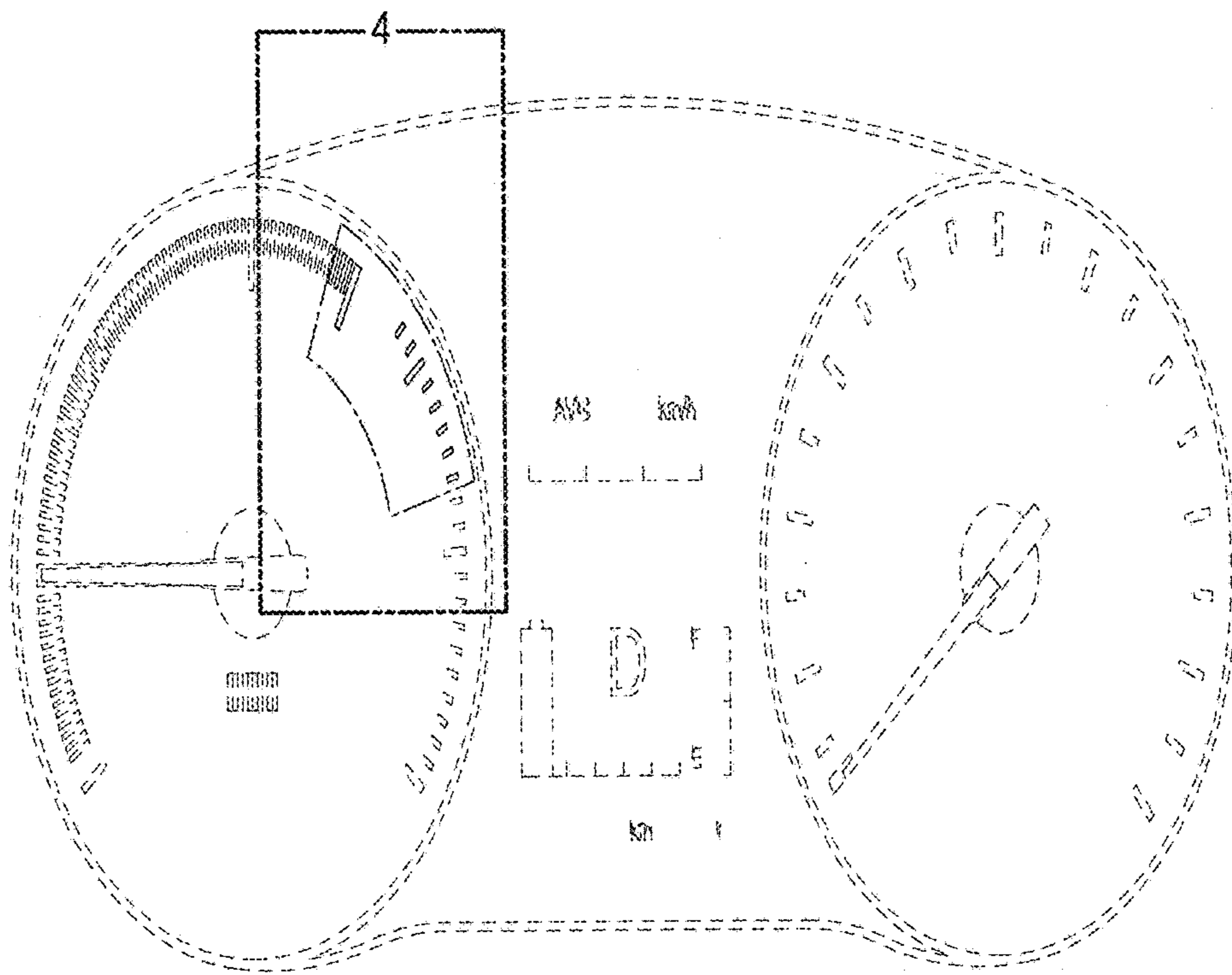

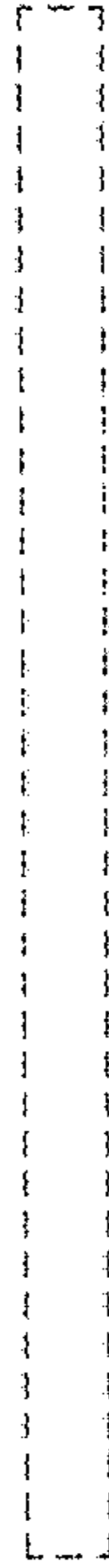

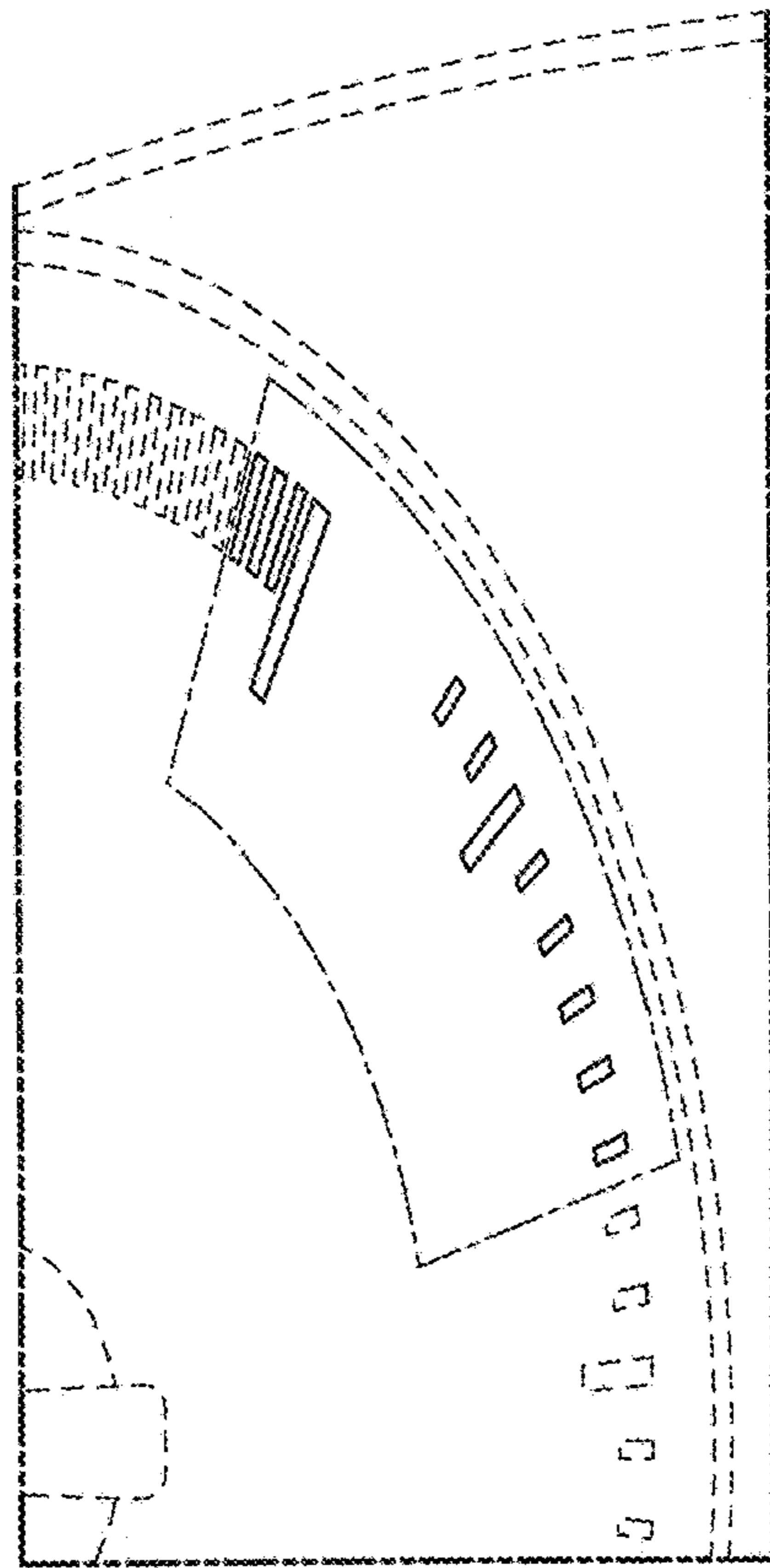

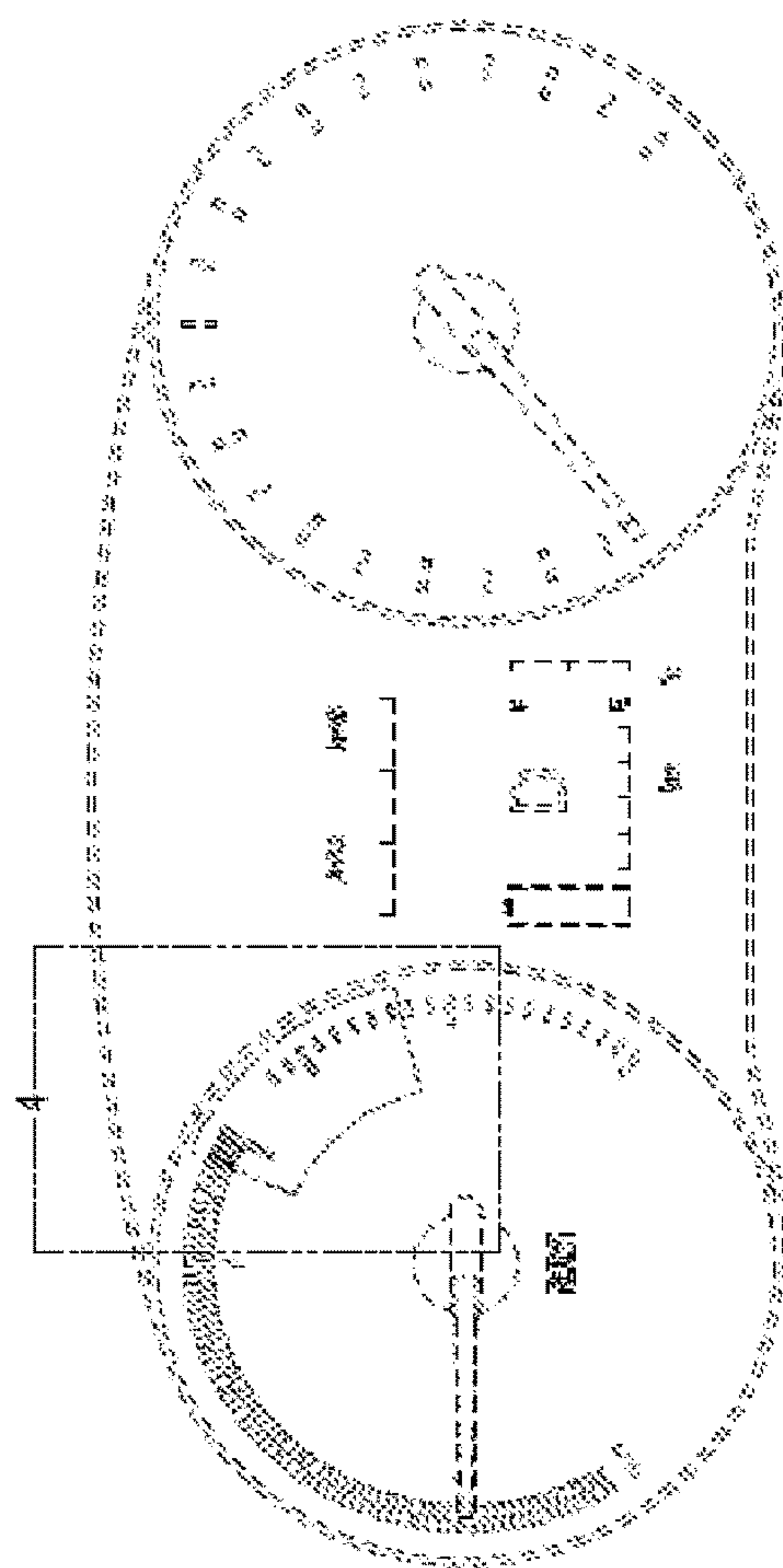

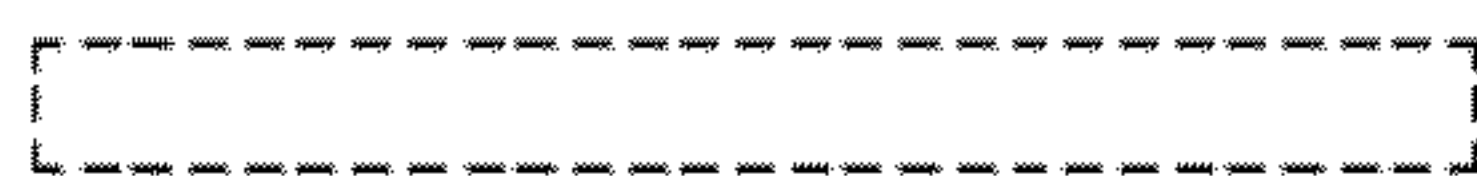

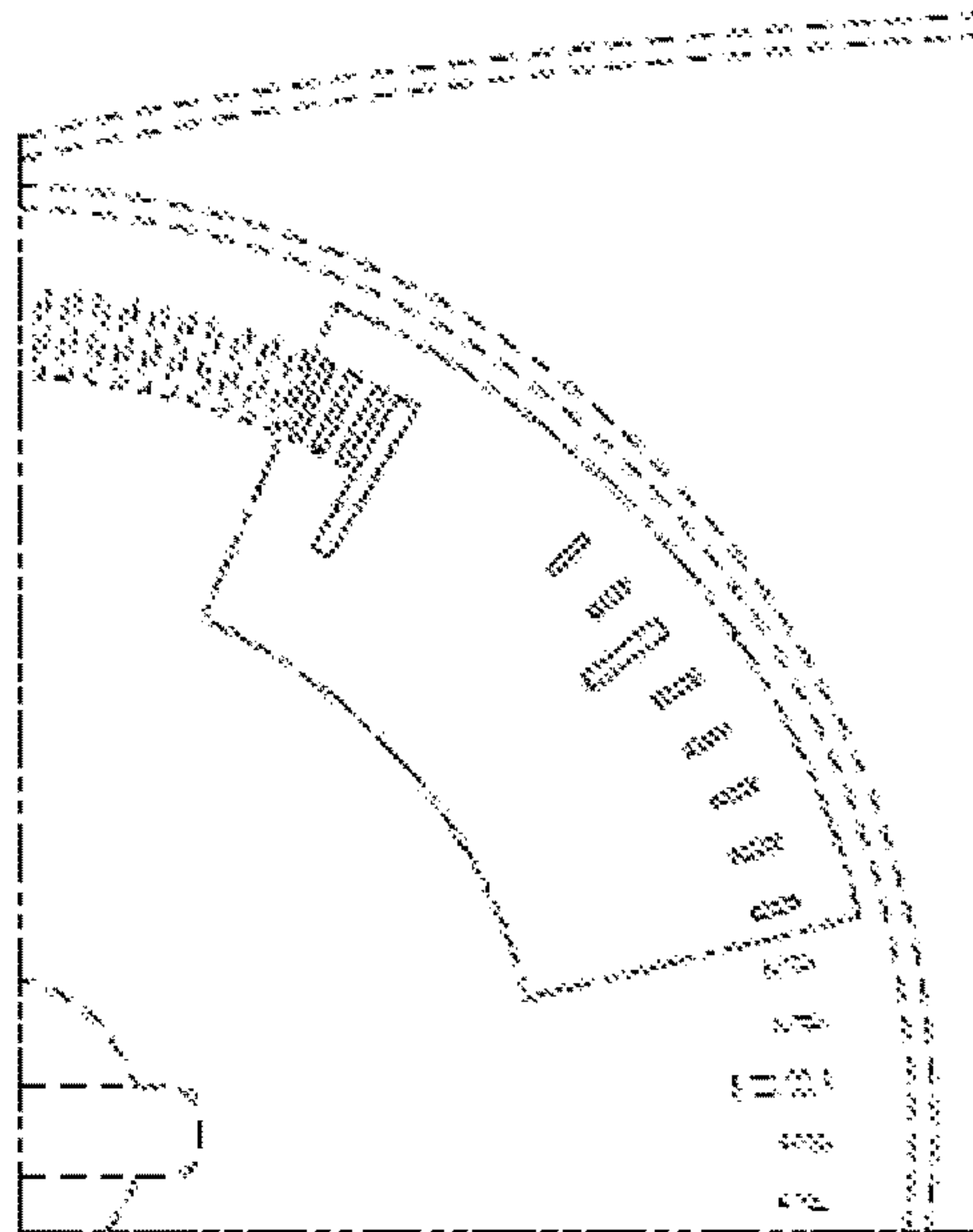
